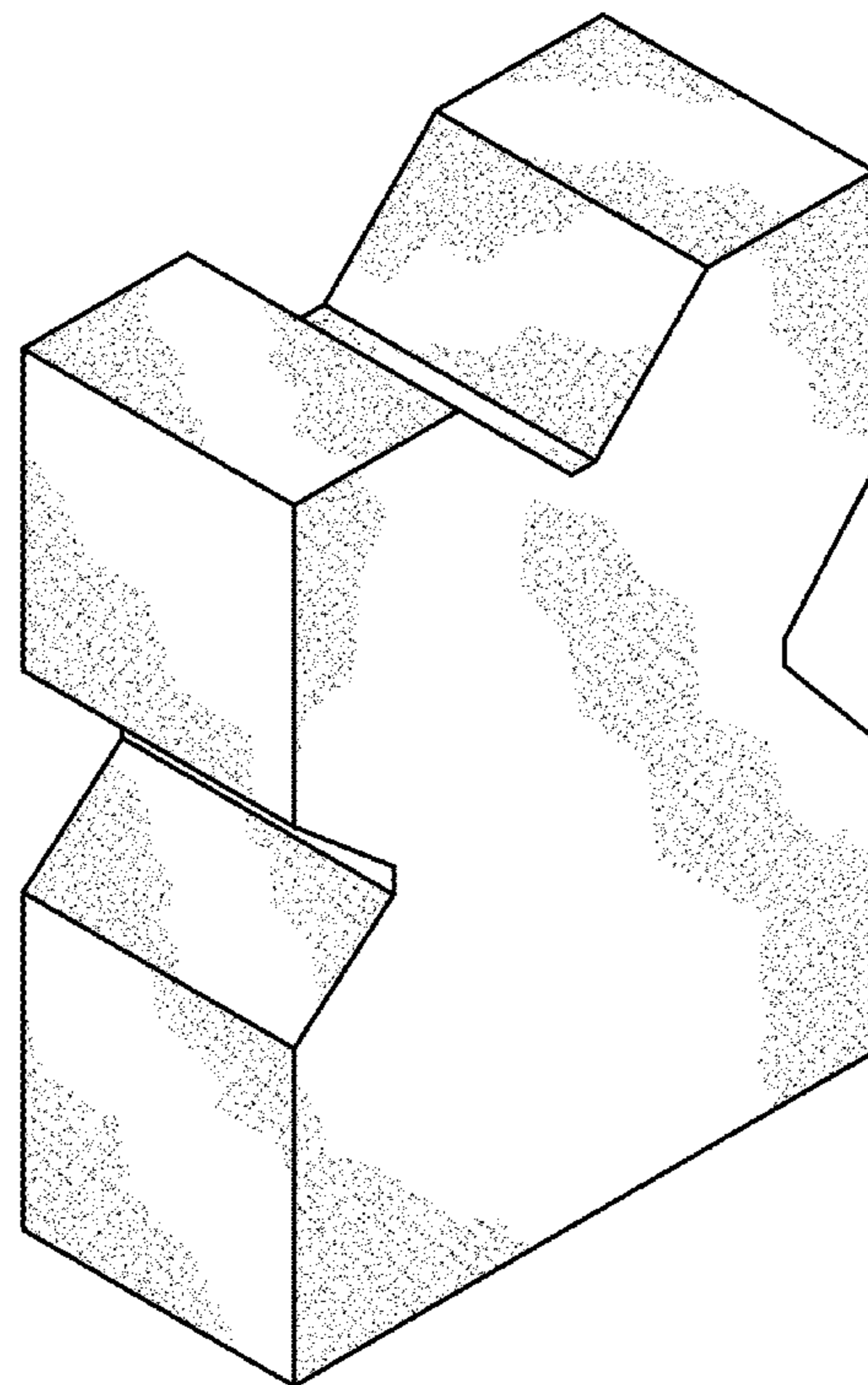
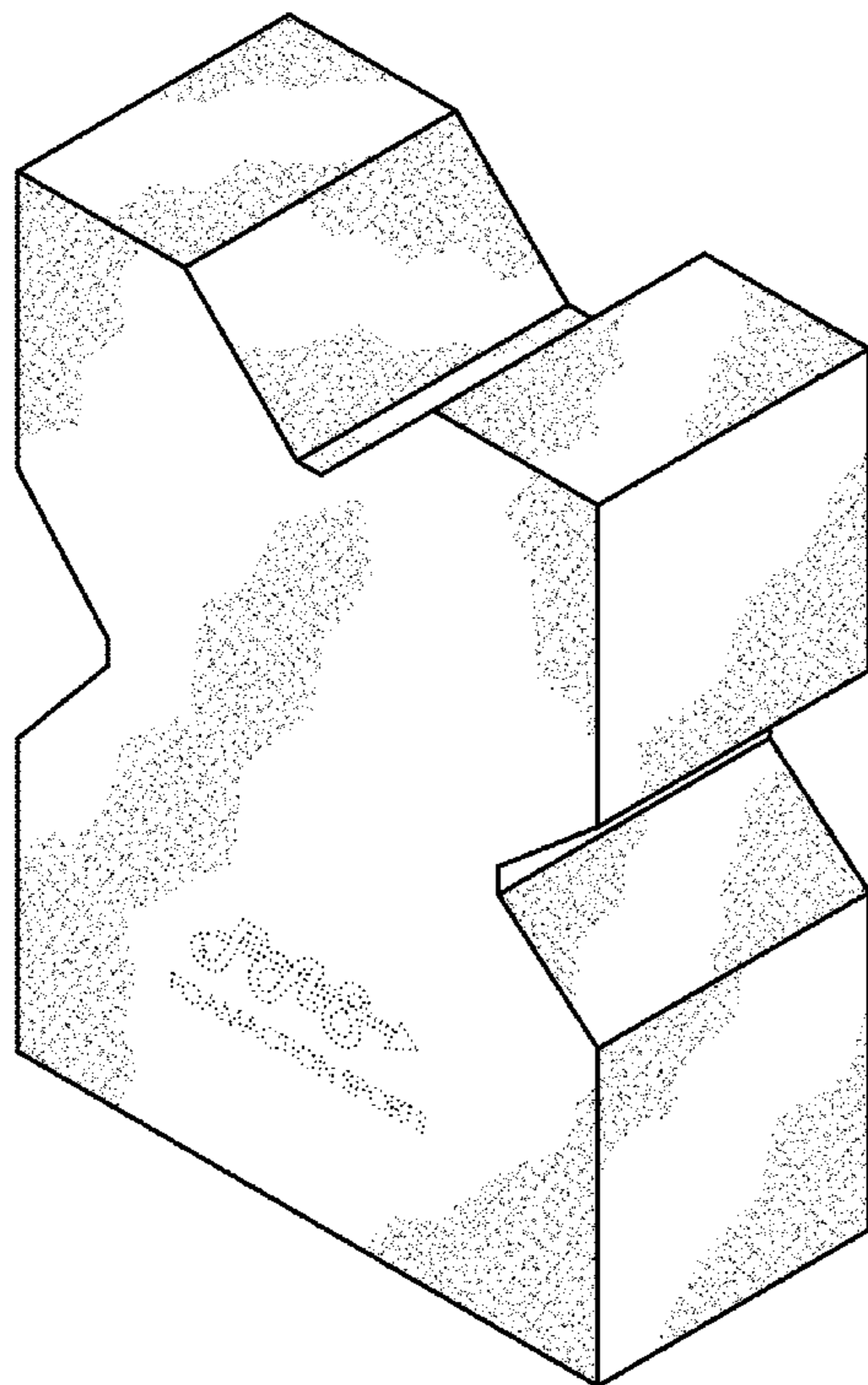
(57) **CLAIM**

We claim the ornamental design for a foam gun rest, as shown and described in the figures.

DESCRIPTION

FIG. 1 is a front perspective view of a foam gun rest, in accordance with the present design;

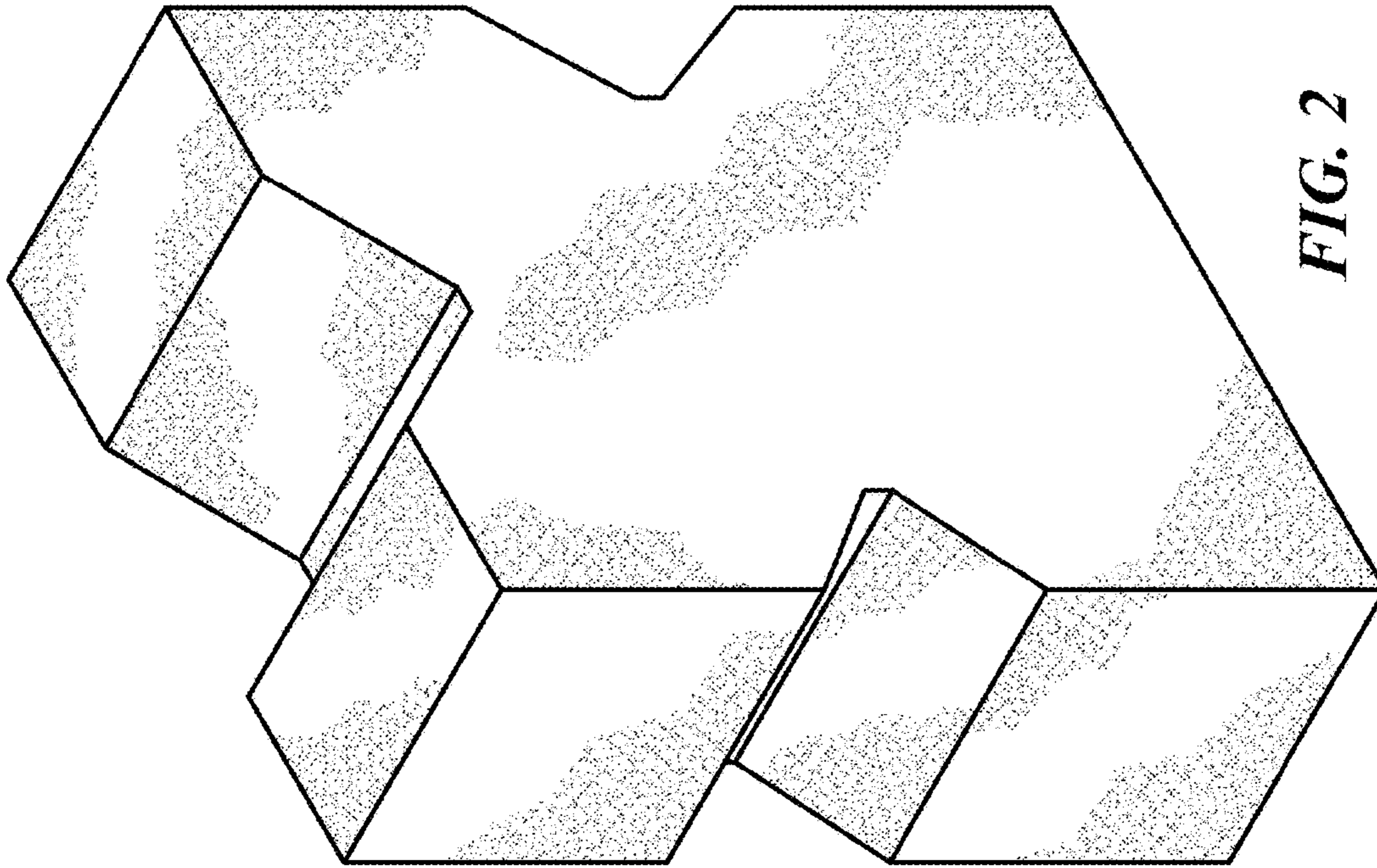

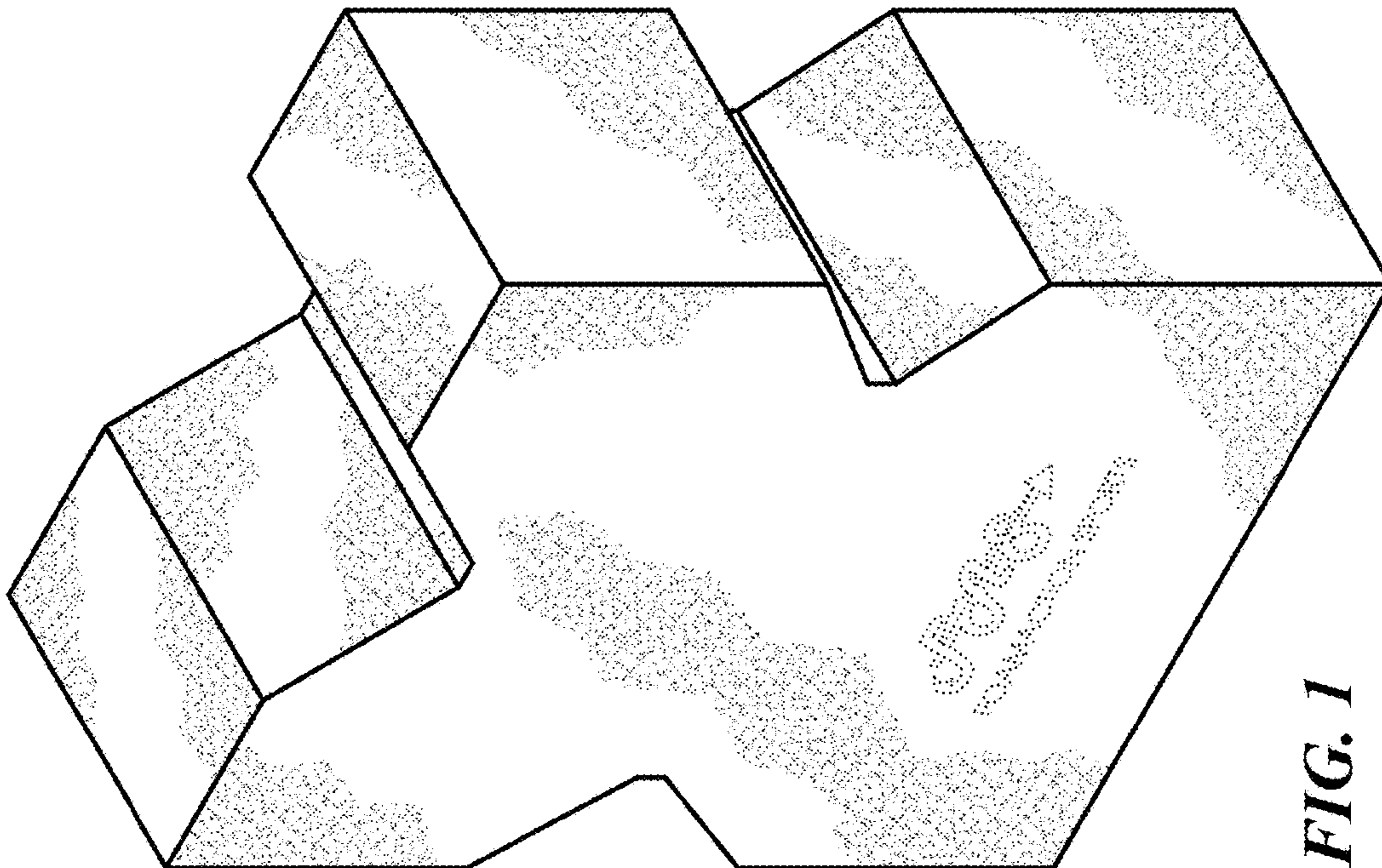

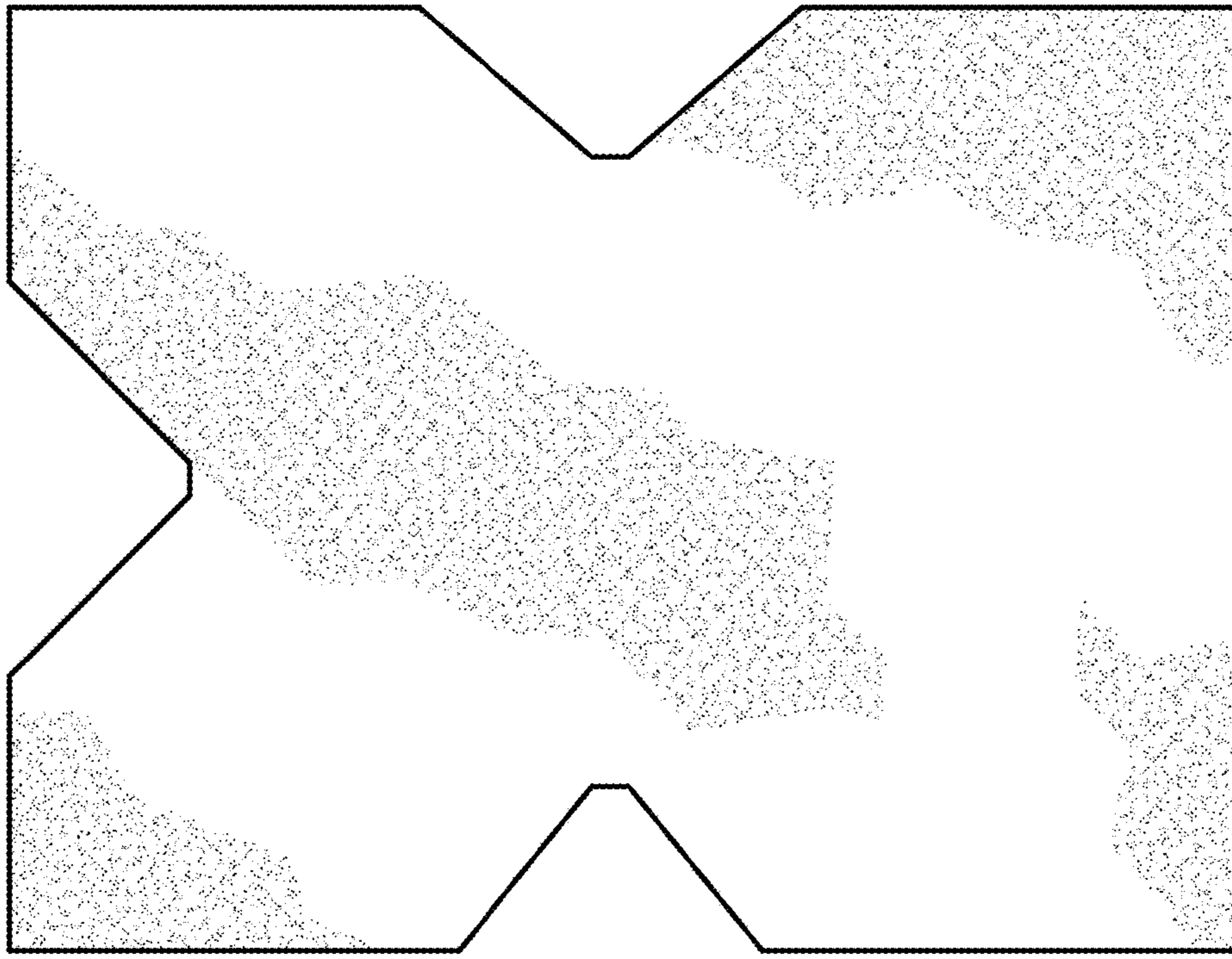

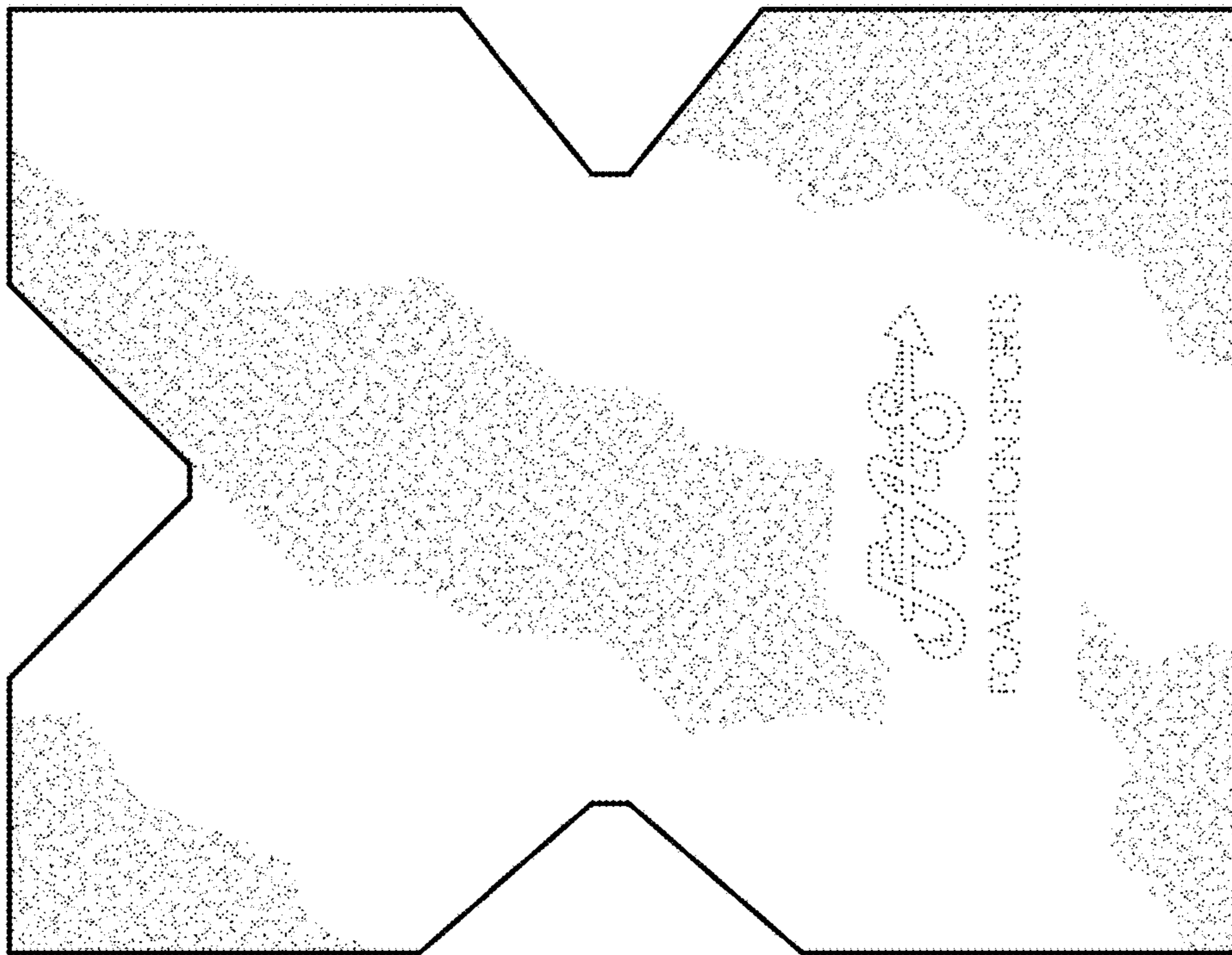

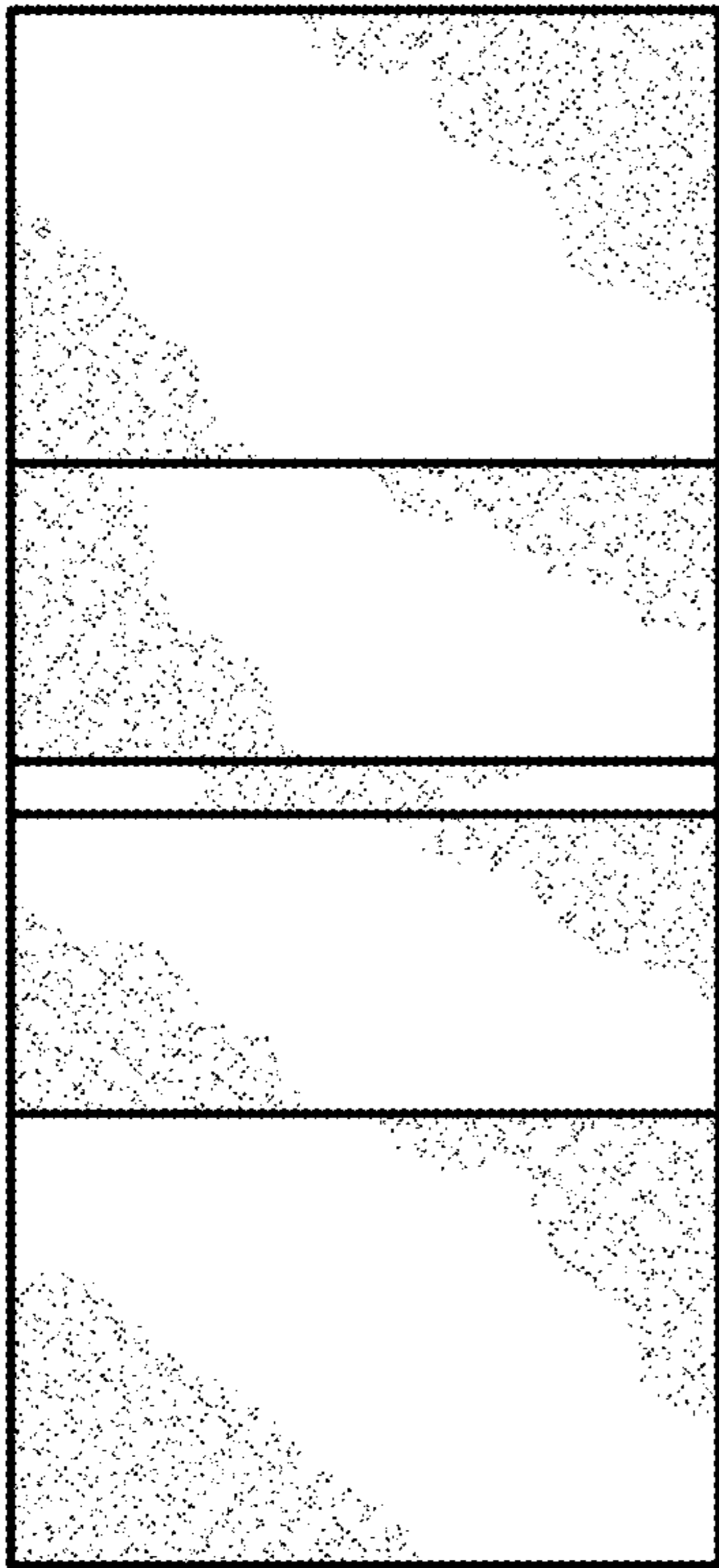

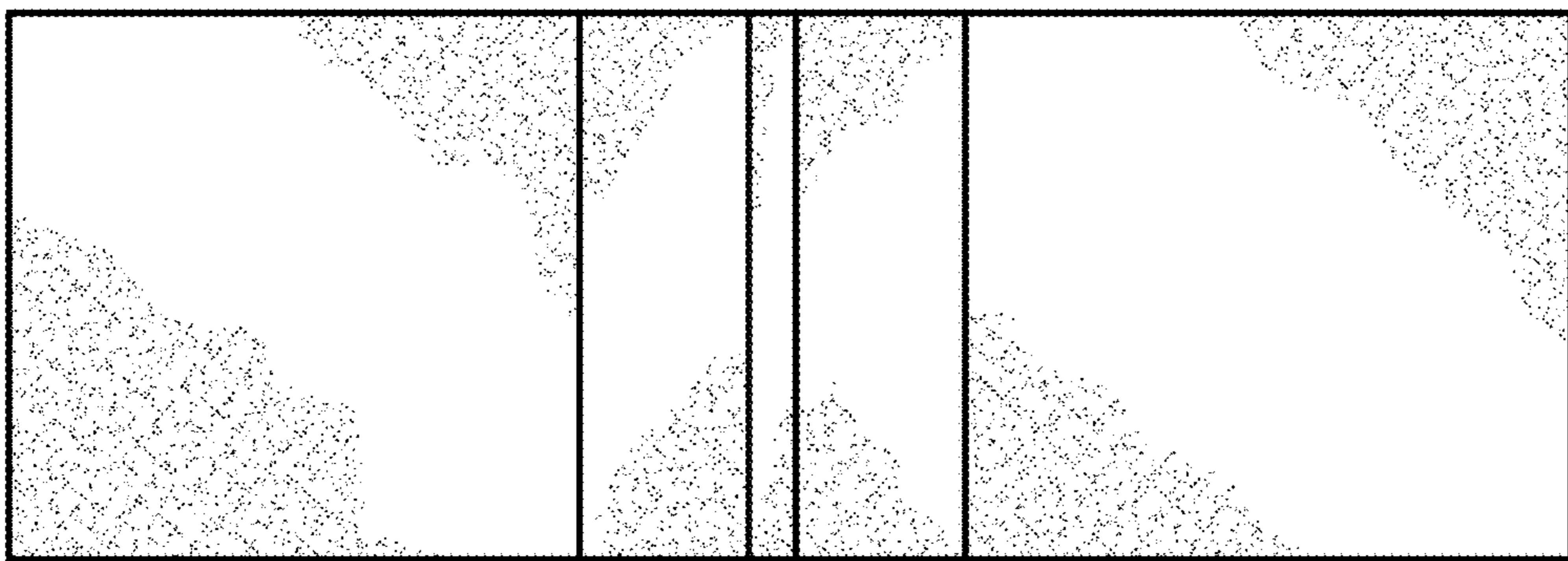

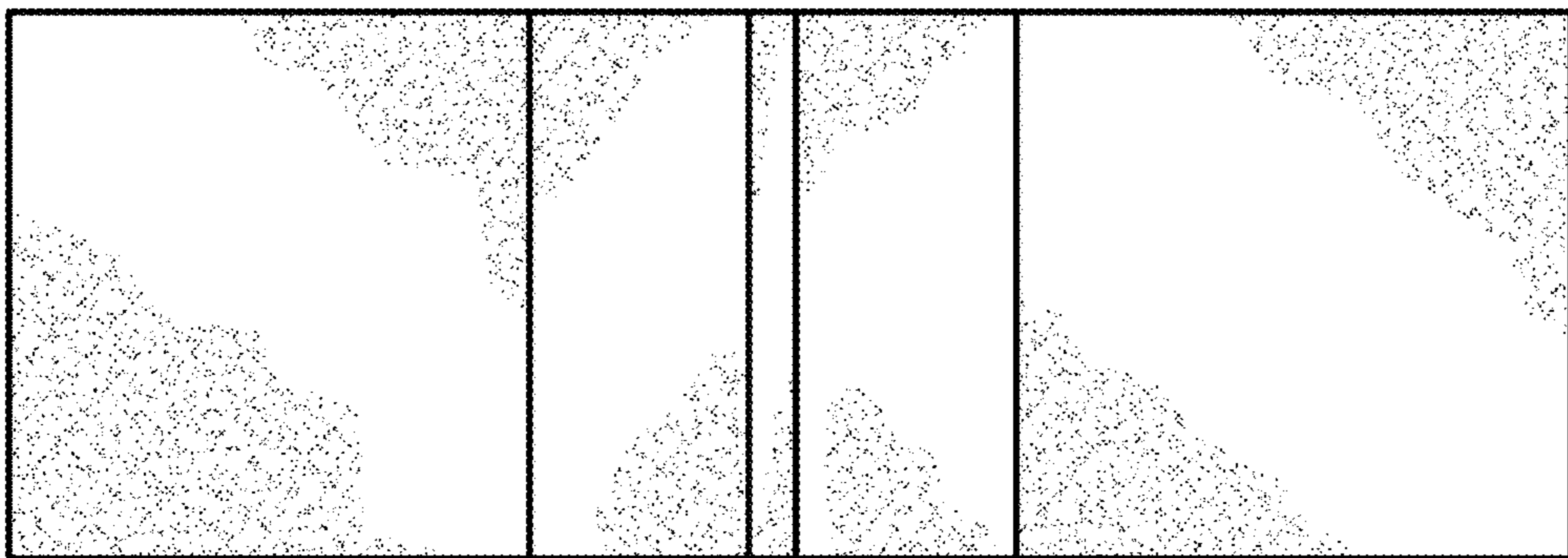
