The ornamental design for a suture grasper tip, as shown and described.

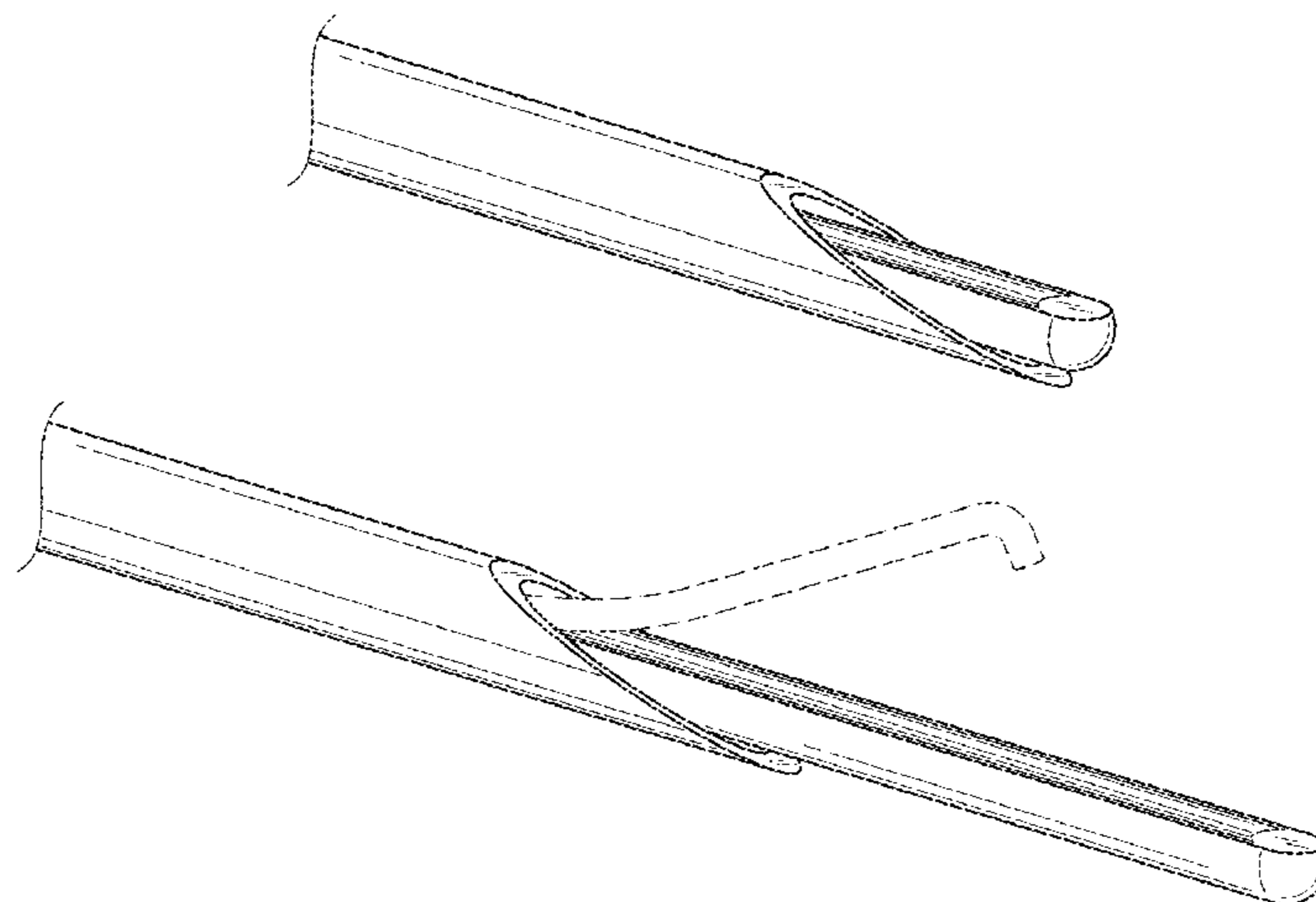
DESCRIPTION

FIG. 1 is a perspective view of the suture grasper tip showing my new design;
FIG. 2 is a Right side view thereof, the Left side being a mirror image of the Right side;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a perspective view of the suture grasper tip in an extended position;
FIG. 7 is a Right side view thereof, the Left side being a mirror image of the Right side;
FIG. 8 is a top view thereof;
FIG. 9 is a bottom view thereof; and,
FIG. 10 is a front view thereof.

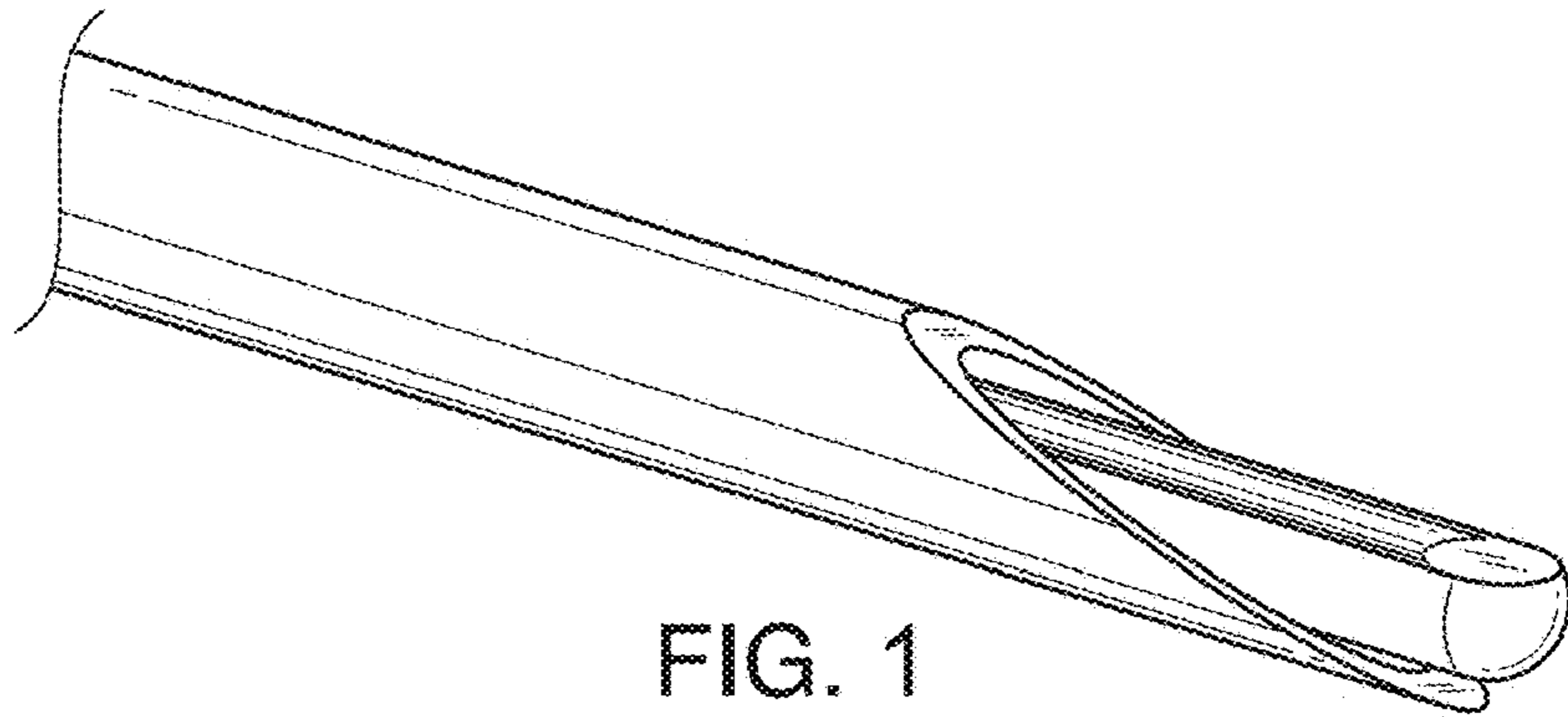

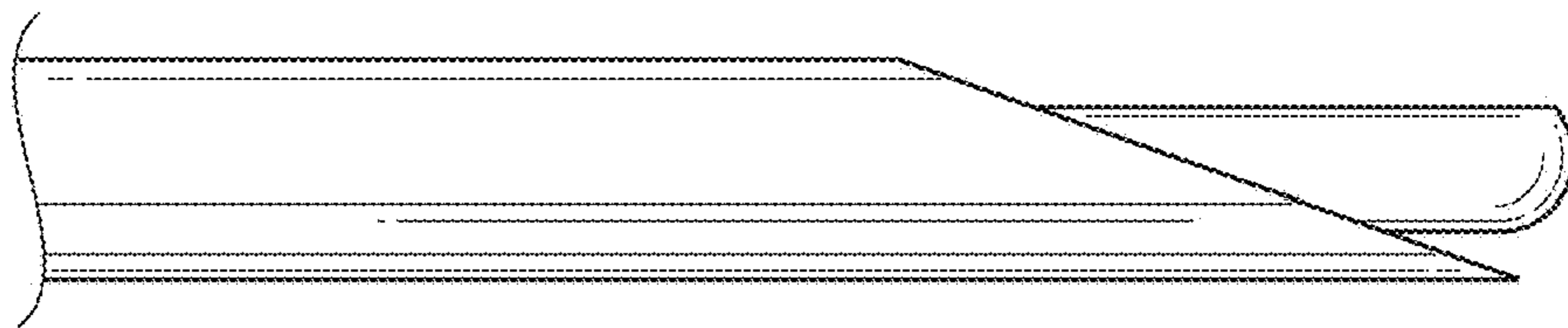

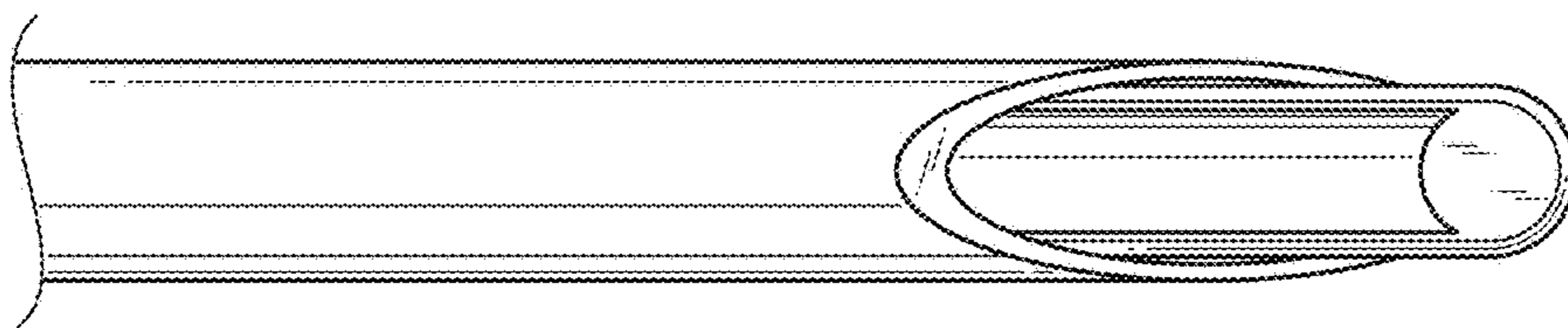

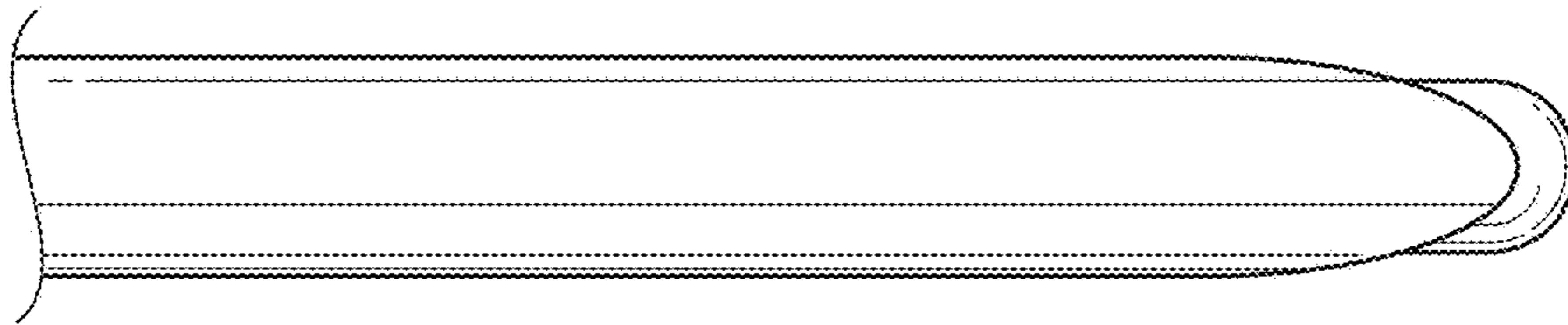

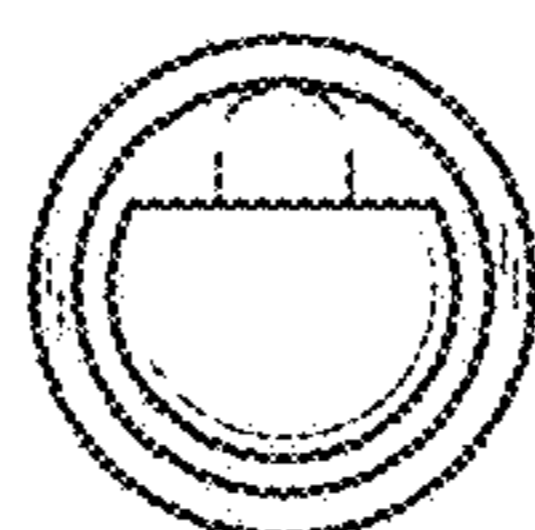
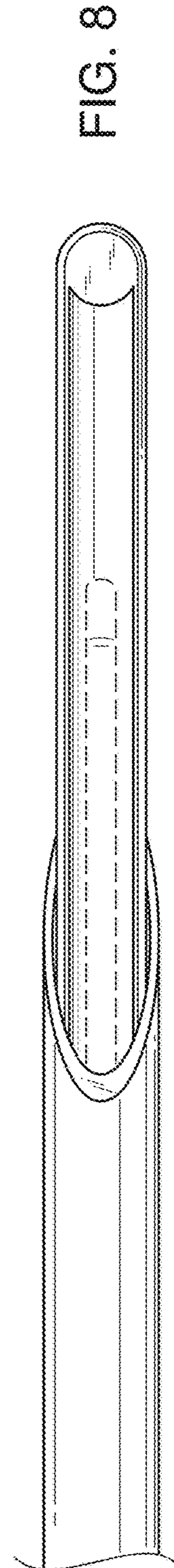
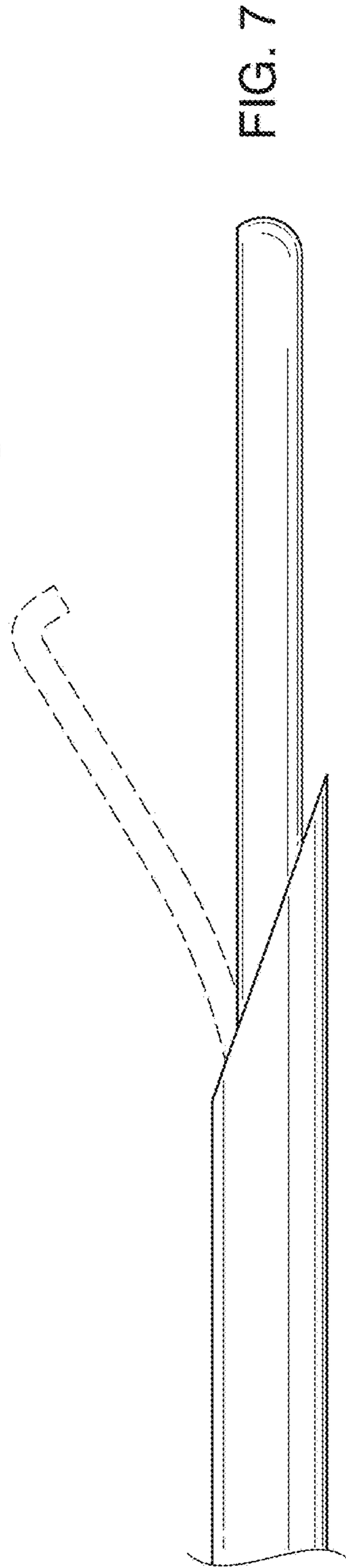
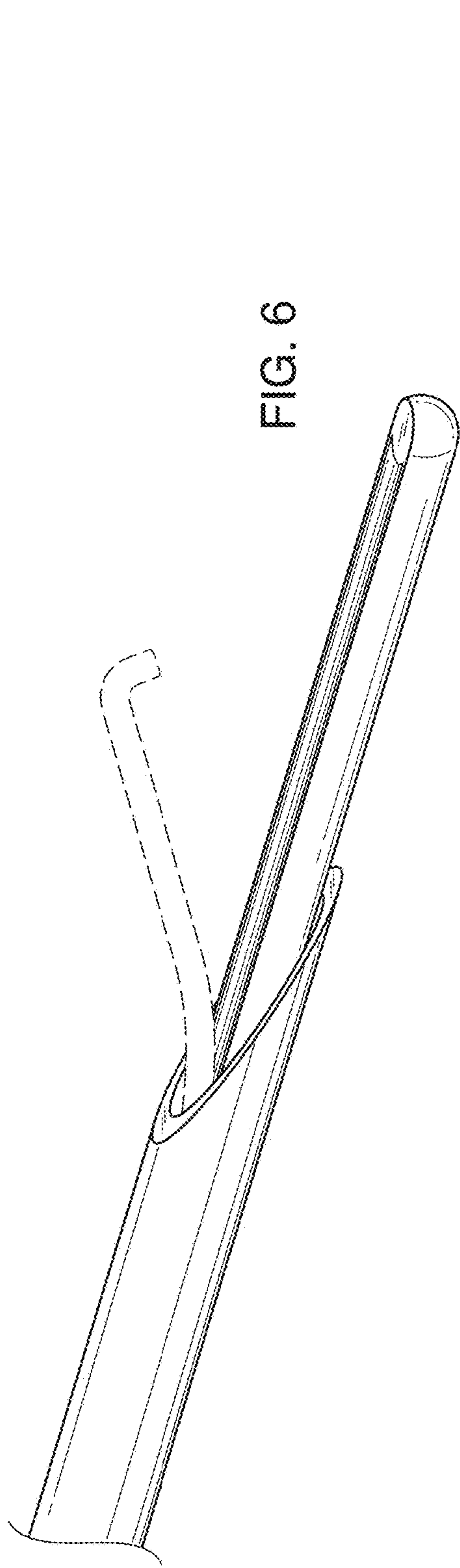

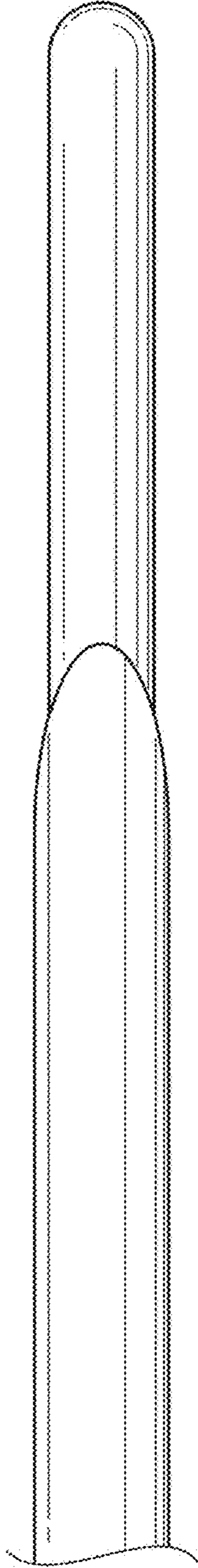

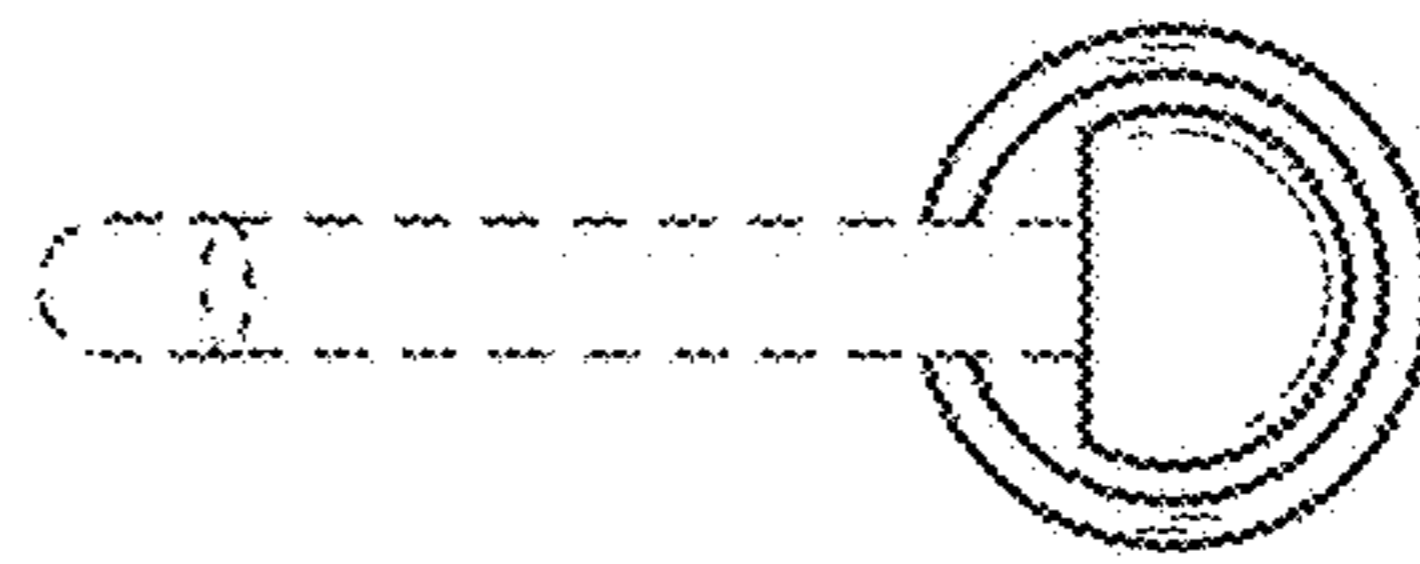
