The ornamental design for a cigarette paper, as shown and described.

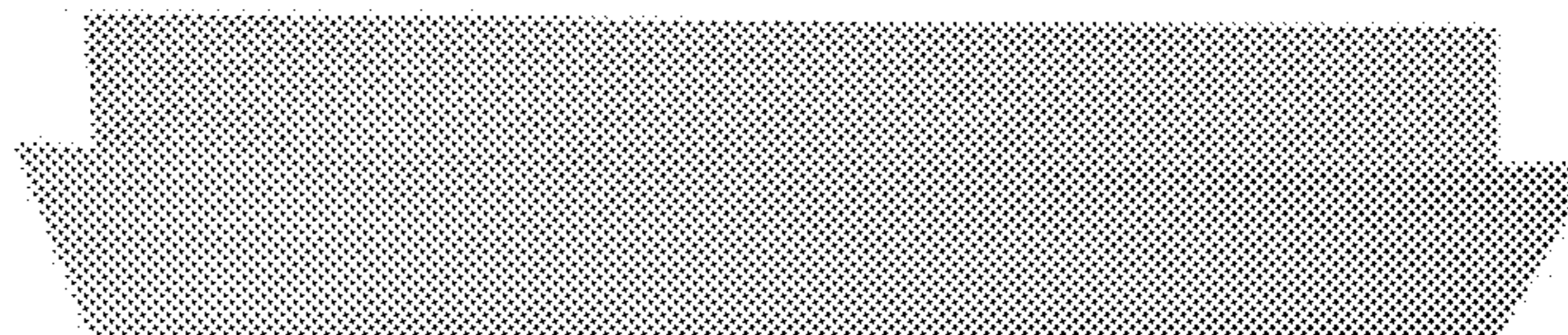
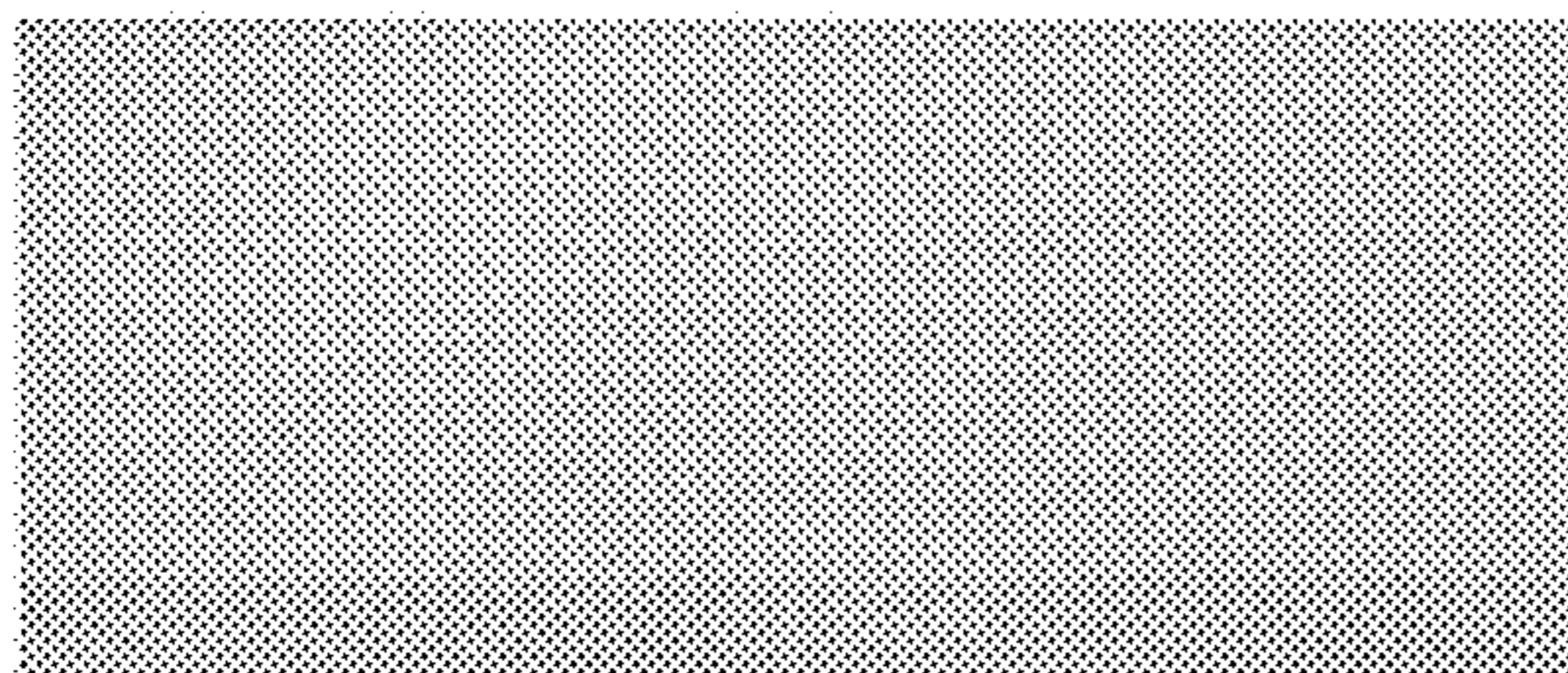
**DESCRIPTION**

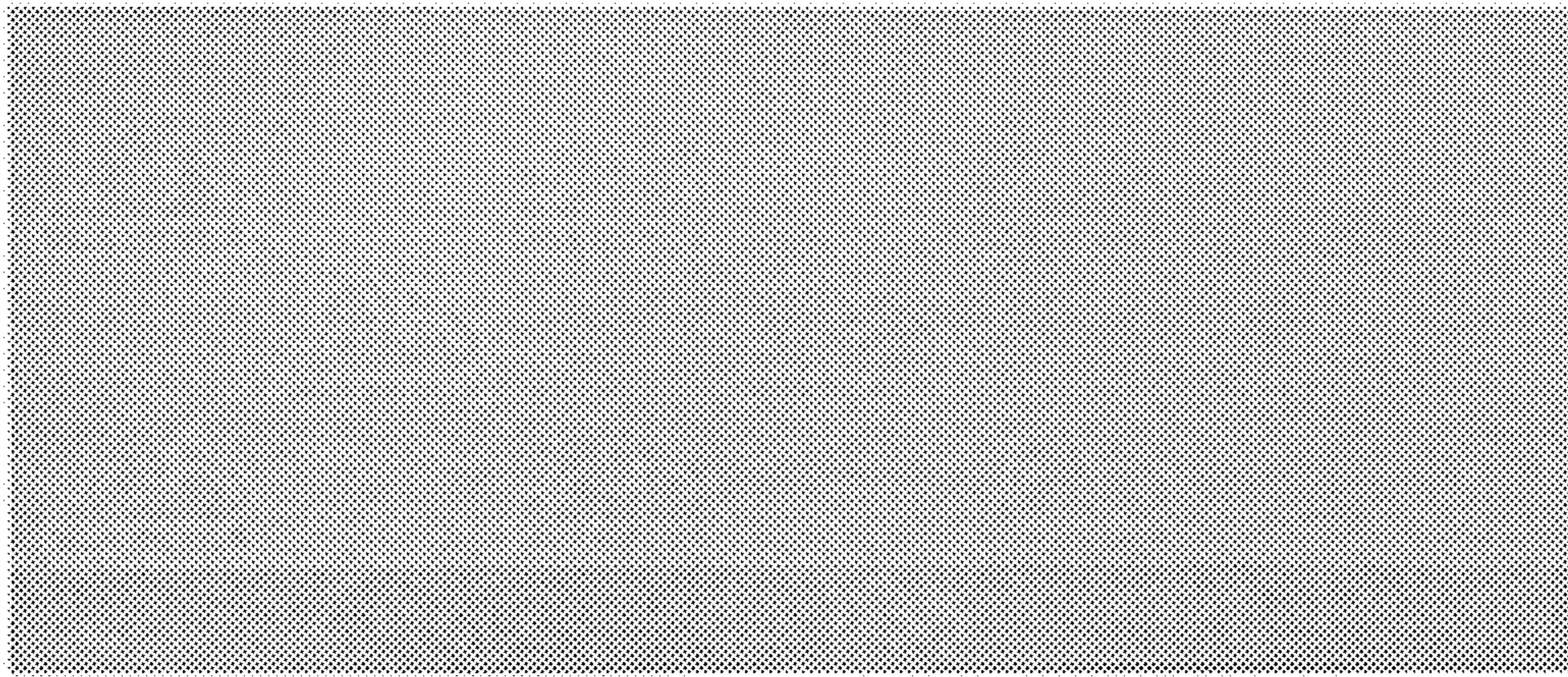

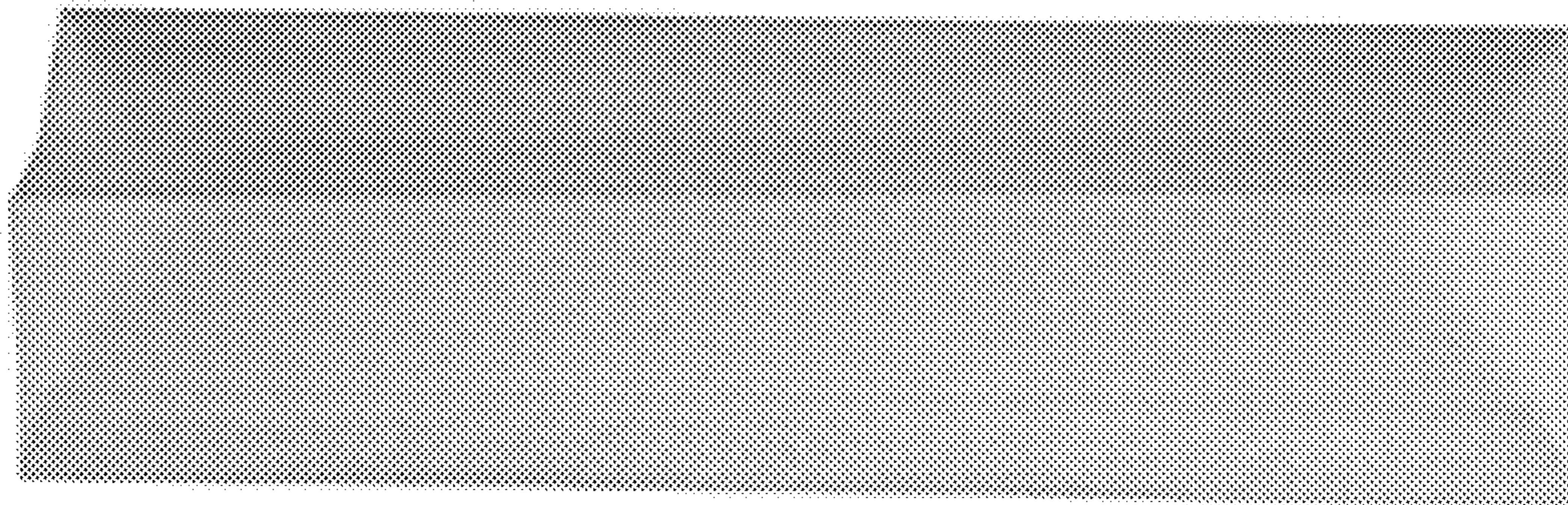

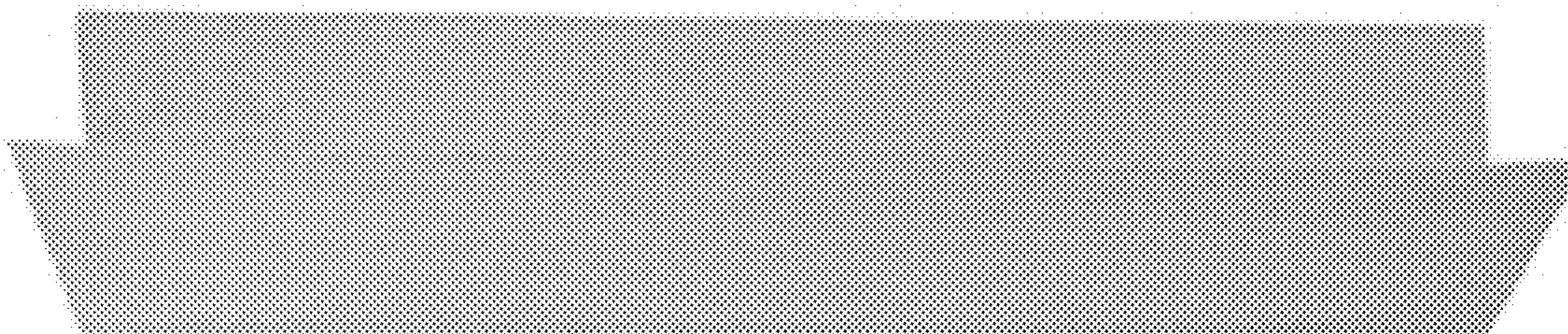
