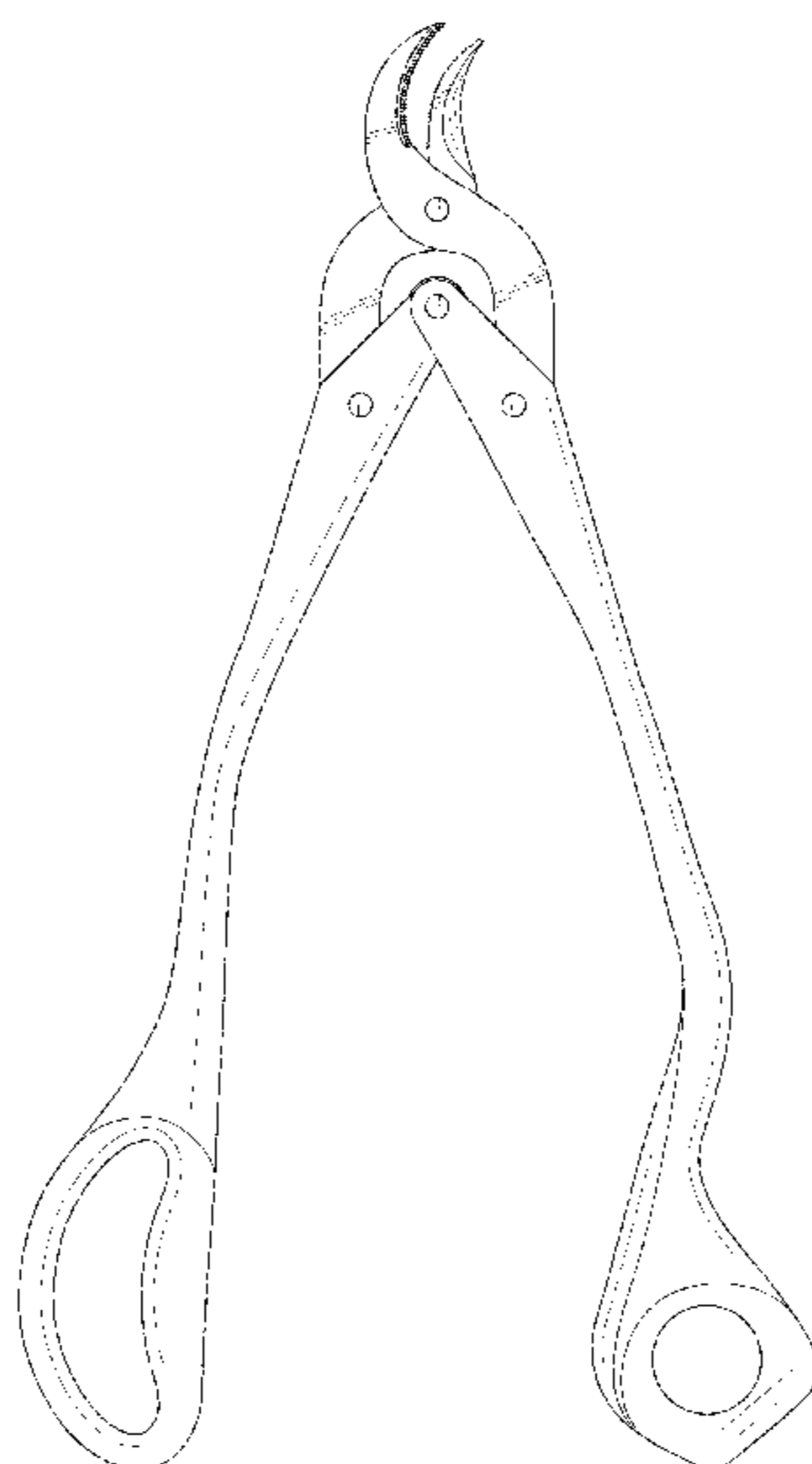
(57) **CLAIM**

The ornamental design for a toenail clipper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a toenail clipper showing the new design, in an open position;  
FIG. 2 is a front view of FIG. 1, in a closed position;  
FIG. 3 is a rear view of FIG. 1, in an open position;  
FIG. 4 is a rear view of FIG. 1, in a closed position;  
FIG. 5 is a left side view of FIG. 1;  
FIG. 6 is a right side view of FIG. 1;  
FIG. 7 is a top view of FIG. 1;  
FIG. 8 is a bottom view of FIG. 1;  
FIG. 9 is a close up front perspective view of a portion of FIG. 1, to show the detail of the blades; and,  
FIG. 10 is a close up front perspective view from the rear side of FIG. 9, to show the detail of the blades.  
The dashed lines in FIGS. 9-10 show enlarged views of the toenail clipper and form no part of the claimed design.

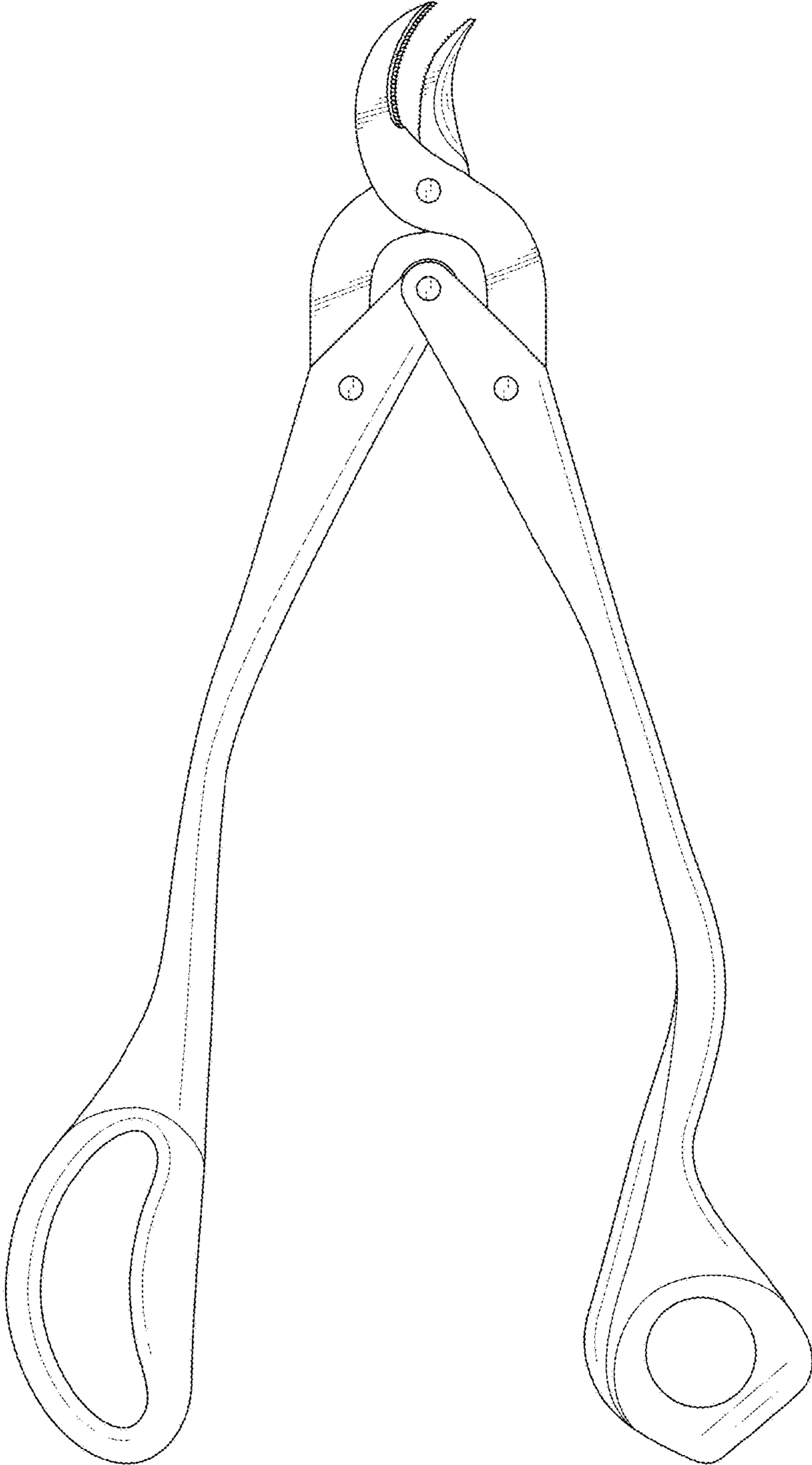

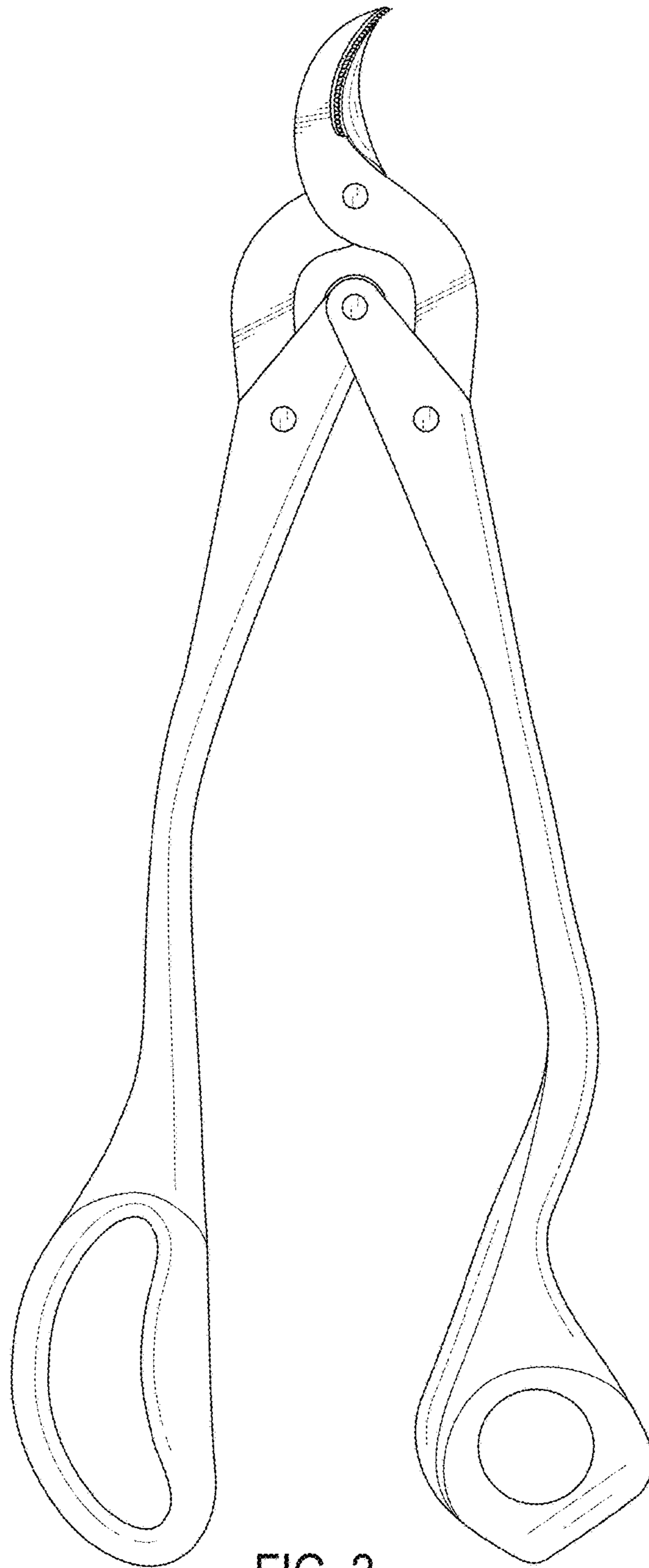

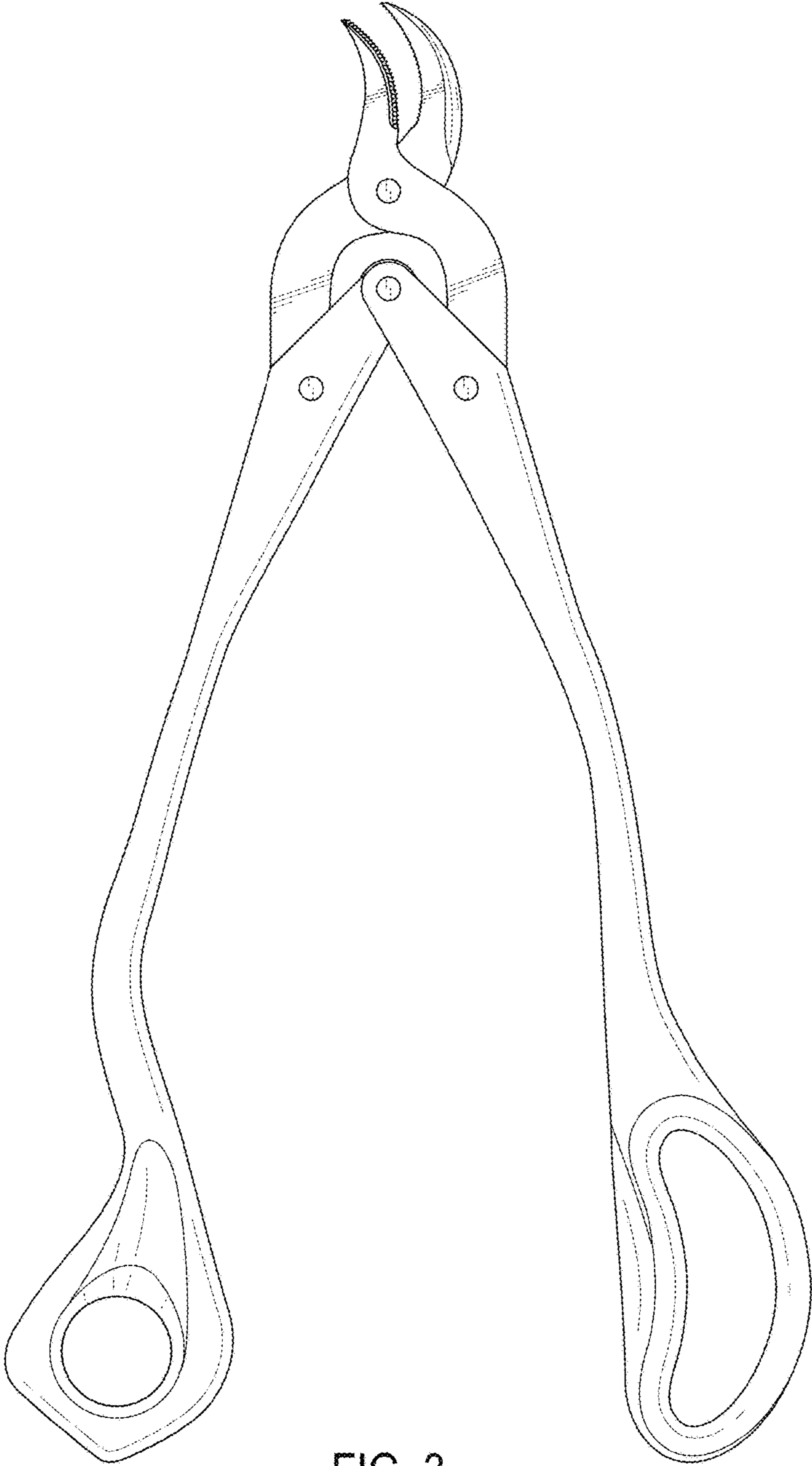

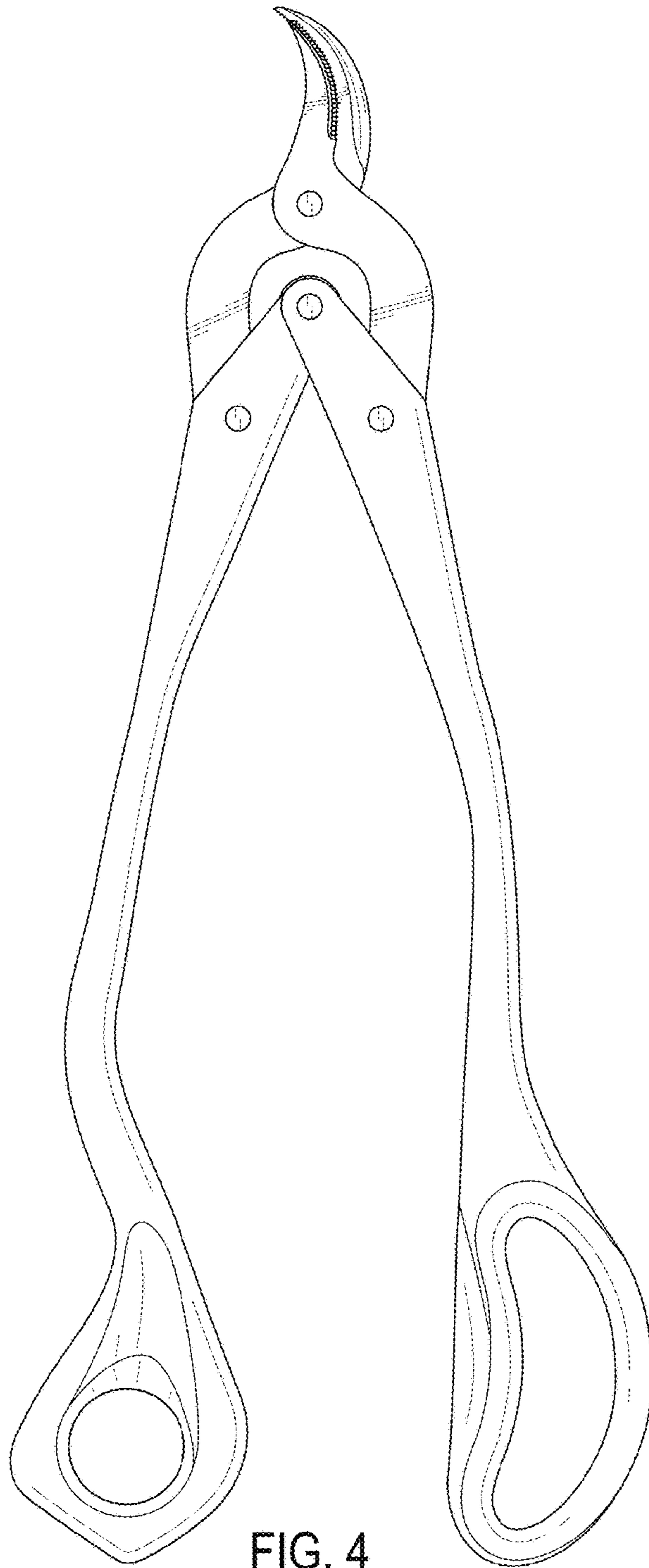

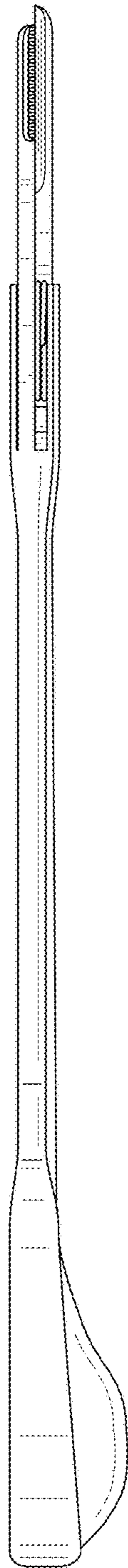

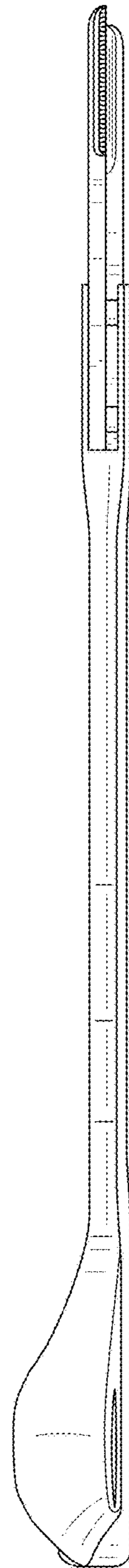

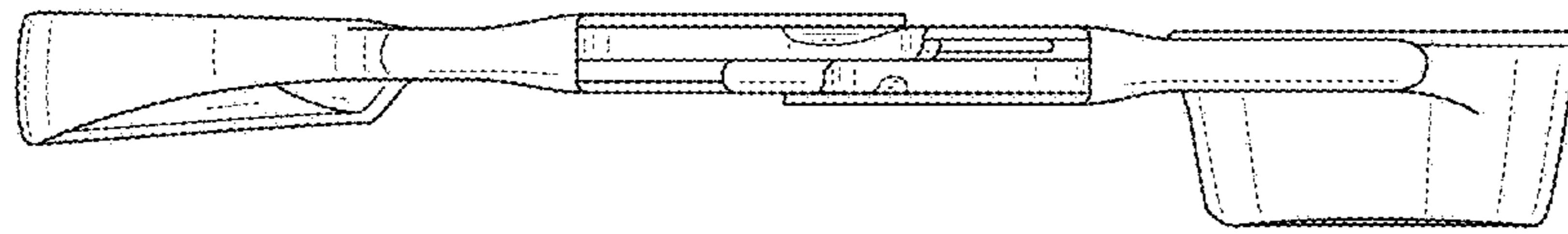

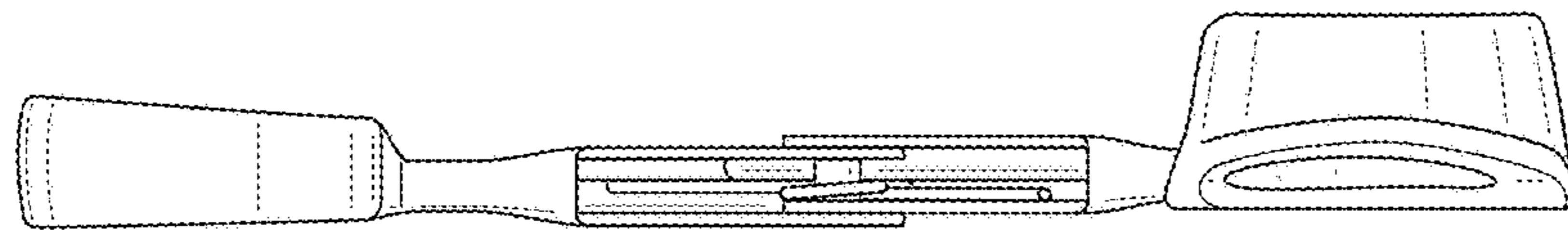

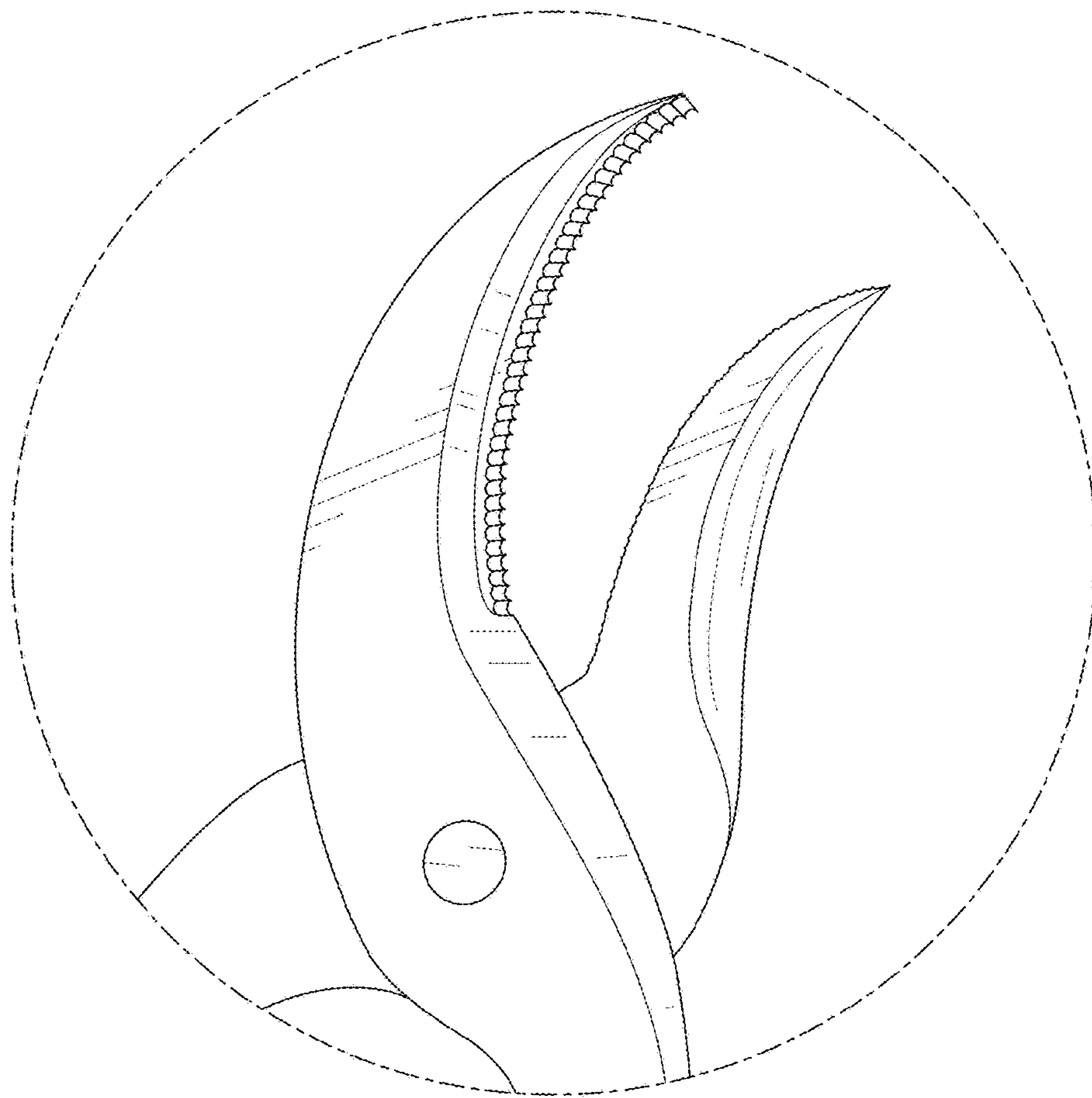

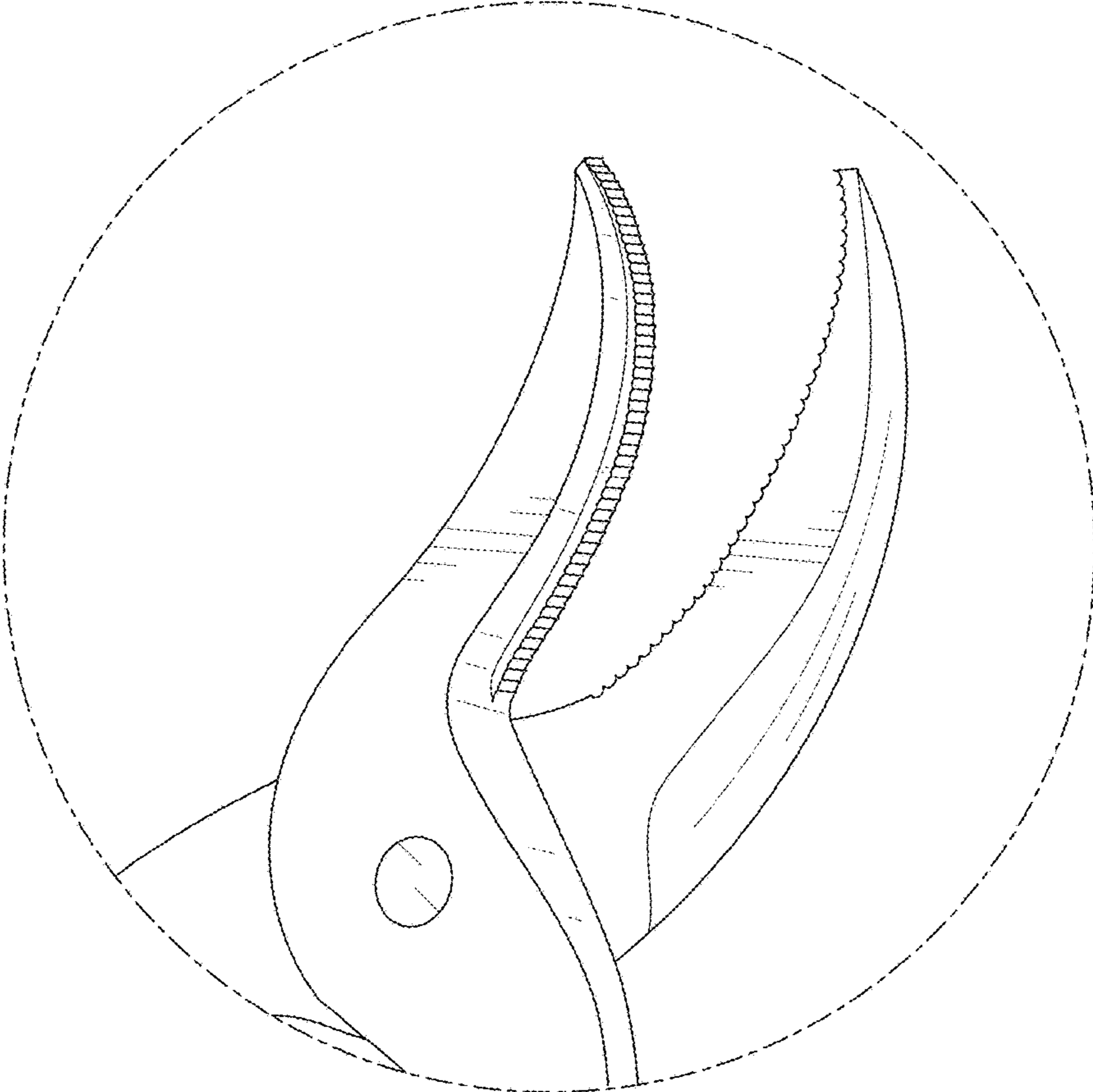
