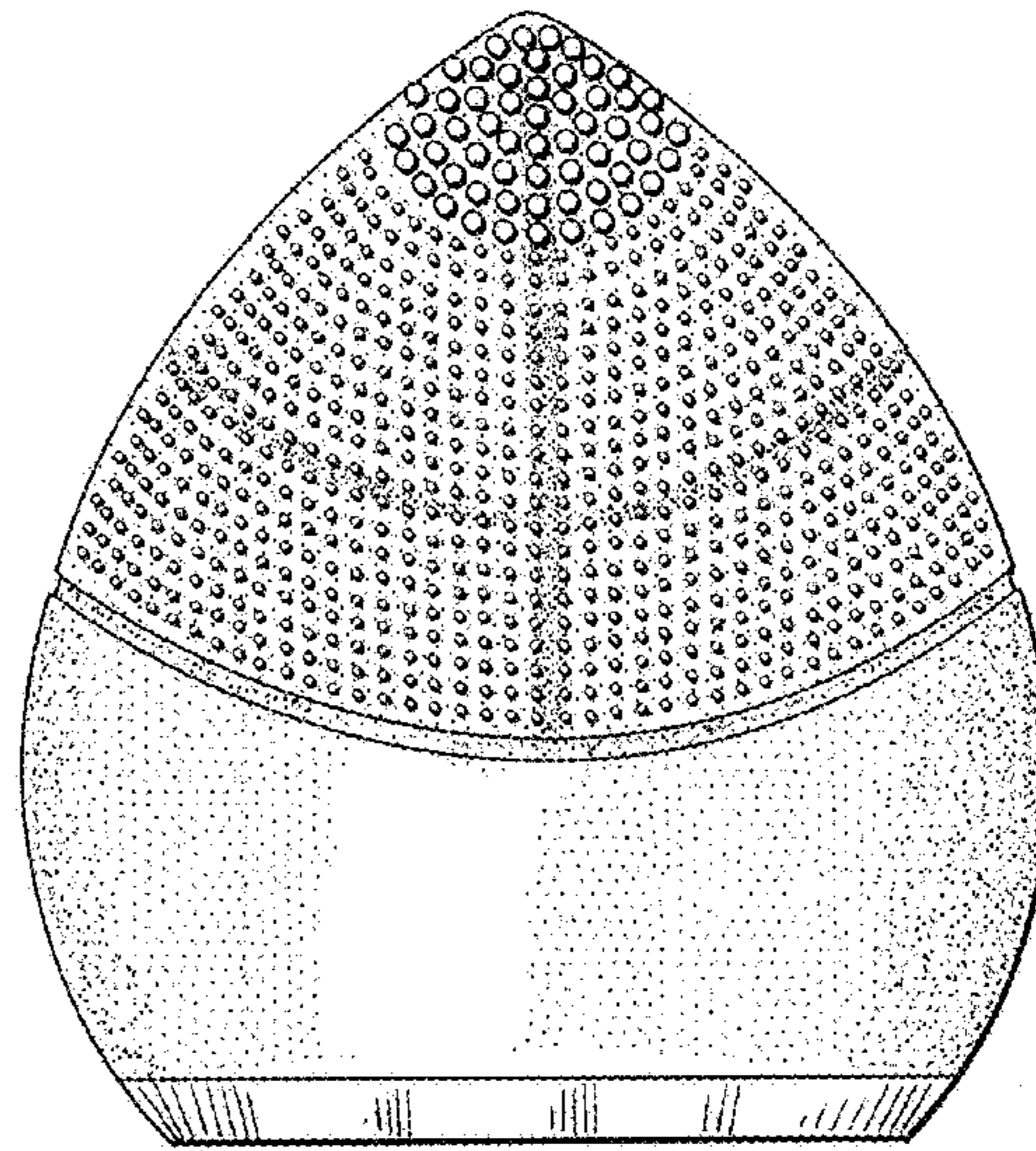
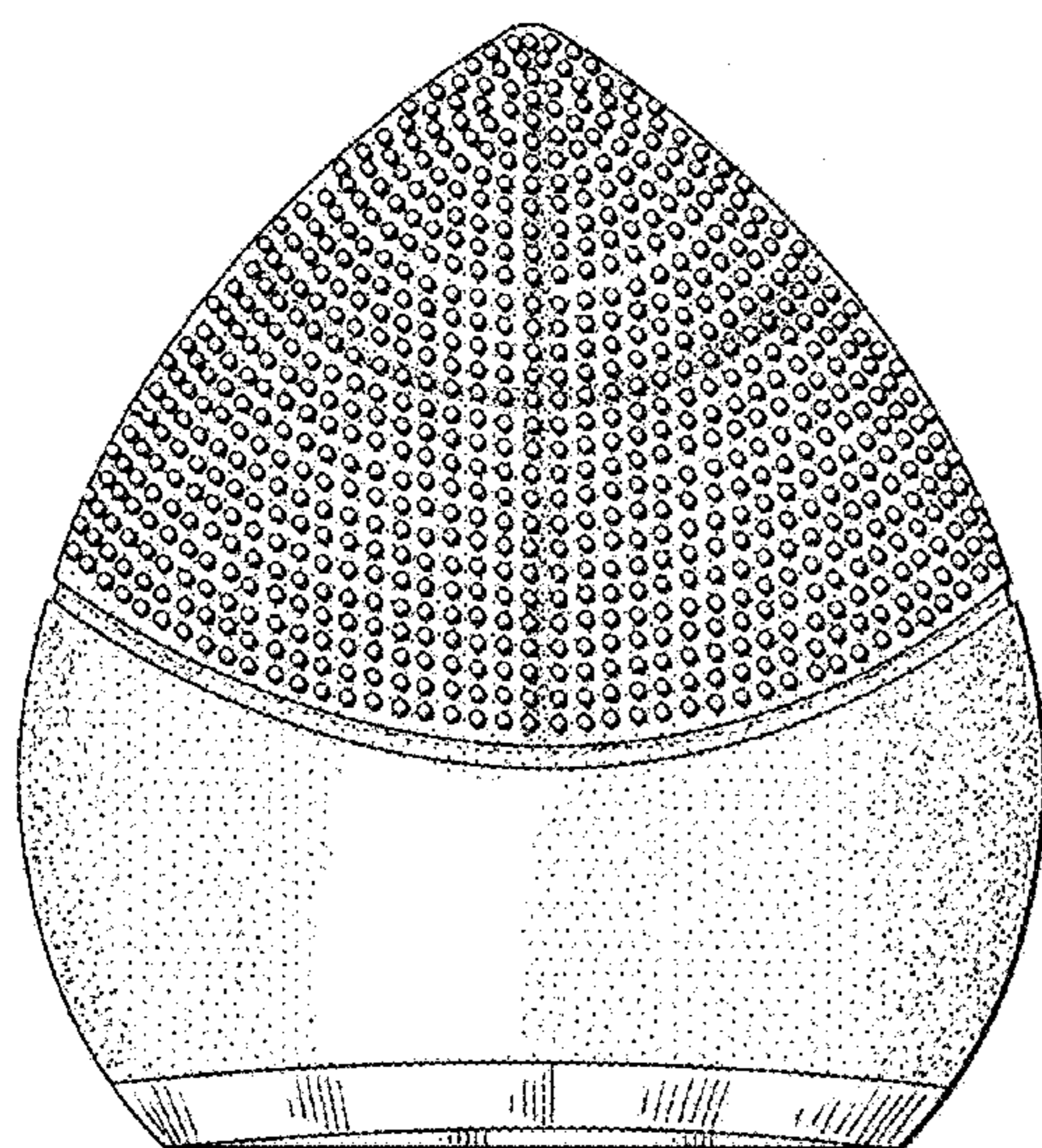
(57) **CLAIM**

The ornamental design for a face cleaner, as shown and described.

**DESCRIPTION**

FIG. 1 is top plan view of a face cleaner; FIG. 2 is a right side perspective view of the face cleaner; FIG. 3 is a front elevation view of the face cleaner; FIG. 4 is a left side perspective view of the face cleaner; FIG. 5 is rear elevation view of the face cleaner including a boundary line shown in broken-line; and, FIG. 6 is a bottom plan view of a face cleaner. The broken line in FIG. 5 of the face cleaner is for the purpose of illustrating environment, and forms no part of the claimed design.

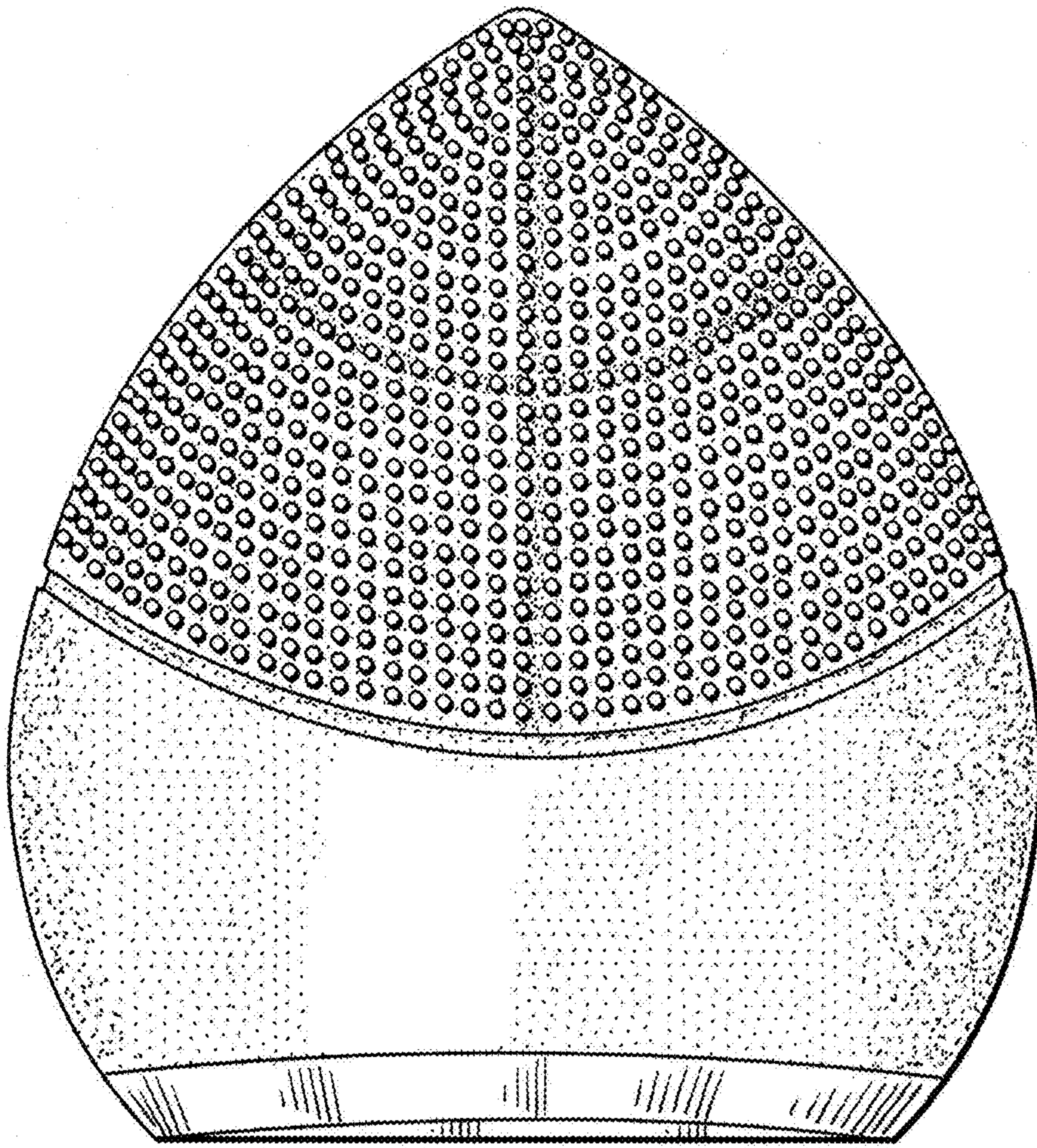

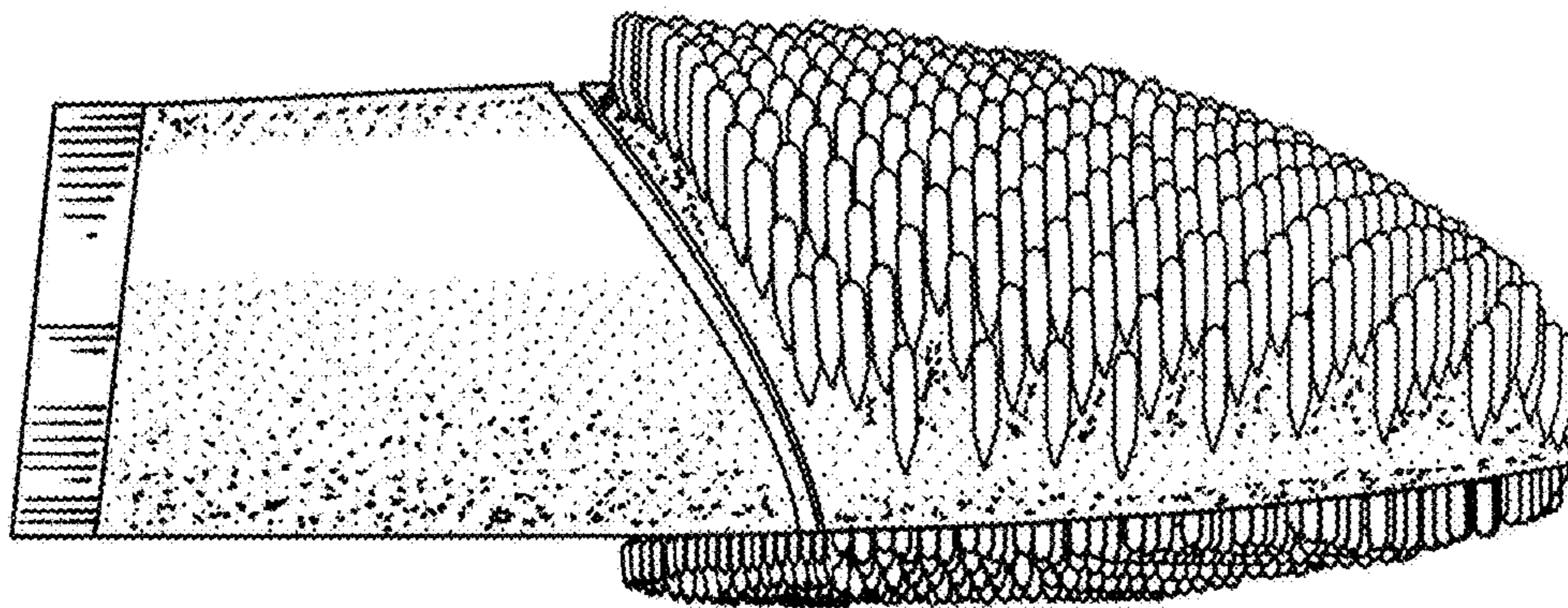

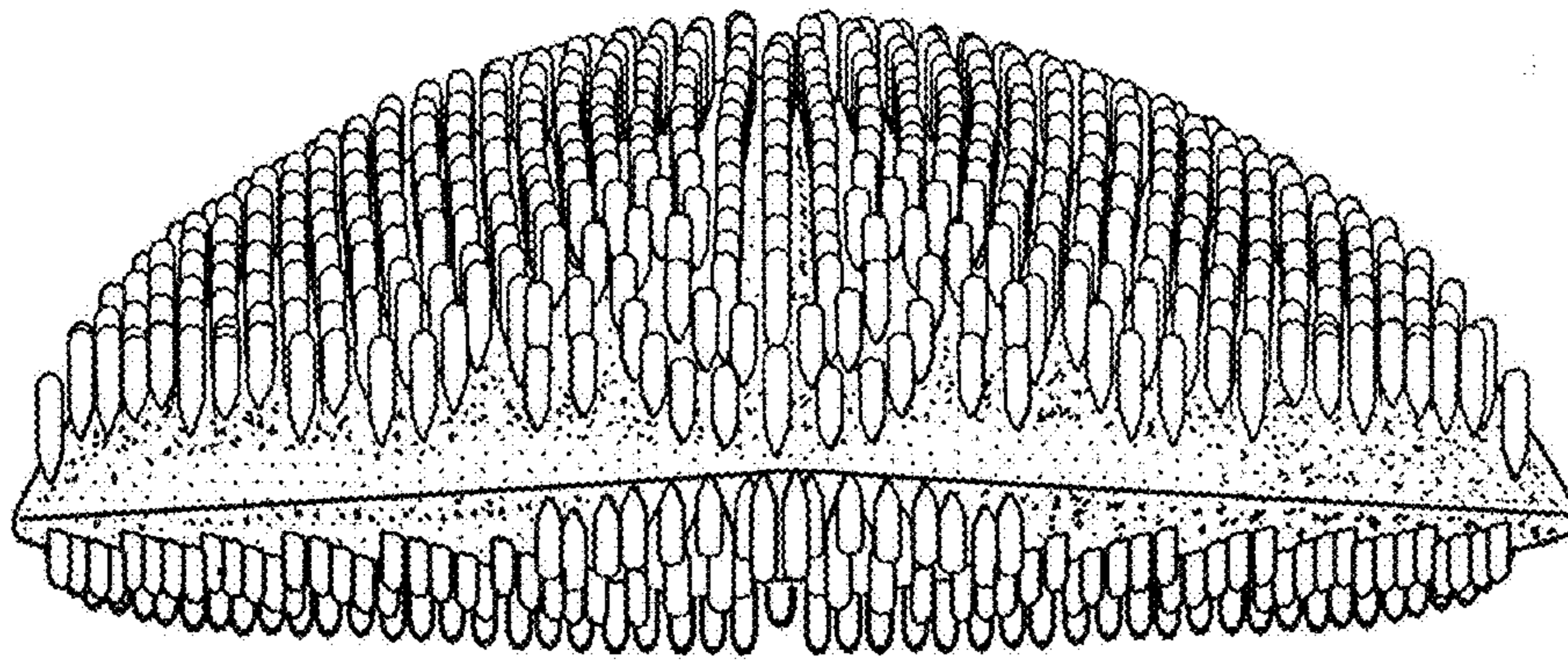

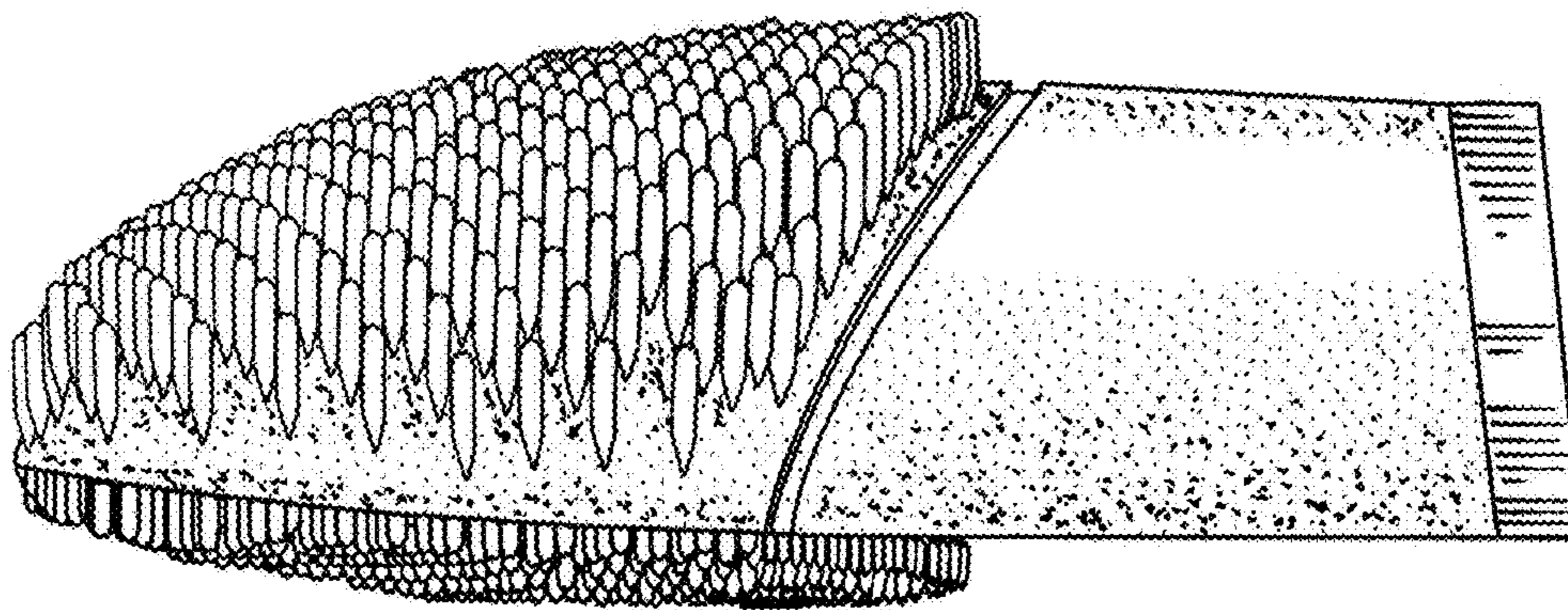

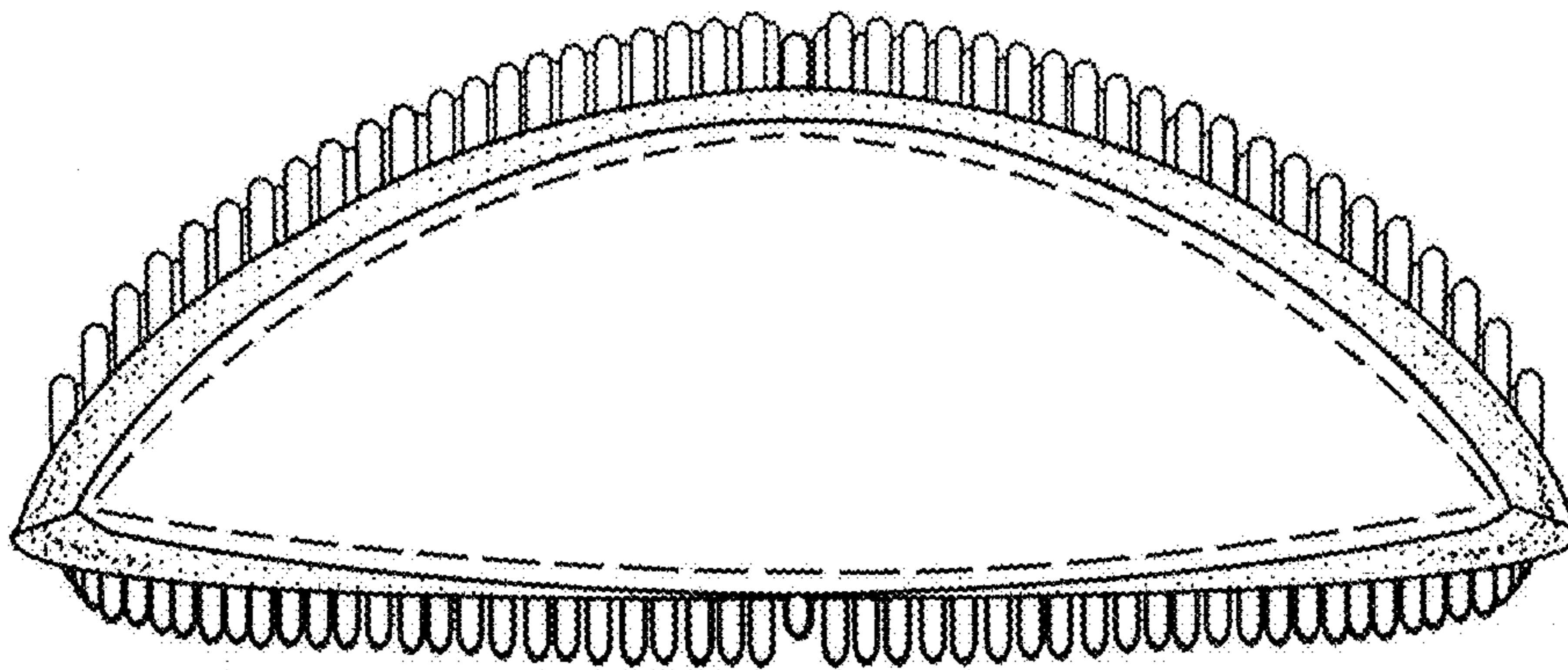

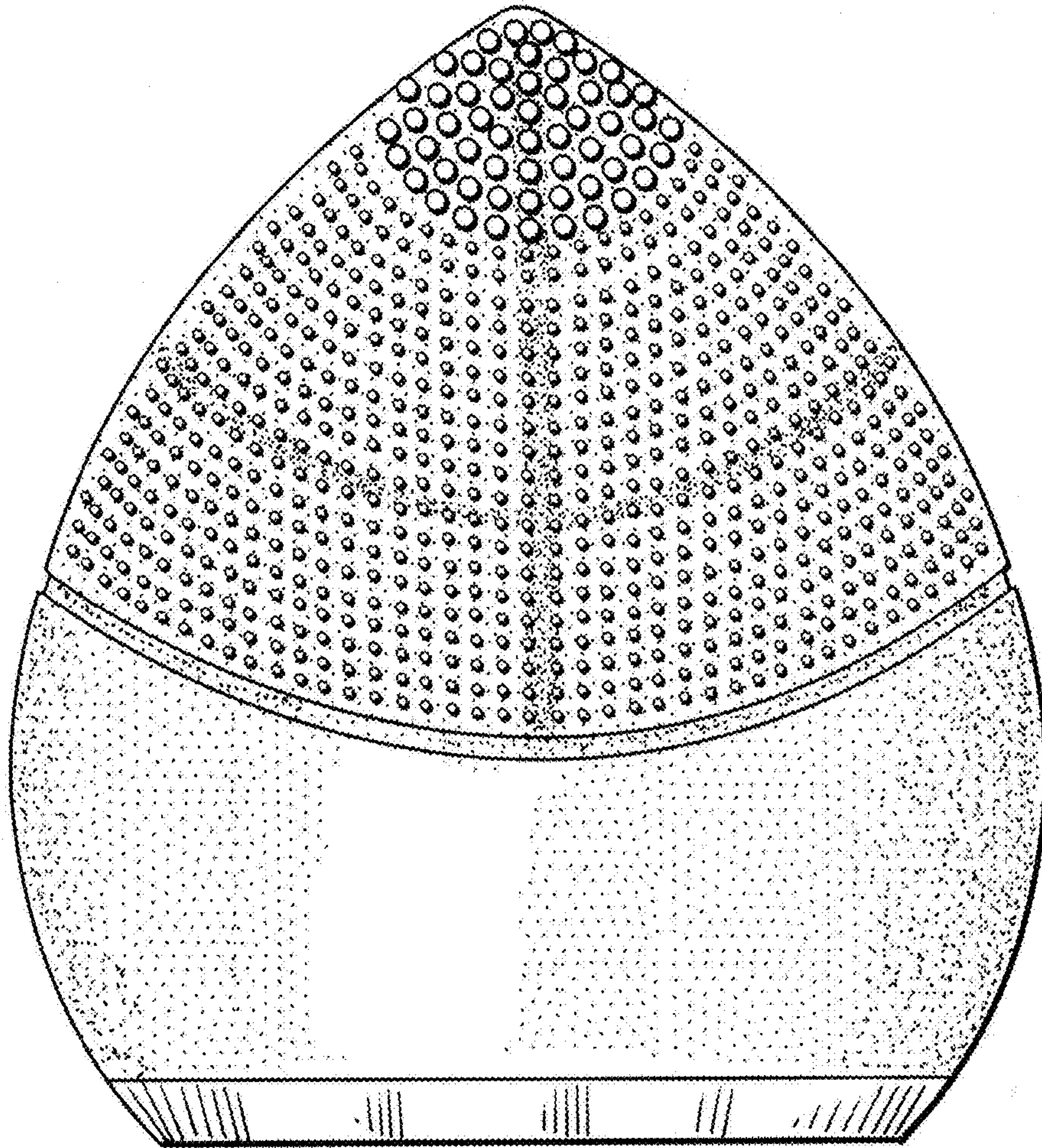
