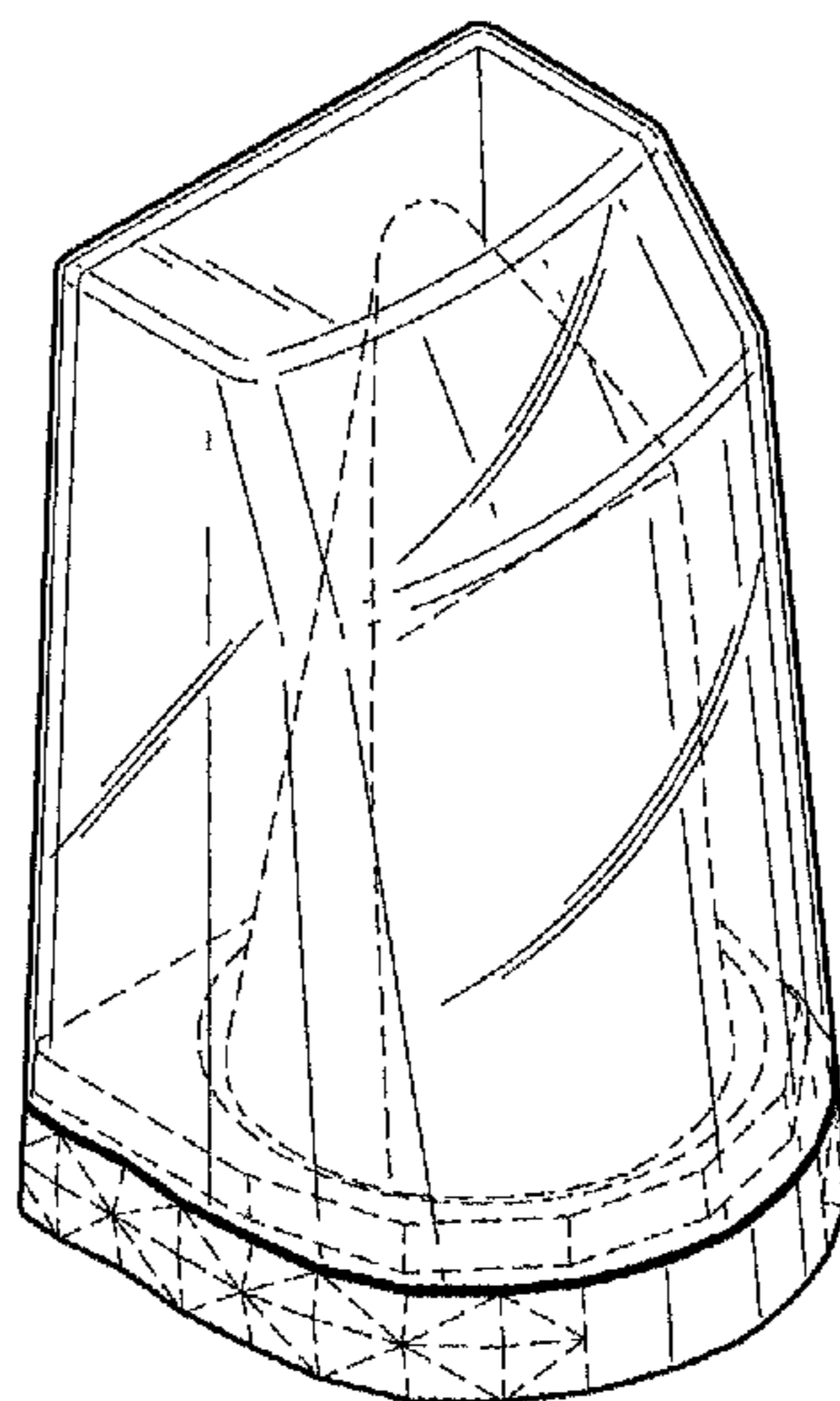
(57) **CLAIM**

The ornamental design for a cosmetic sponge case, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a cosmetic sponge case. FIG. 2 is a front view of the cosmetic sponge case shown in FIG. 1. FIG. 3 is a side view of the cosmetic sponge case shown in FIG. 1. FIG. 4 is a rear view of the cosmetic sponge case shown in FIG. 1. FIG. 5 is a top view of the cosmetic sponge case shown in FIG. 1; and, FIG. 6 is a bottom view of the cosmetic sponge case shown in FIG. 1. The dashed lines in FIGS. 1 through 6 represent features of the cosmetic sponge case which form no part of the claimed design.

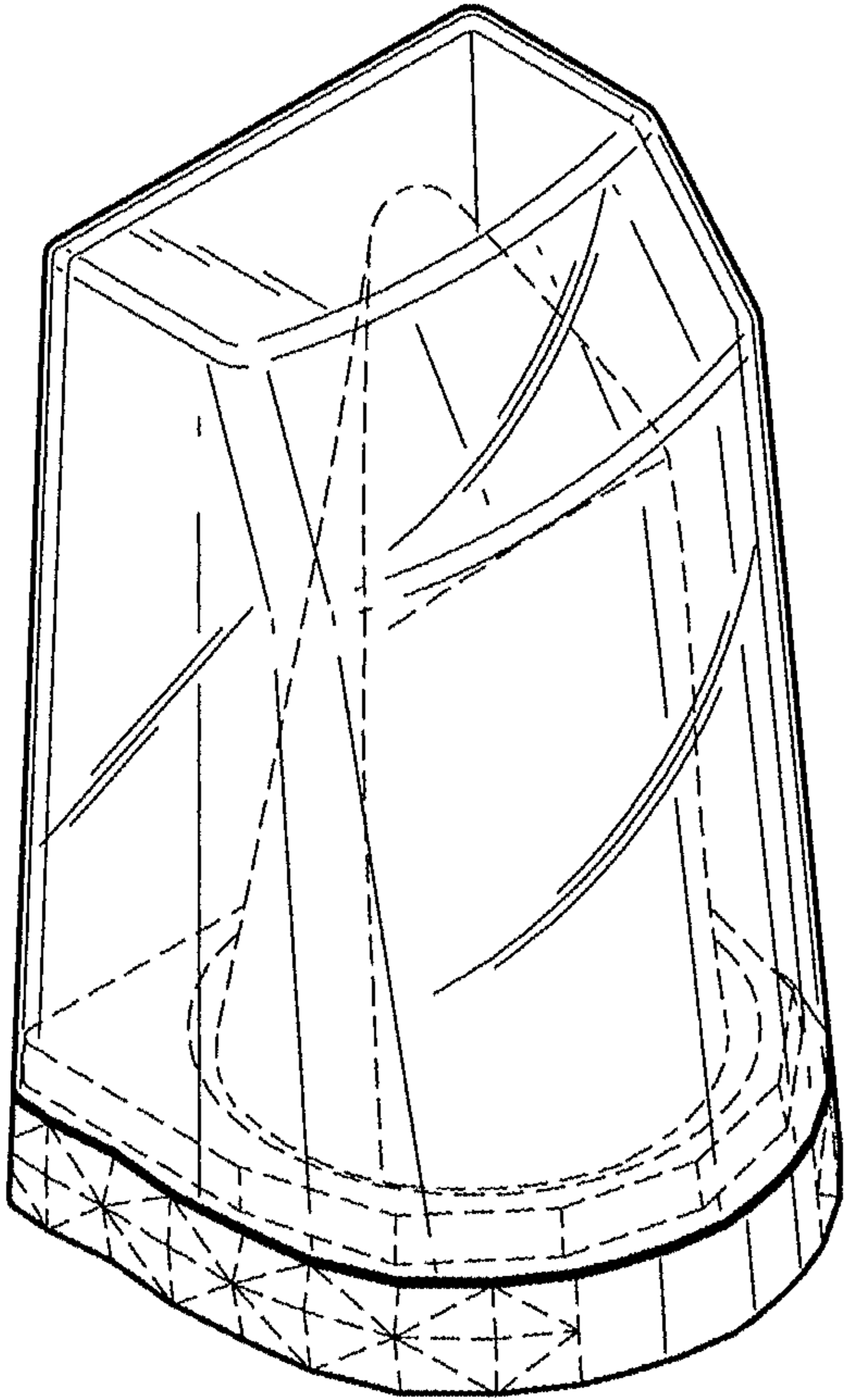

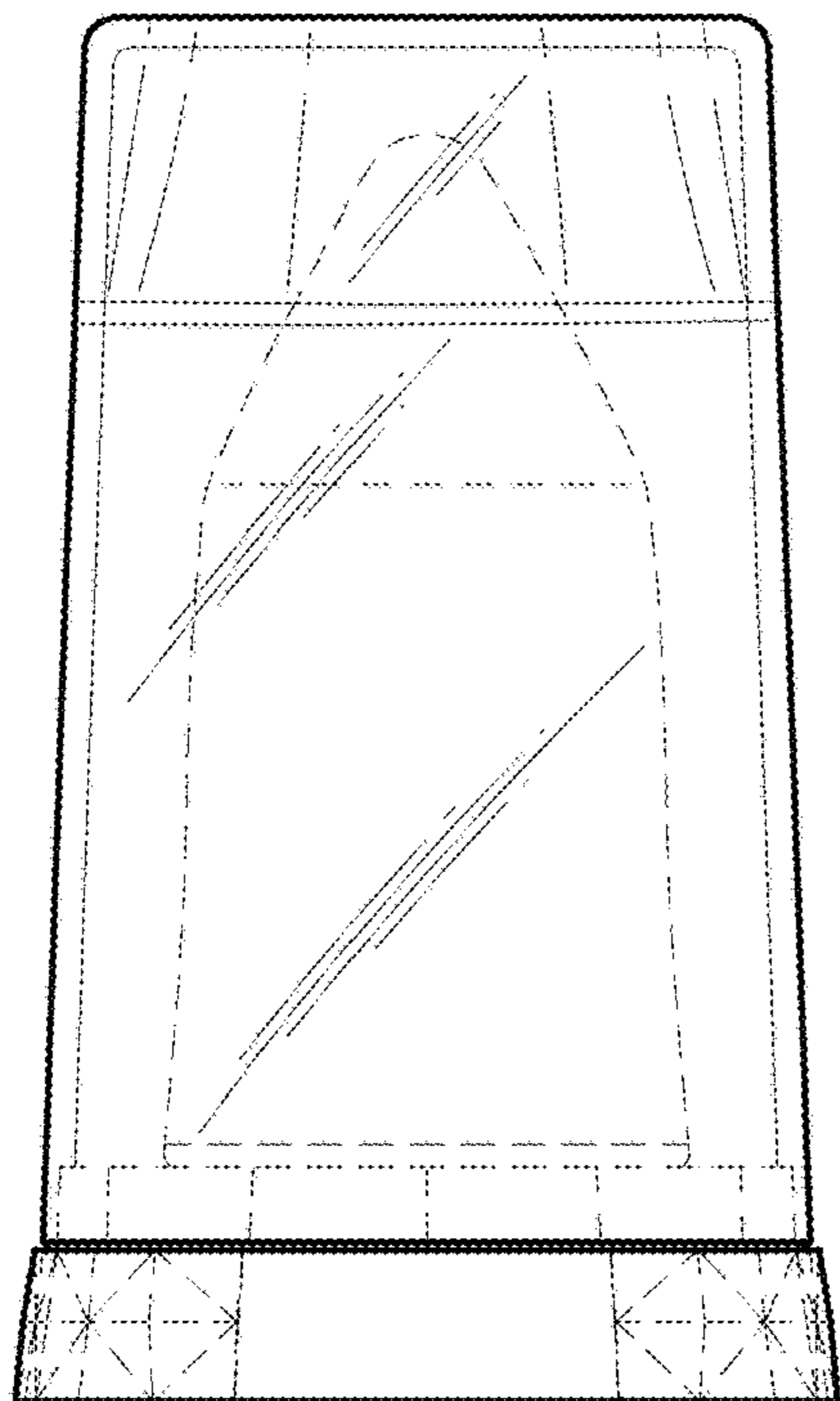

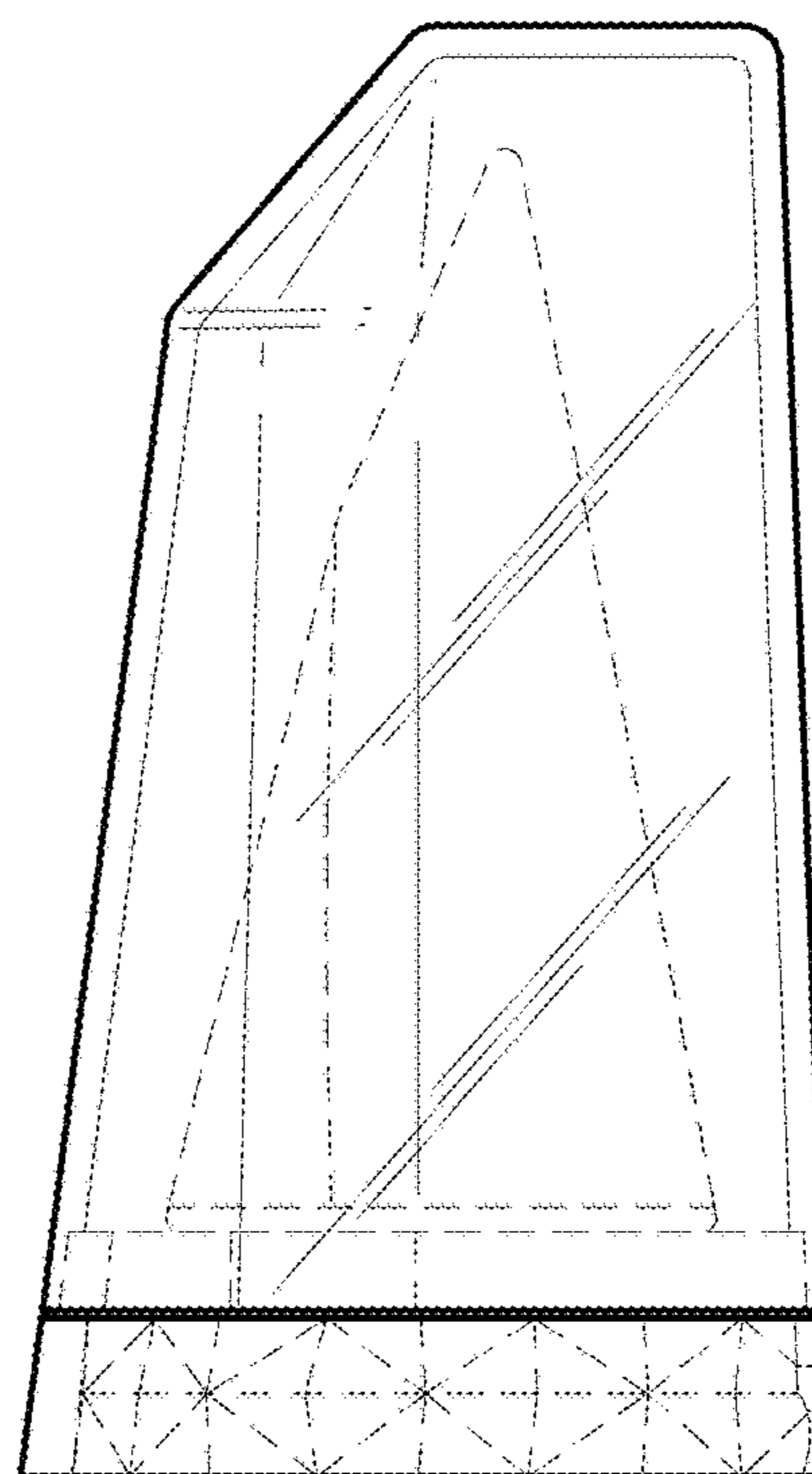

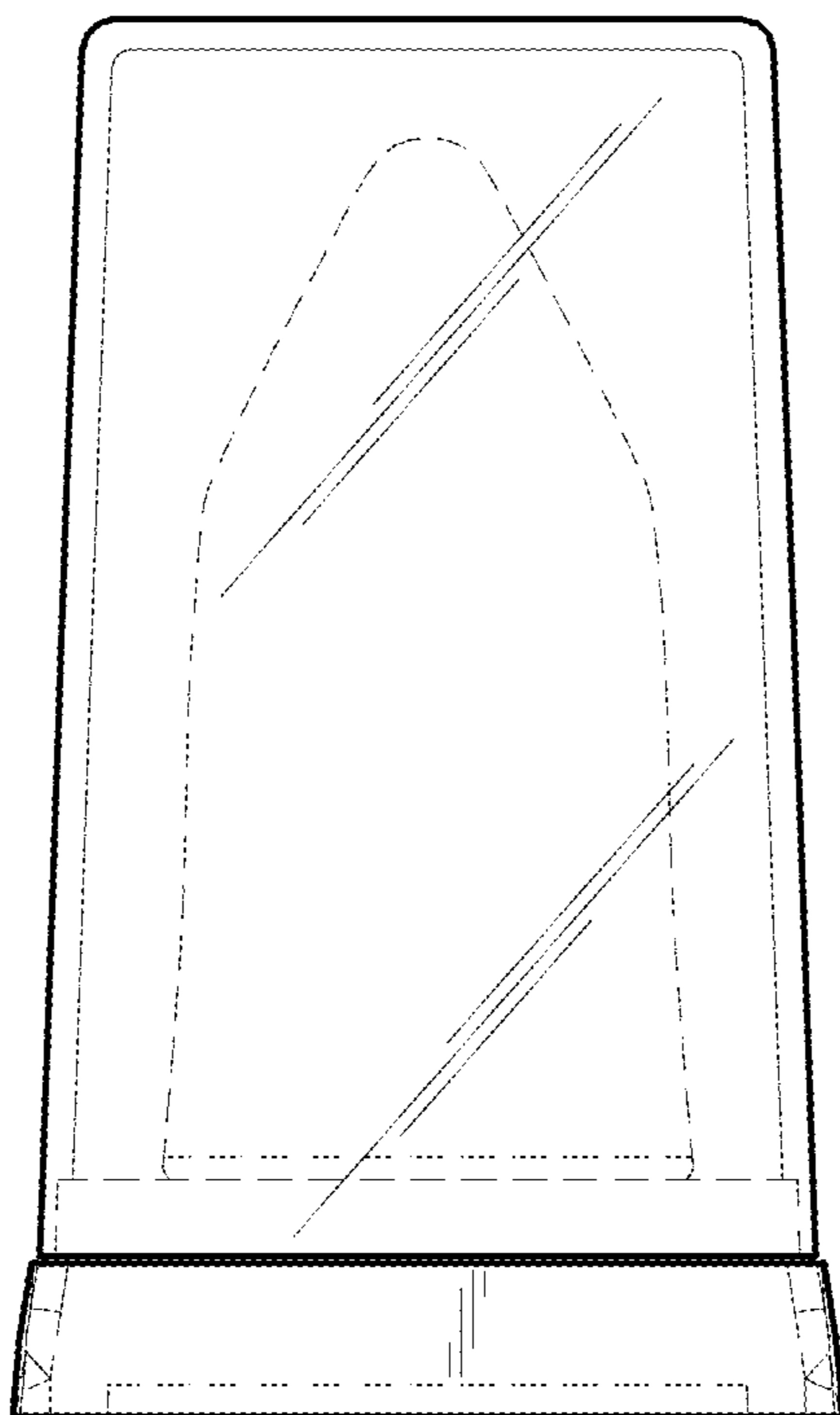

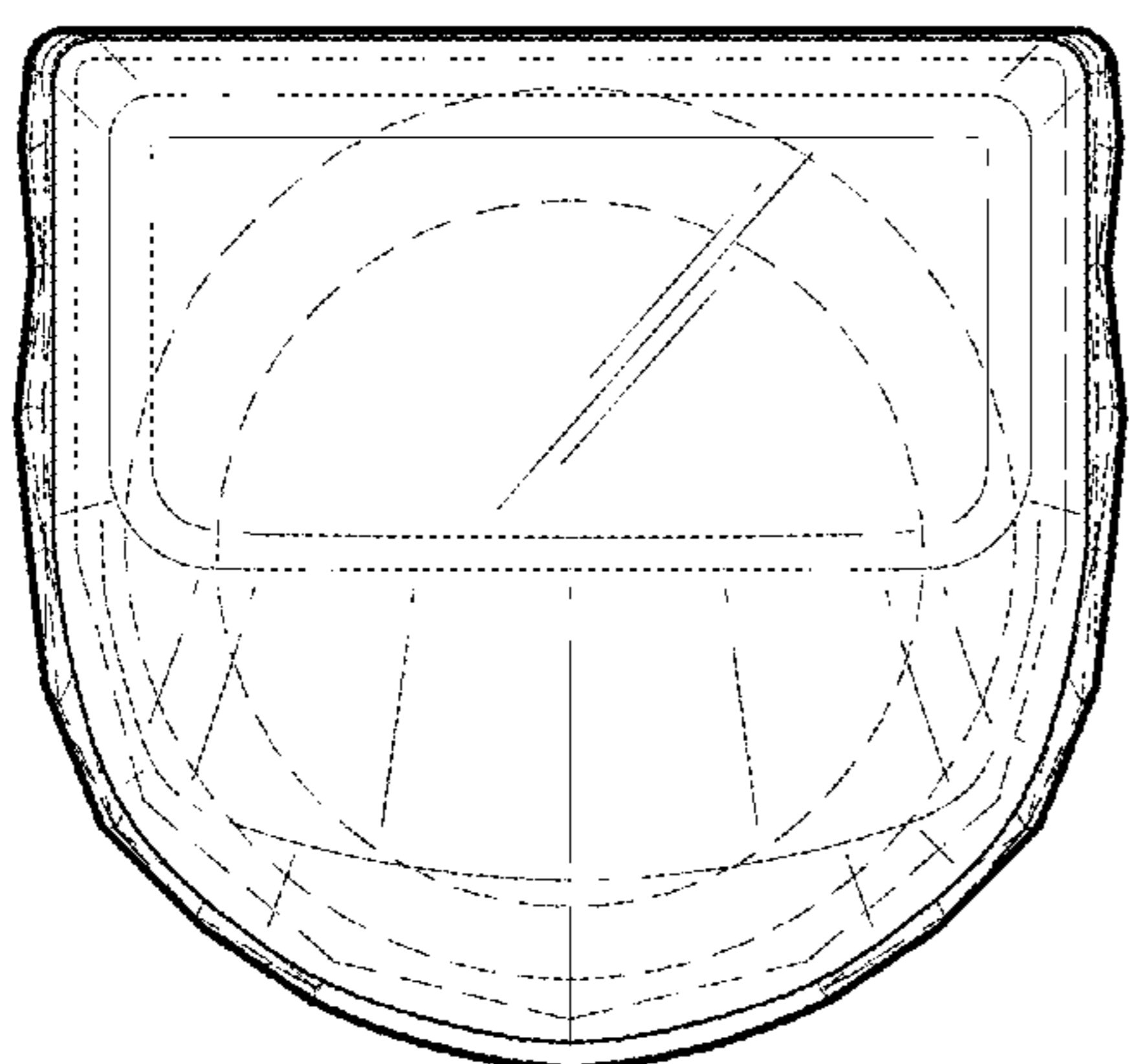

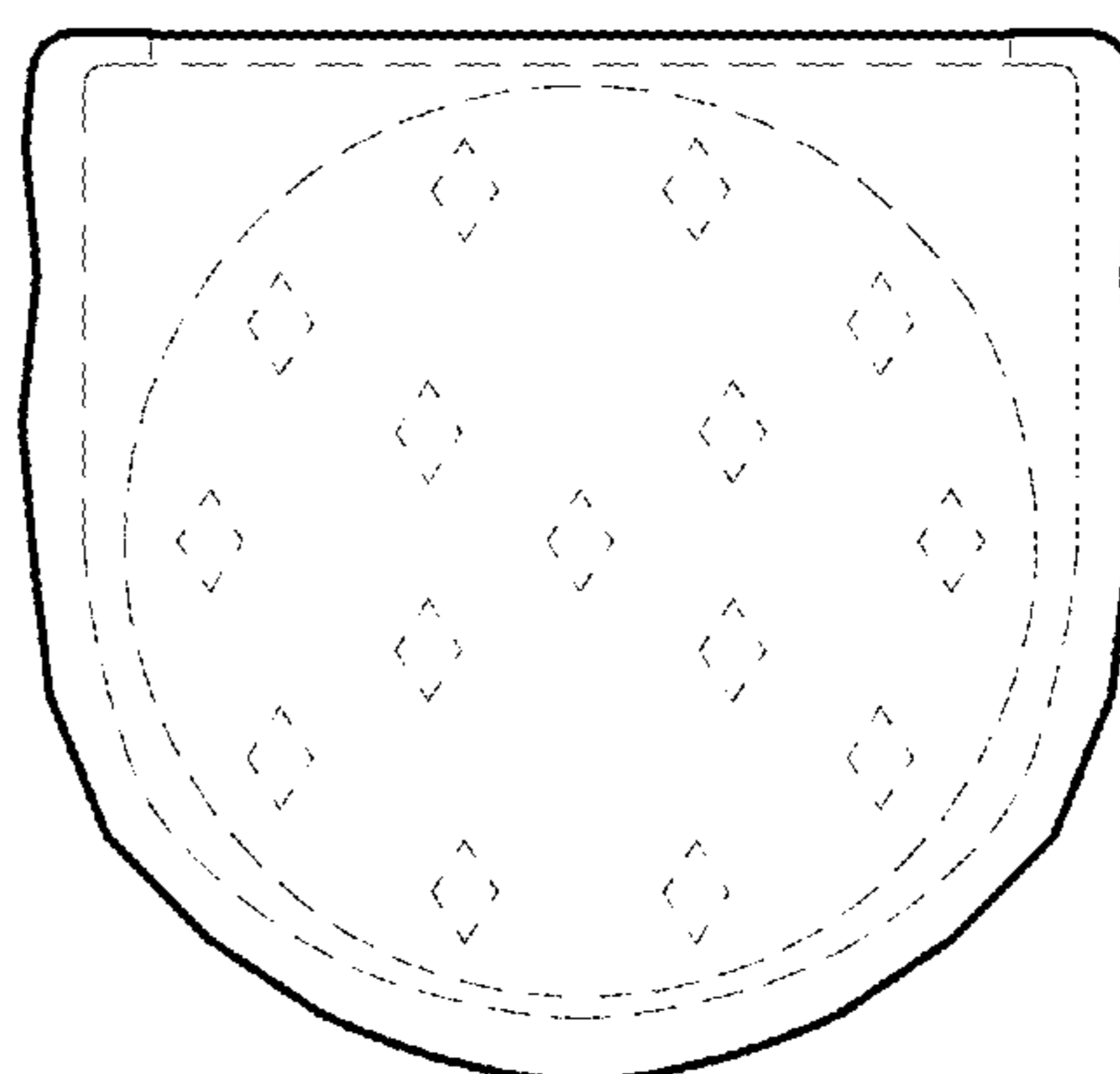
