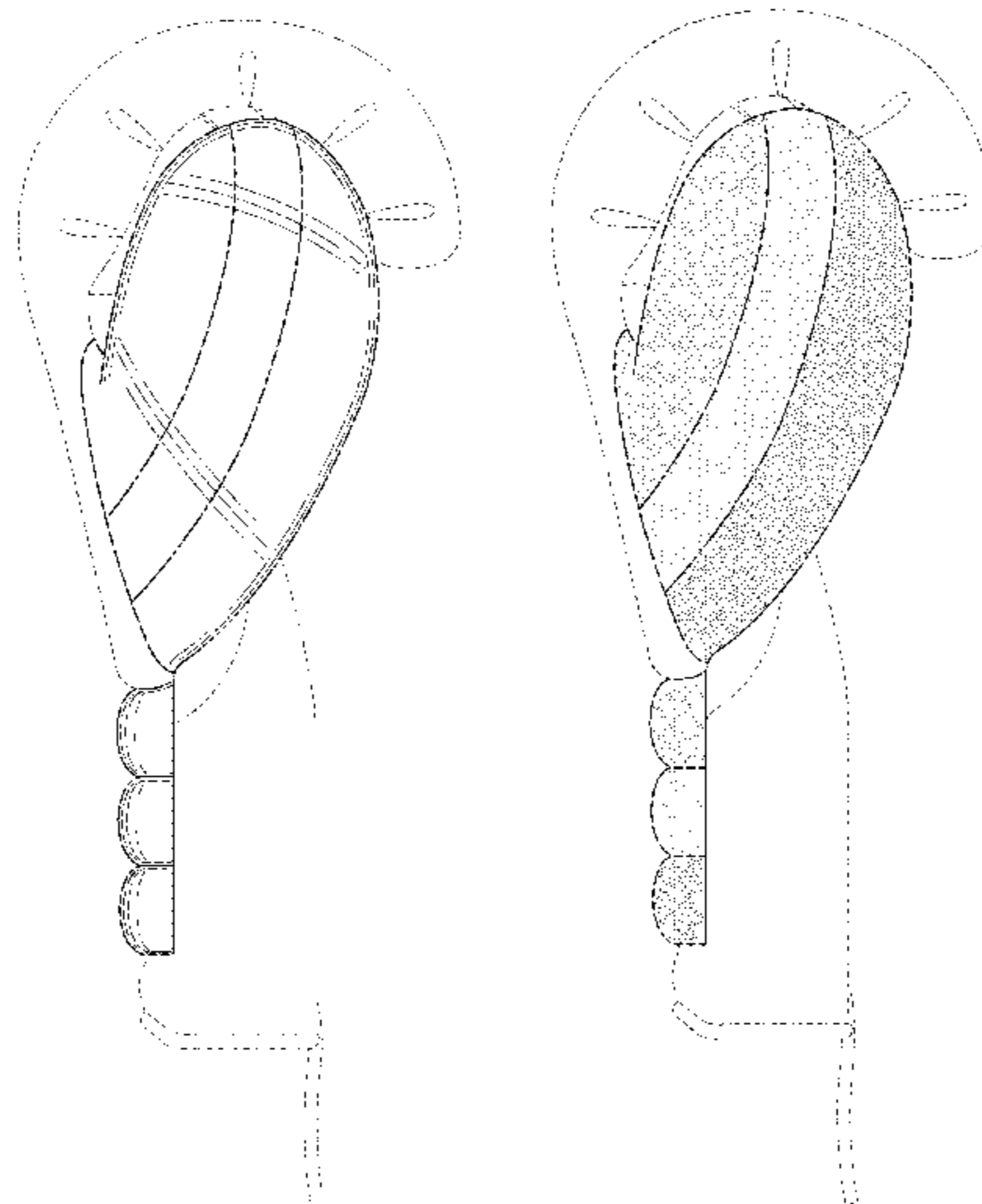
(57) **CLAIM**

The ornamental design for a boxing glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a boxing glove showing a first embodiment of my new design; FIG. 2 is a bottom view thereof; FIG. 3 is a top view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a front plan view thereof; FIG. 7 is a back plan view thereof; and FIG. 8 is a perspective view of a second embodiment of a boxing glove showing my new design; FIG. 9 is a bottom view thereof; FIG. 10 is a top view thereof; FIG. 11 is a left side view thereof; FIG. 12 is a right side view thereof; FIG. 13 is a front plan view thereof; and, FIG. 14 is a back plan view thereof. The broken lines depict portions of the boxing glove that form no part of the claimed design.

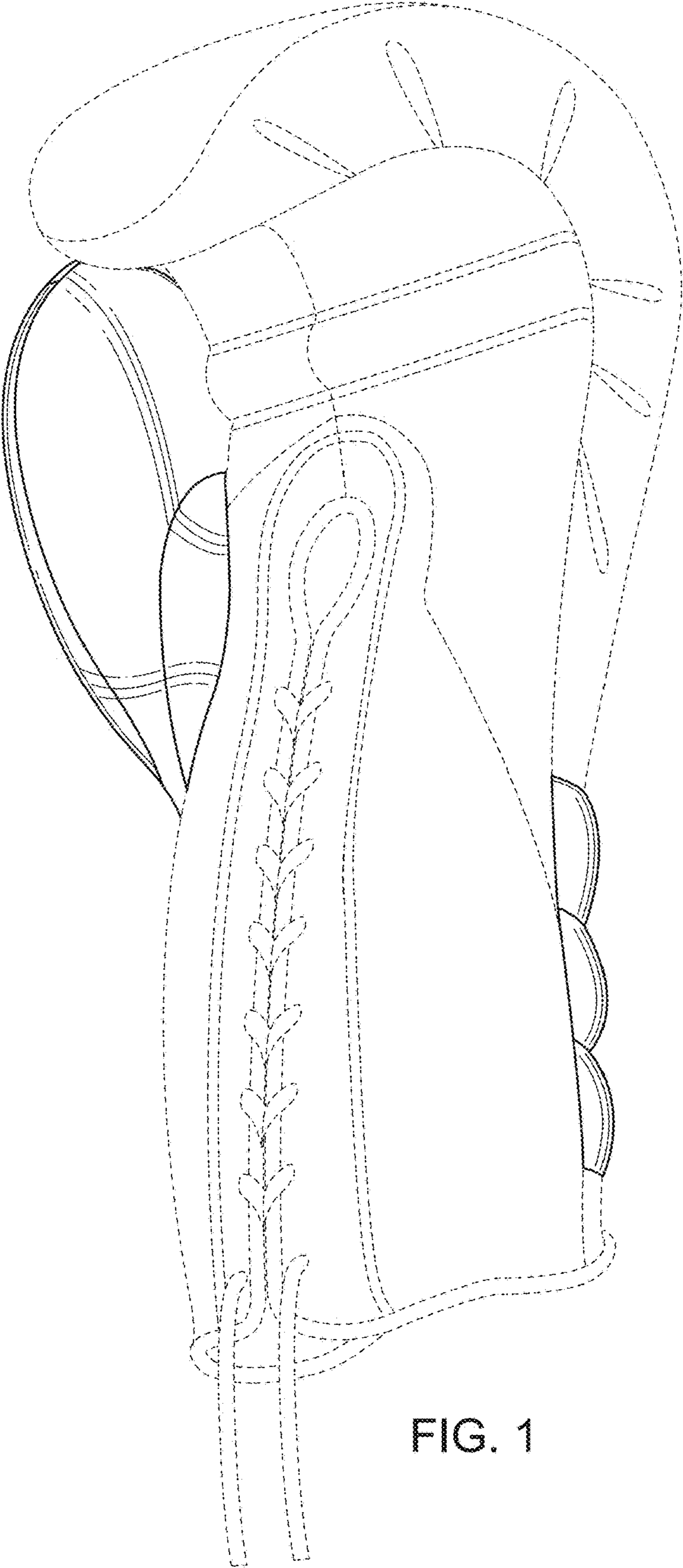

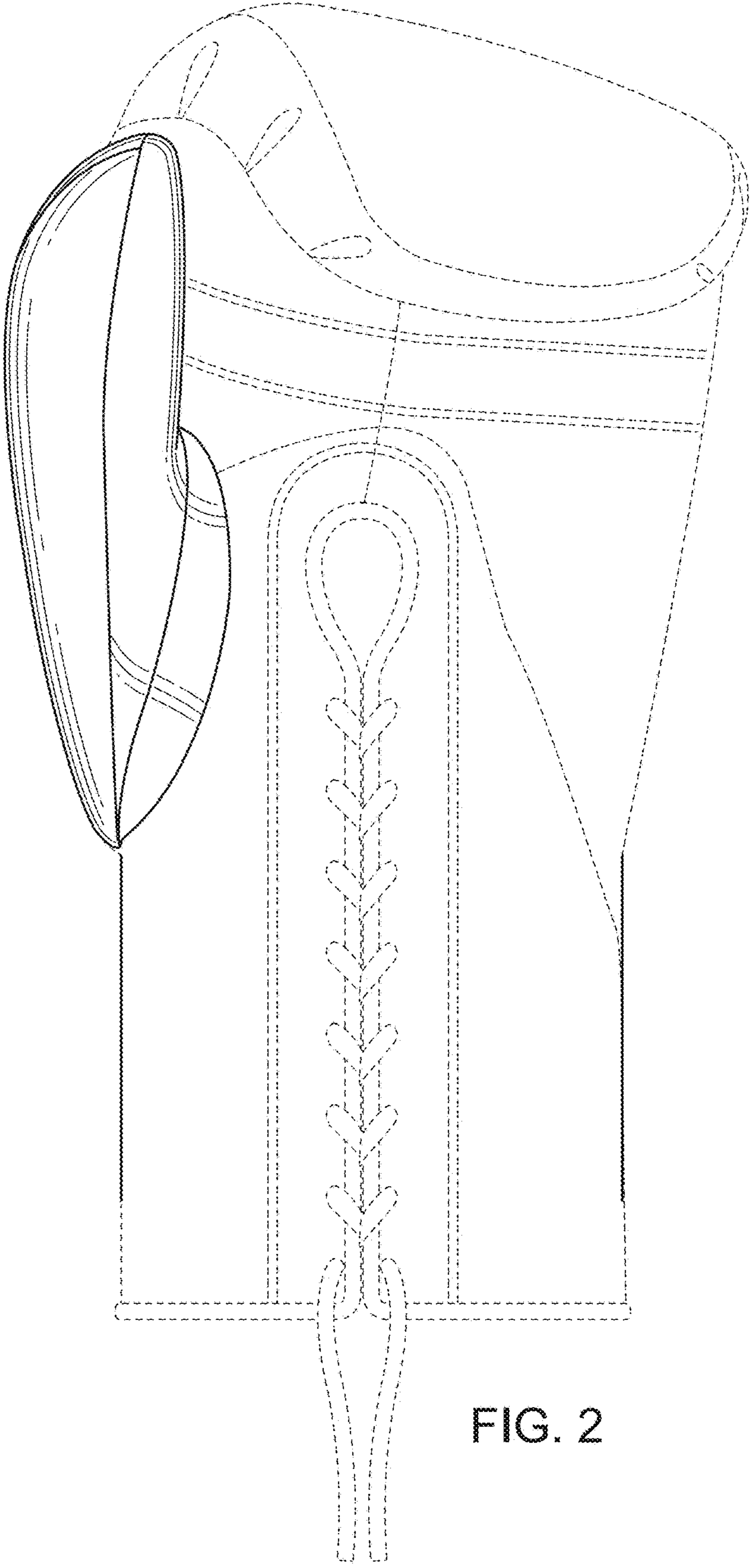

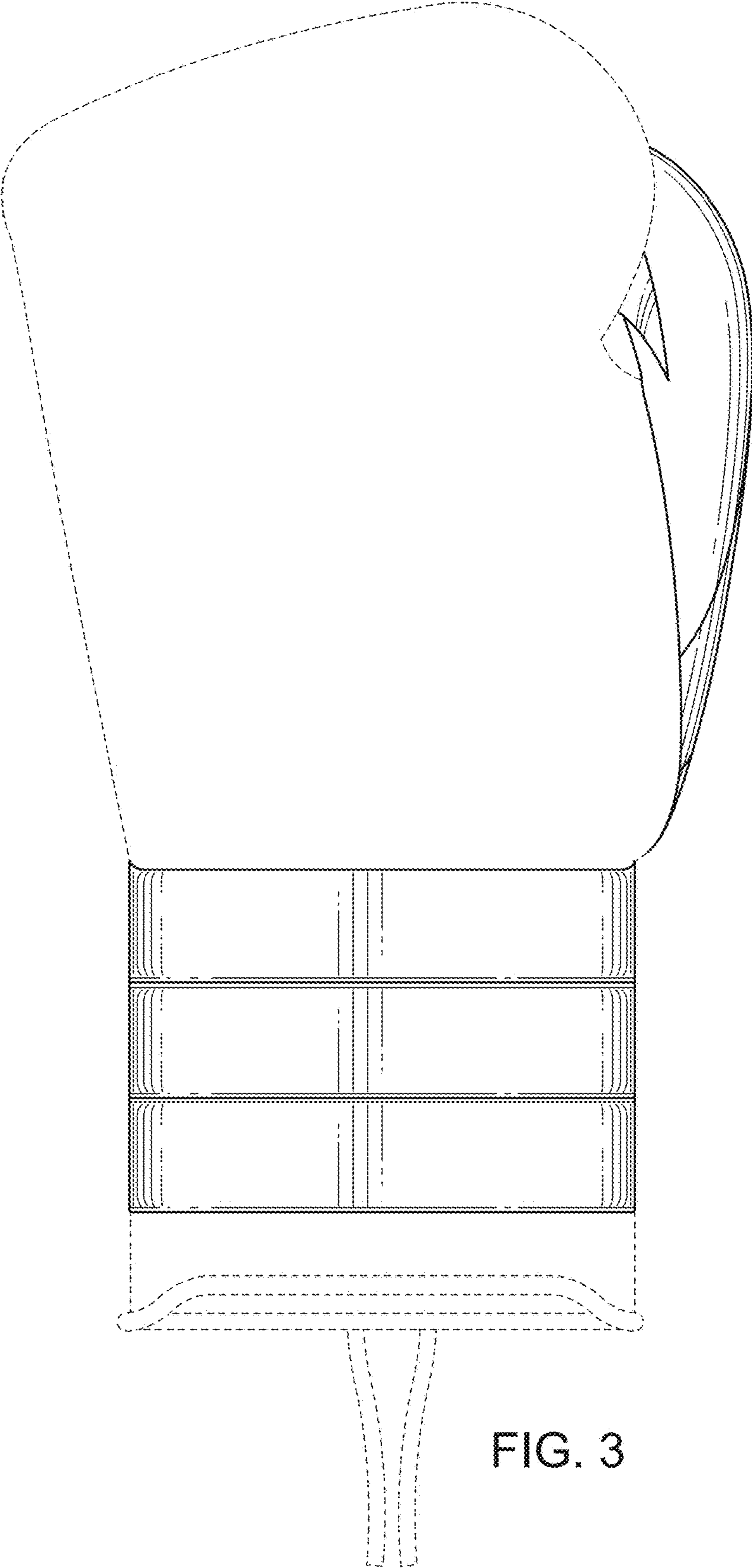

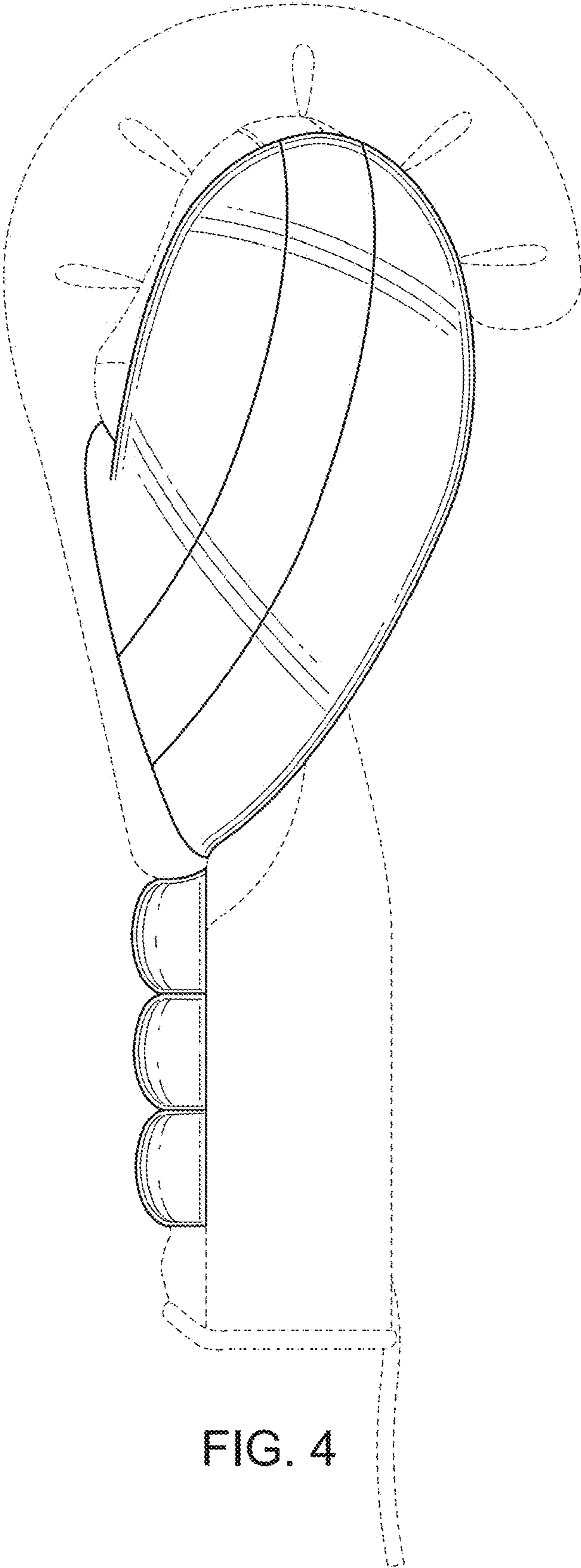

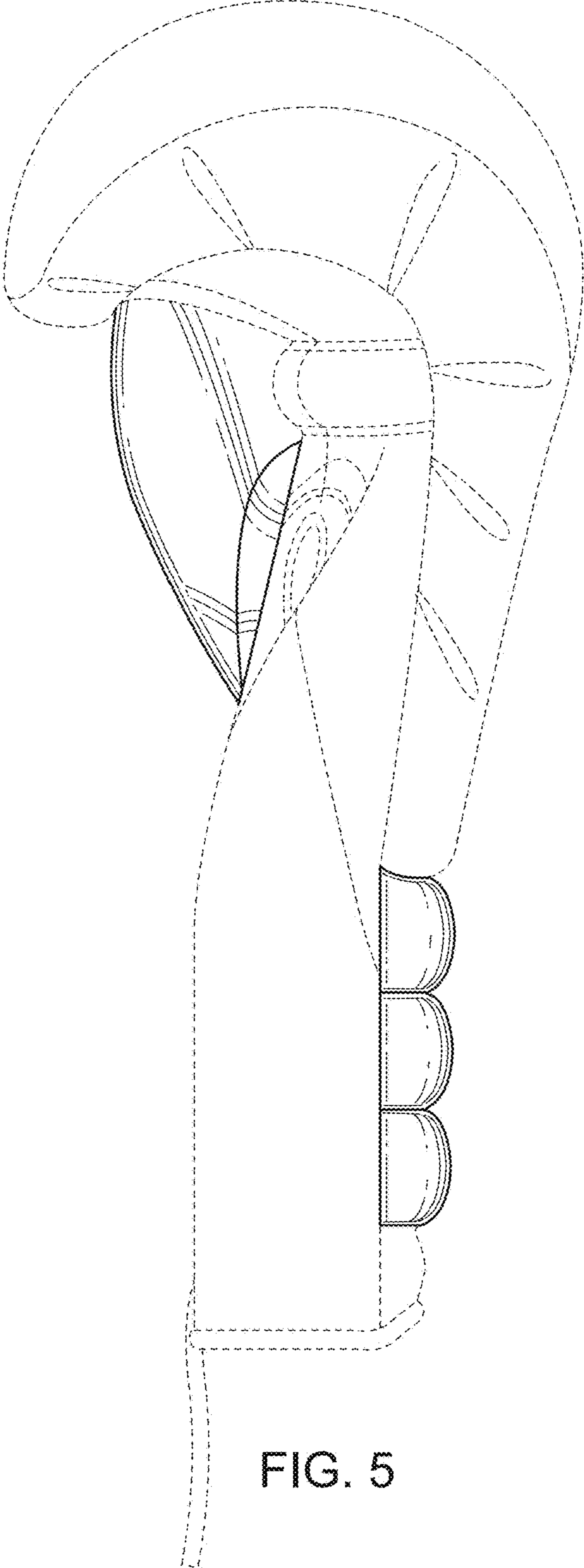

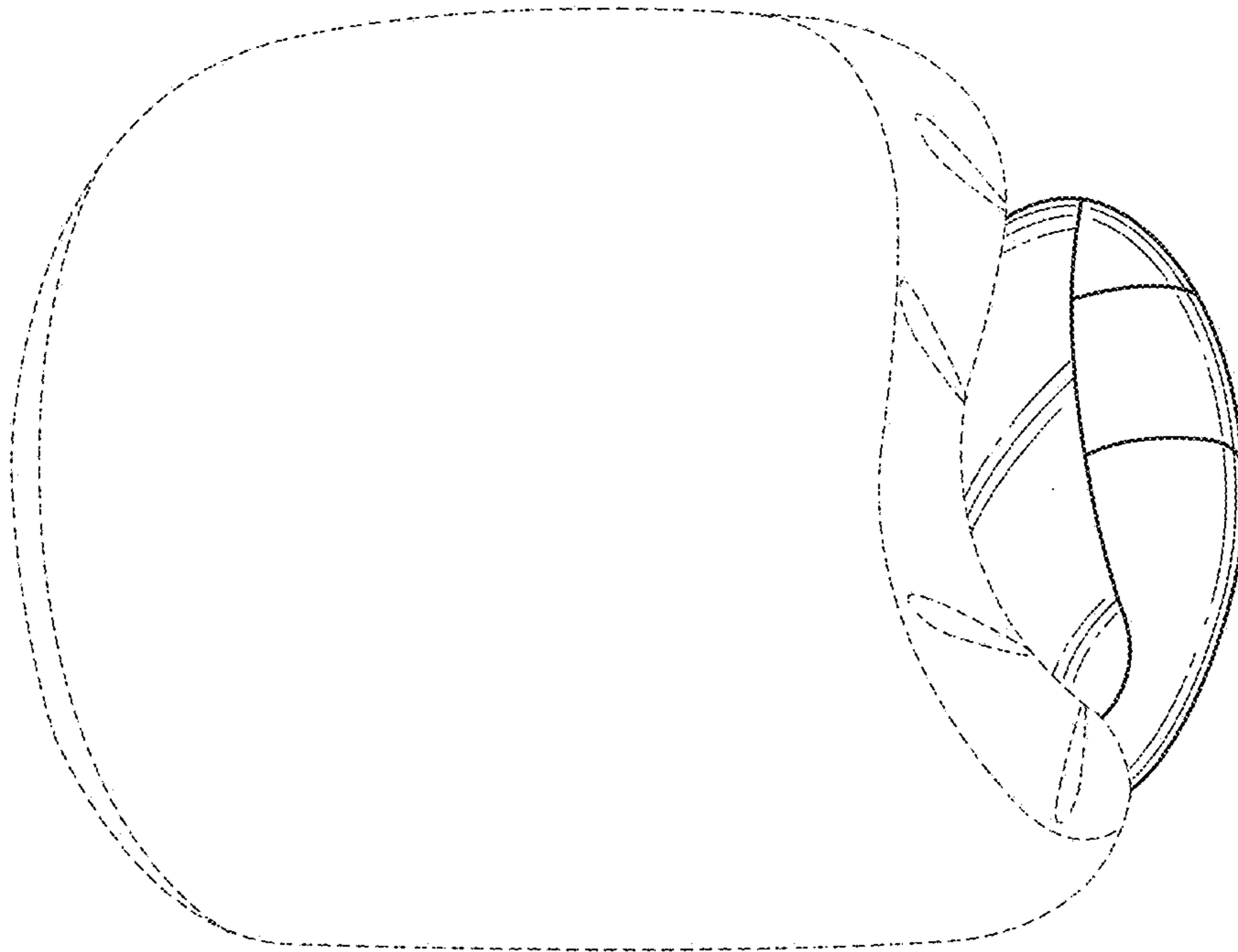

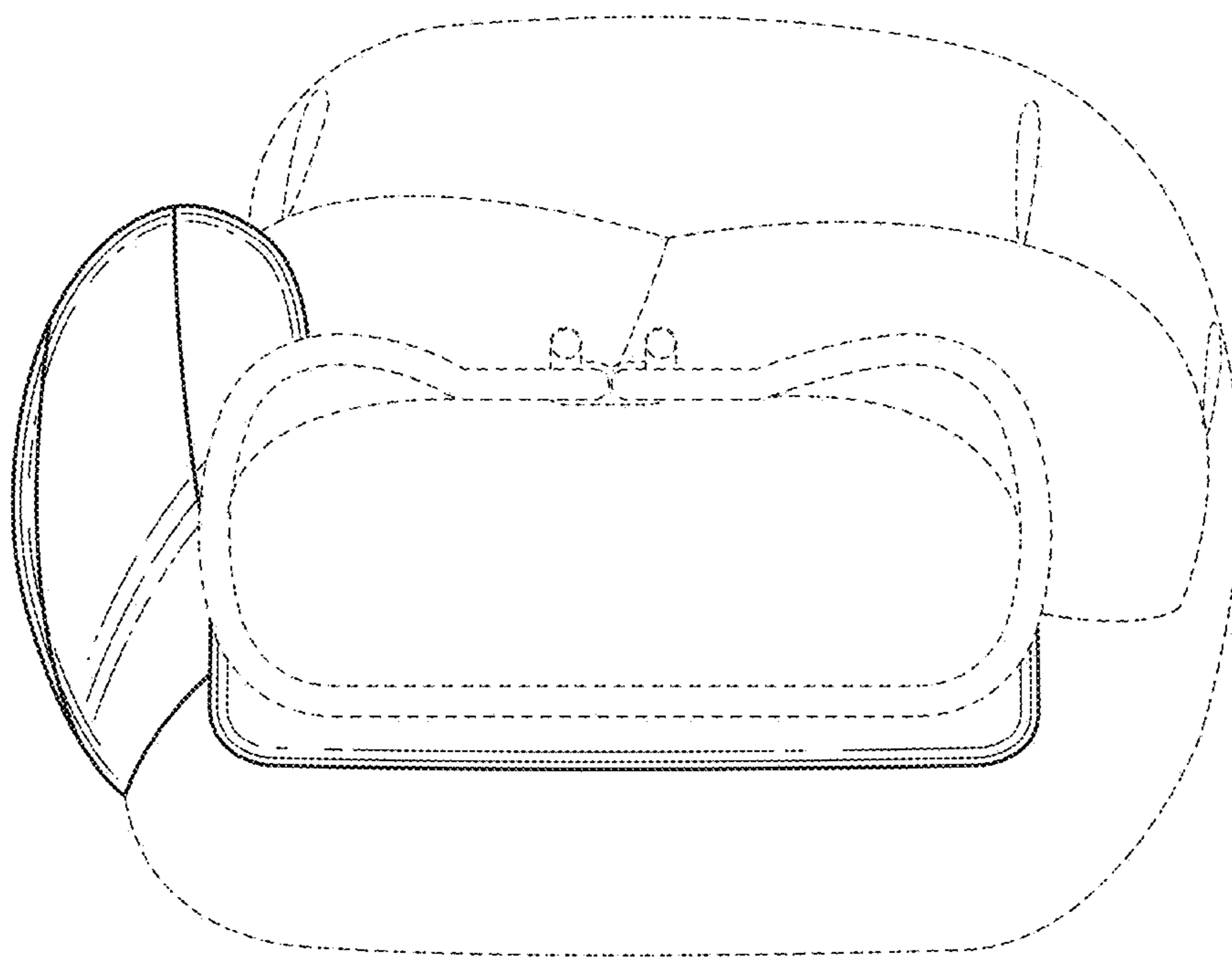

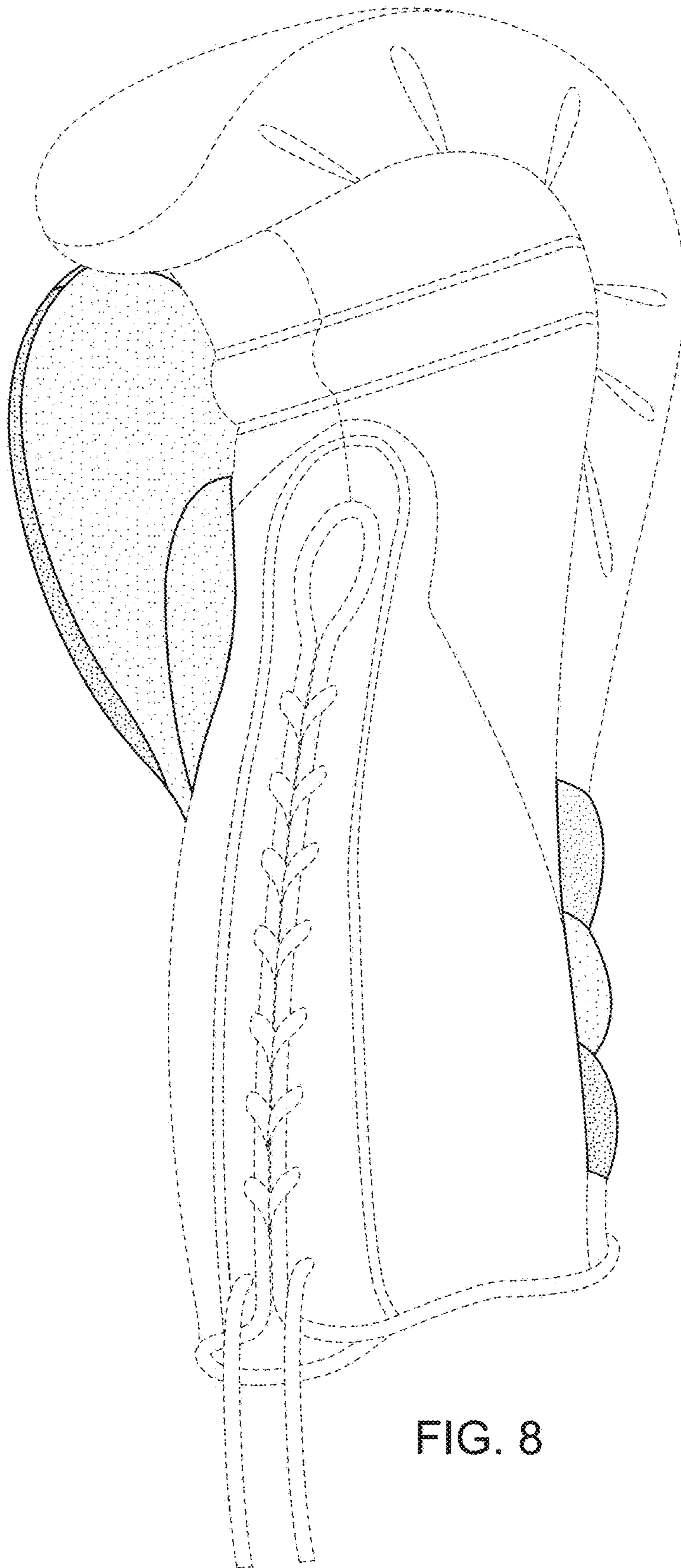

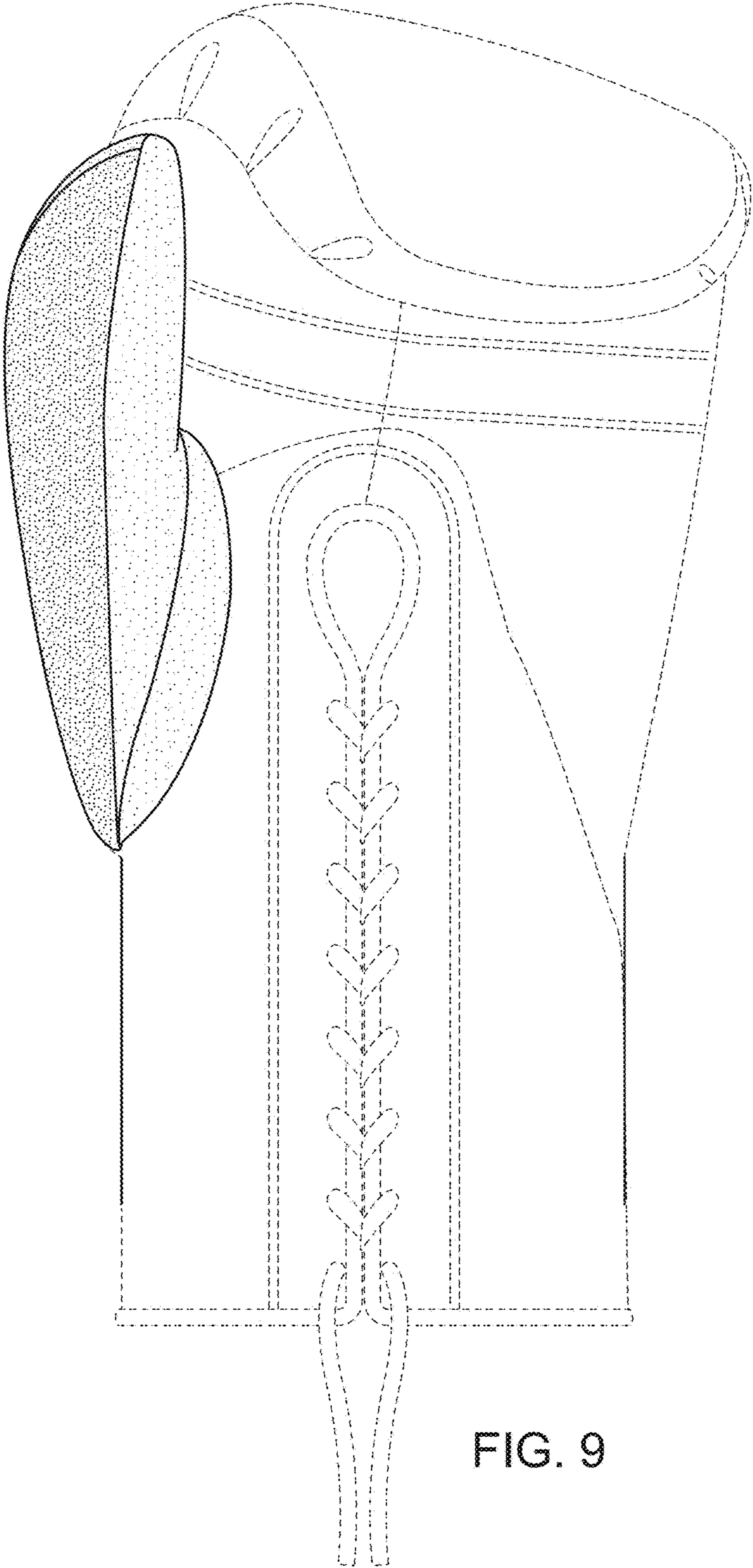

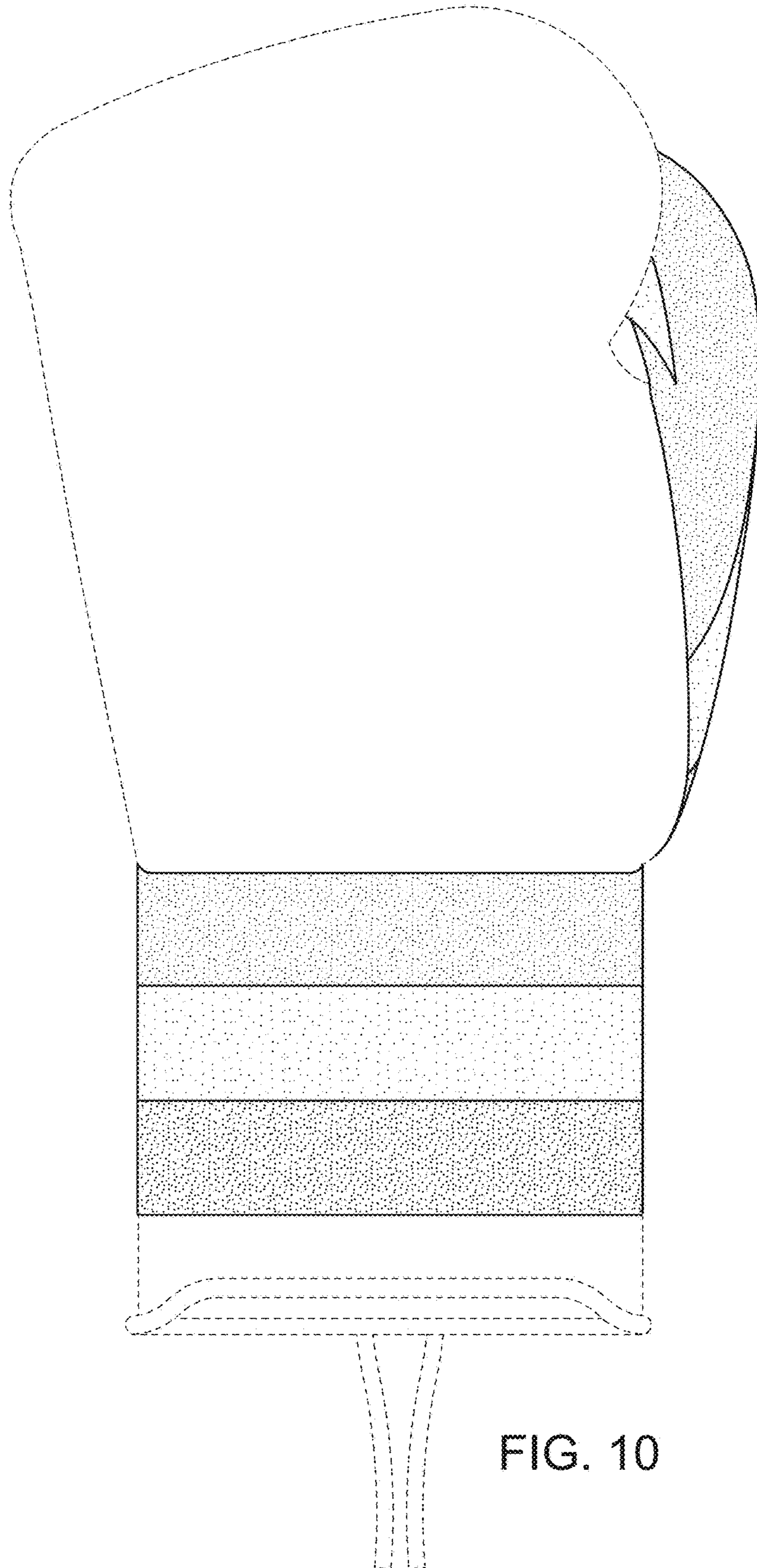

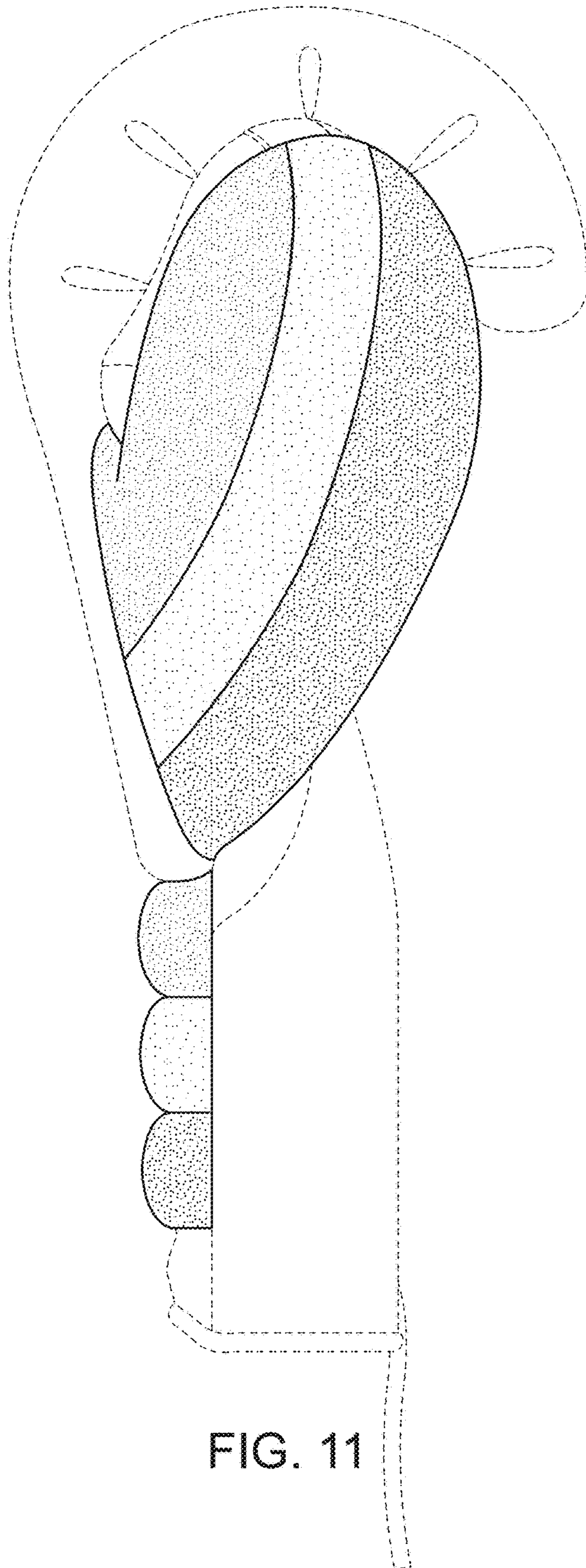

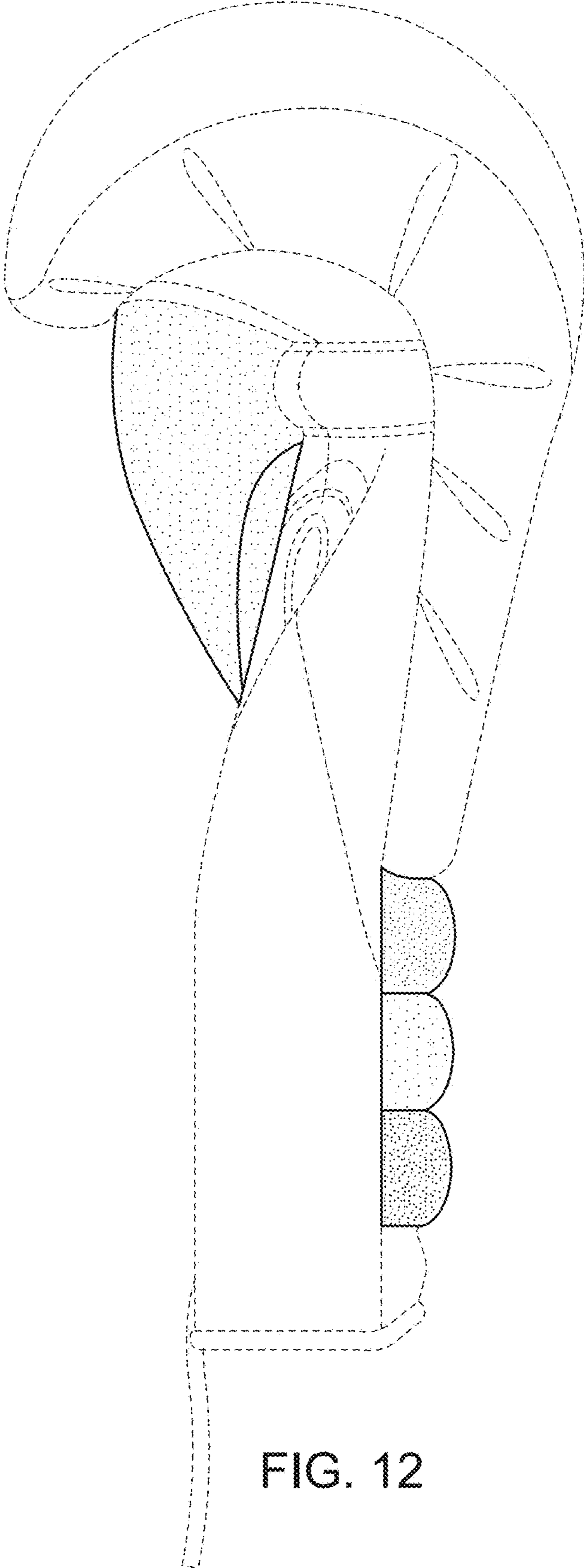

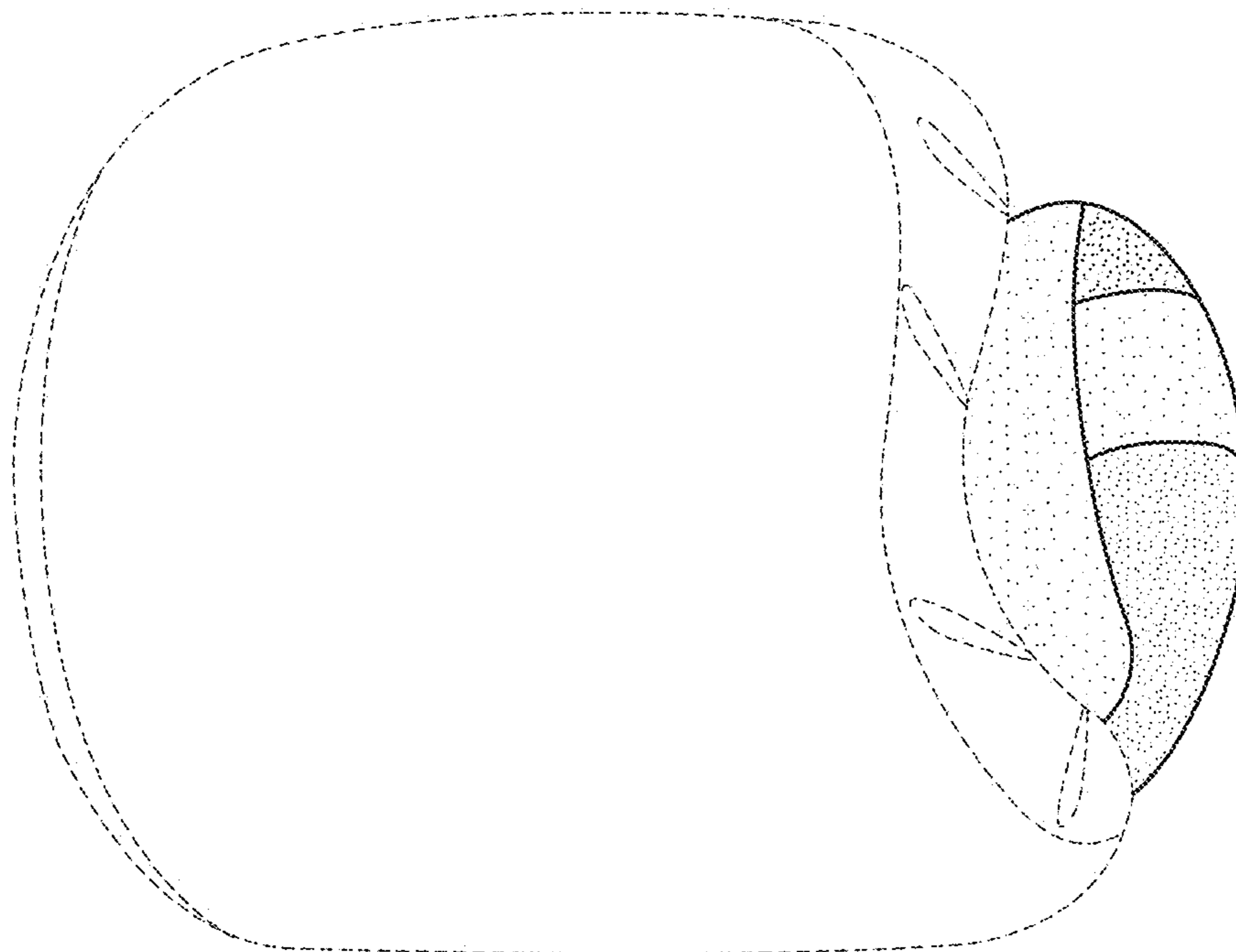

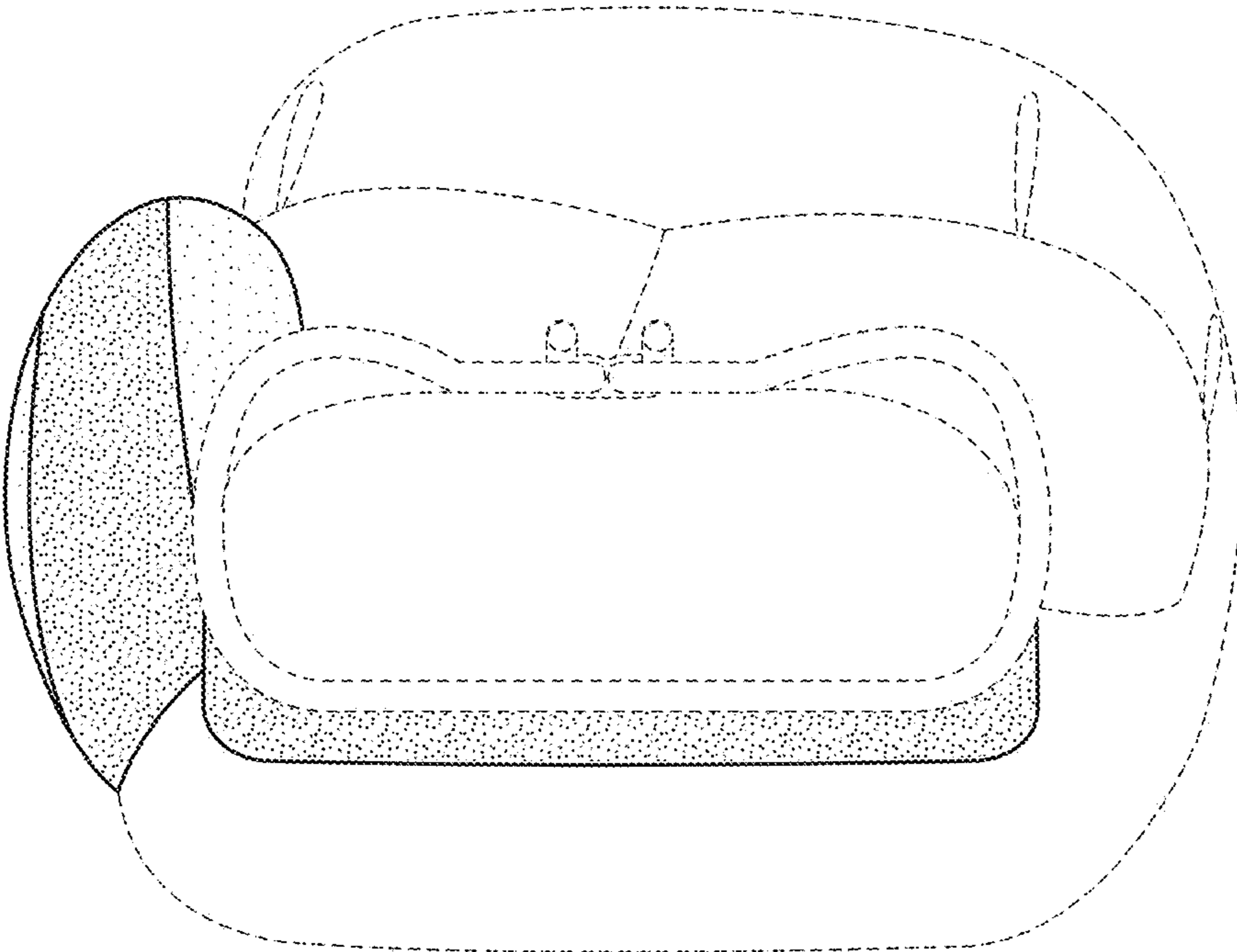
