FIG. 4 is a rear elevation thereof;

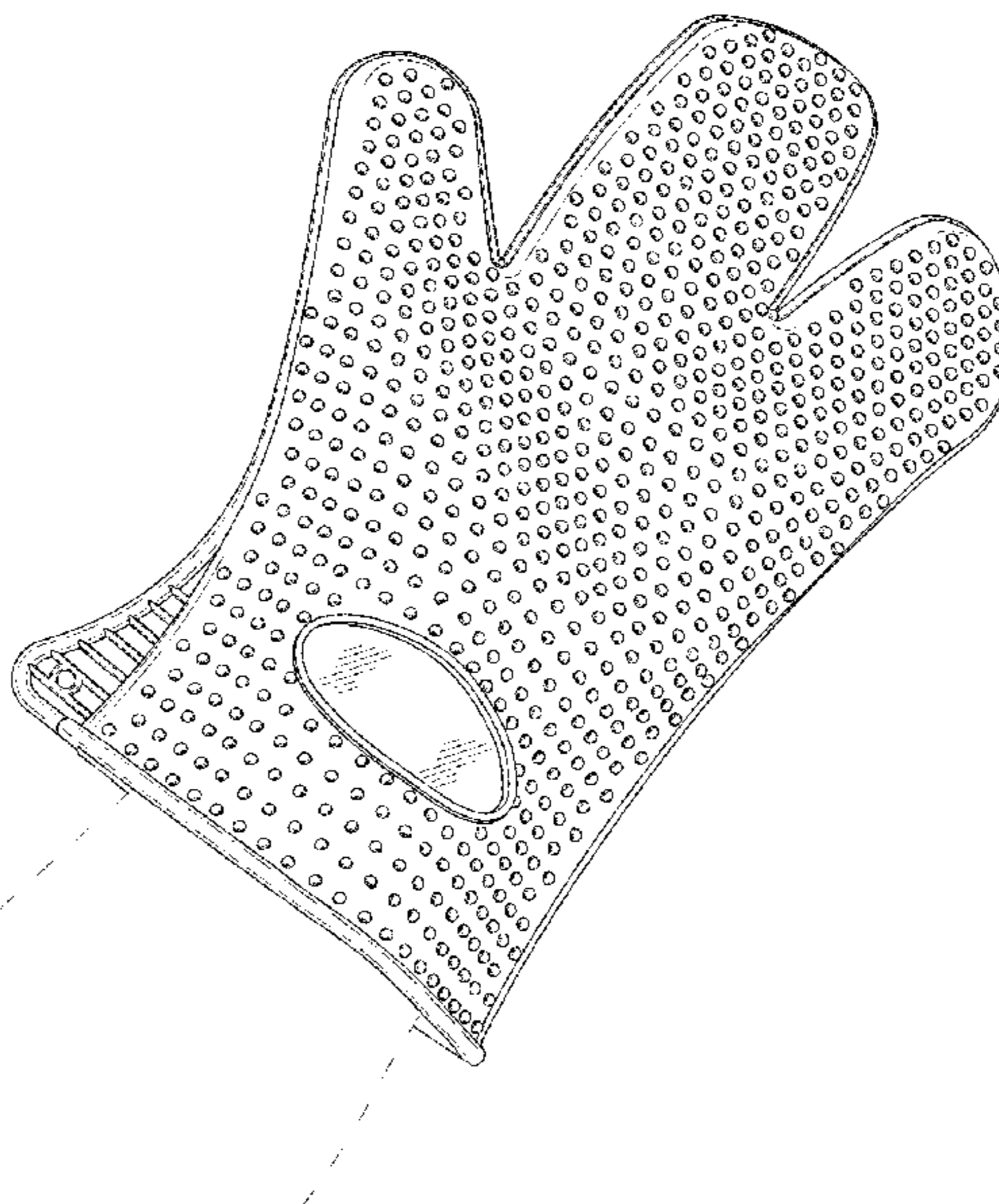
FIG. 5 is a thumb-side elevation thereof;

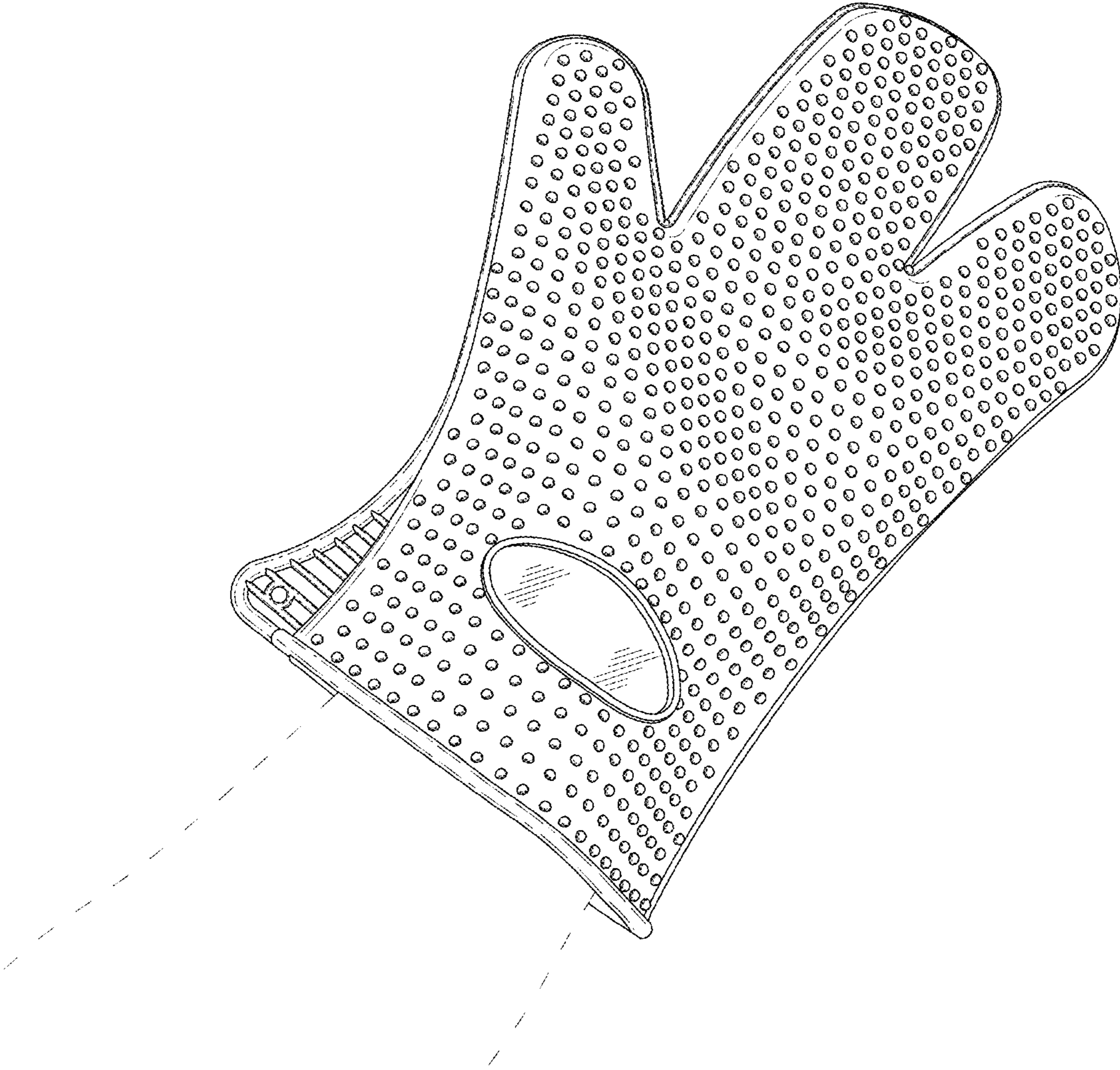

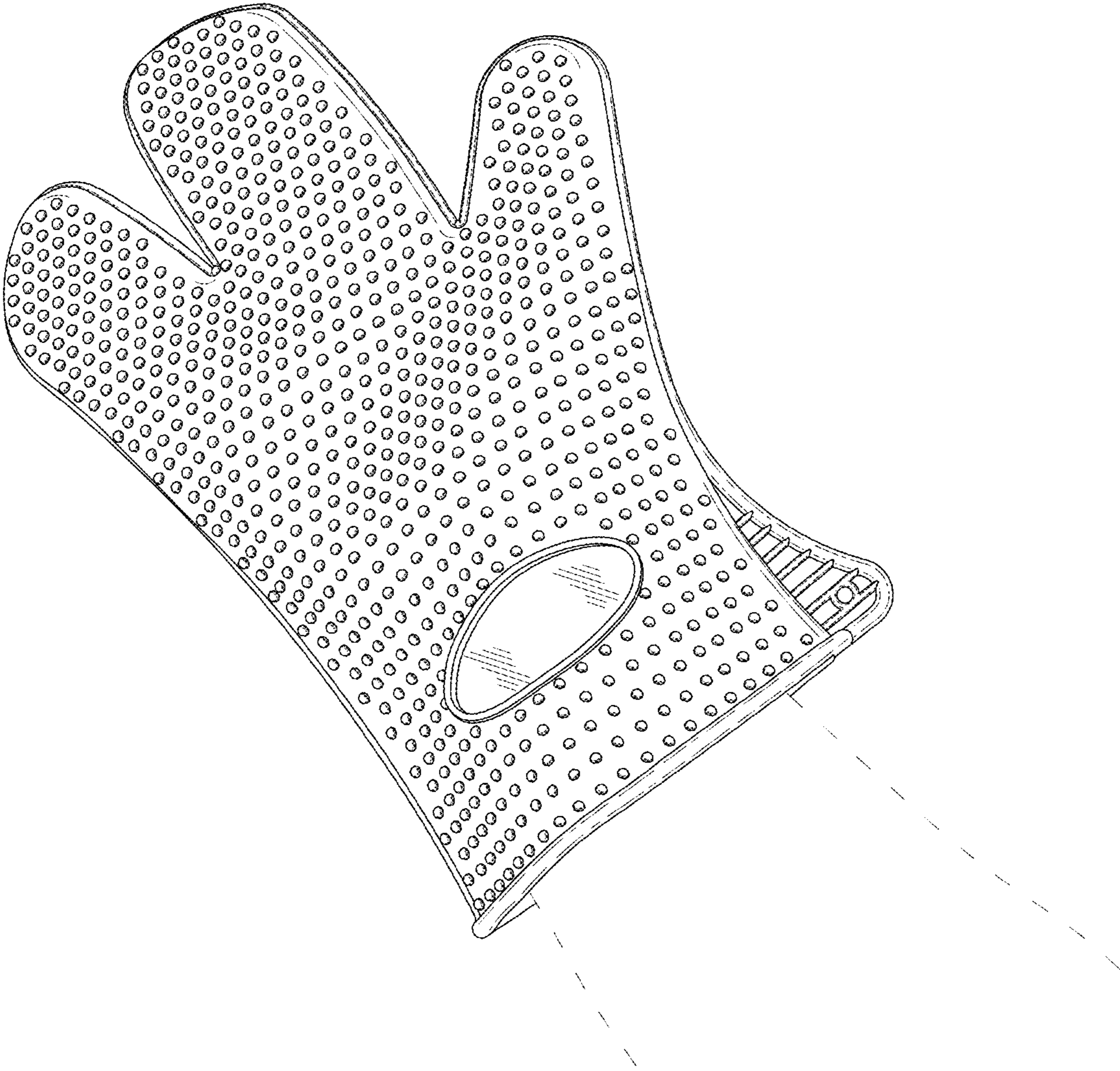

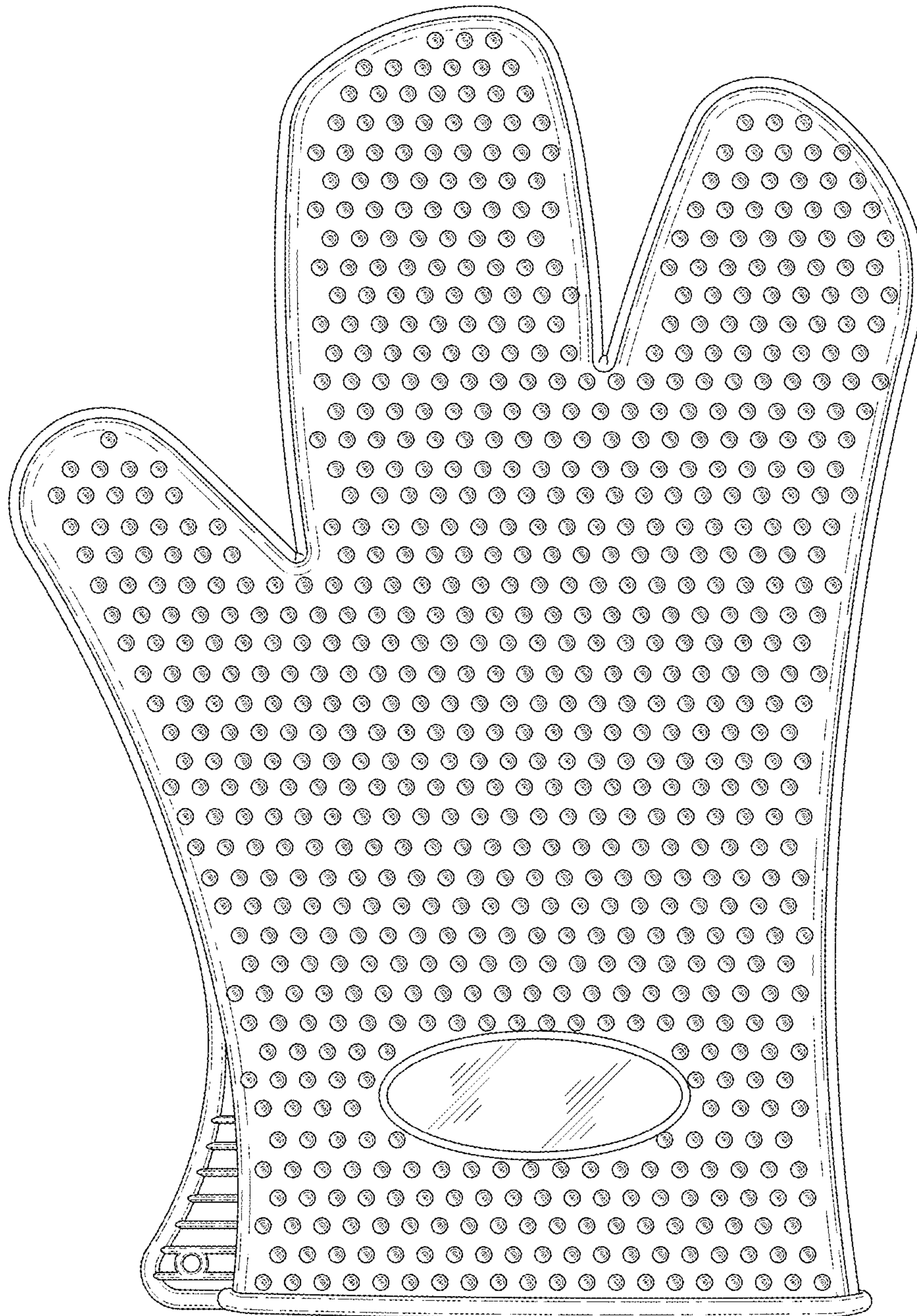

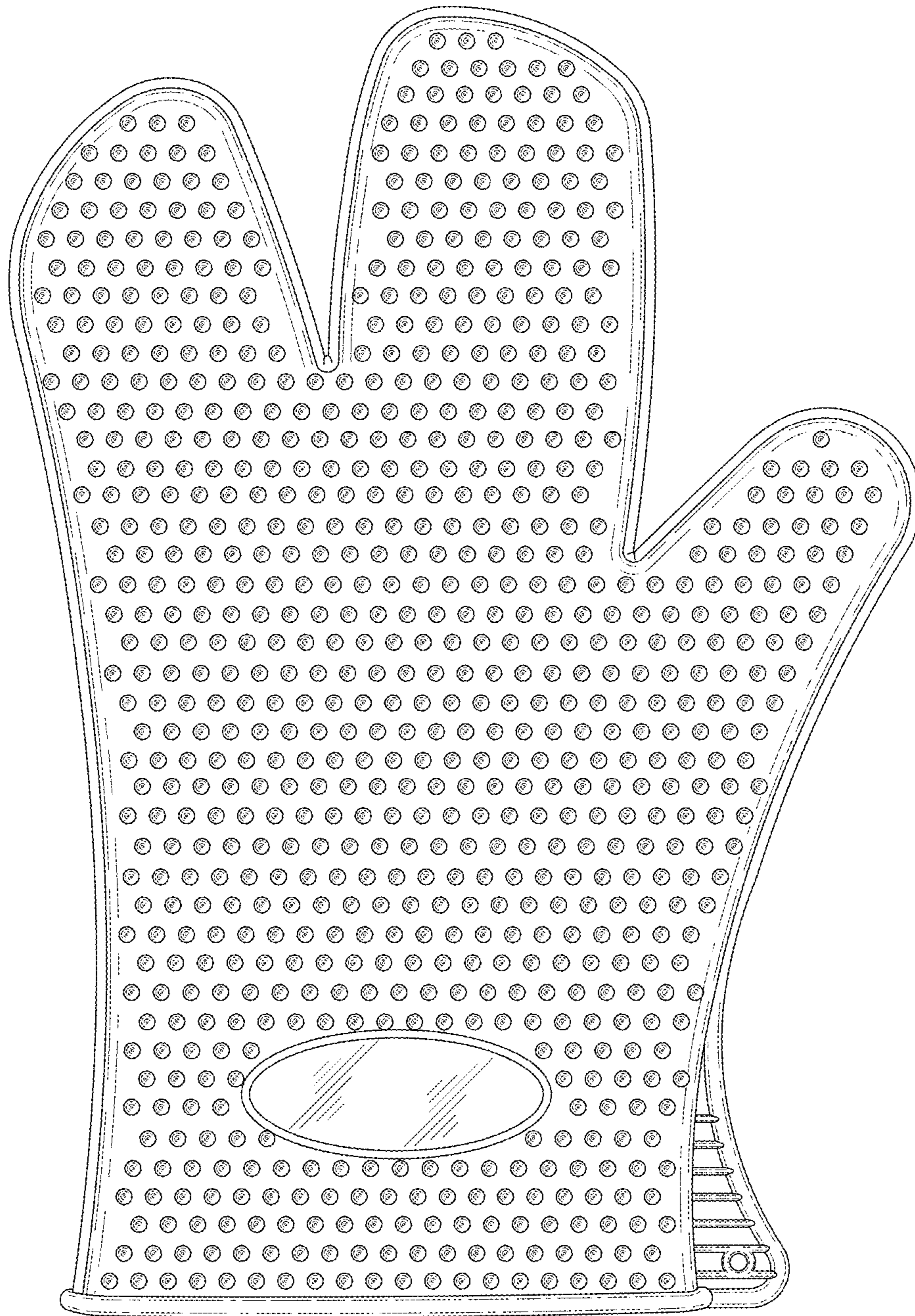

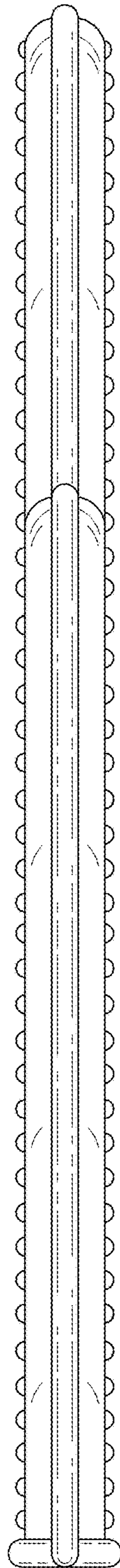

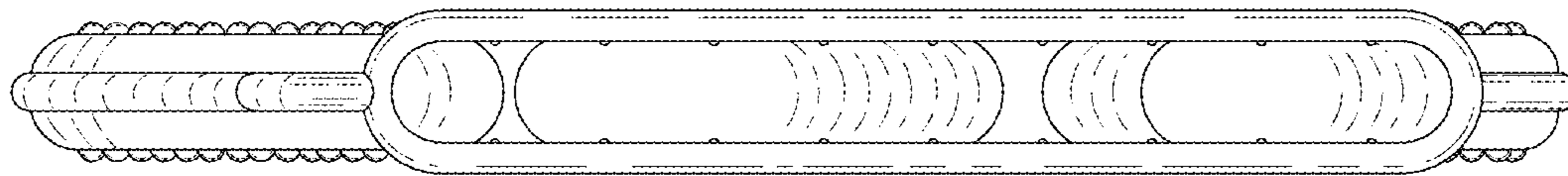

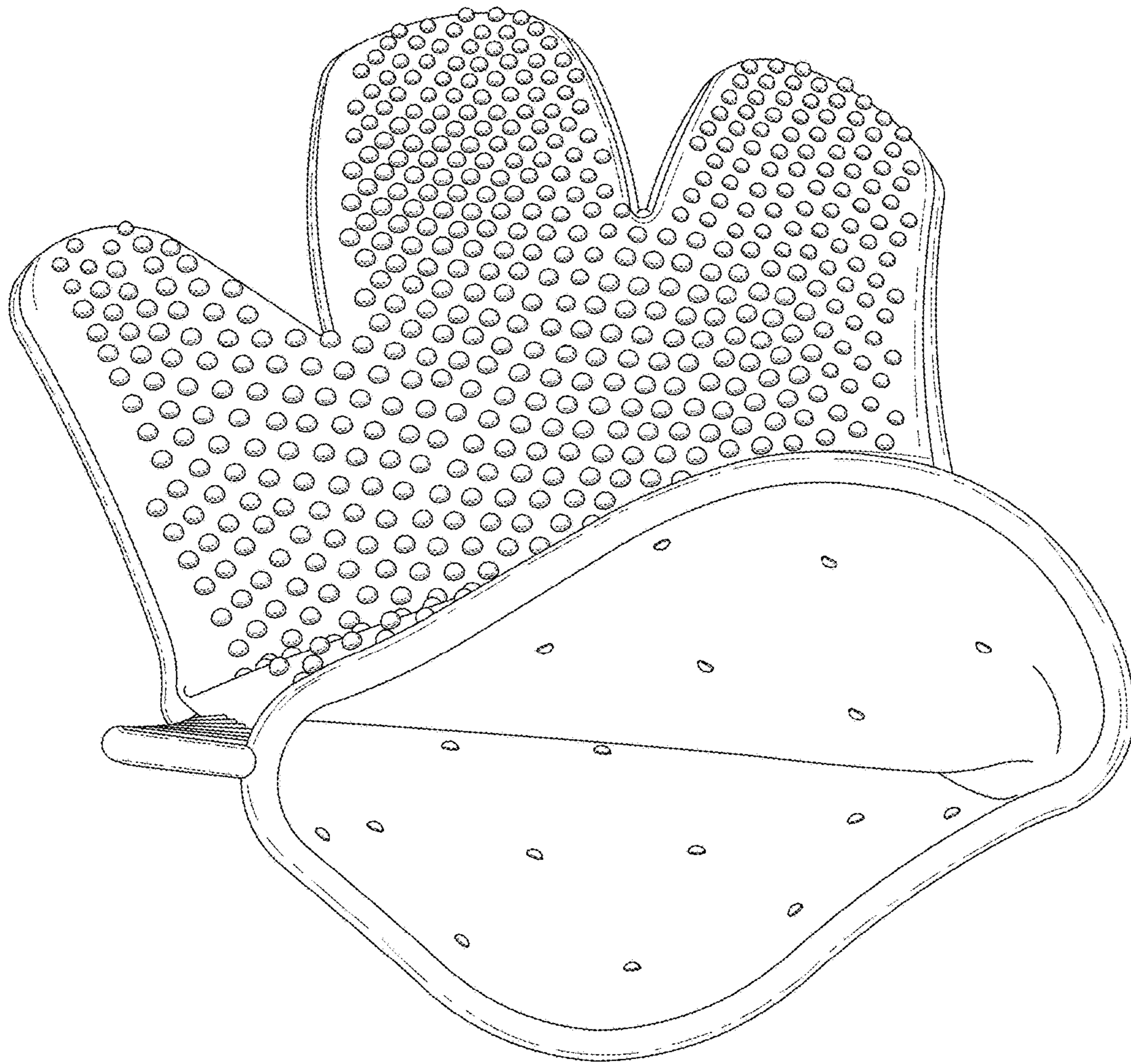
