showing a new design.

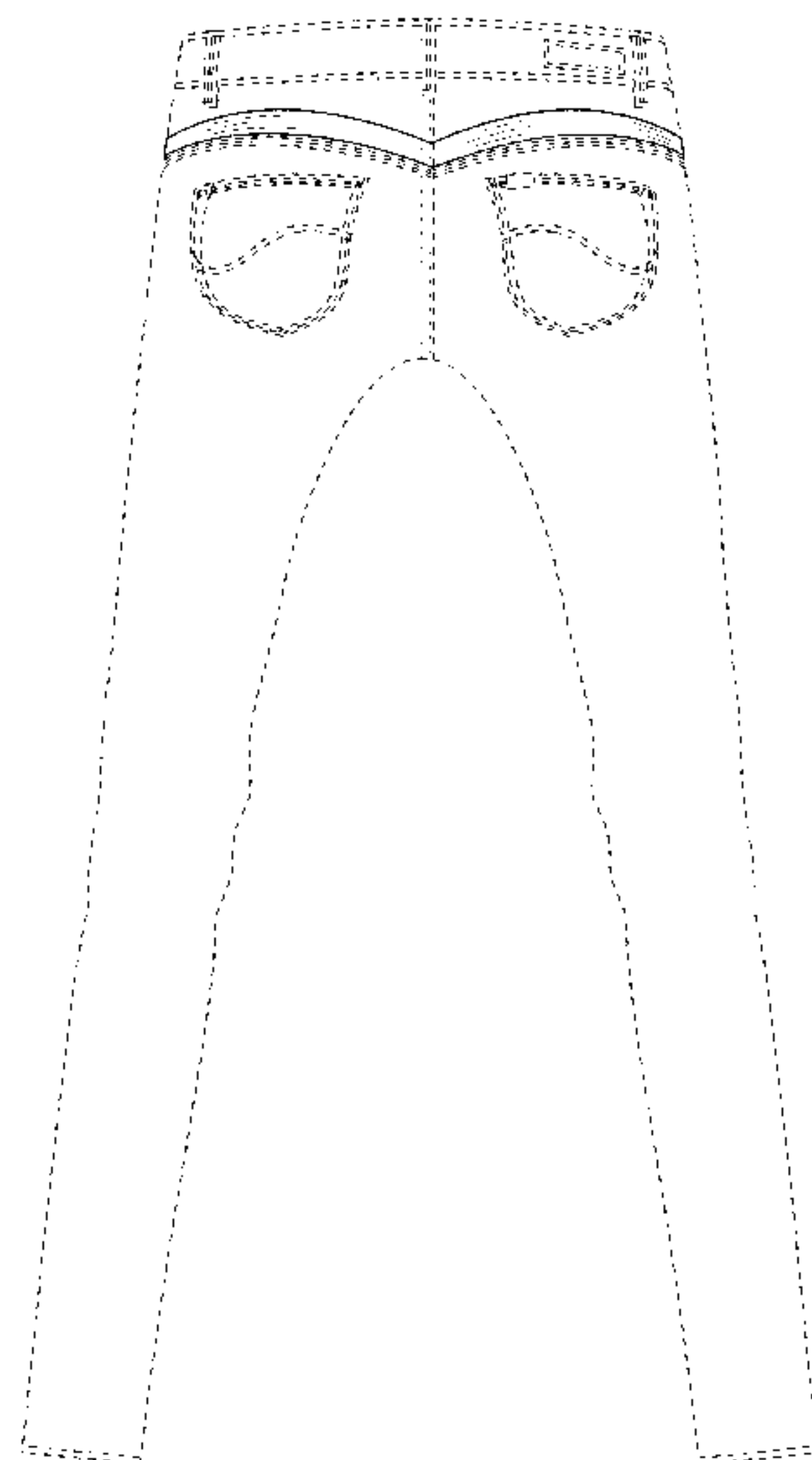
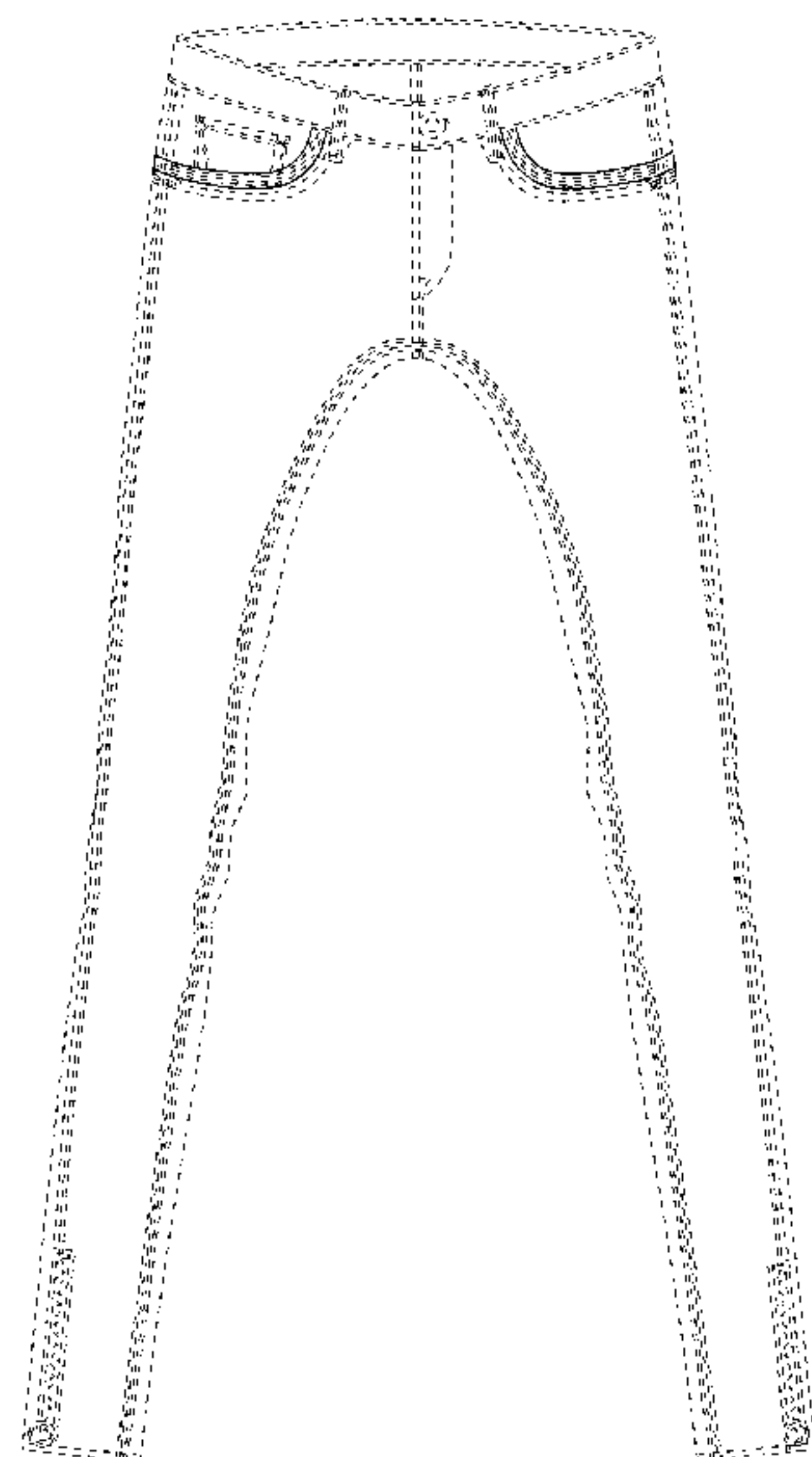
FIG. 6 is a bottom view of a double seam yoke lying flat

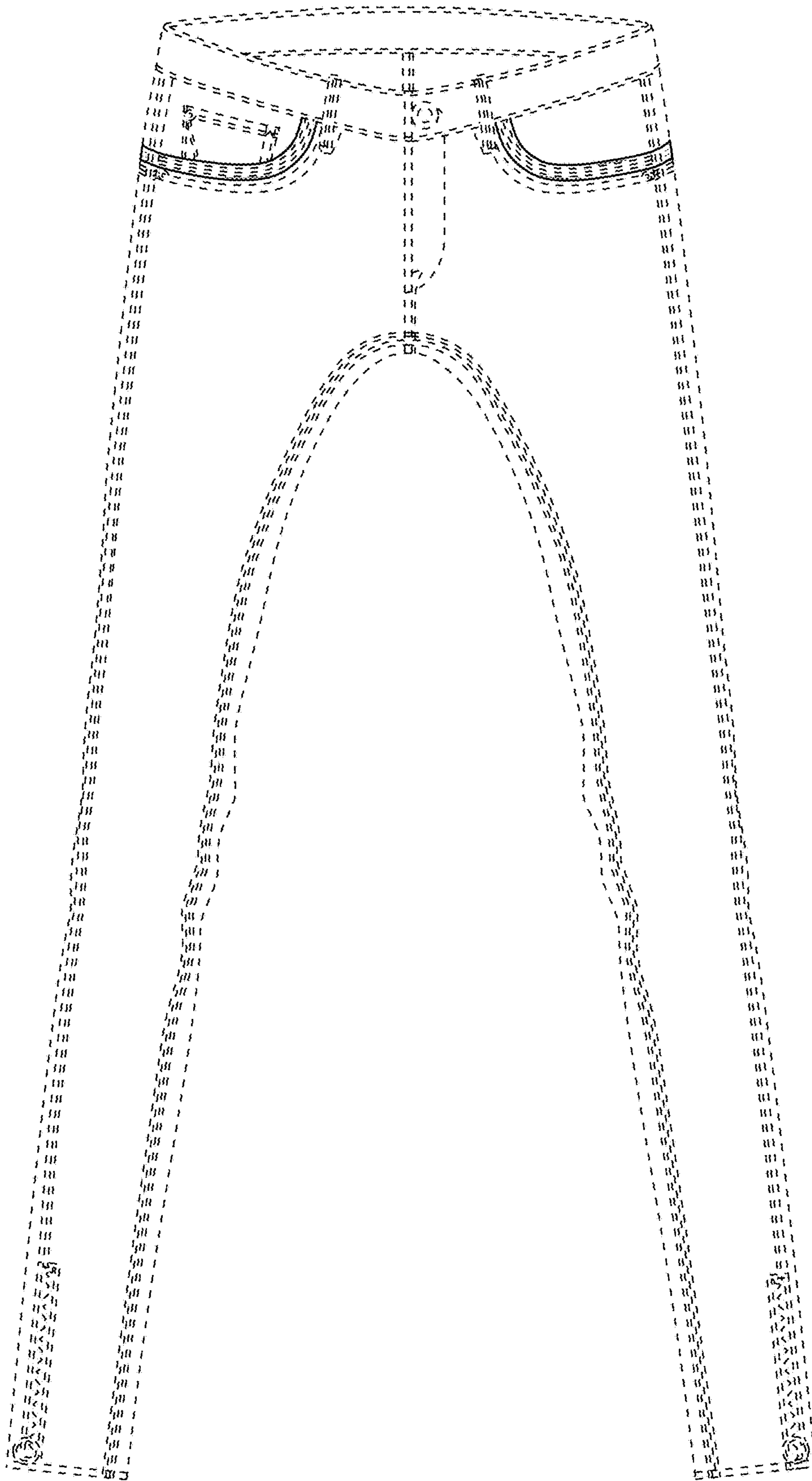

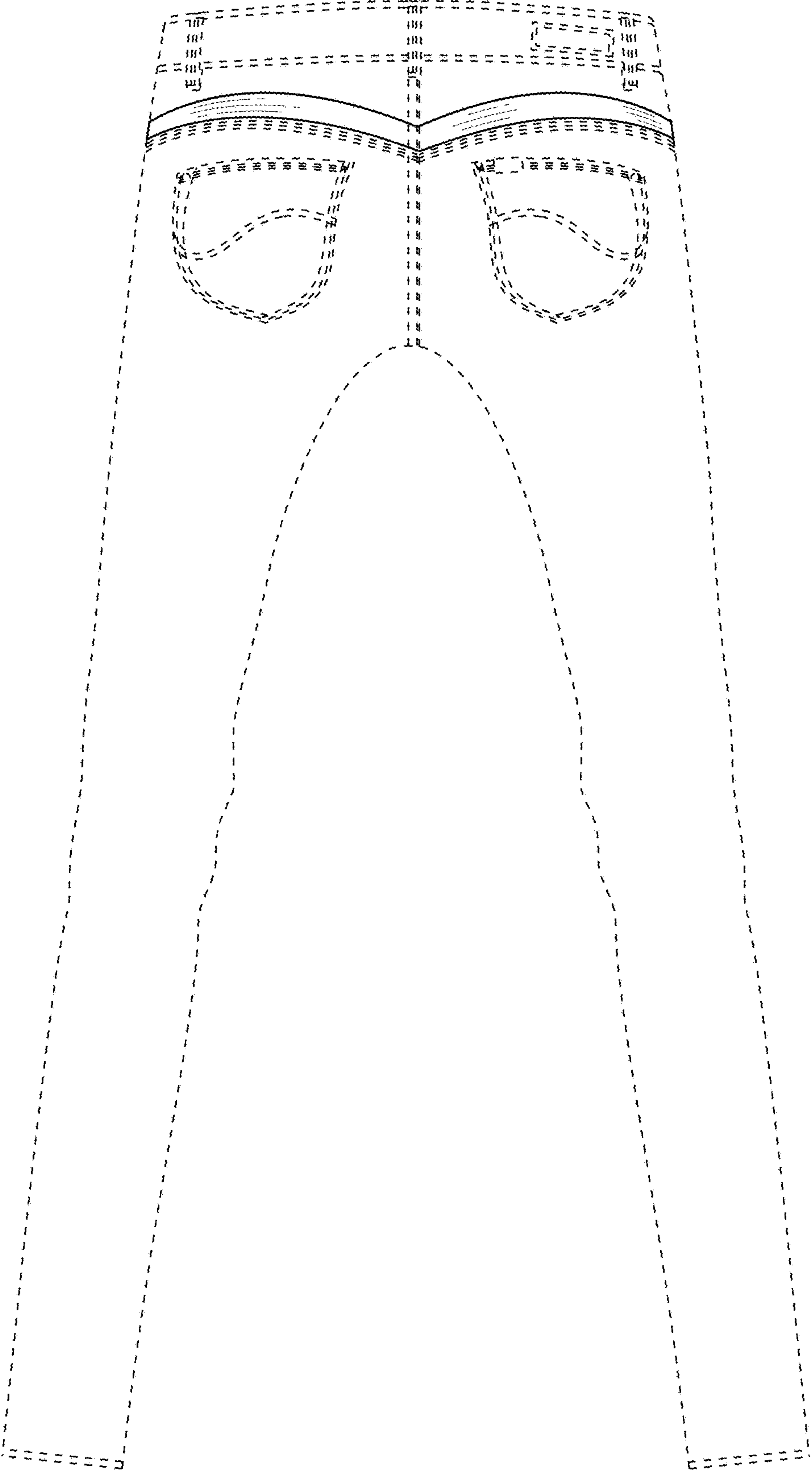

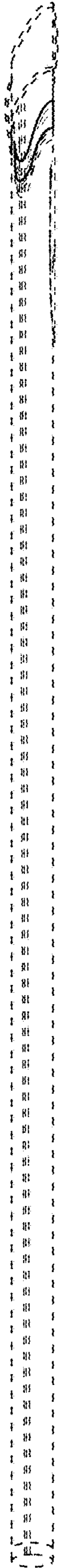

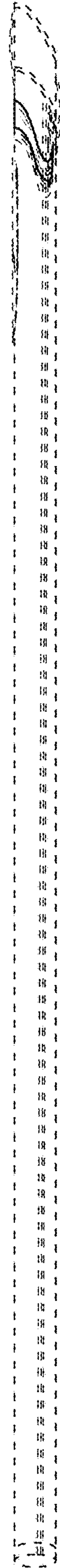

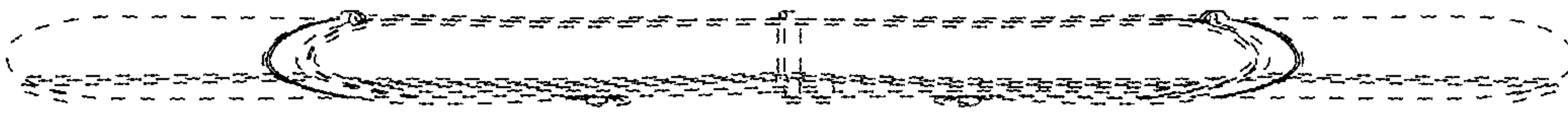

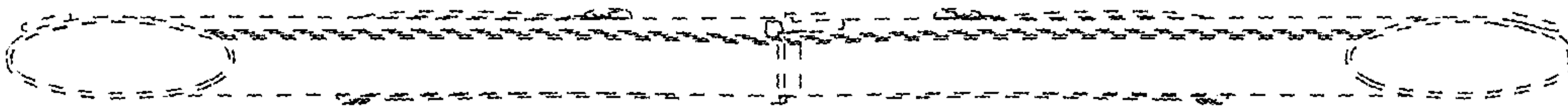

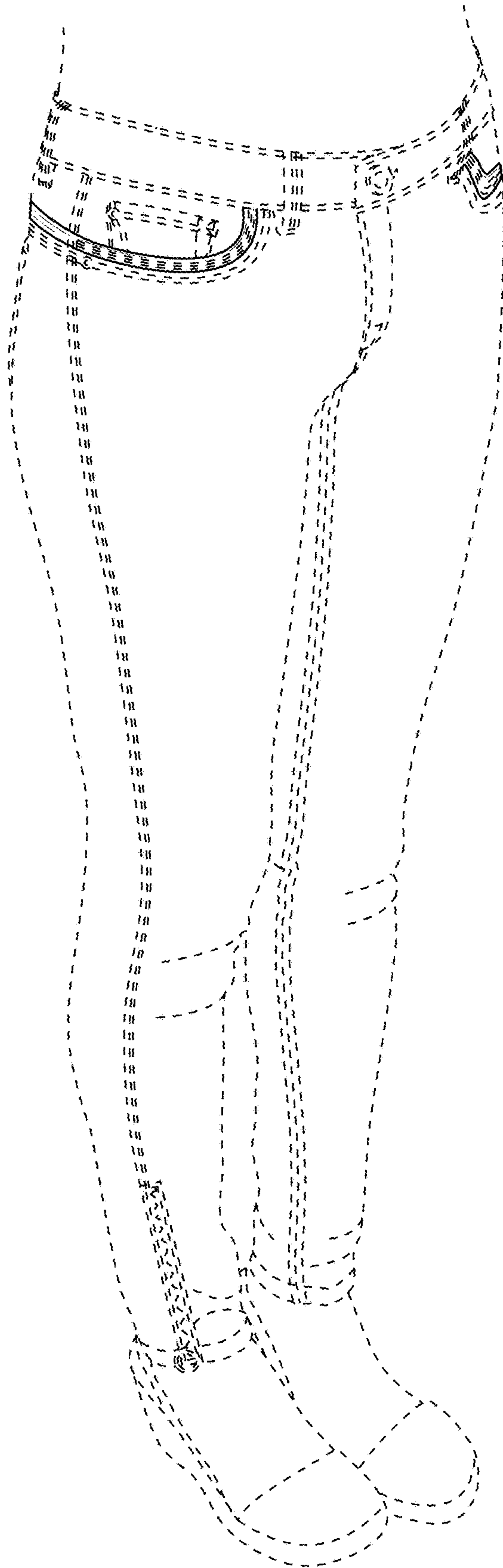

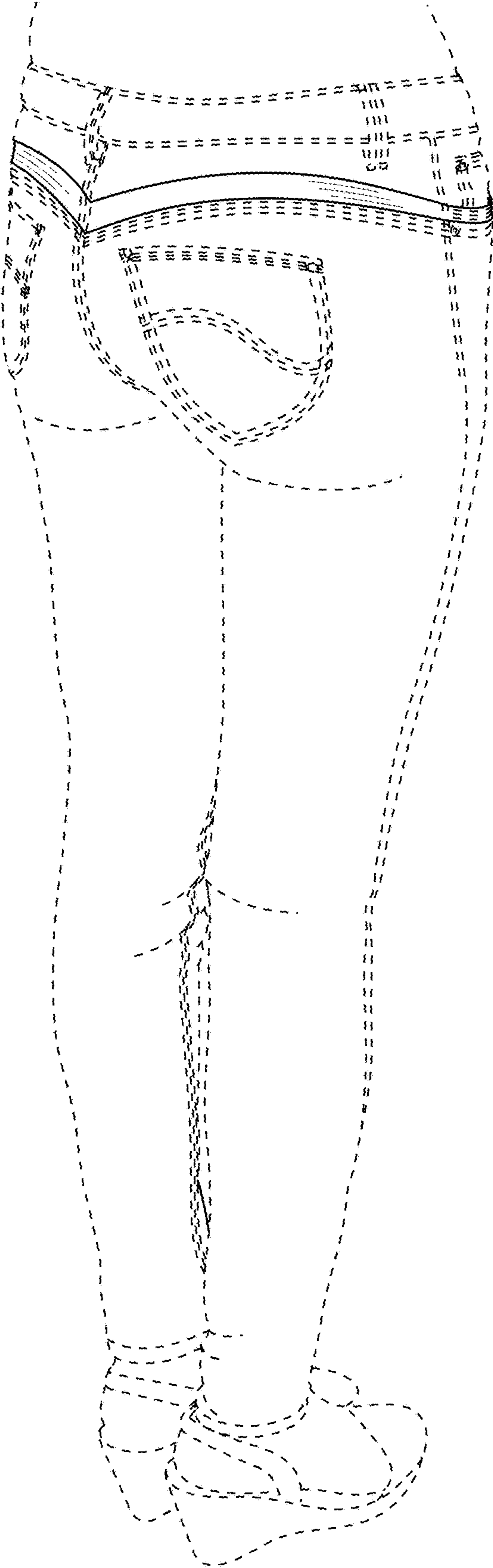
