We claim the ornamental design for a speaker, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a speaker, showing our new design;
FIG. 2 is a rear perspective view of a speaker, shown with the stand in opened condition;
FIG. 3 is a rear perspective view of the speaker;
FIG. 4 is a front view of the speaker;
FIG. 5 is a rear view of the speaker;
FIG. 6 is a top view of the speaker;
FIG. 7 is a bottom view of the speaker;

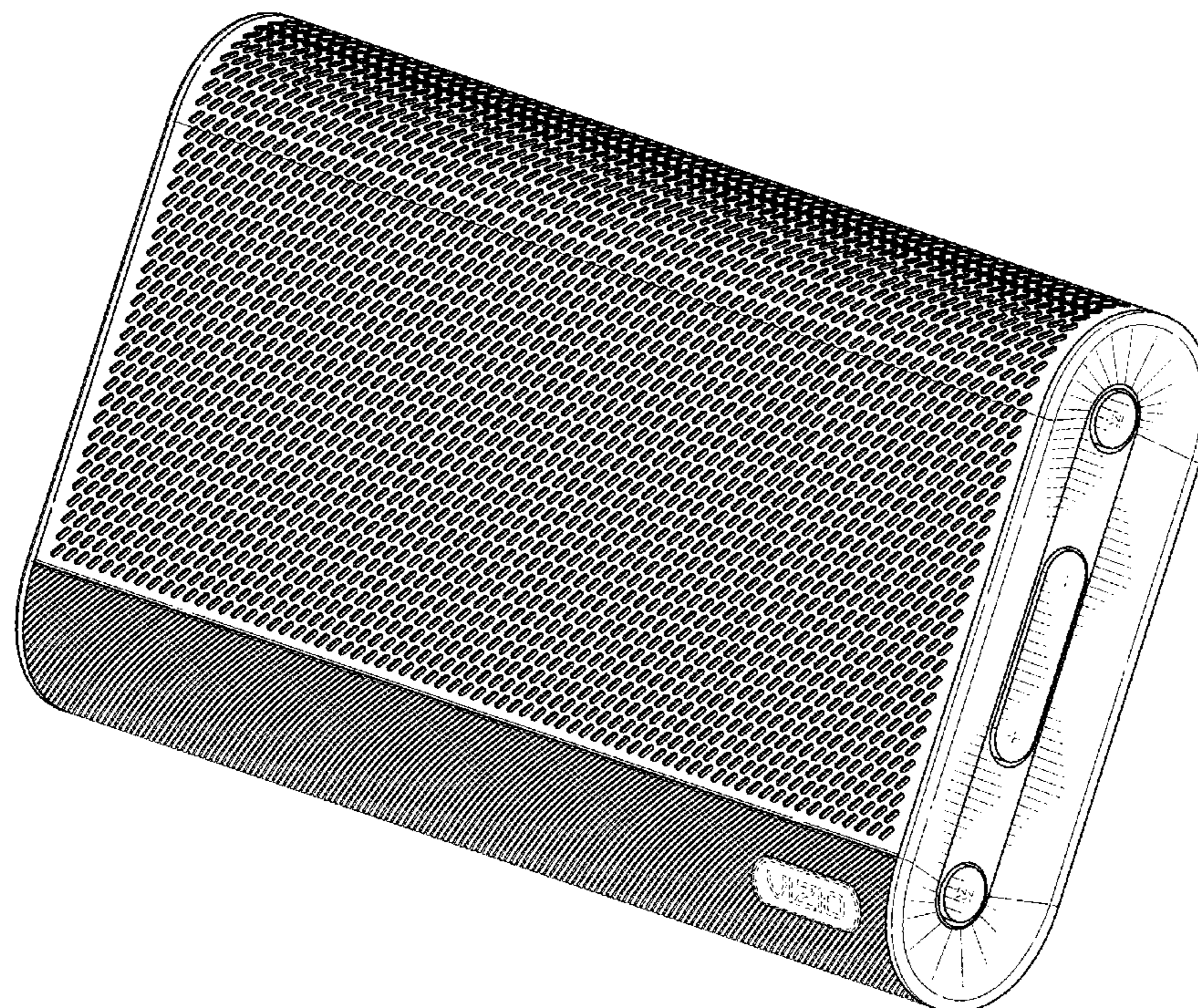

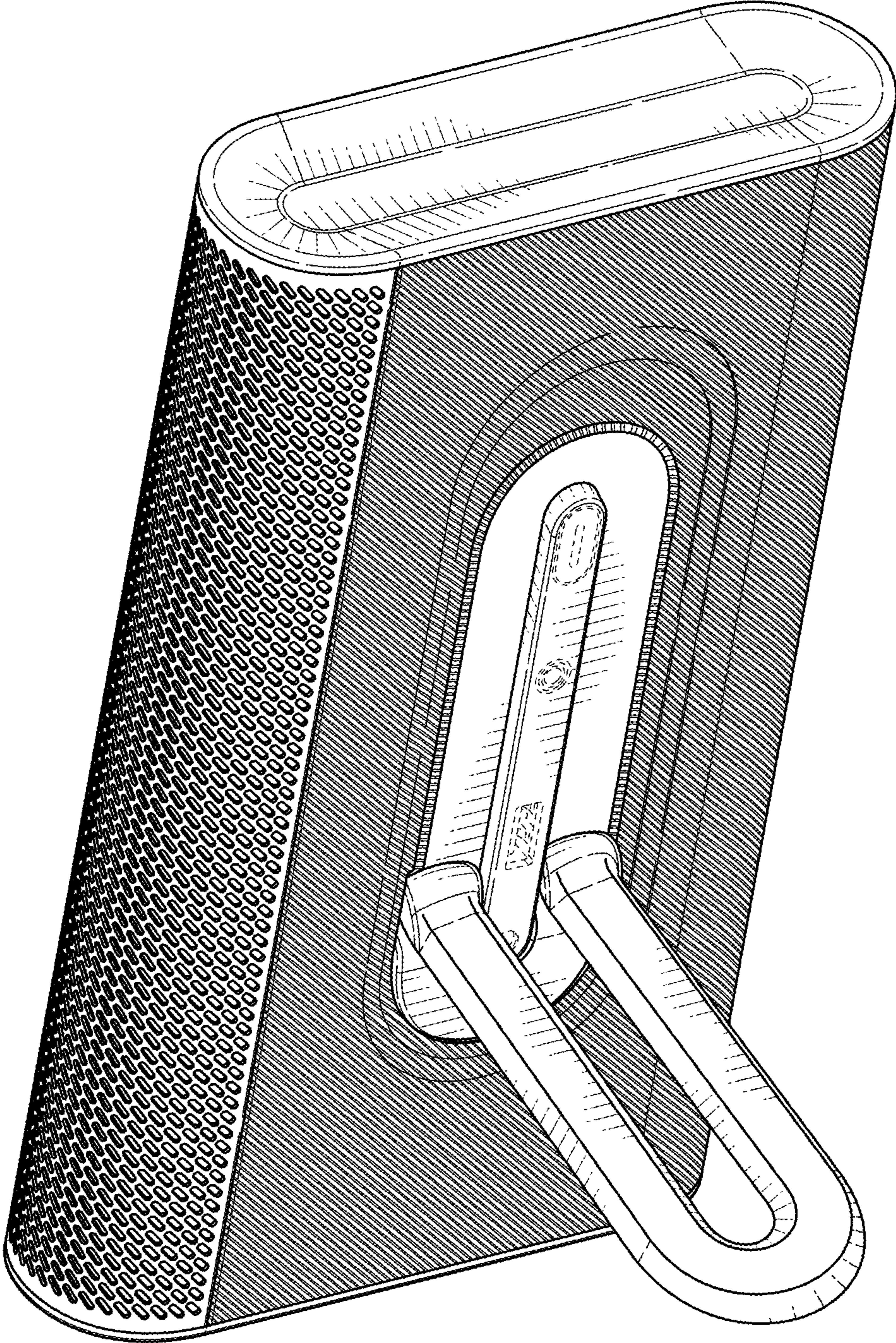

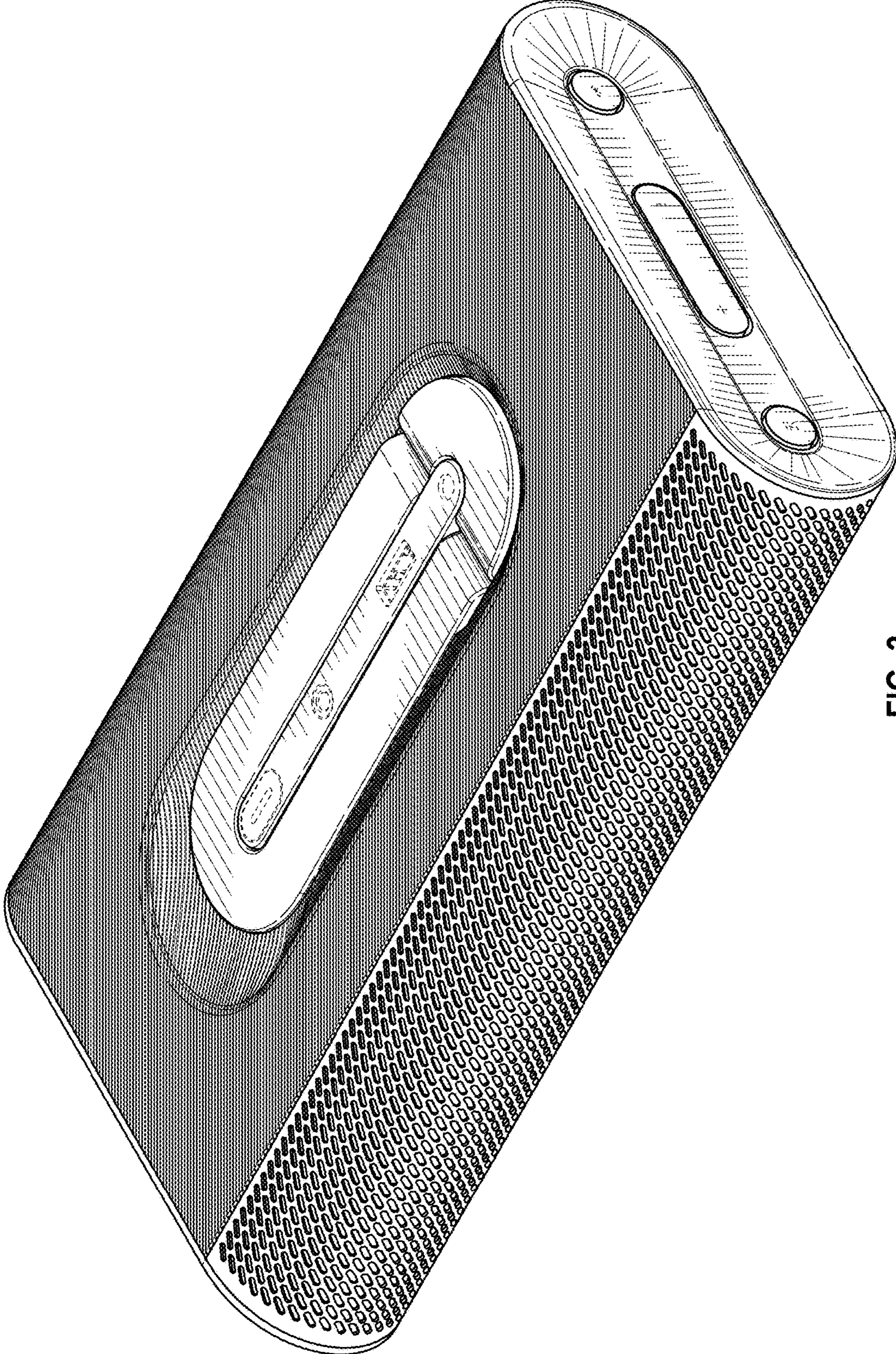

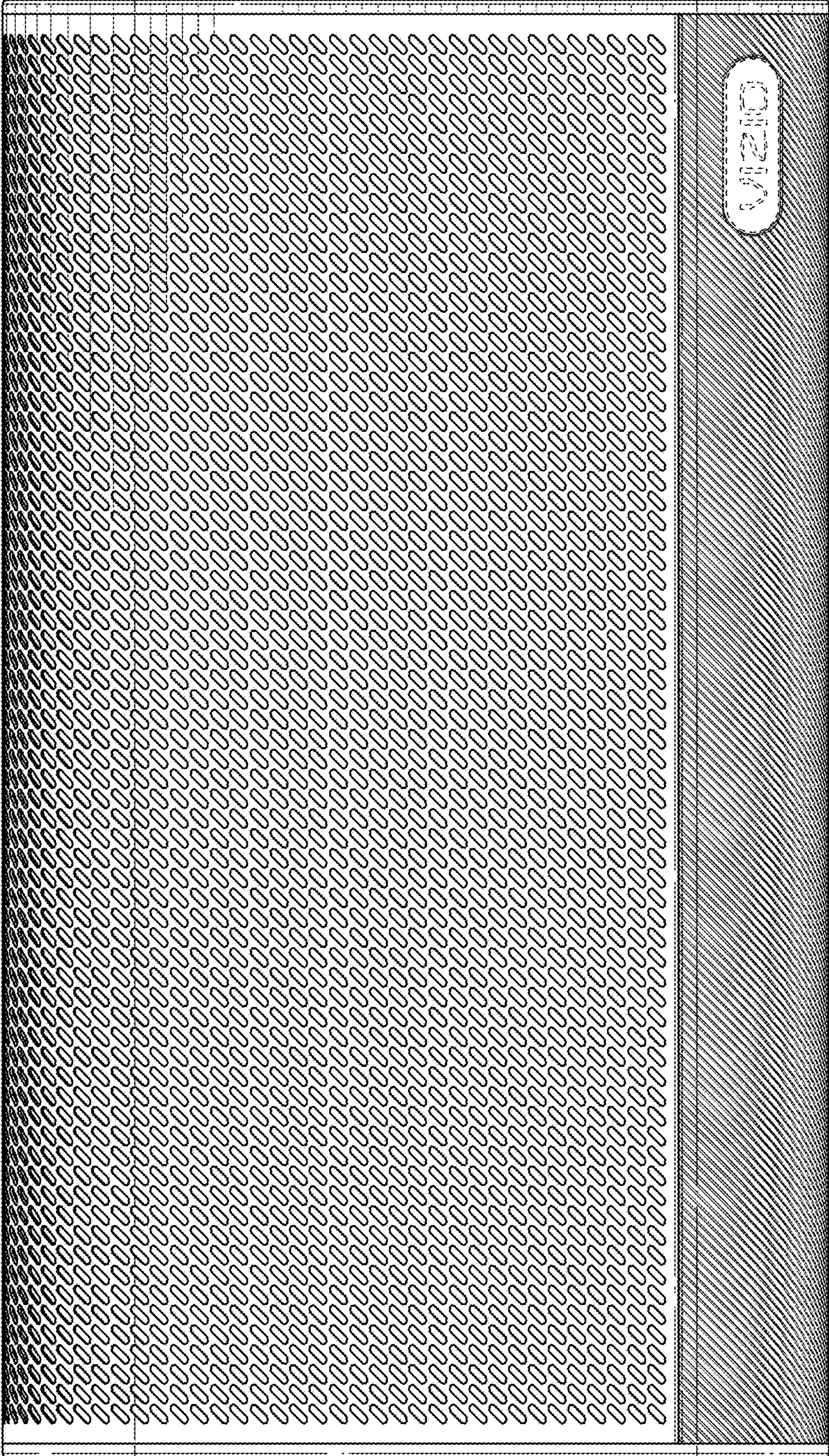

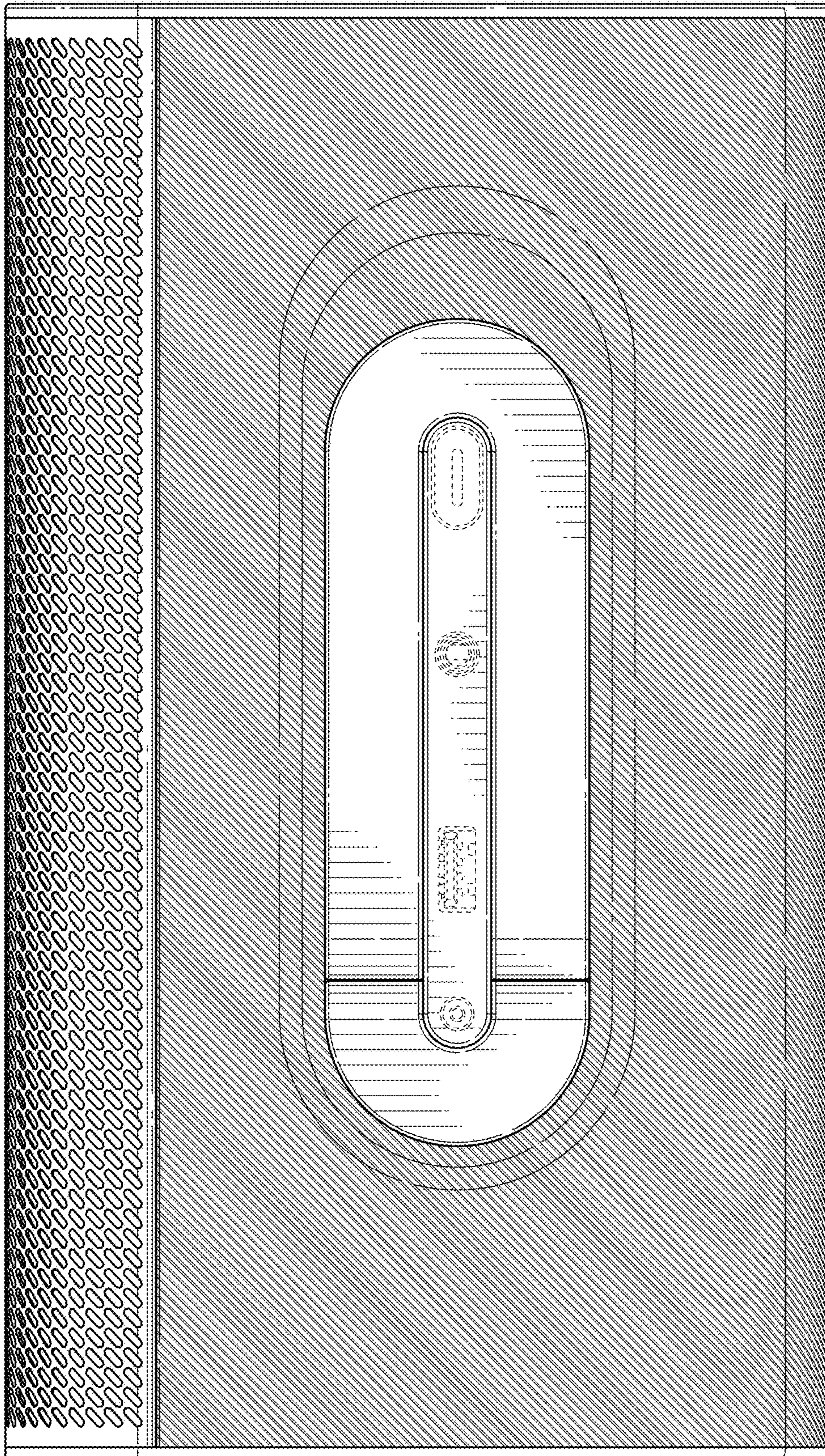

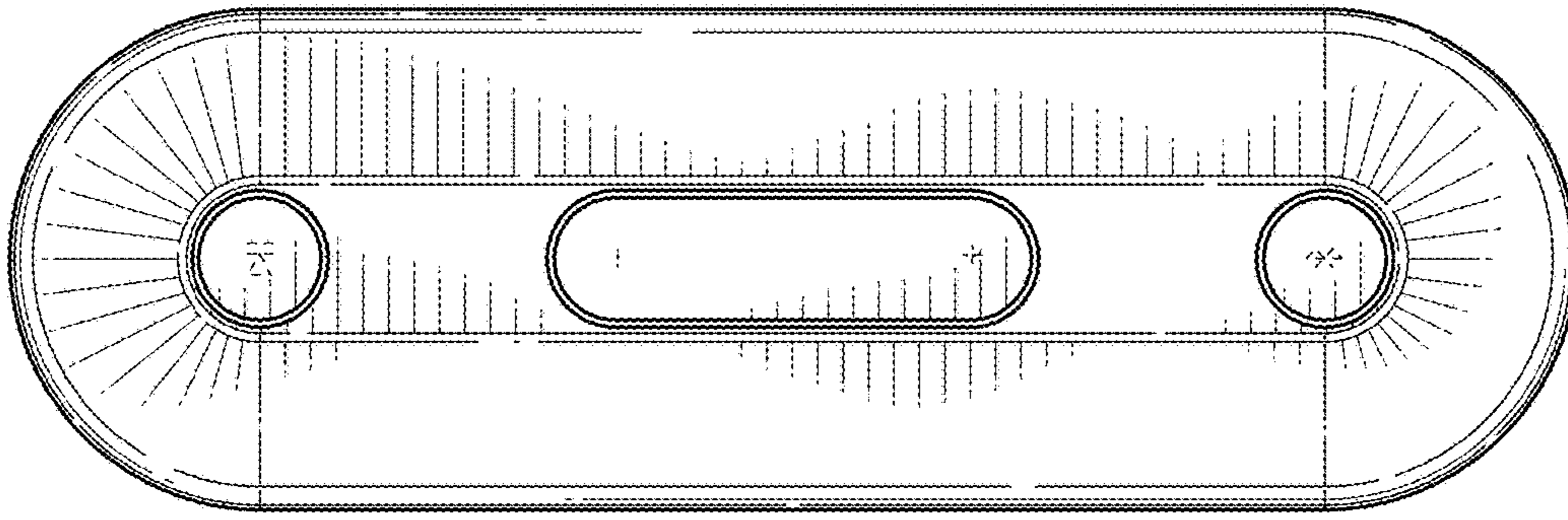

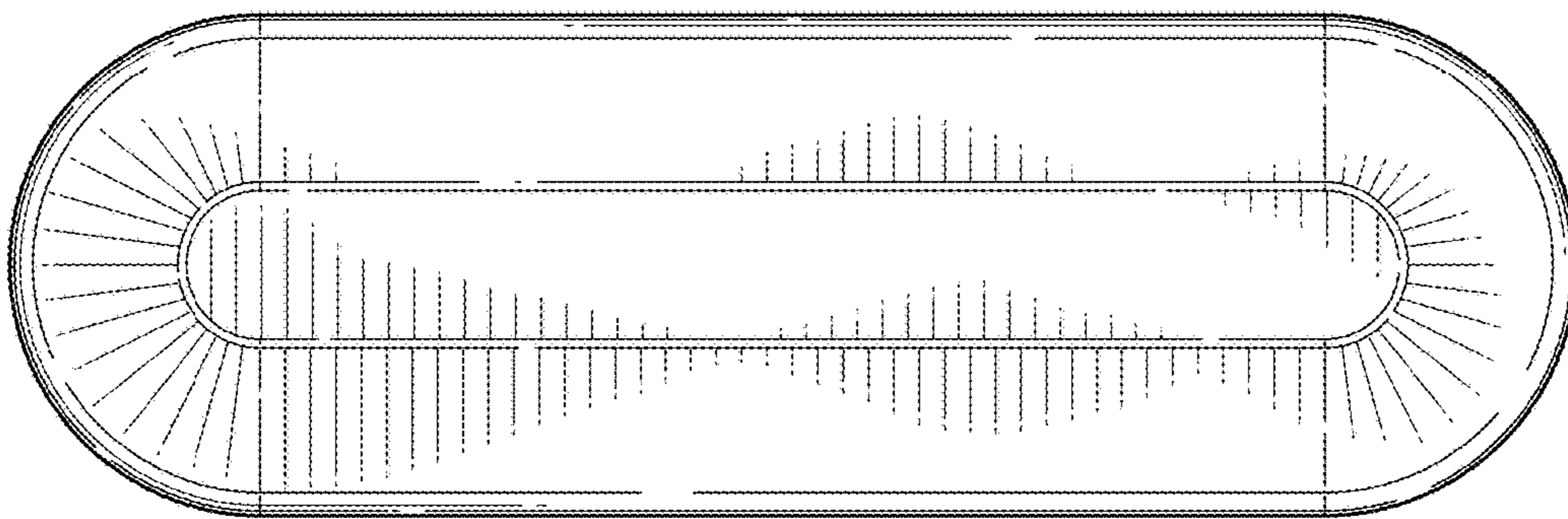

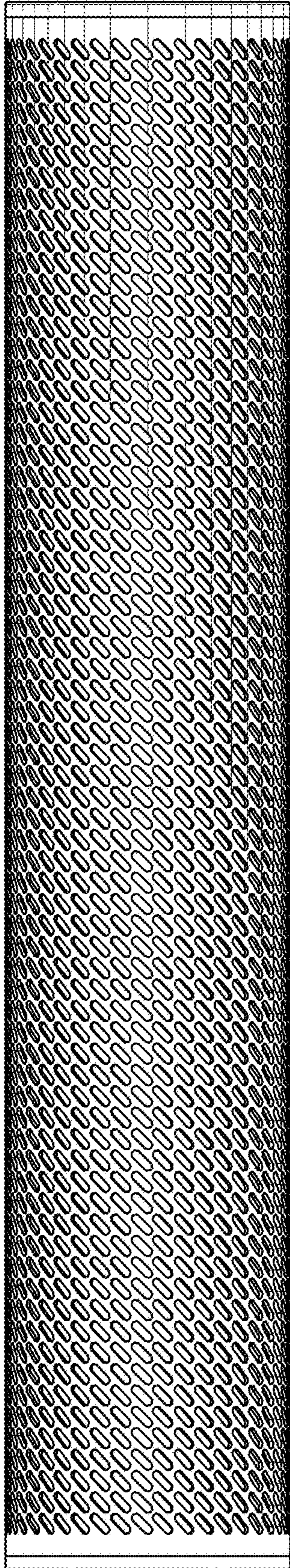

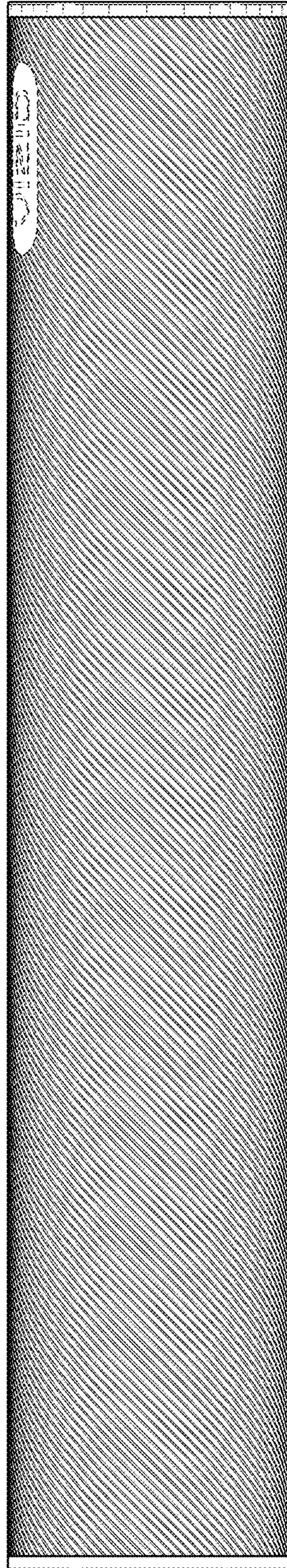
