DESCRIPTION

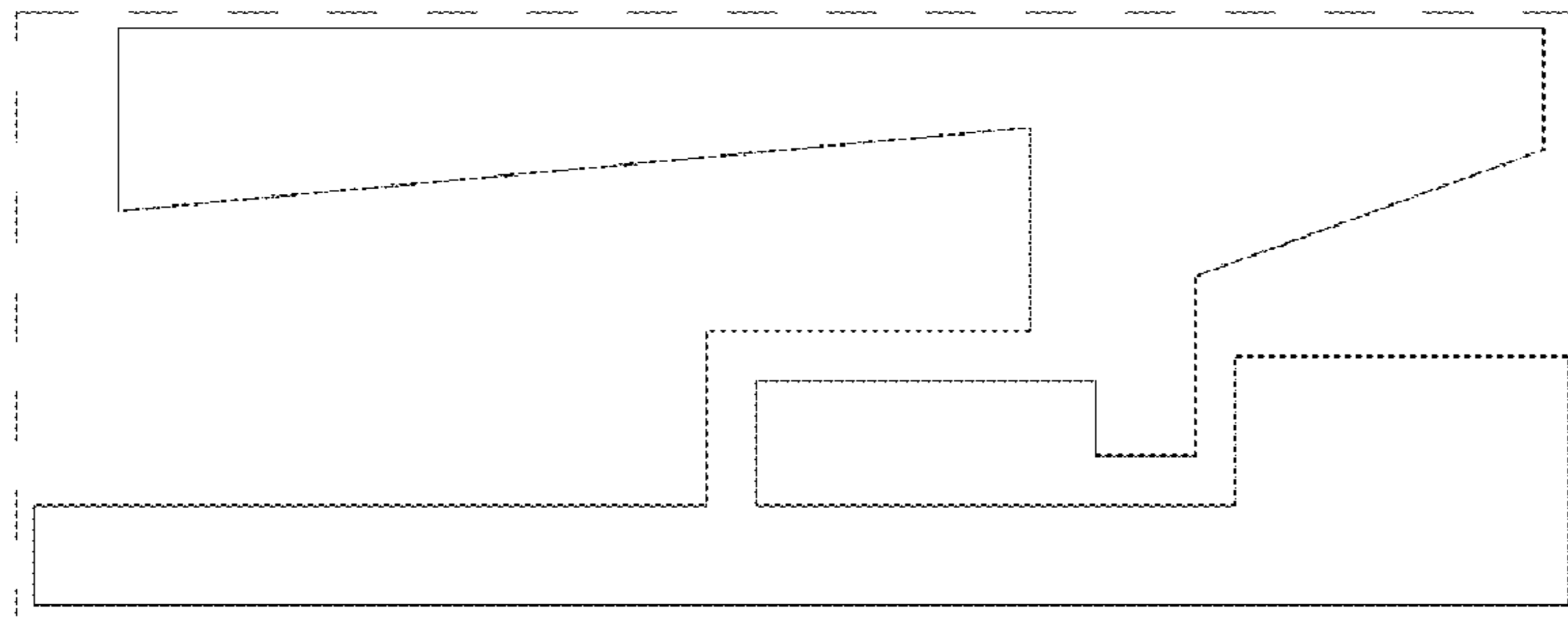
FIG. 1 is a top plan view of an antenna with a base in broken lines;

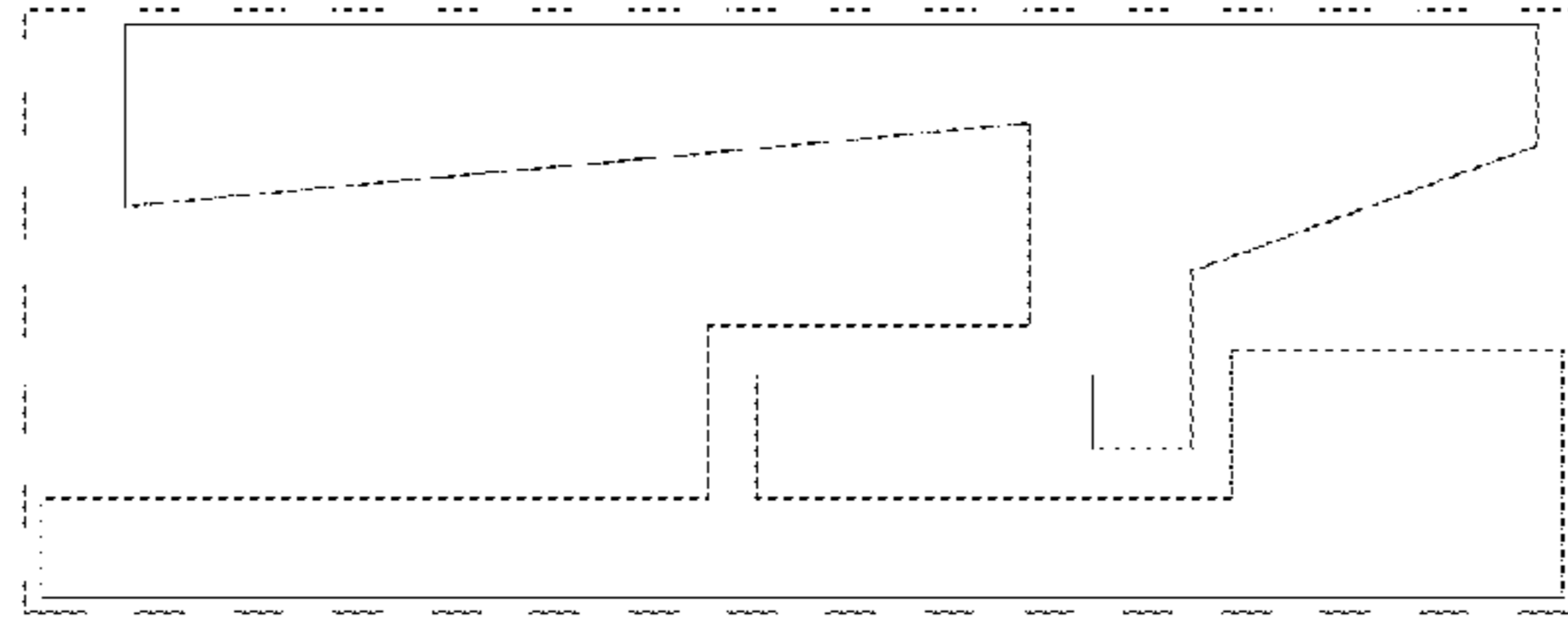

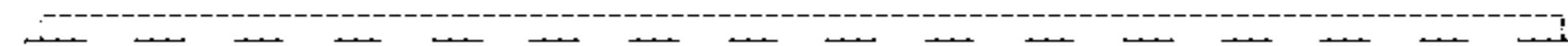

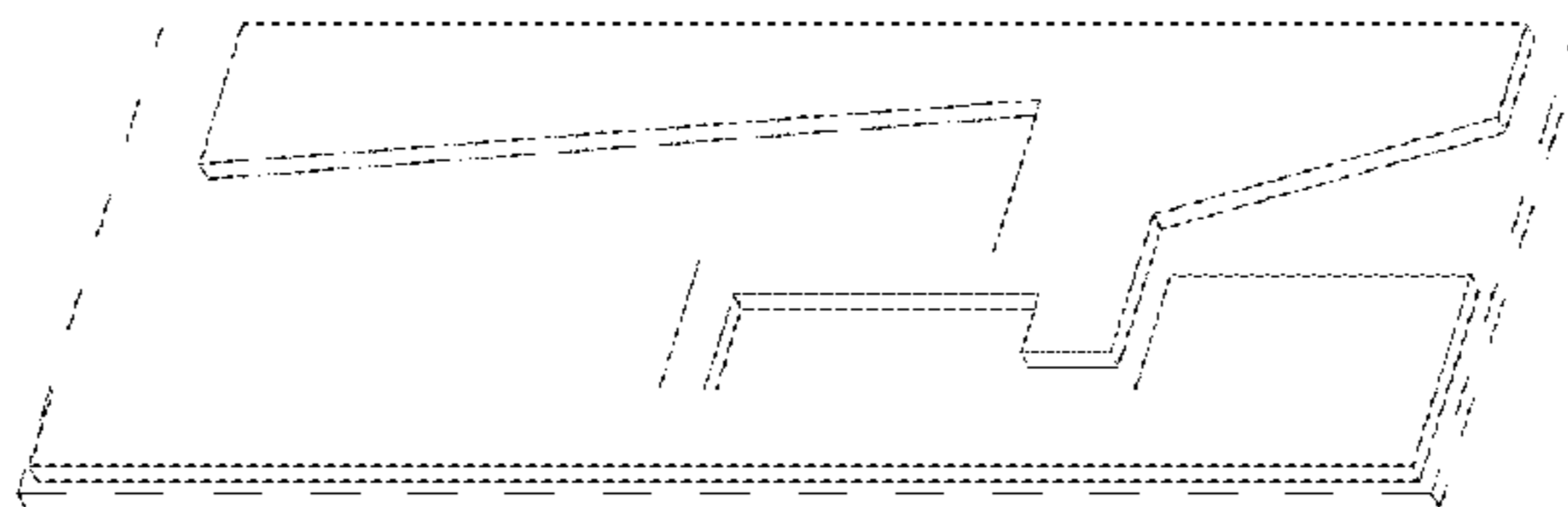

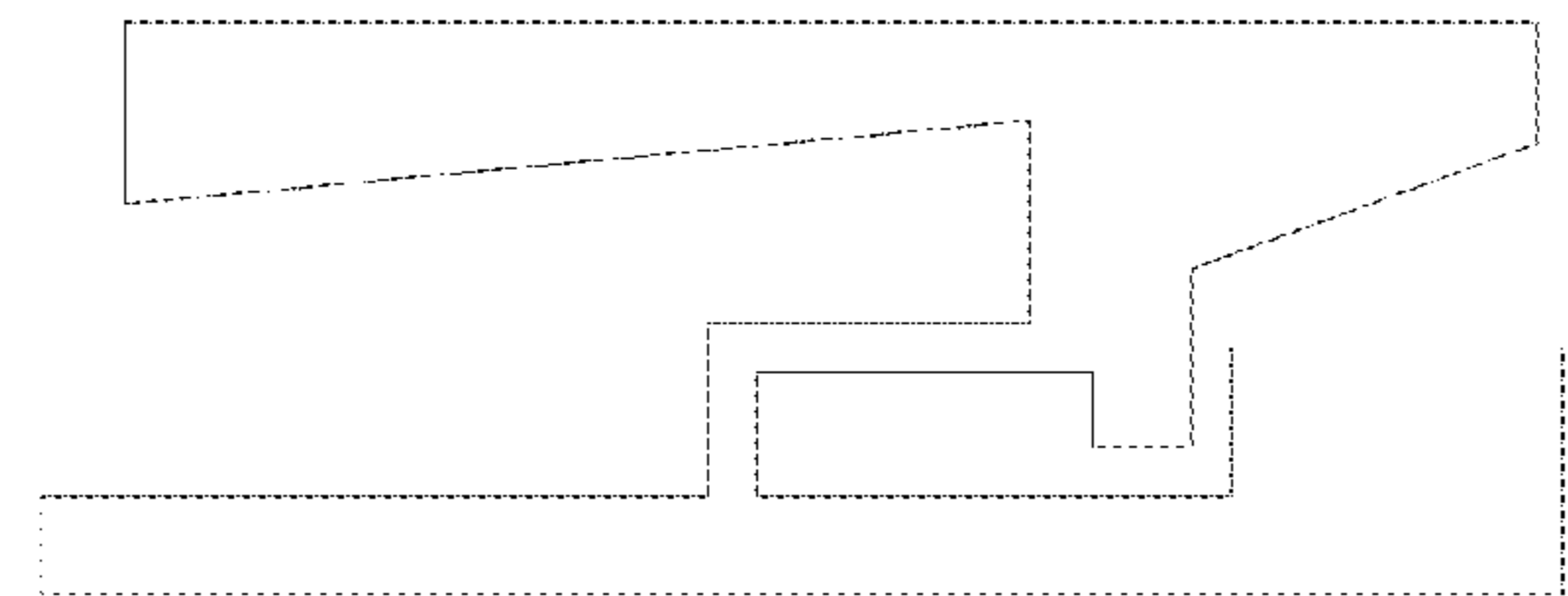

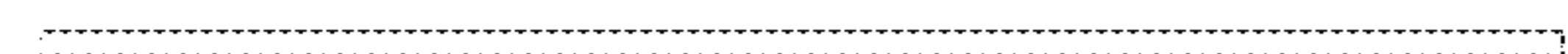
