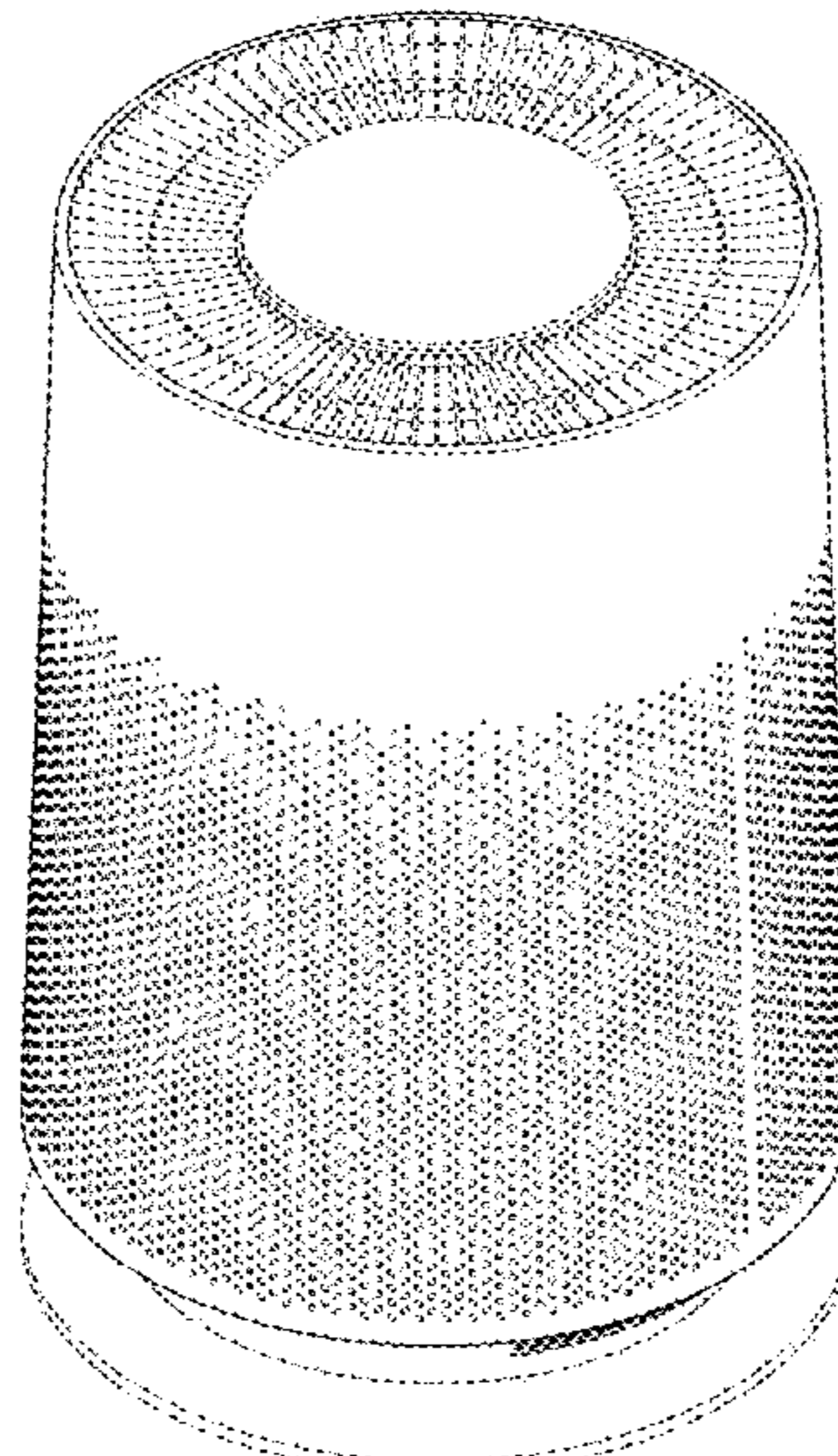
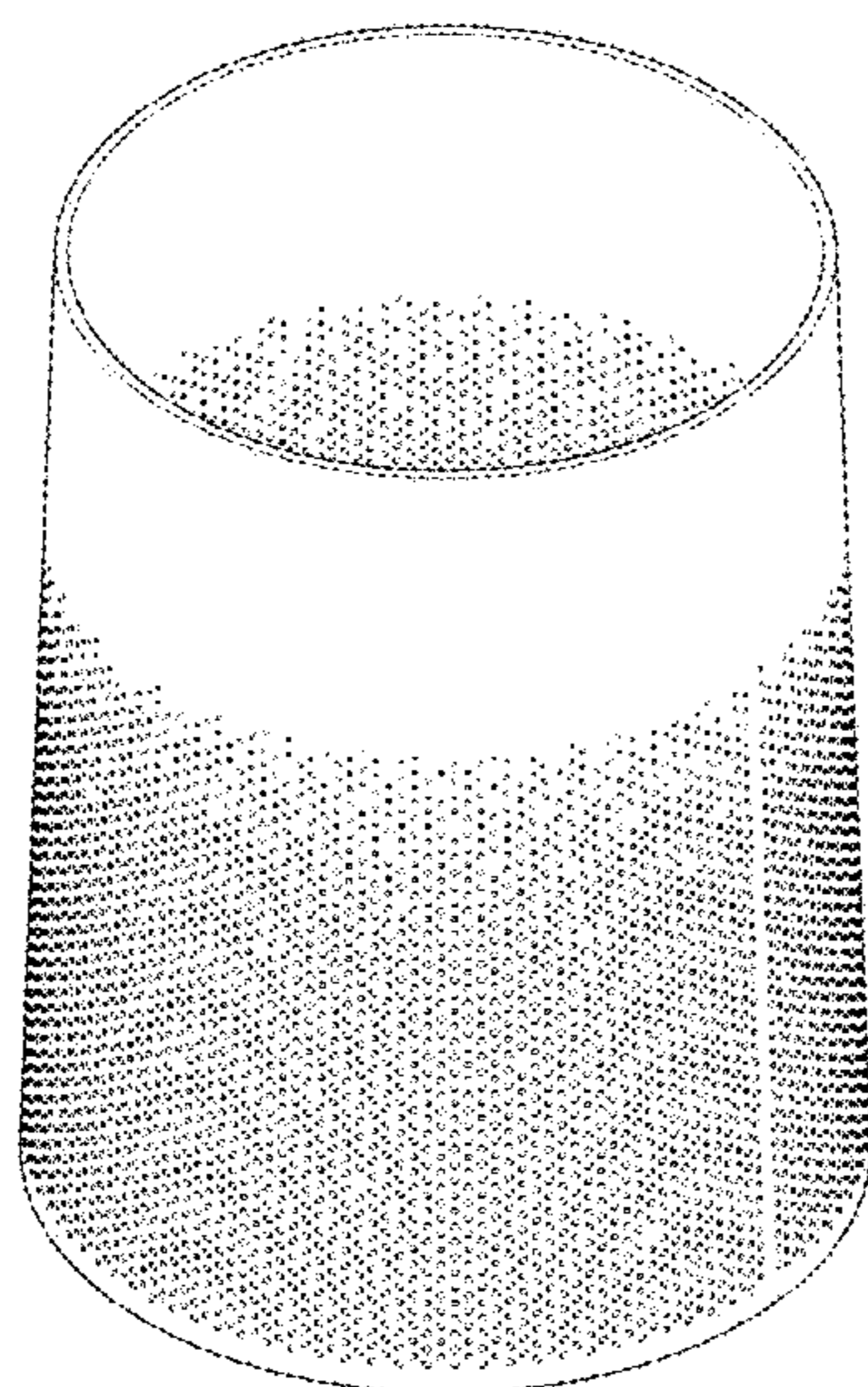
(57) **CLAIM**

The ornamental design for a cover for air purifier, as shown and described.

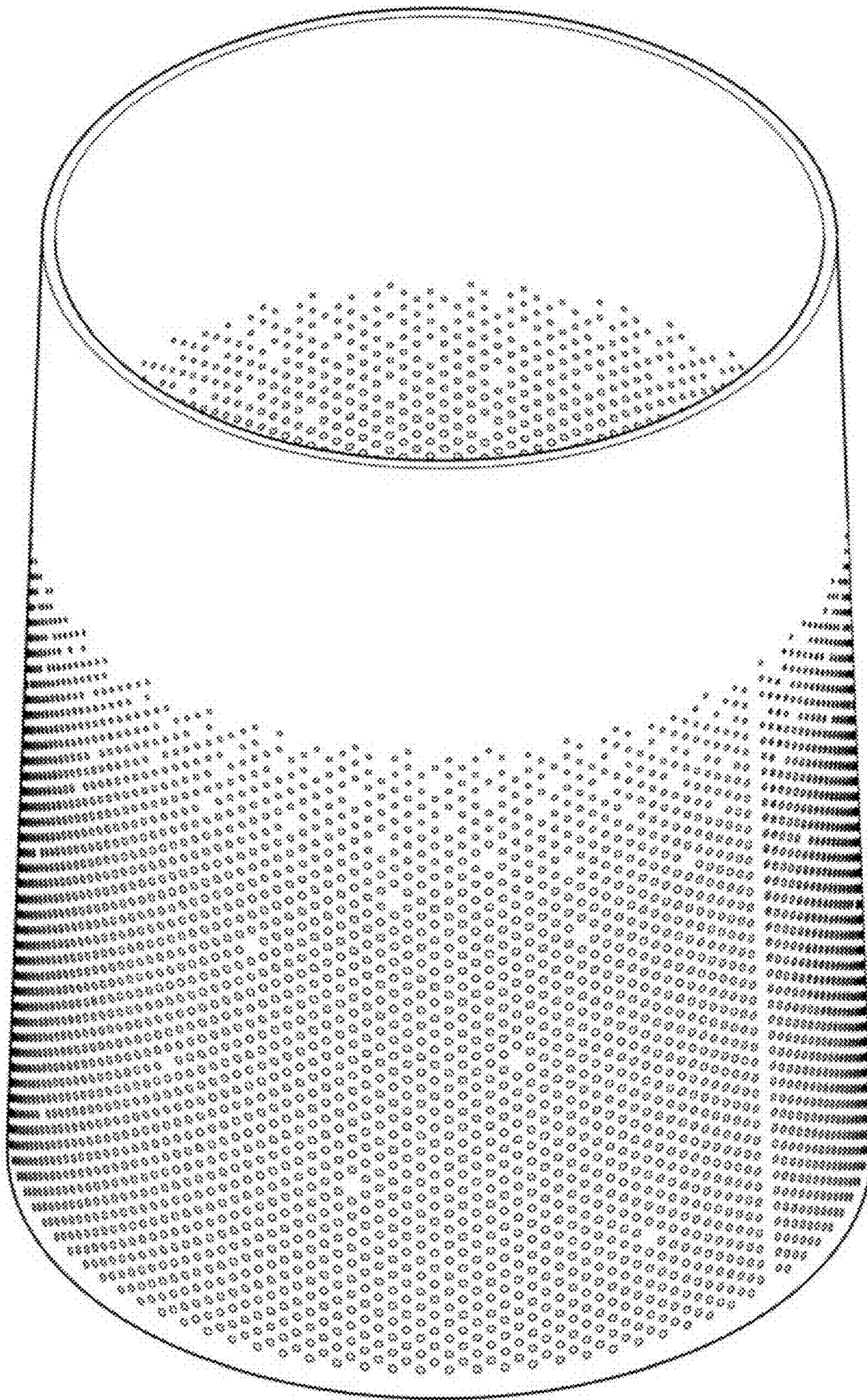
DESCRIPTION

1. Cover for air purifier
1.1 is a perspective view of a cover for air purifier, showing our new design;
1.2 is a front elevation view thereof;
1.3 is a rear elevation view thereof;
1.4 is a left-side elevation view thereof;
1.5 is a right-side elevation view thereof;
1.6 is a top plan view thereof;
1.7 is a bottom plan view thereof; and
1.8 is a perspective view thereof, in a use condition.
The broken line showing of the air purifier is for the purpose of illustrating environment of the article and forms no part of the claimed design.

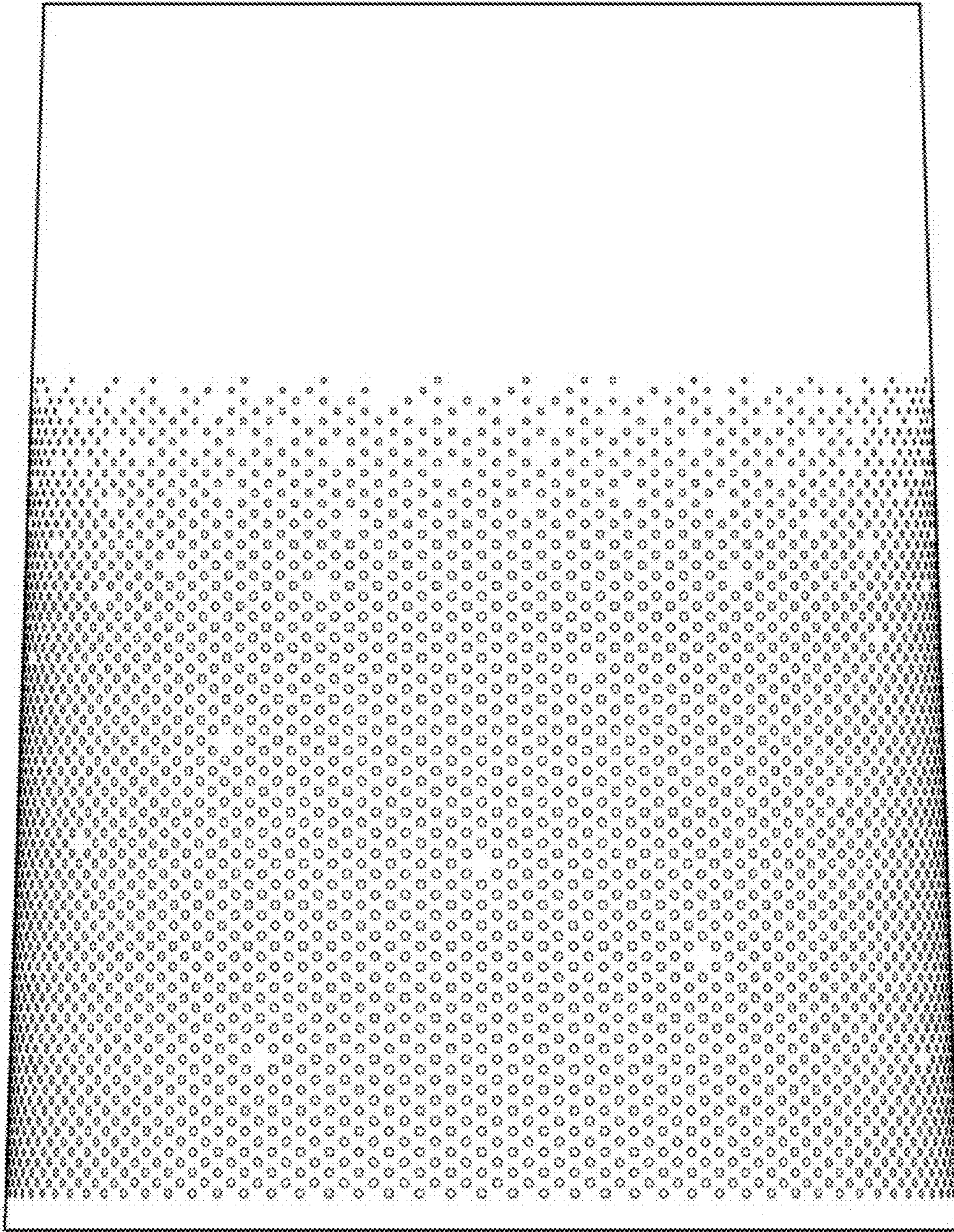

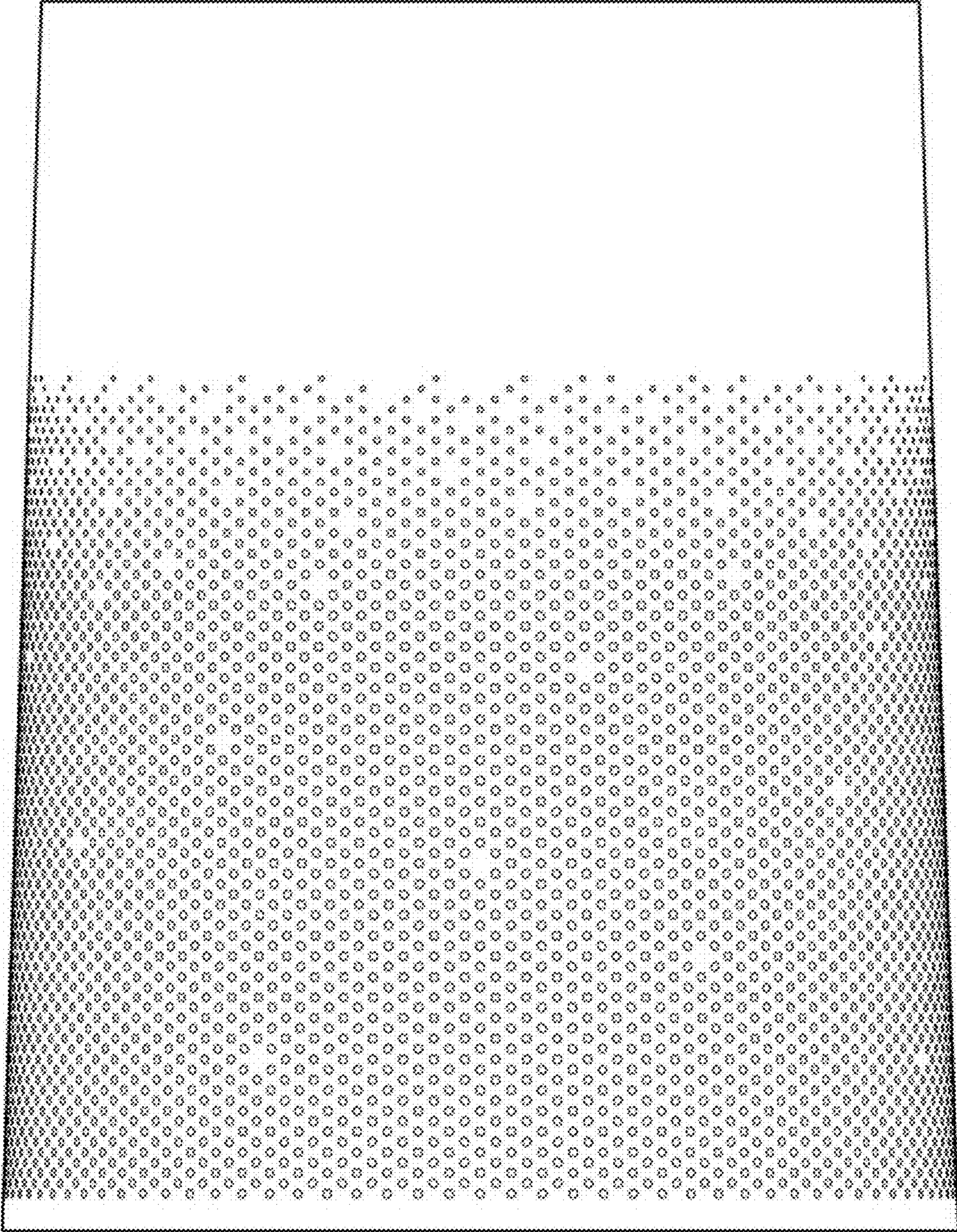

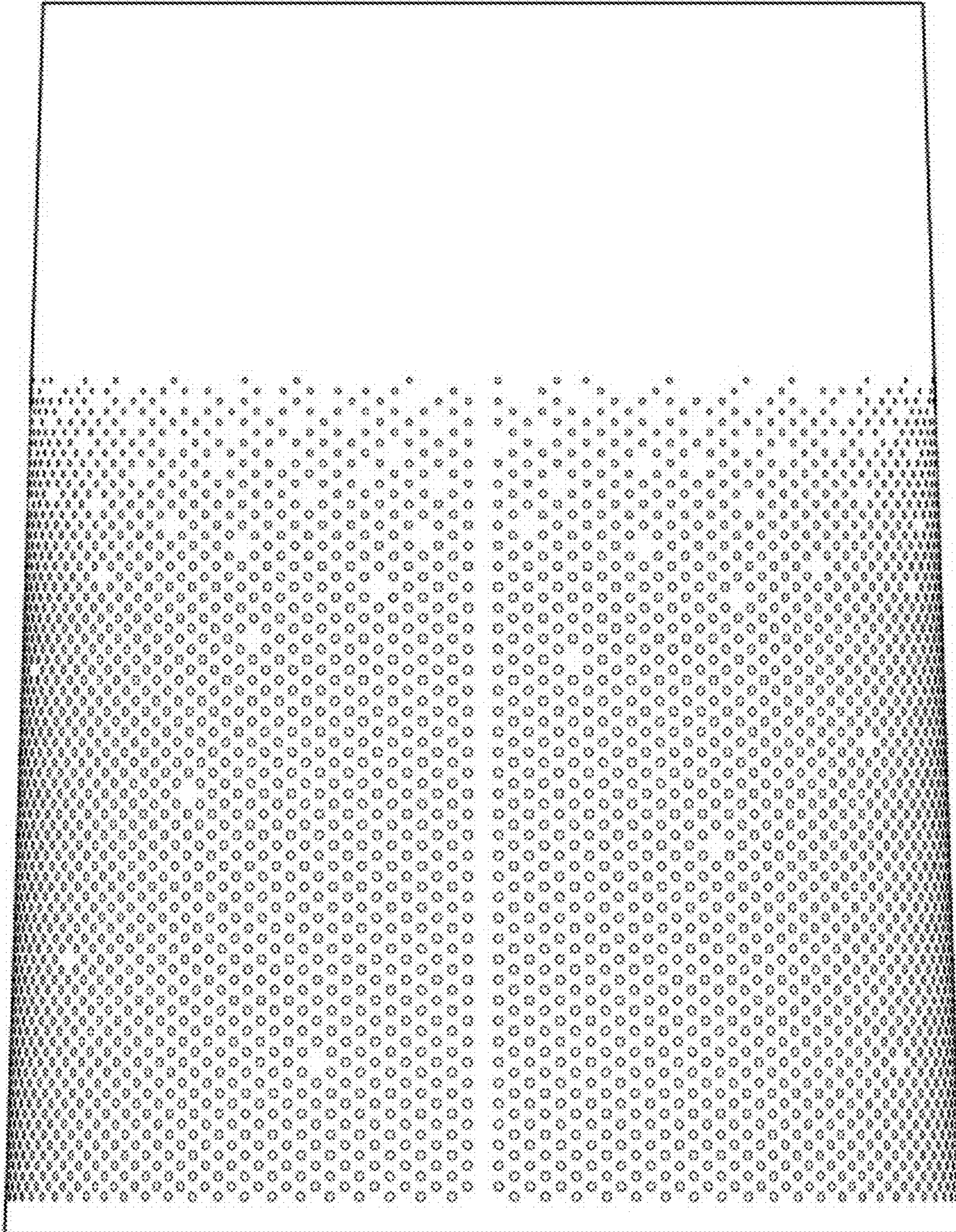

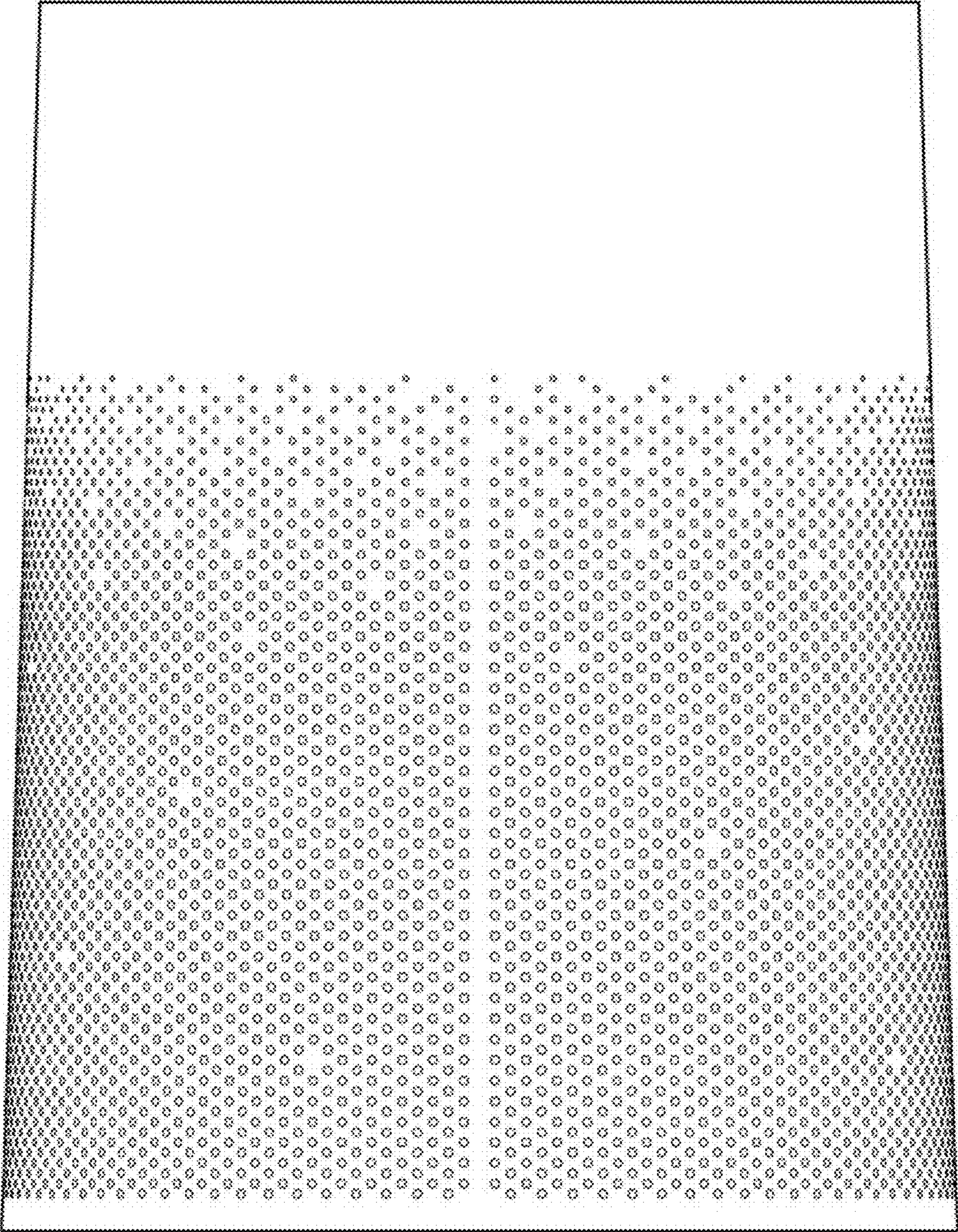

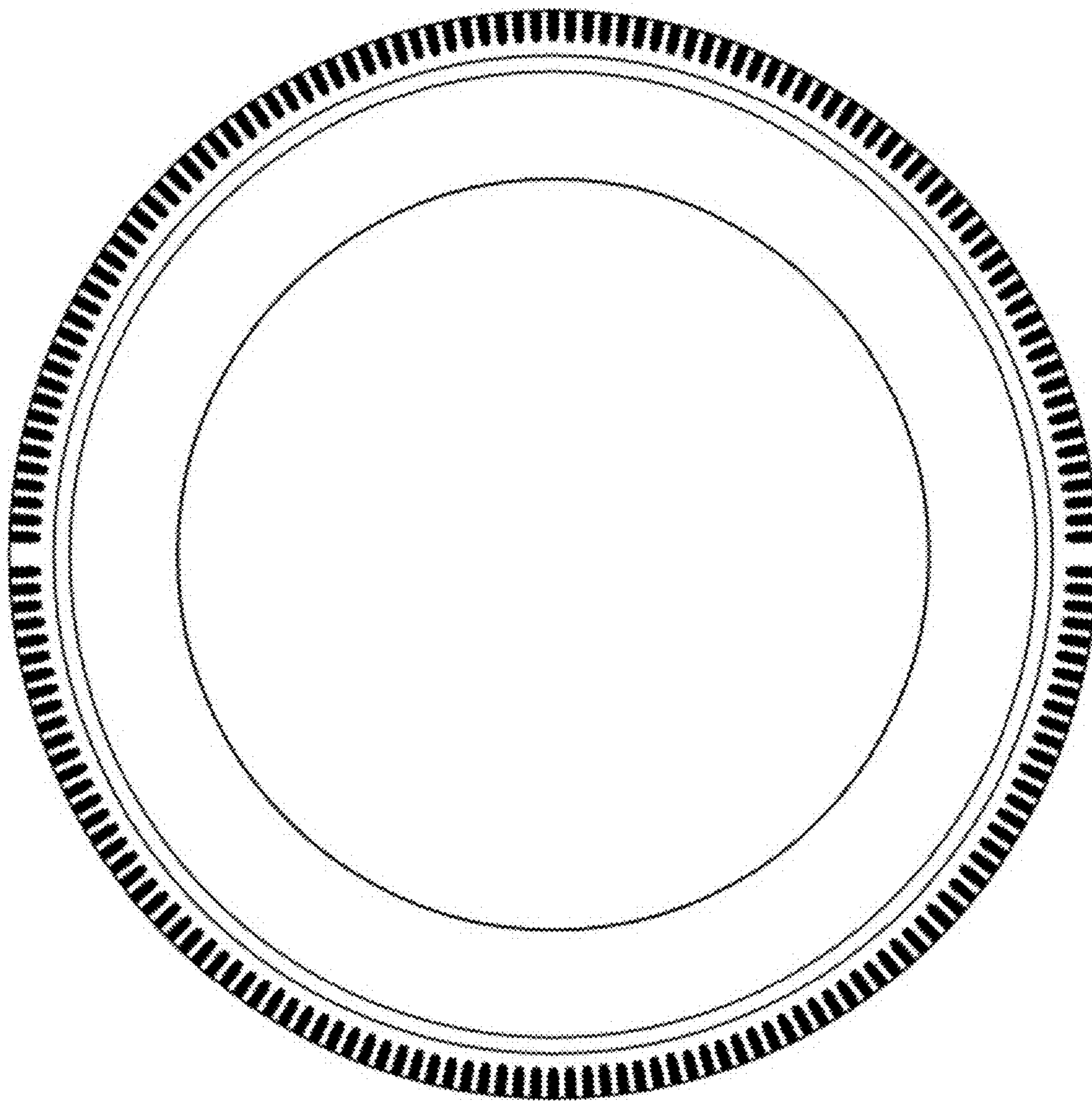

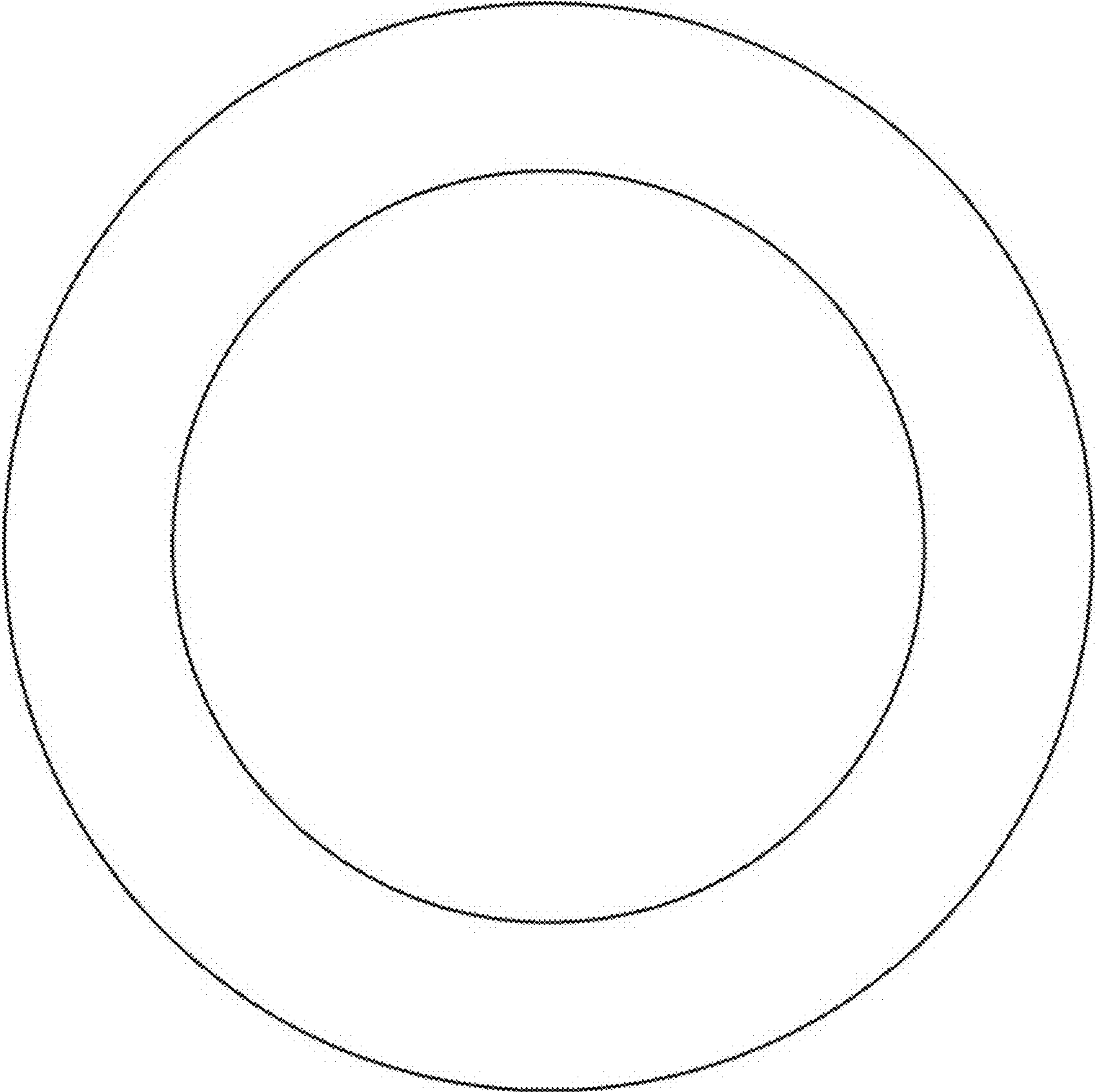
