DESCRIPTION

FIG. 1 is a perspective view of a barrel lighting fixture showing our new design;

FIG. 2 is a top plan view thereof;

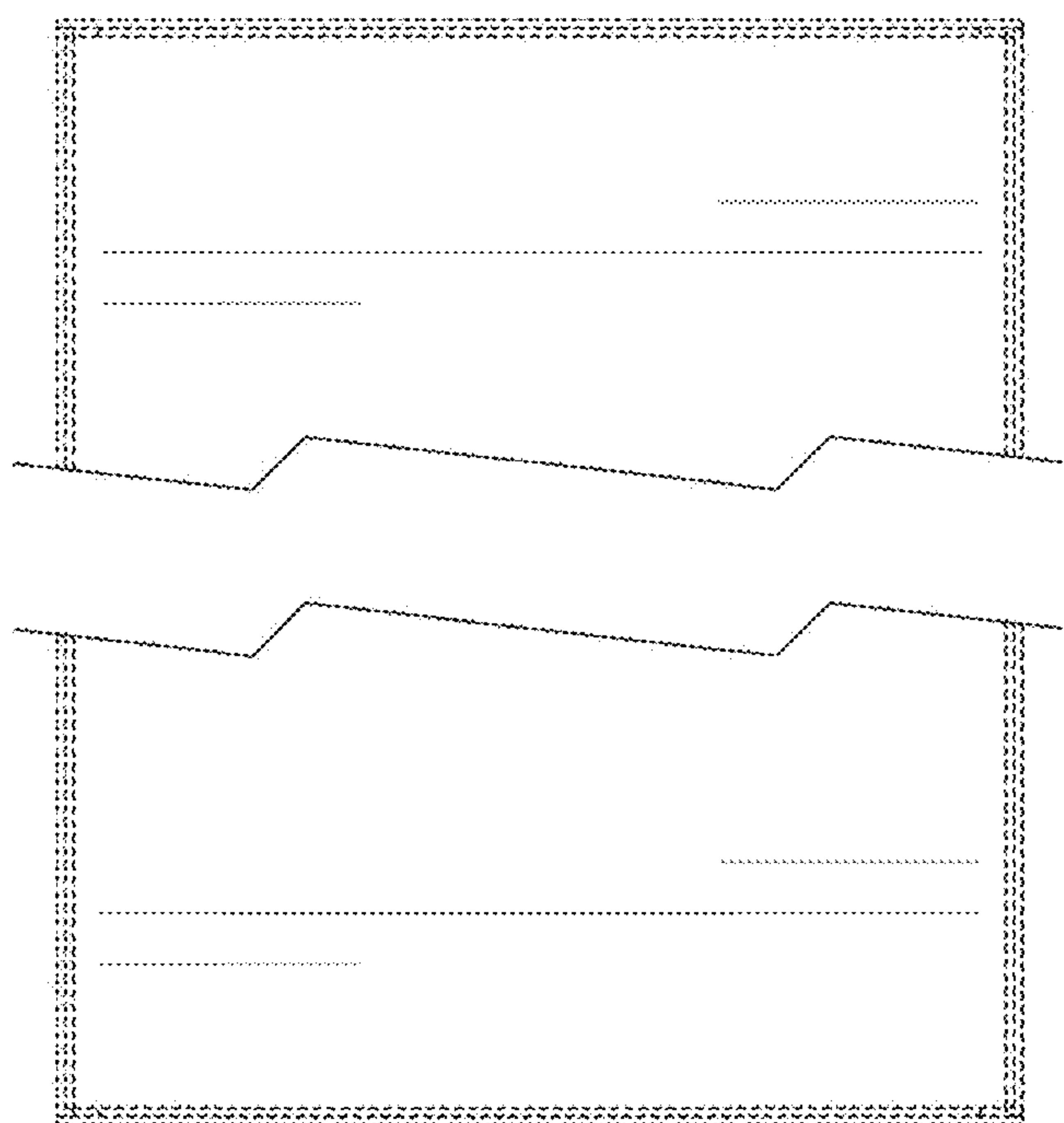
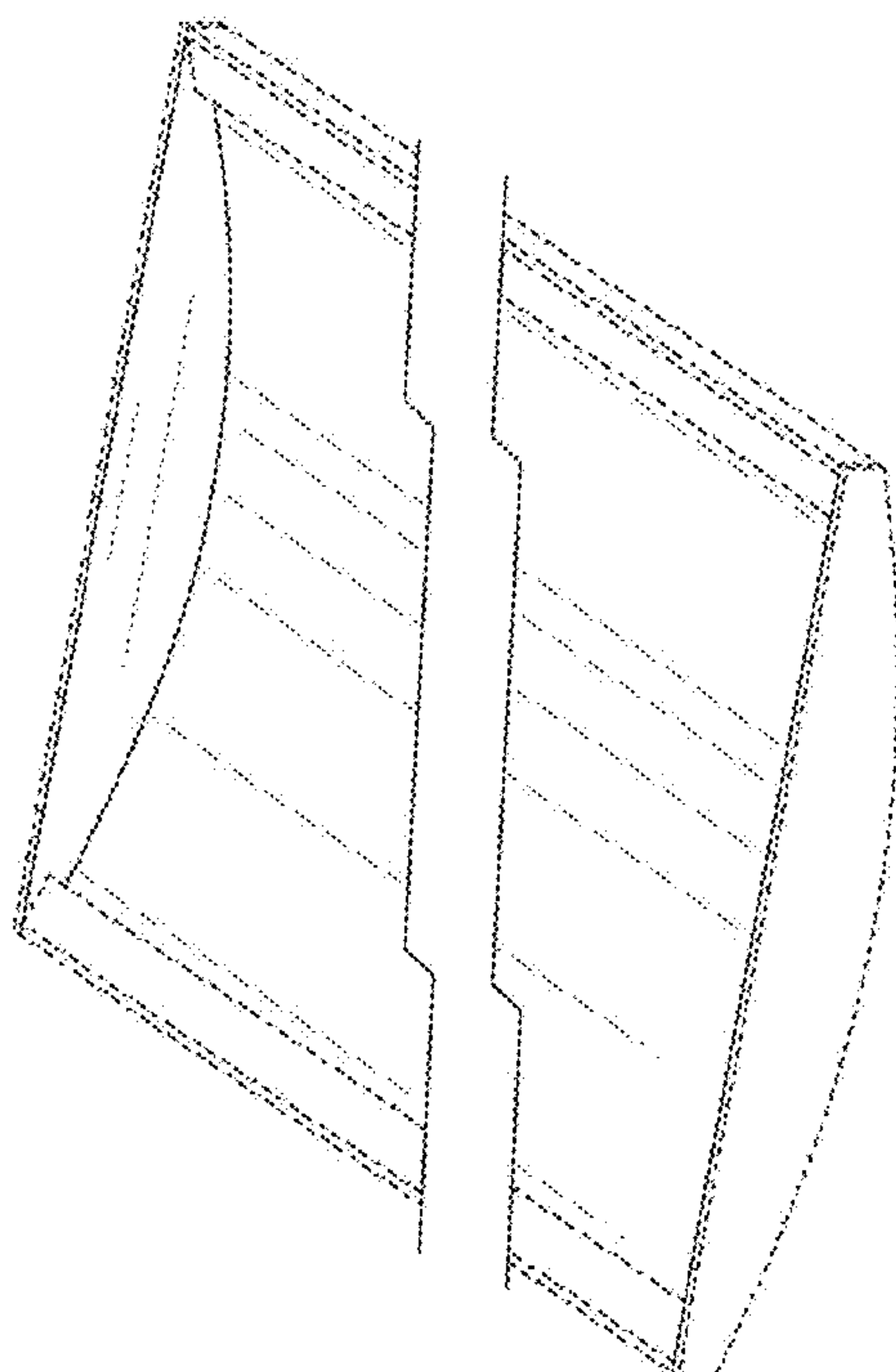
FIG. 3 is a bottom plan view thereof;

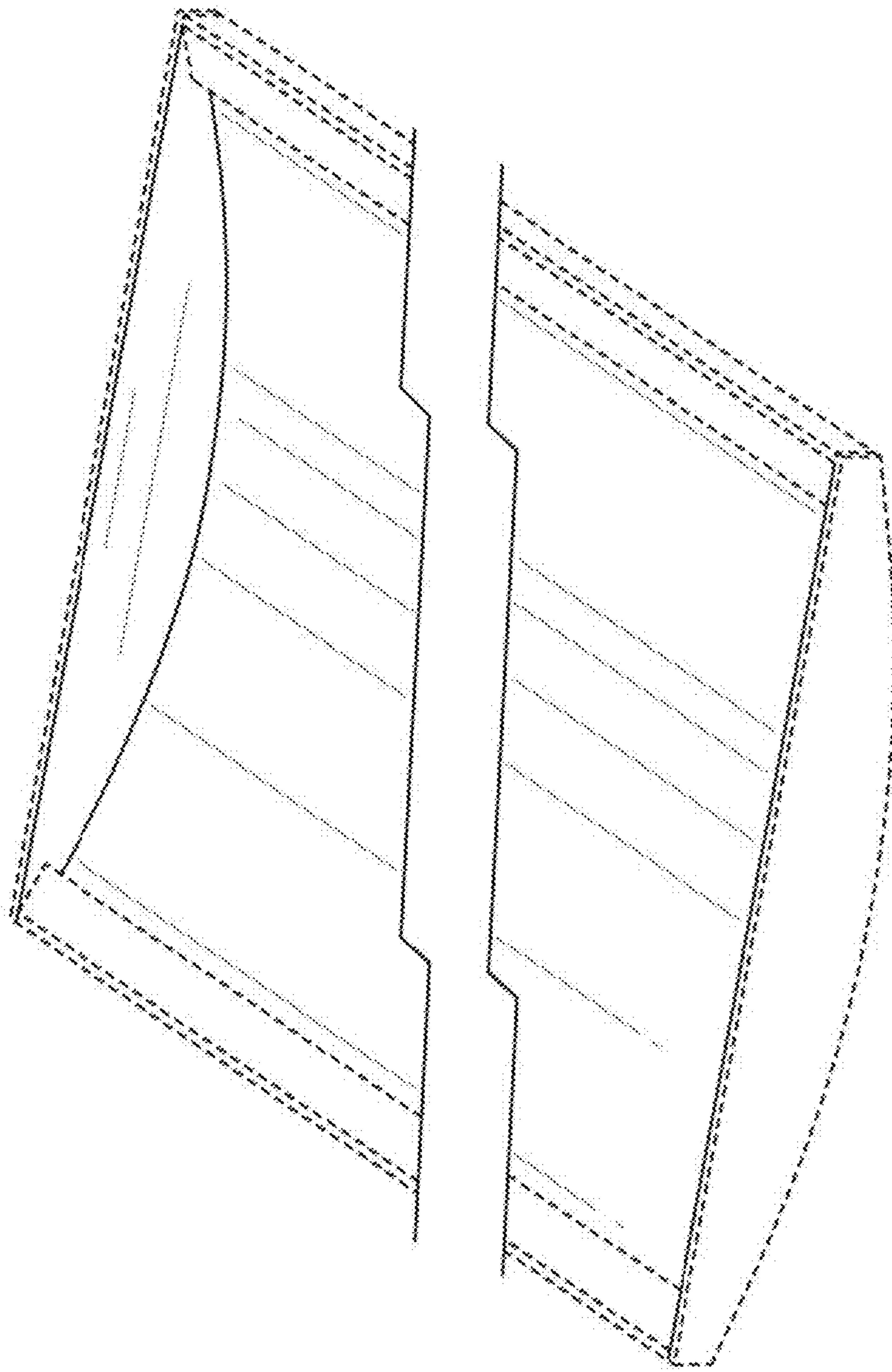

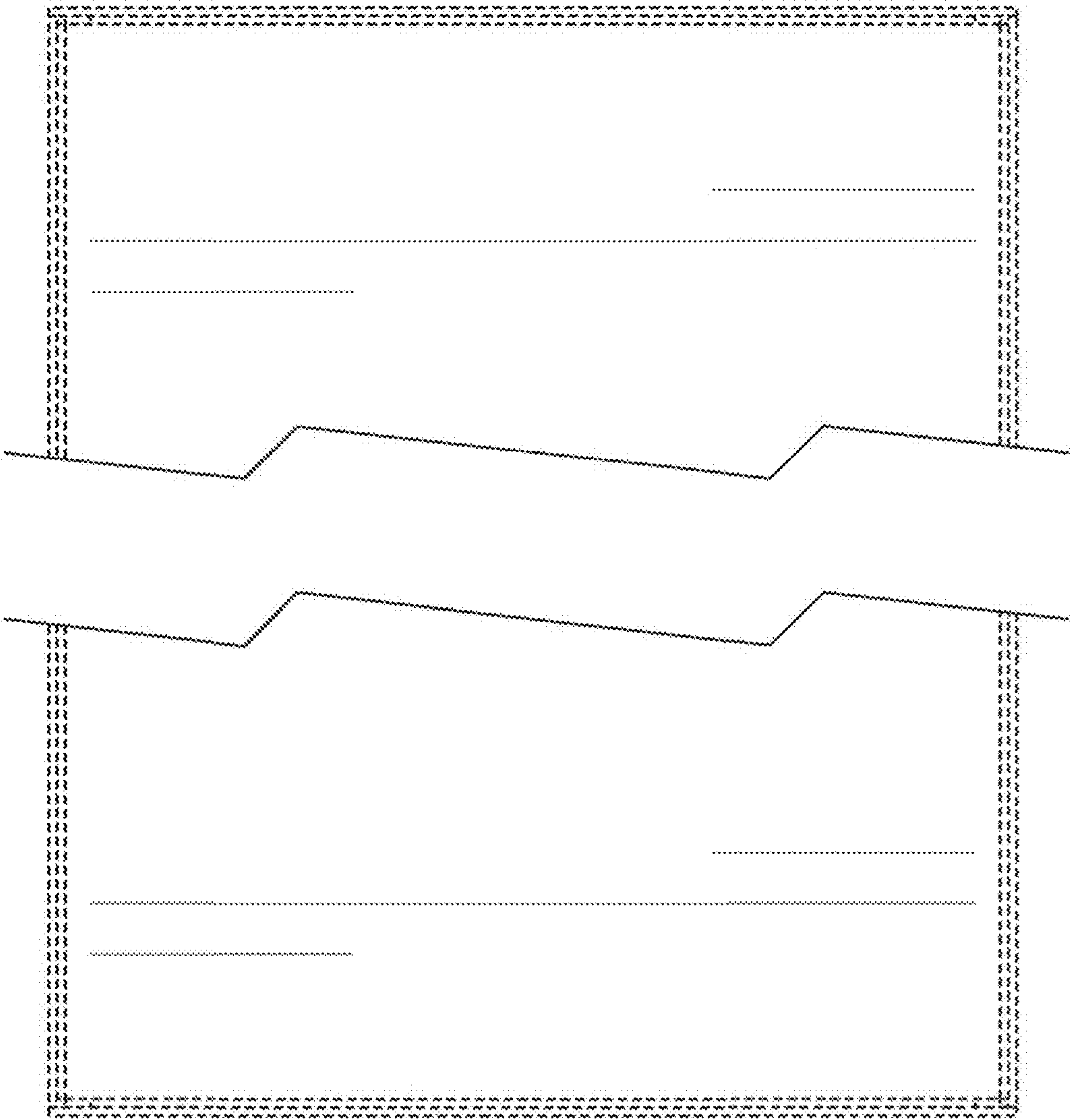

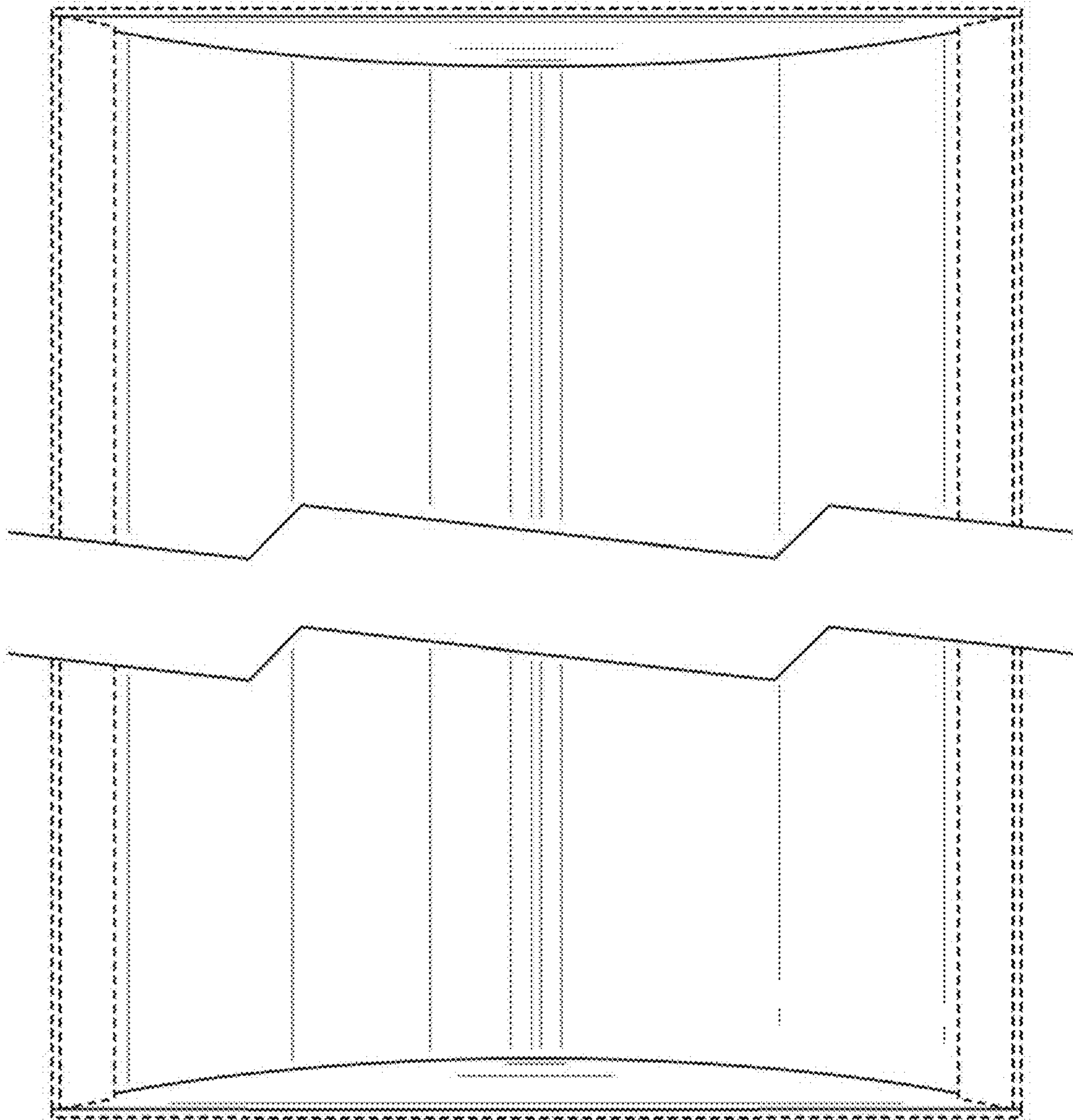

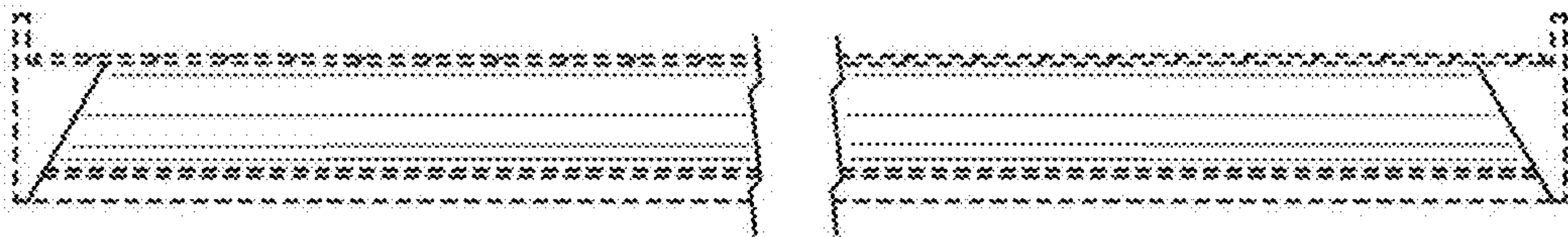
