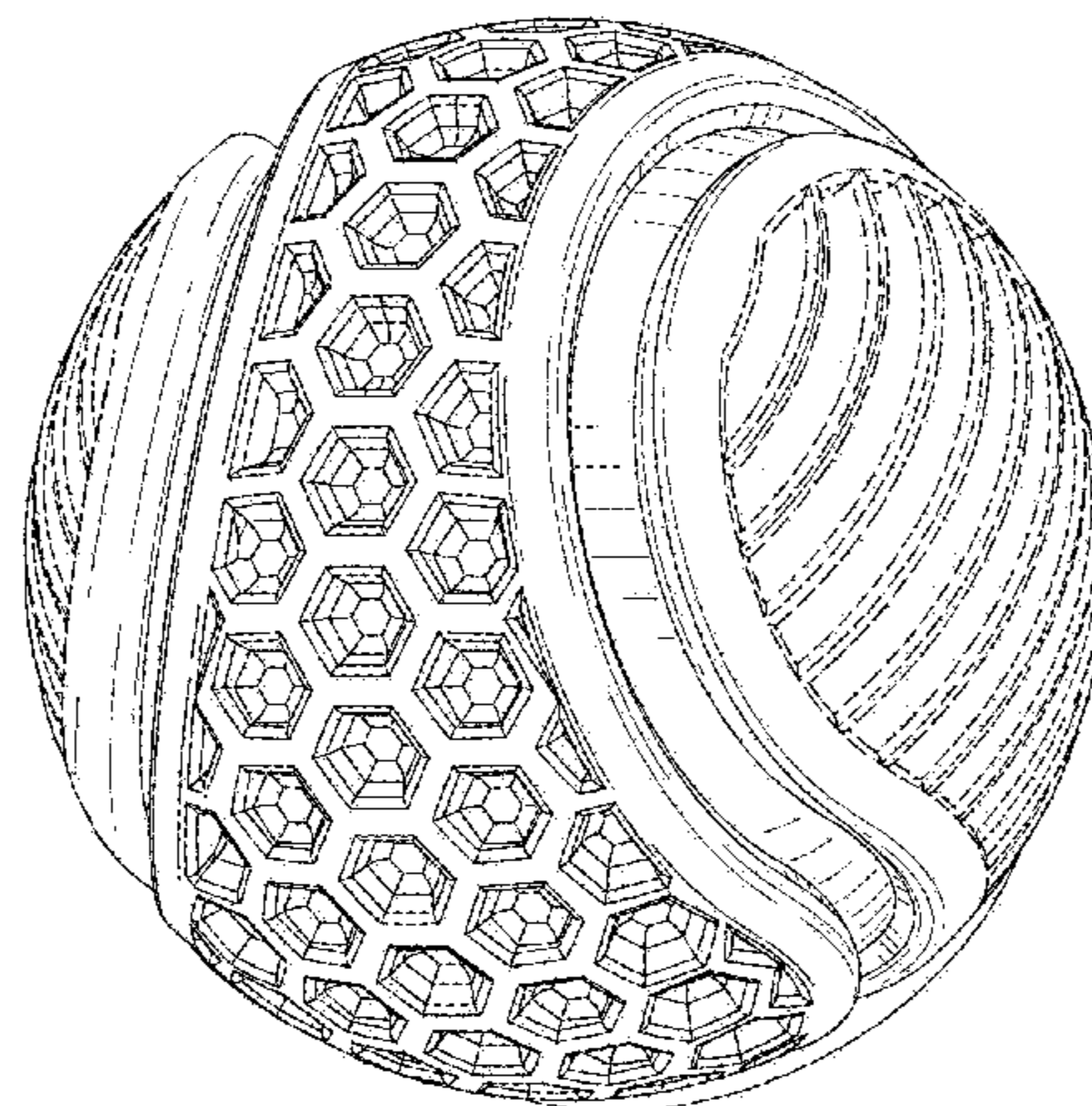
(57) **CLAIM**

I claim the ornamental design for a toy ball, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a toy ball;
 FIG. 2 is a front view of the design of FIG. 1;
 FIG. 3 is a rear view of the design of FIG. 1;
 FIG. 4 is a top view of the design of FIG. 1;
 FIG. 5 is a bottom view of the design of FIG. 1;
 FIG. 6 is a left view of the design of FIG. 1;
 FIG. 7 is a right view of the design of FIG. 1;
 FIG. 8 is a front perspective view of a second embodiment of a toy ball;
 FIG. 9 is a front view of the design of FIG. 8;
 FIG. 10 is a rear view of the design of FIG. 8;
 FIG. 11 is a top view of the design of FIG. 8;
 FIG. 12 is a bottom view of the design of FIG. 8;

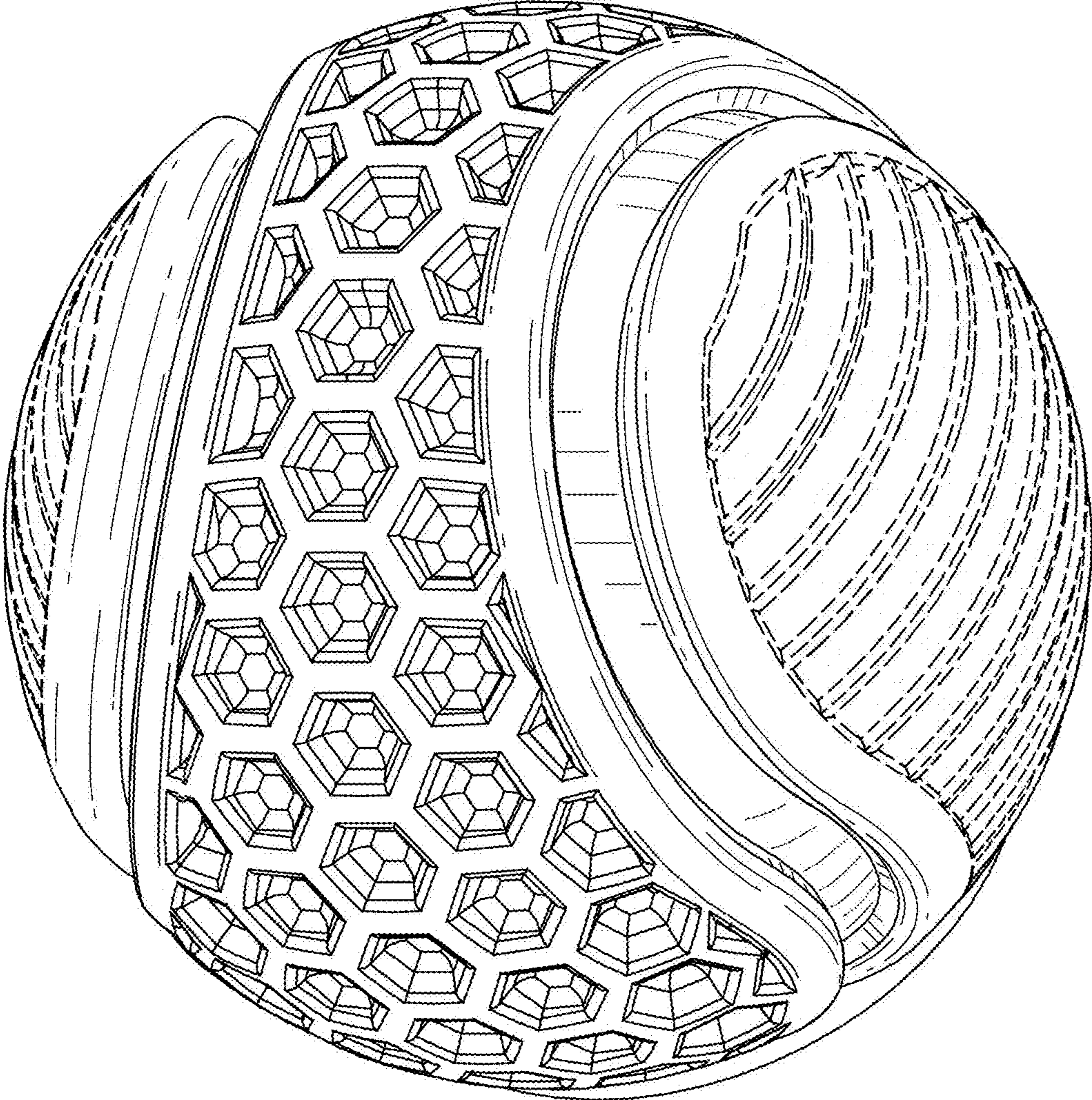

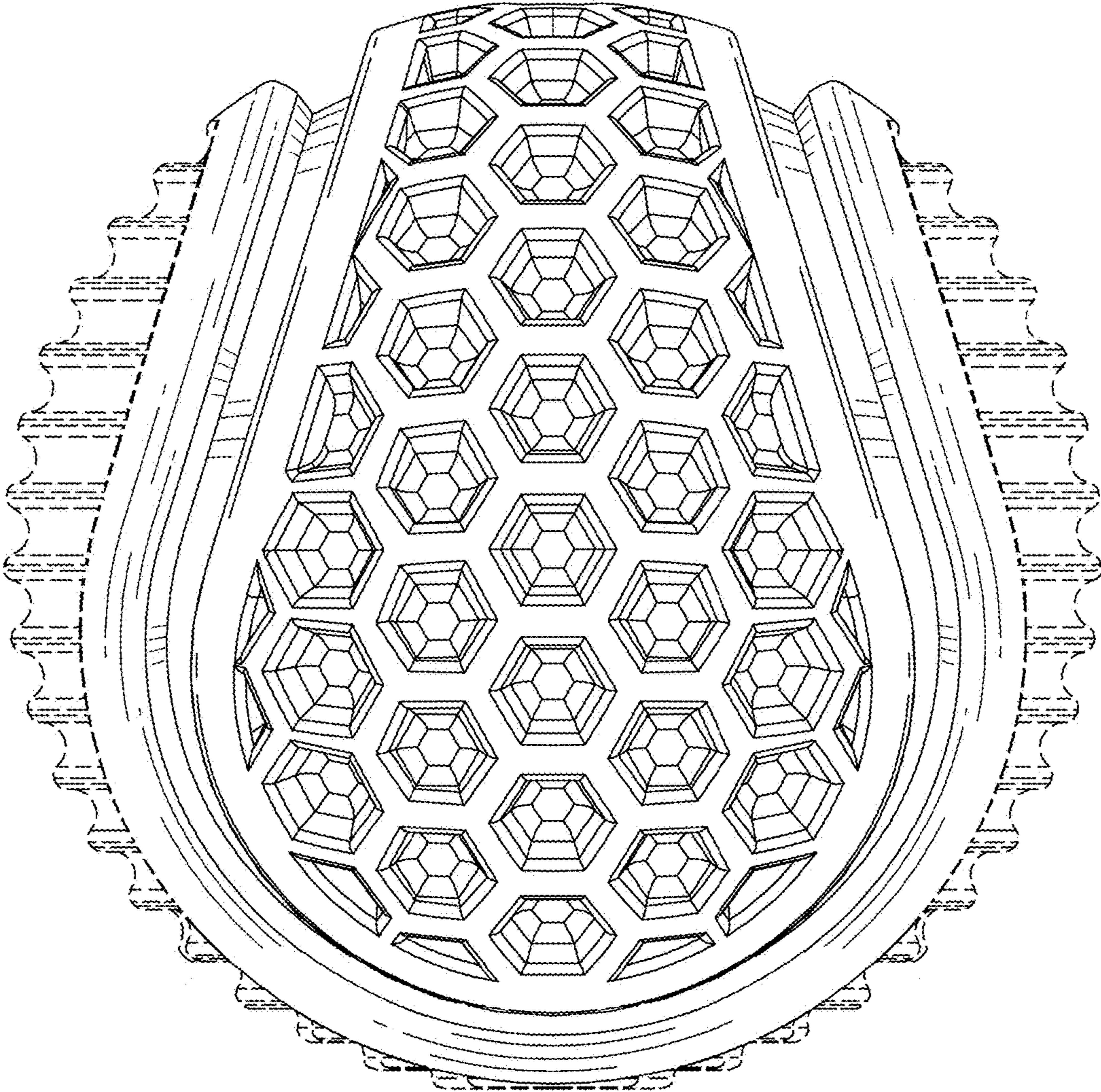

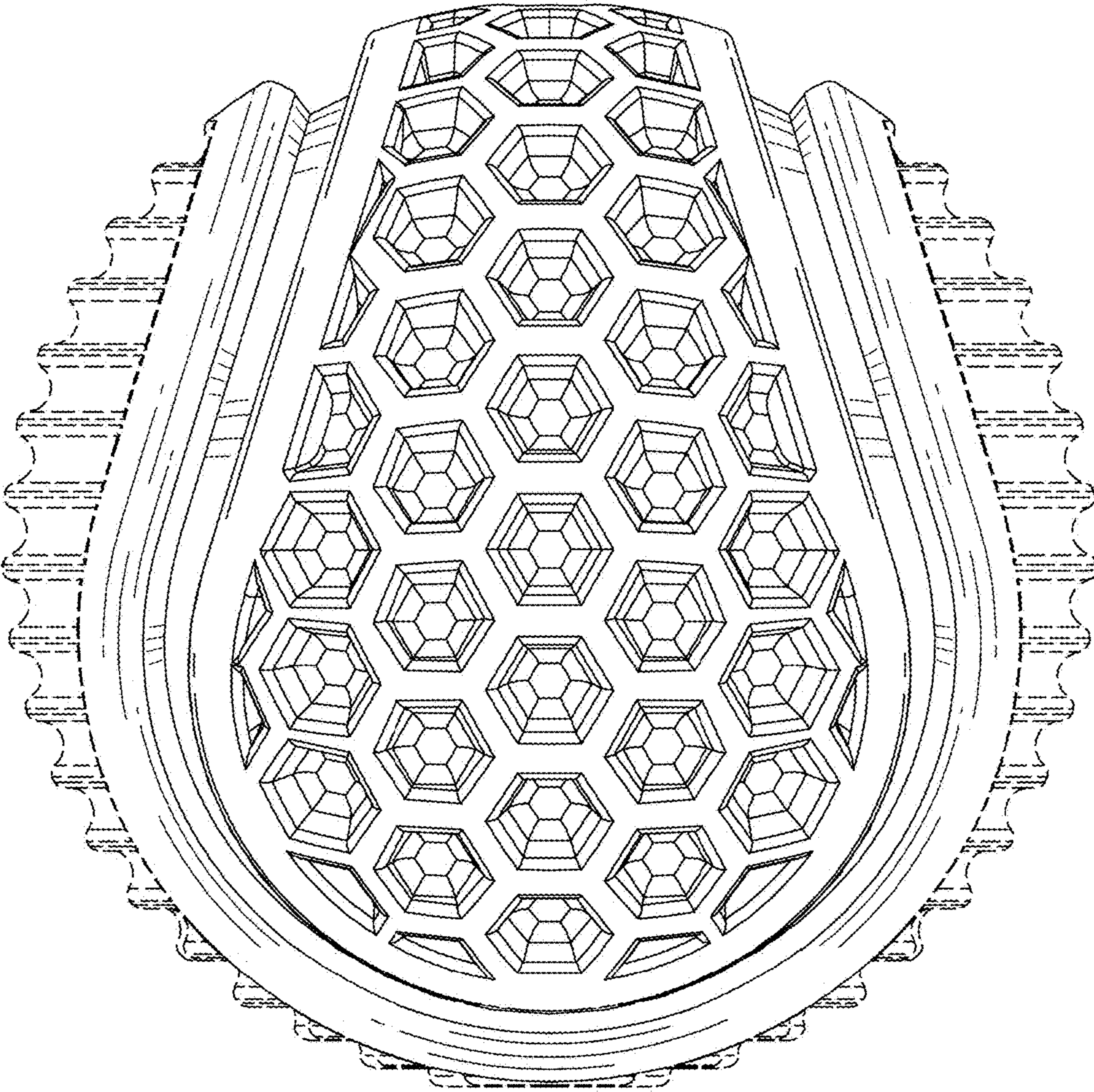

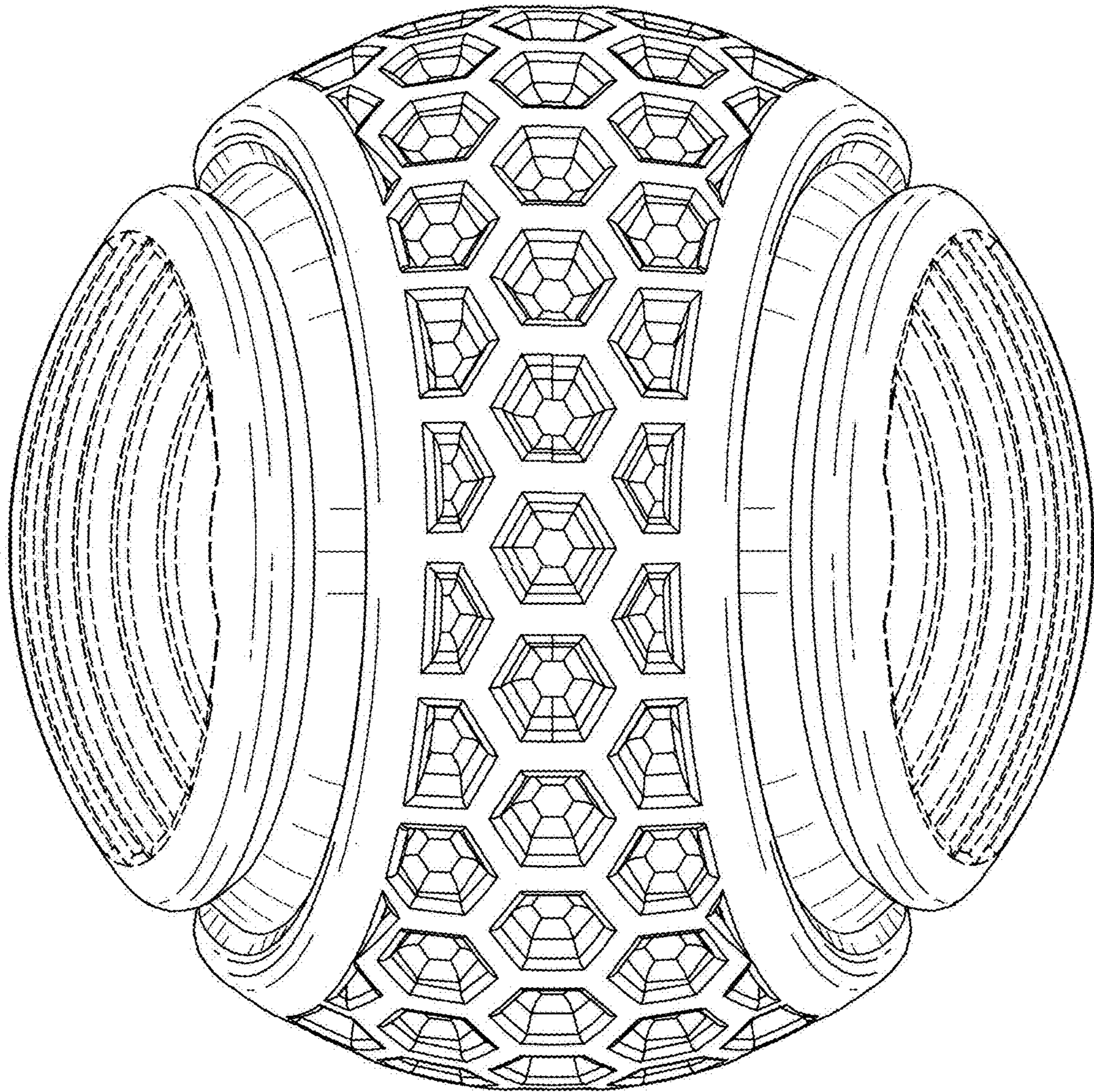

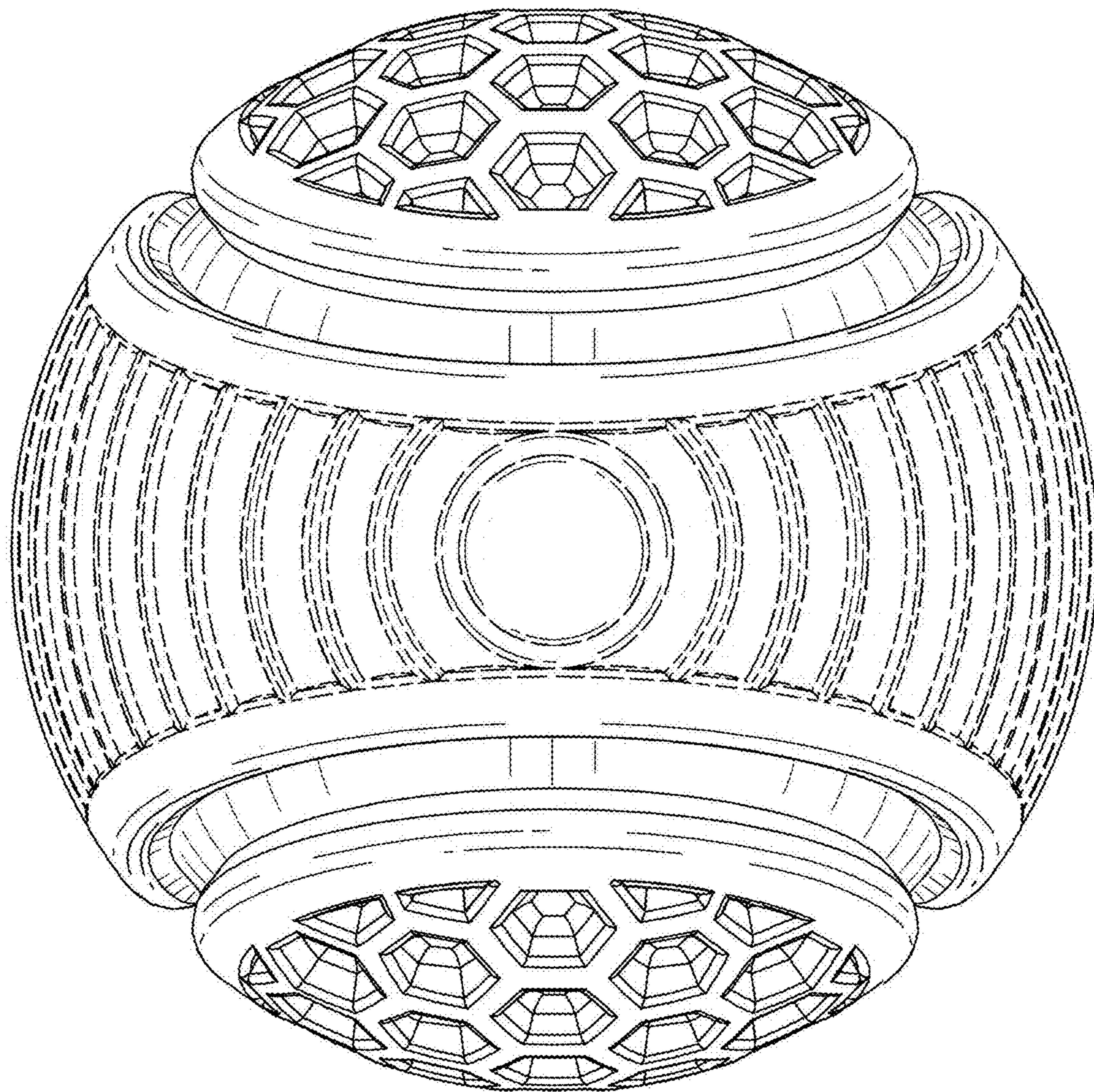

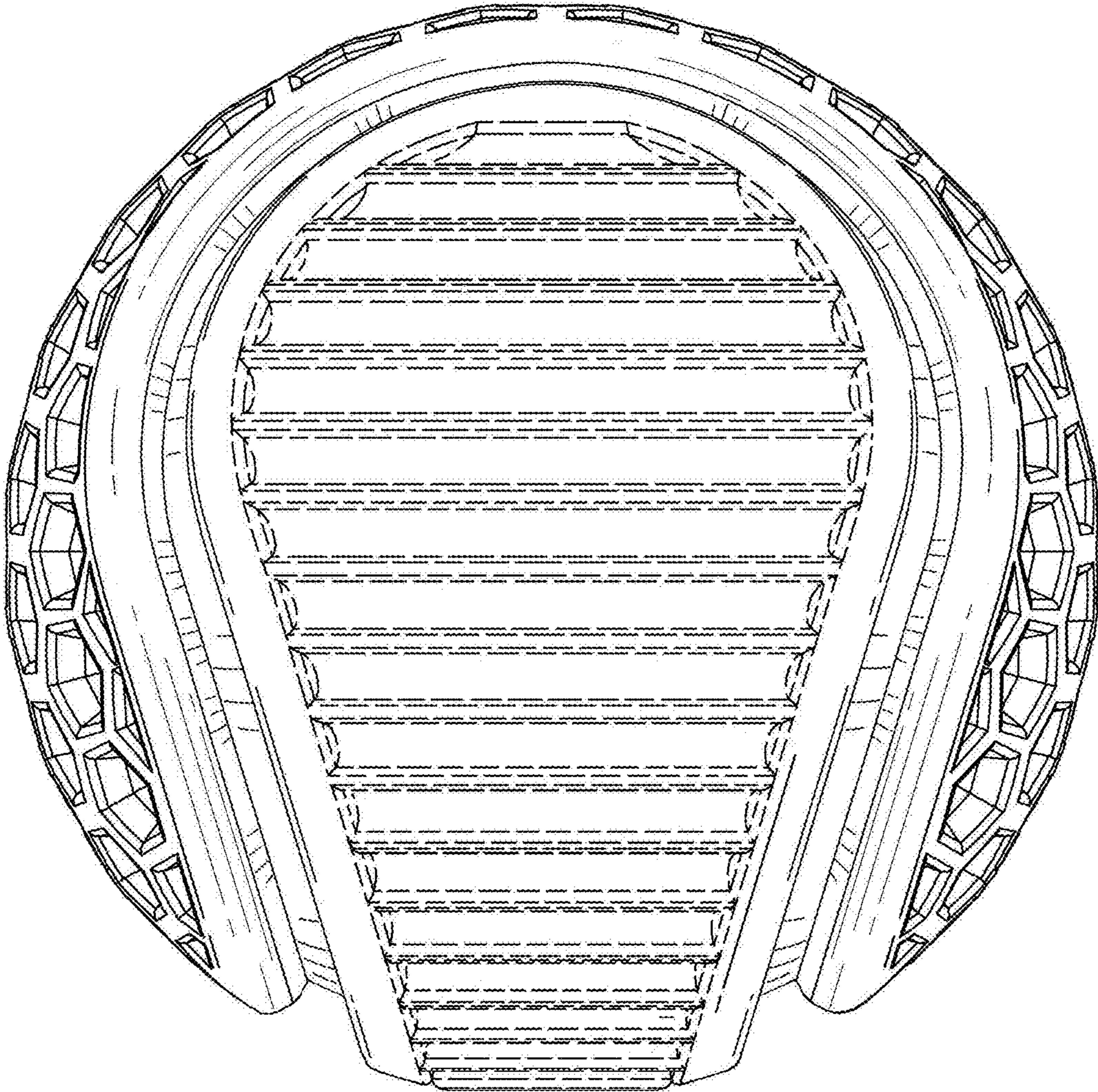

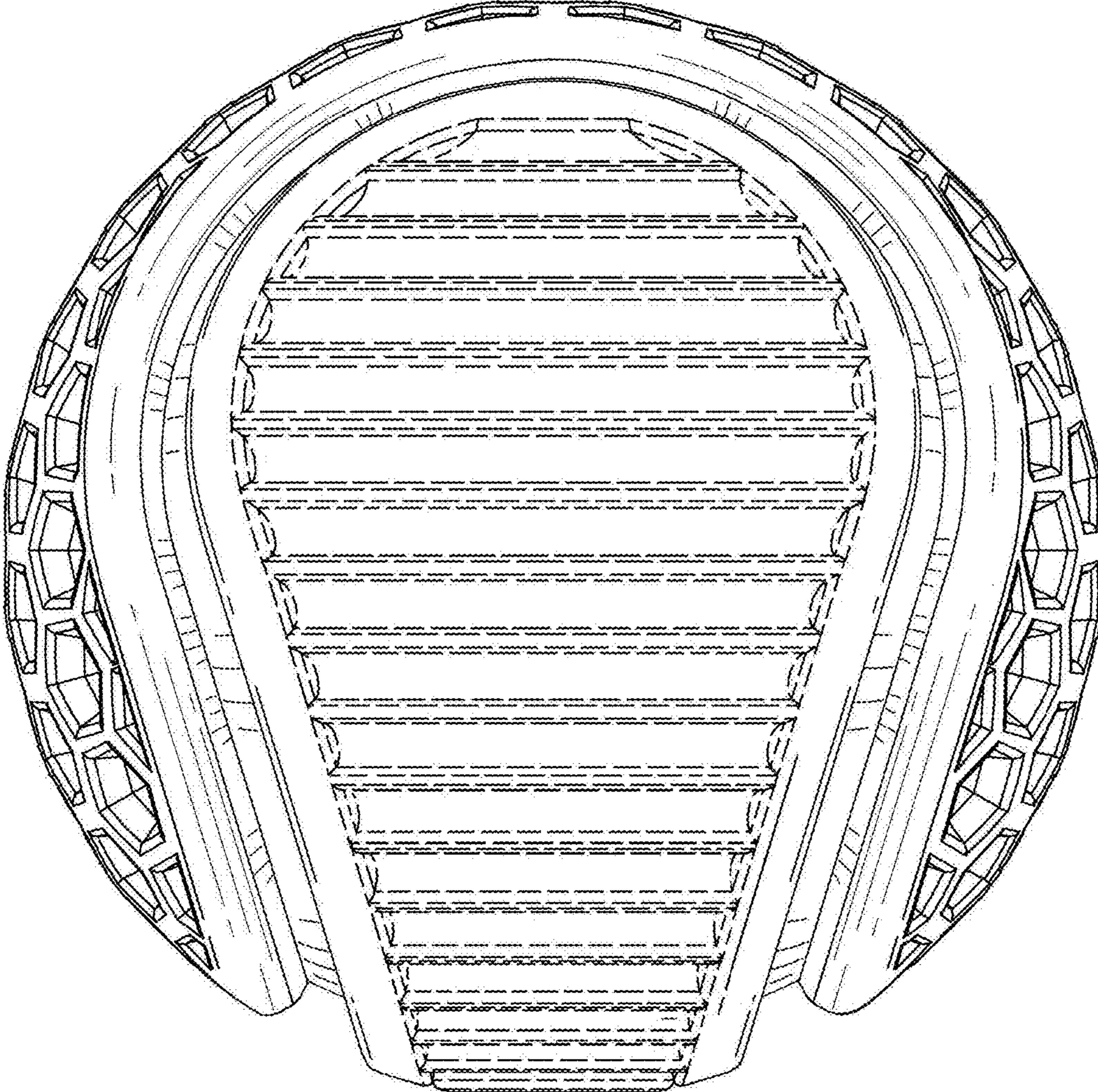

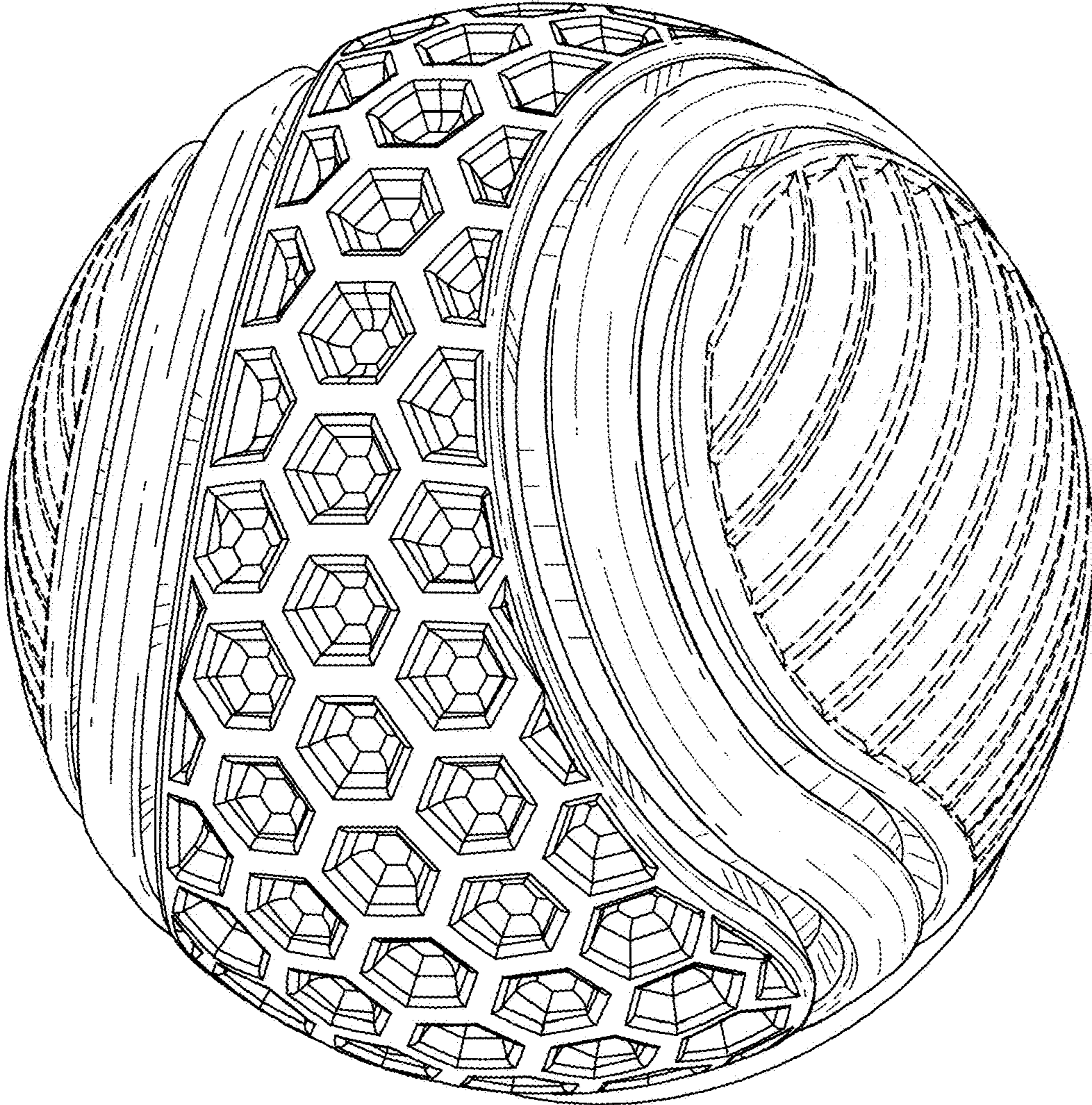

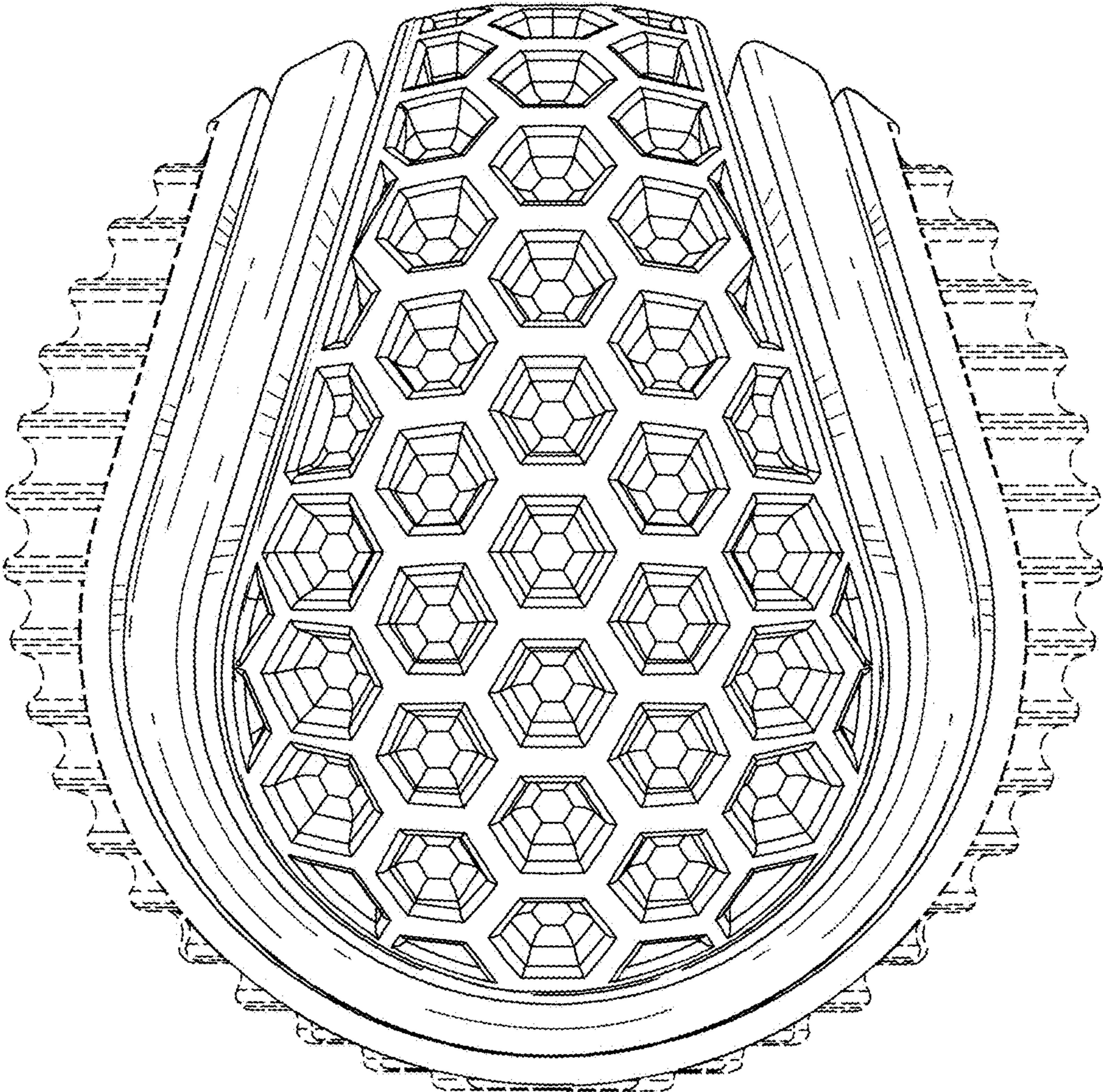

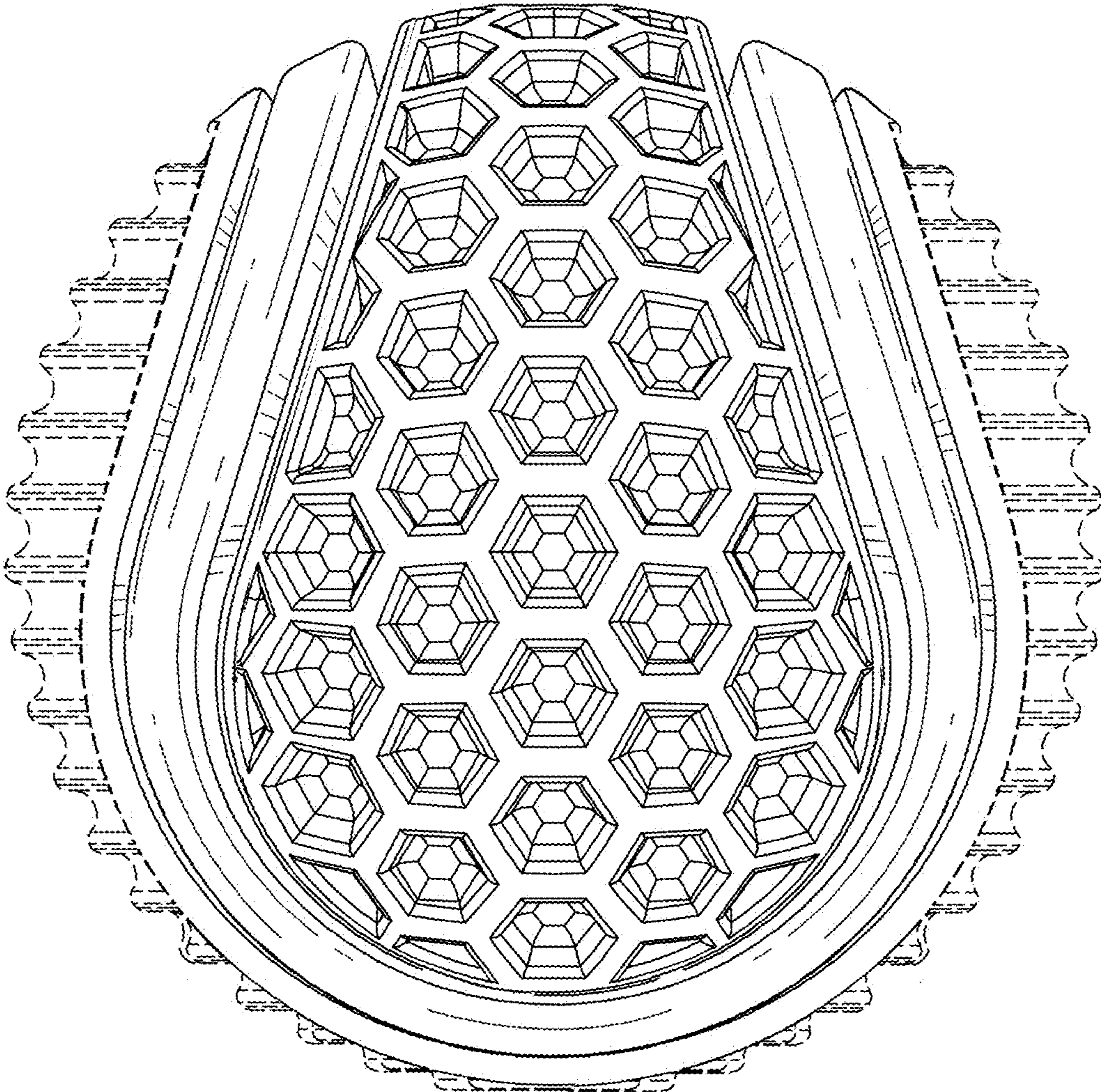

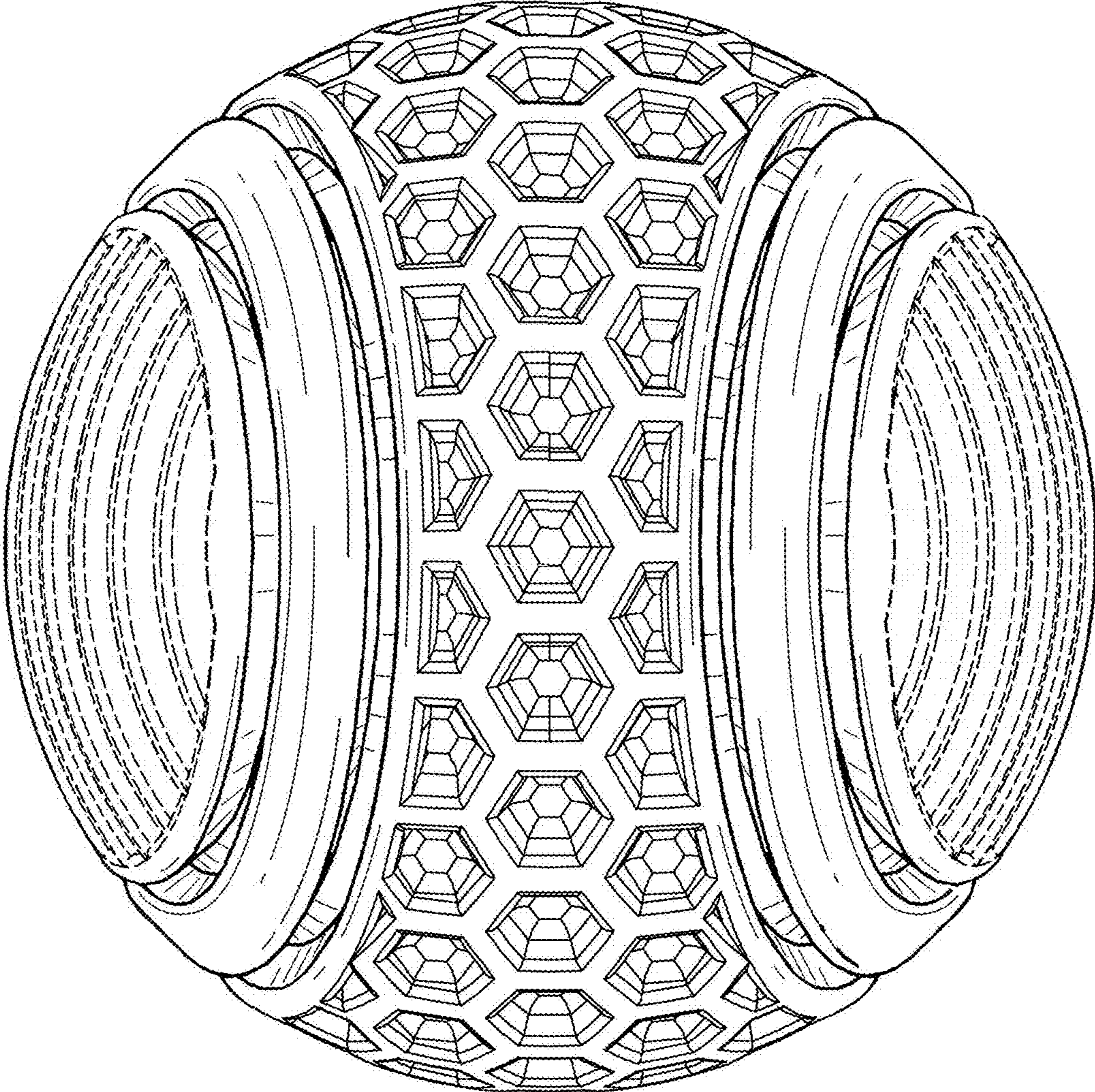

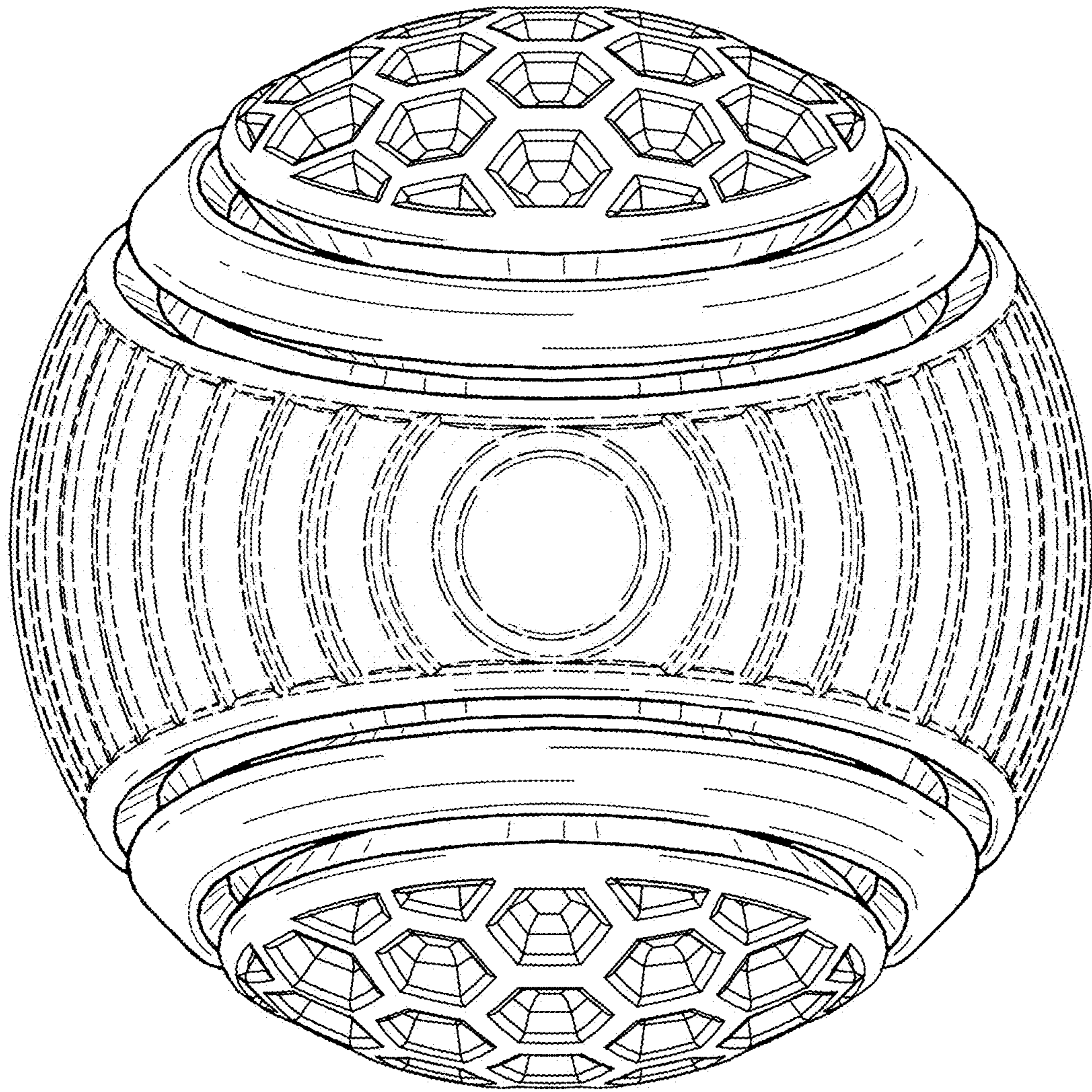

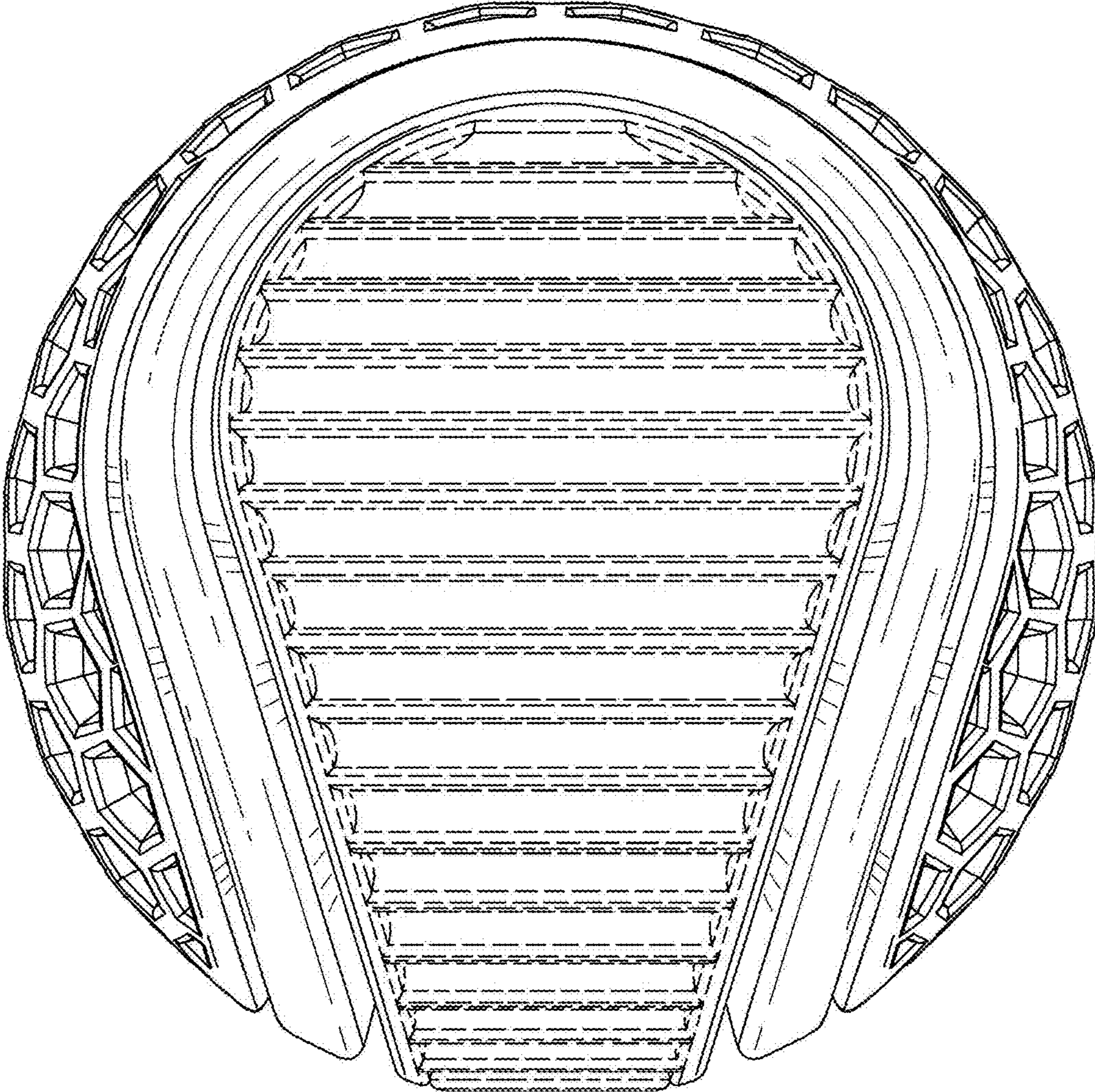

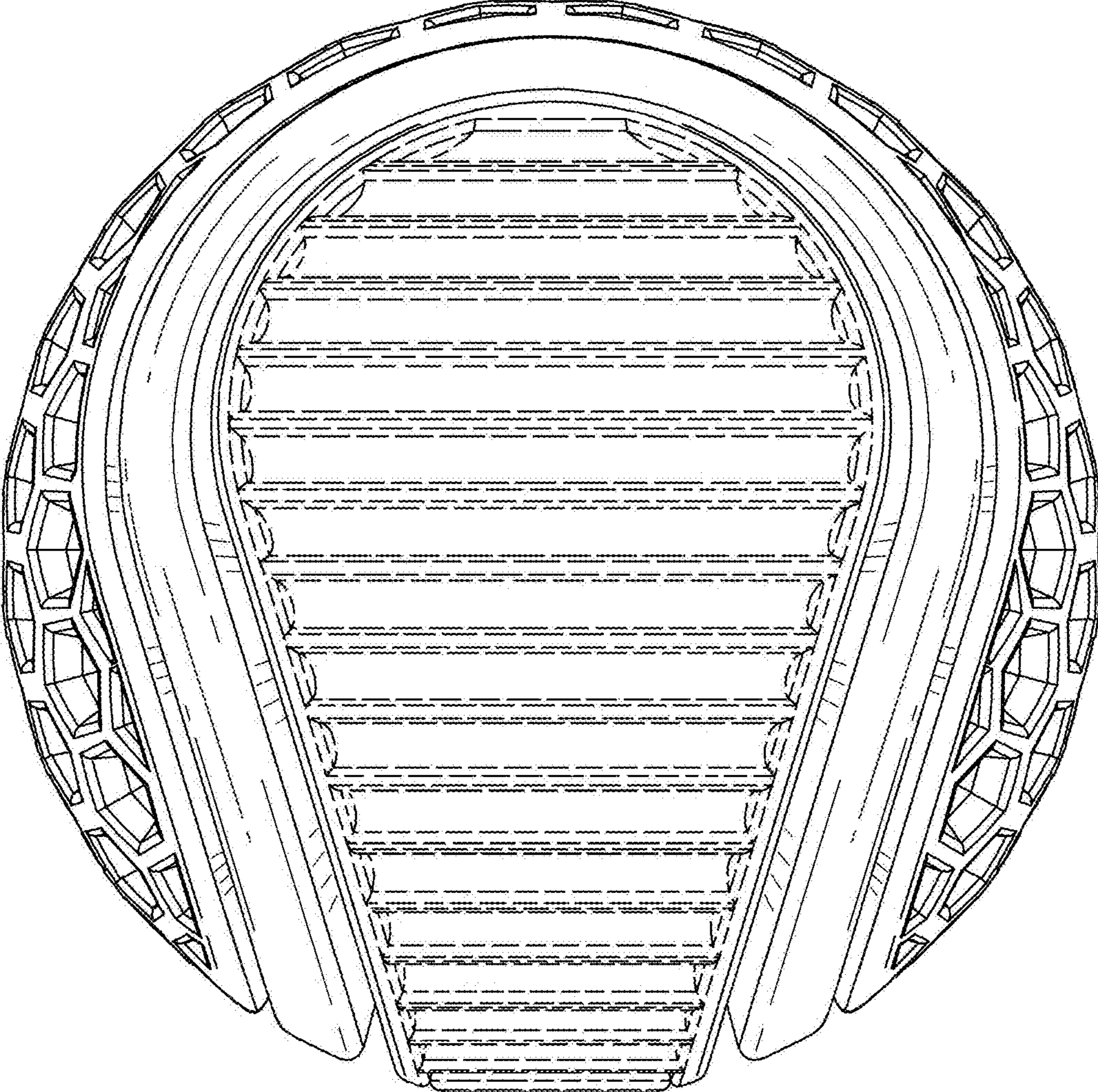
