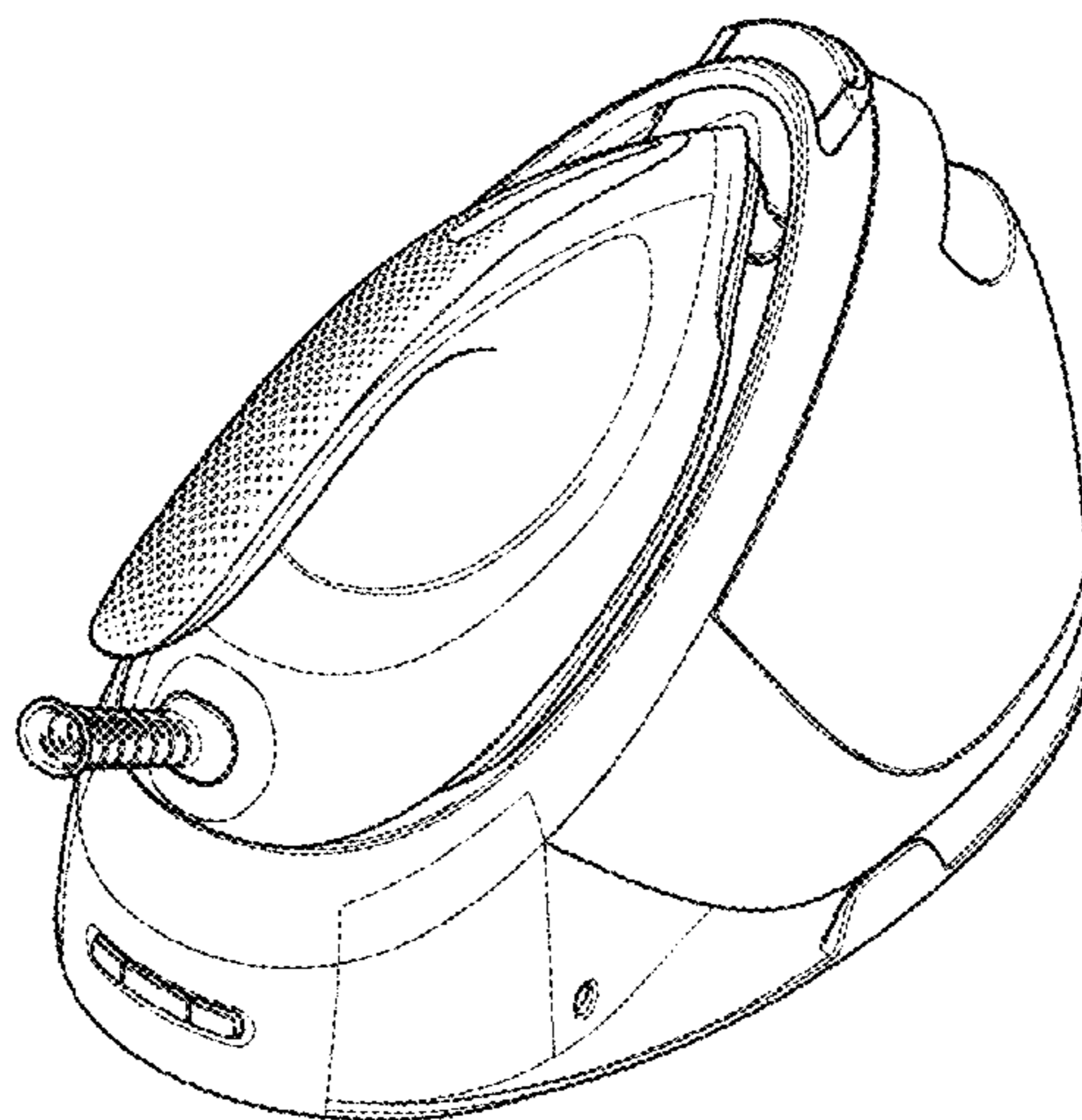
(57) **CLAIM**

The ornamental design for an iron with steam generator, as shown and described.

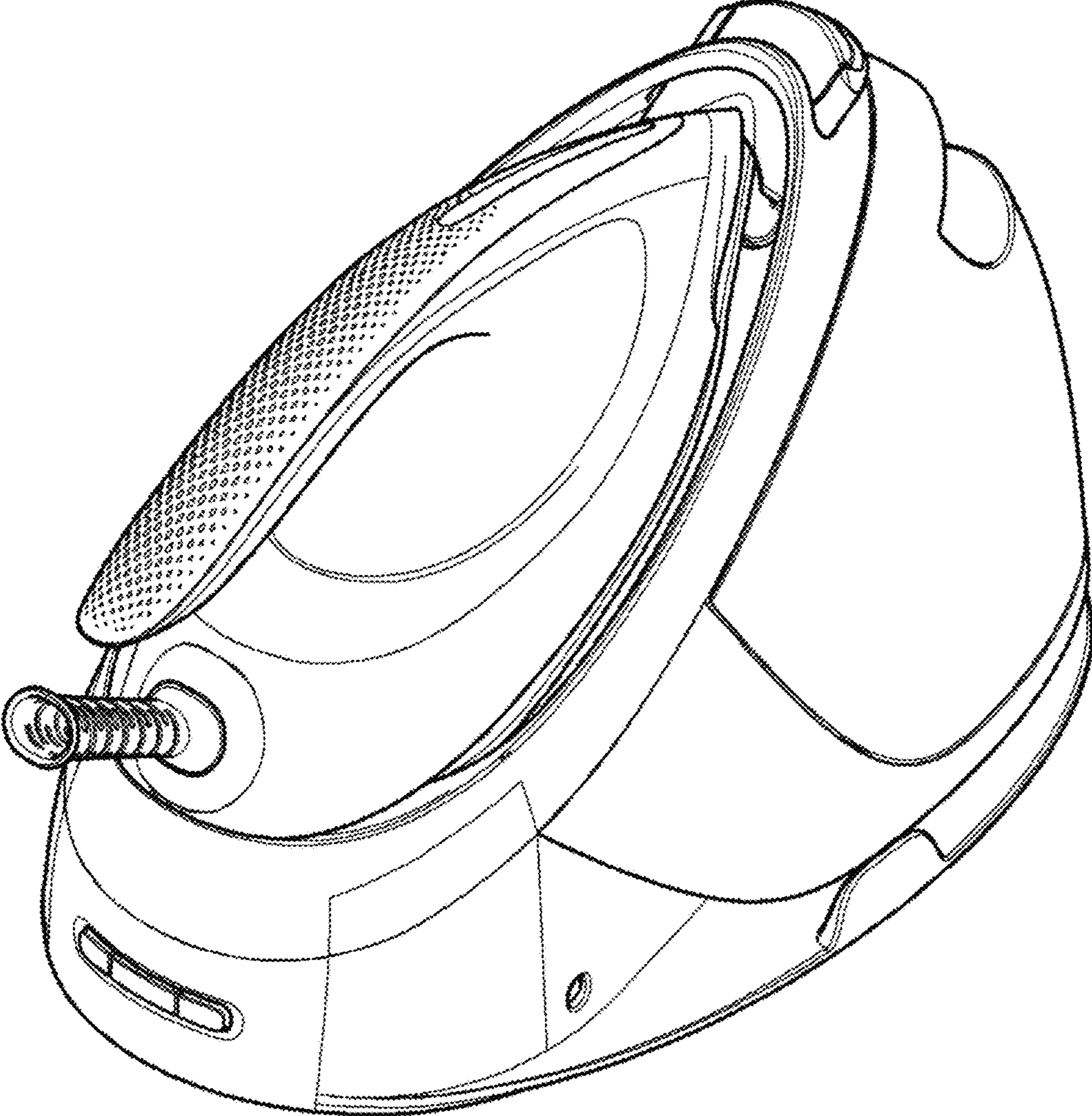
**DESCRIPTION**

**1.7** is a bottom plan view thereof.

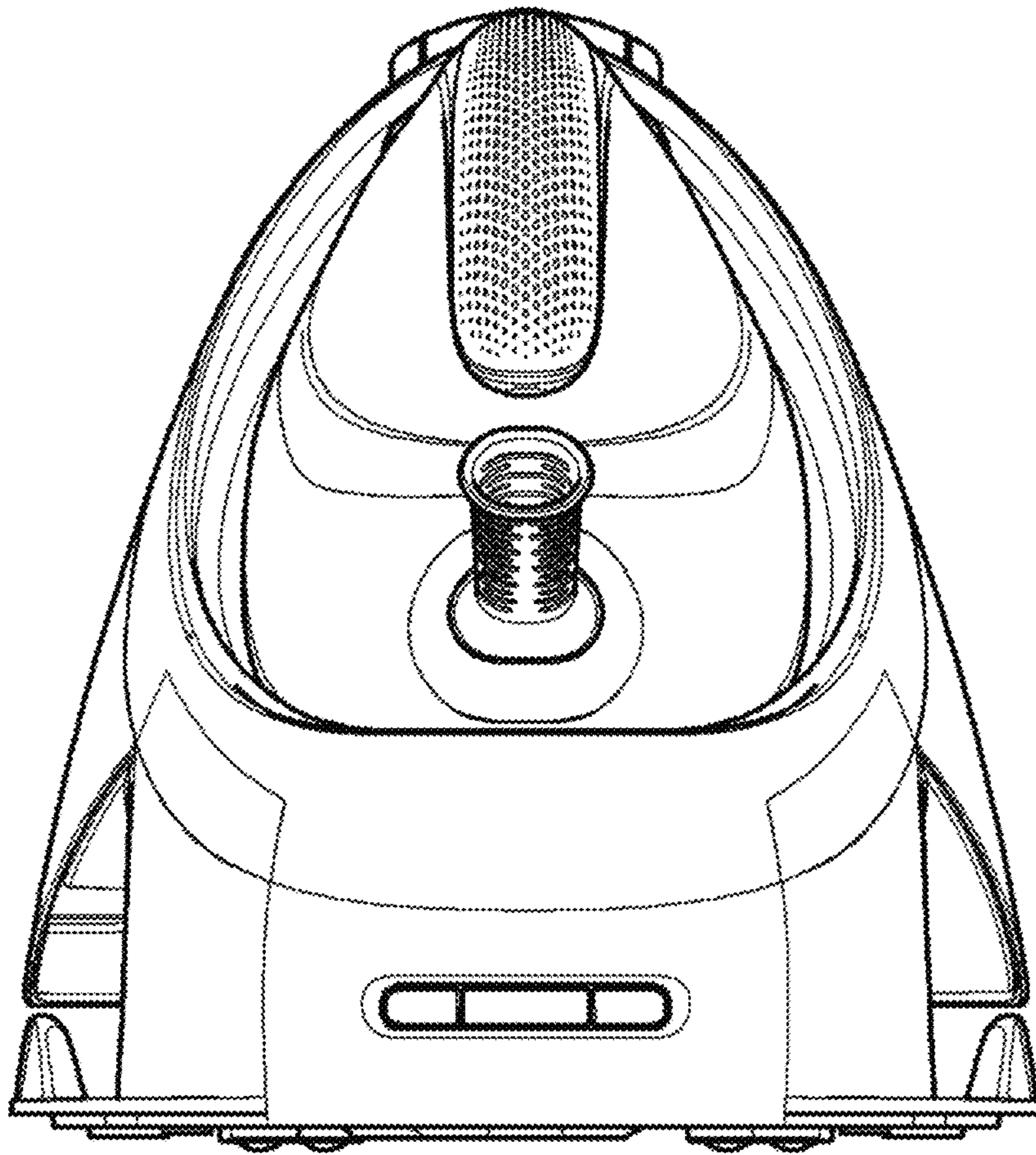

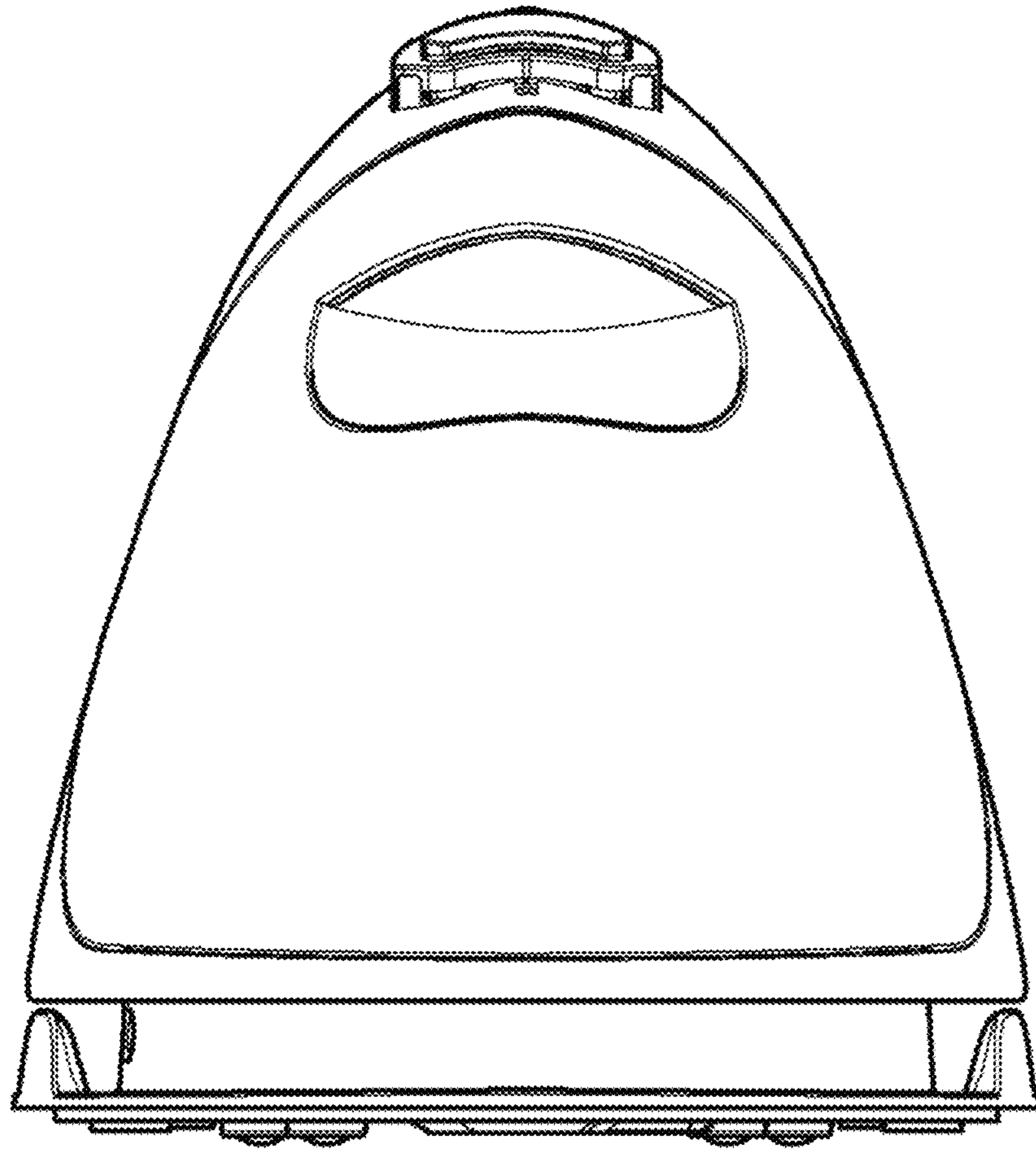

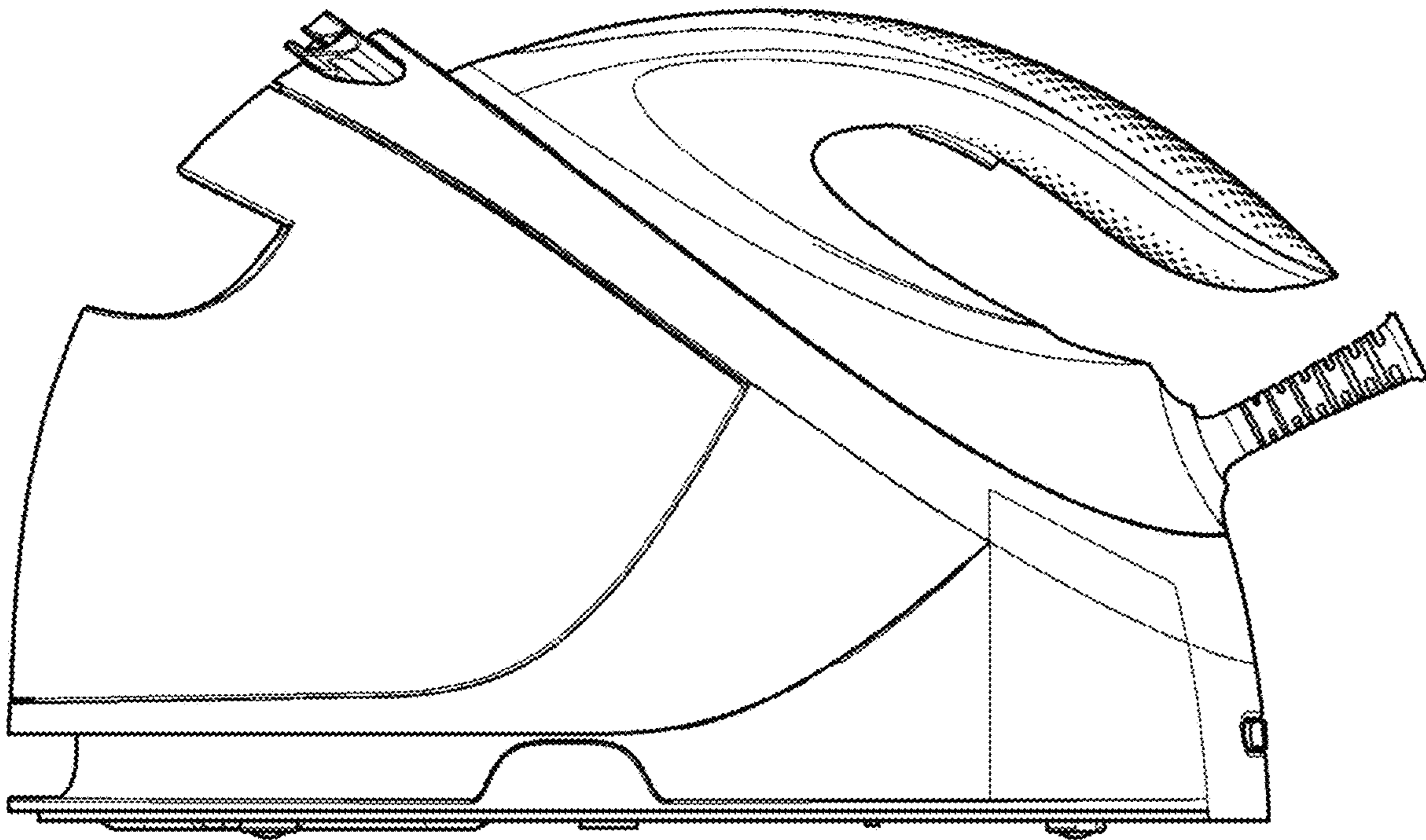

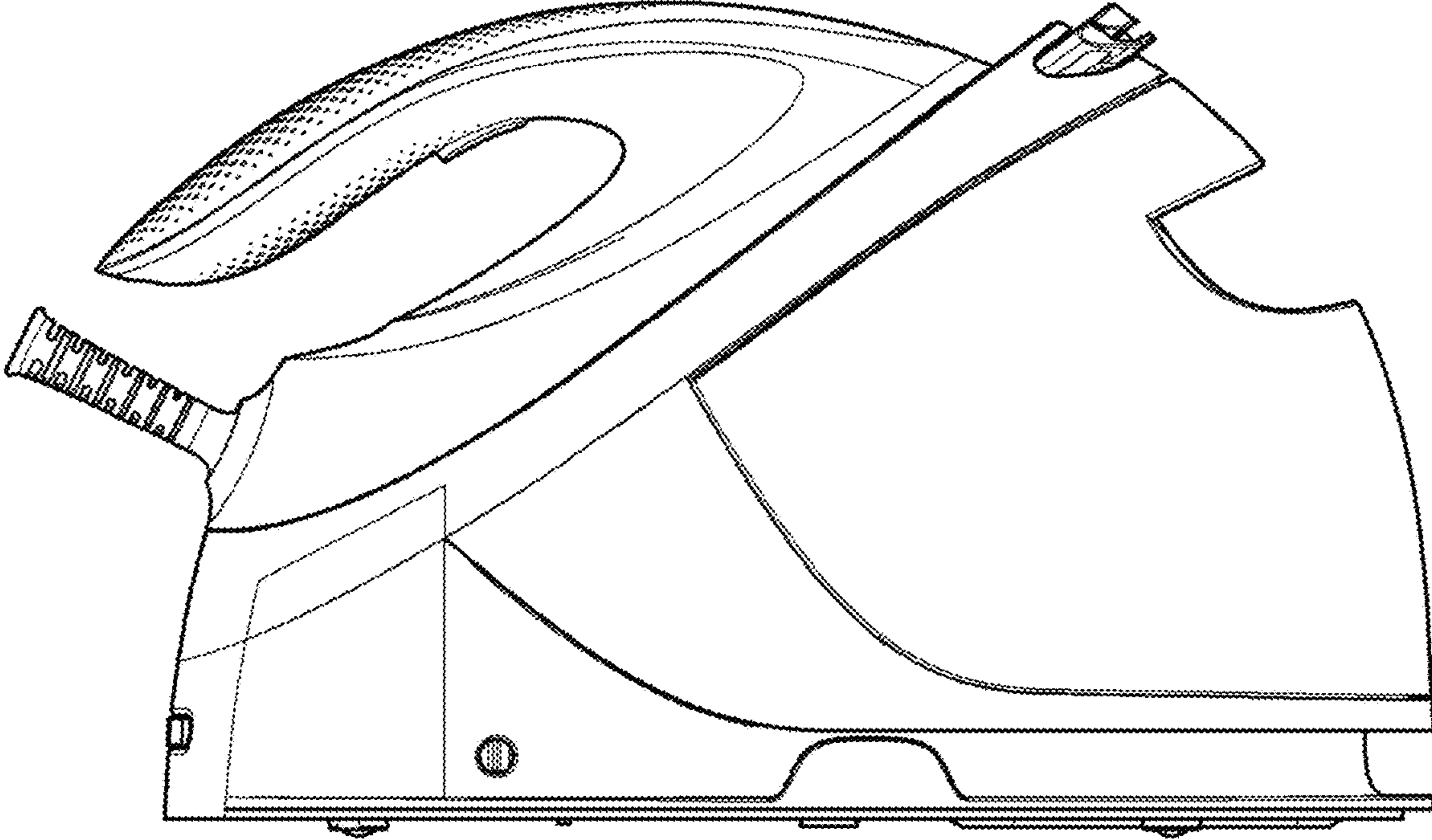

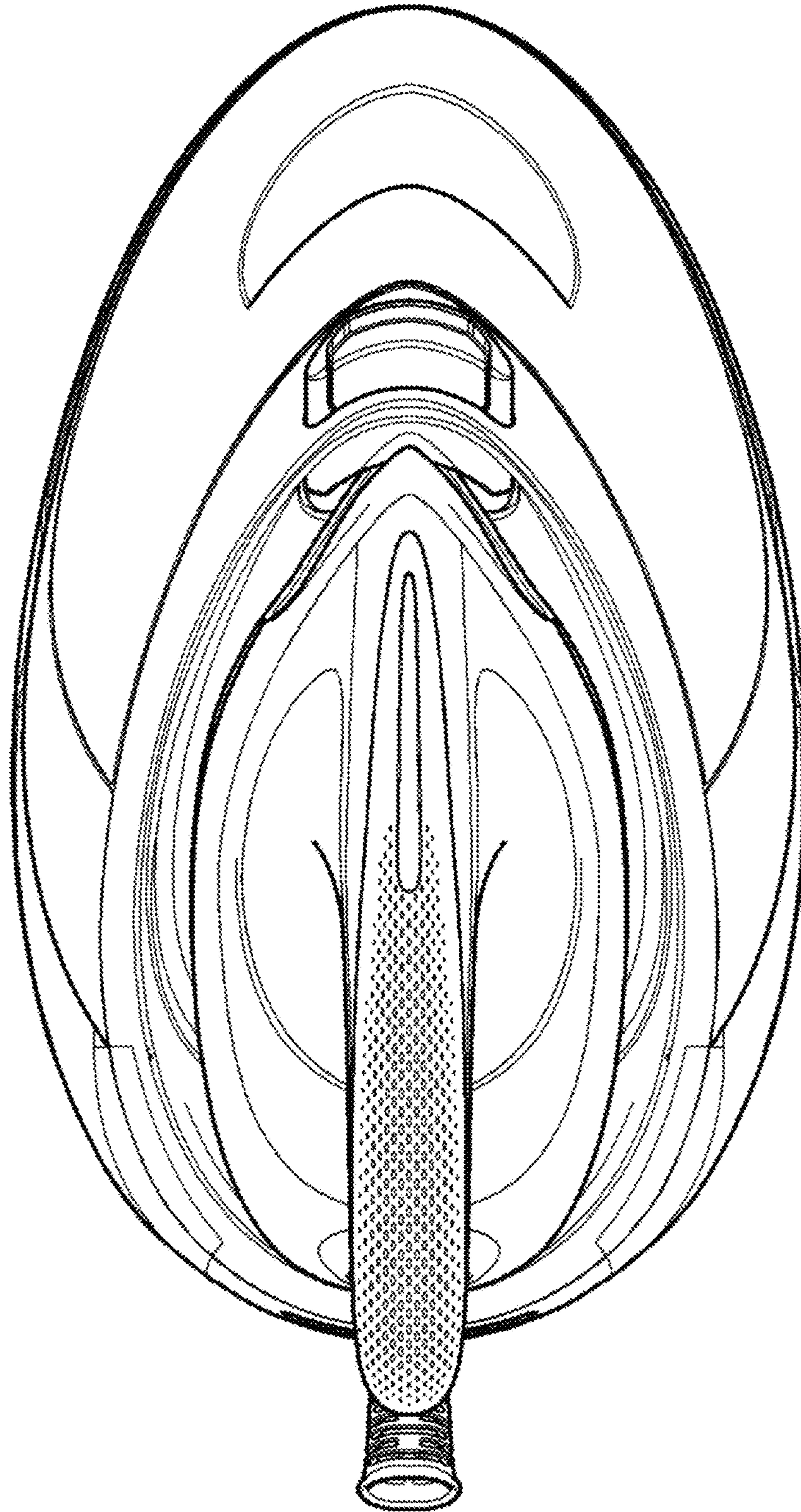
