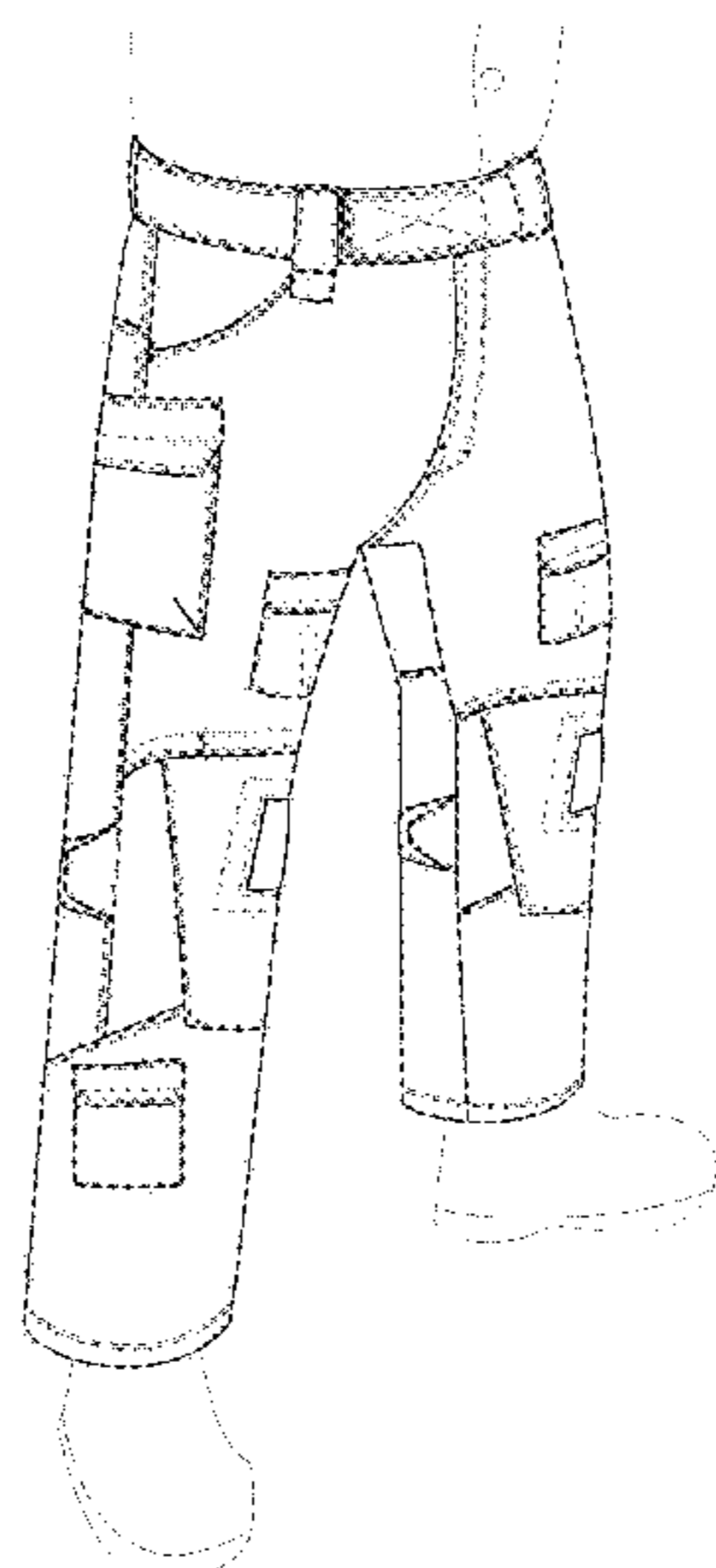
(57) **CLAIM**

The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an exemplary embodiment of the pants, showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof; and,
FIG. 5 is a right side view thereof.
The broken lines shown in FIG. 1 outside of the pants depict additional structures that form no part of the claimed design, while the broken lines shown within the pants throughout the various figures represent stitching.

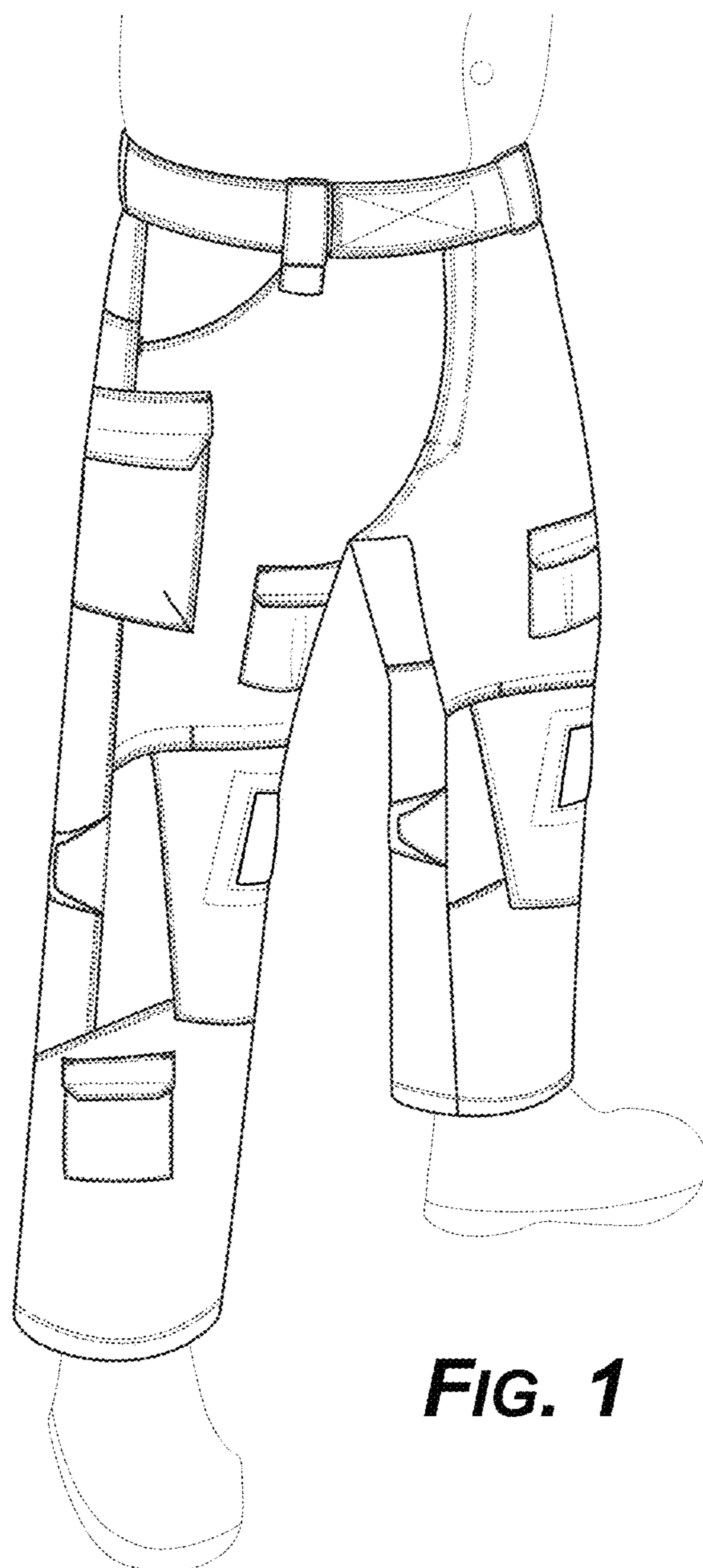

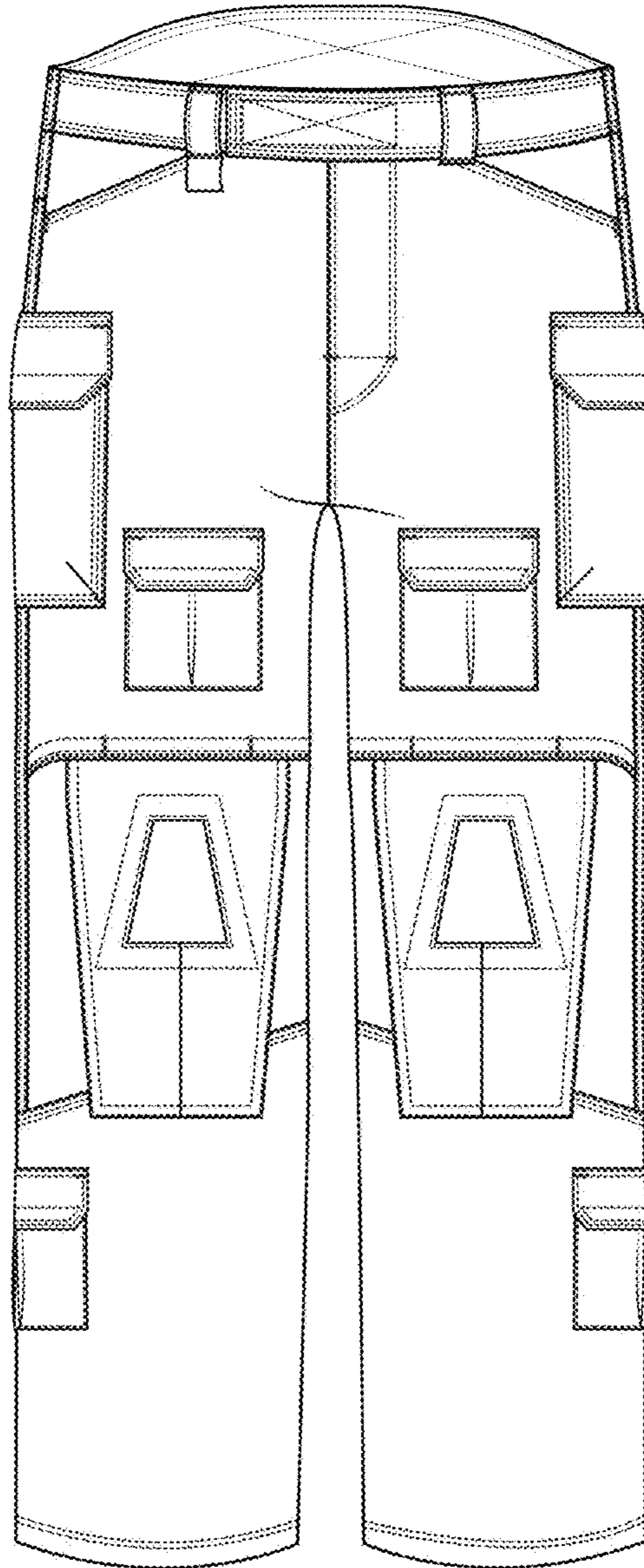

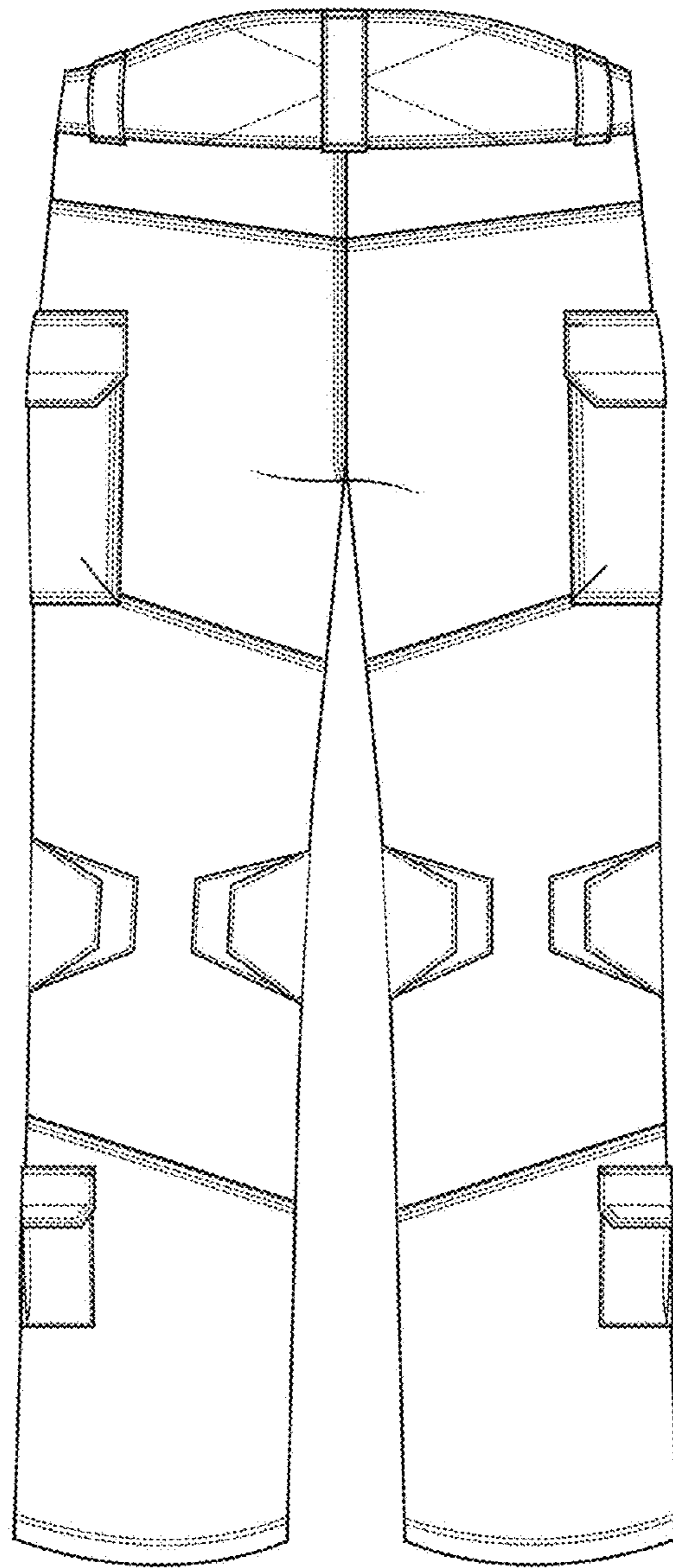

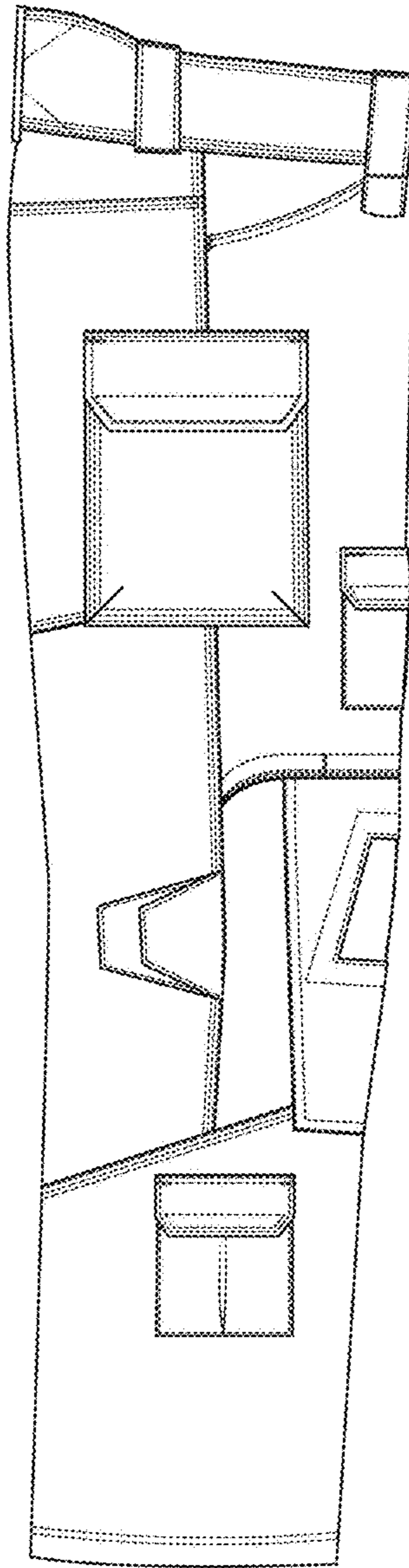

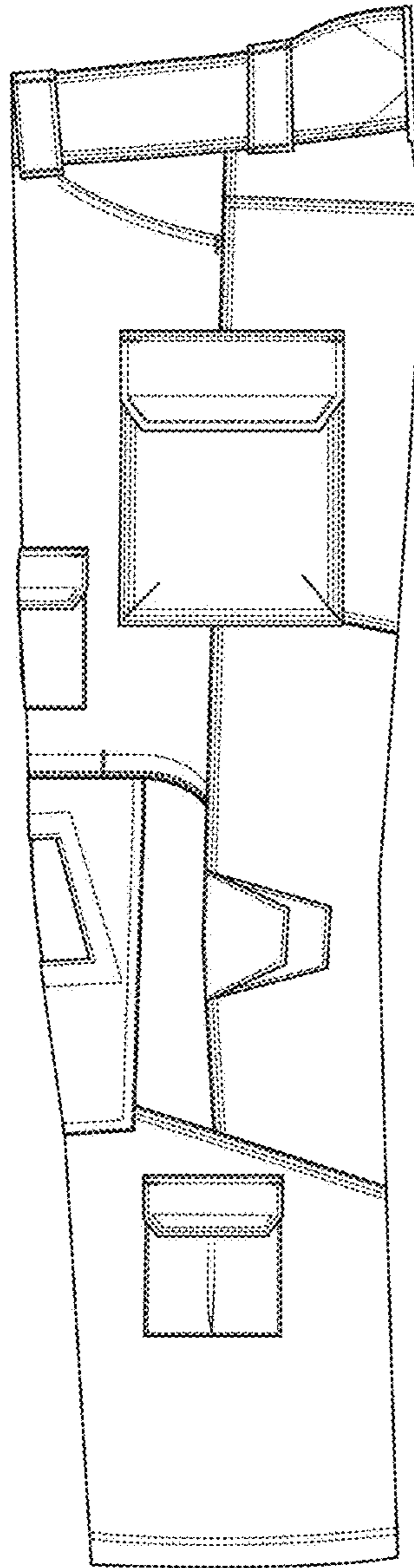
