DESCRIPTION

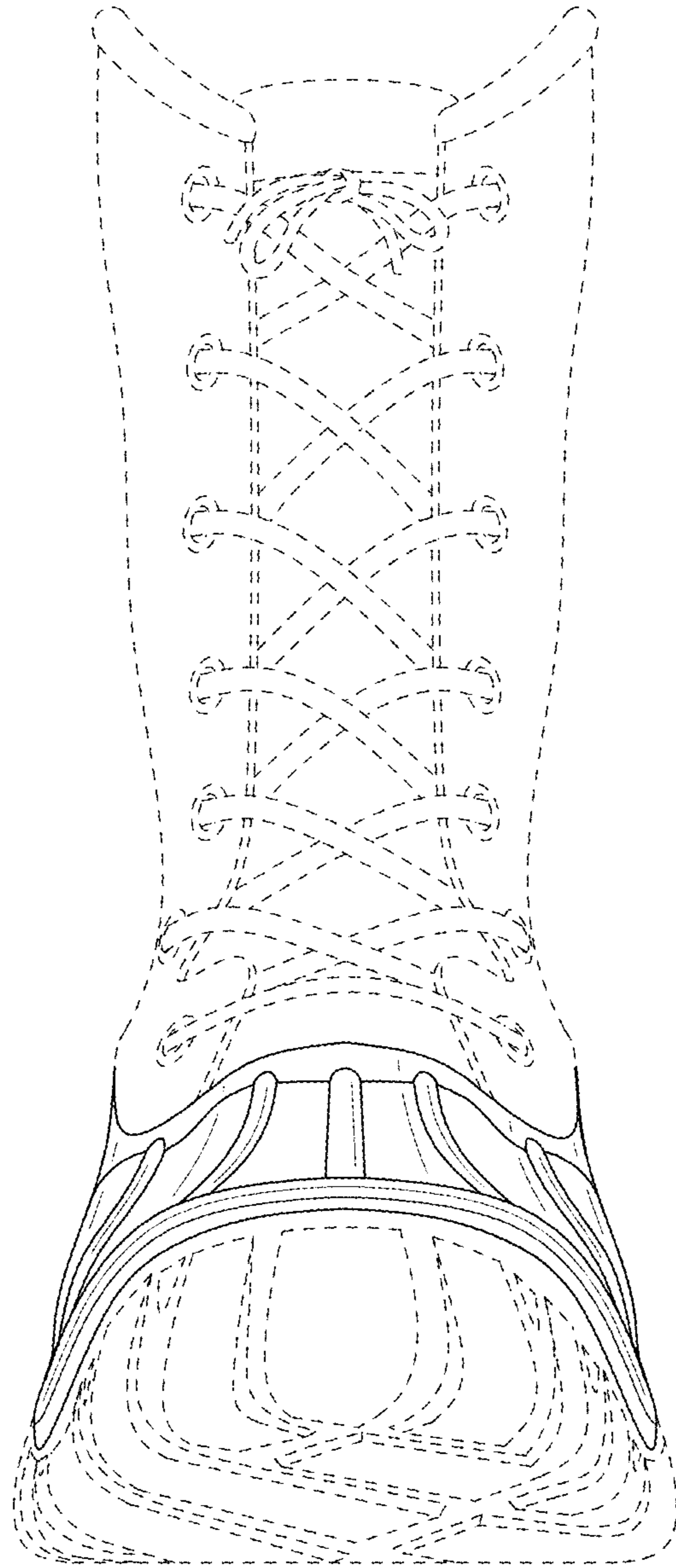

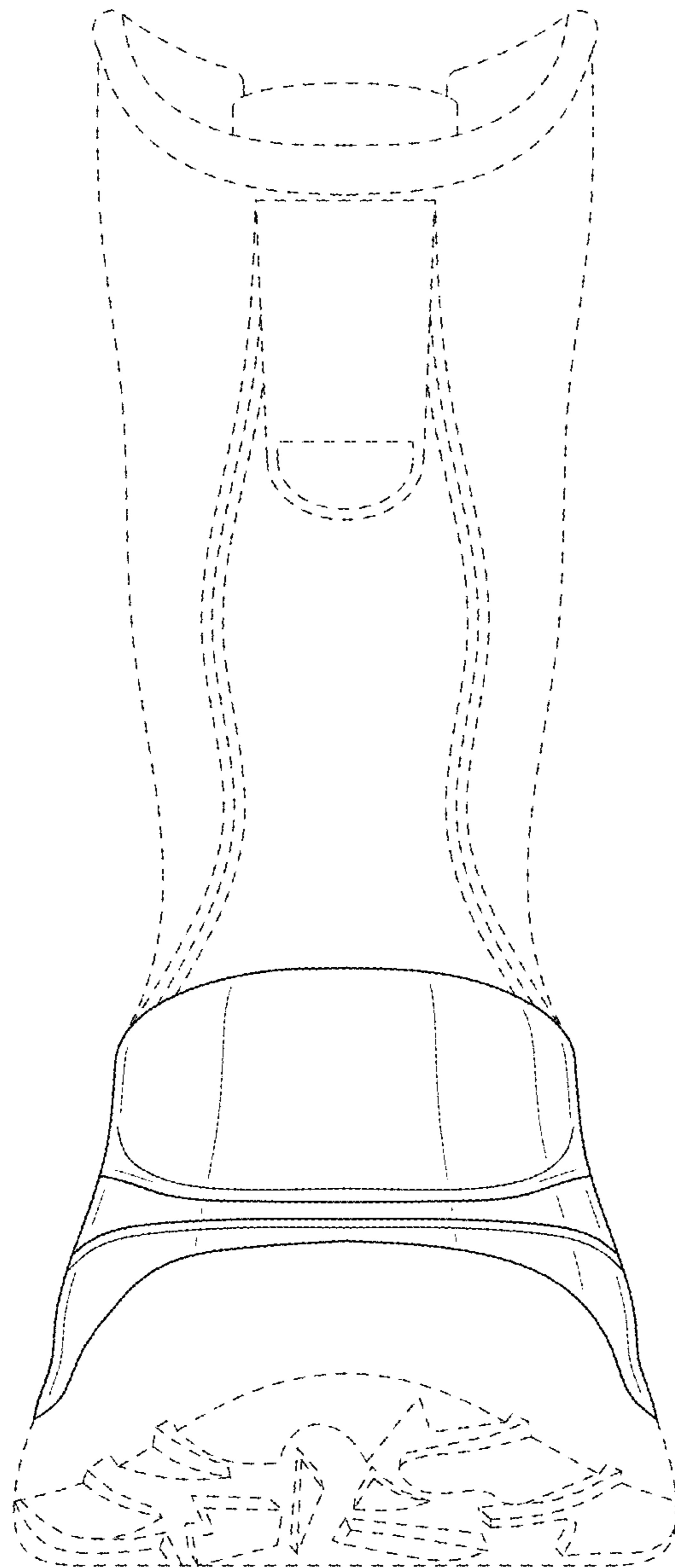

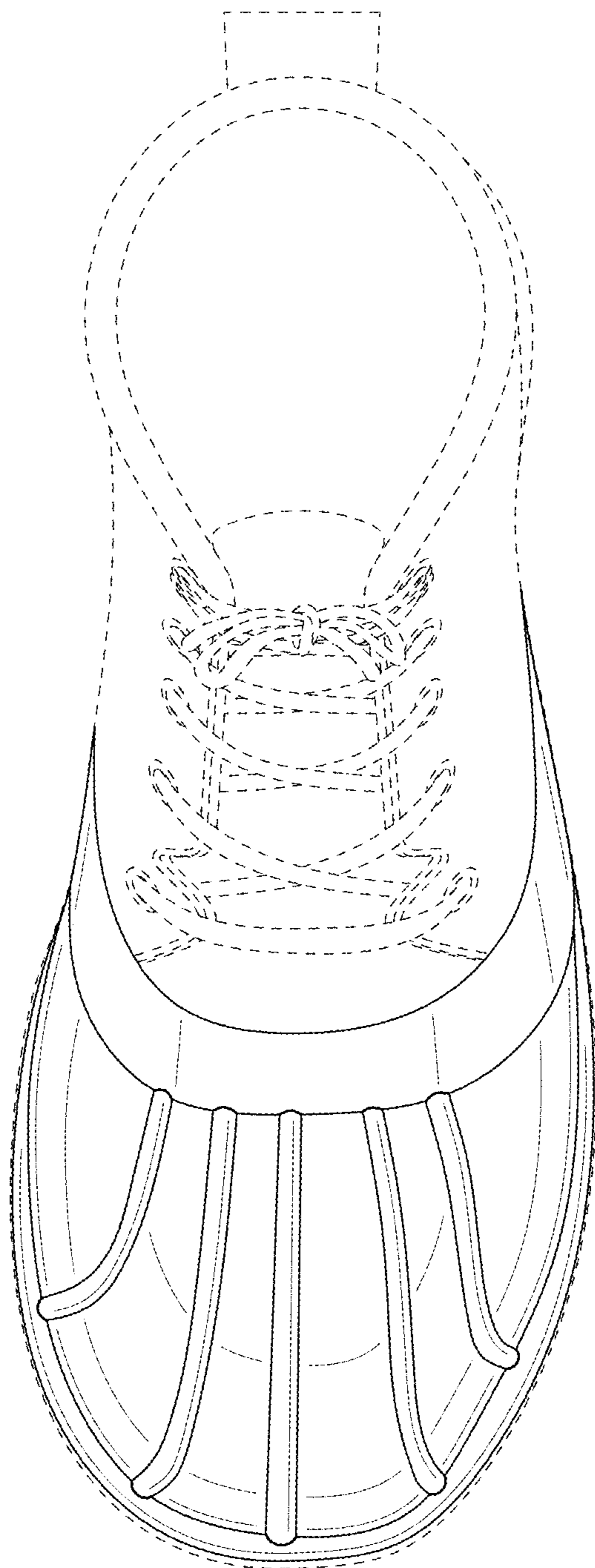

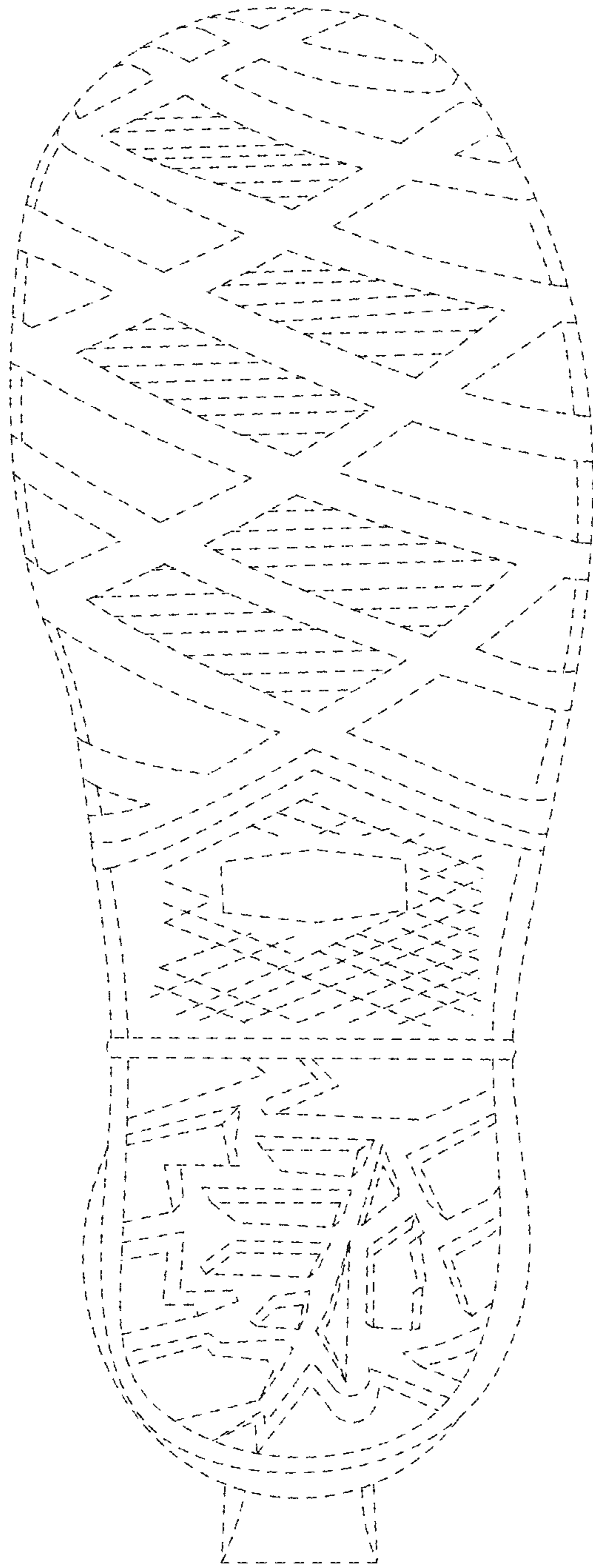

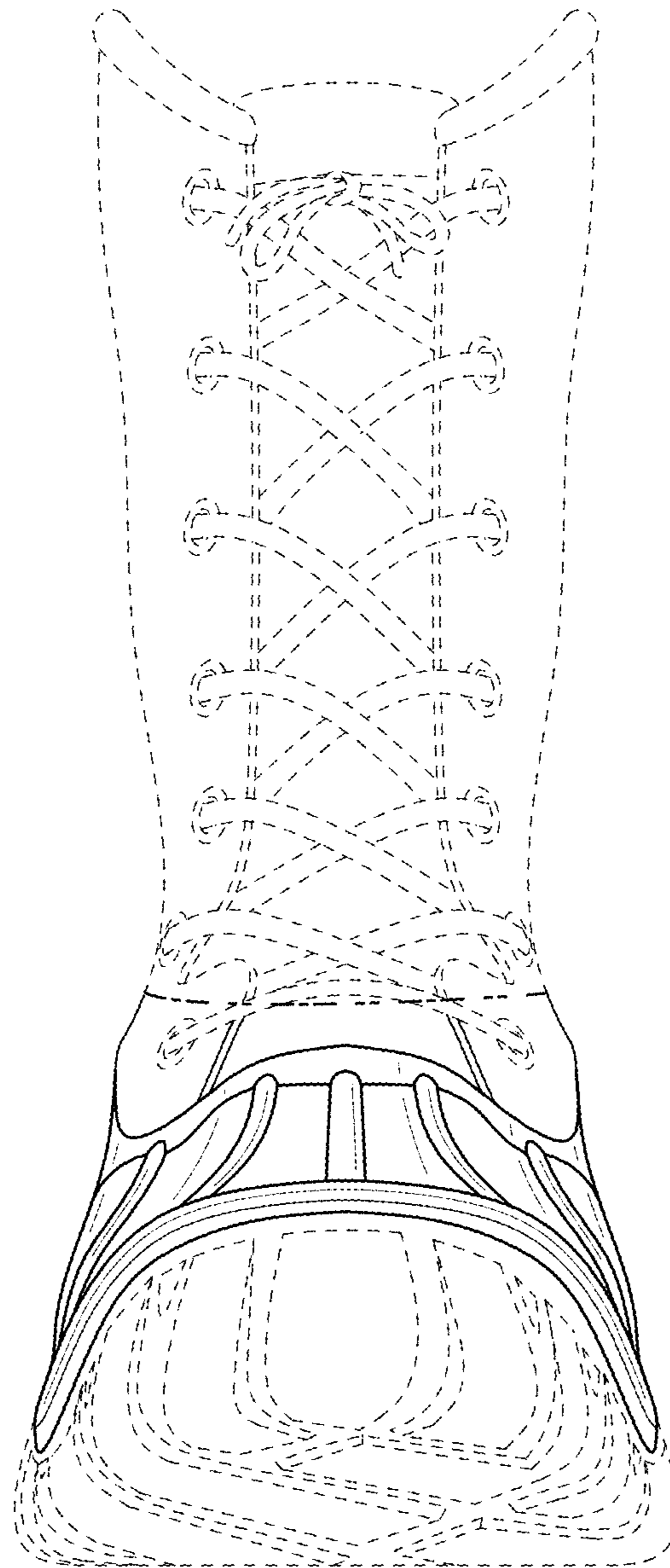

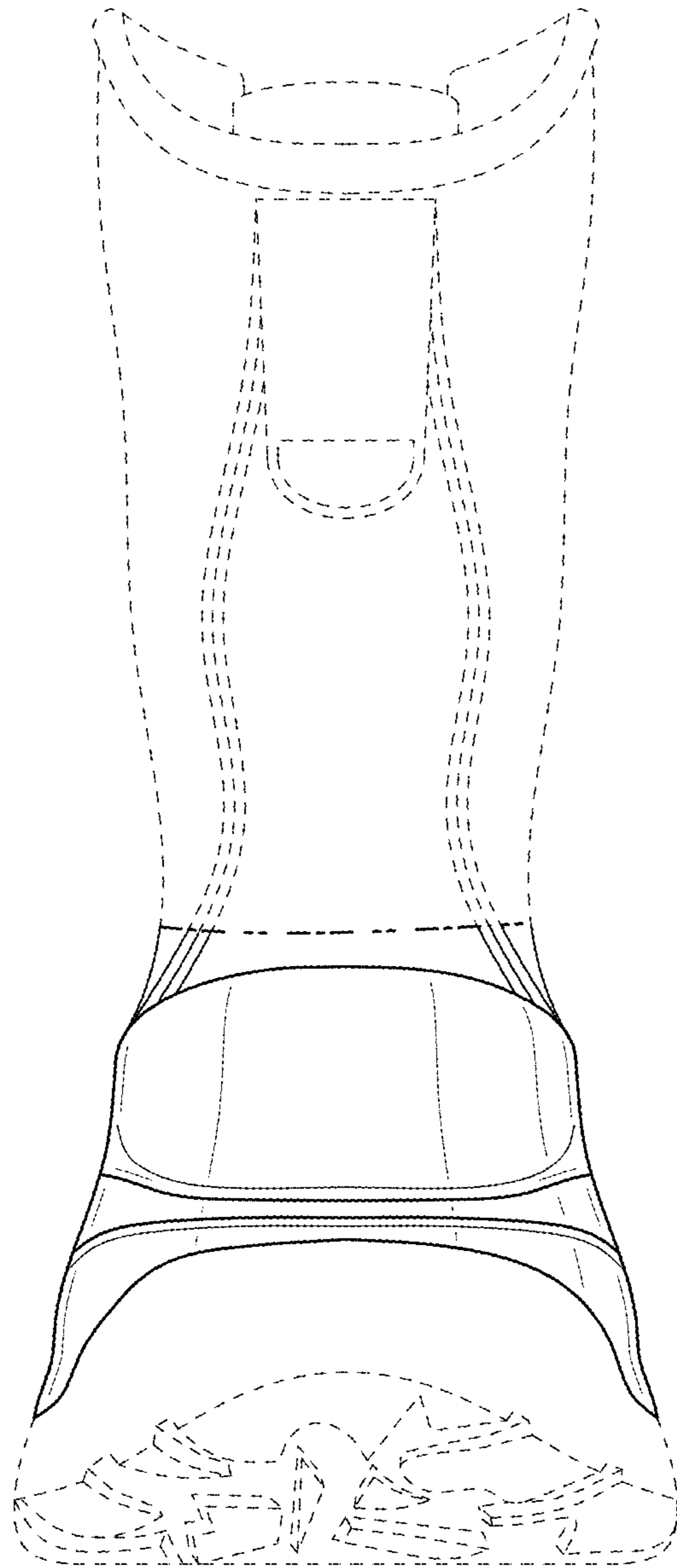

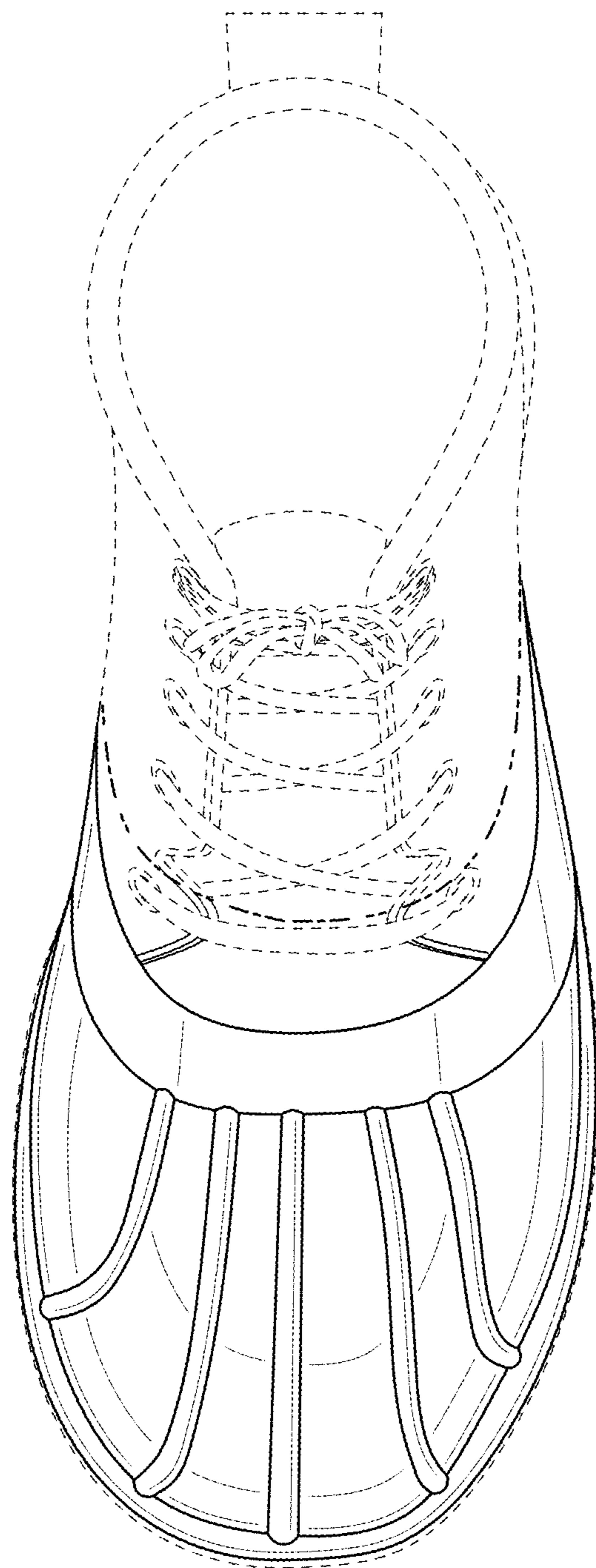

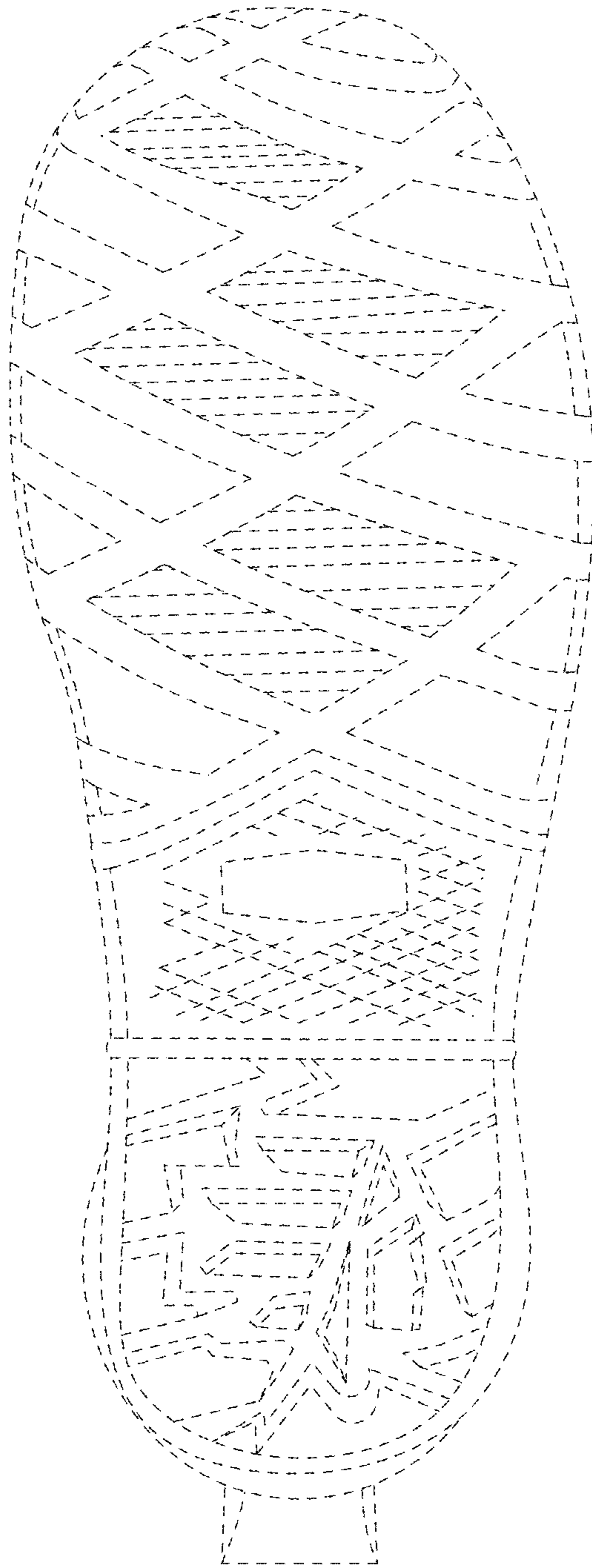
