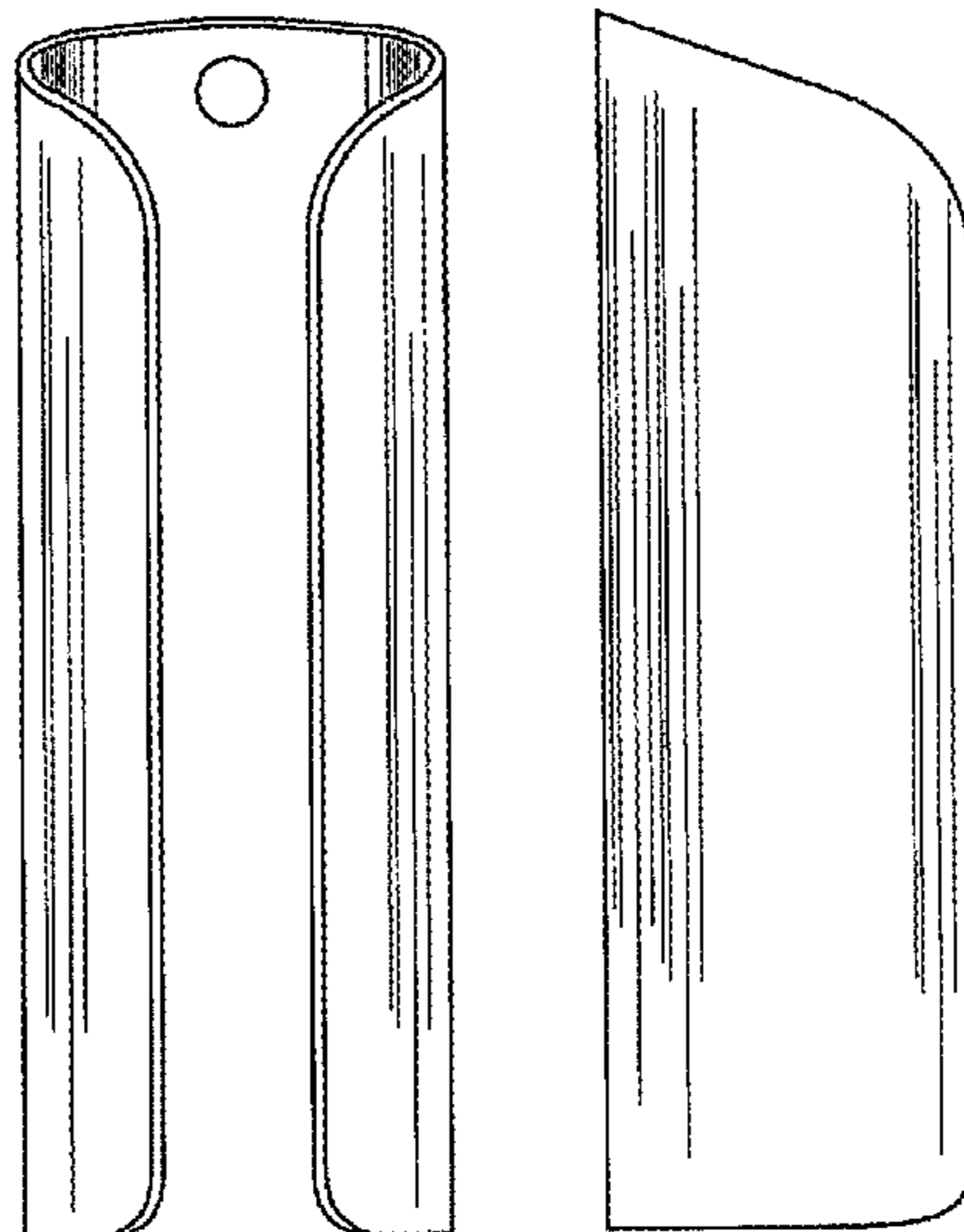
(57) **CLAIM**

The ornamental design for a vial or lip balm holder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a vial or lip balm holder showing my new design;
FIG. 2 is a left side elevation view thereof;
FIG. 3 is a top elevation view thereof;
FIG. 4 is a back plan view thereof;
FIG. 5 is a perspective view thereof, shown in environment
FIG. 6 is a second front elevation view of the vial or lip balm holder; shown in environment;
FIG. 7 is a third elevation view of the vial or lip balm holder, shown in environment; and,
FIG. 8 is a fourth elevation view of the vial or lip balm holder, shown in environment.

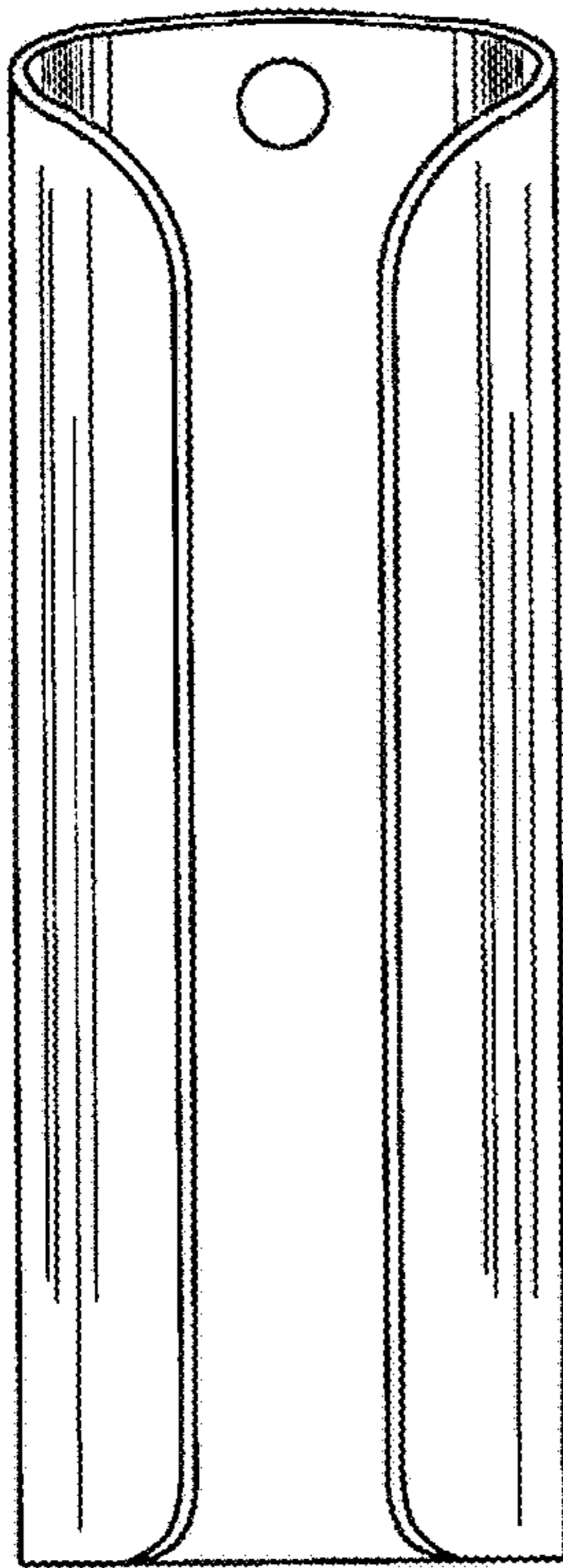

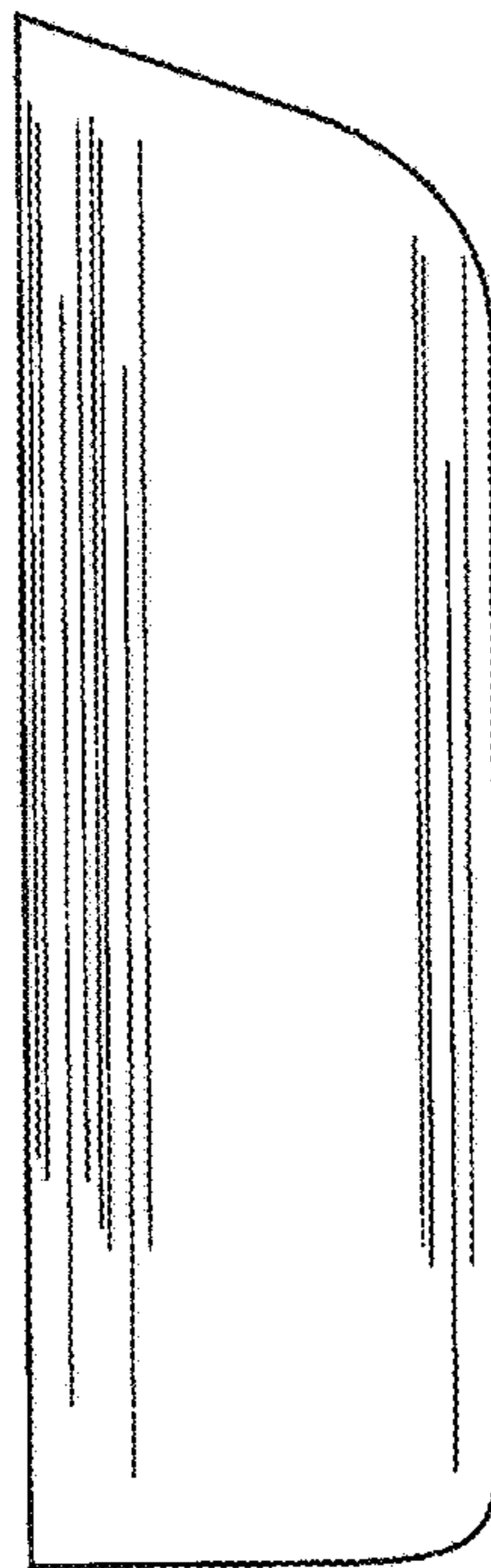

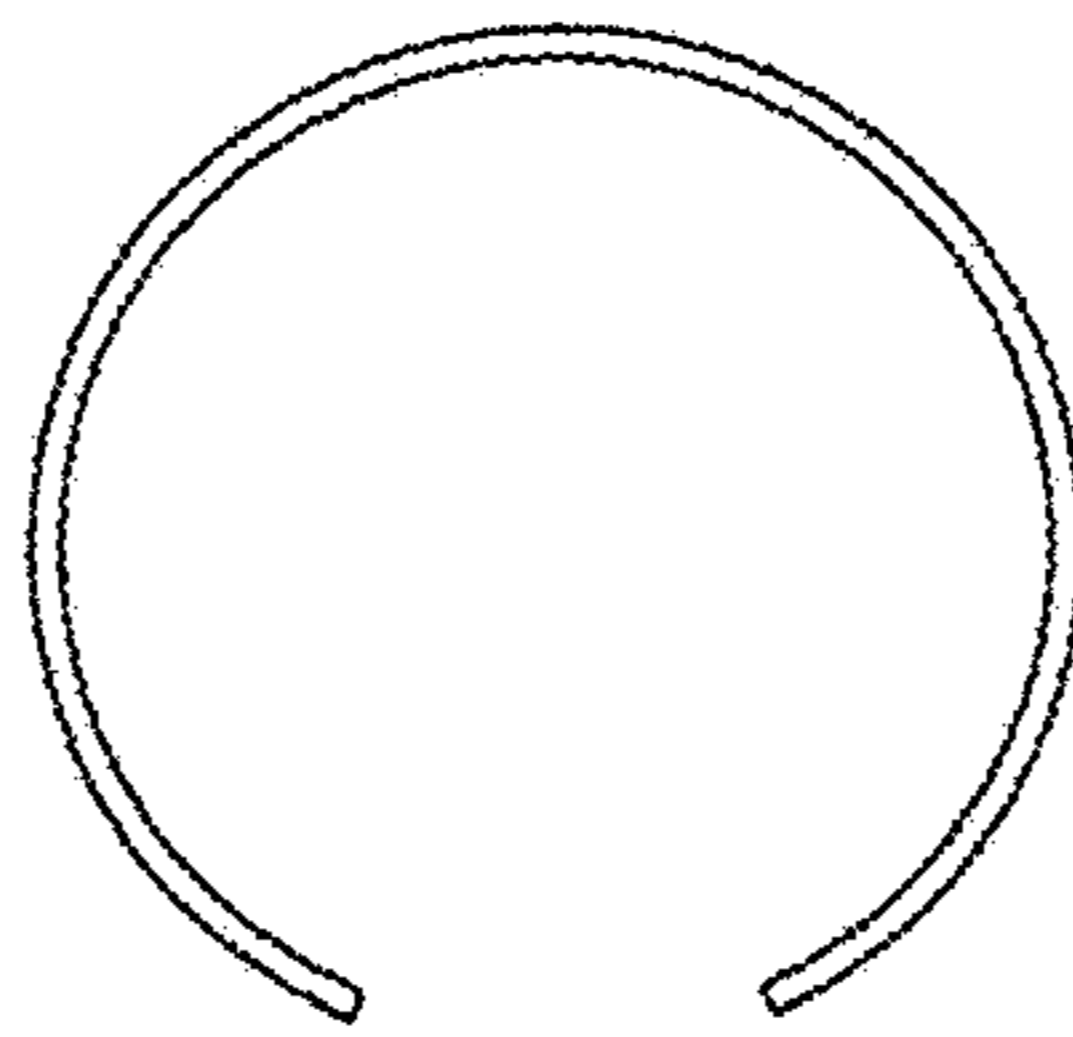

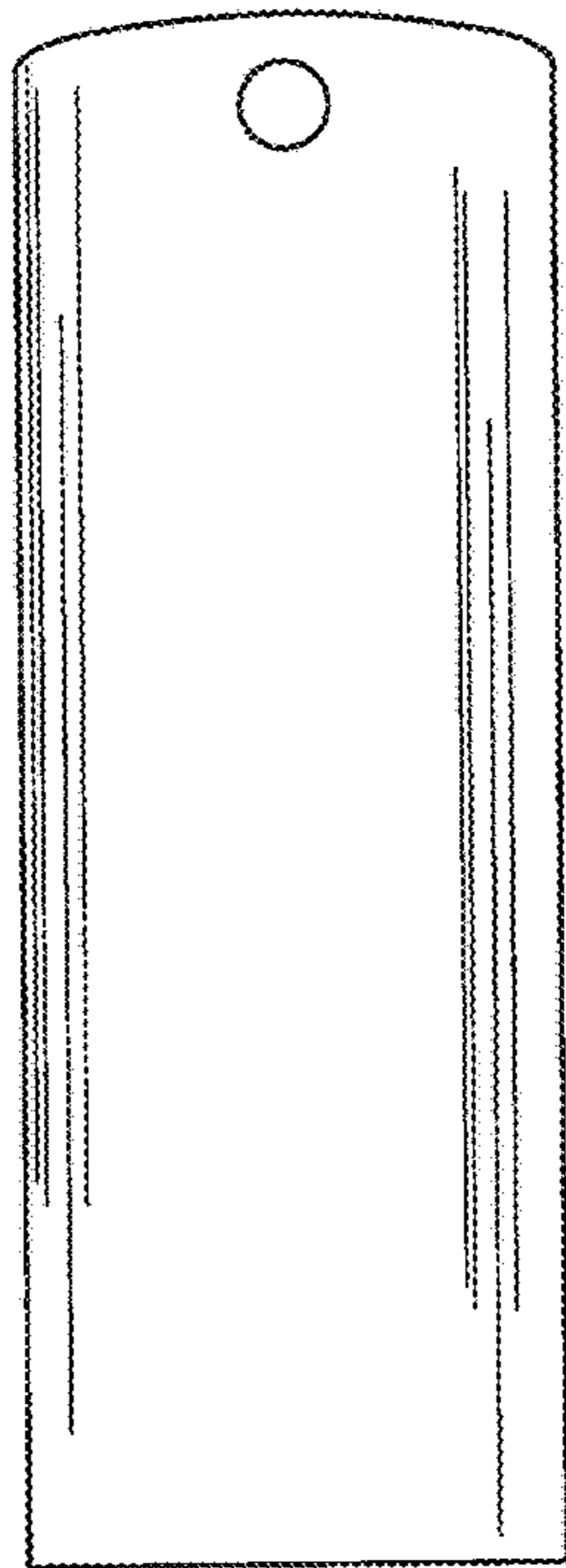

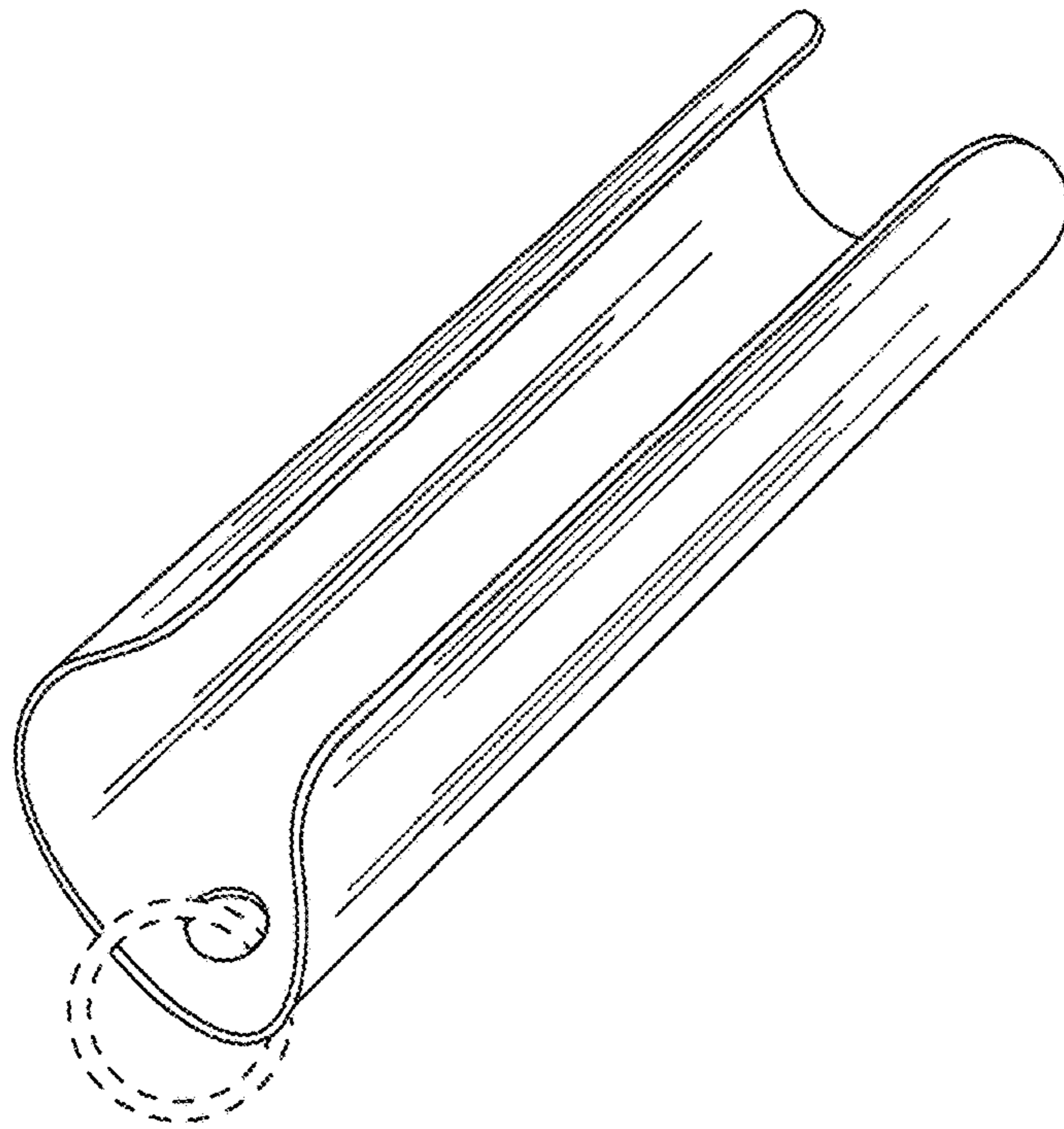

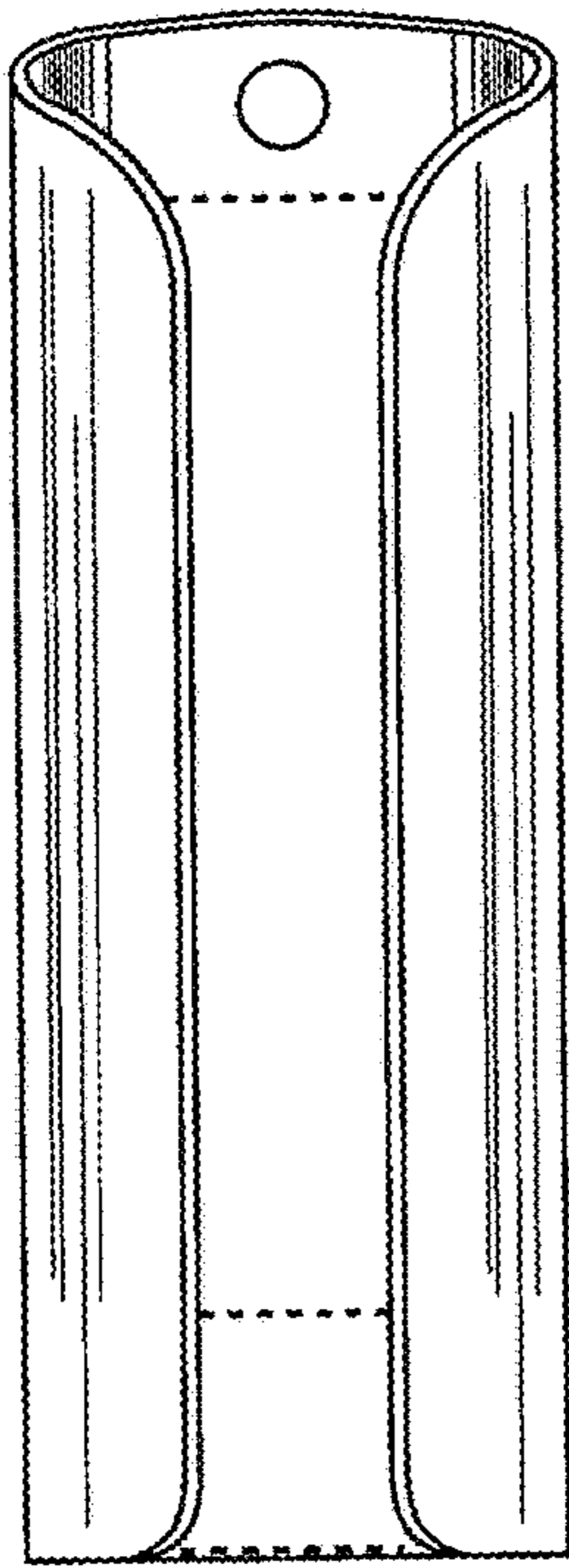

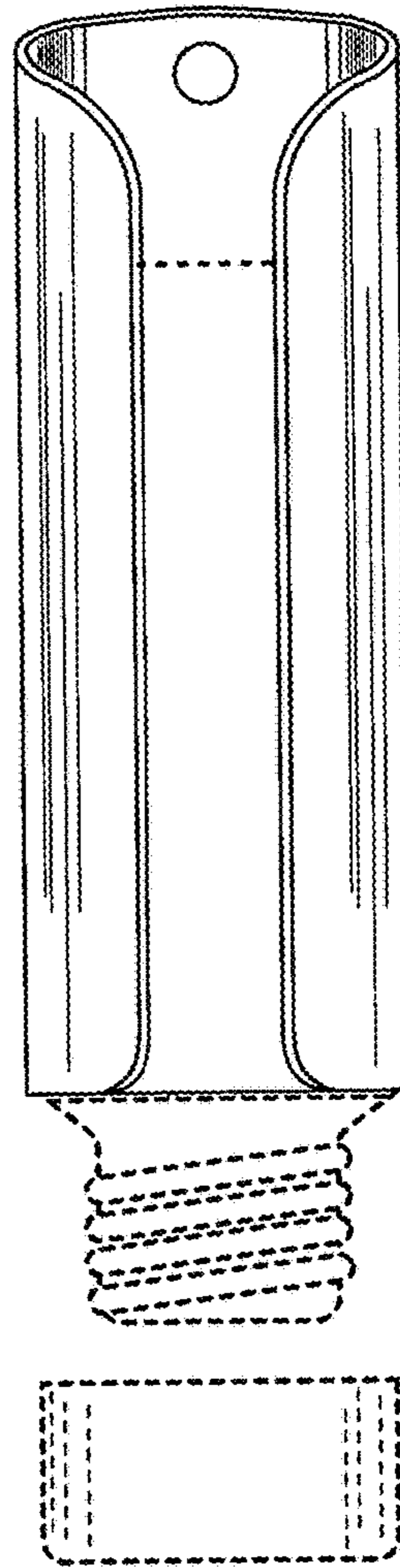

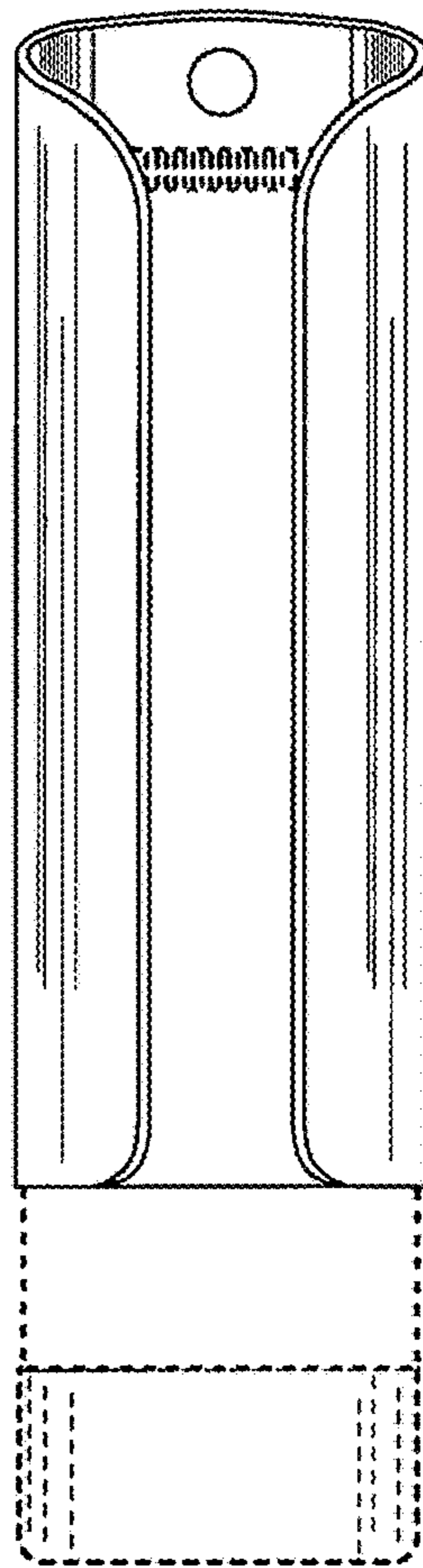
