(57) **CLAIM**

The ornamental design for a combined shoe brush mitten and bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view for a combined shoe brush mitten and bag showing an exposed interior side thereof shown in a shoe brush mitten mode;

FIG. 2 is a right side view of the combined shoe brush mitten and bag shown in FIG. 1;

FIG. 3 is an end view of the combined shoe brush mitten and bag shown in FIG. 1 and showing a closed end thereof;

FIG. 4 is a left side view of the combined shoe brush mitten and bag shown in FIG. 1;

FIG. 5 is an opposite end view of an open end of the combined shoe brush mitten and bag shown in FIG. 1 and showing an open end thereof;

FIG. 6 is a top view of the combined shoe brush mitten and bag shown in FIG. 1;

FIG. 7 is a bottom view of the combined shoe brush mitten and bag shown in FIG. 1;

FIG. 8 is a perspective view of the combined shoe brush mitten and bag showing an exposed exterior side thereof shown in a bag mode.

FIG. 9 is an end view of the combined shoe brush mitten and bag shown in FIG. 8 and showing a closed end thereof.

FIG. 10 is an opposite end view of the combined shoe brush mitten and bag shown in FIG. 8 and showing an open end thereof;

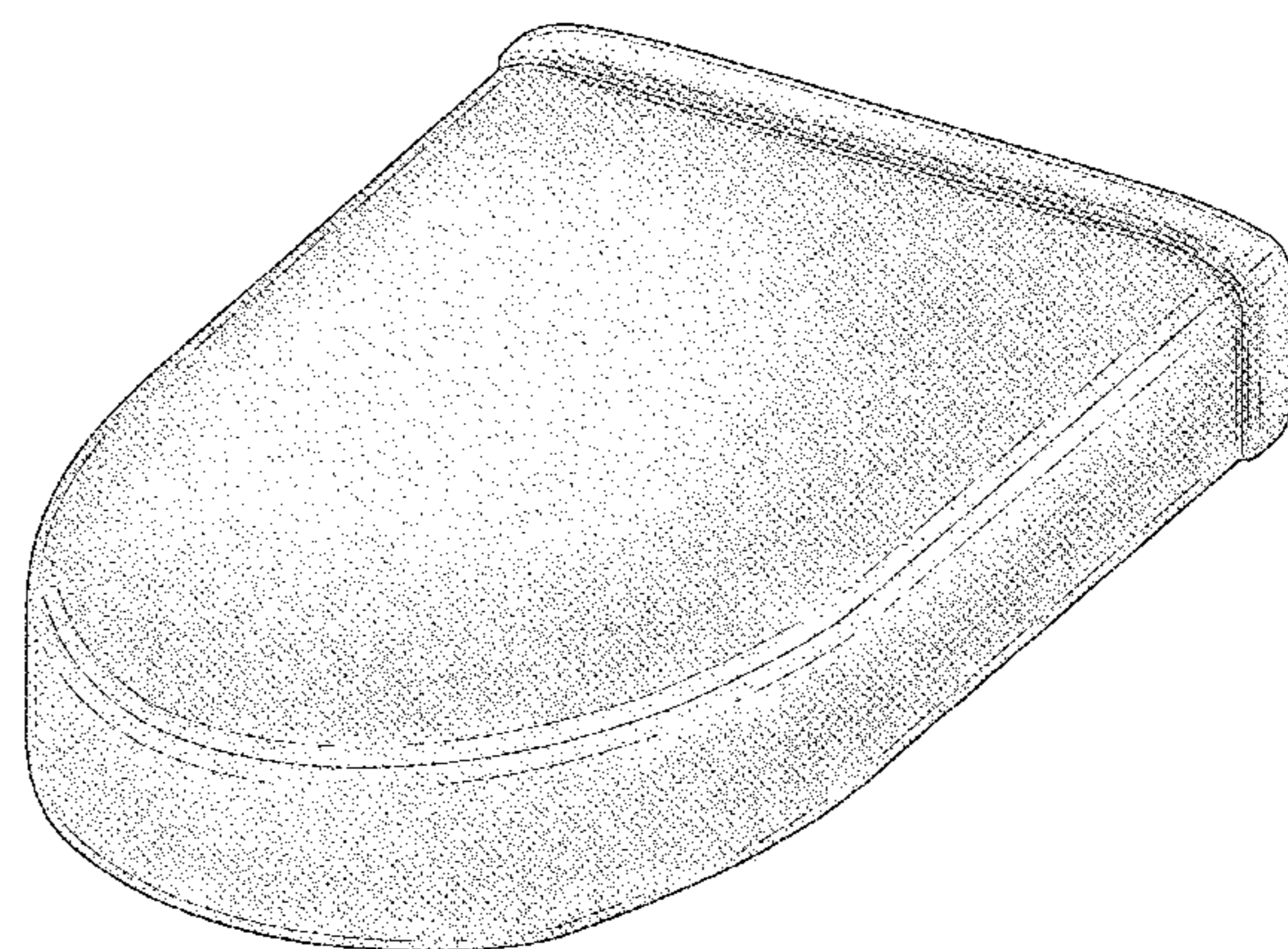
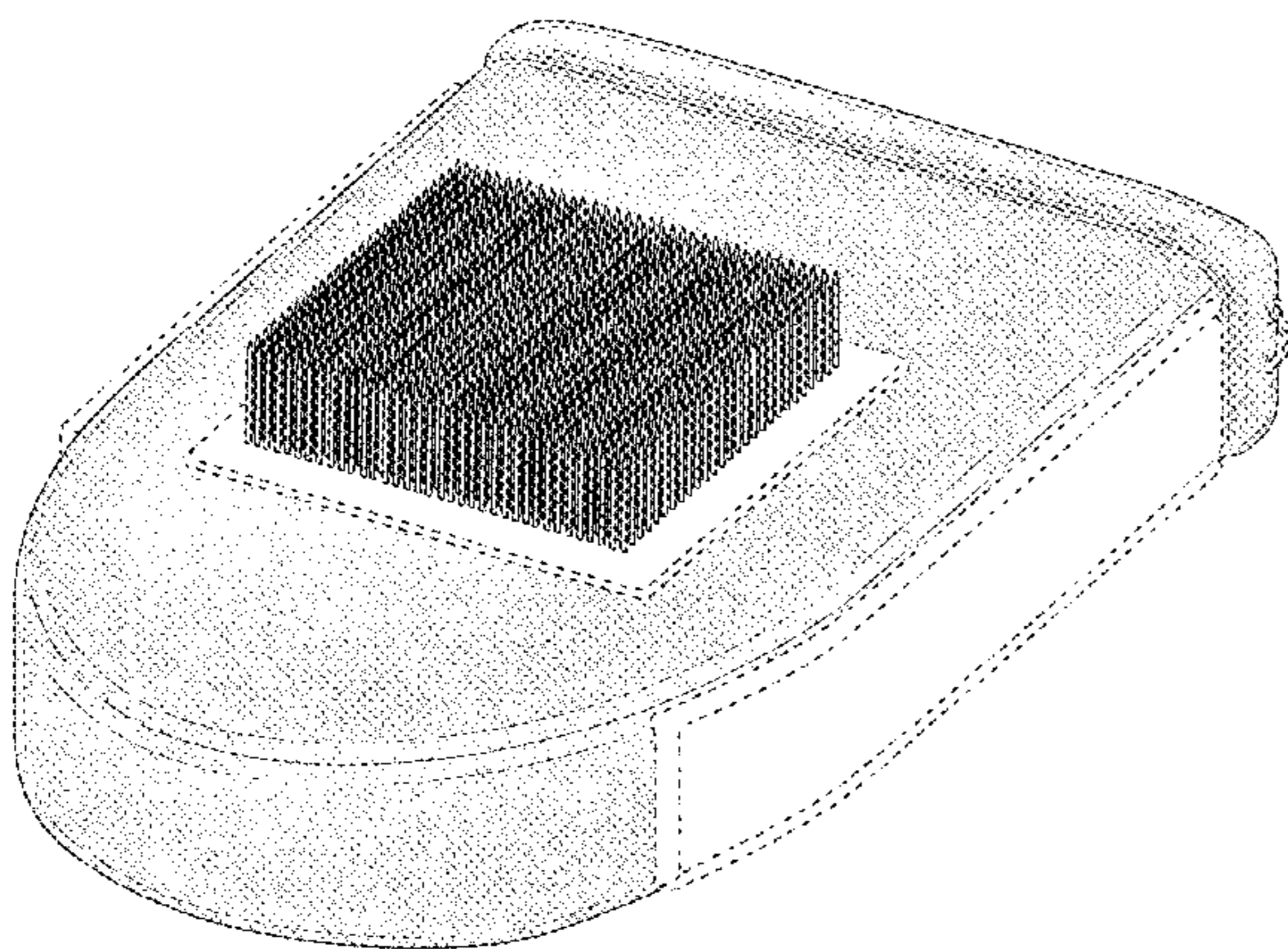
FIG. 11 is a left side view of the combined shoe brush mitten and bag shown in FIG. 8;

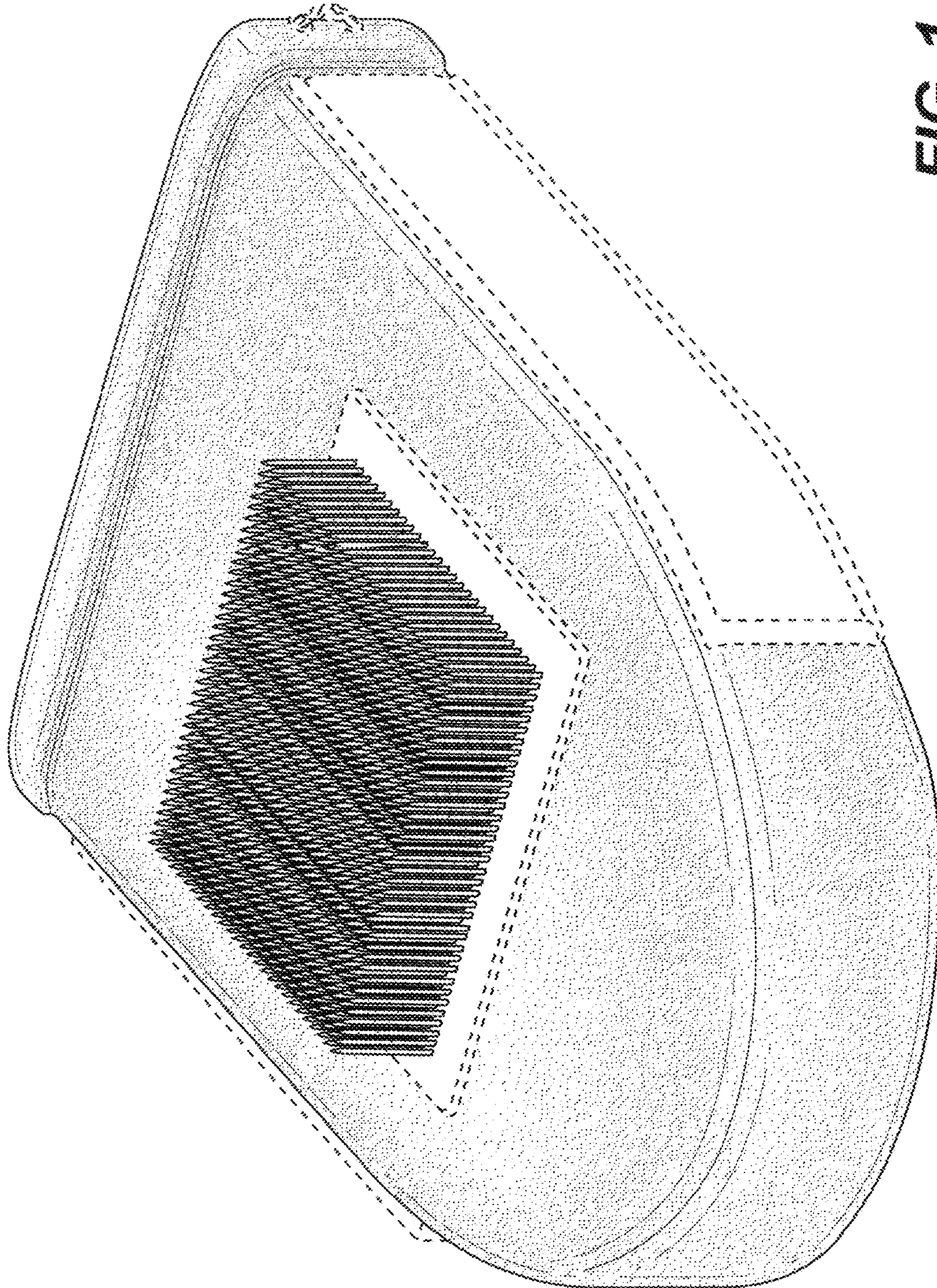
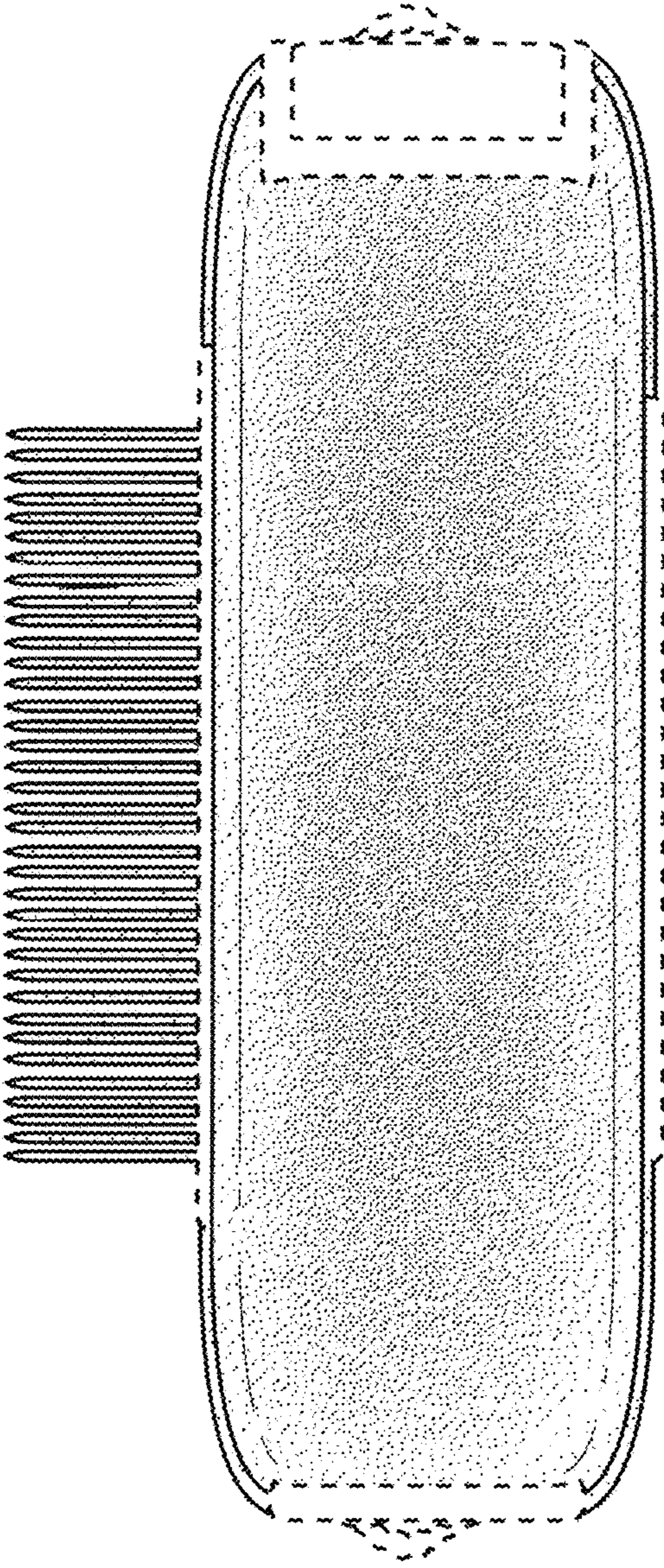
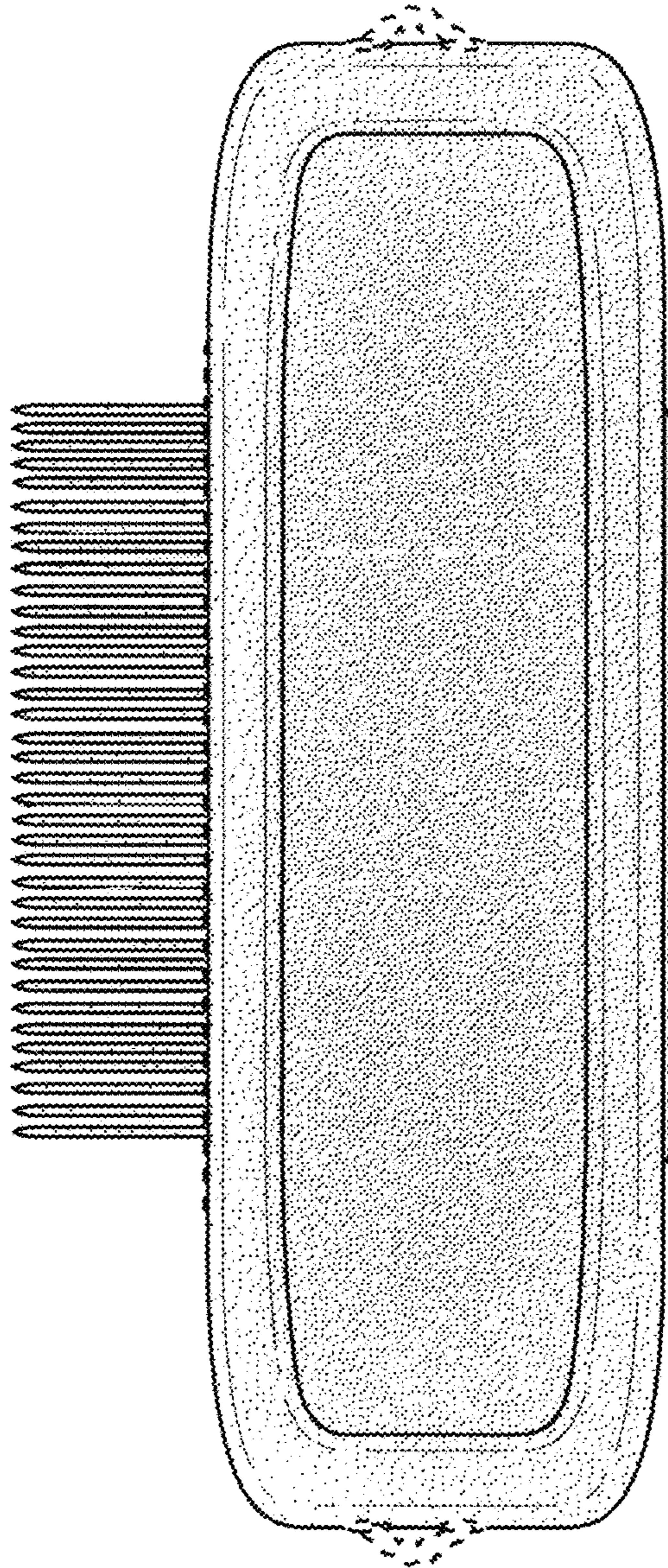

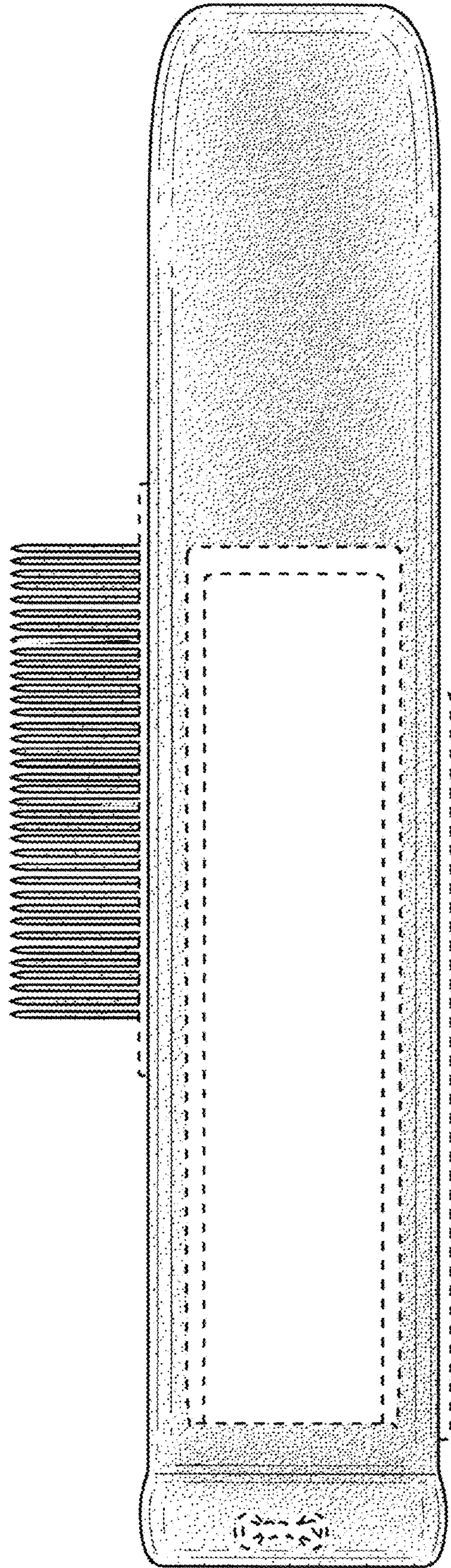

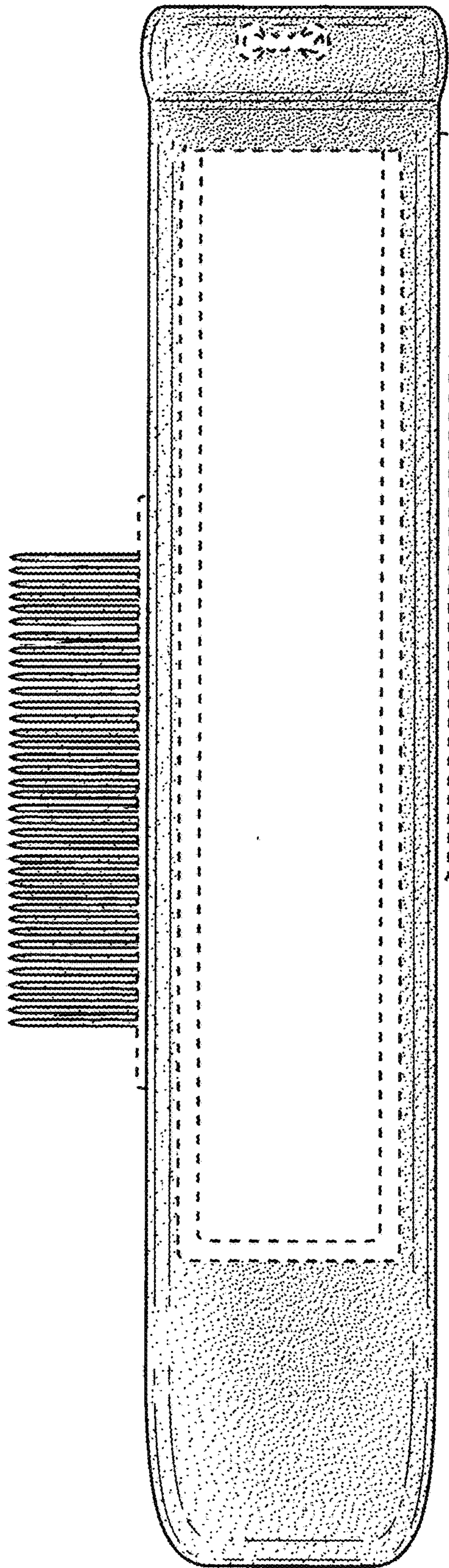

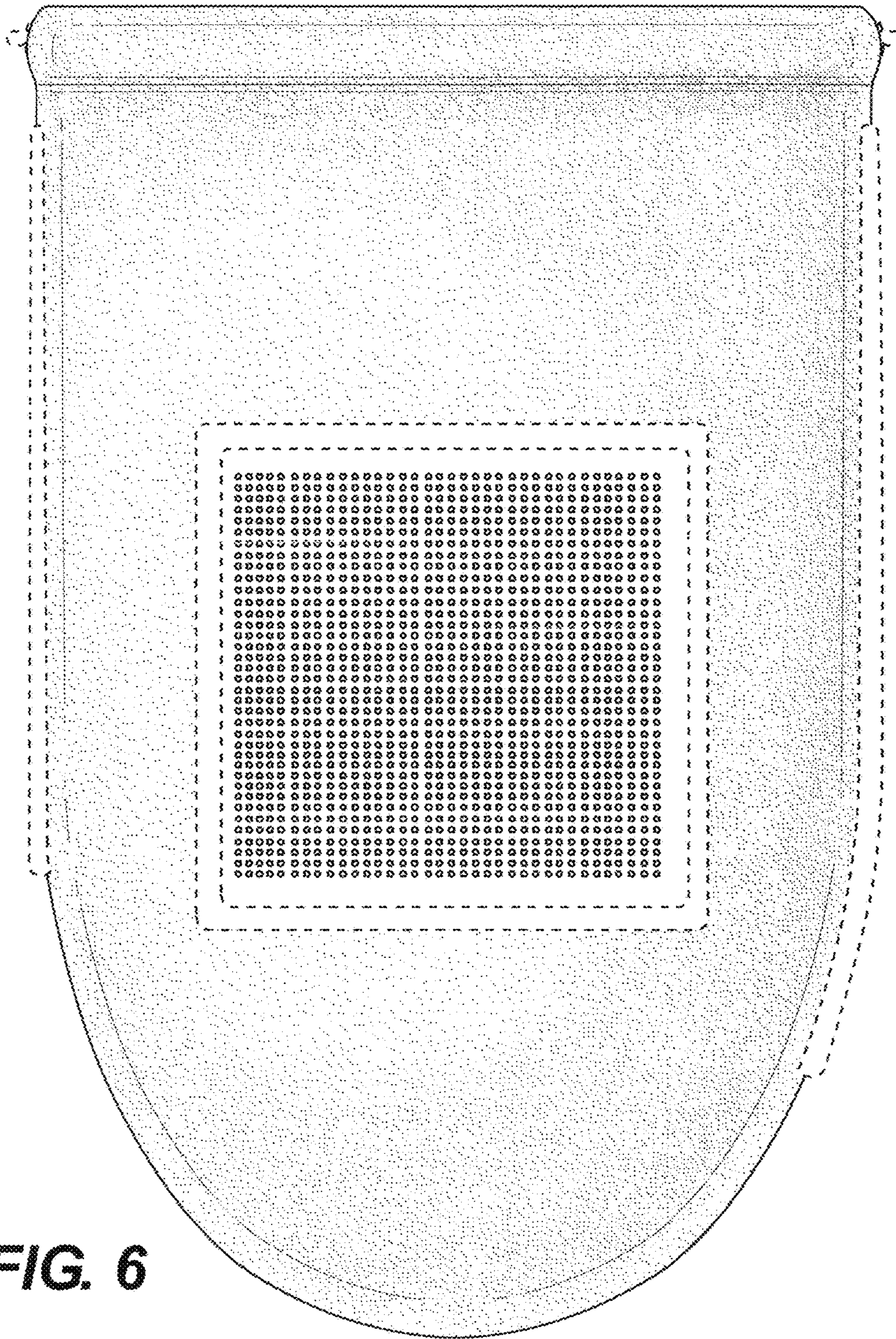

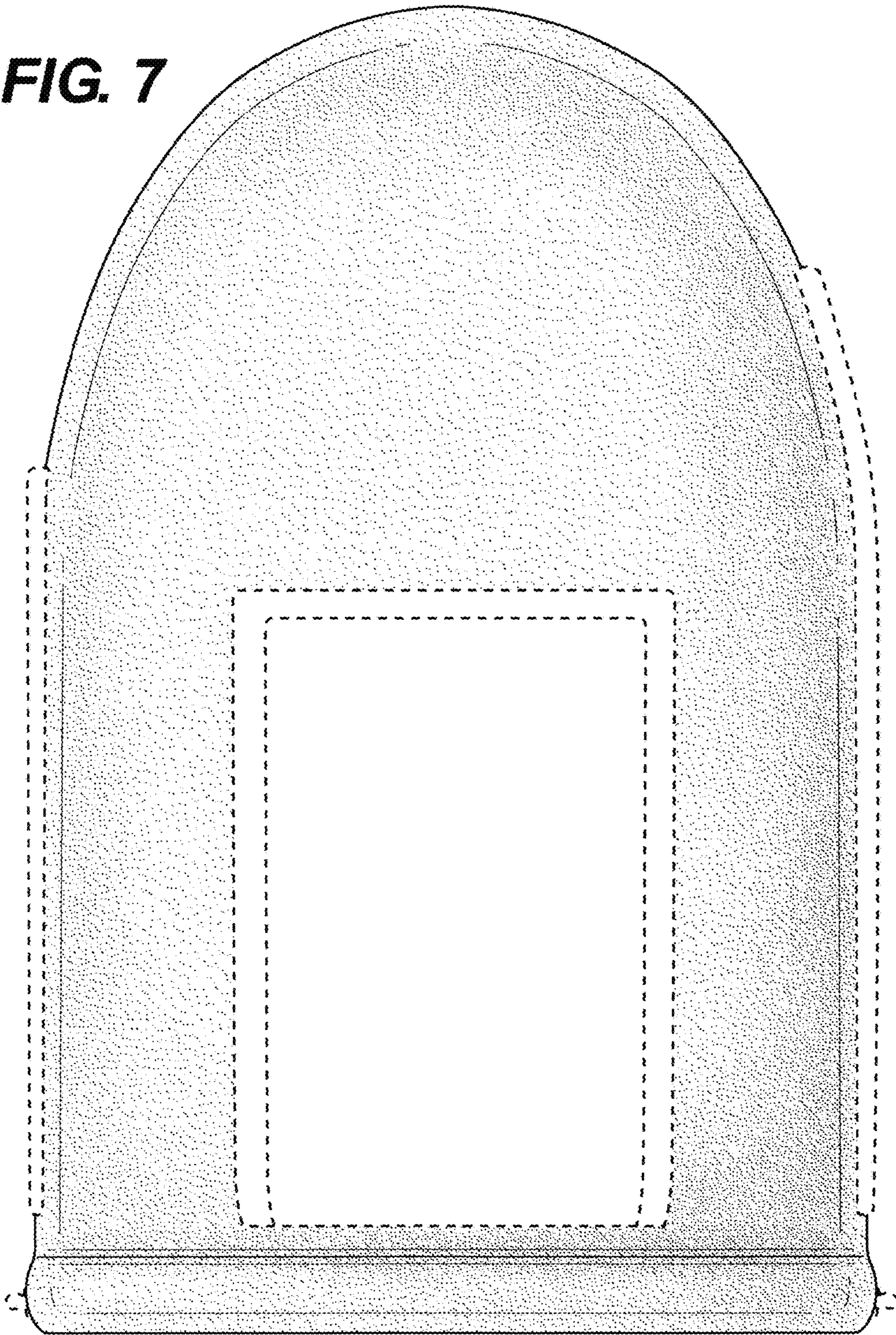

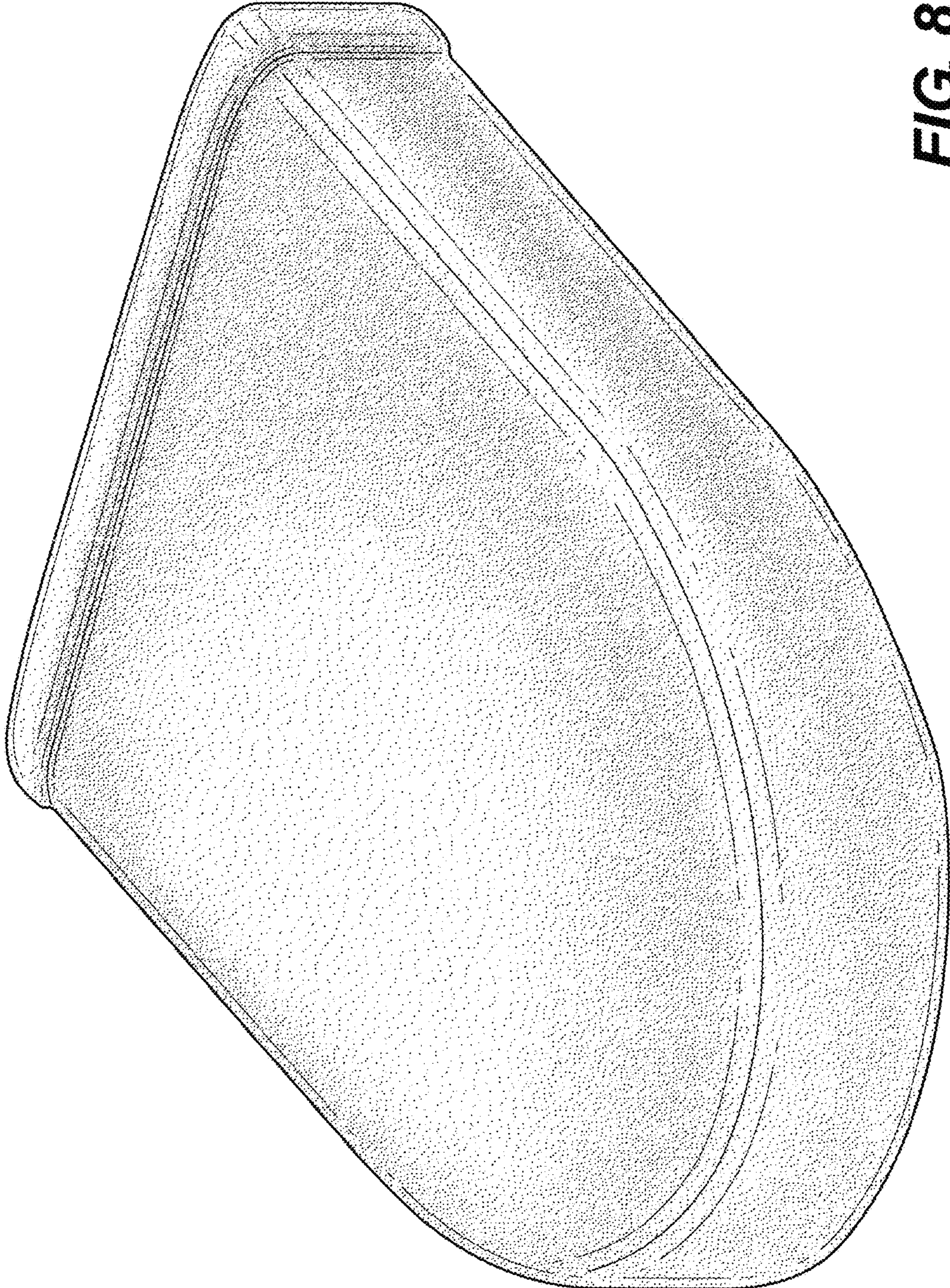
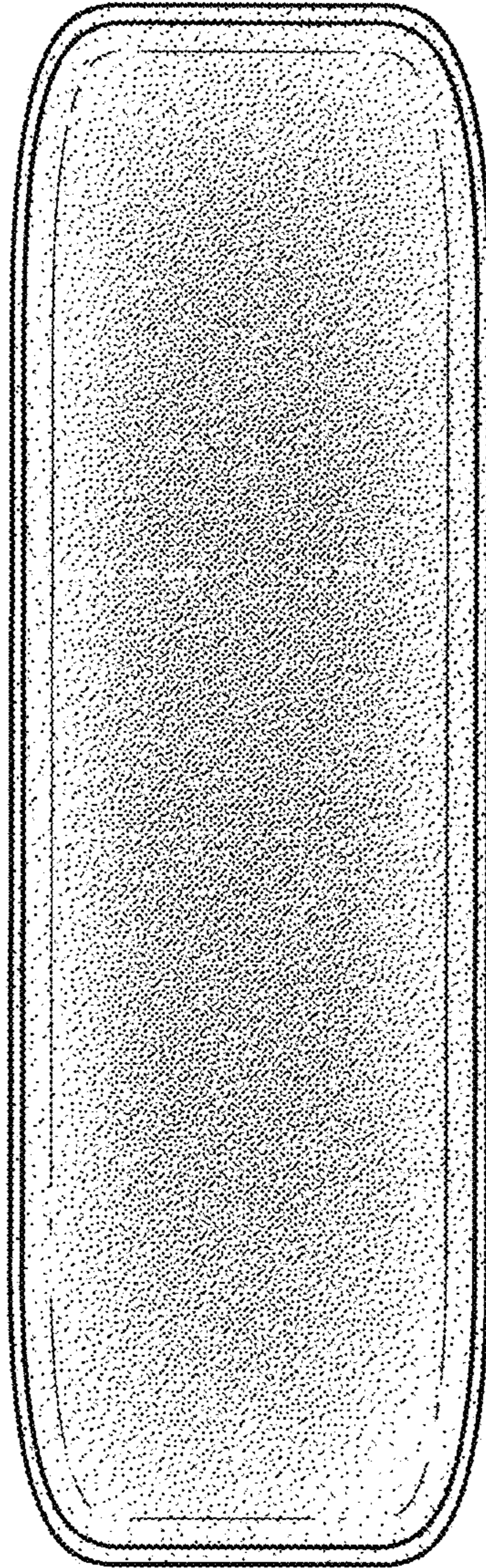
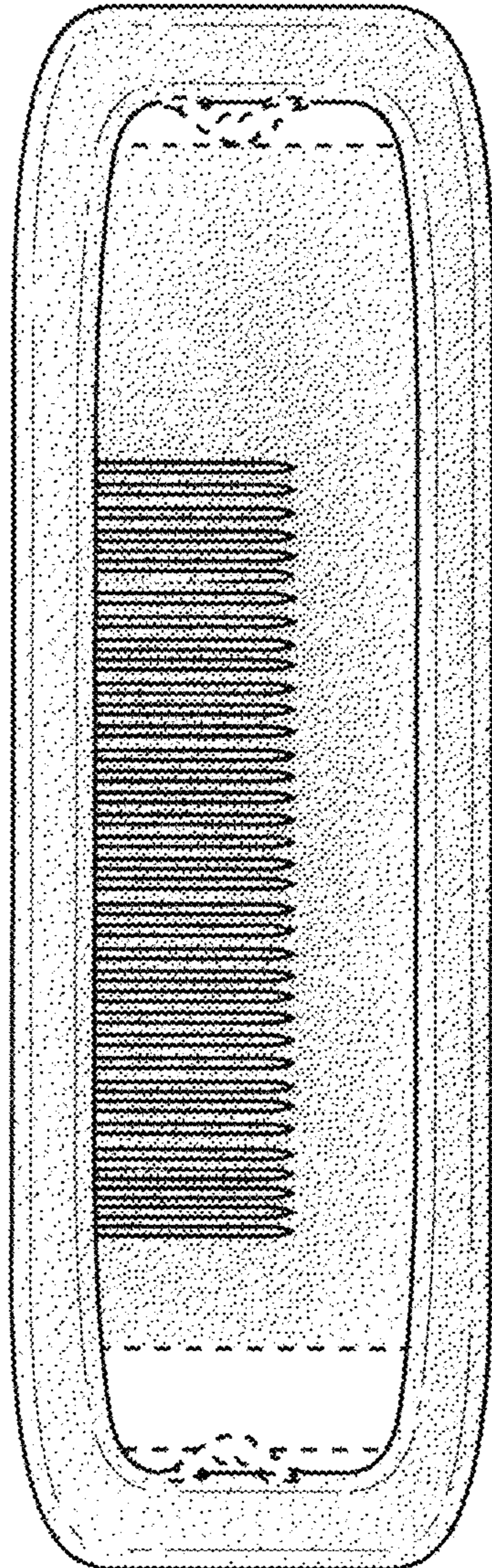

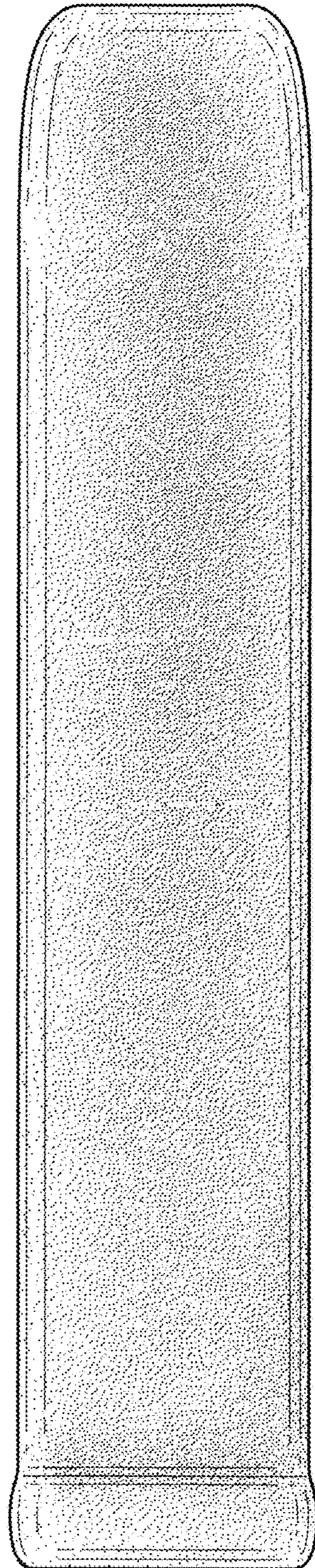

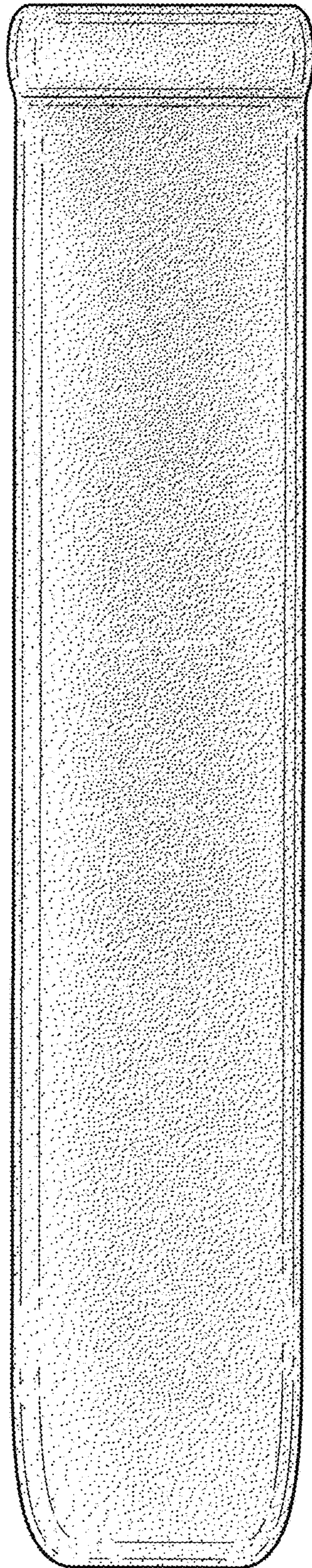

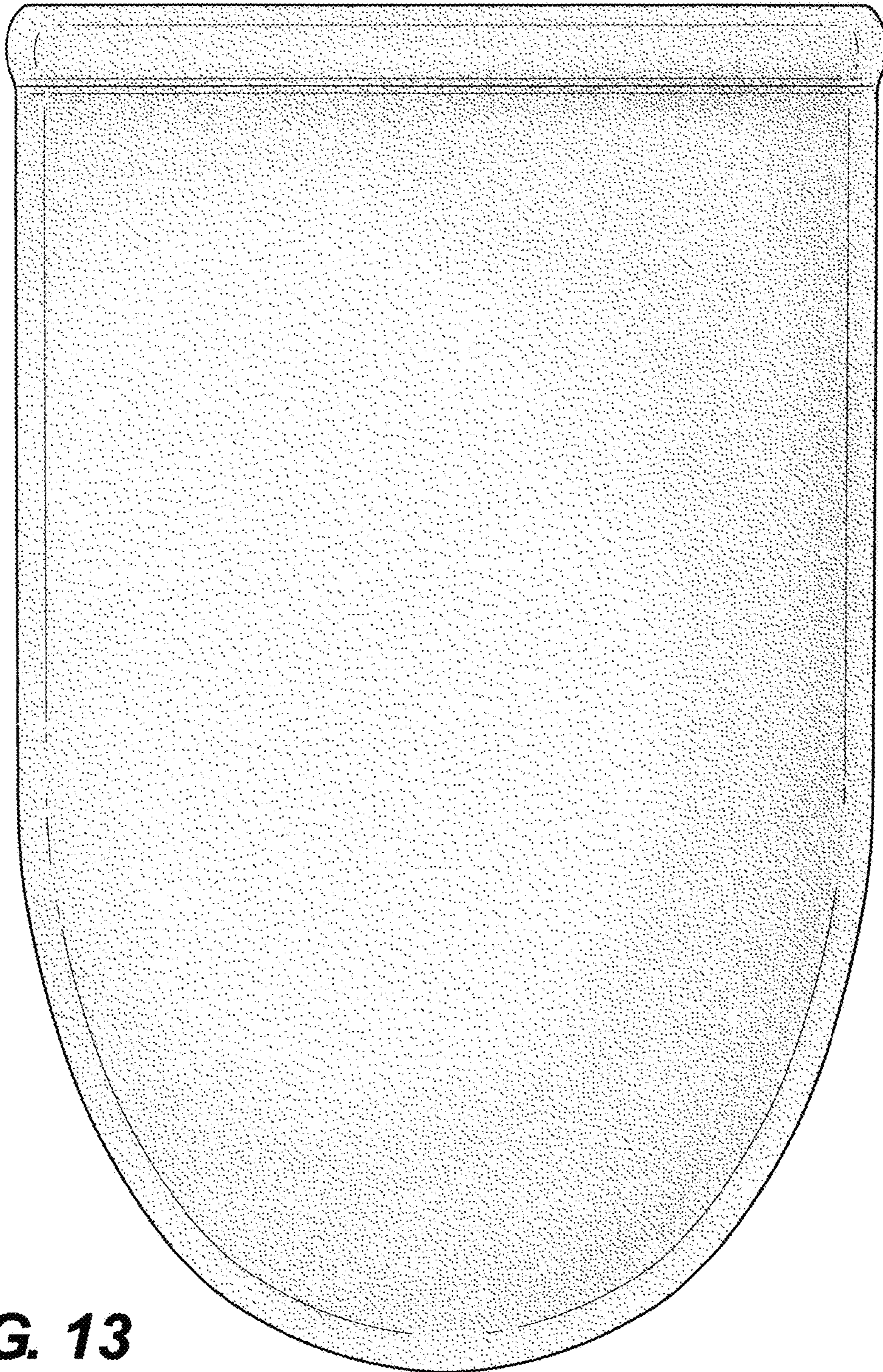
