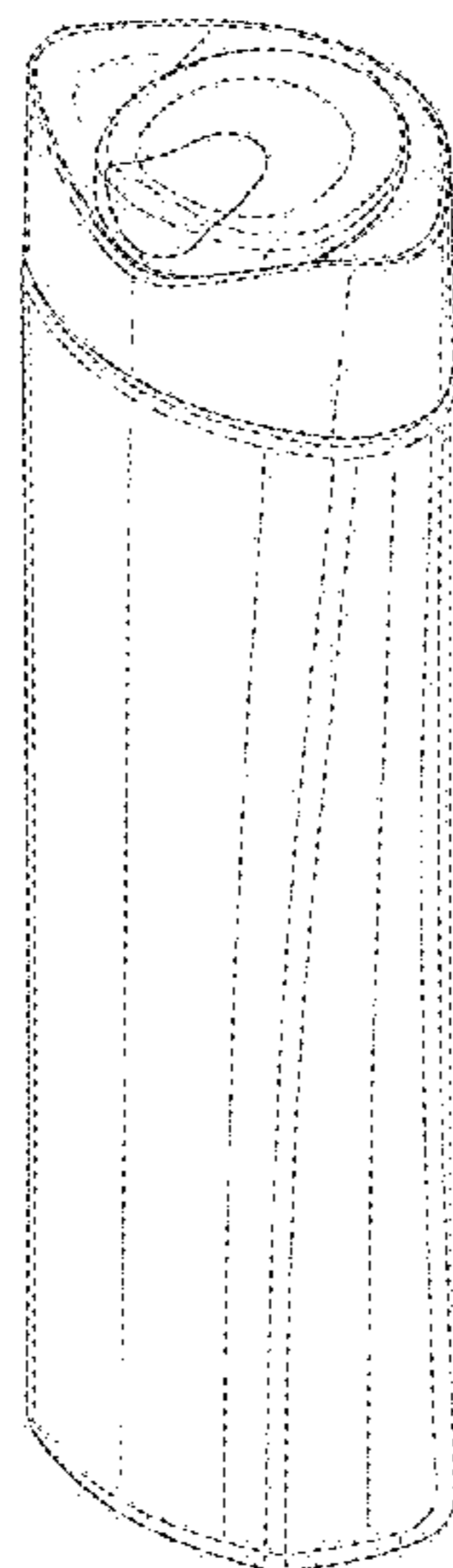
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front and side perspective view of a bottle in accordance with my new design;

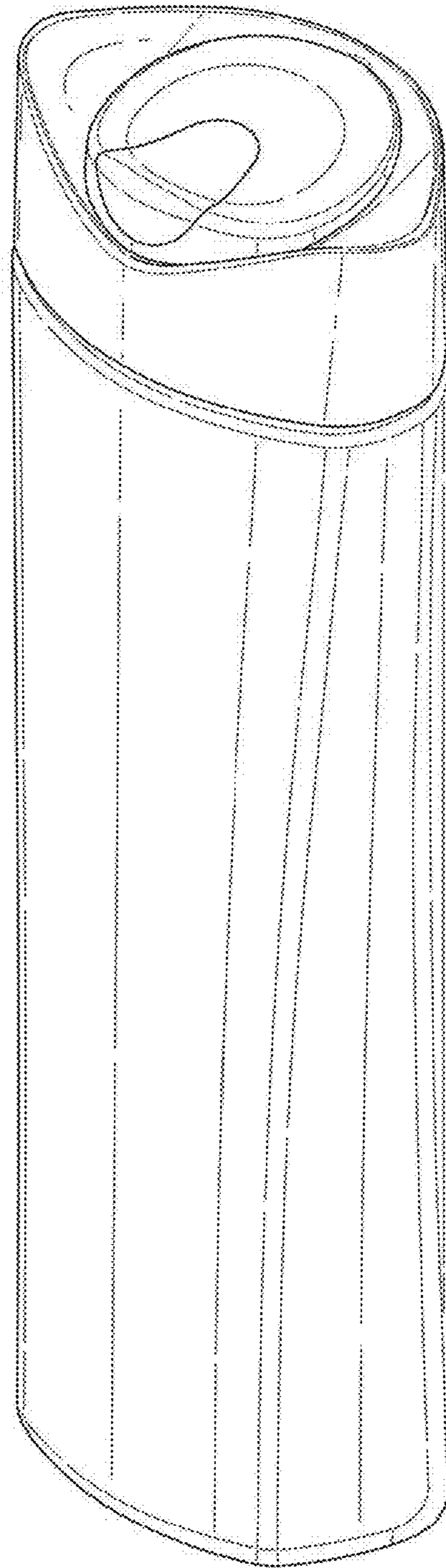

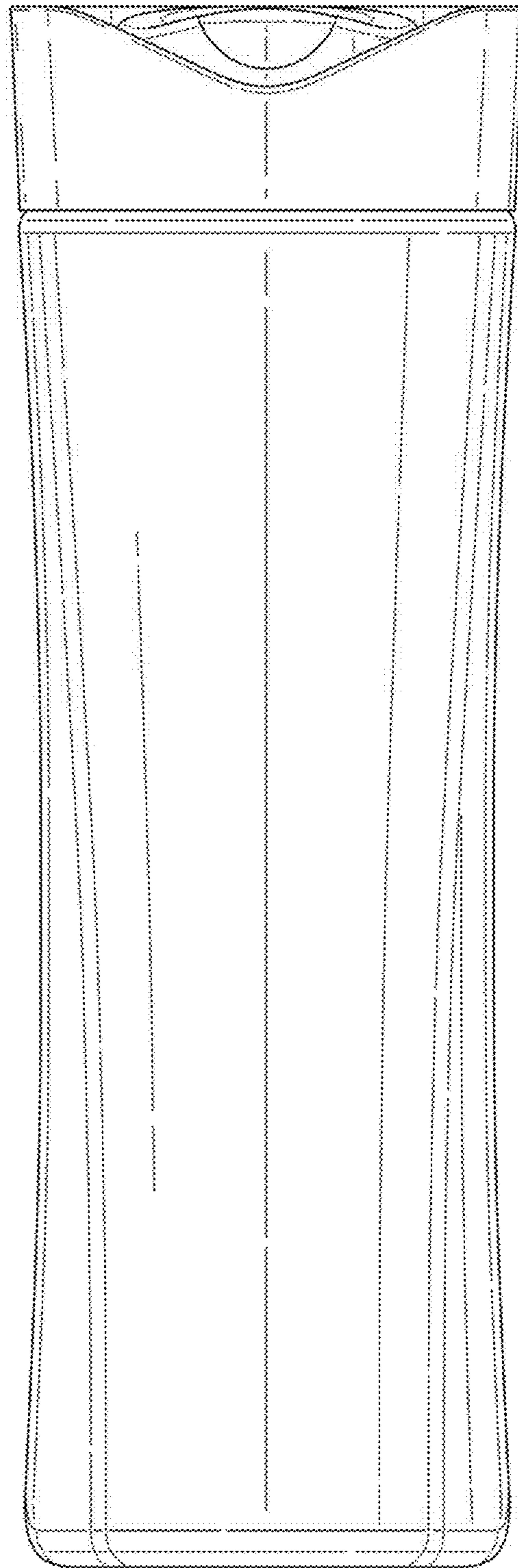

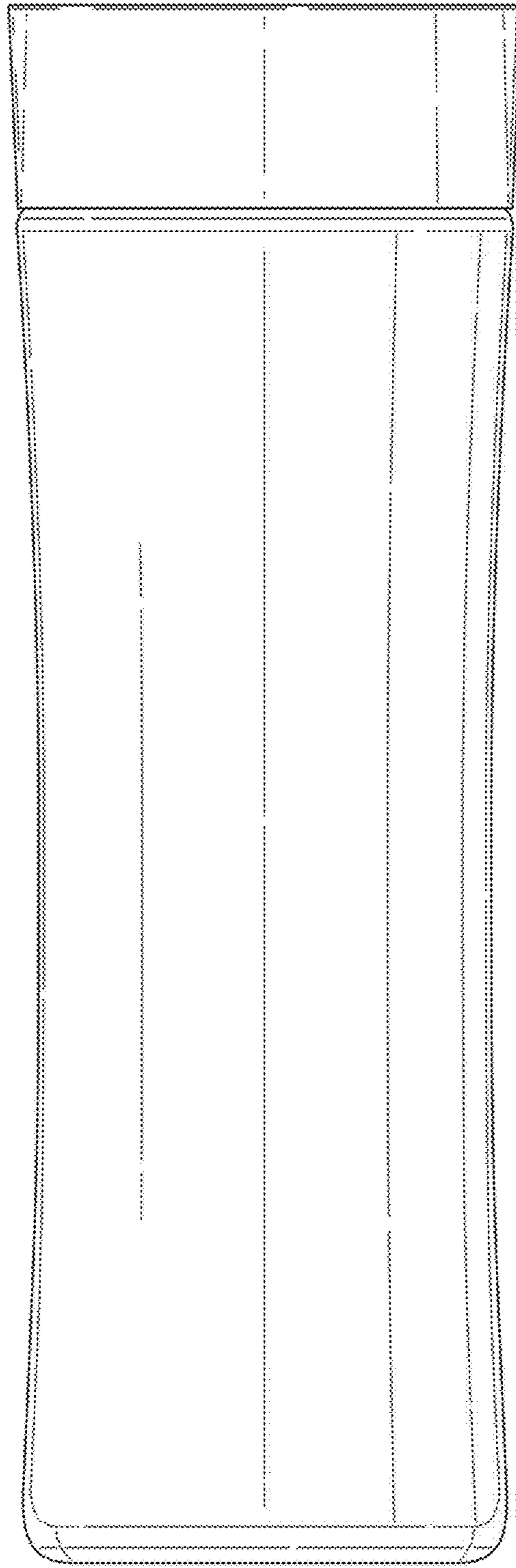

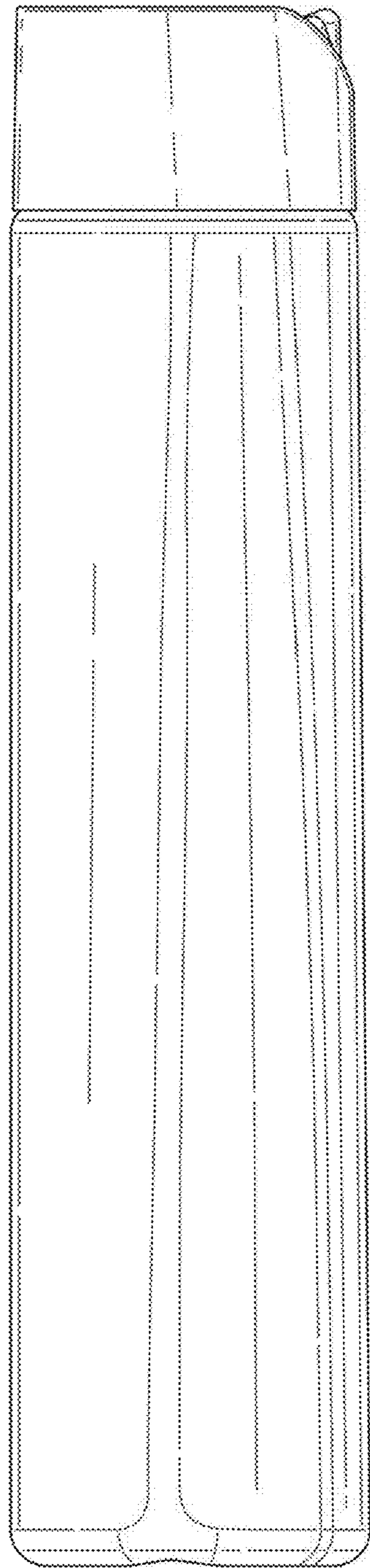

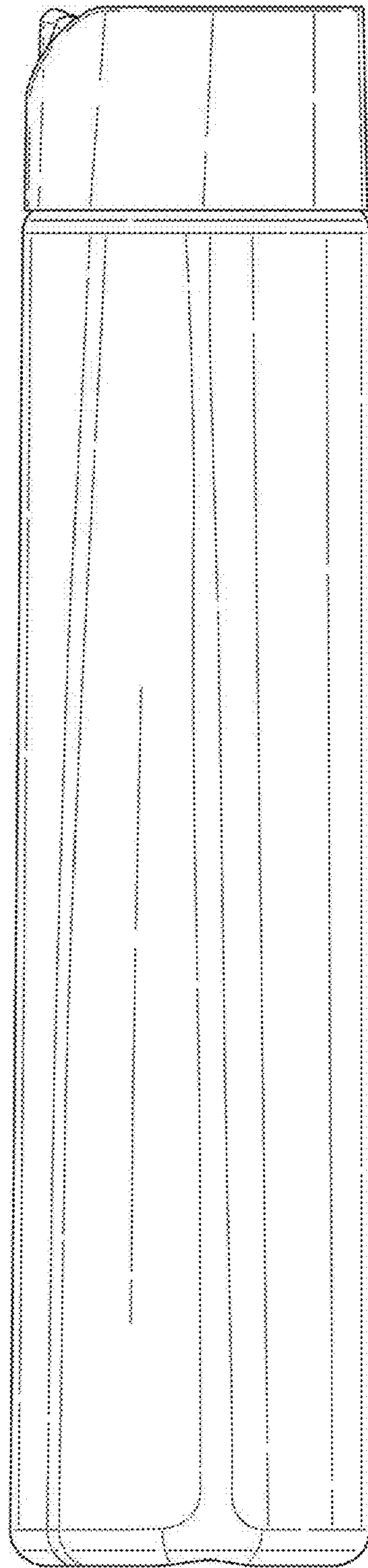

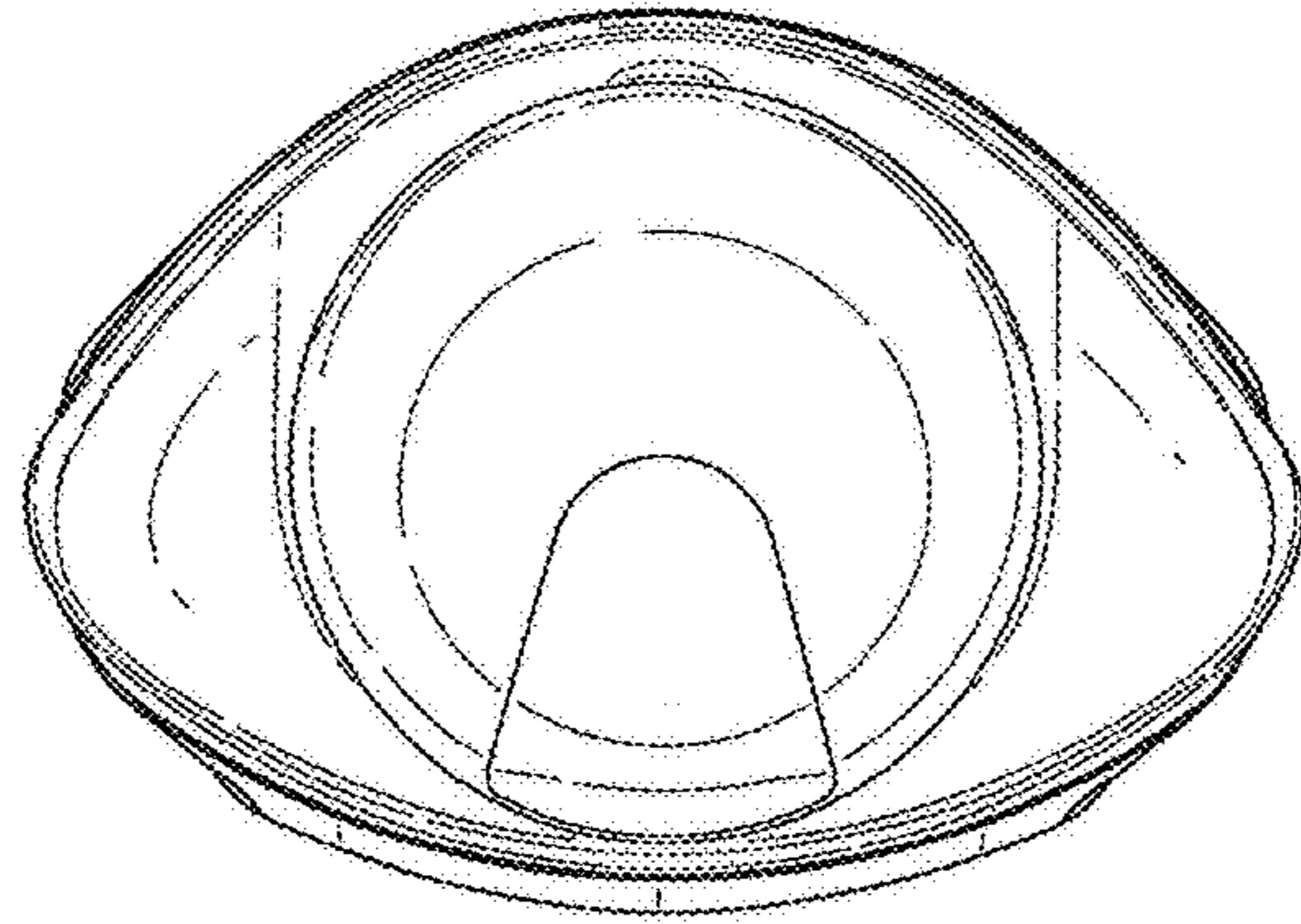

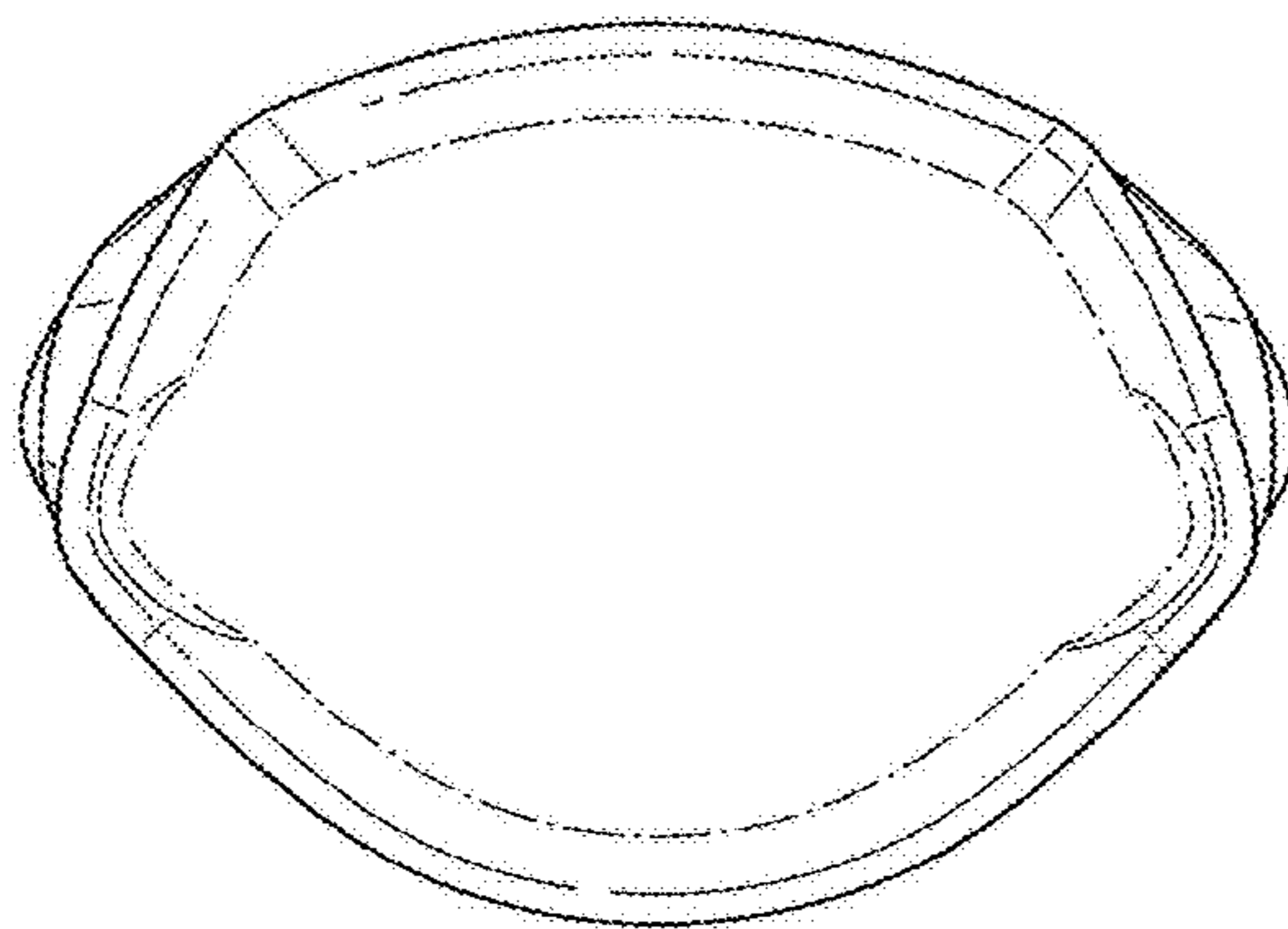
