(57) **CLAIM**

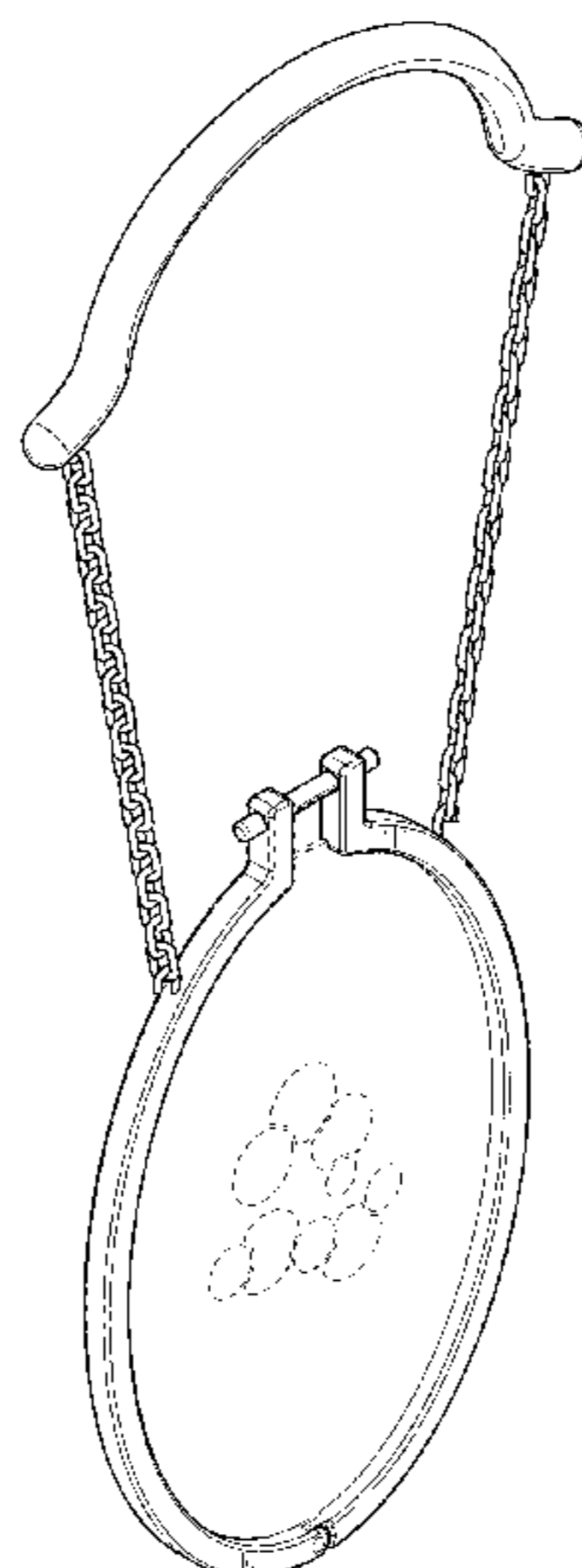
The ornamental design for a surround assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from above, to the front and one side of a first embodiment of the new design for a surround assembly with artwork inside shown in broken lines; FIG. 2 is a perspective view from above, to the front and one side of the first embodiment of the new design without artwork inside; FIG. 3 is a front elevation view thereof; FIG. 4 is a top view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a right side elevation view thereof; FIG. 9 is a perspective view from above, to the front and one side of a second embodiment of the new design for a surround assembly with artwork inside shown in broken lines; FIG. 10 is a perspective view from above, to the front and one side of the second embodiment of the new design without artwork inside; FIG. 11 is a front elevation view thereof; FIG. 12 is a top view thereof; FIG. 13 is a left side elevation view thereof; FIG. 14 is a rear elevation view thereof; FIG. 15 is a bottom view thereof; and, FIG. 16 is a right side elevation view thereof.

The broken lines shown in the drawings illustrate environmental structure that forms no part of the claimed design. The surround assembly is shown with symbolic break lines in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

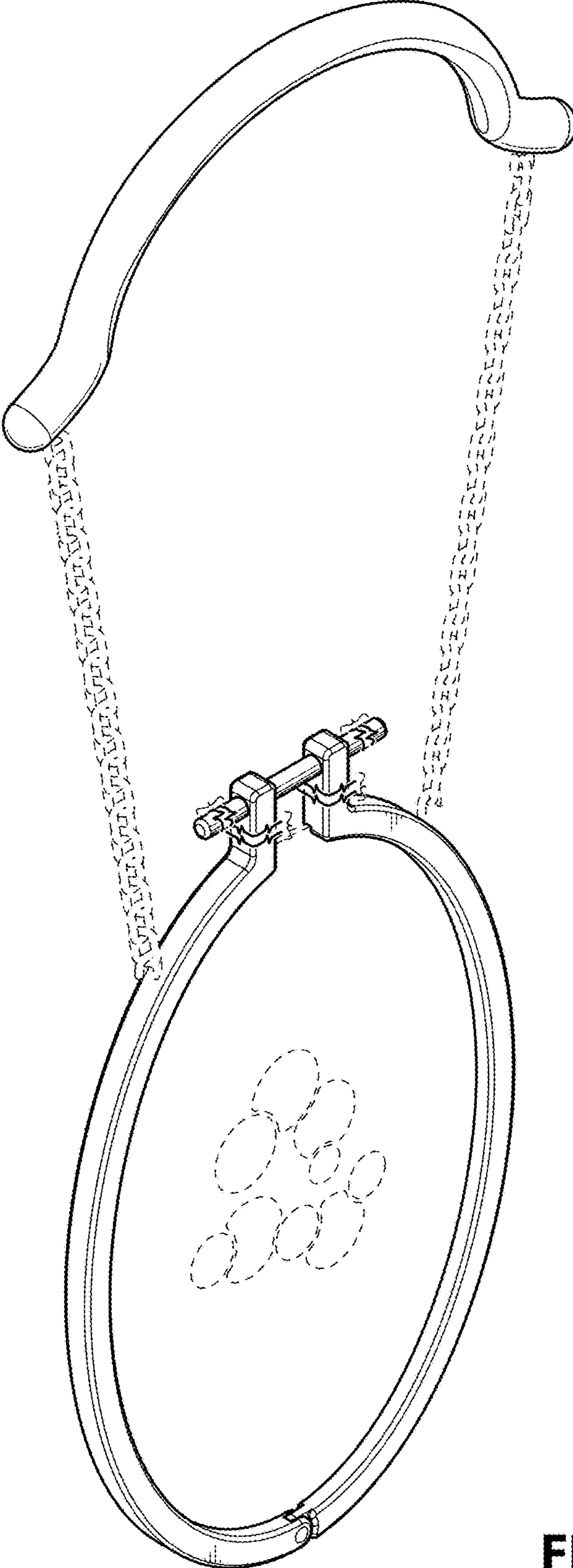

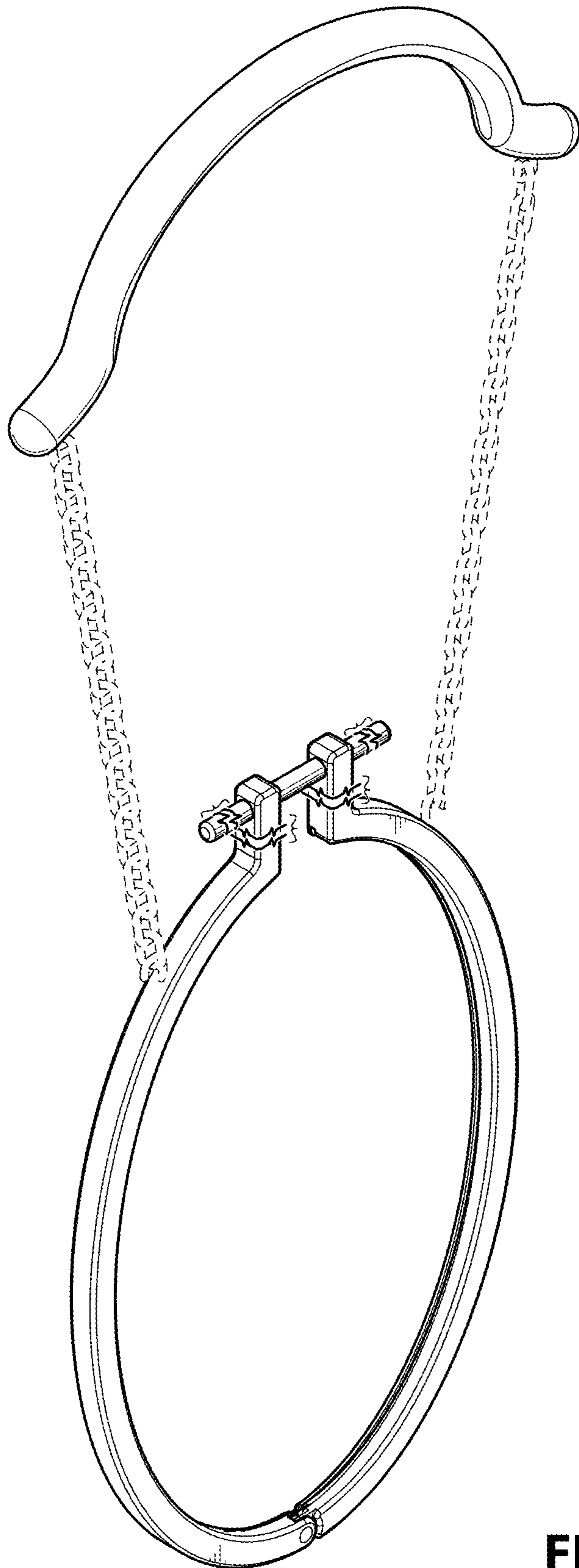
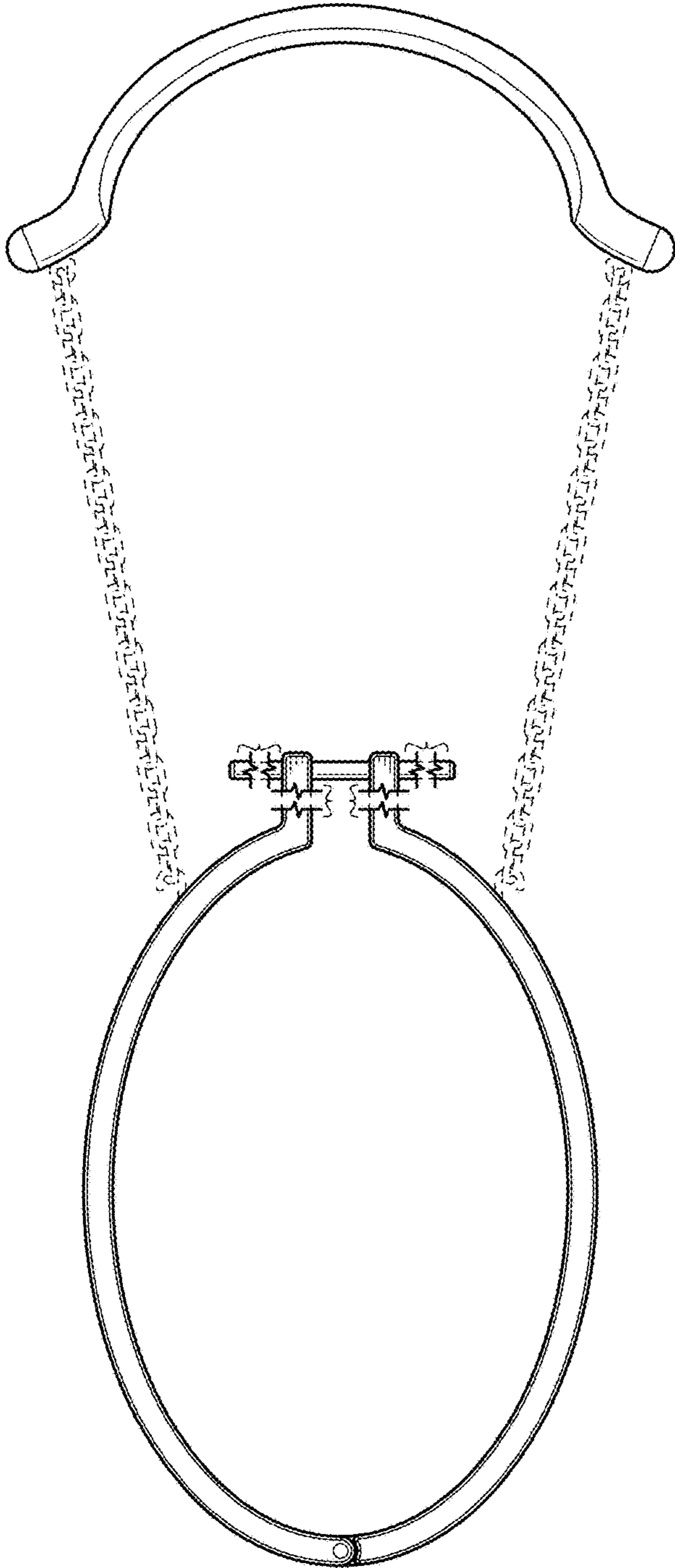

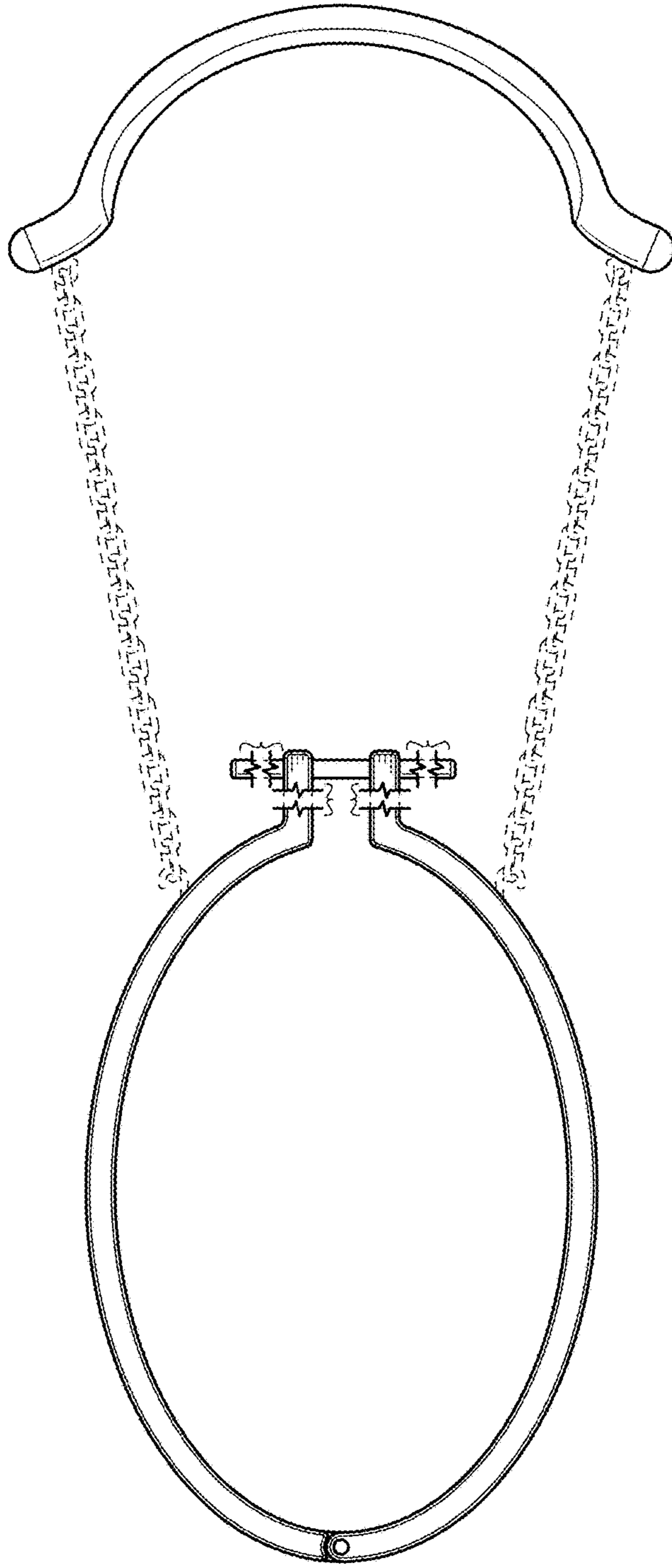

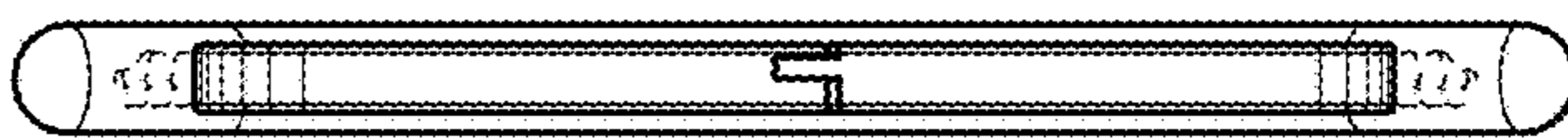

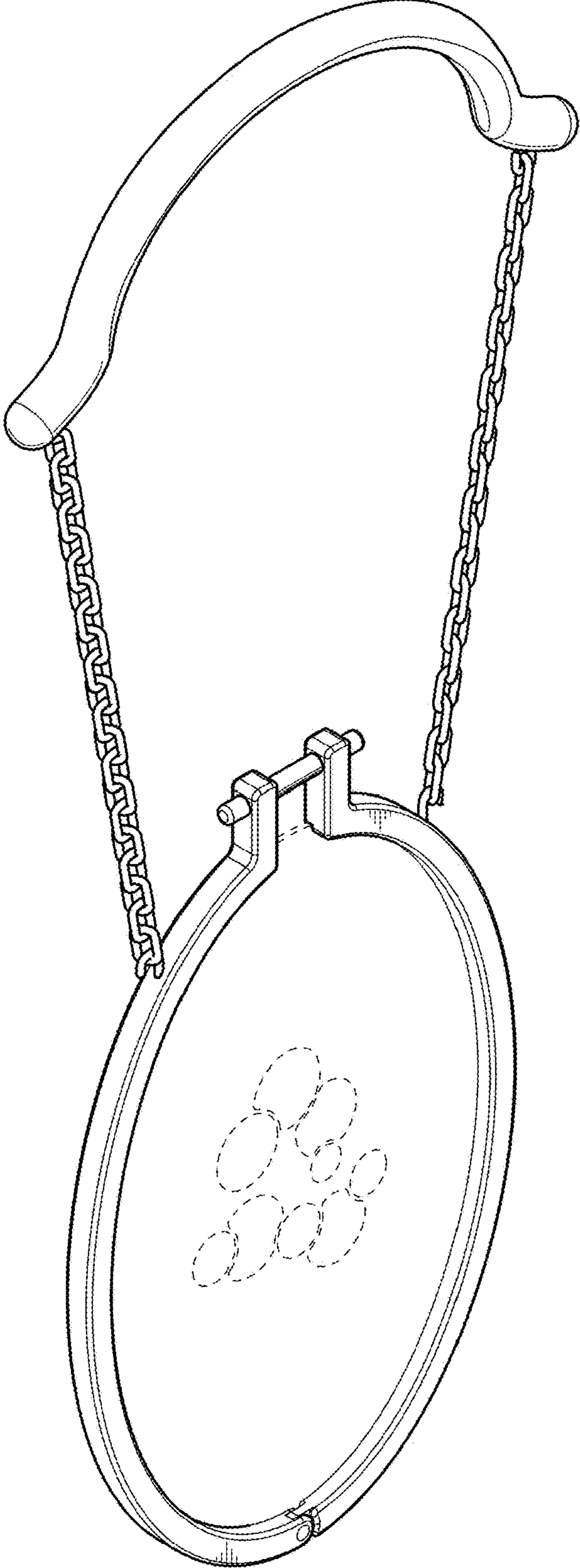
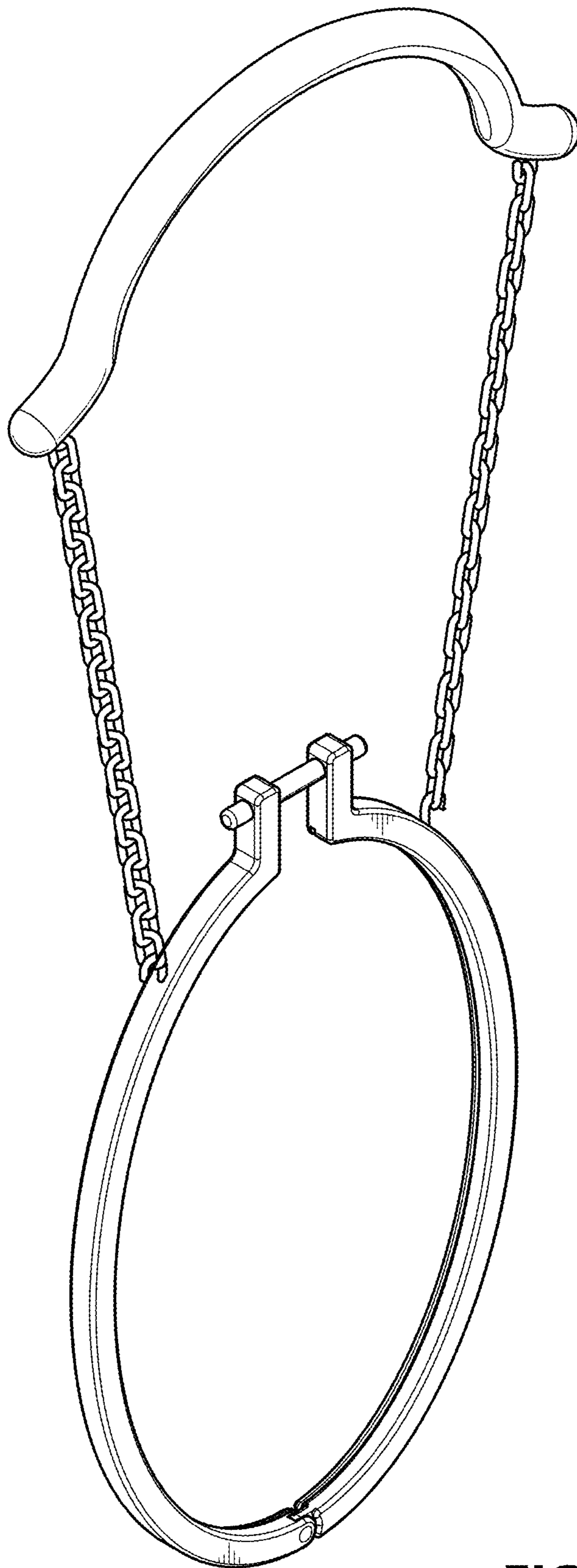

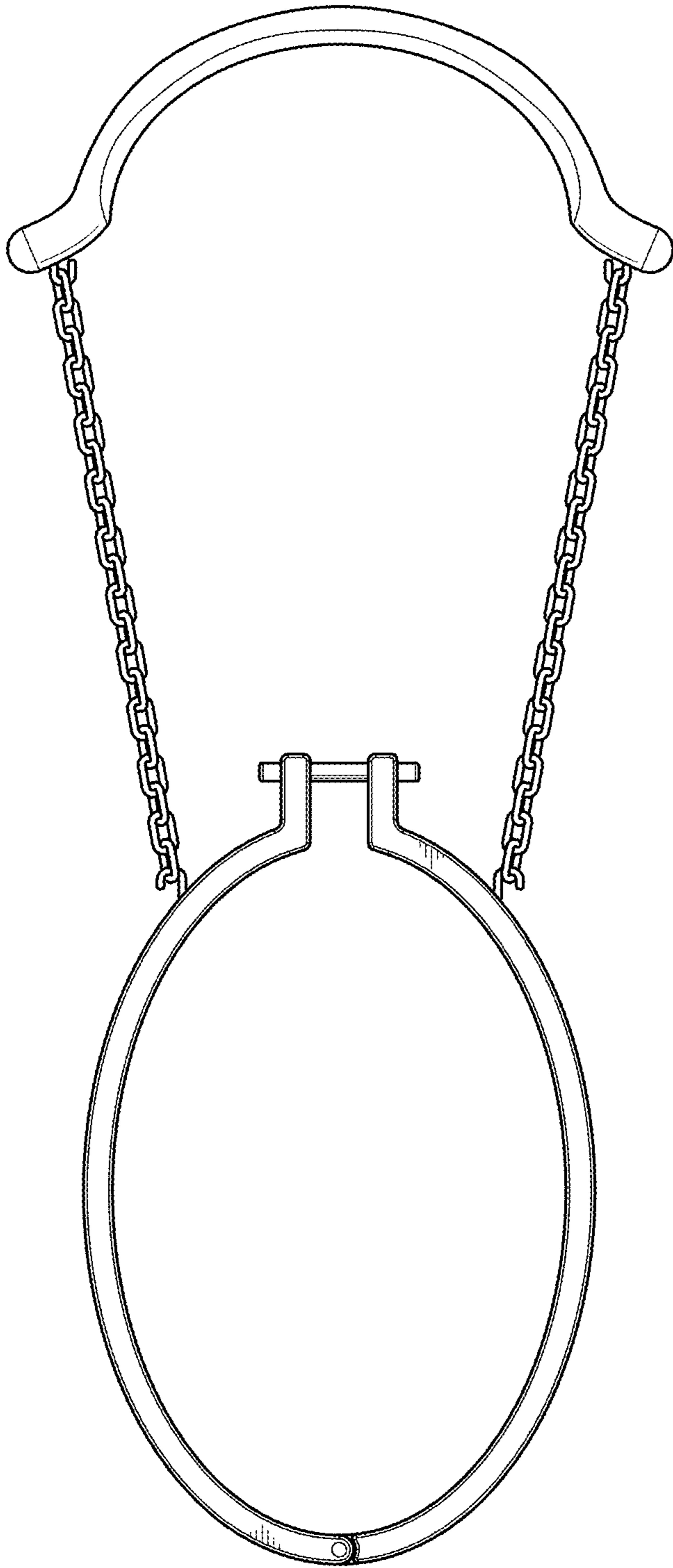

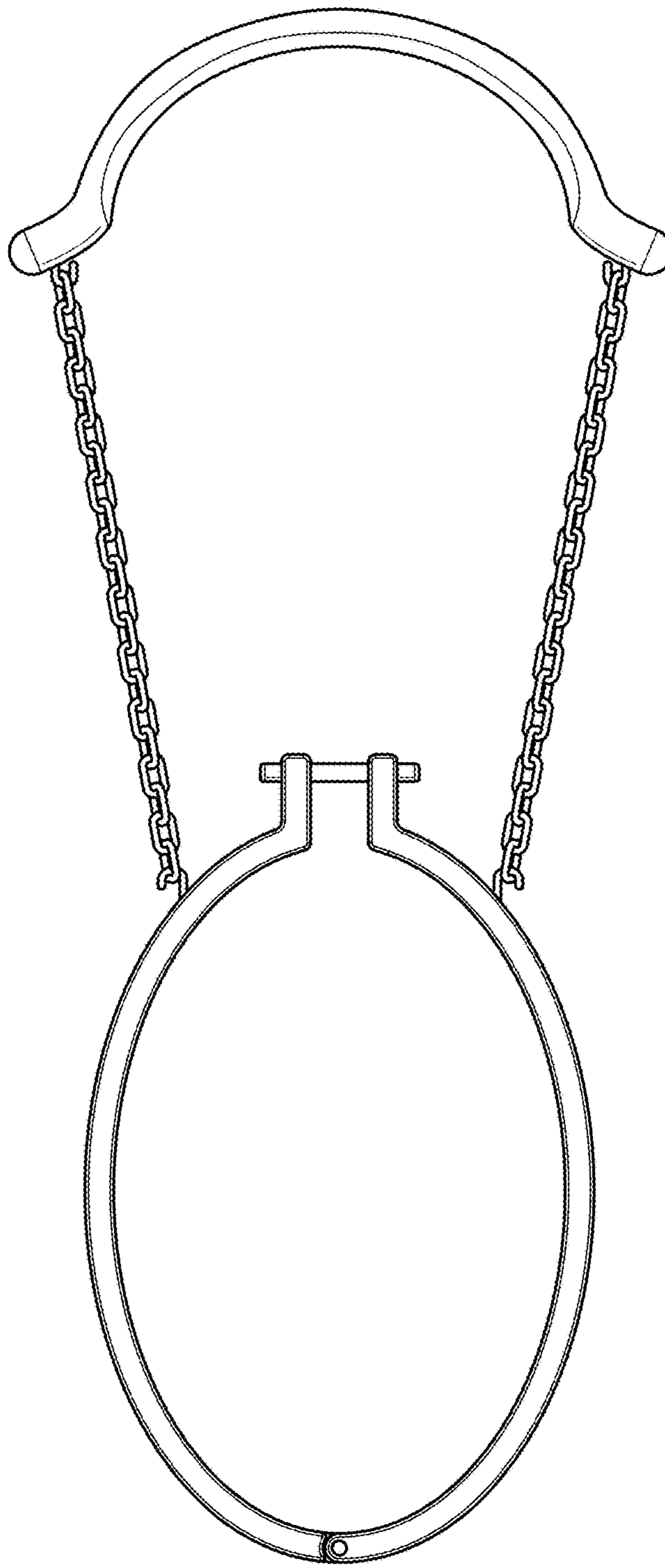
