(57) **CLAIM**

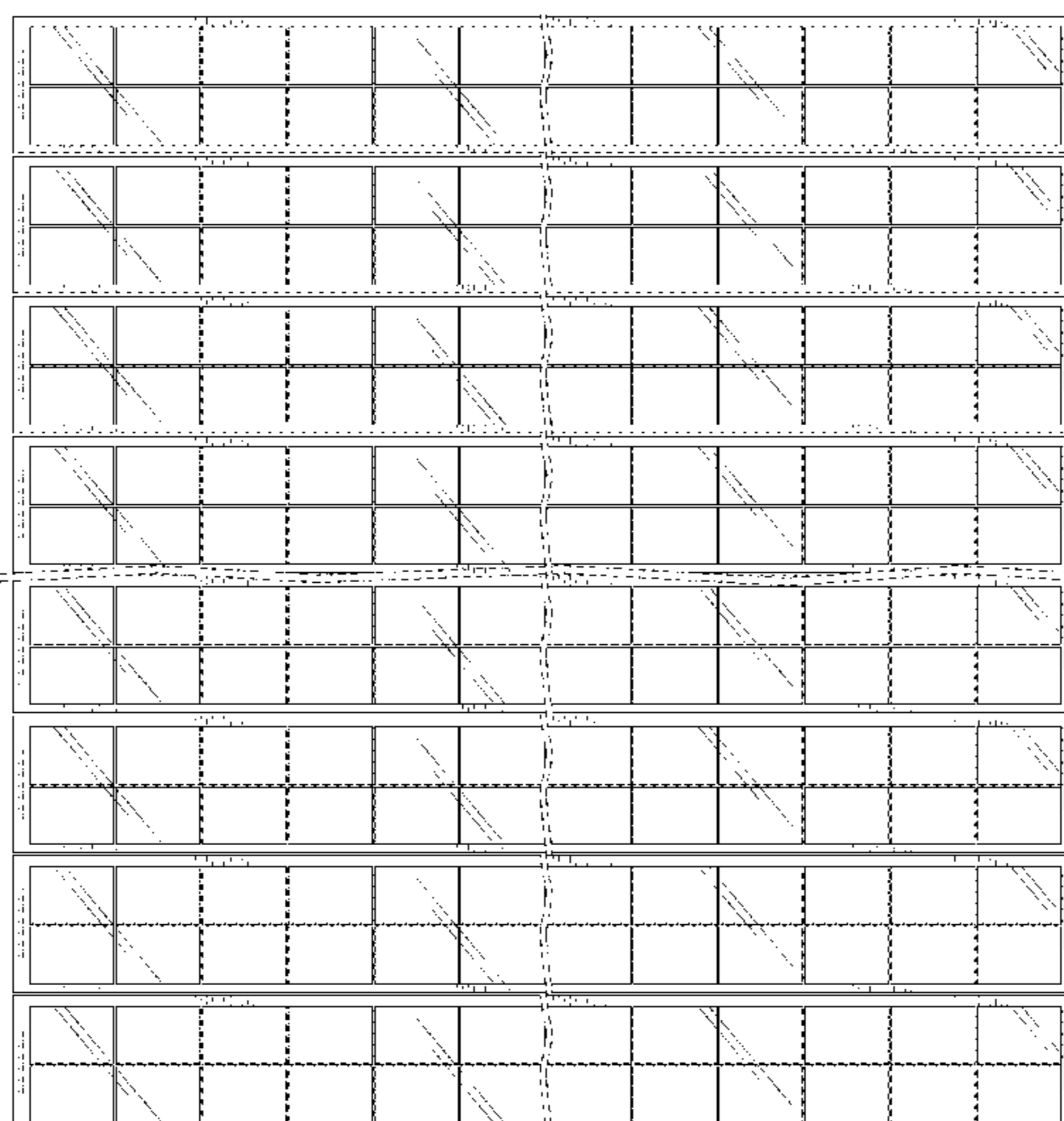
The ornamental design for a solar collector, as shown and described.

**DESCRIPTION**

FIG. 1 is front elevational view of a solar collector showing my novel design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;  
FIG. 7 is a front perspective view thereof;  
FIG. 8 is a front elevational view of a second embodiment of the solar collector mounted on a support stand;  
FIG. 9 is right side elevational view of the second embodiment;  
FIG. 10 is a front elevational view of a third embodiment of the solar collector shown mounted to a wall; and,  
FIG. 11 is a right side elevational view of the third embodiment.

The broken lines shown in FIGS. 1-7 indicate a symbolic break in length. The appearance of any portion of the article between the break lines forms no part of the claimed design. The broken lines shown in FIGS. 8-11 illustrate environment and form no part of claimed design.

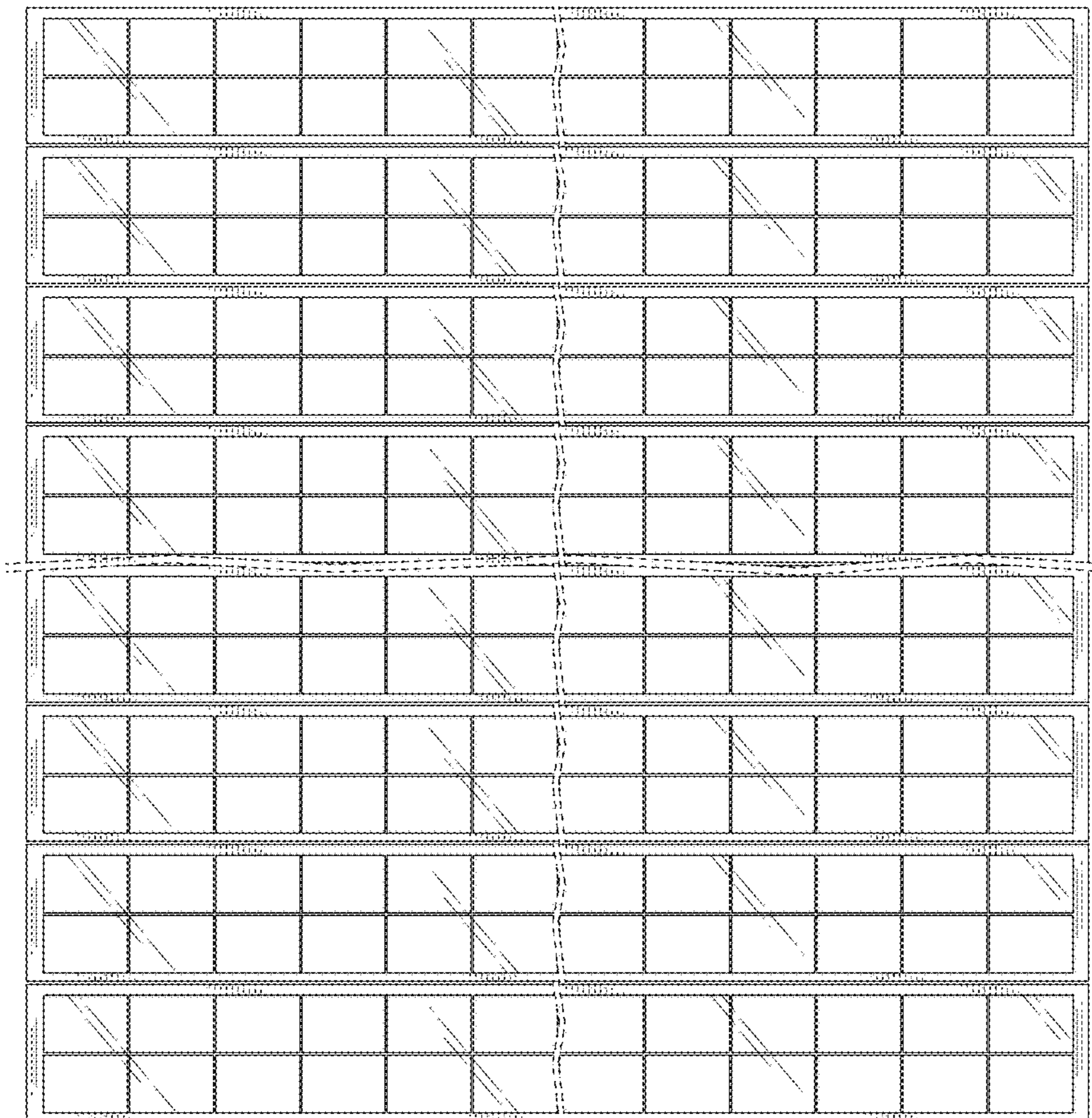
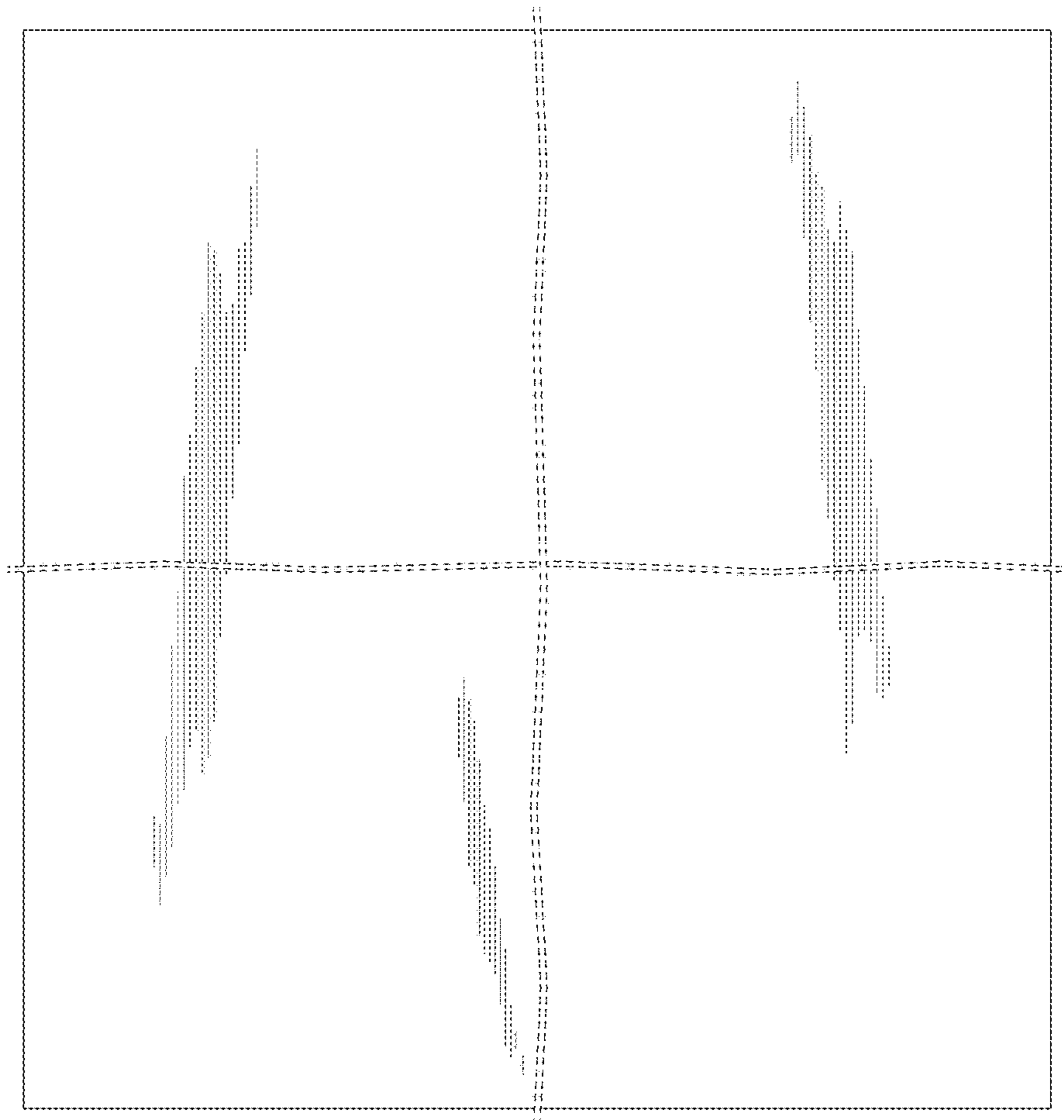
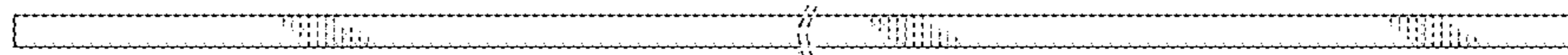


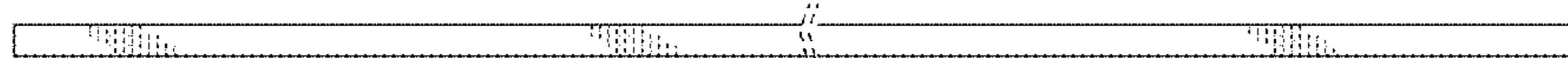

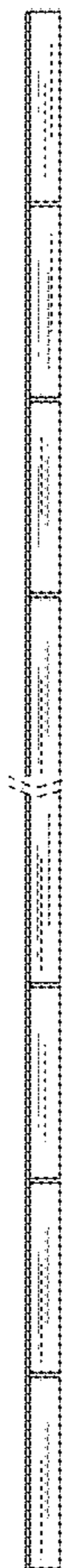

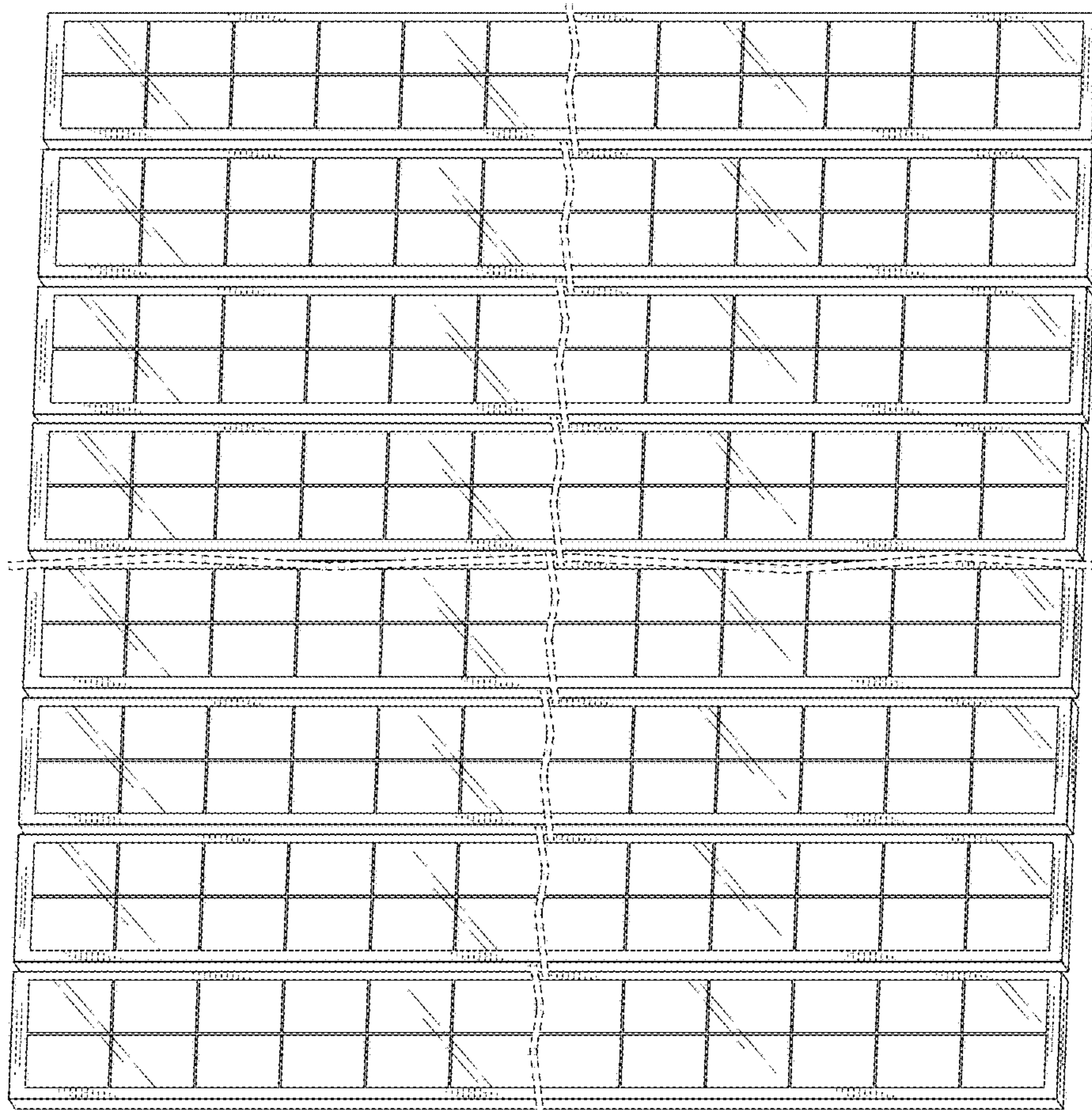
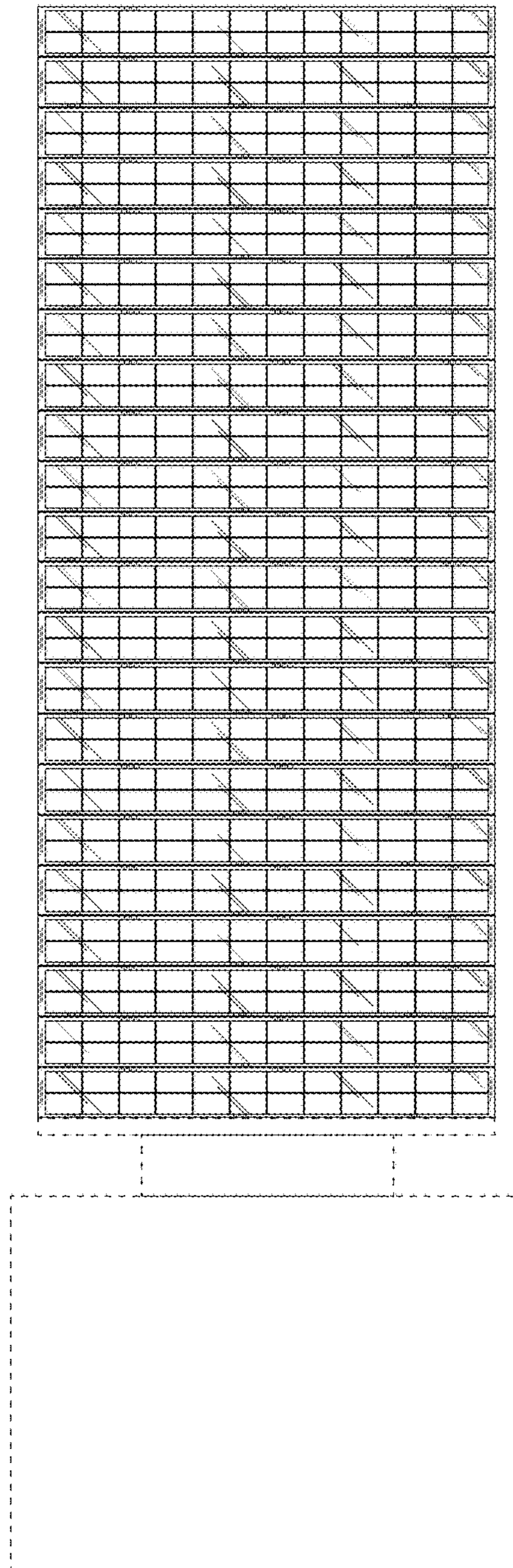
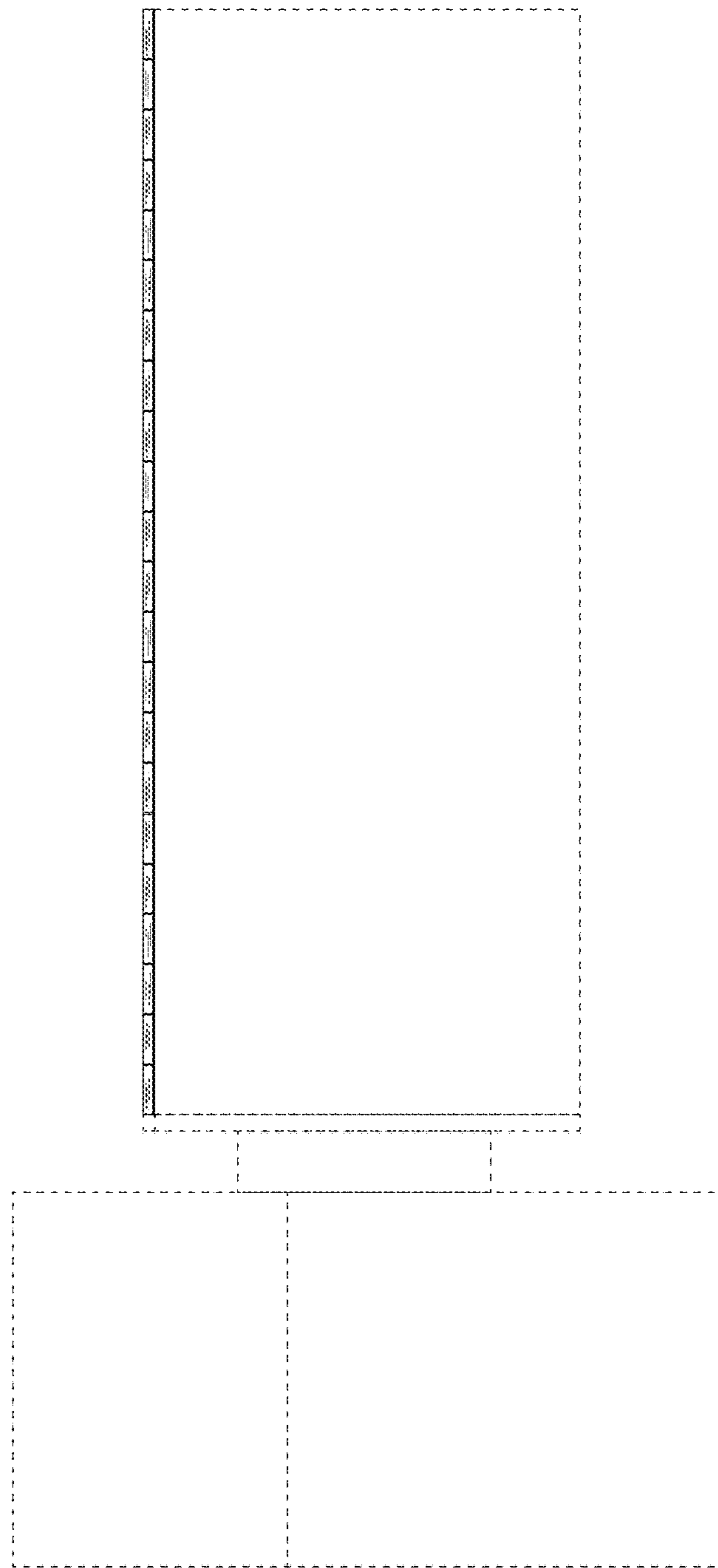

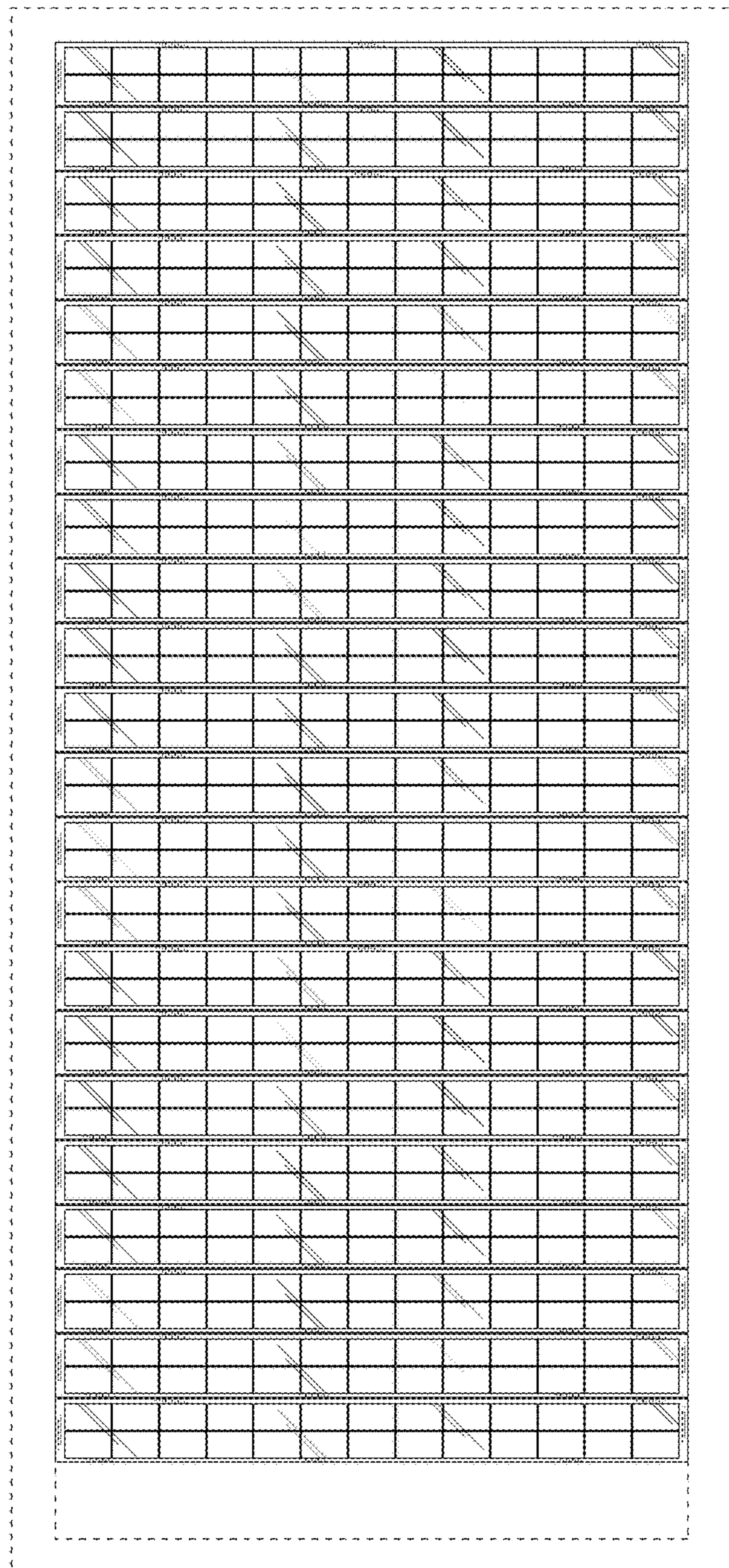
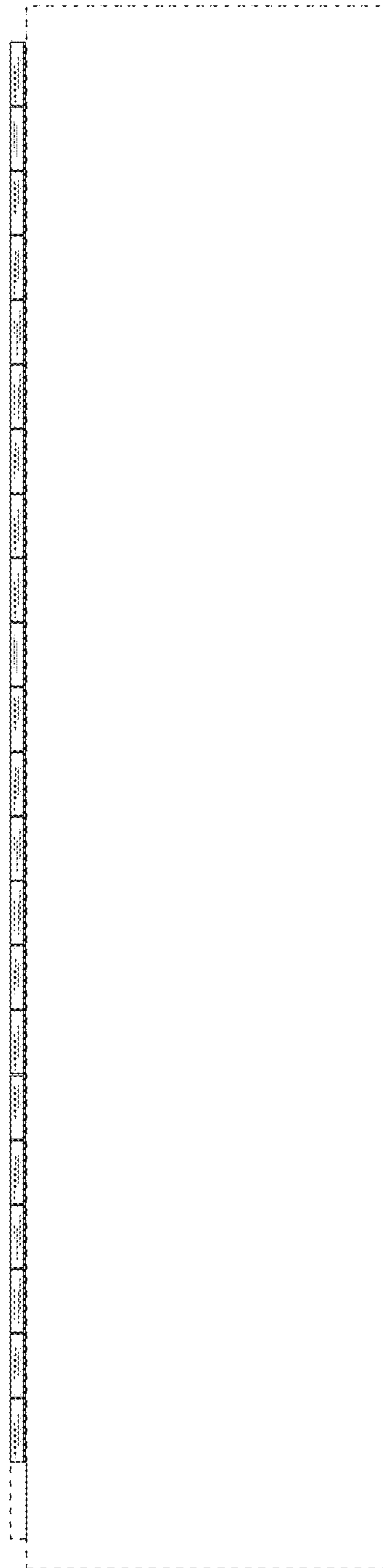
