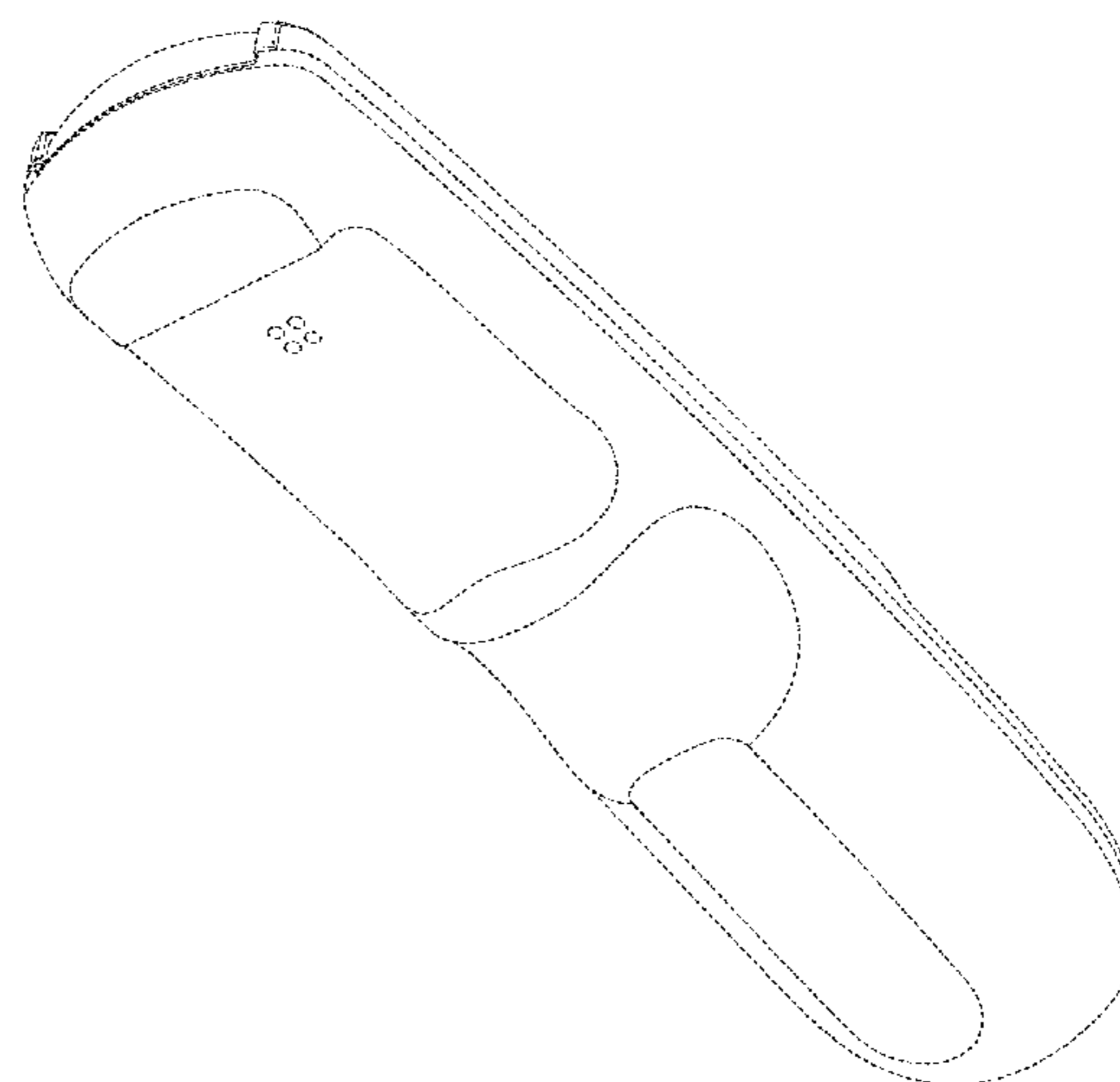
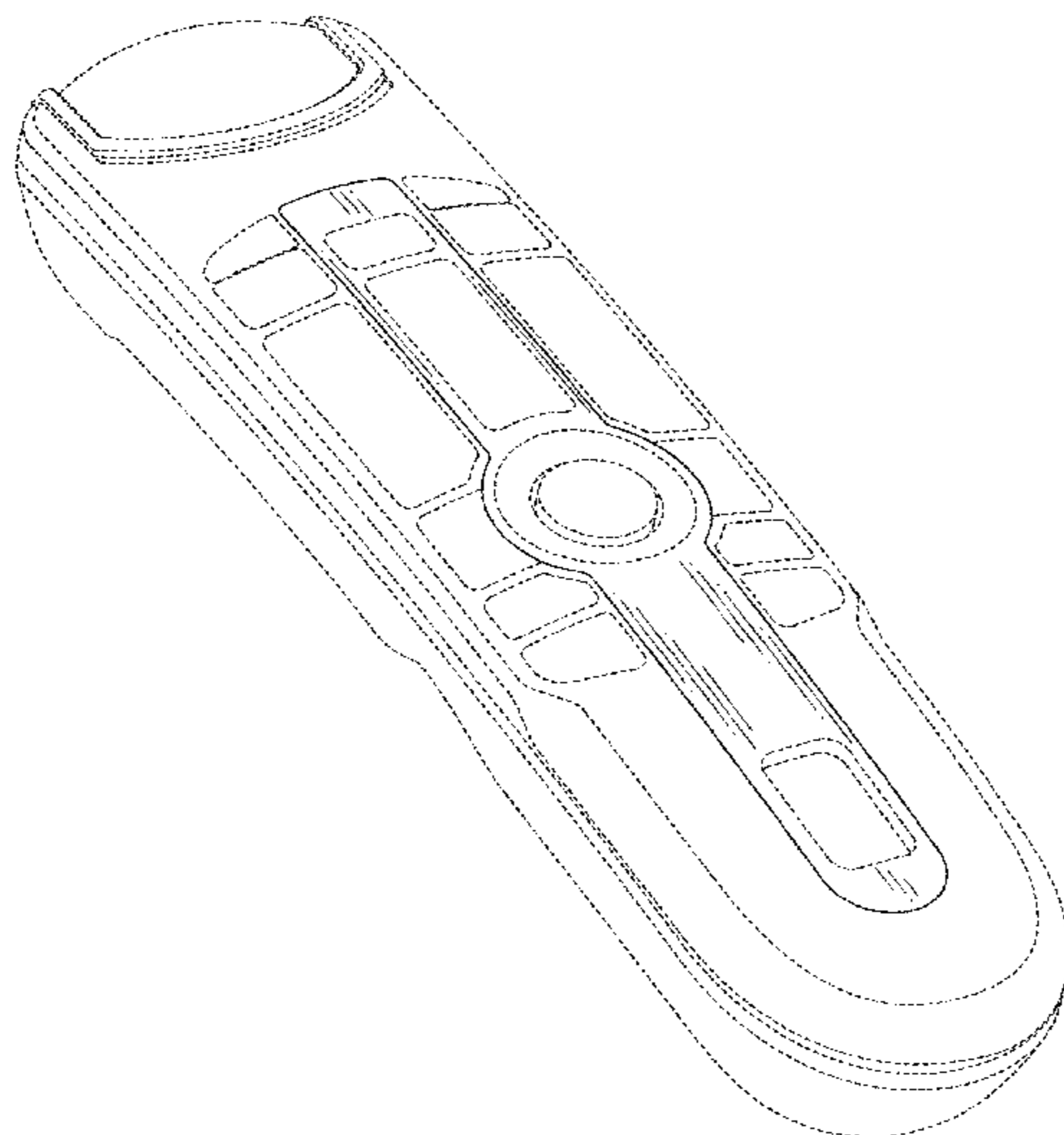
(57) **CLAIM**

described.

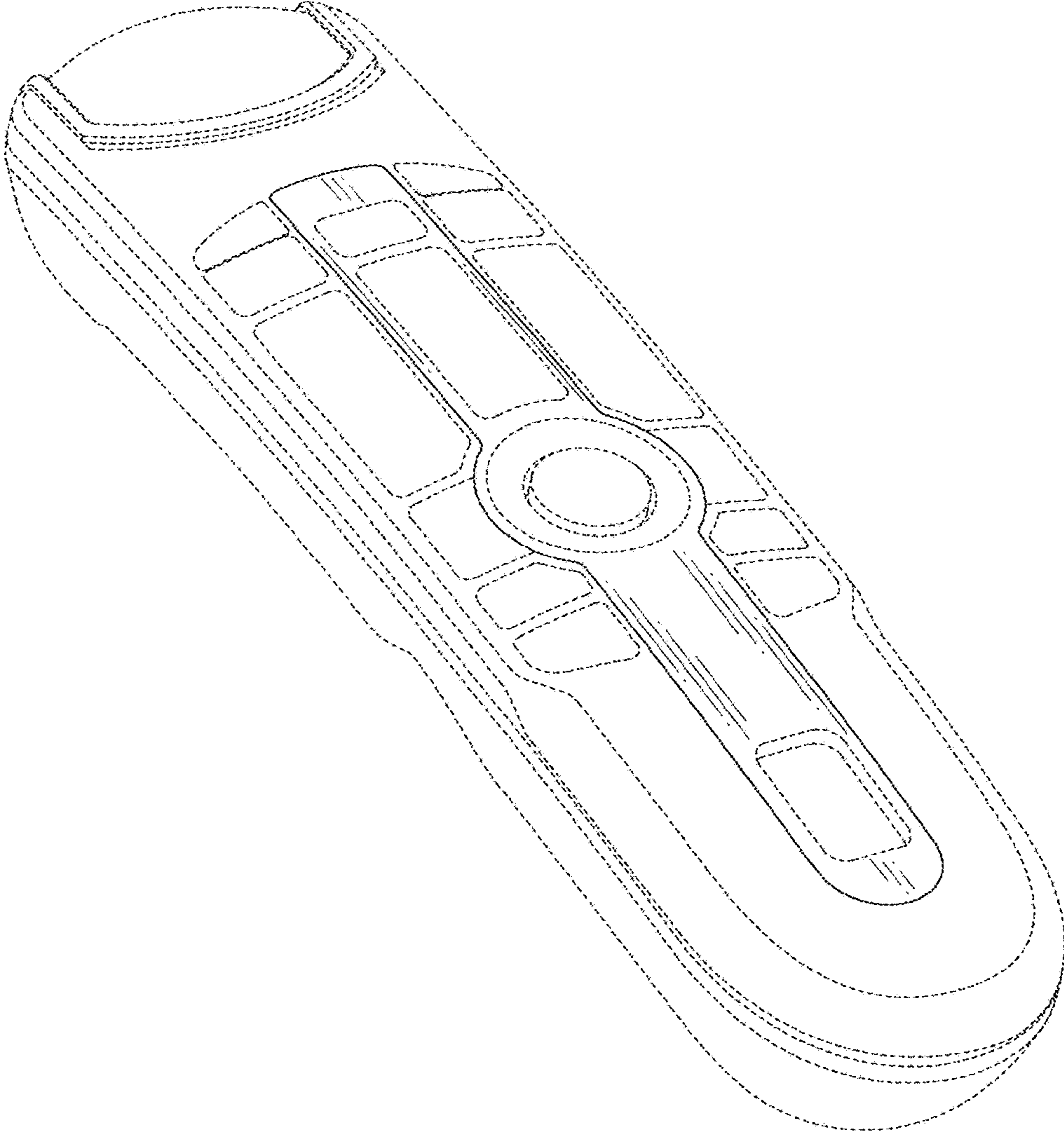
**DESCRIPTION**

design.

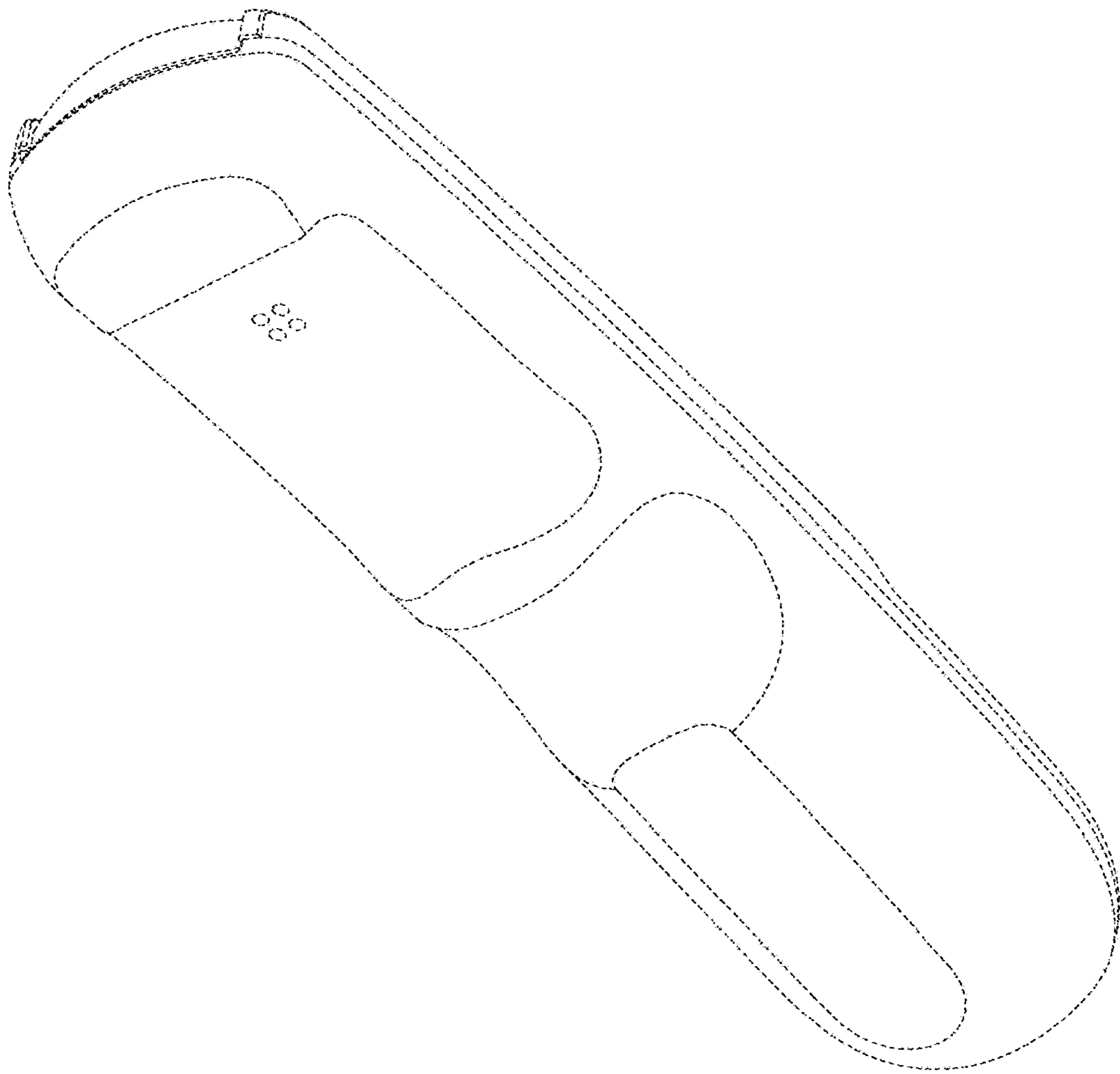

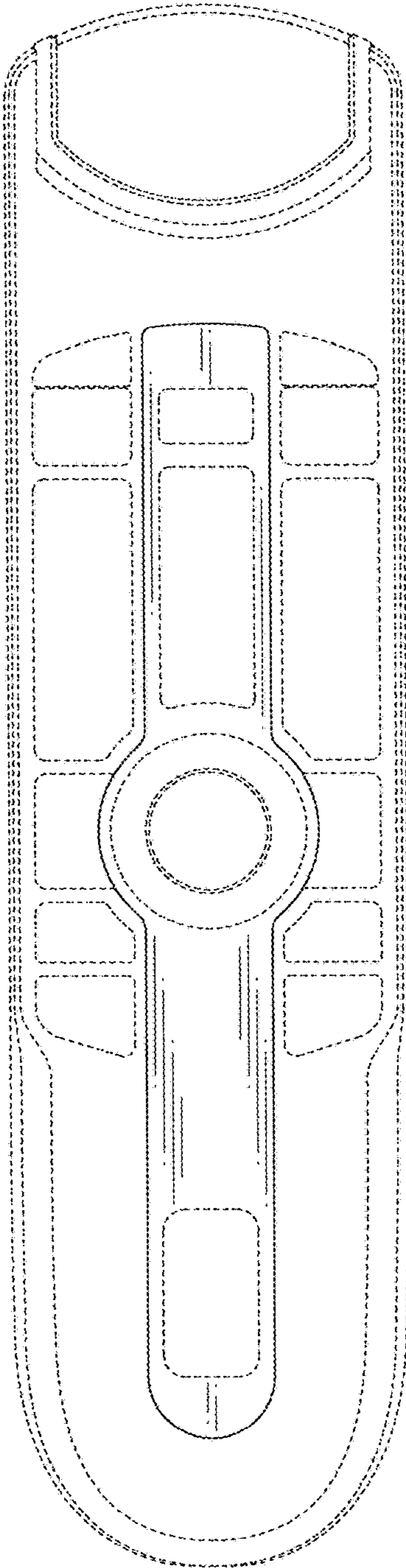

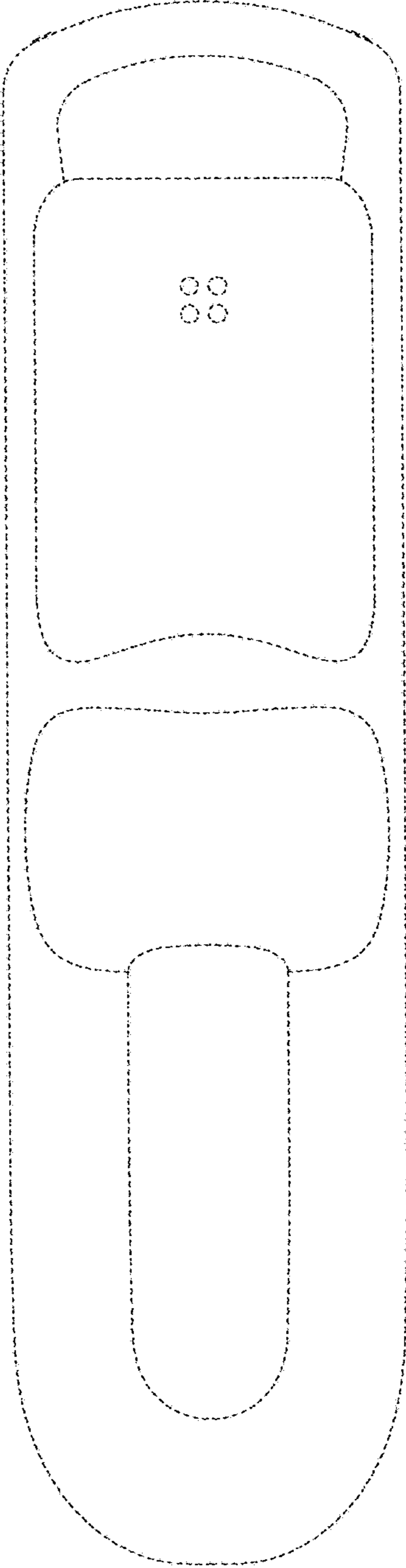

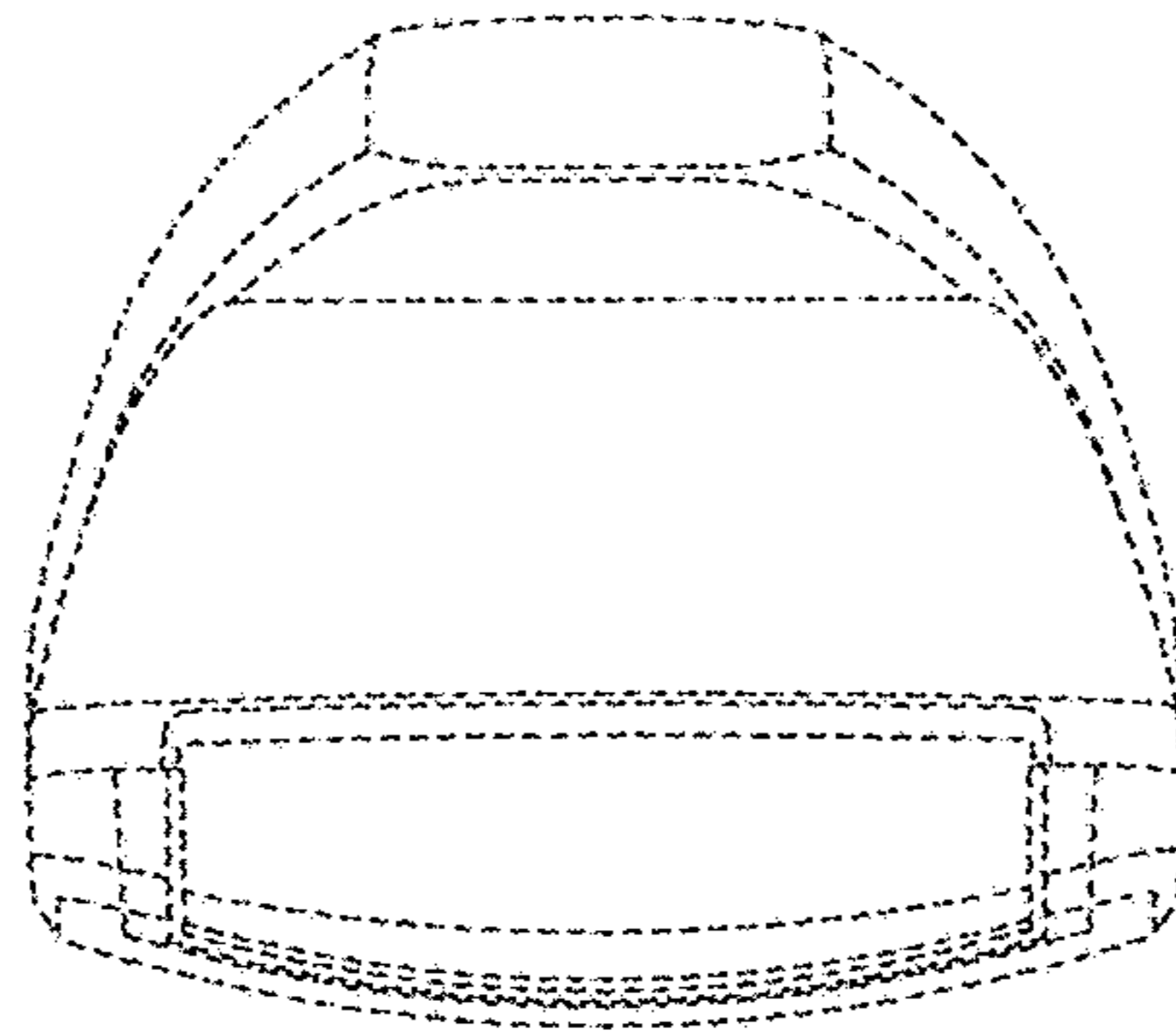

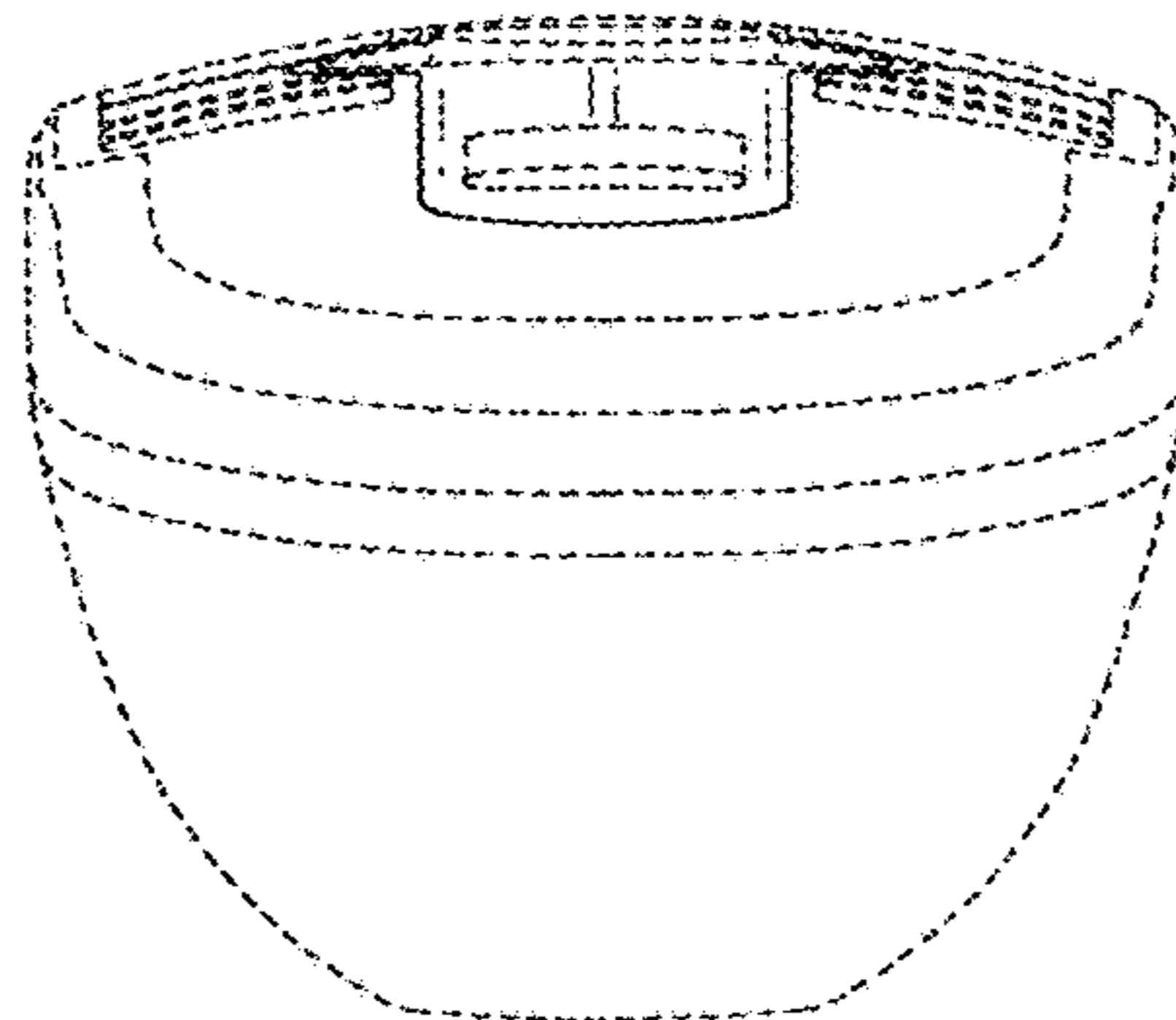

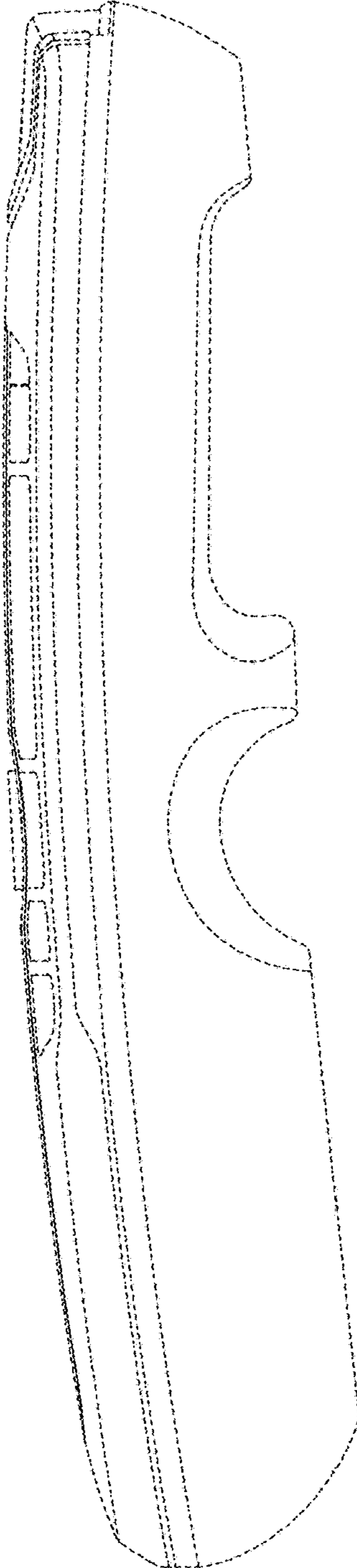
