DESCRIPTION

FIG. 1 is a front, right side, perspective view of a household robot showing our new design;
 FIG. 2 is a front view thereof;

 FIG. 5 is a right side view thereof;
 FIG. 6 is a top view thereof; and,

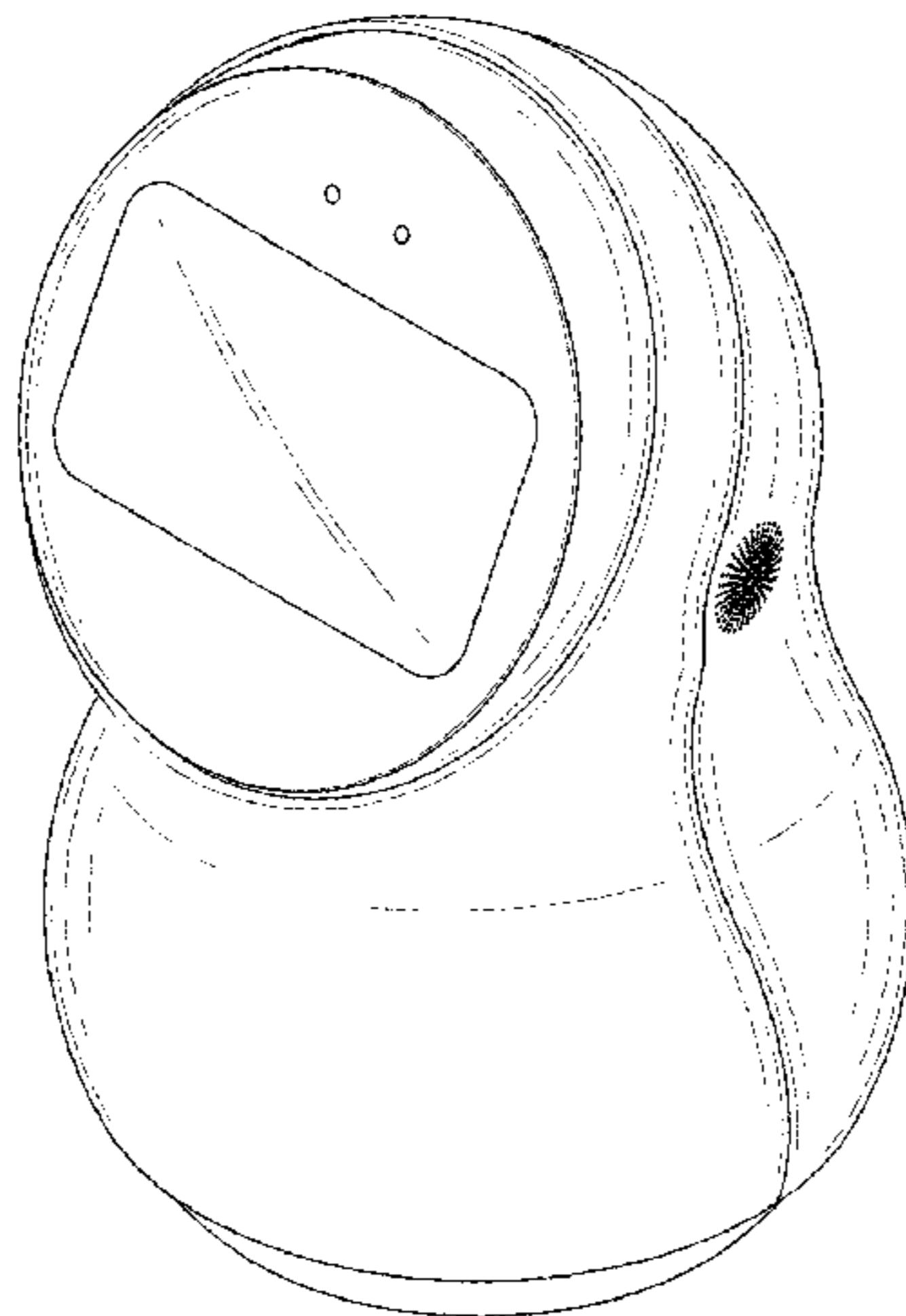

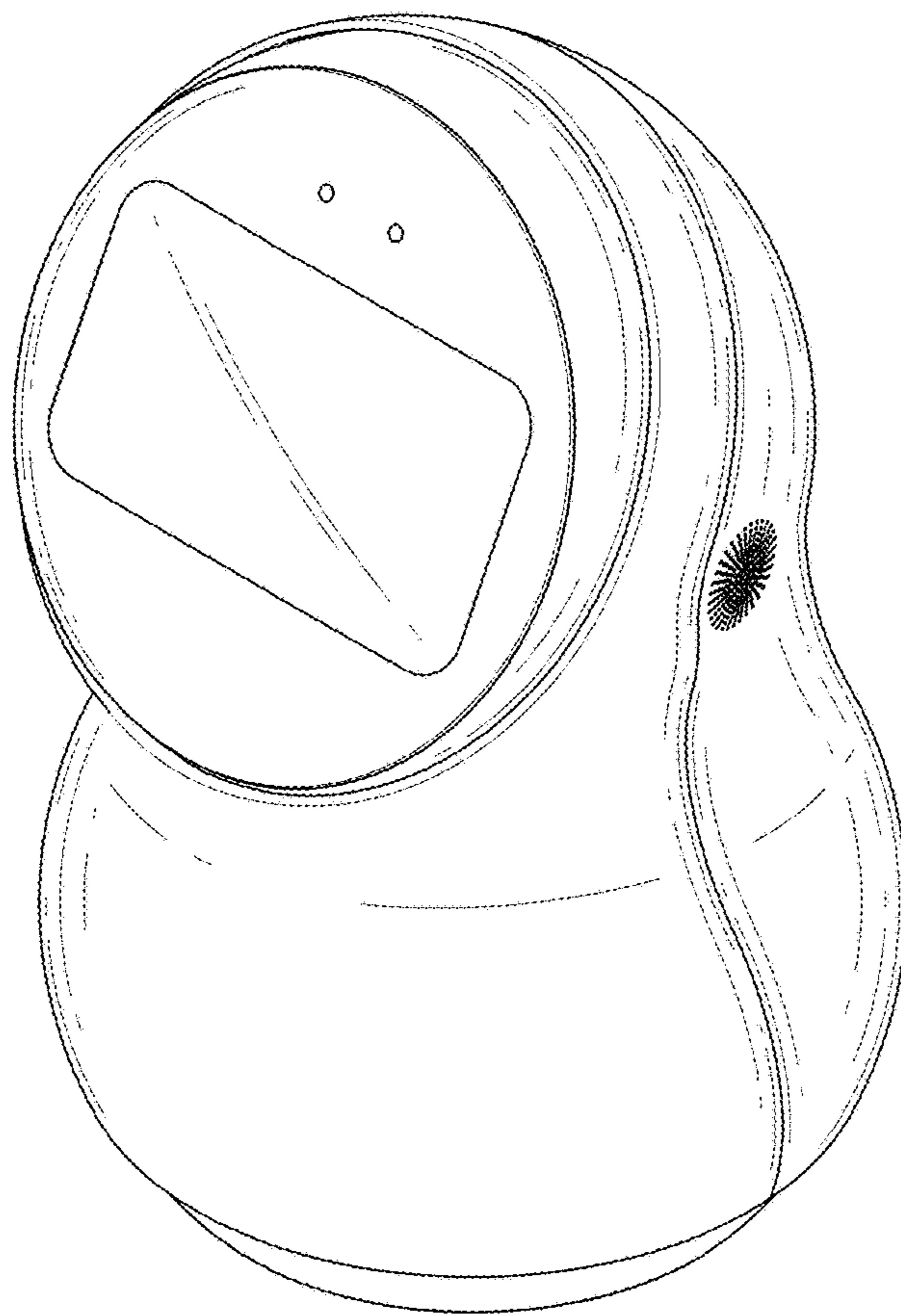

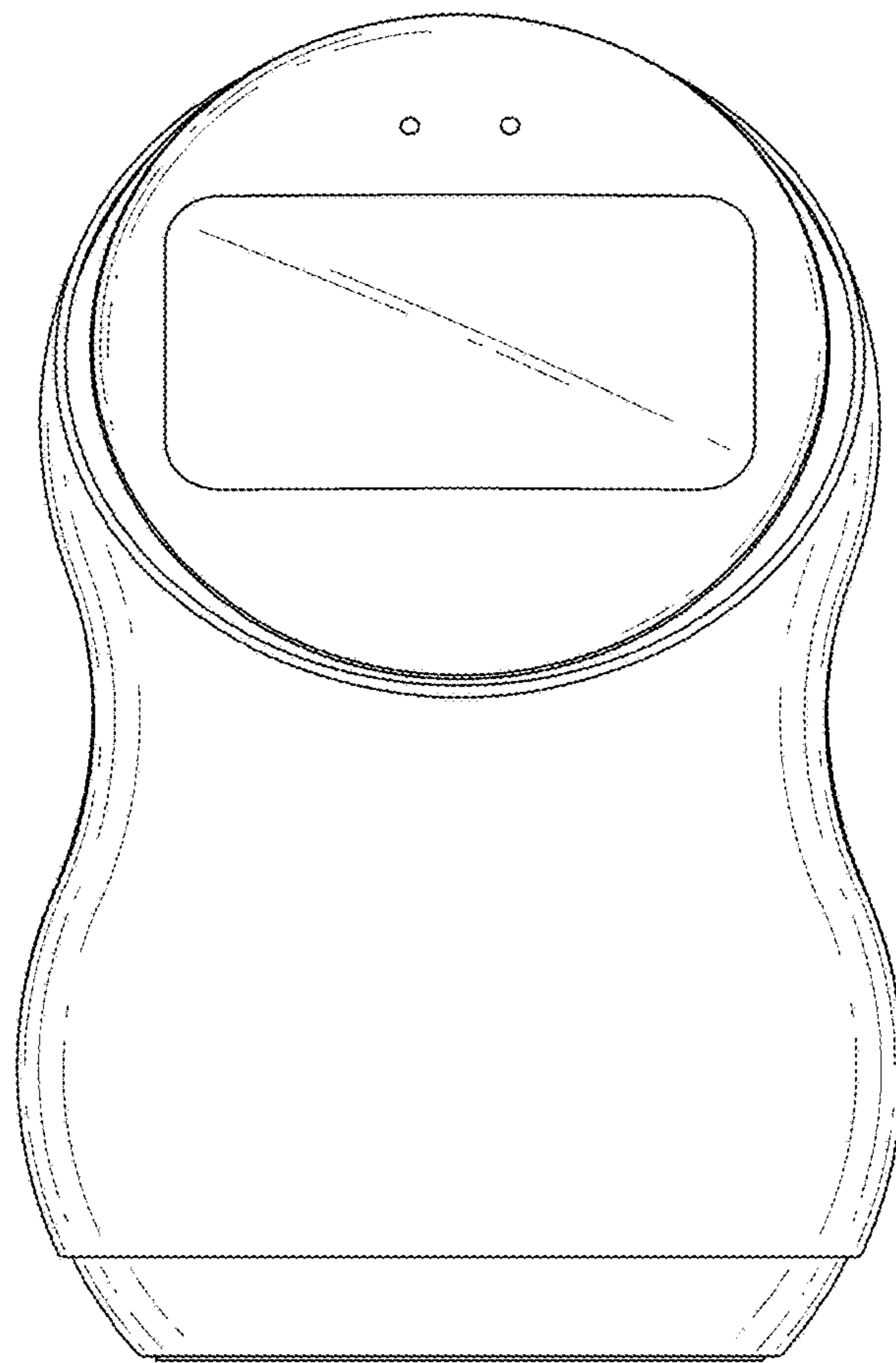

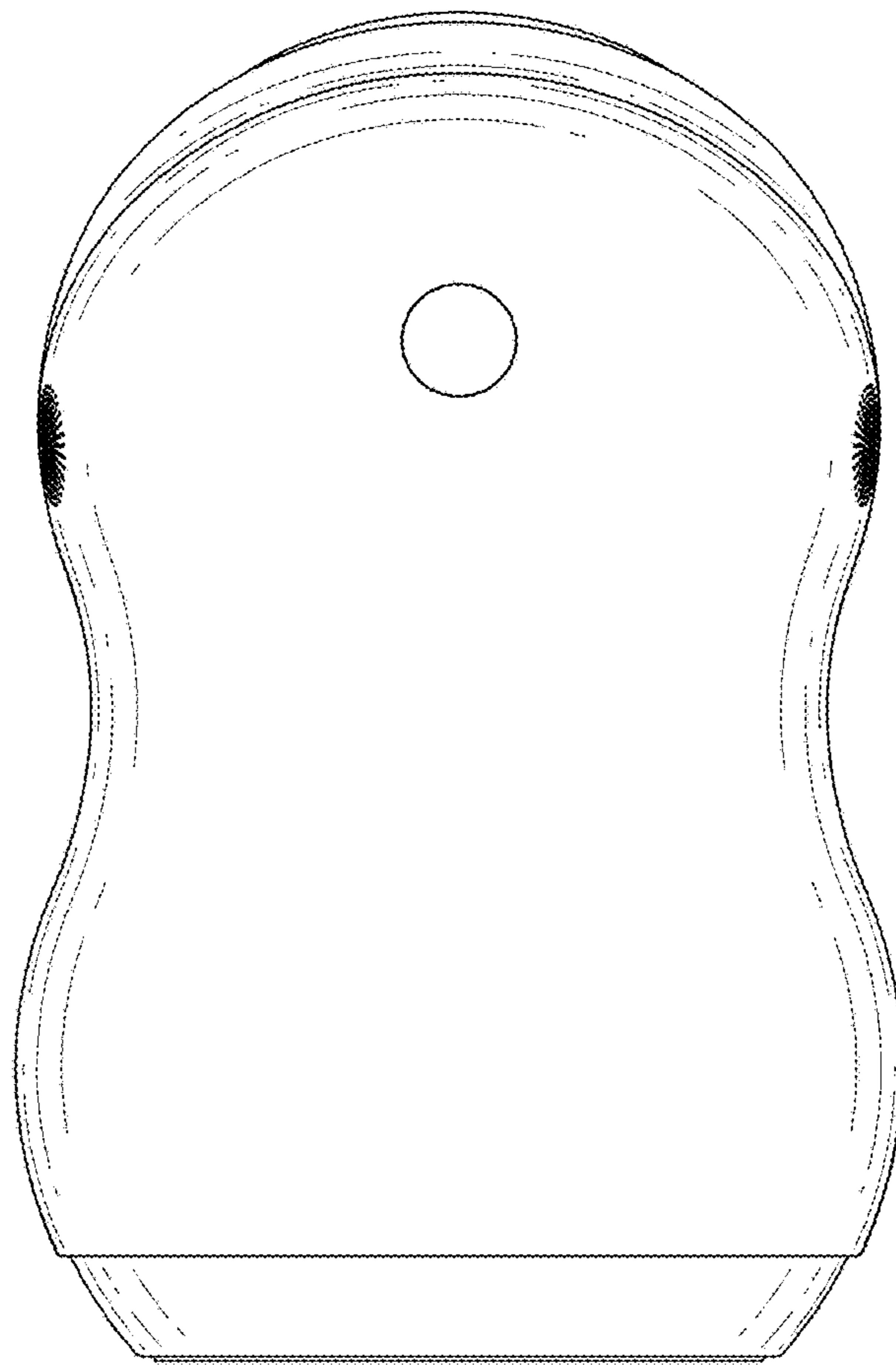

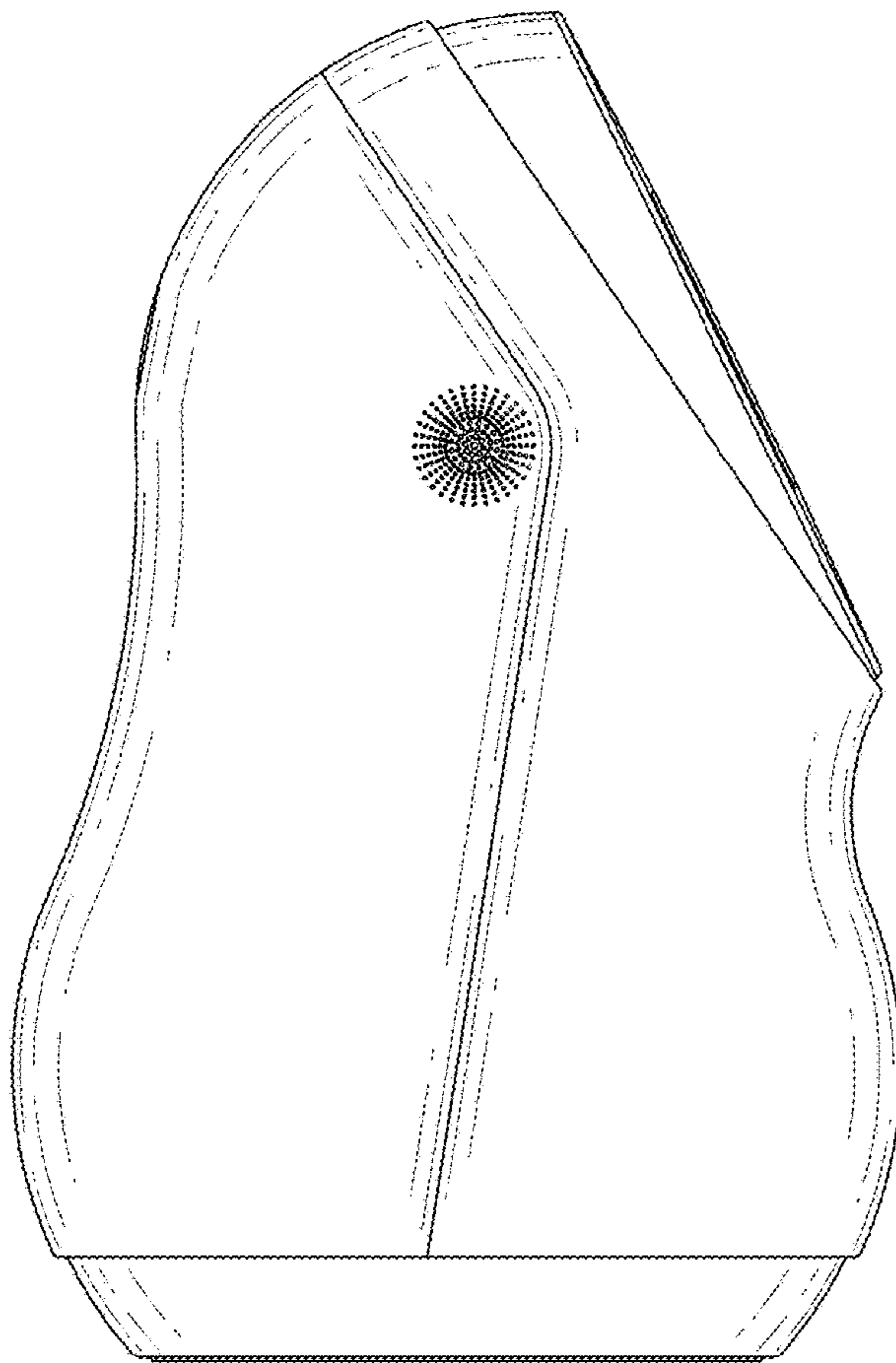

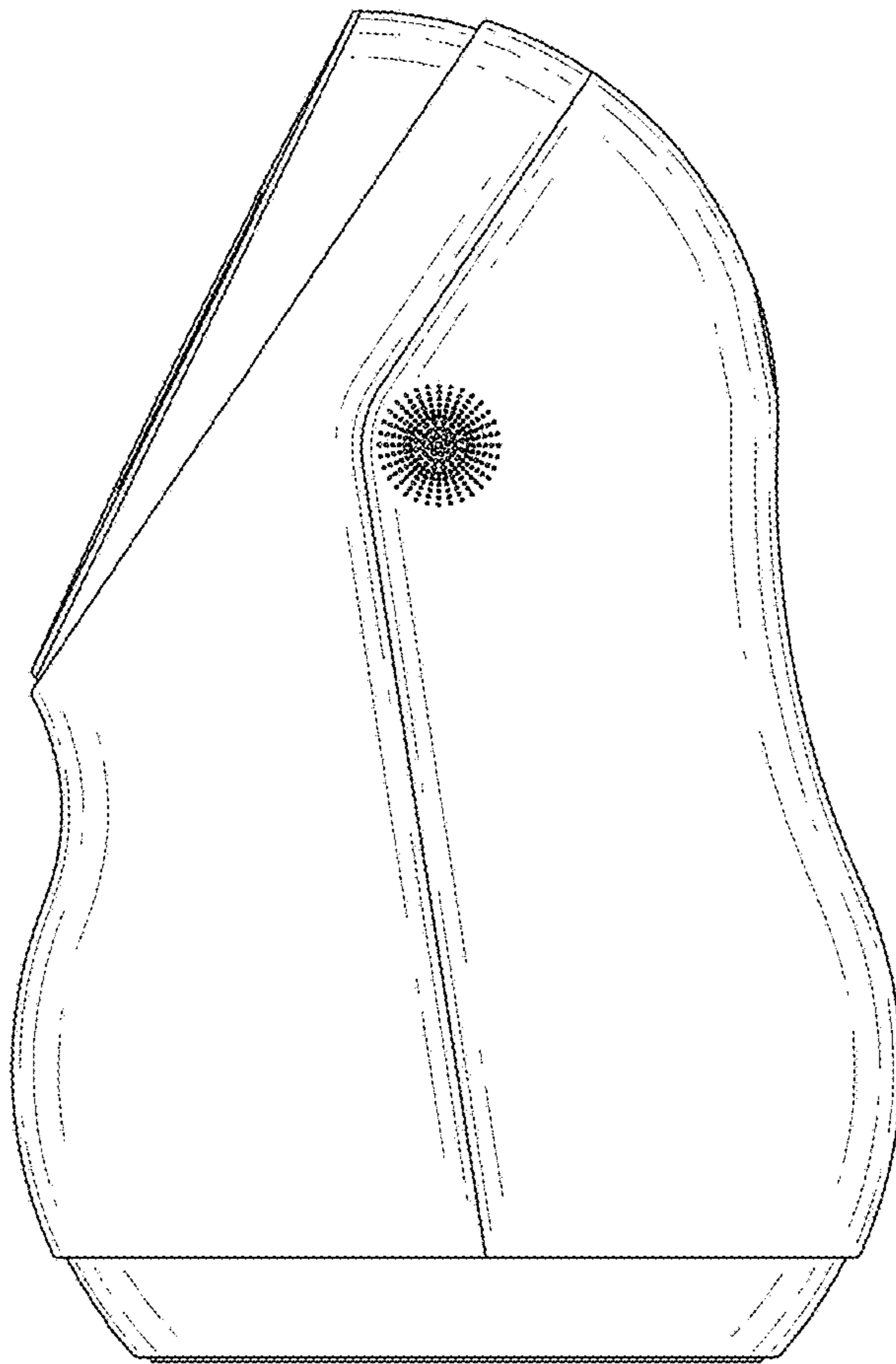

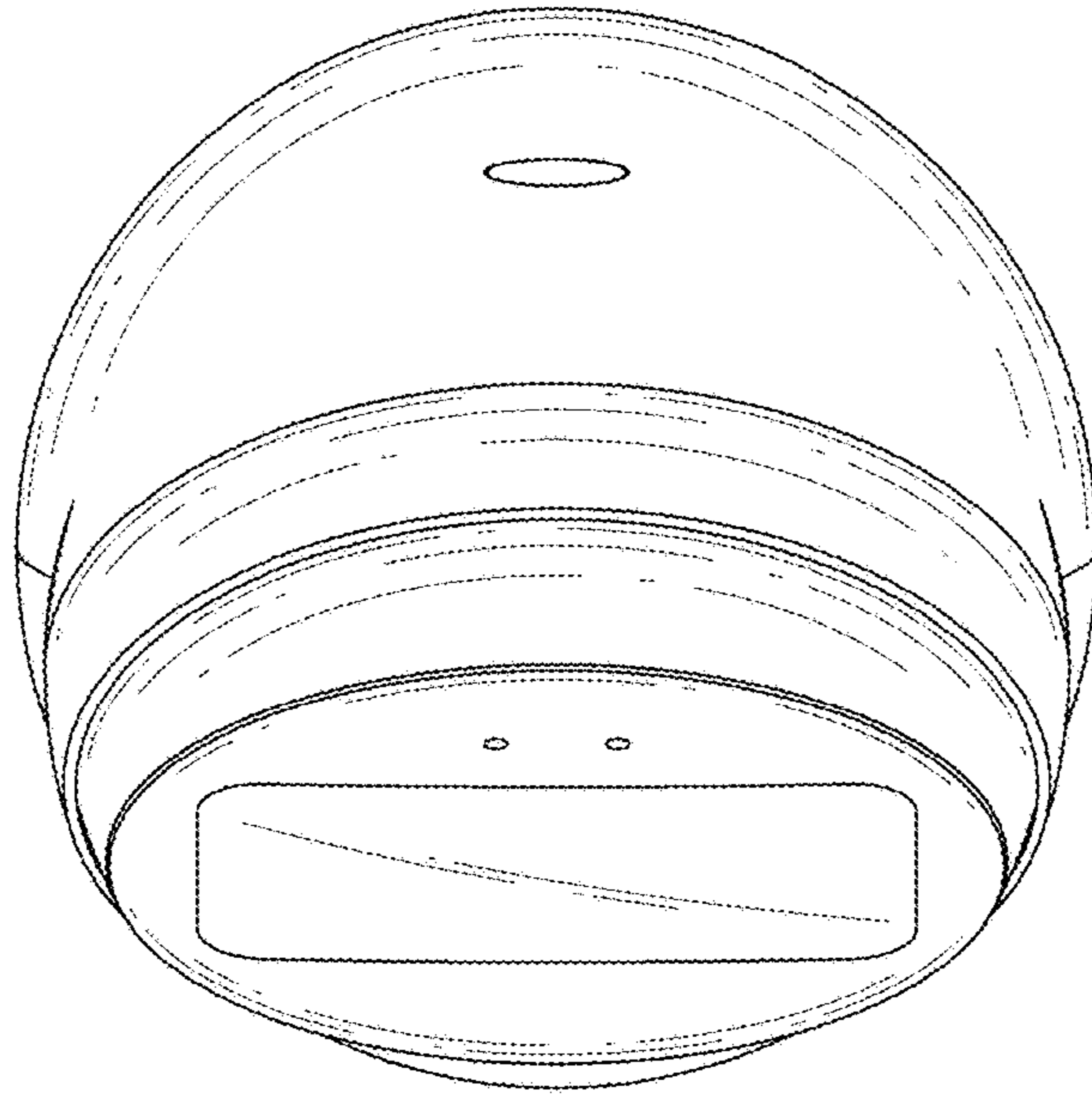
