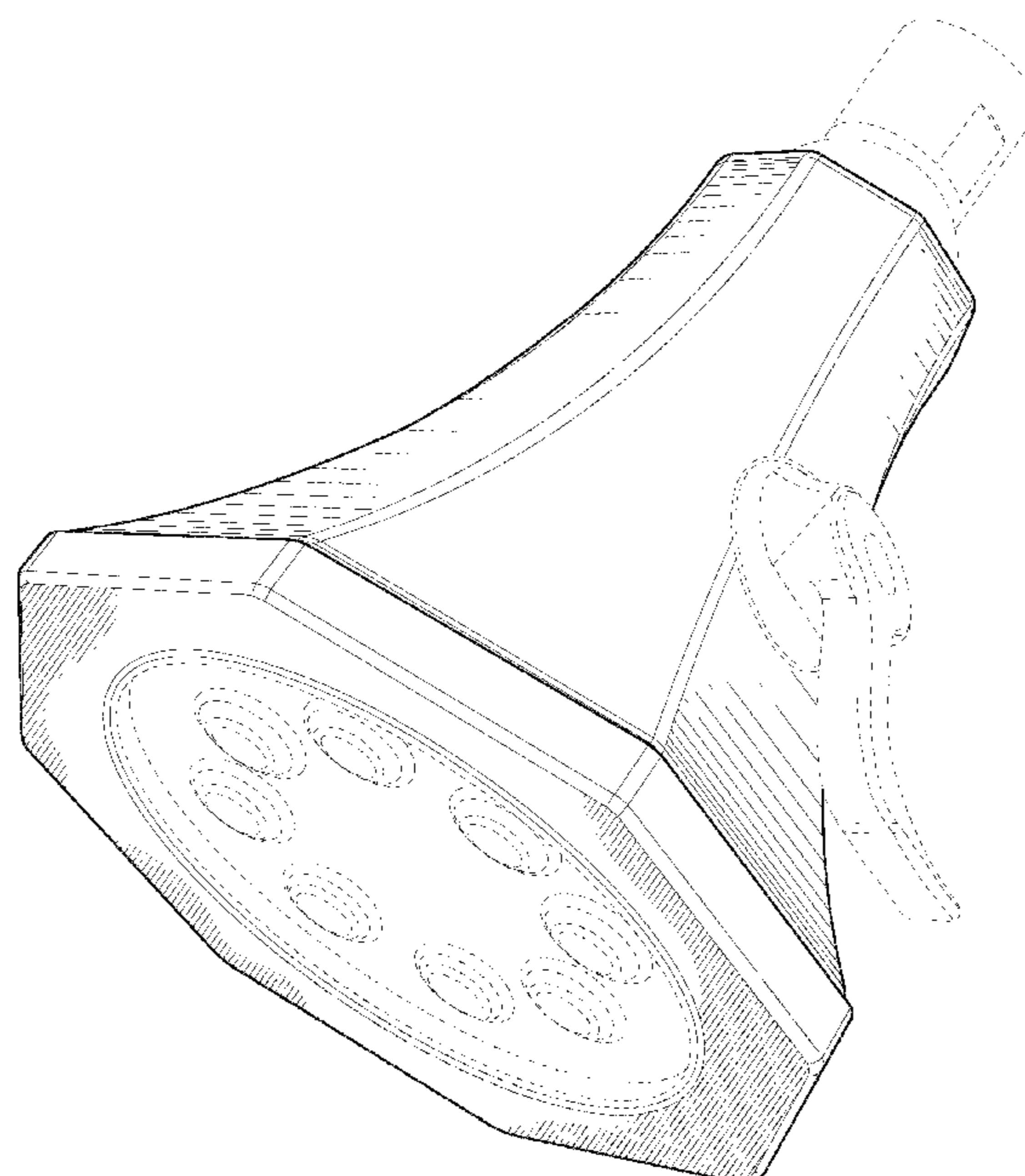
(57) **CLAIM**

The ornamental design for a showerhead, as shown and described.

DESCRIPTION

FIG. 1 is a left-front perspective view of a showerhead according to the present invention;
FIG. 2 is a top-front perspective view of the showerhead and valve of FIG. 1;
FIG. 3 is a right side elevational view of the showerhead and valve of FIG. 1;
FIG. 4 is a left side elevational view of the showerhead and valve of FIG. 1;
FIG. 5 is a front elevational view of the showerhead and valve of FIG. 1;
FIG. 6 is a top plan view of the showerhead and valve of FIG. 1; and,
FIG. 7 is a bottom view of the showerhead and valve of FIG. 1.

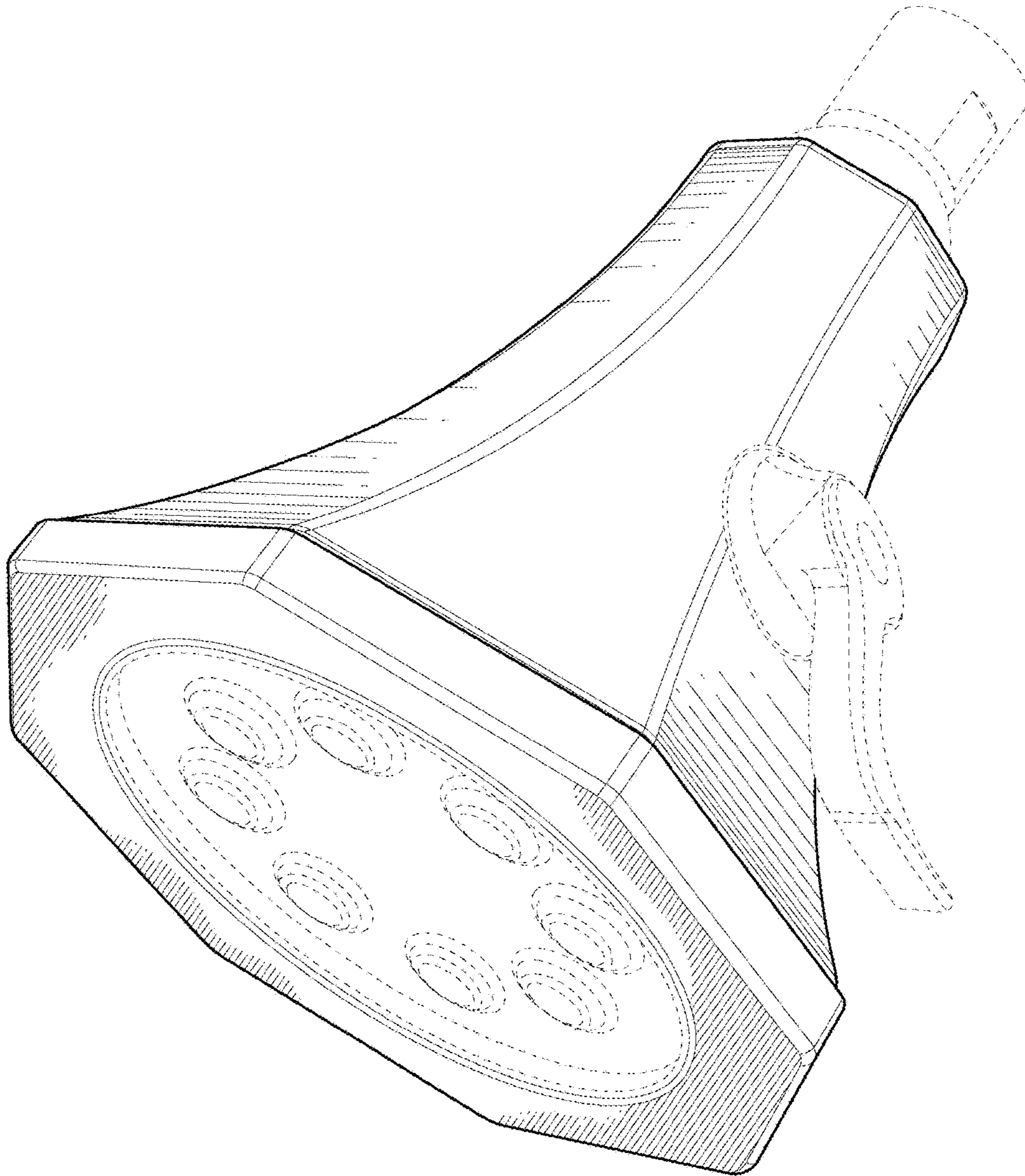

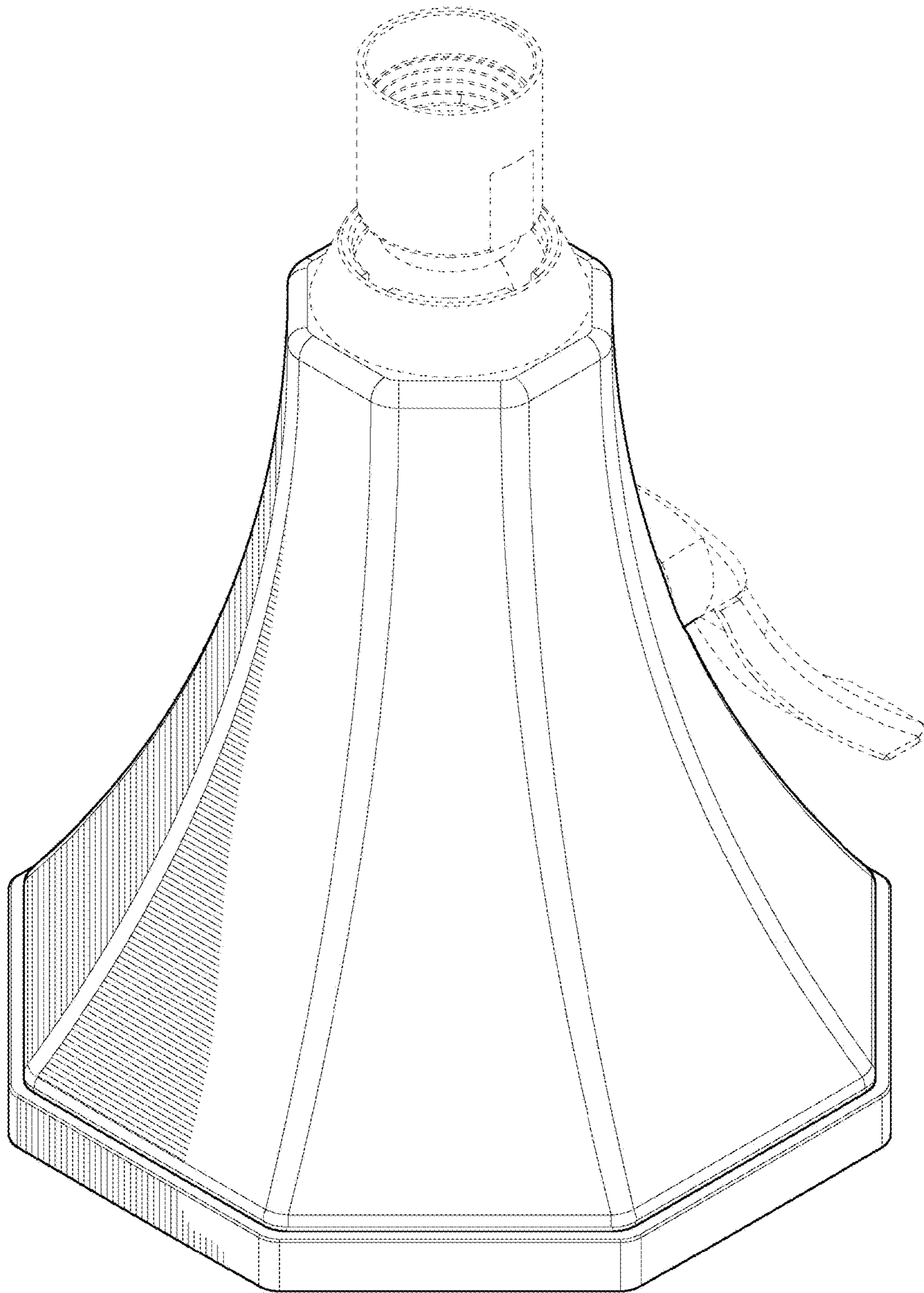

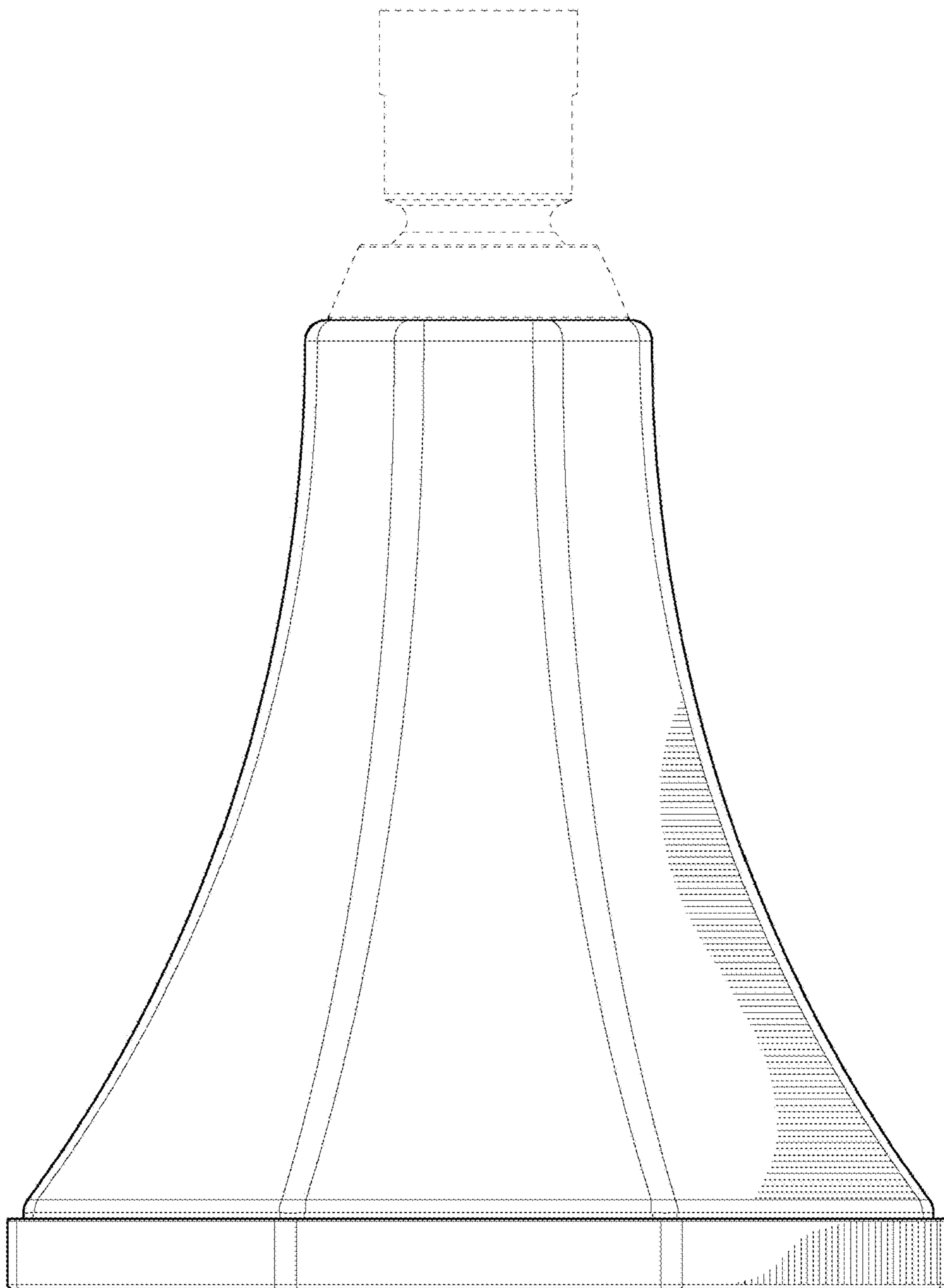

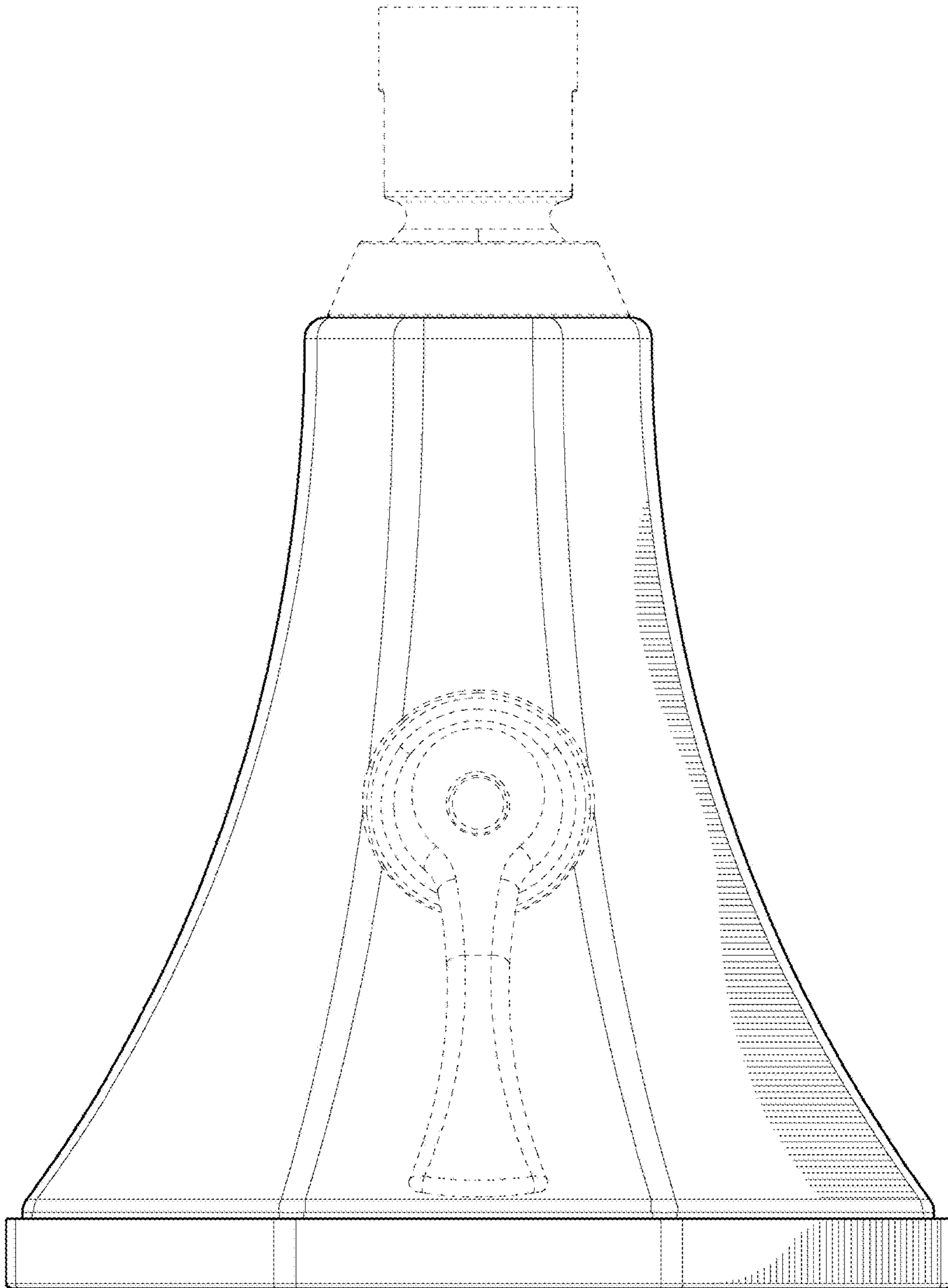

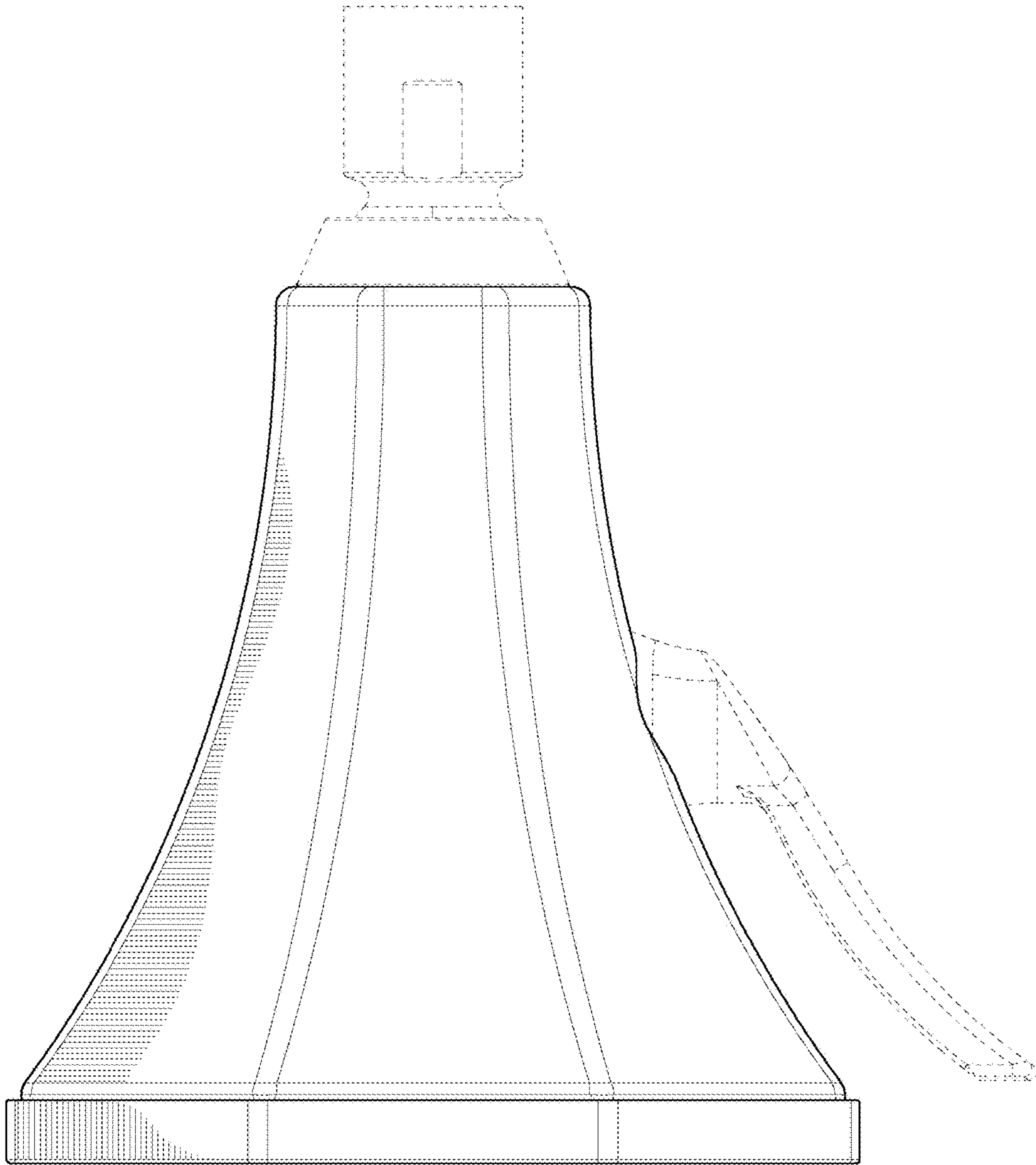

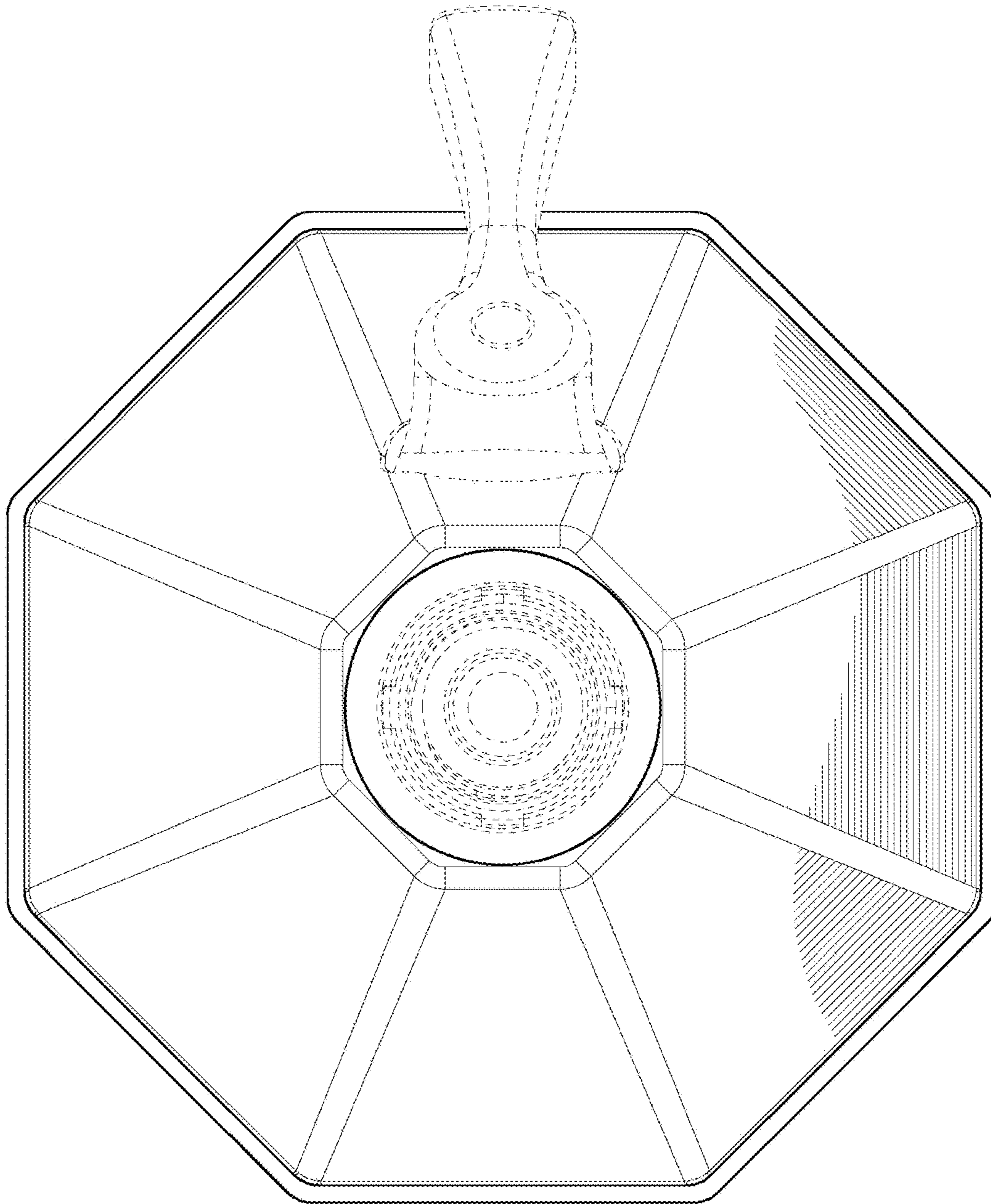

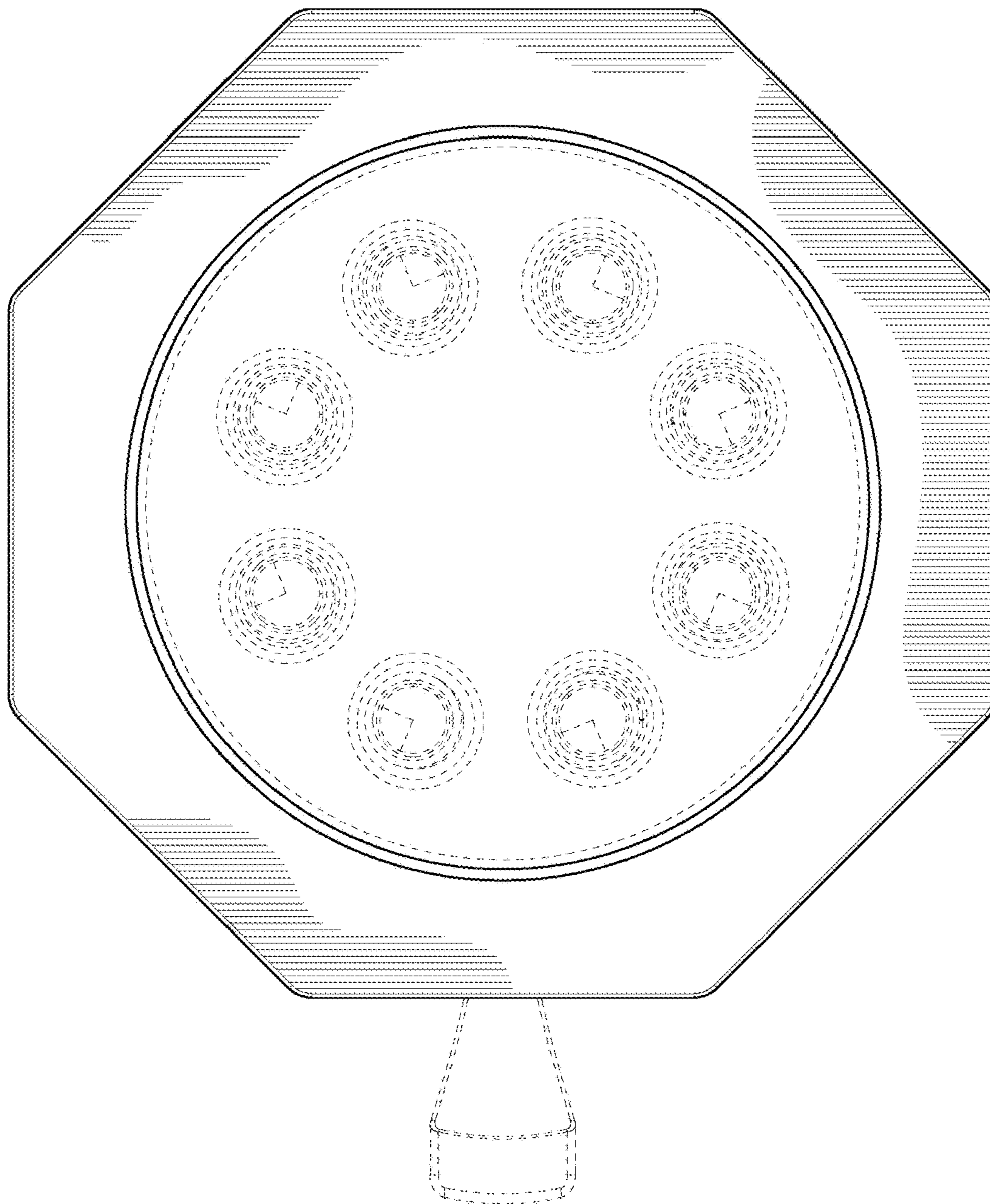
