(57) **CLAIM**

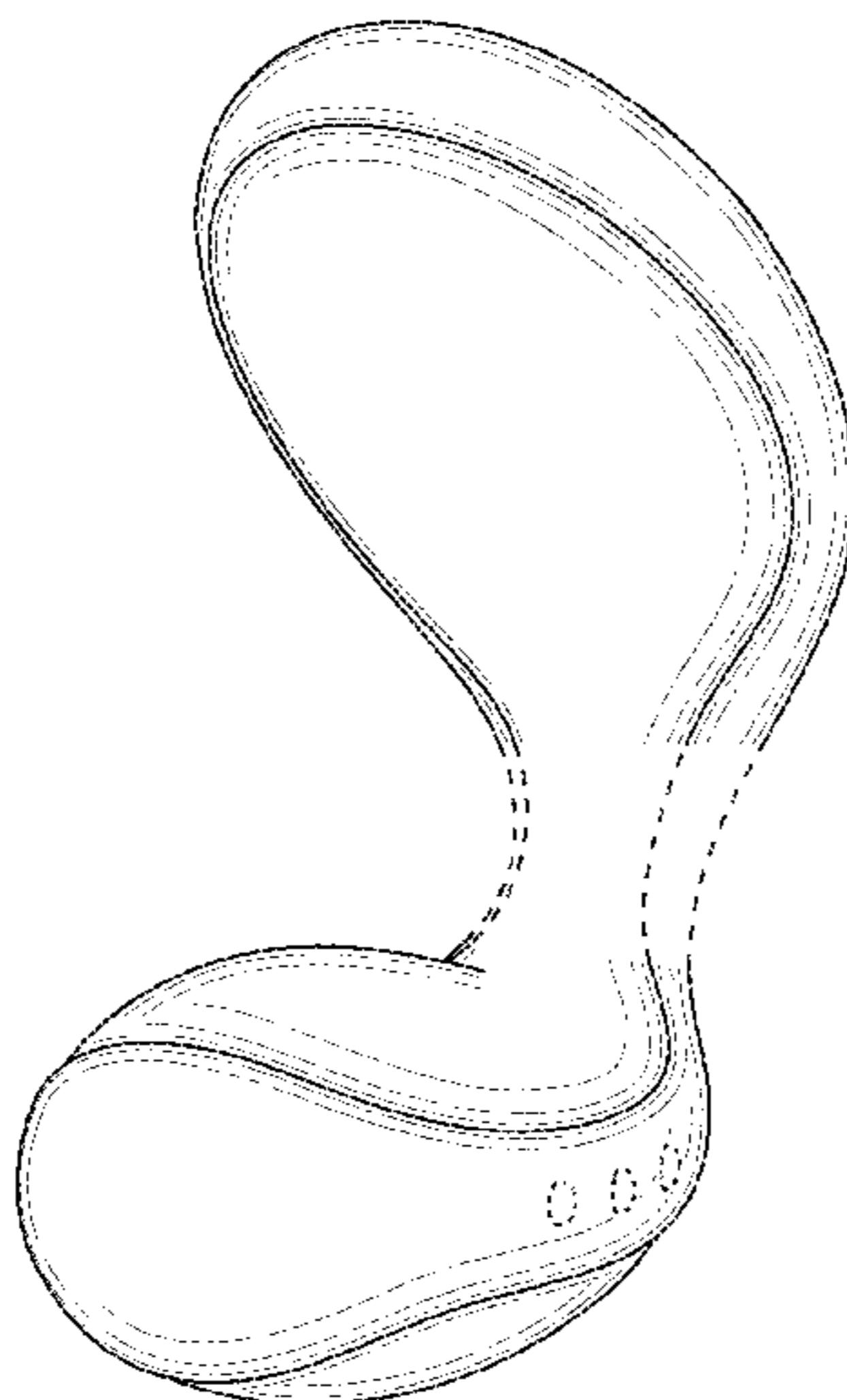
I claim the ornamental design for a vaginal rejuvenation device, as shown and described.

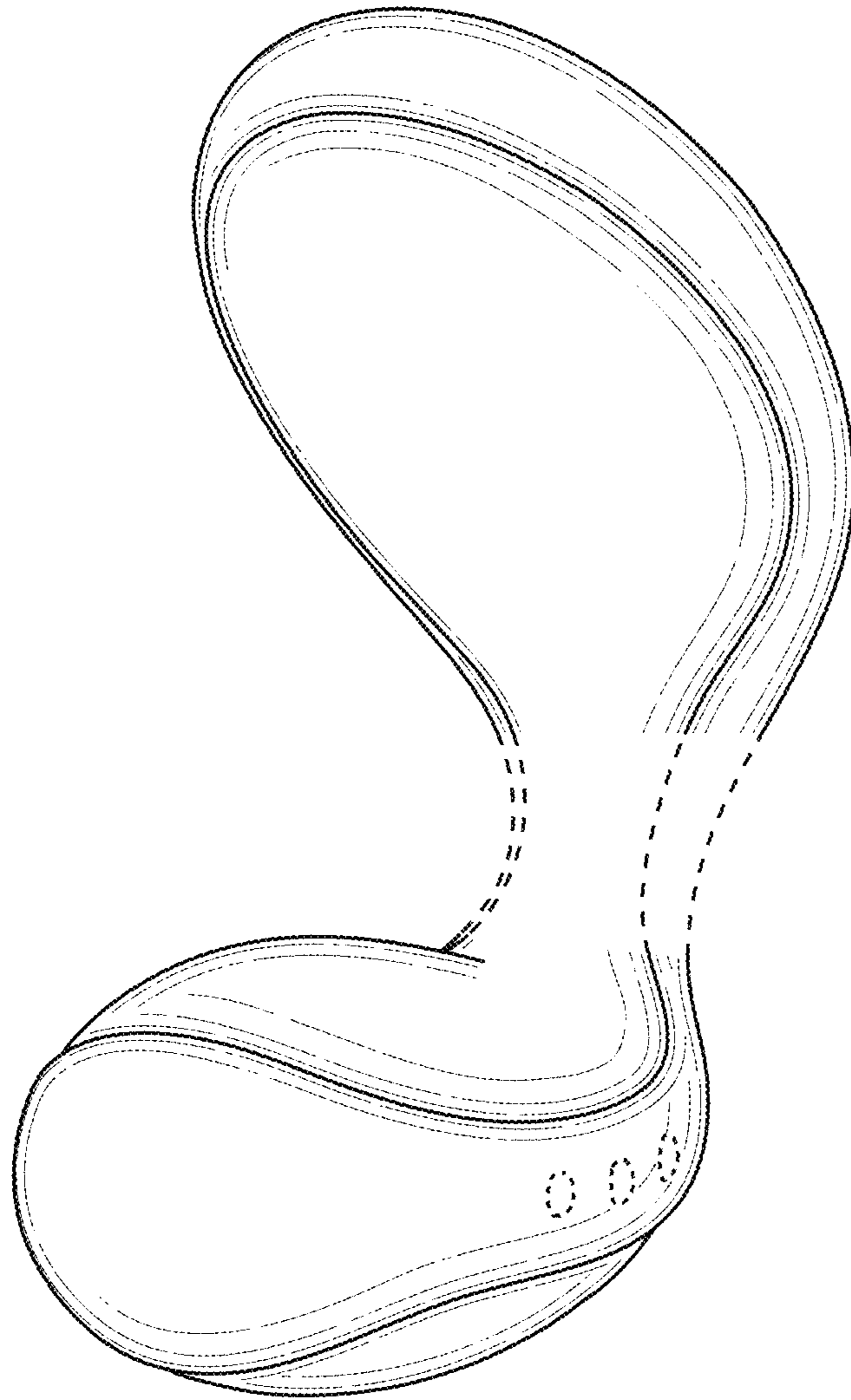

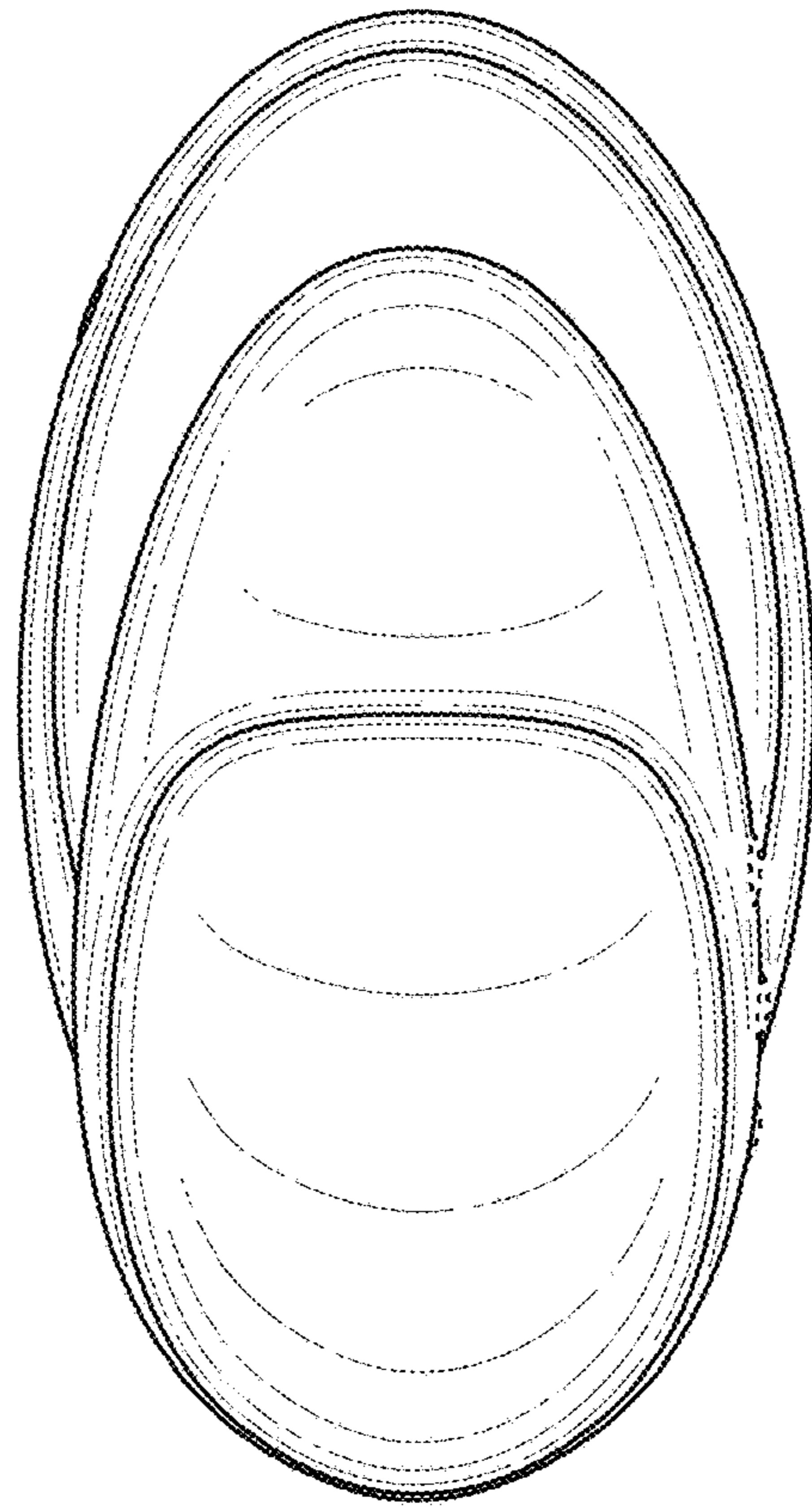

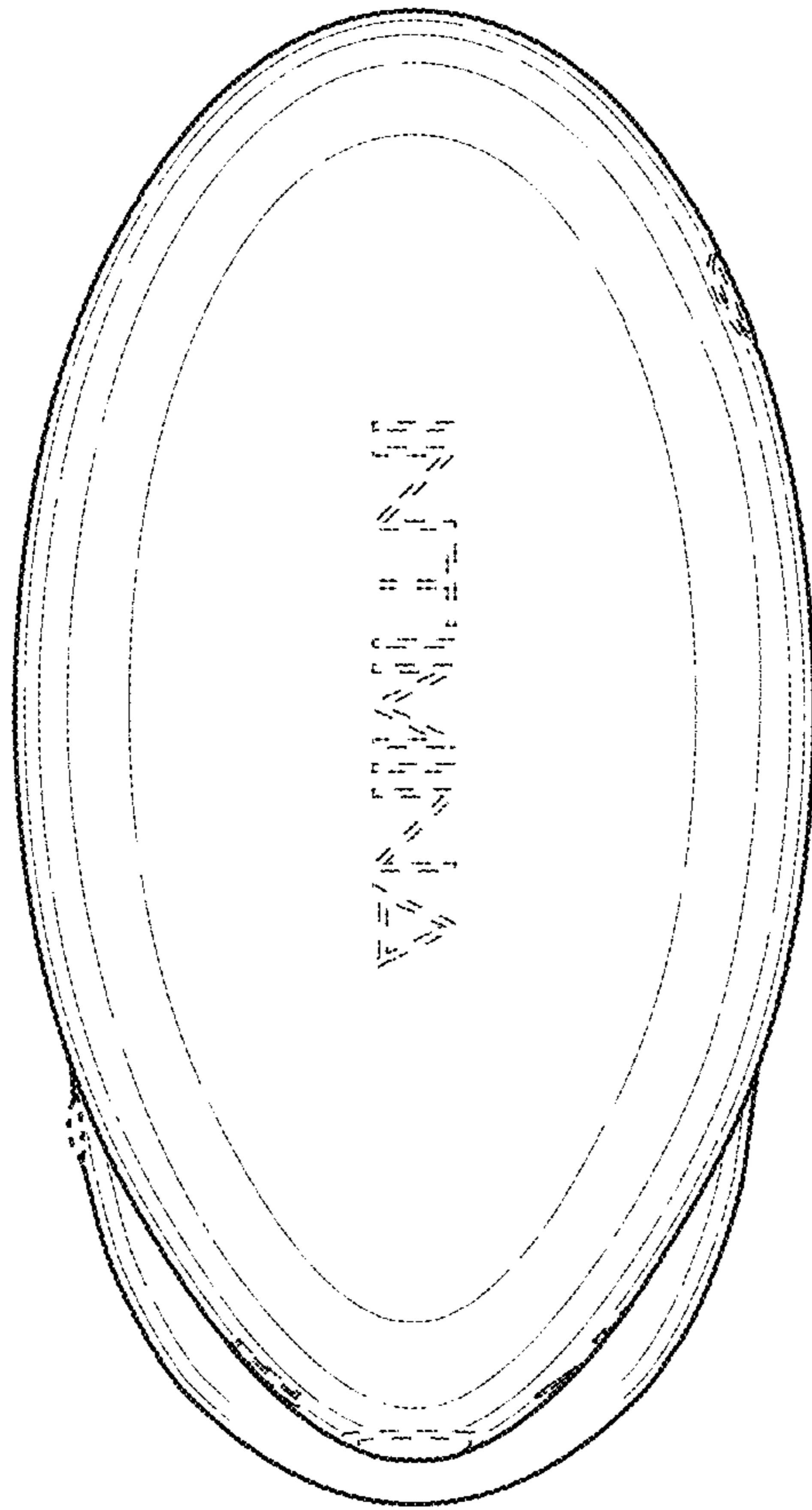

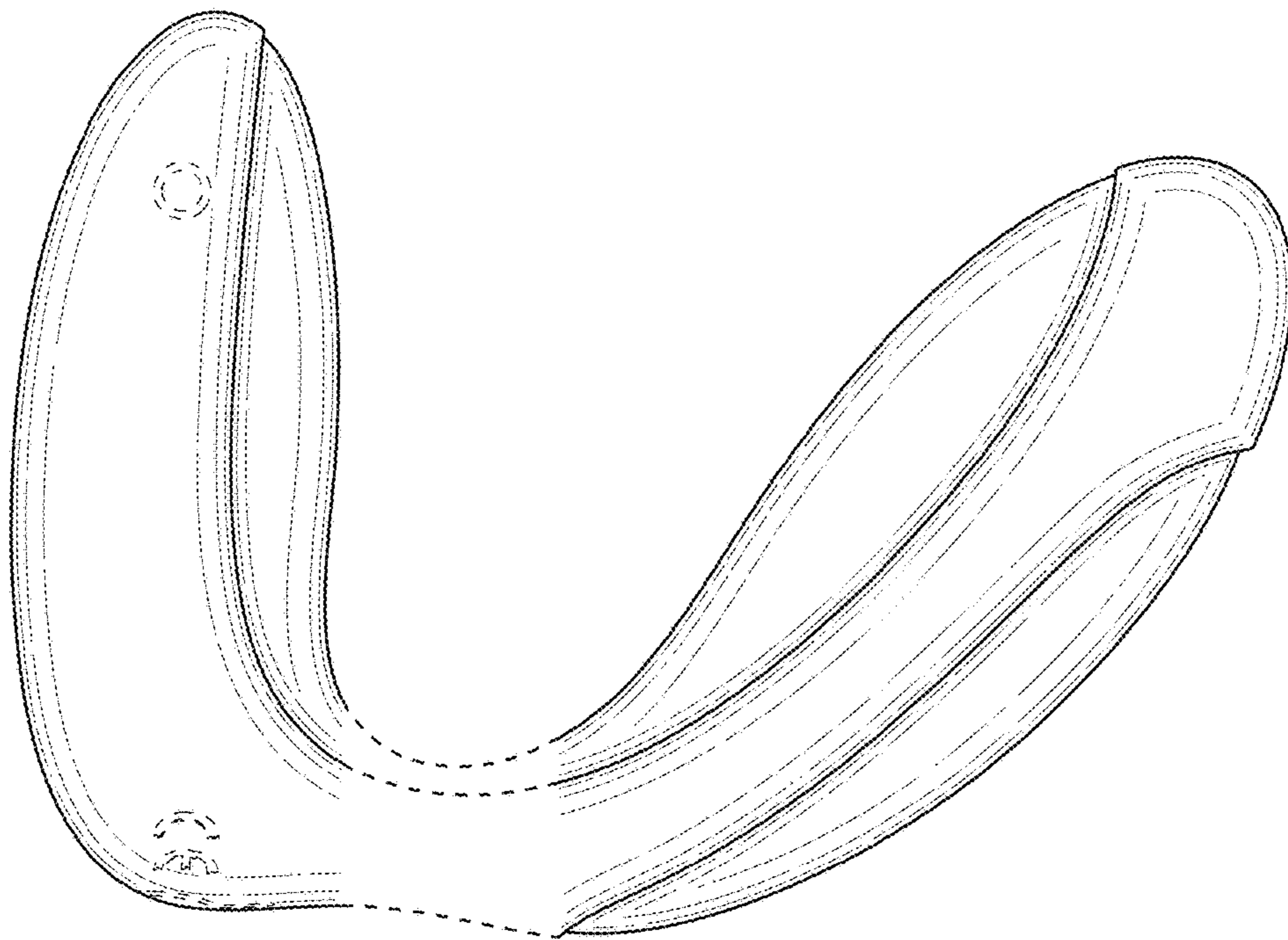

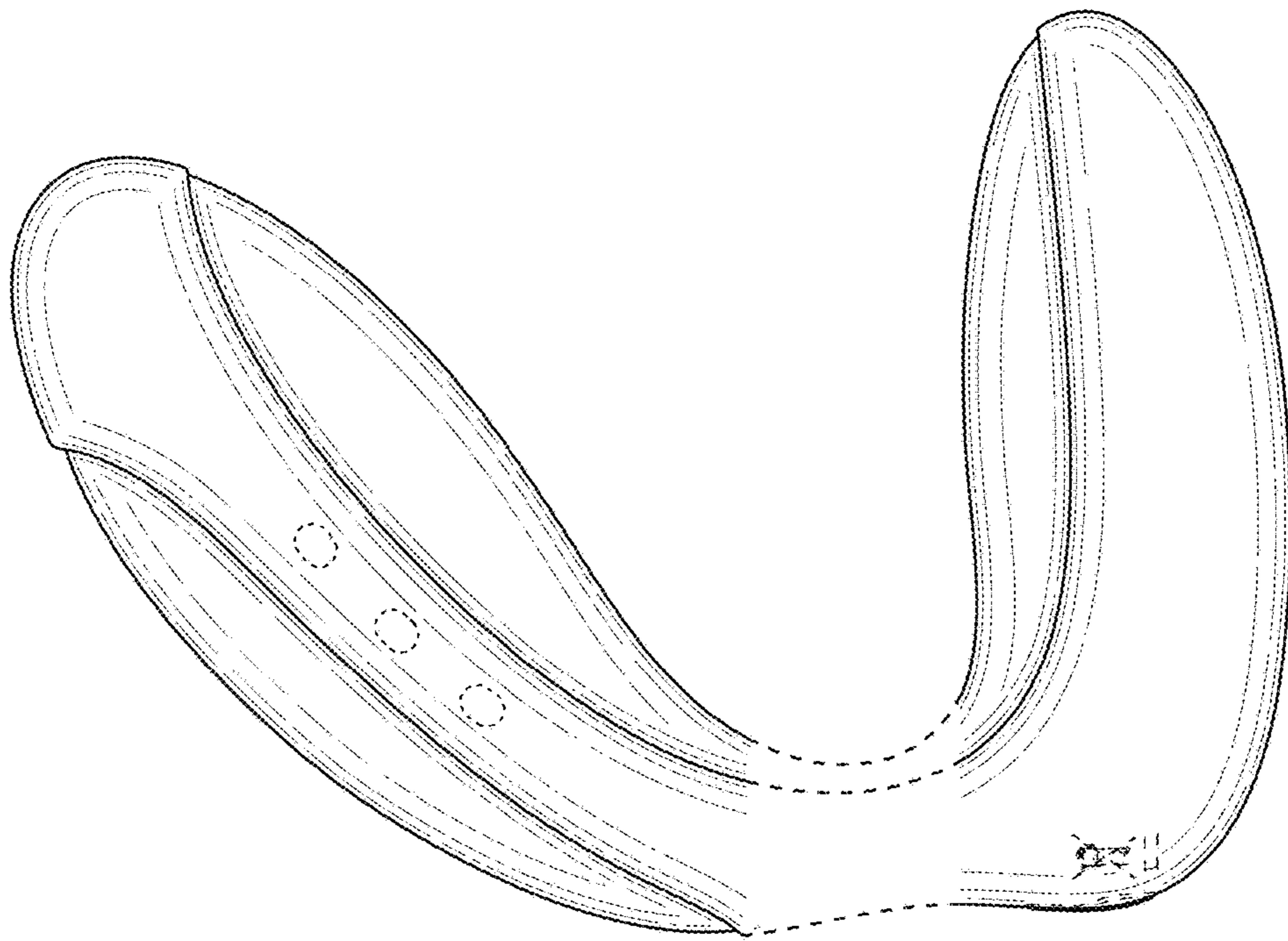
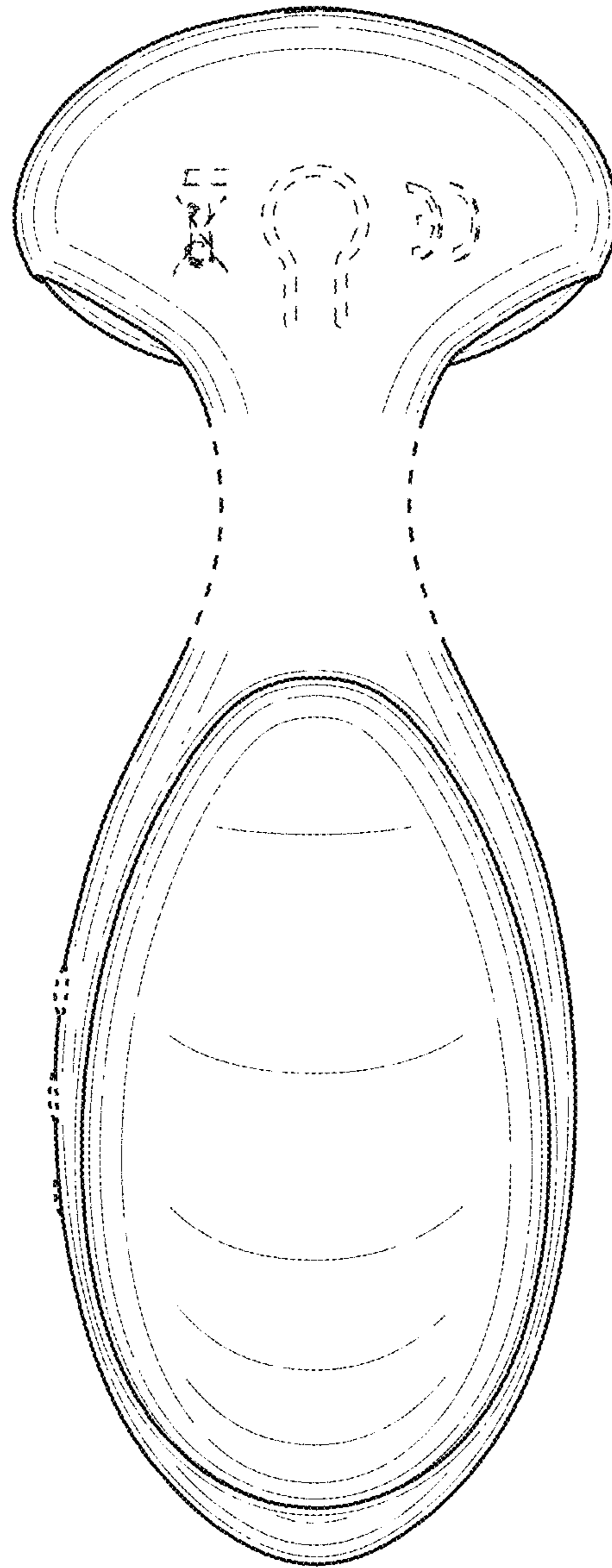
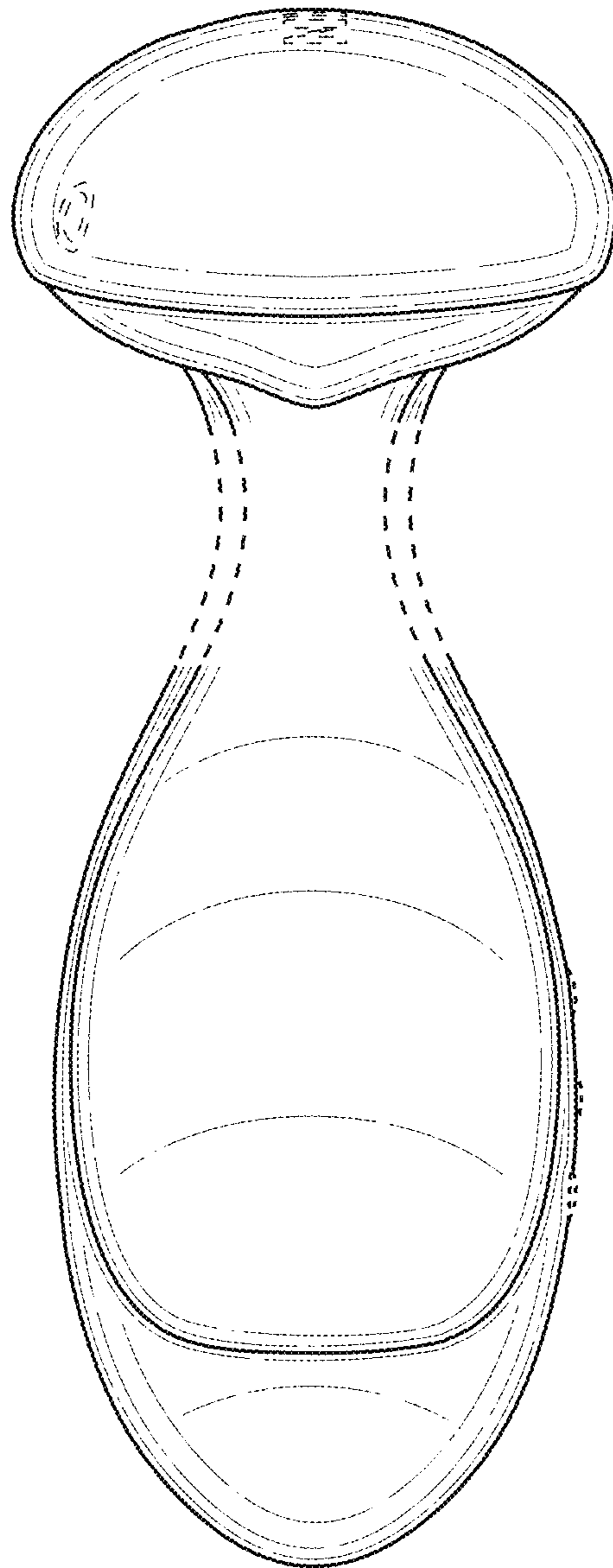
