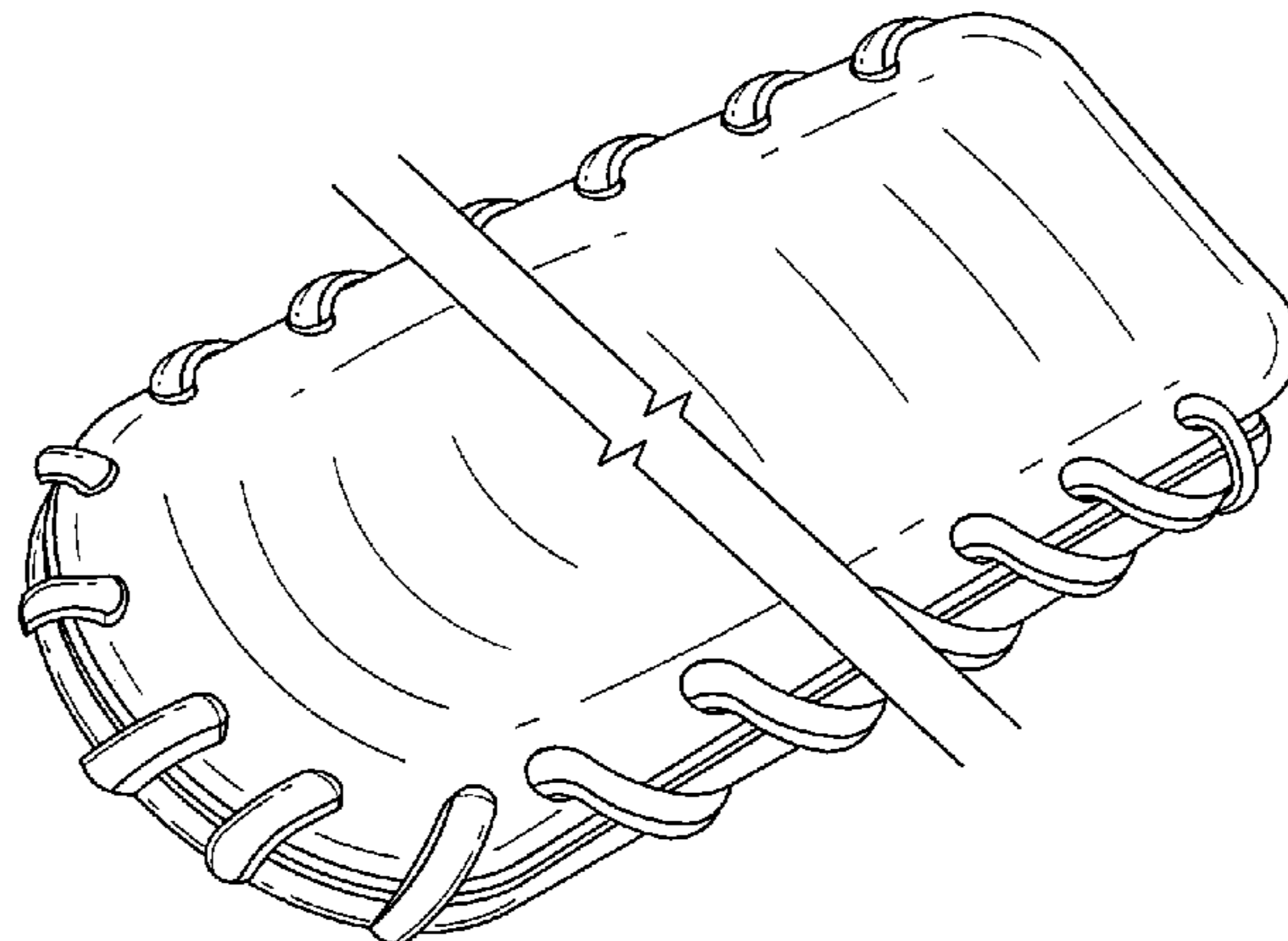
(57) **CLAIM**

The ornamental design for a laced handle holder, as is shown and described herein.

**DESCRIPTION**

FIG. 1 is a perspective view thereof;  
FIG. 2 is a top elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a bottom elevational view thereof;  
FIG. 5 is a front elevational view thereof; and,  
FIG. 6 is a rear plan view thereof.  
The laced handle holder is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

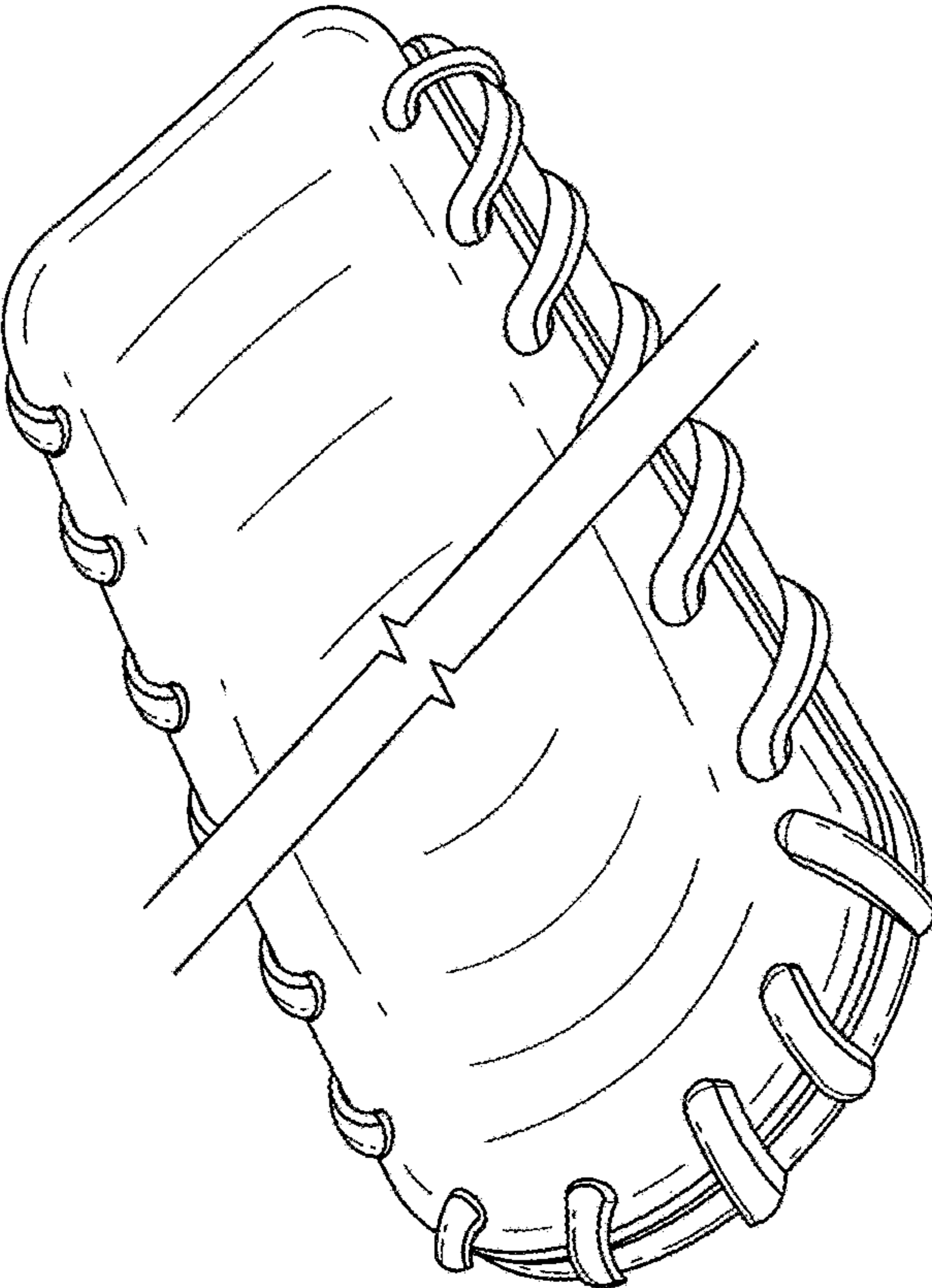

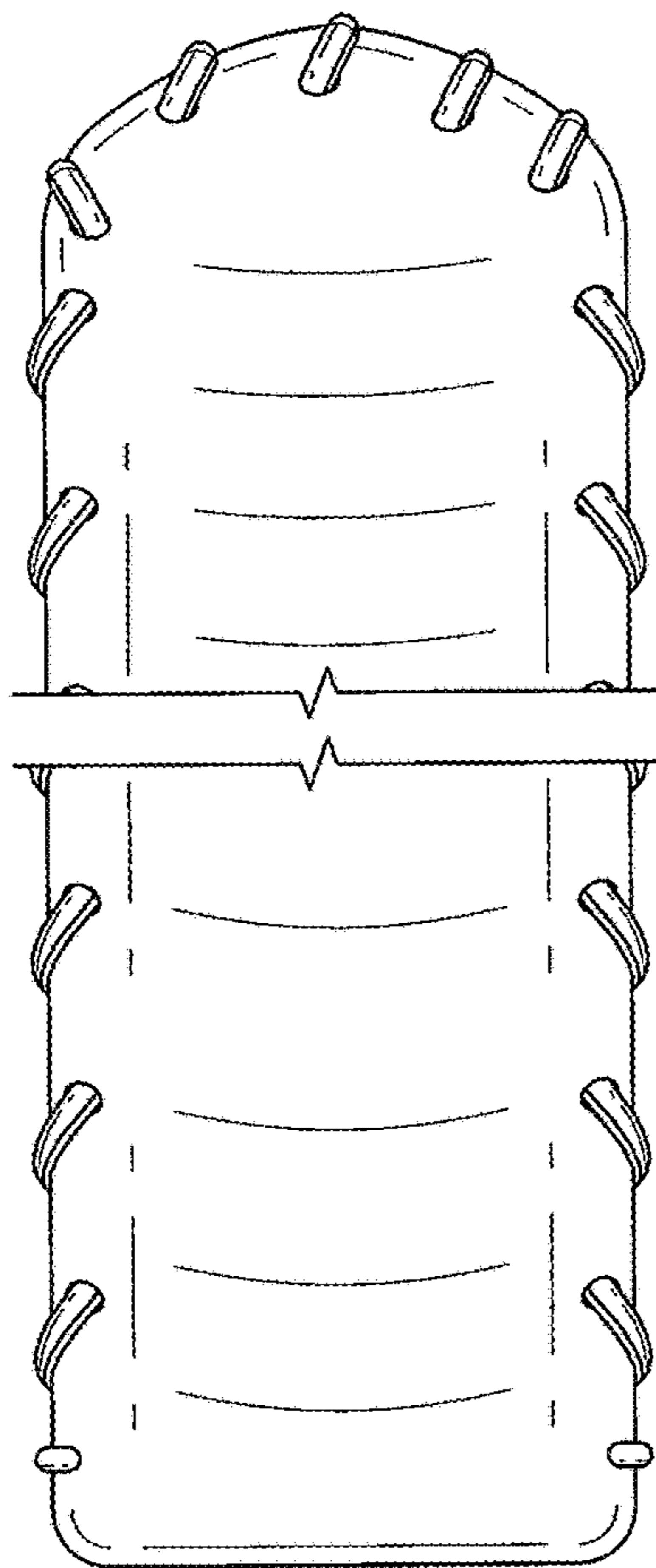

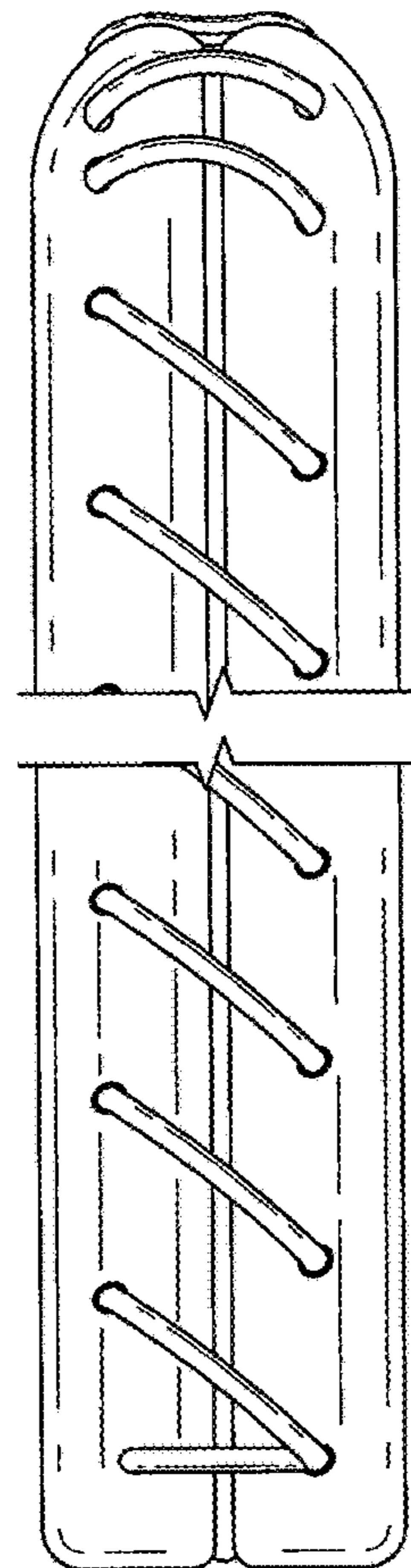

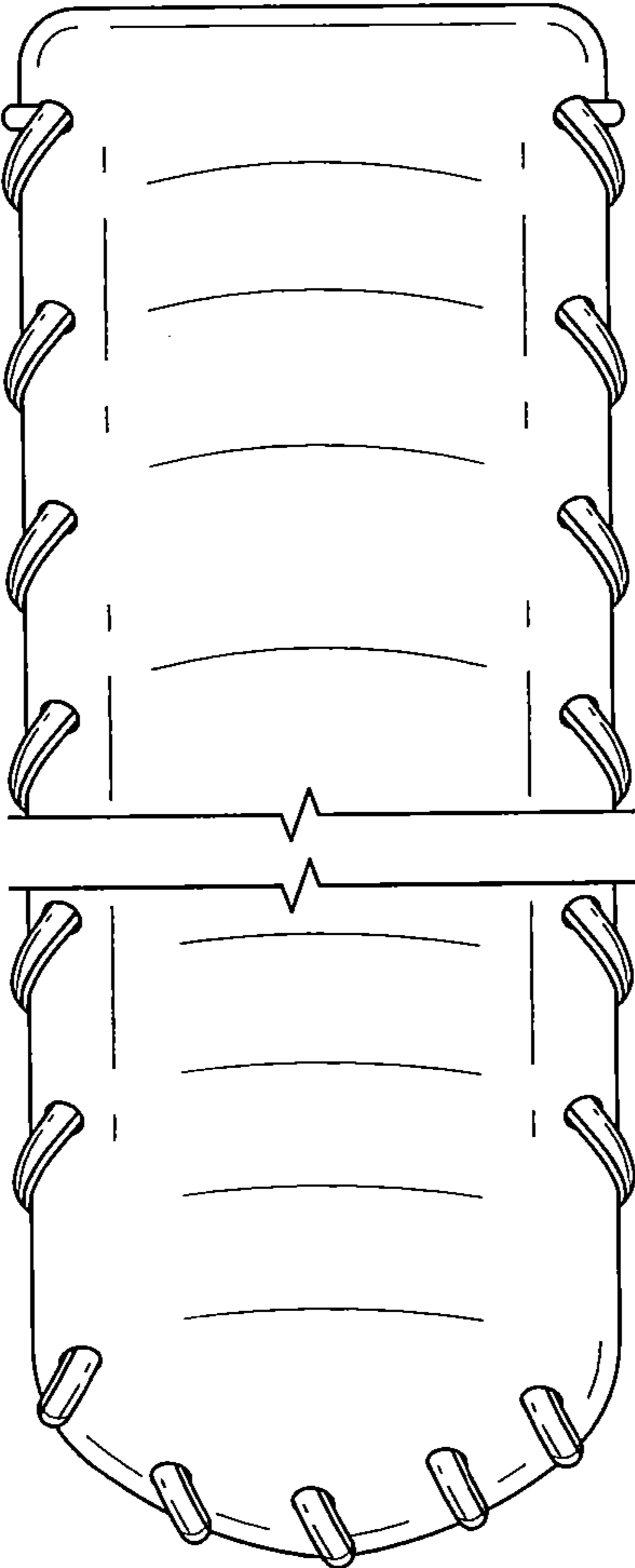

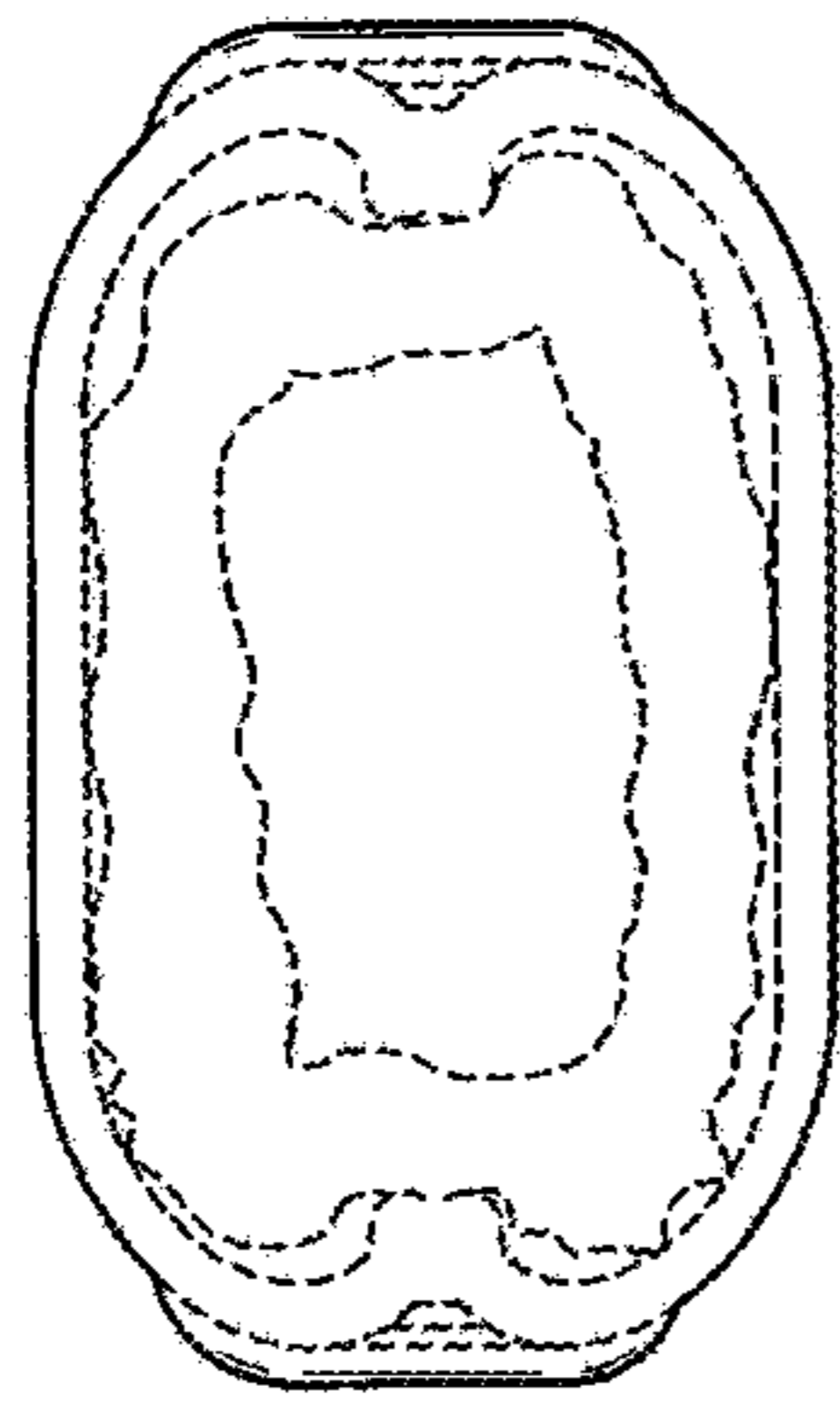

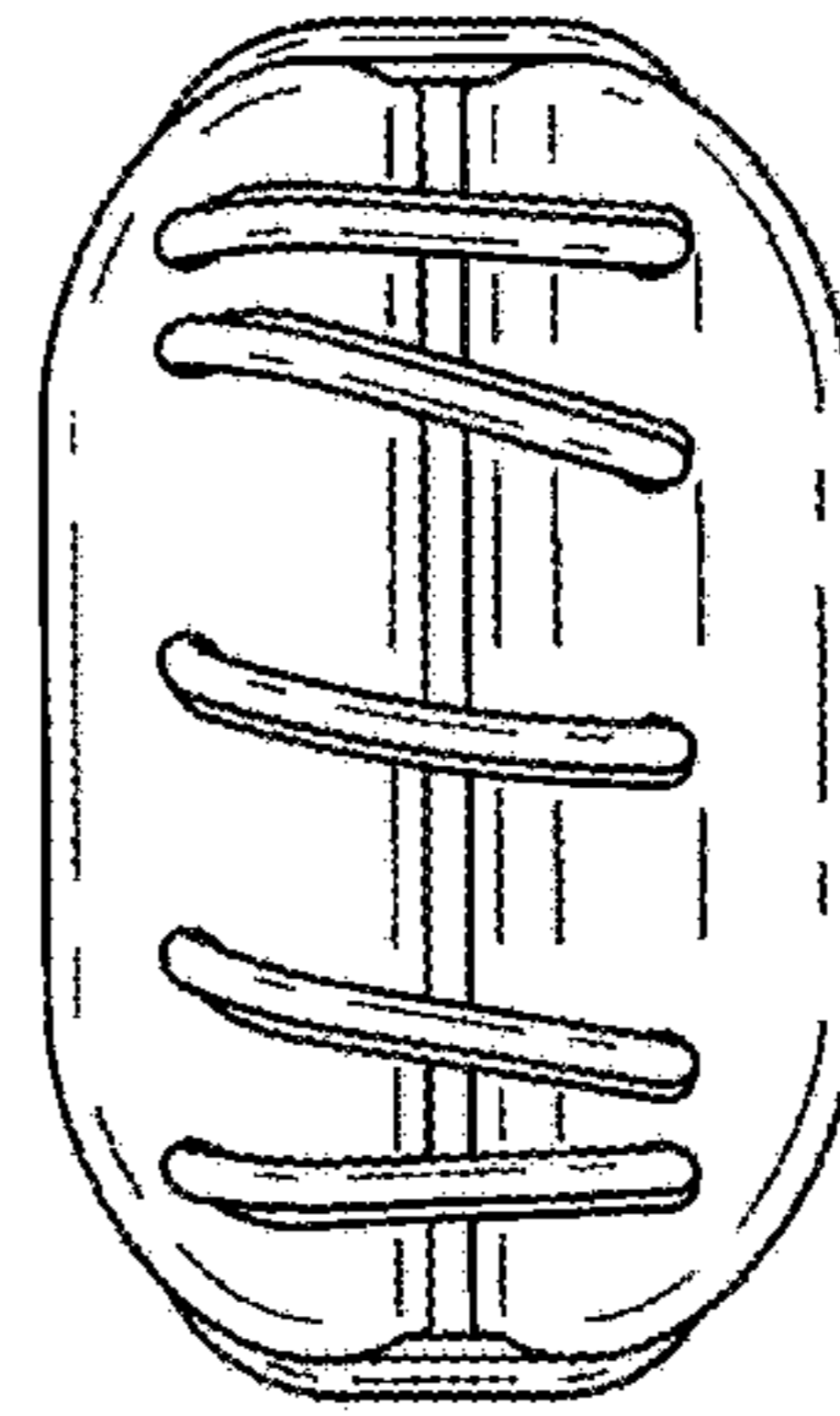
