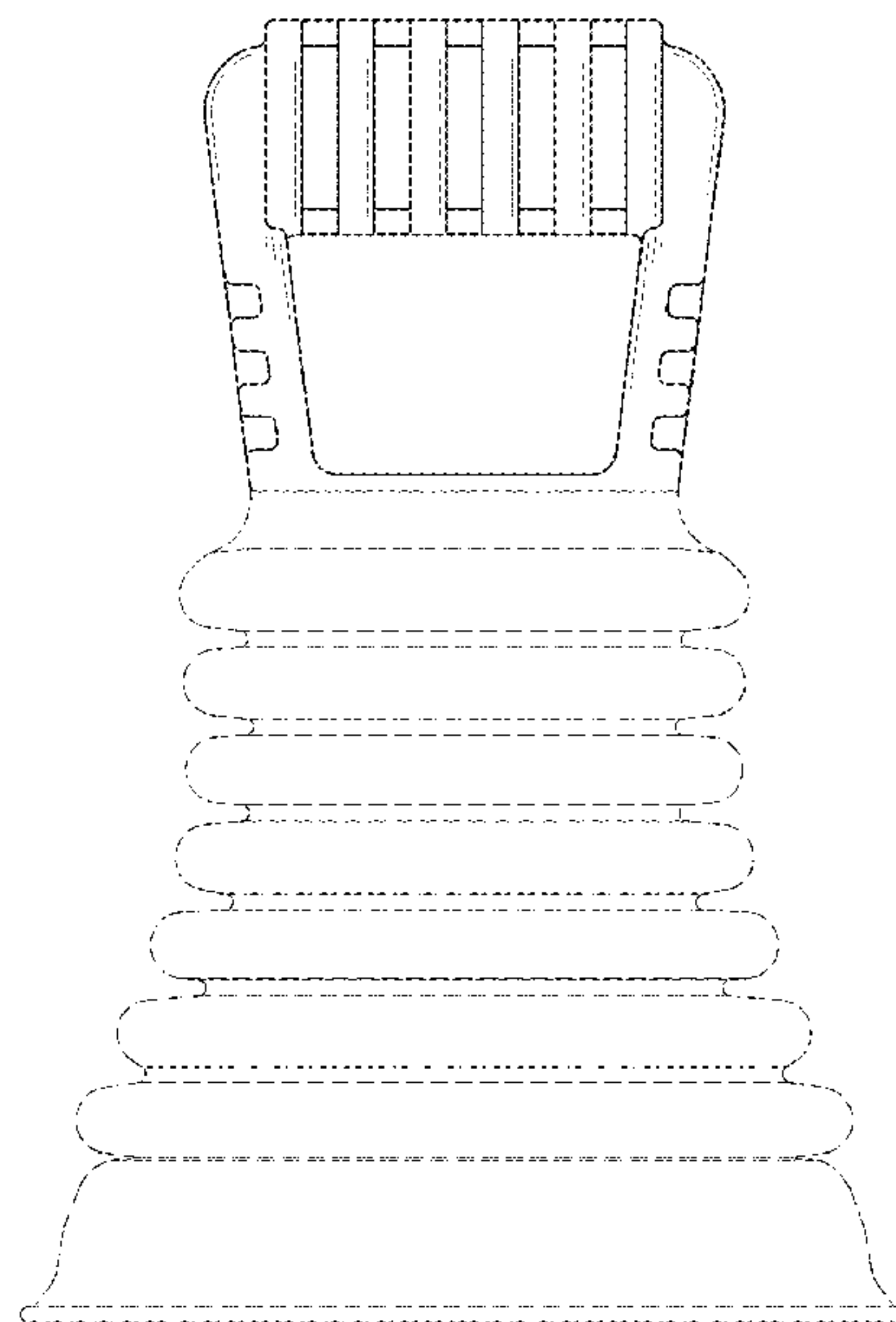
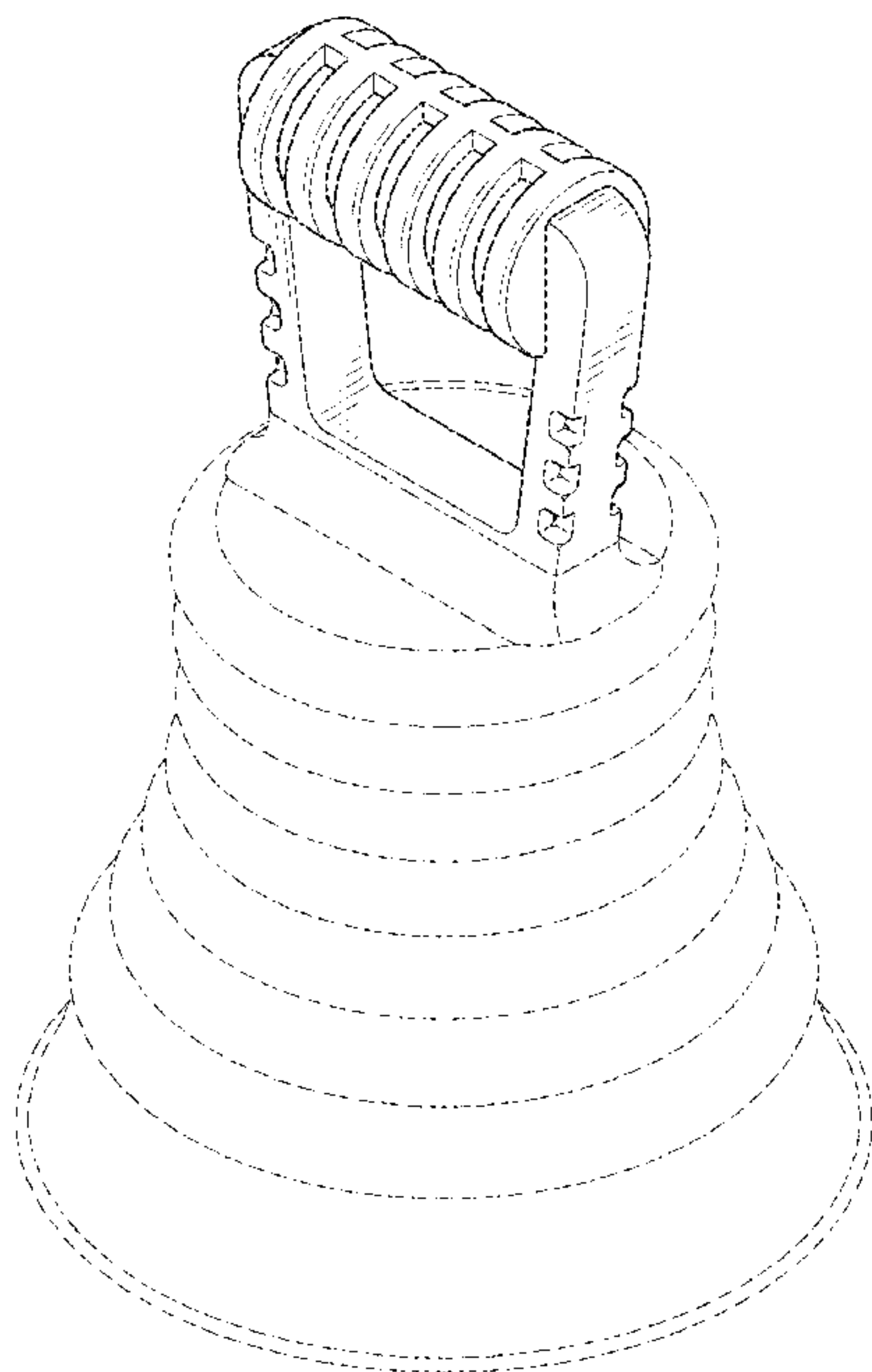
The ornamental design for a handle bar for a conduit dredge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle bar for a conduit dredge, showing my new design;

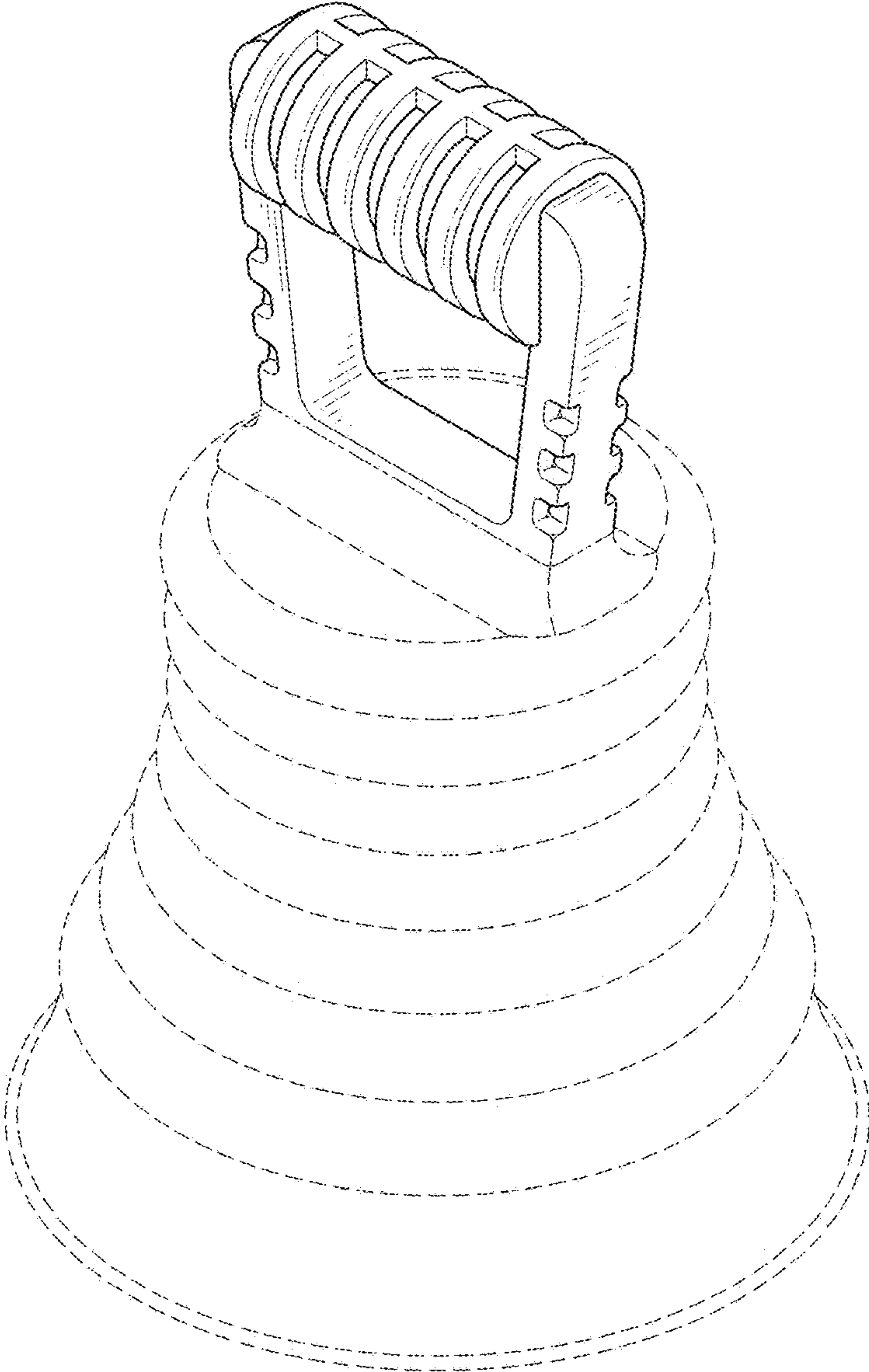

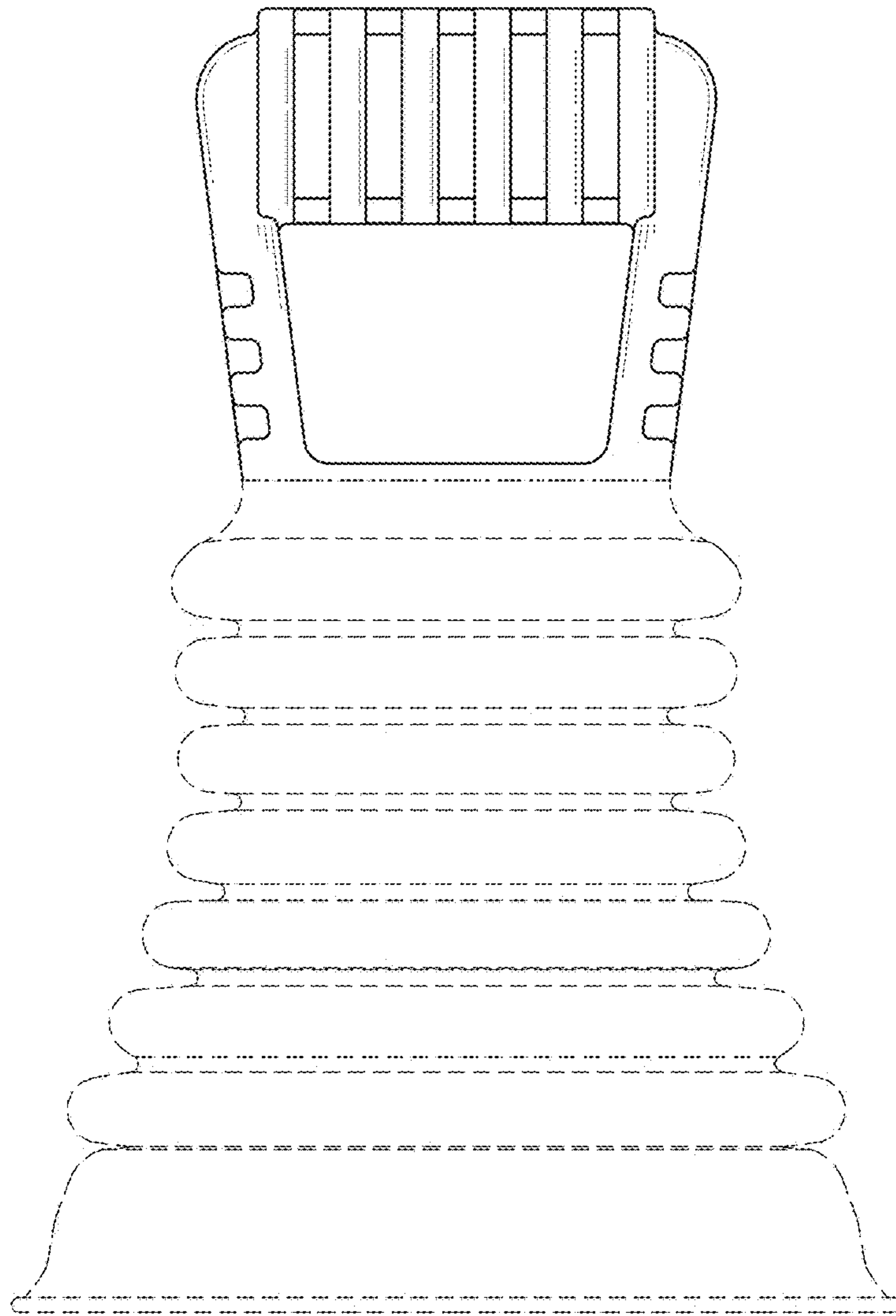

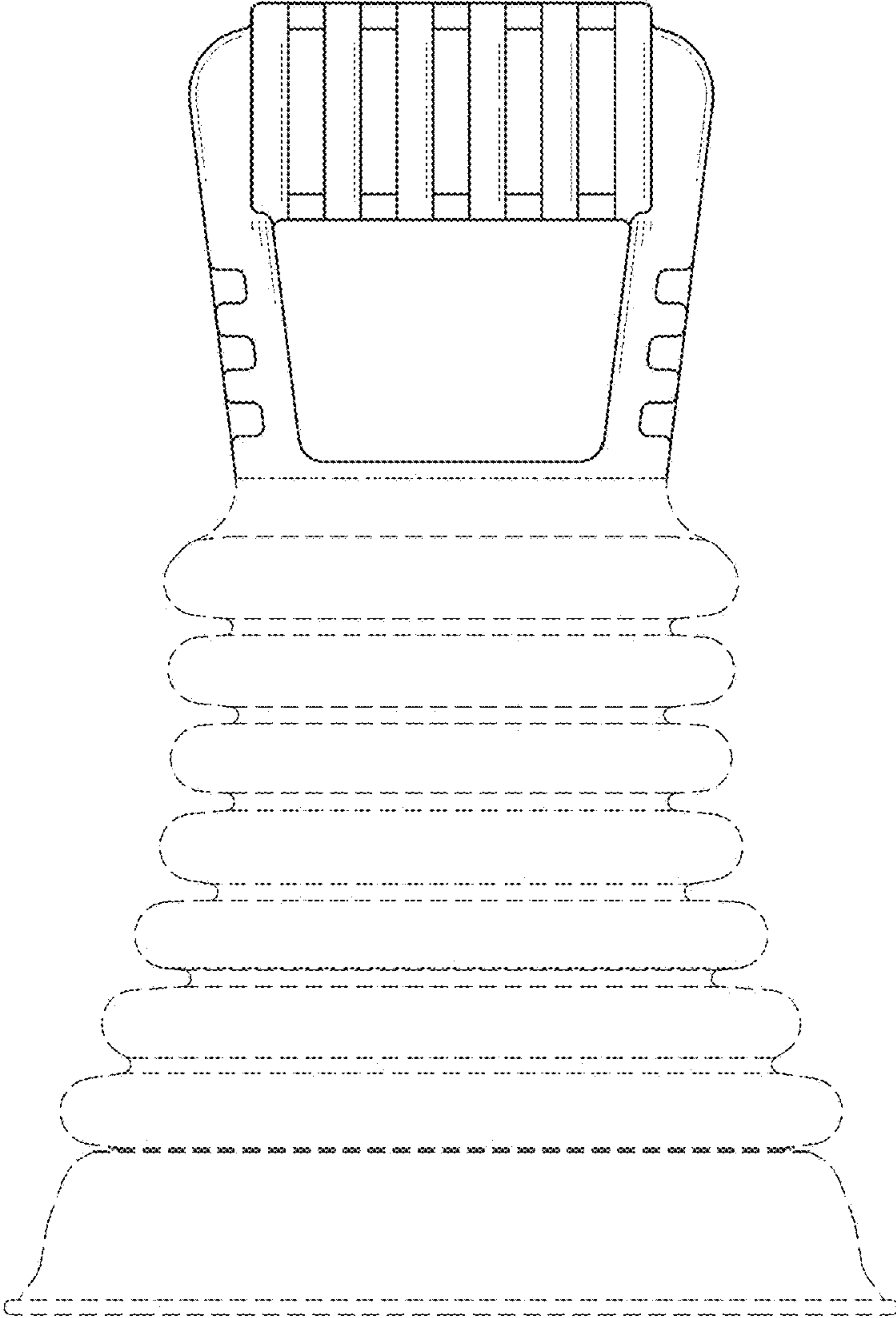

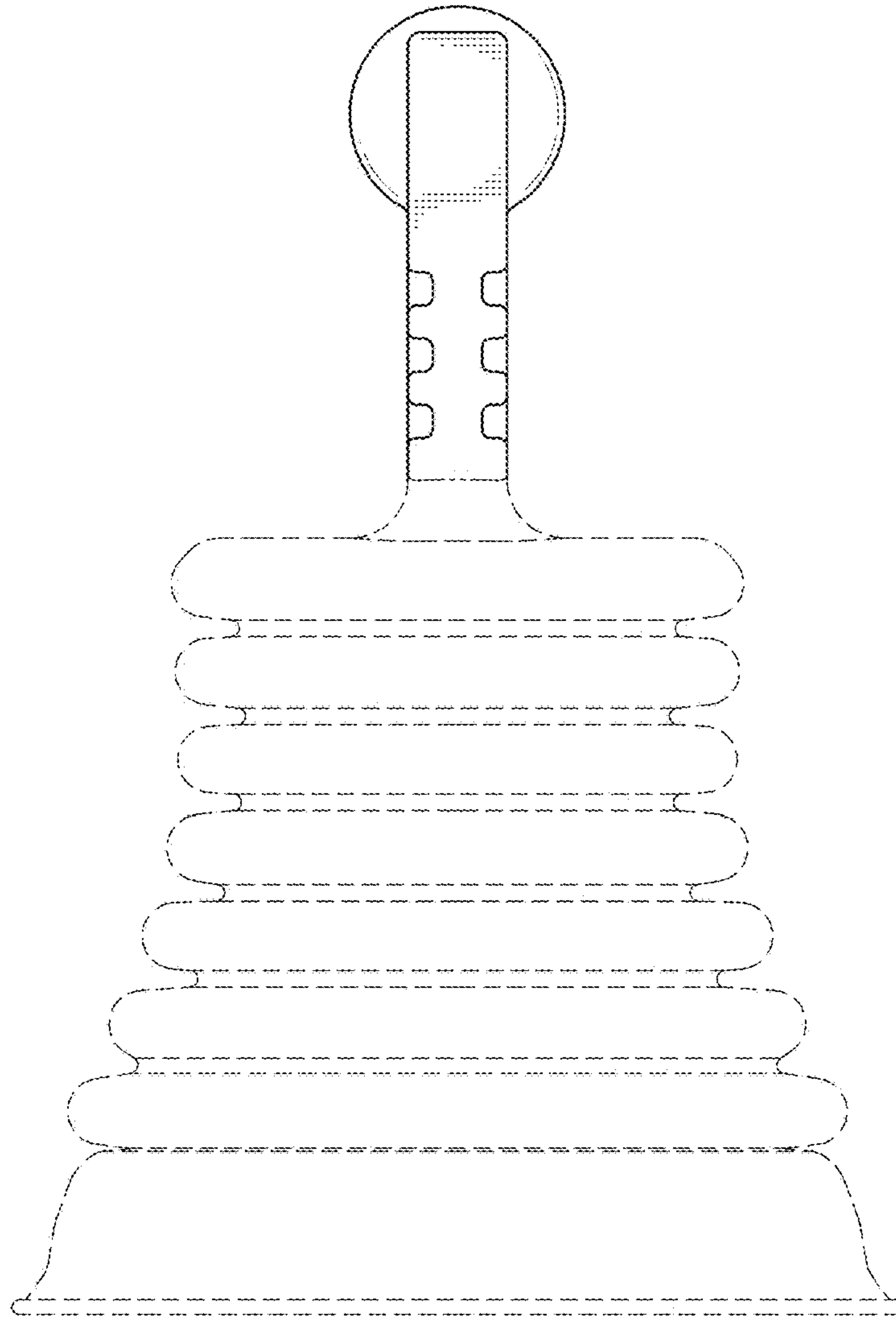

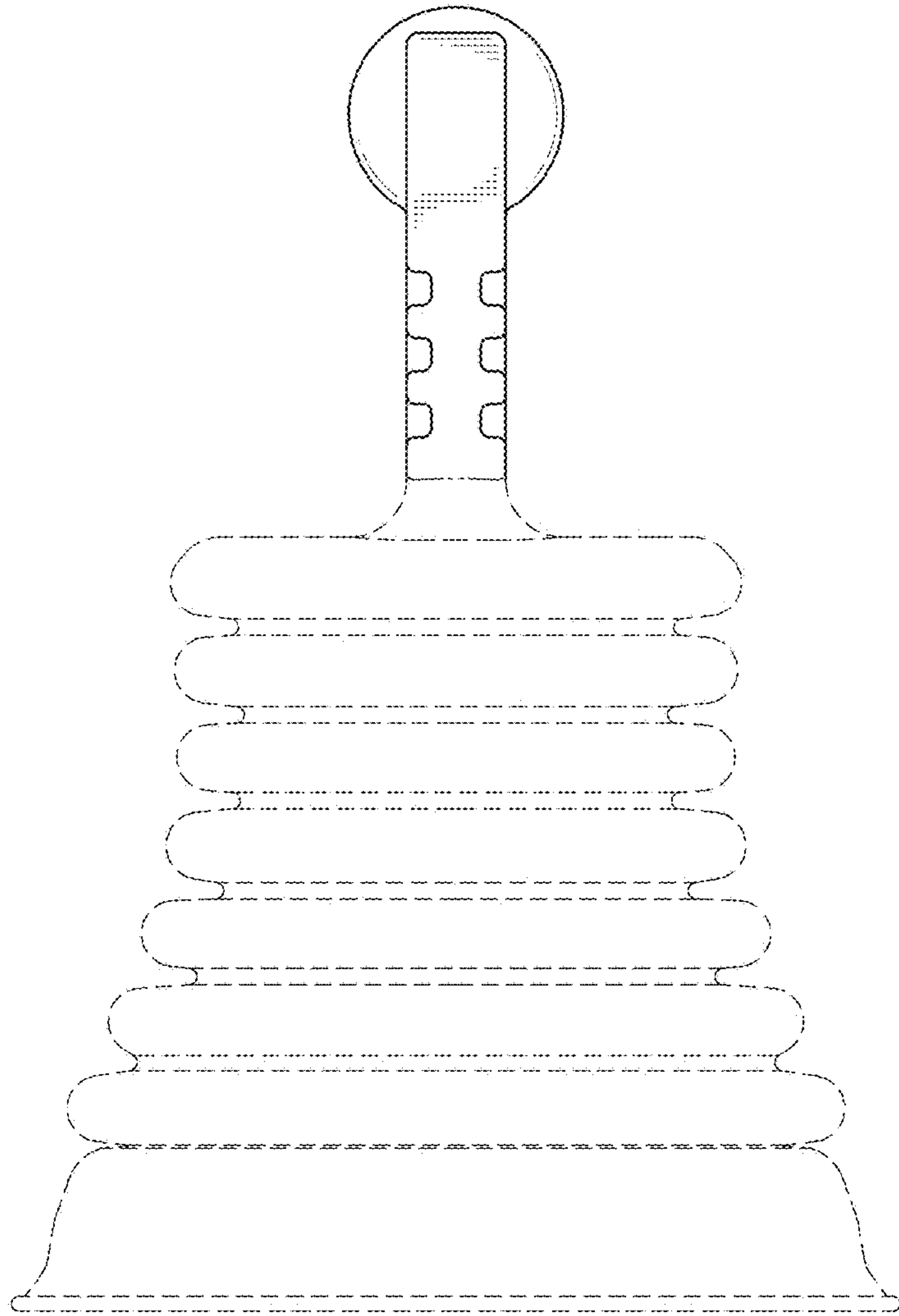

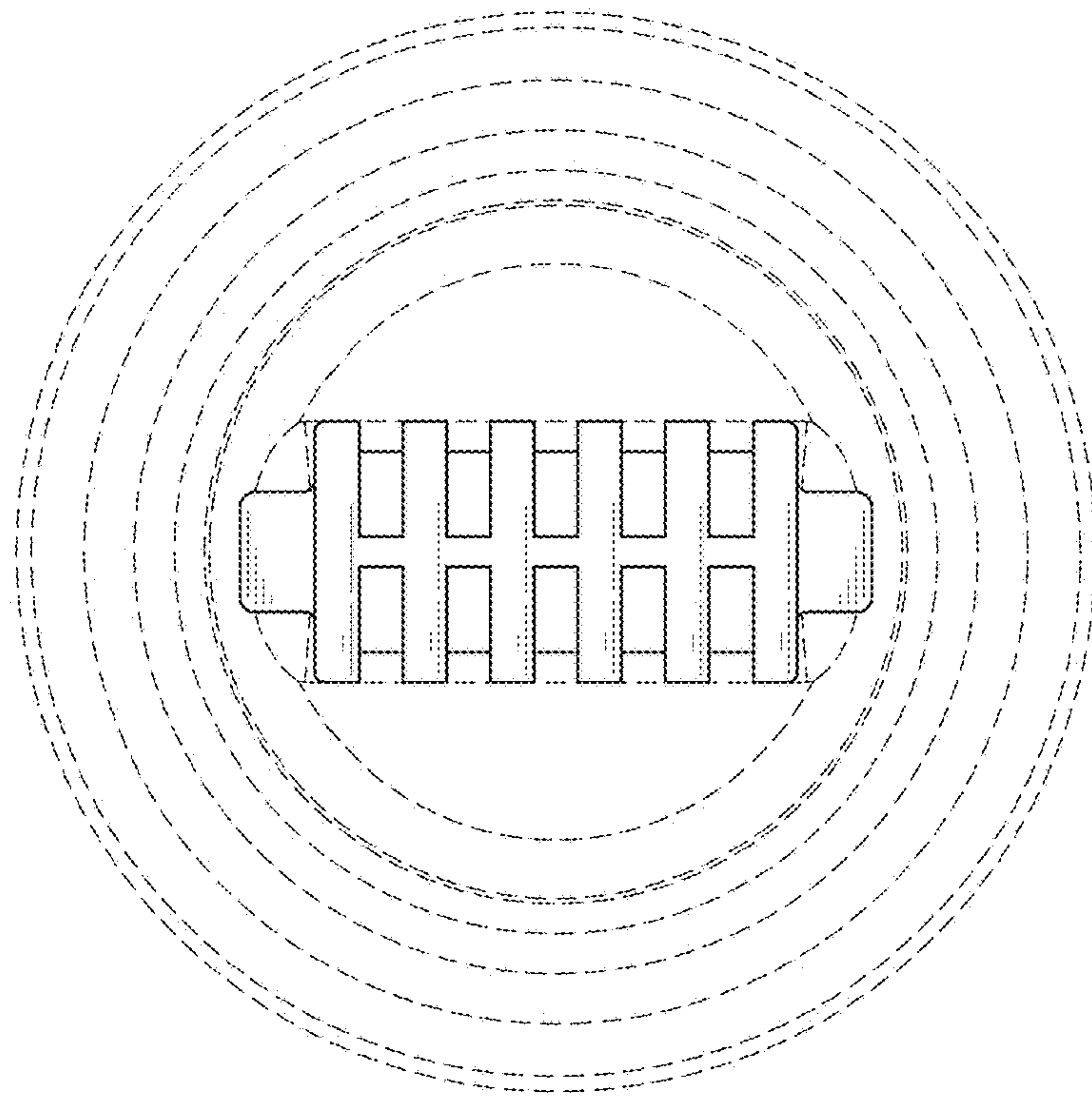
