#### DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;

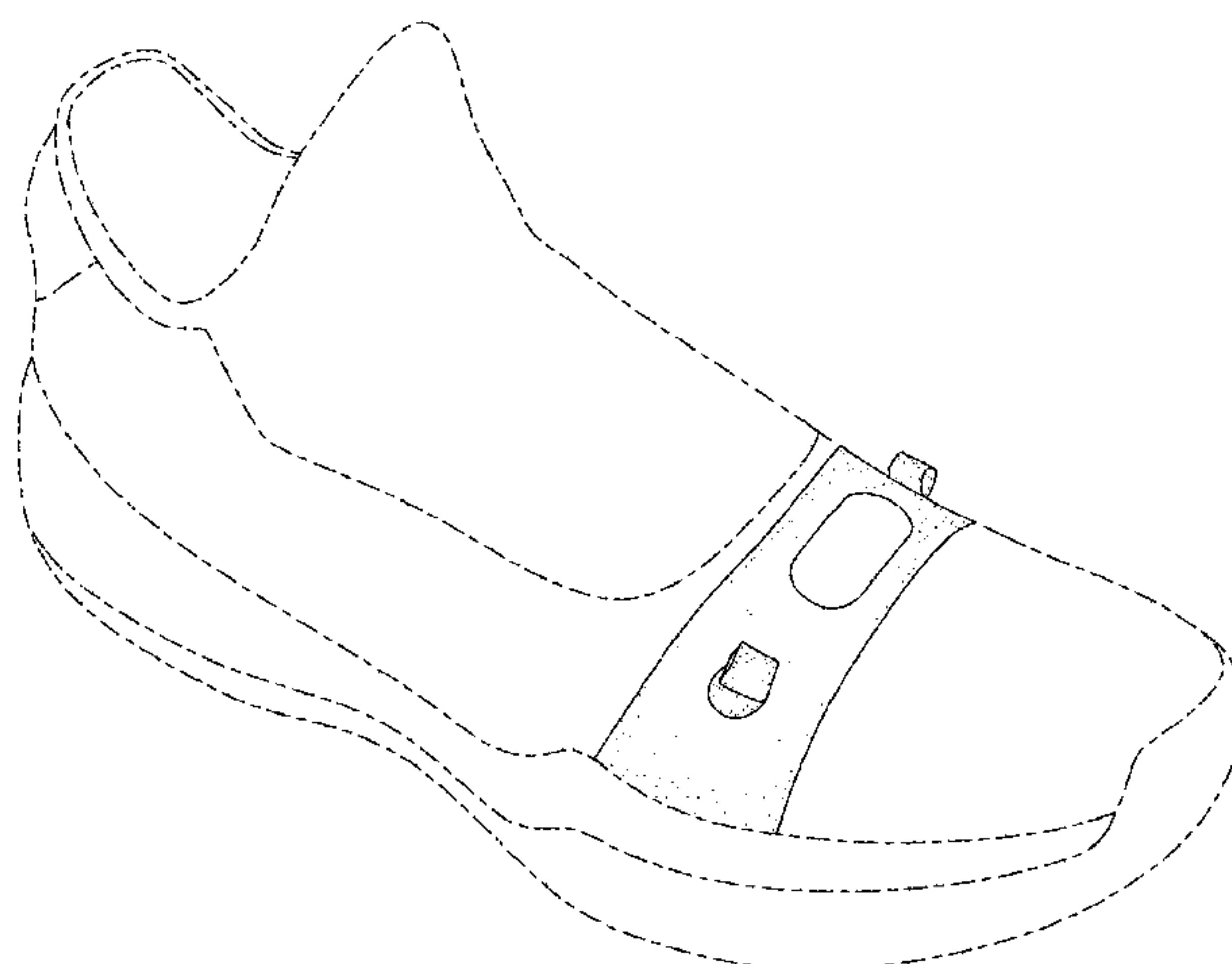
FIG. 2 is a side view thereof;

FIG. 3 is an opposite side view thereof; and,

FIG. 4 is a top view thereof.

The unshaded region within the shaded area that is demarcated by solid lines forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

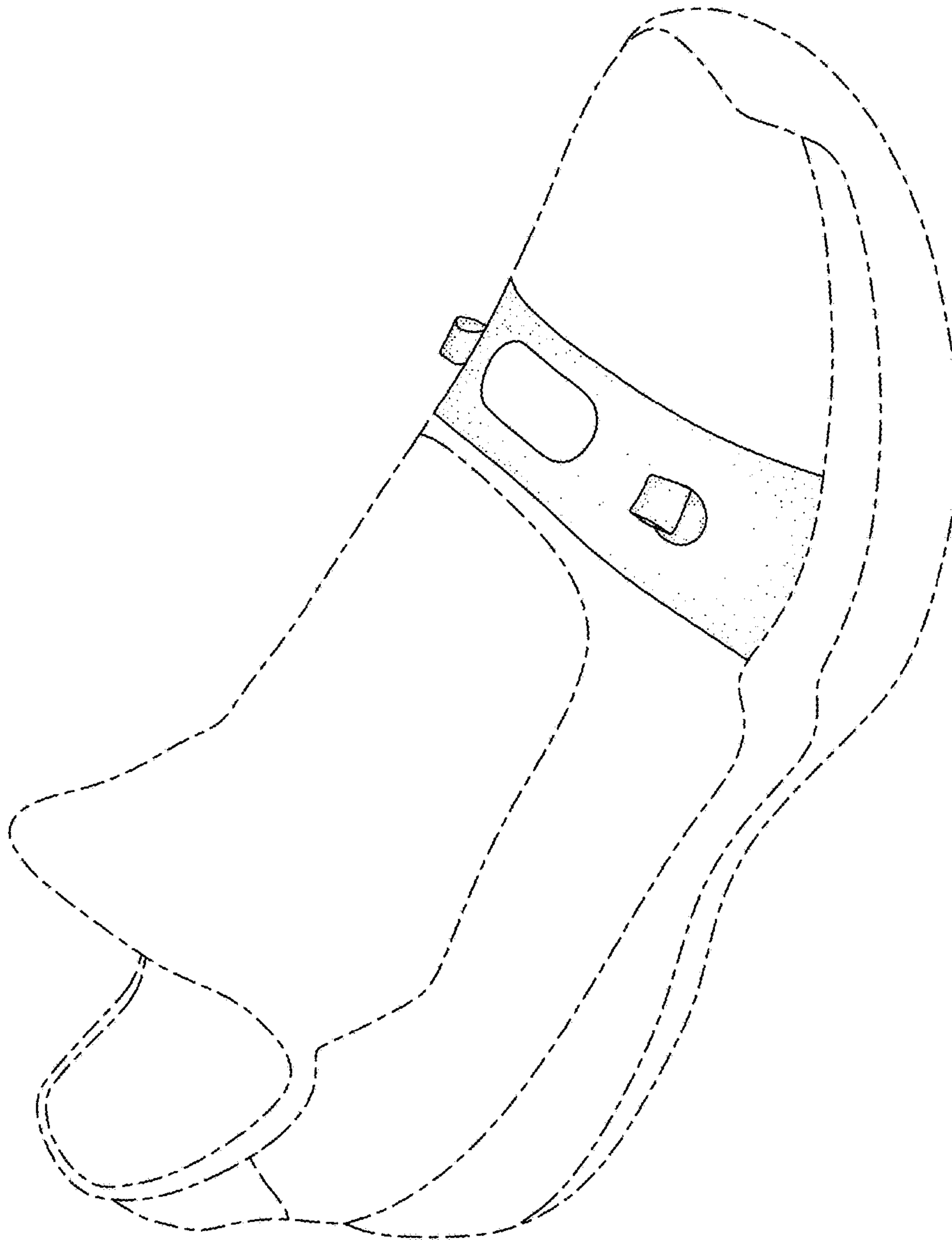

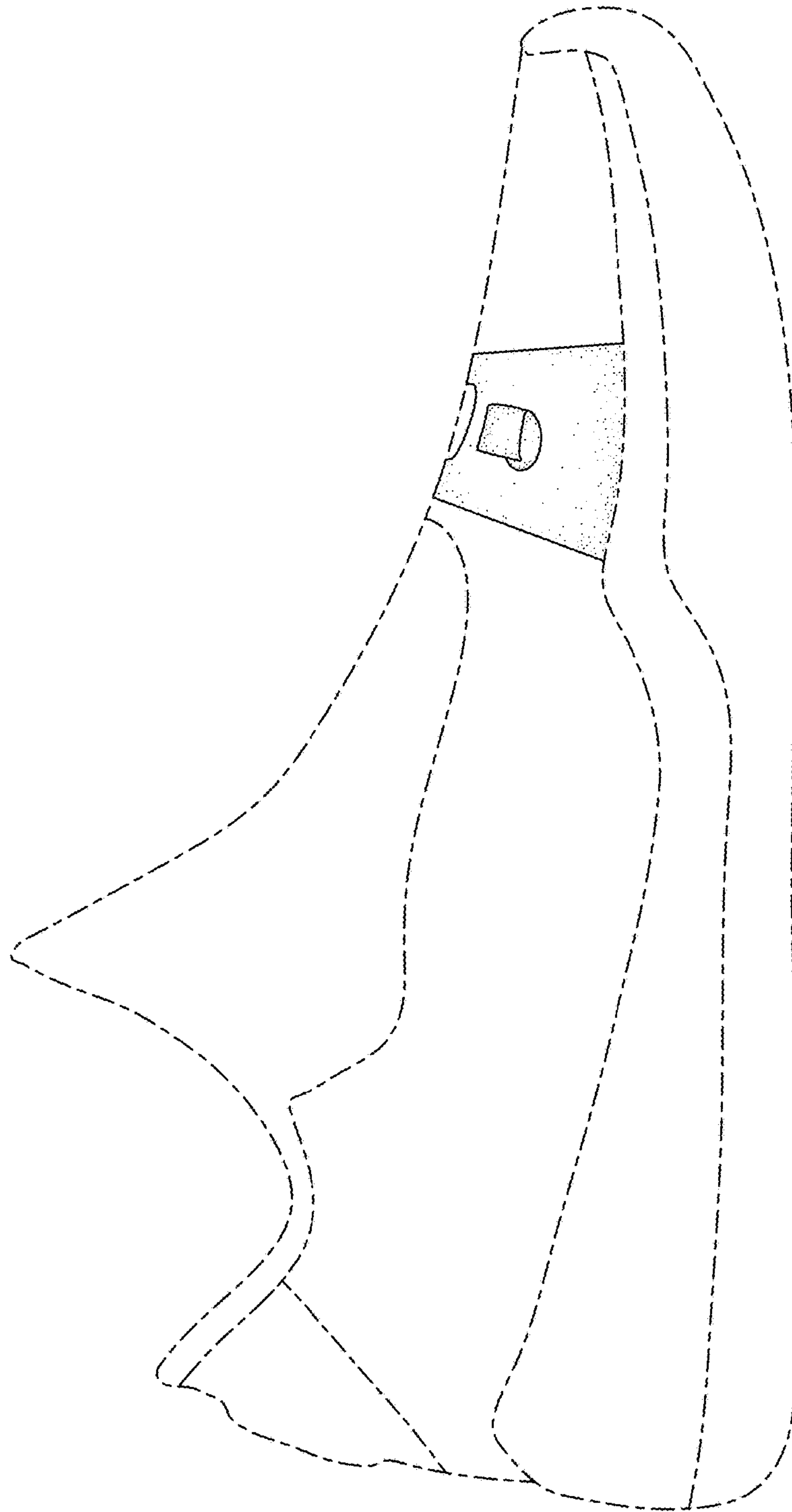

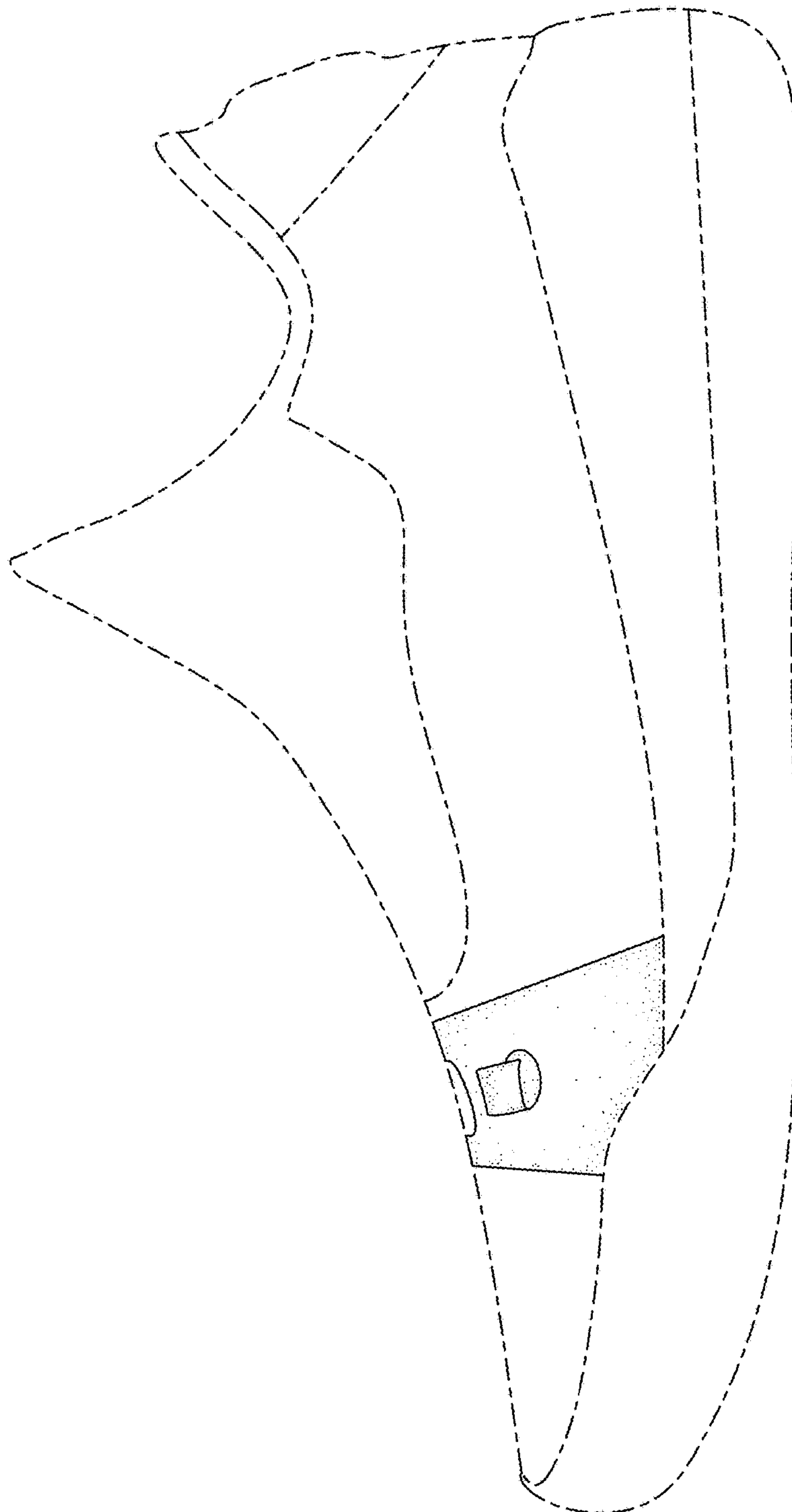

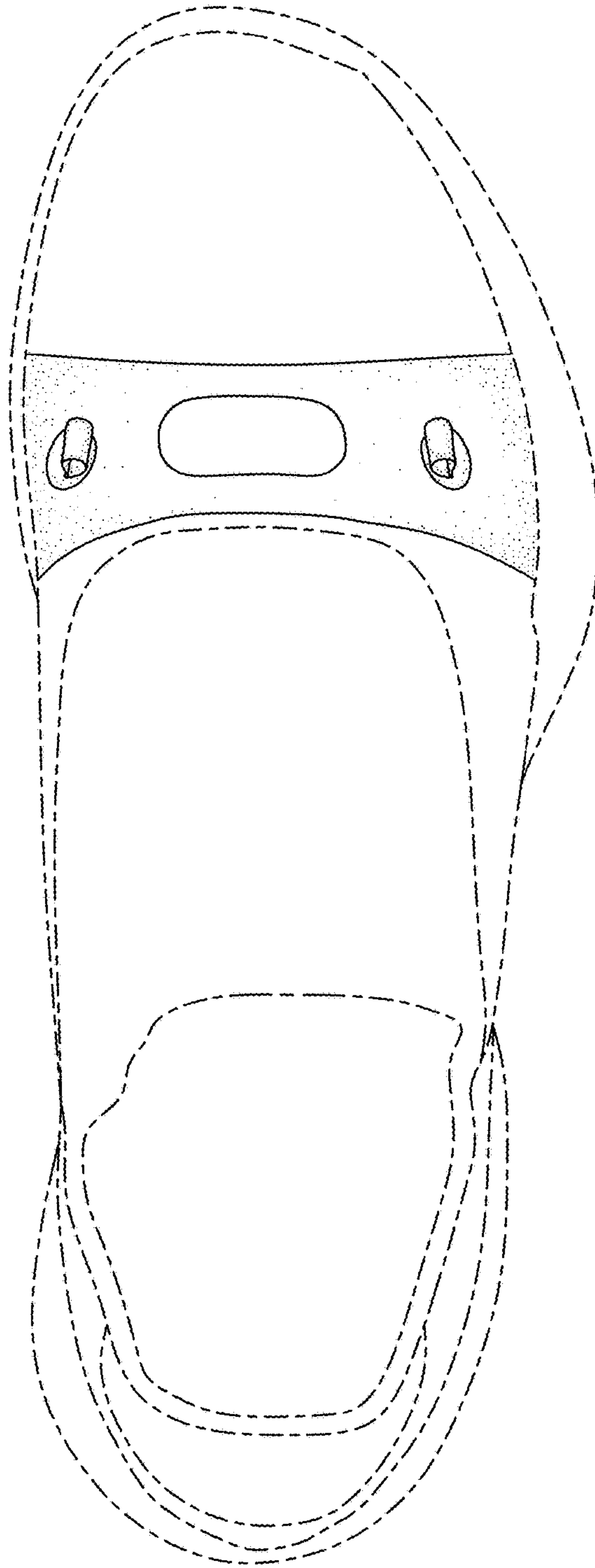
