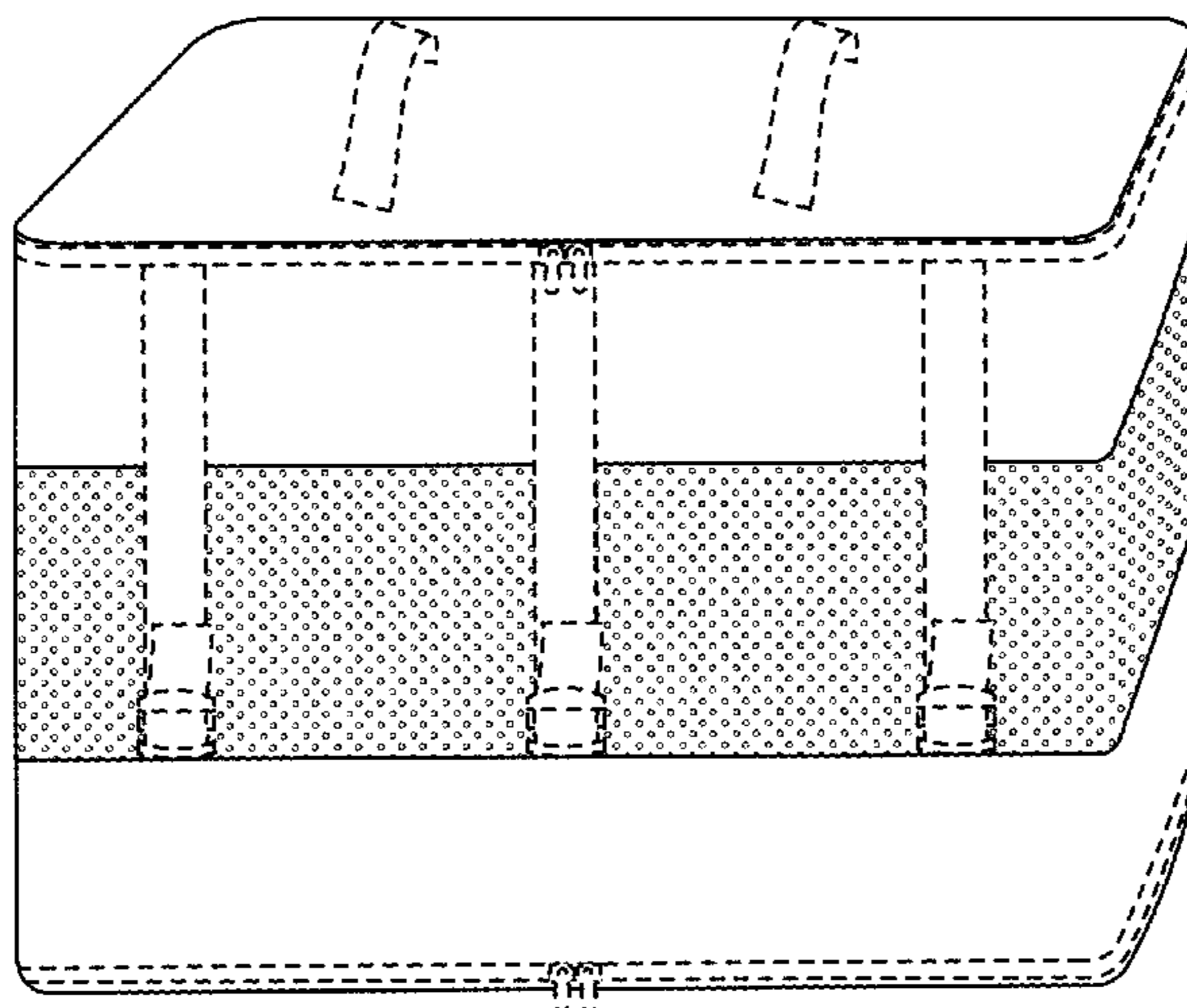
(57) **CLAIM**

I claim the ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bag.
FIG. 2 is another front perspective view thereof.
FIG. 3 is a rear perspective view thereof.
FIG. 4 is a front side view thereof.
FIG. 5 is a back side view thereof.
FIG. 6 is a right side view thereof.
FIG. 7 is a left side view thereof.
FIG. 8 is a top view thereof; and,
FIG. 9 is a bottom view thereof.
The central dotted portion of the bag is intended to illustrate mesh. The broken lines illustrate portions of the bag and form no part of the claimed design.

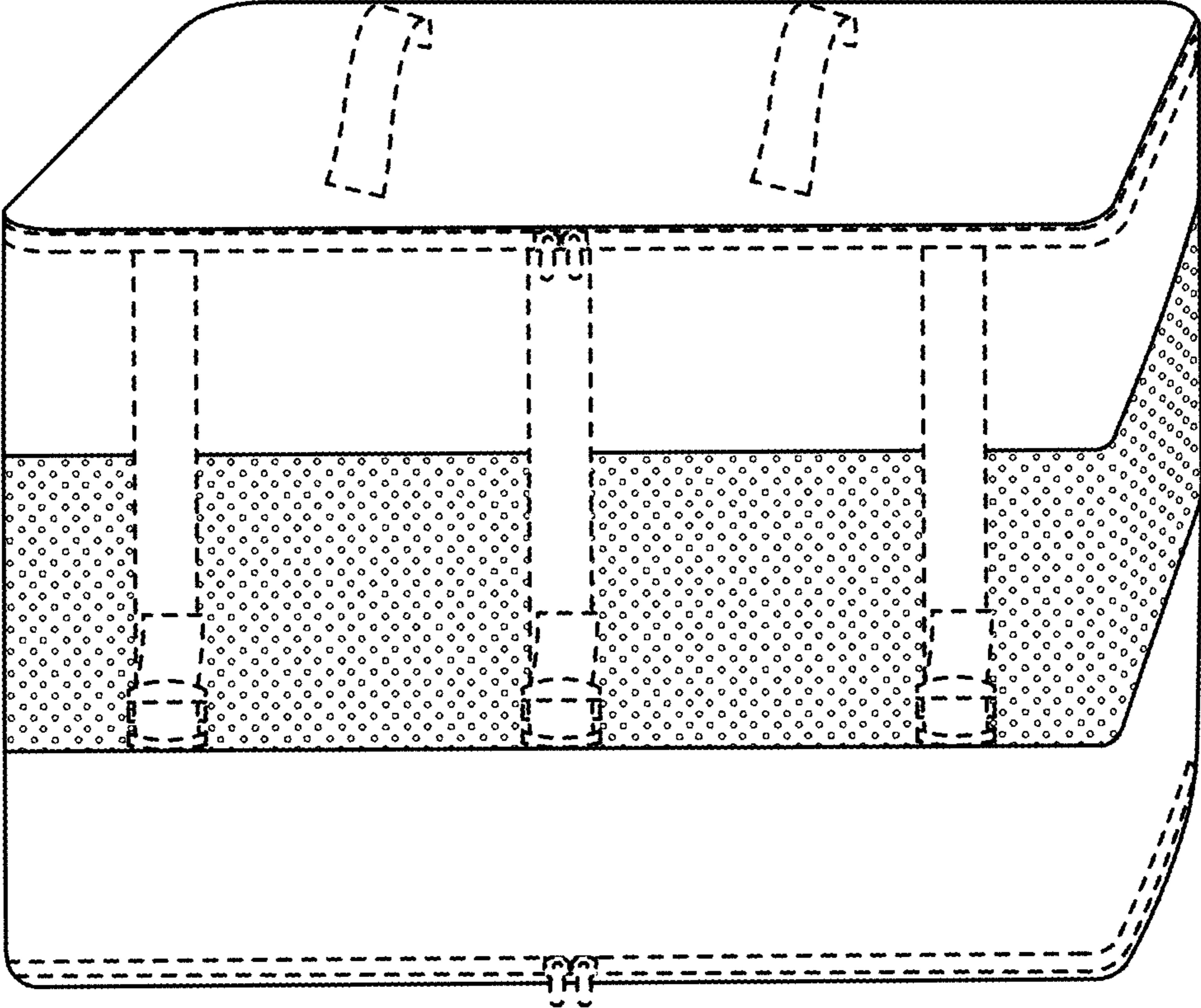

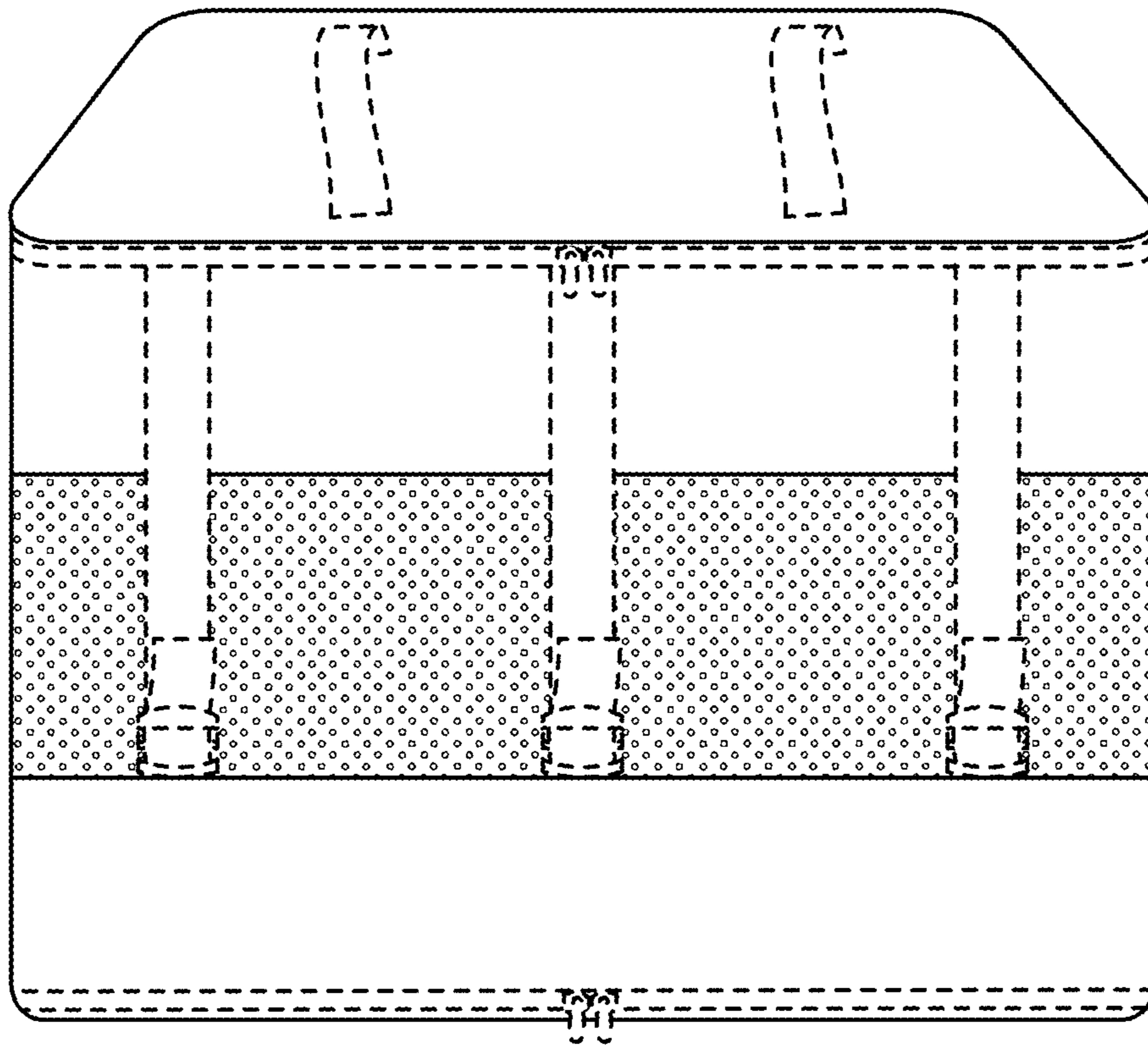

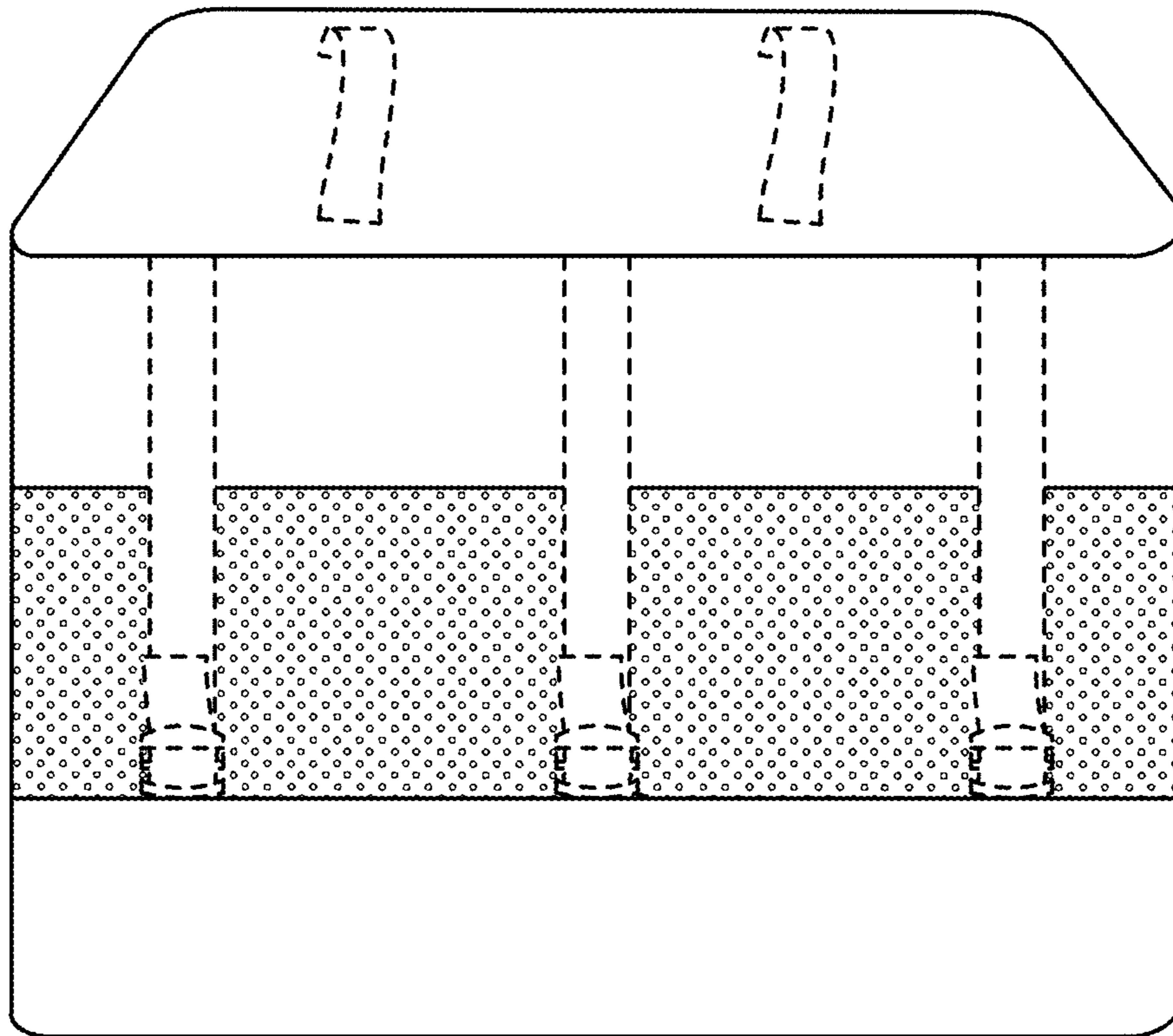

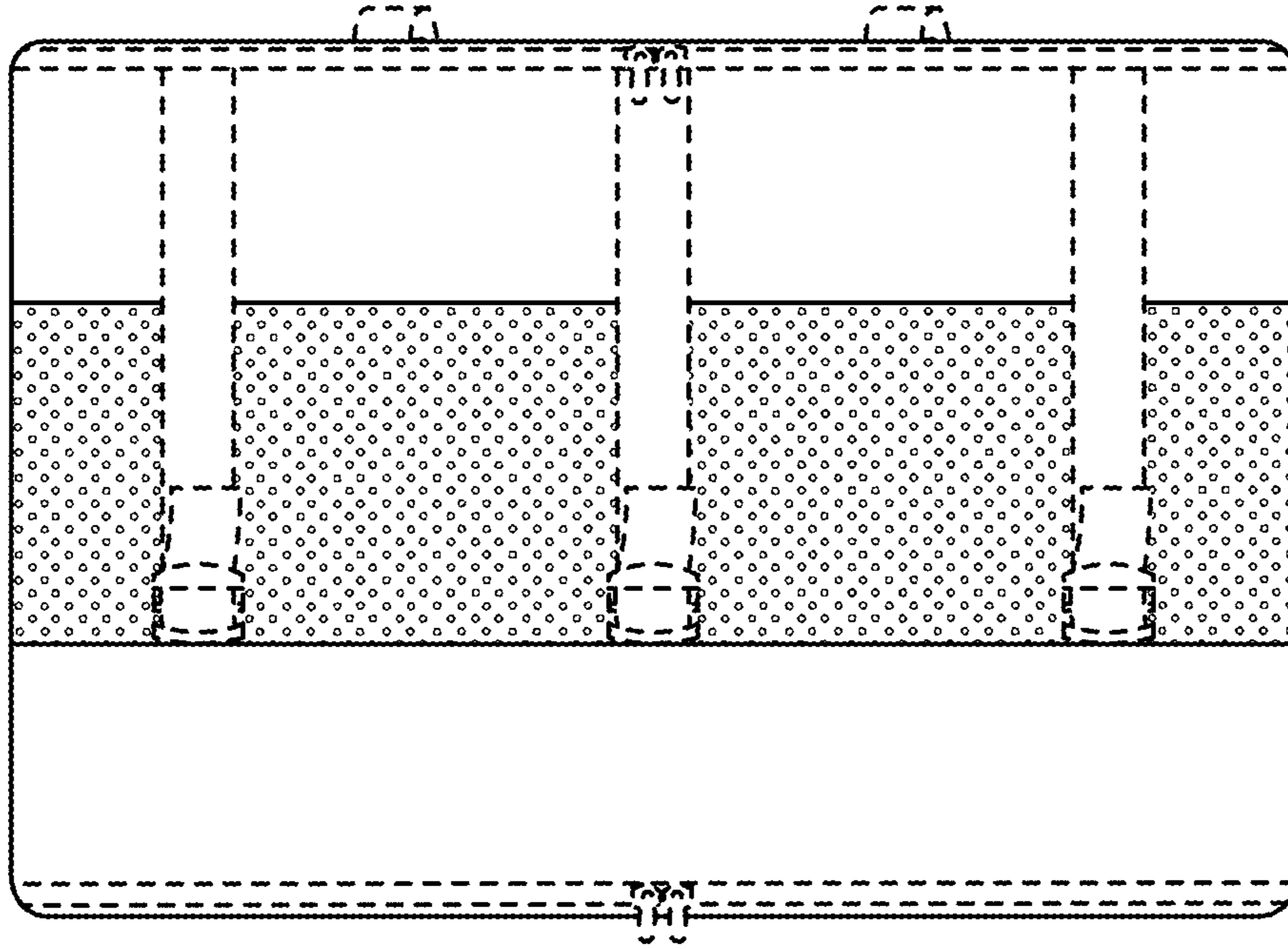

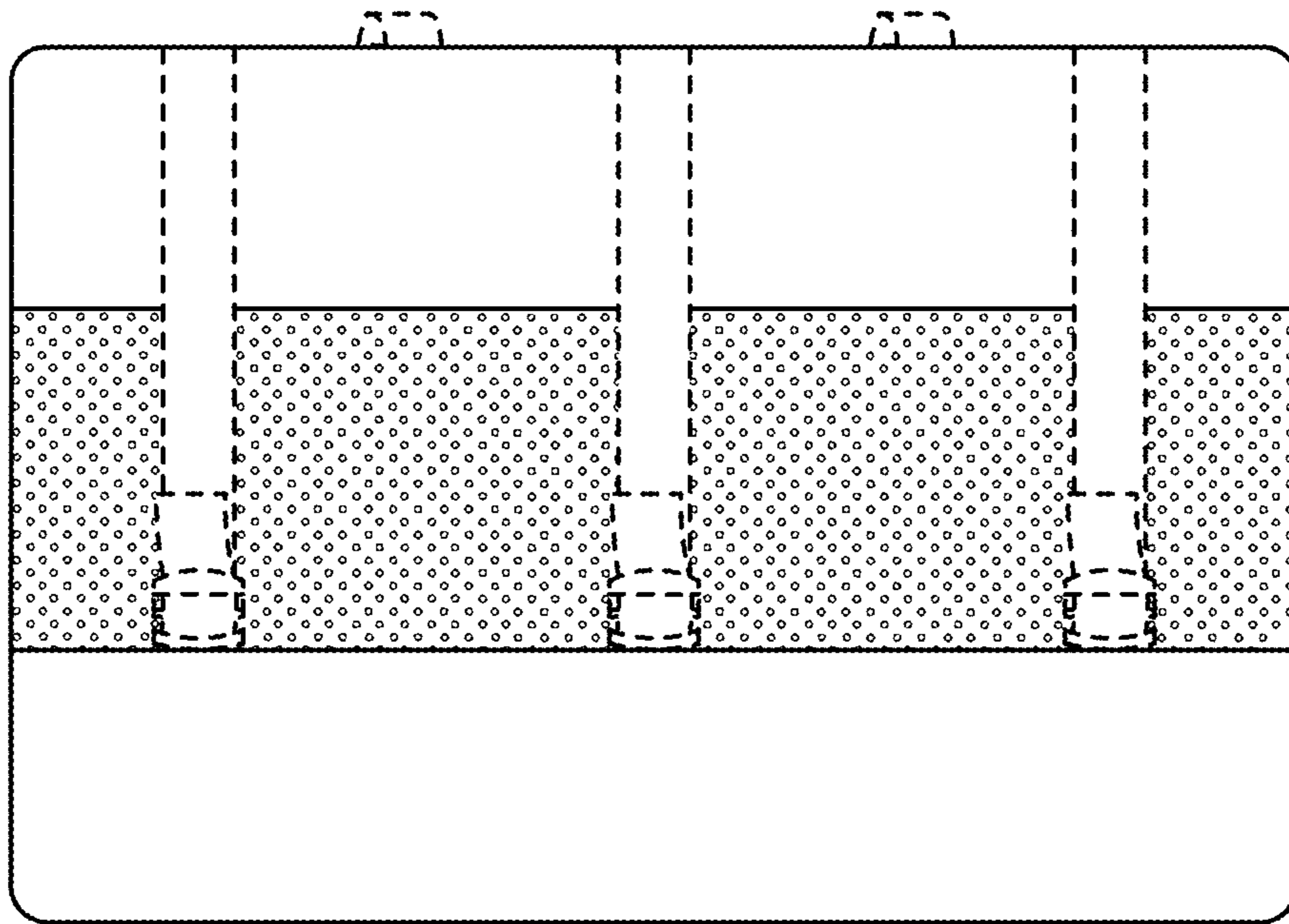

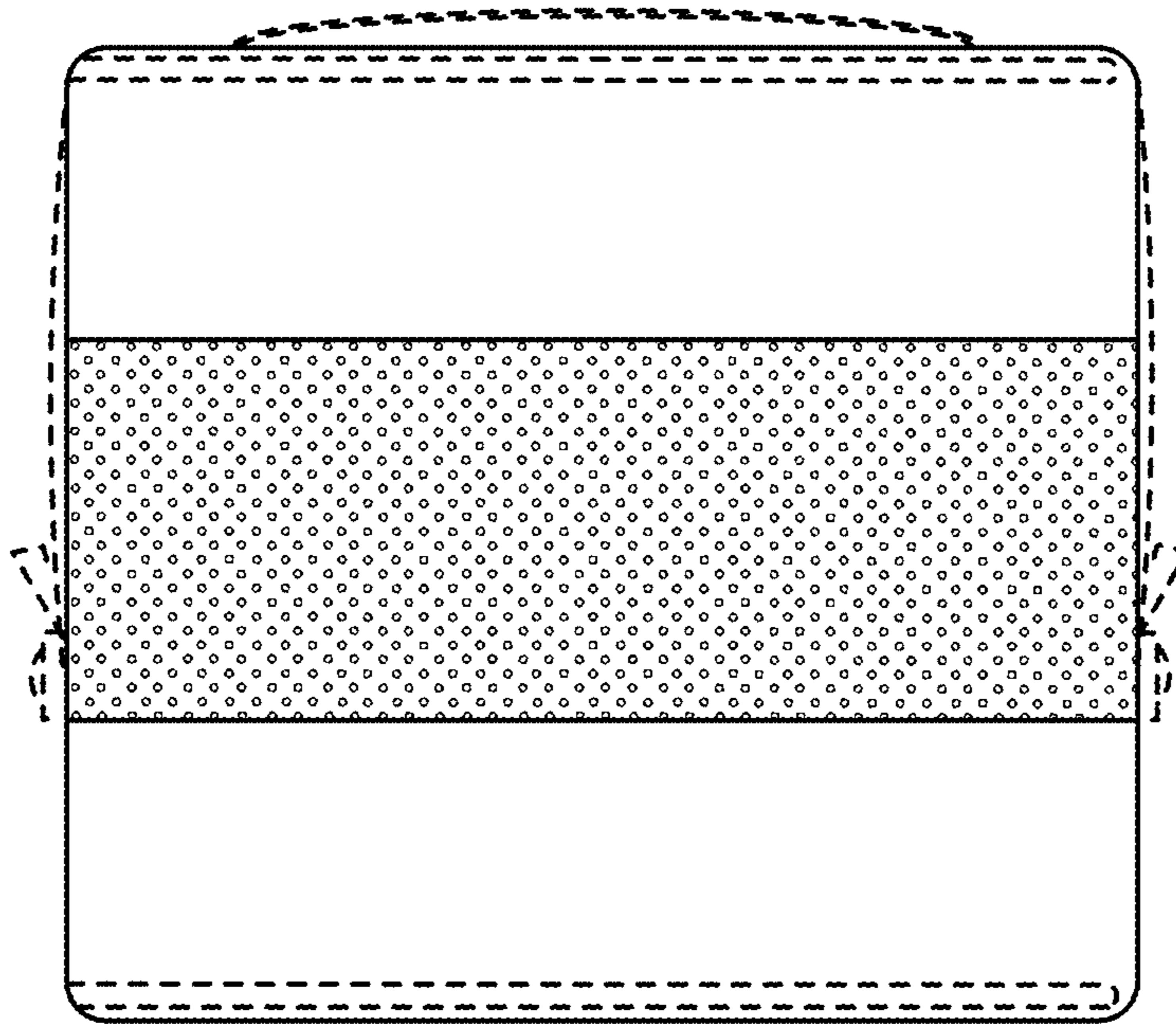

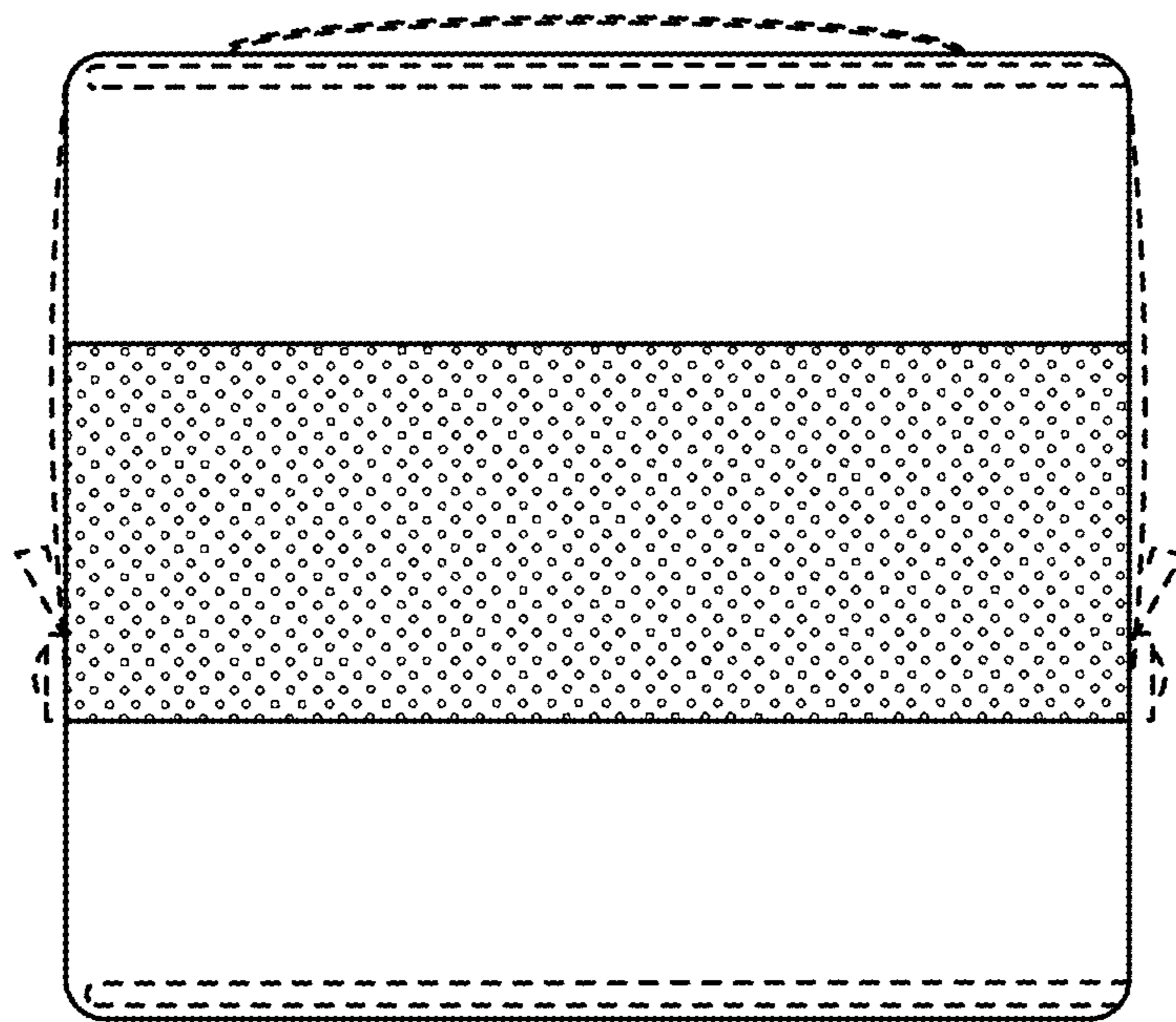

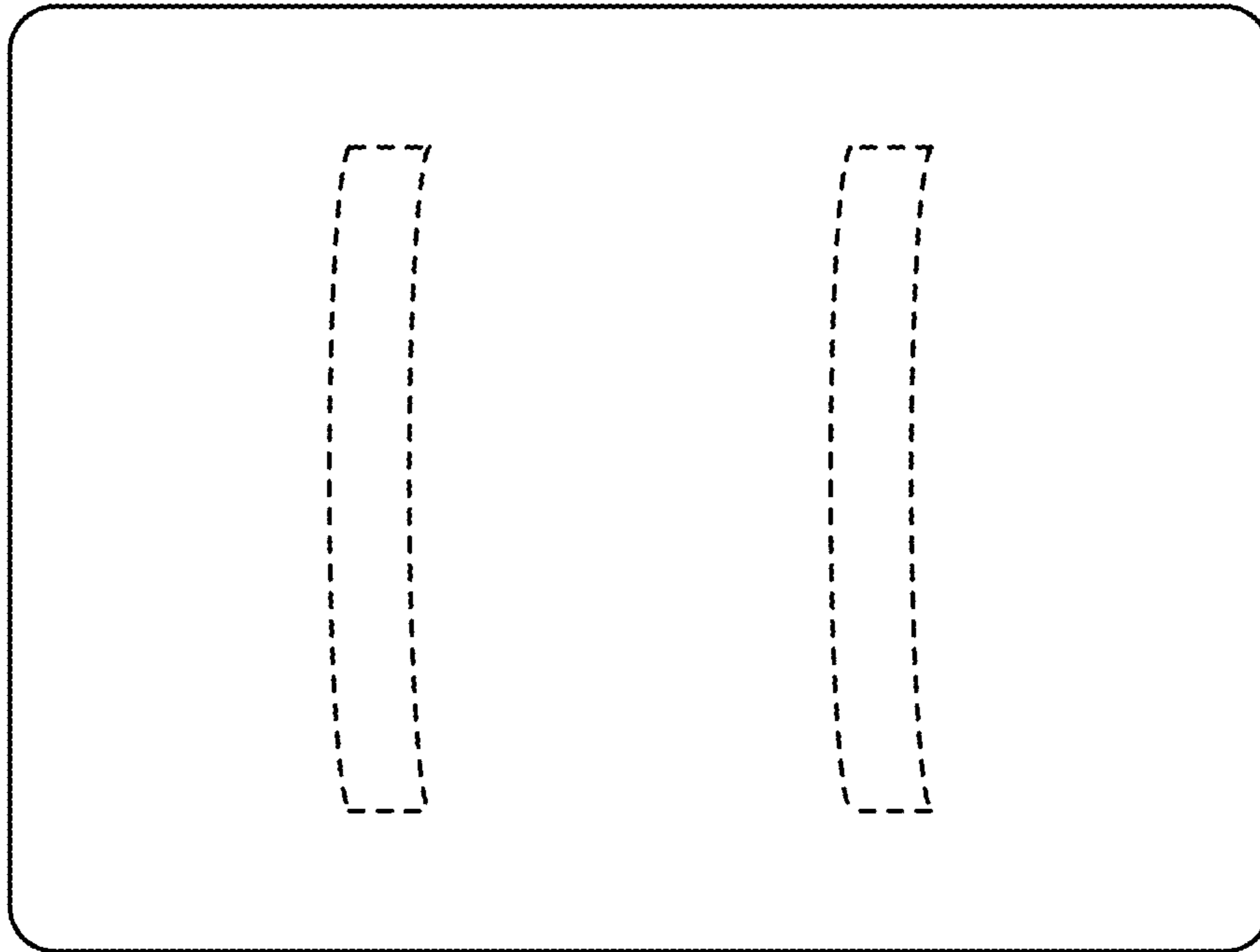

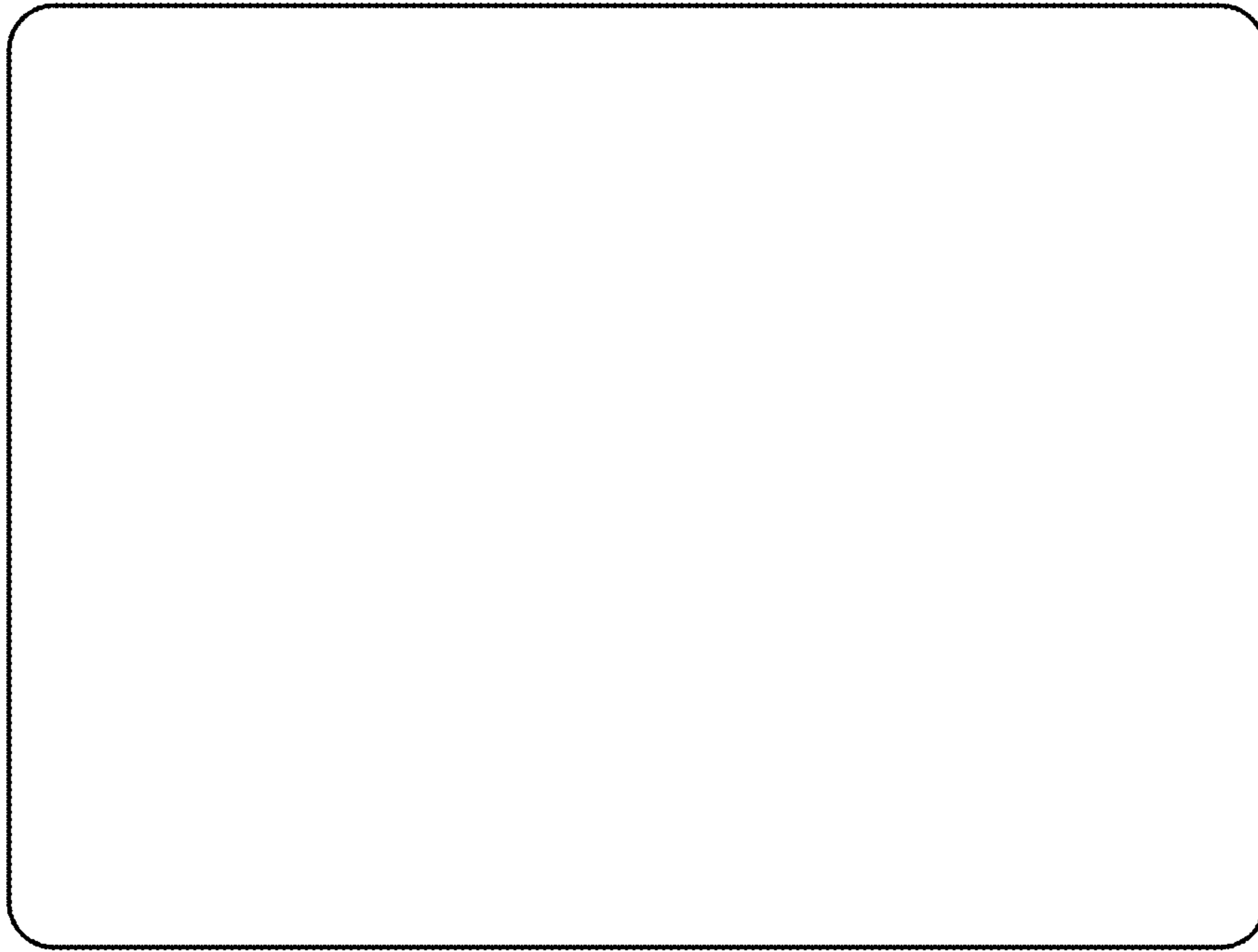
