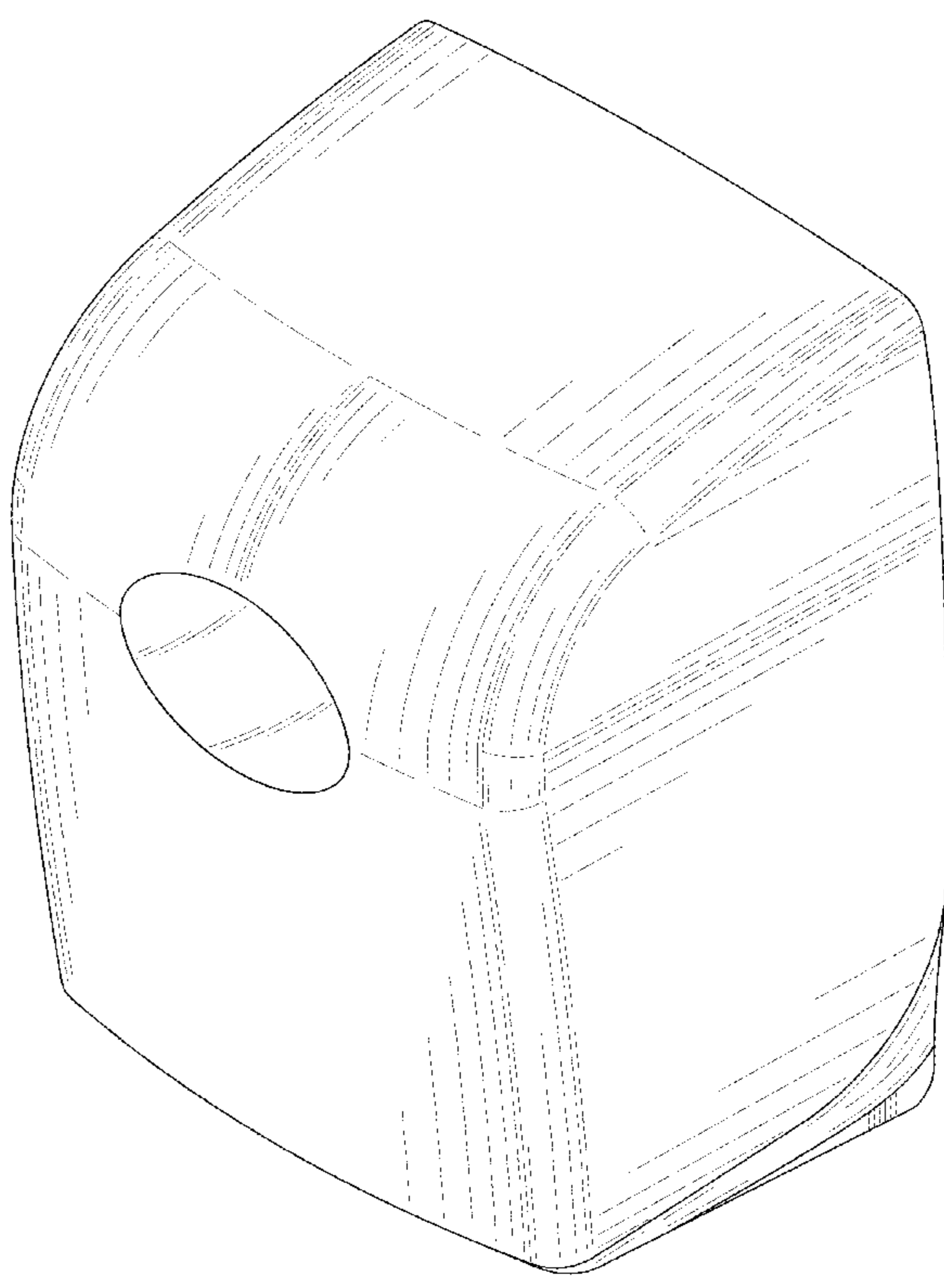
(57) **CLAIM**

The ornamental design for a paper product dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a paper product dispenser embodying my new design;  
 FIG. 2 is a back perspective view of the dispenser shown in FIG. 1.  
 FIG. 3 is a front view of the dispenser shown in FIG. 1;  
 FIG. 4 is a right side view of the dispenser shown in FIG. 1;

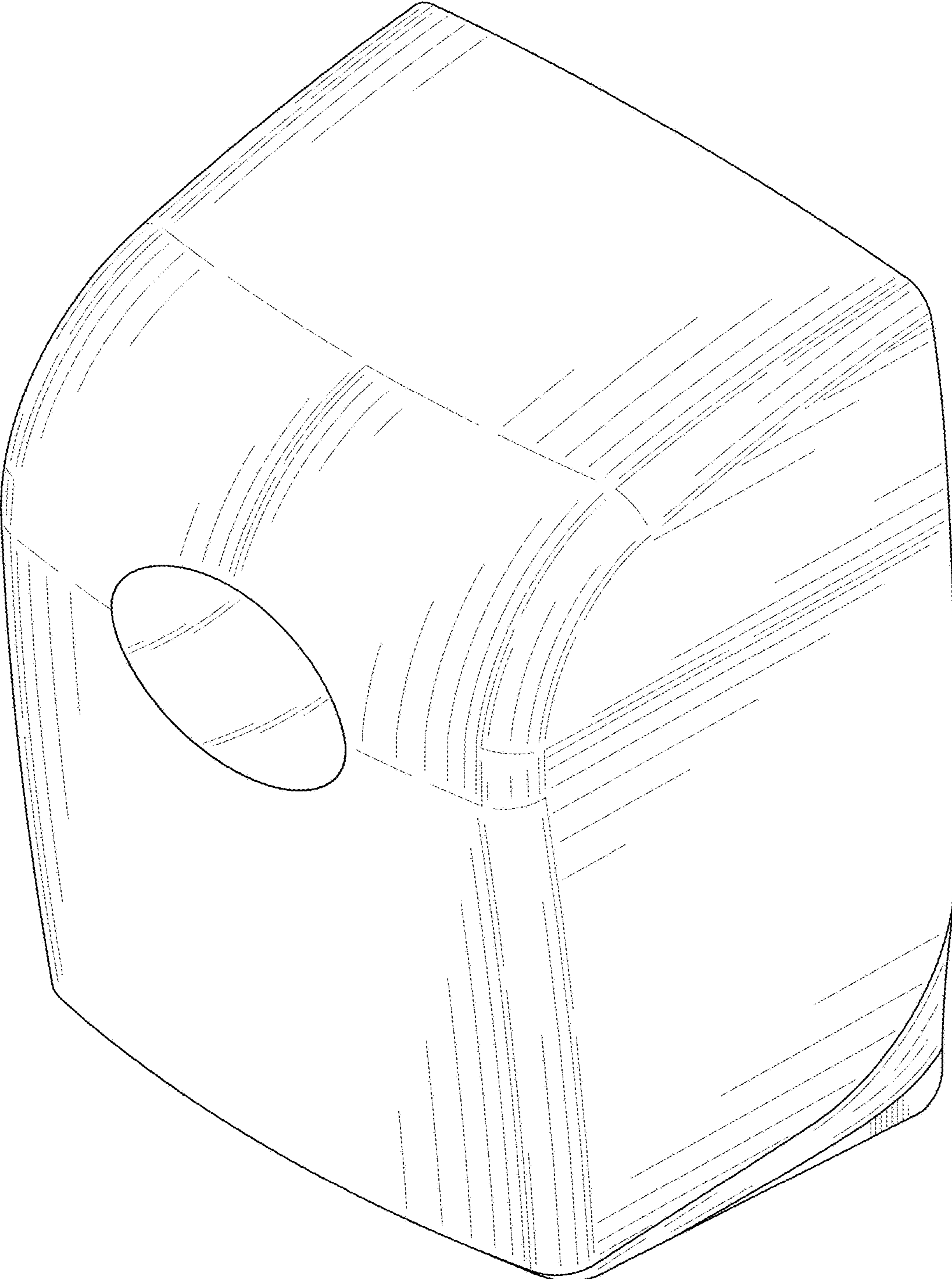

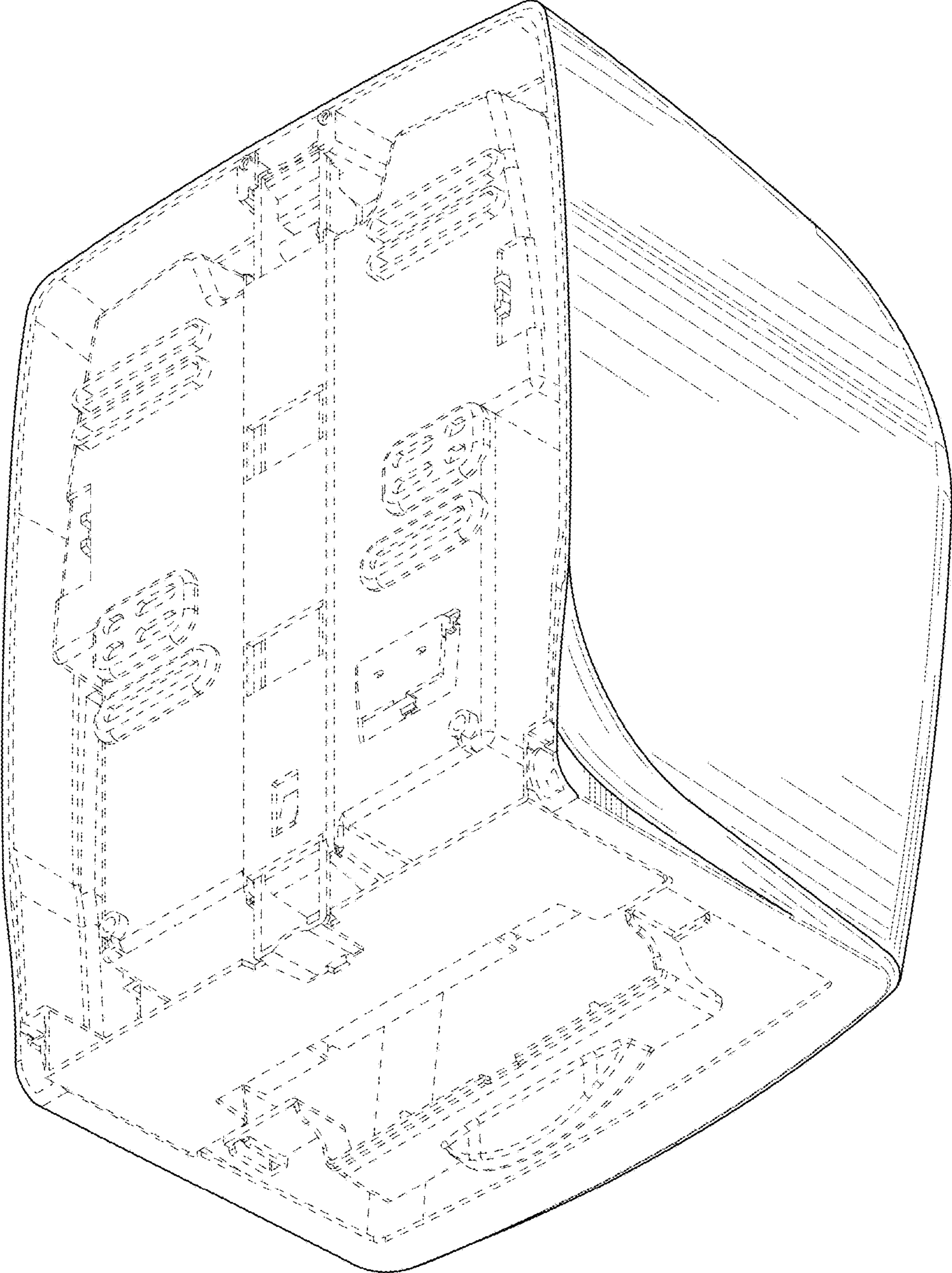

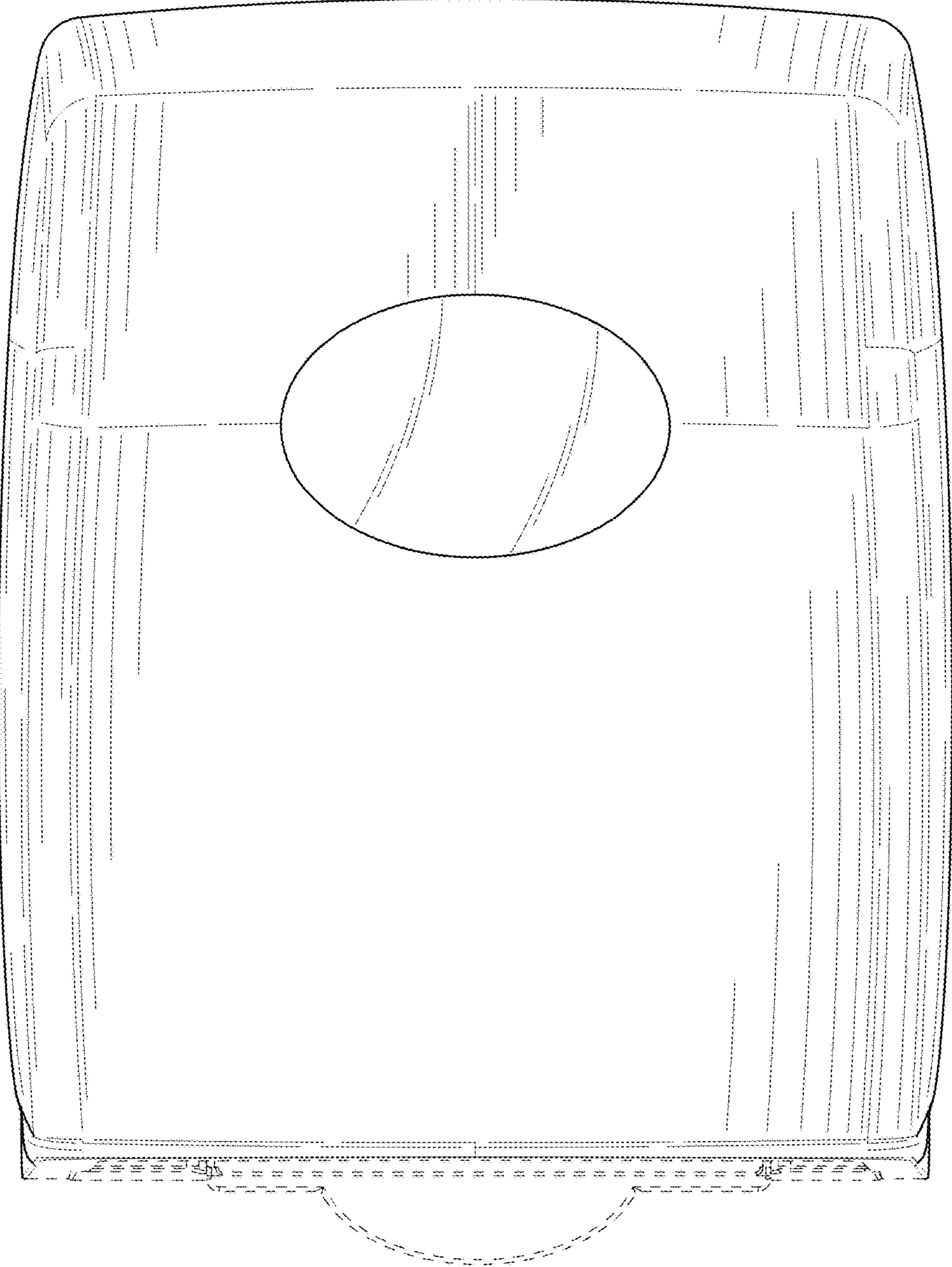

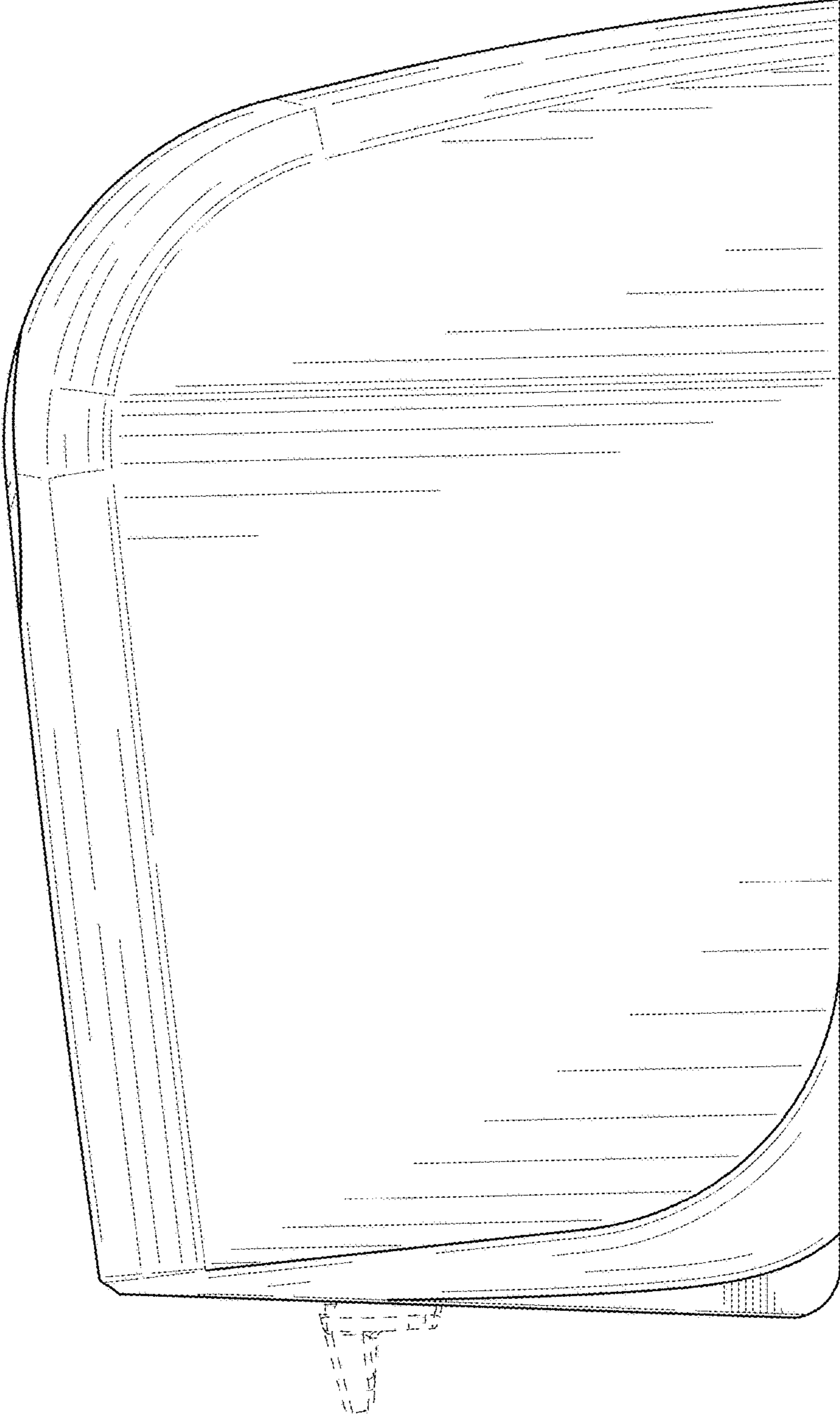

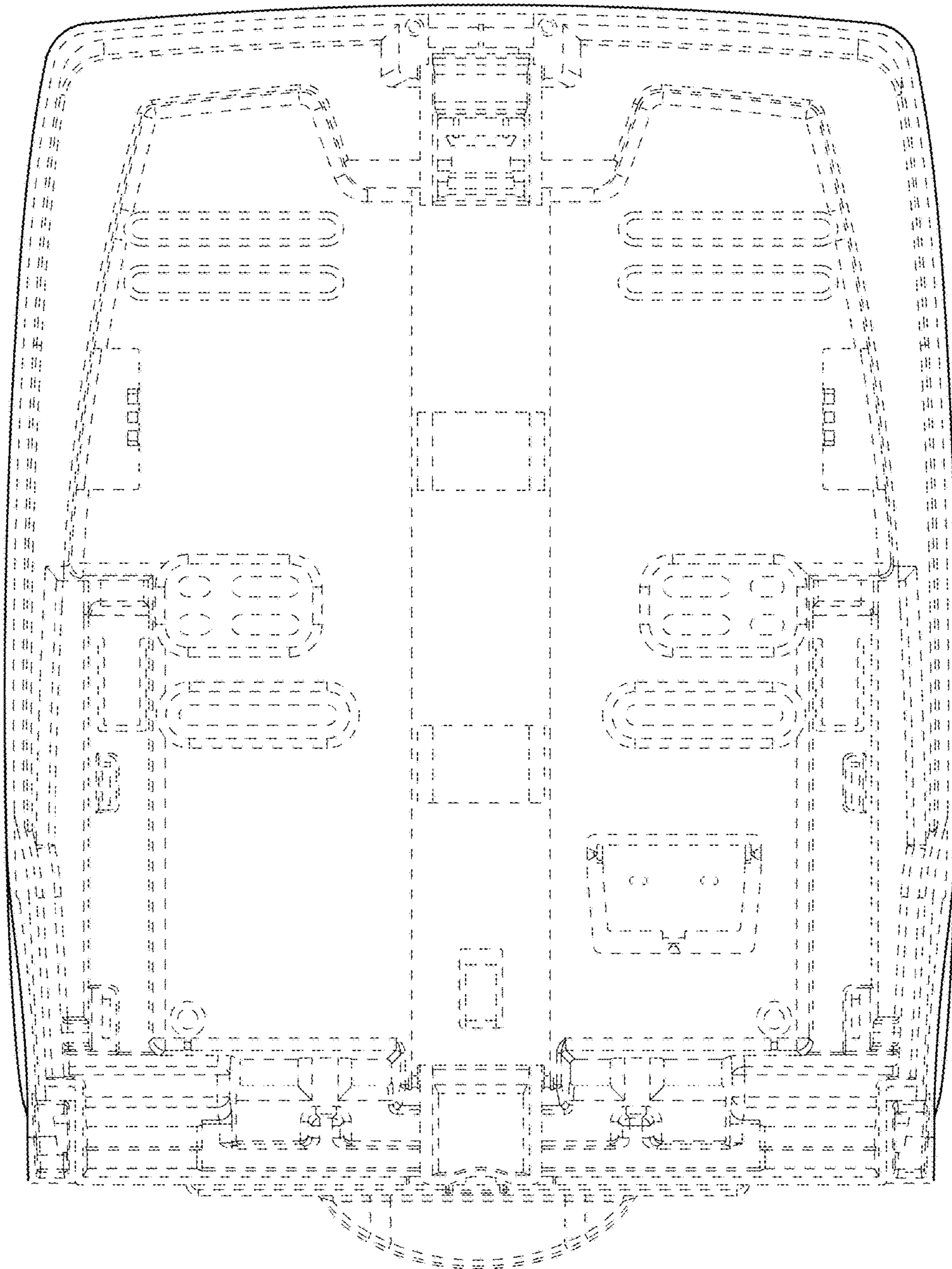

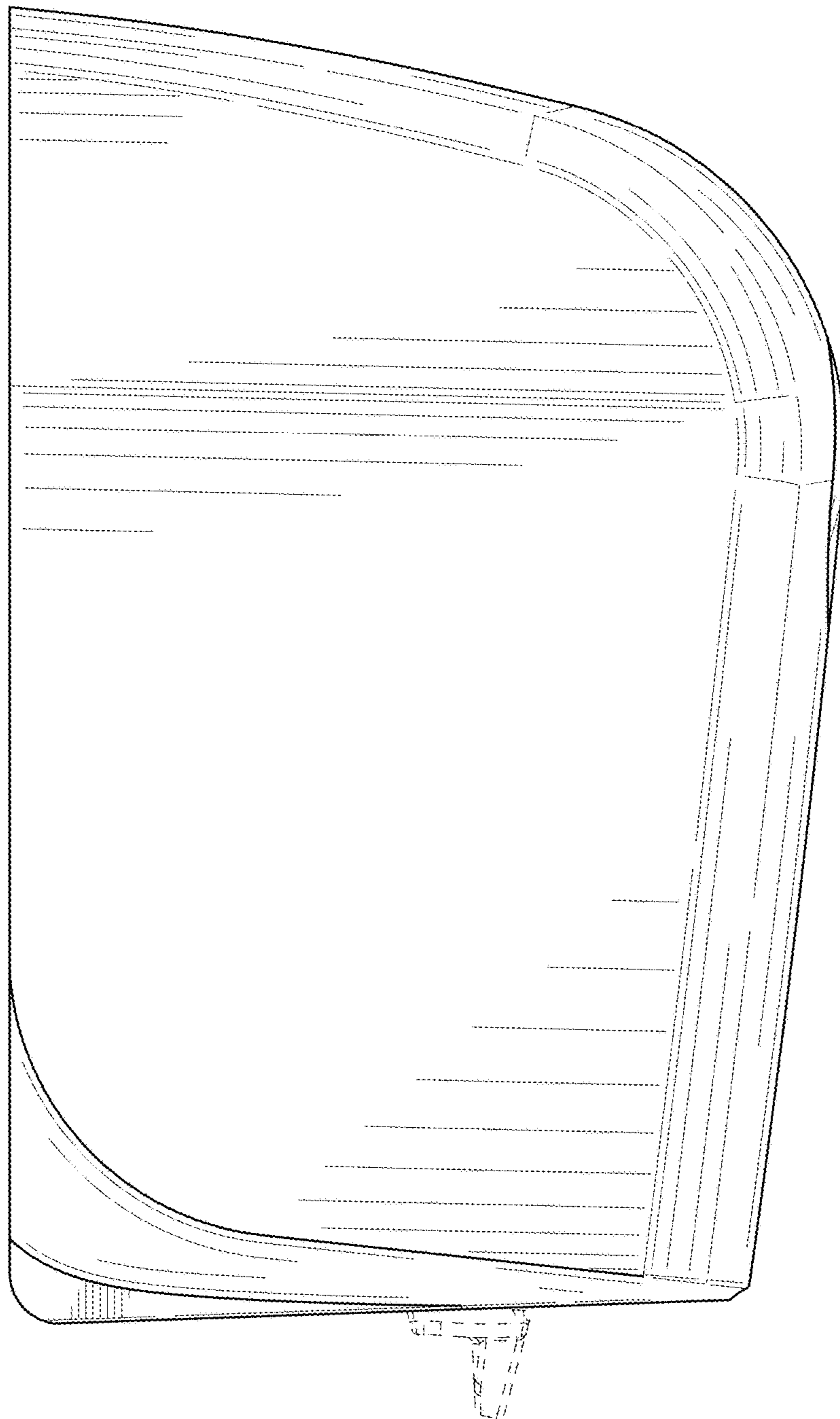

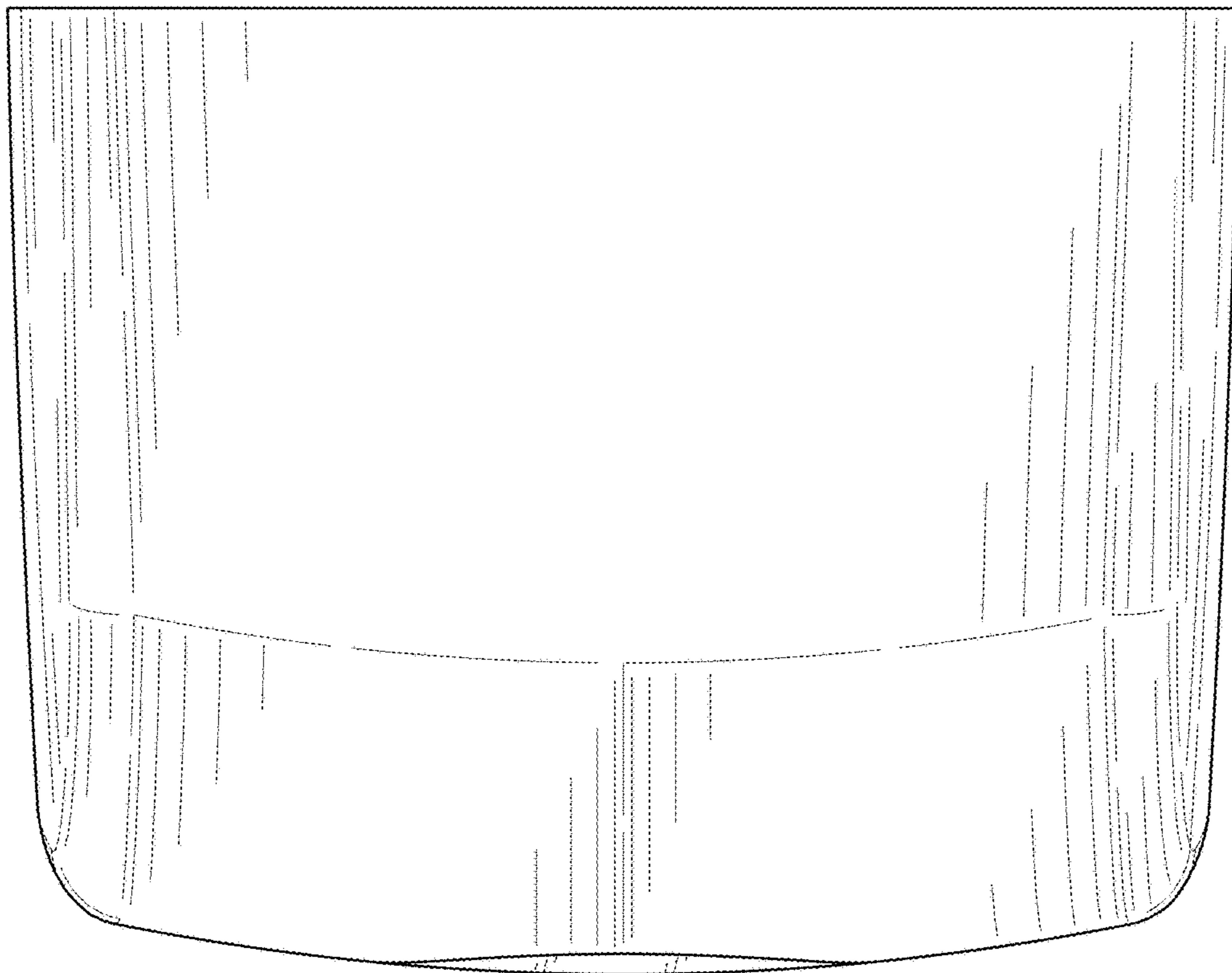

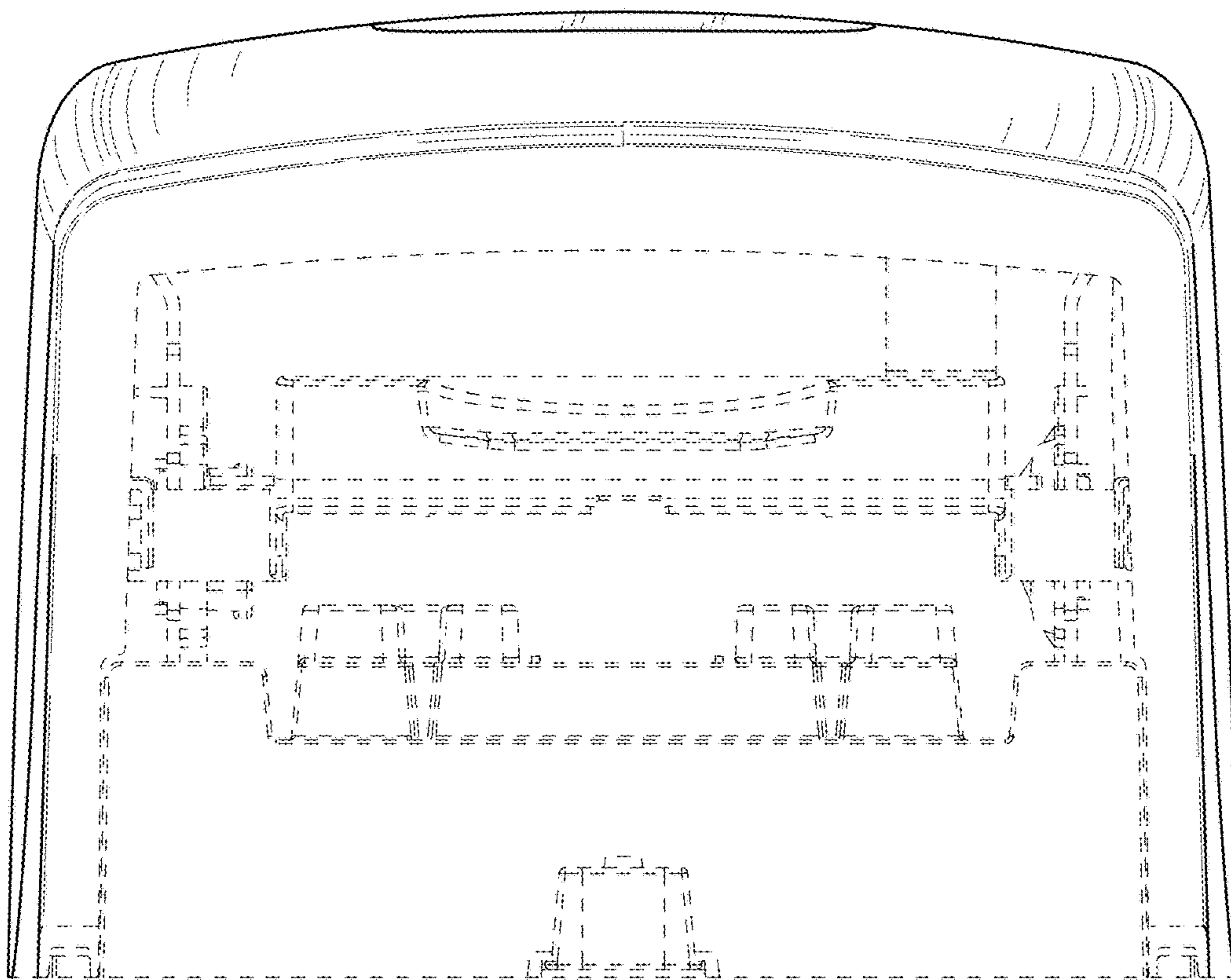
