(57) **CLAIM**

The ornamental design for a gliding tiered expanded mesh shelf, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a gliding tiered expanded mesh shelf shown with environment;

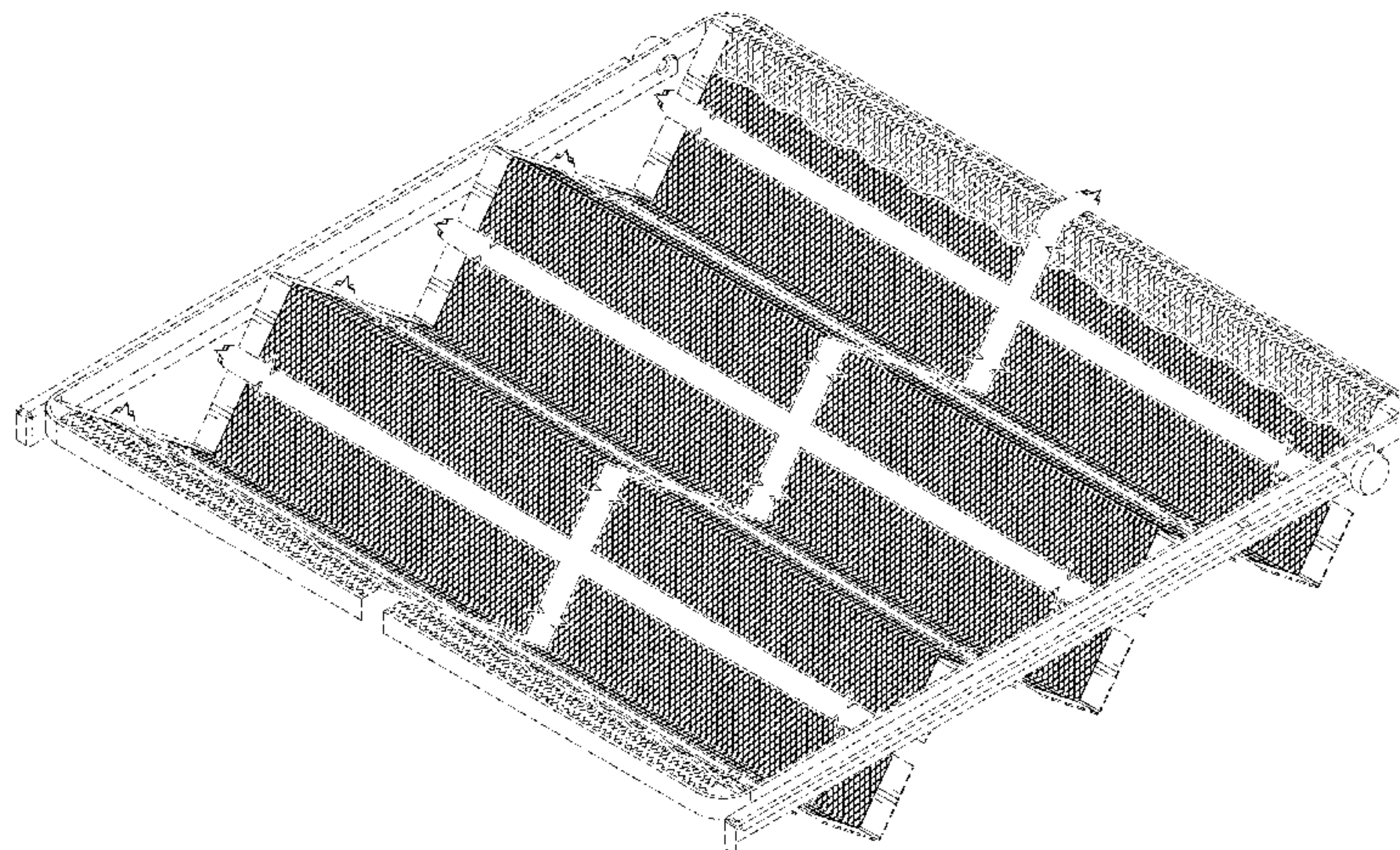


FIG. 22 is a top perspective view of a fourth embodiment of a gliding tiered expanded mesh shelf shown with environment;

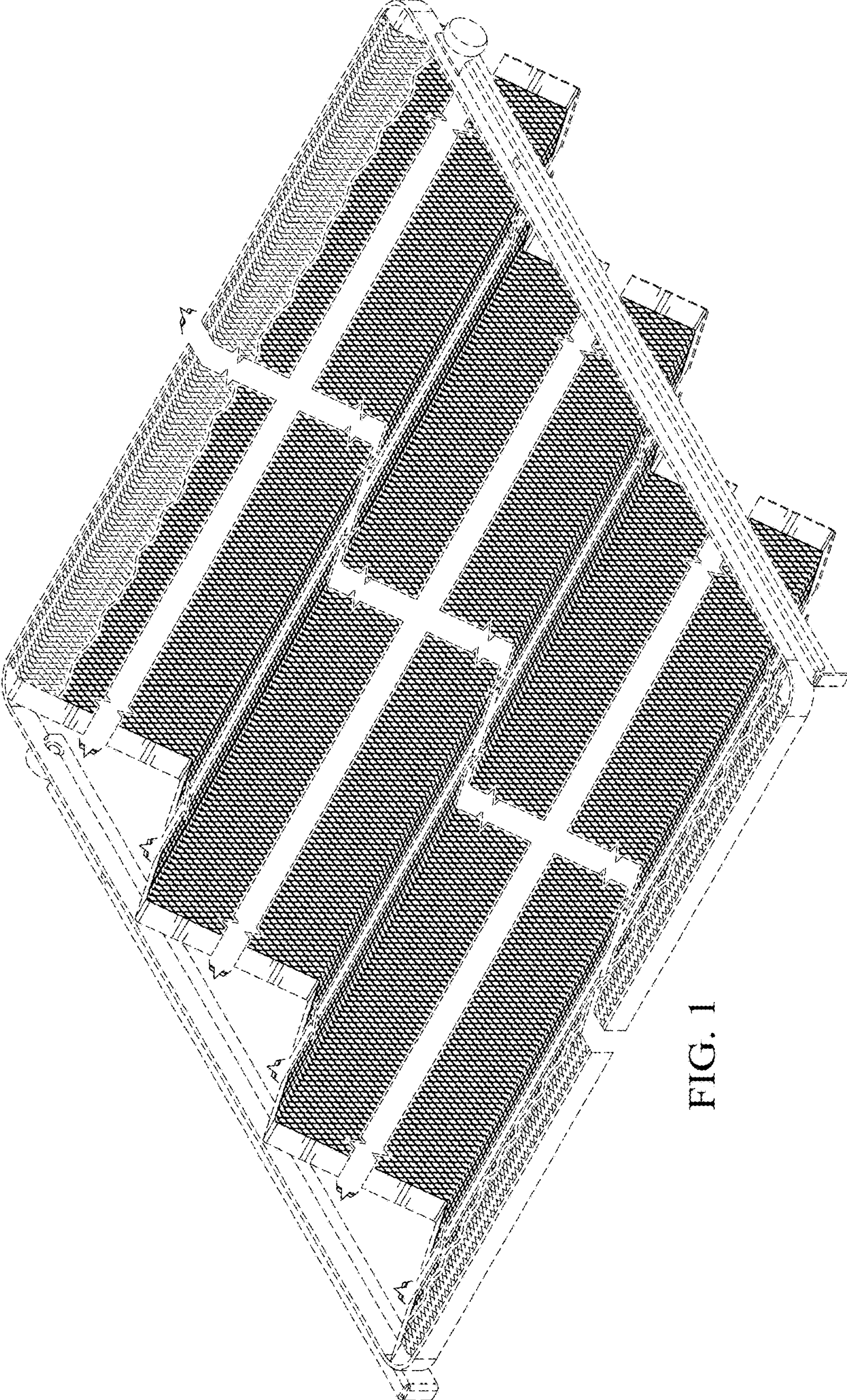

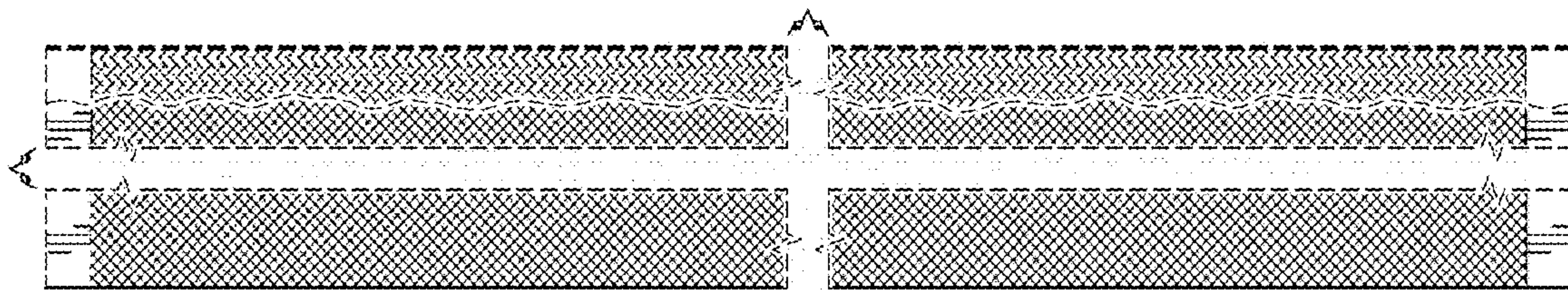

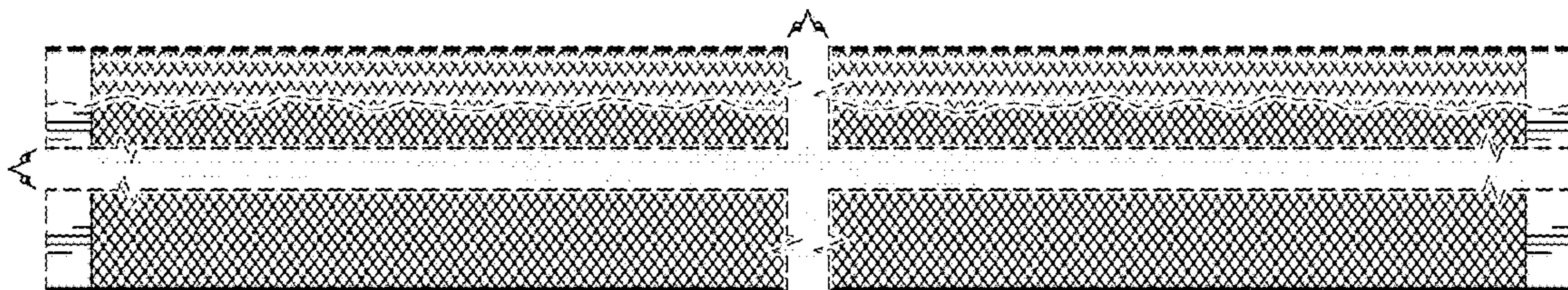

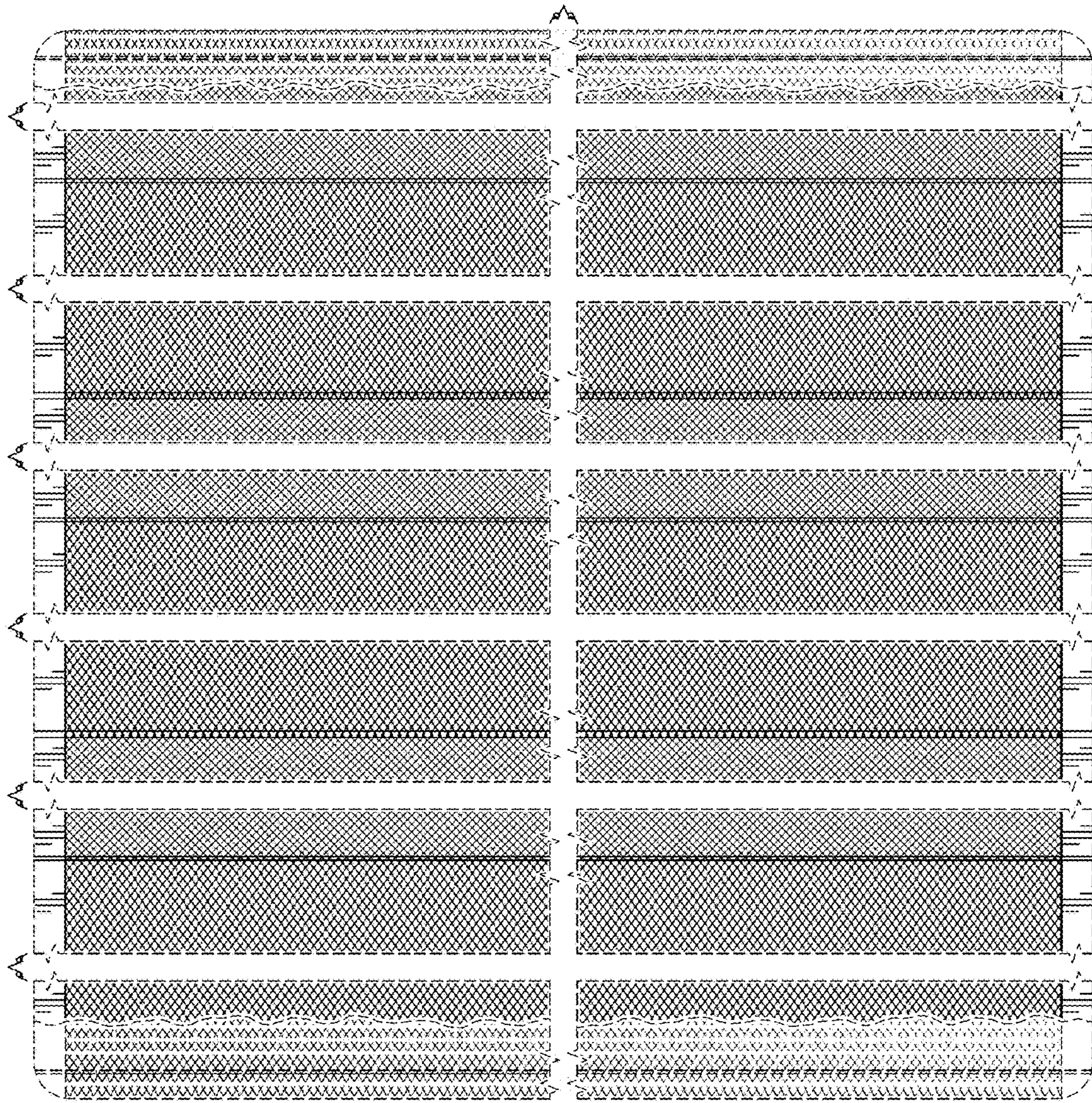

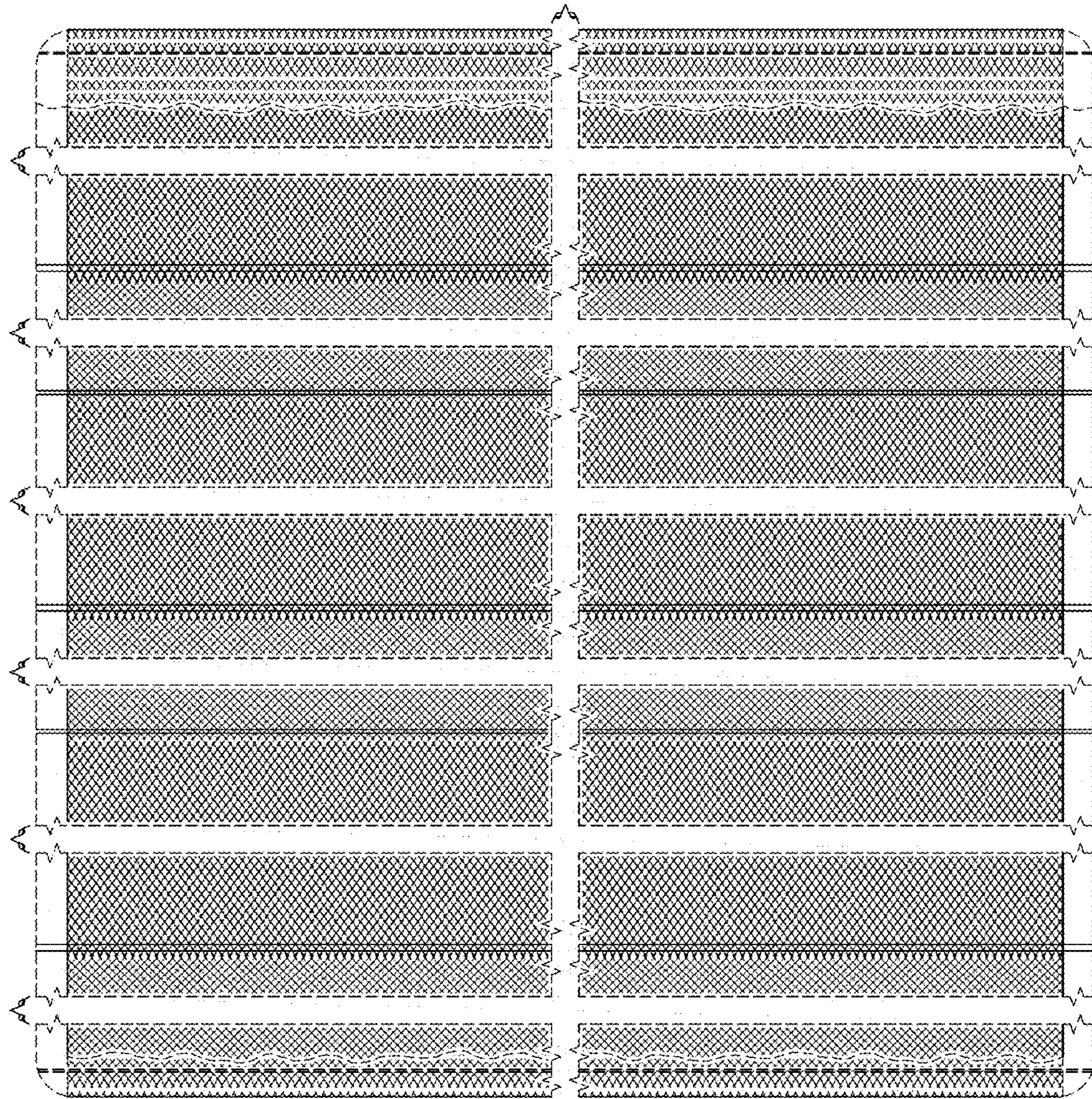

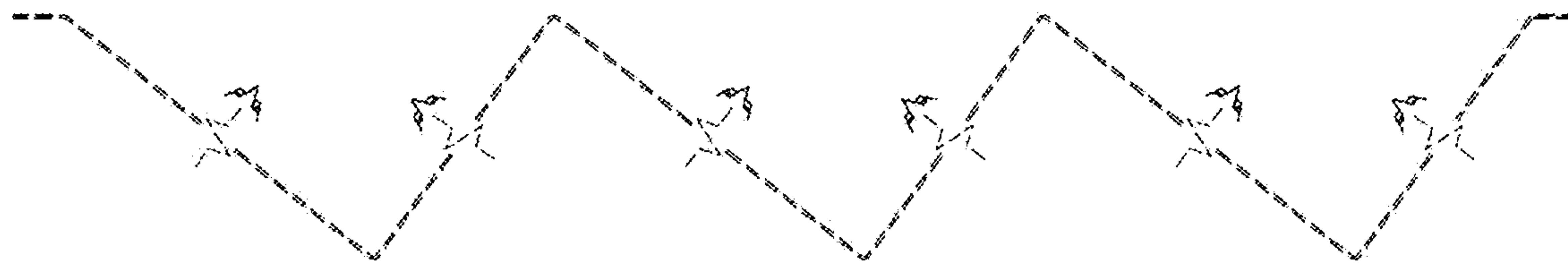

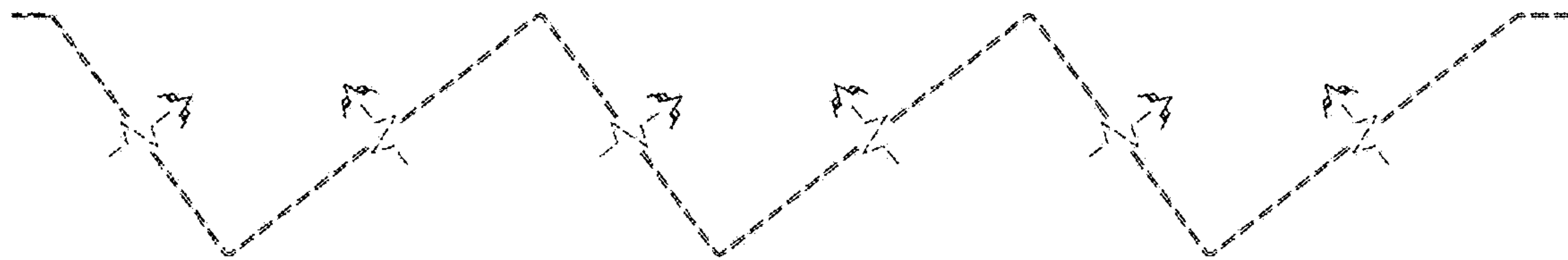

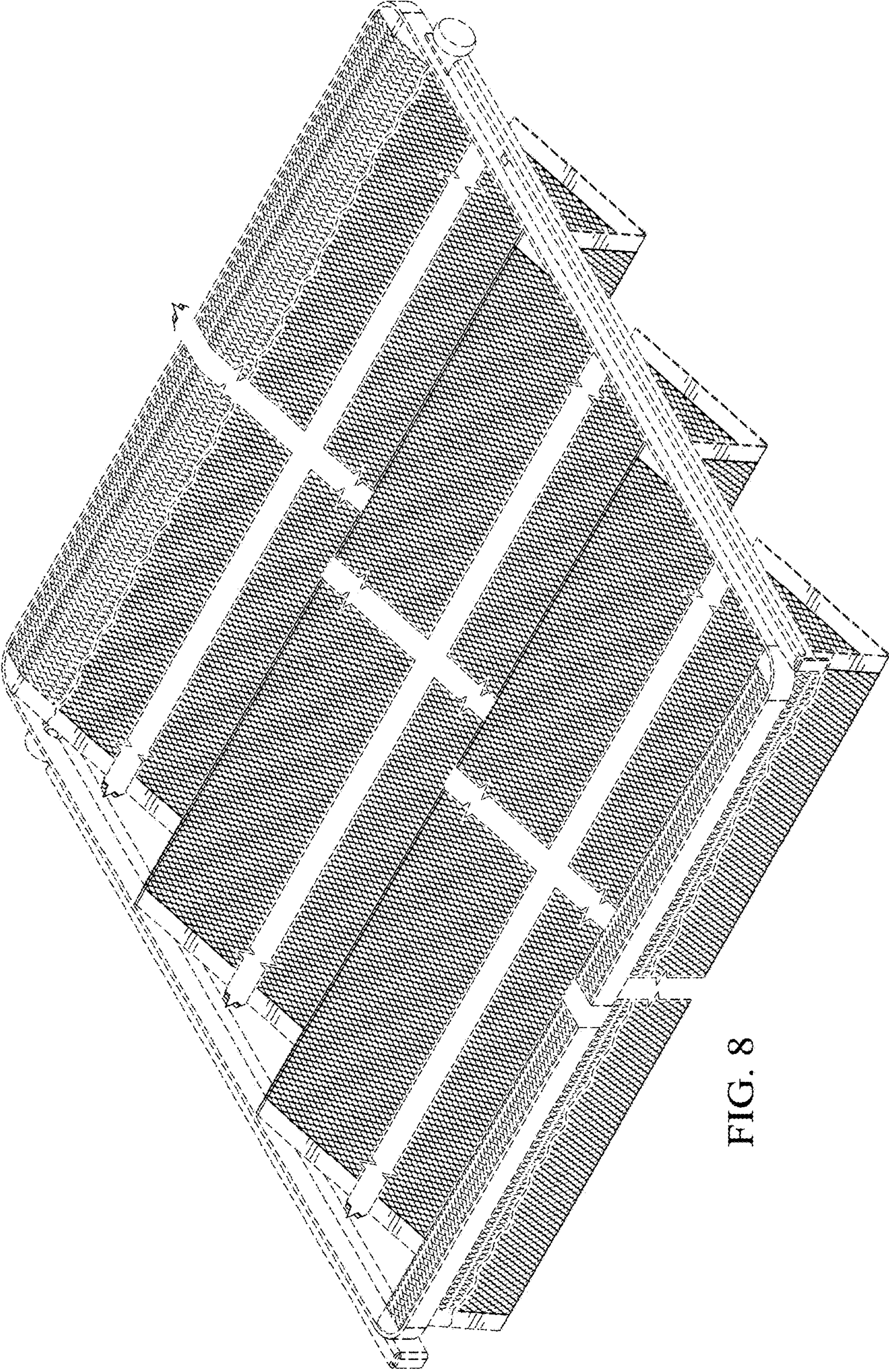

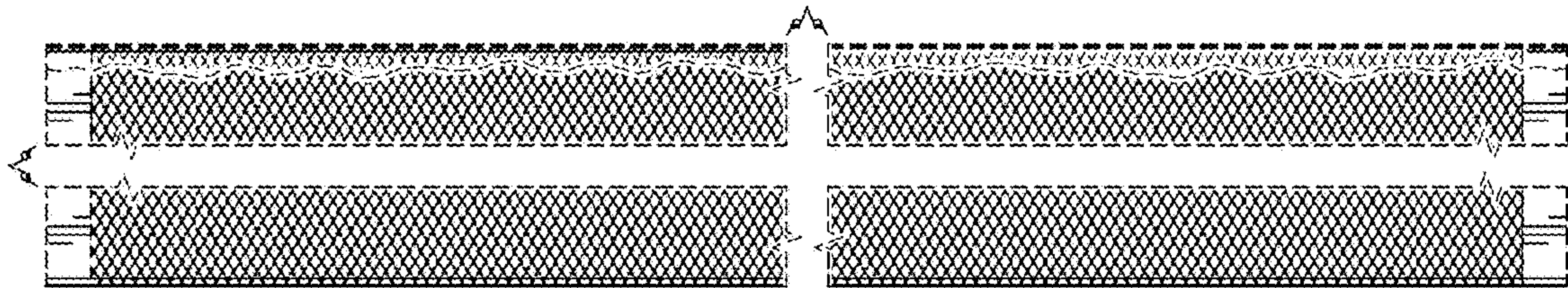

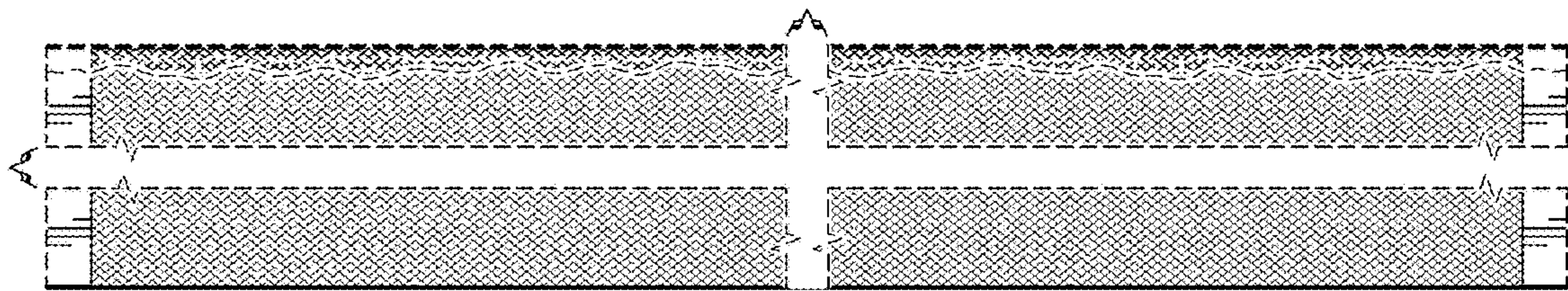

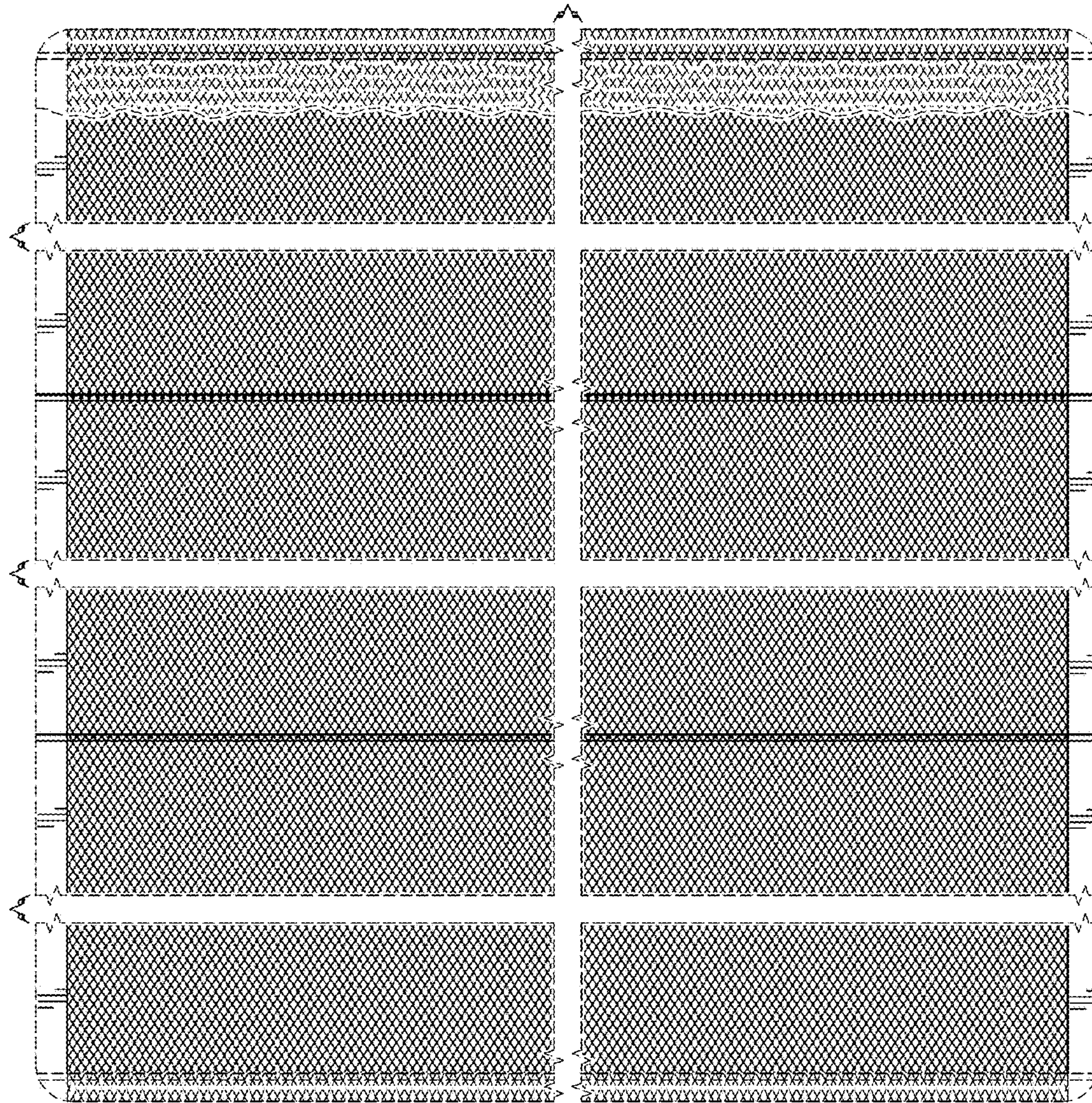

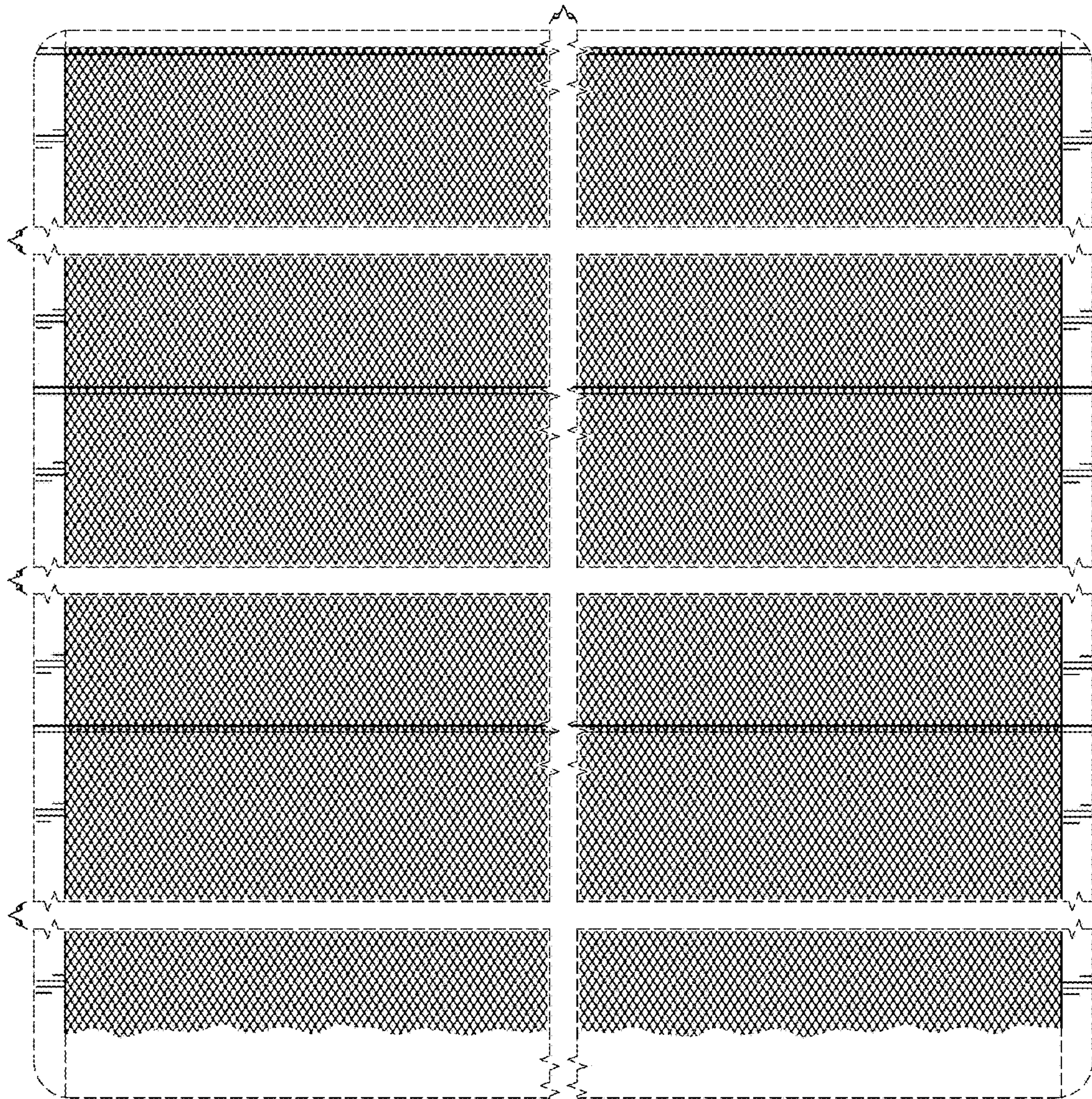

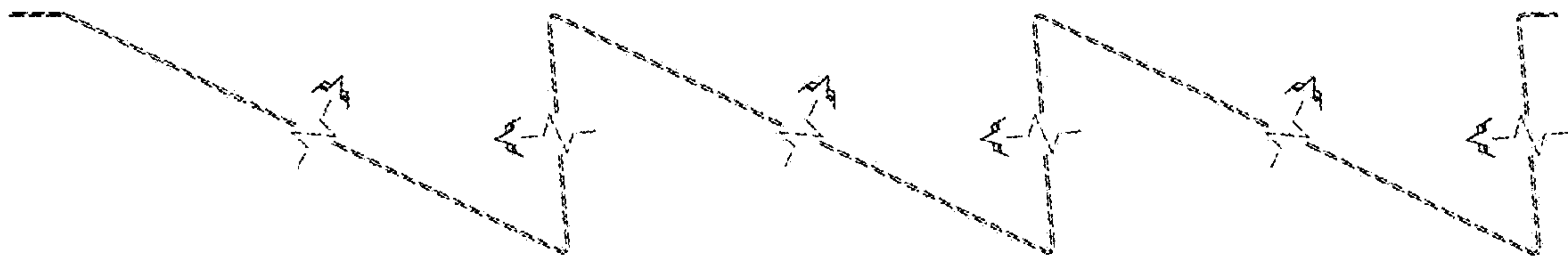

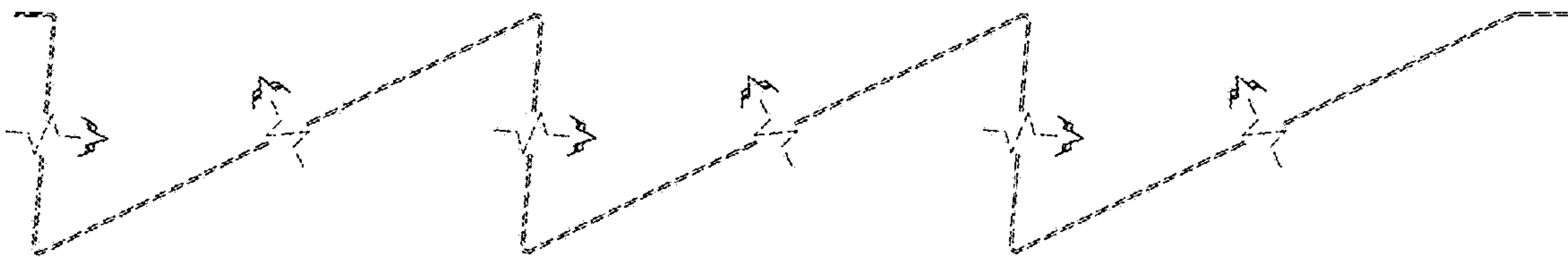

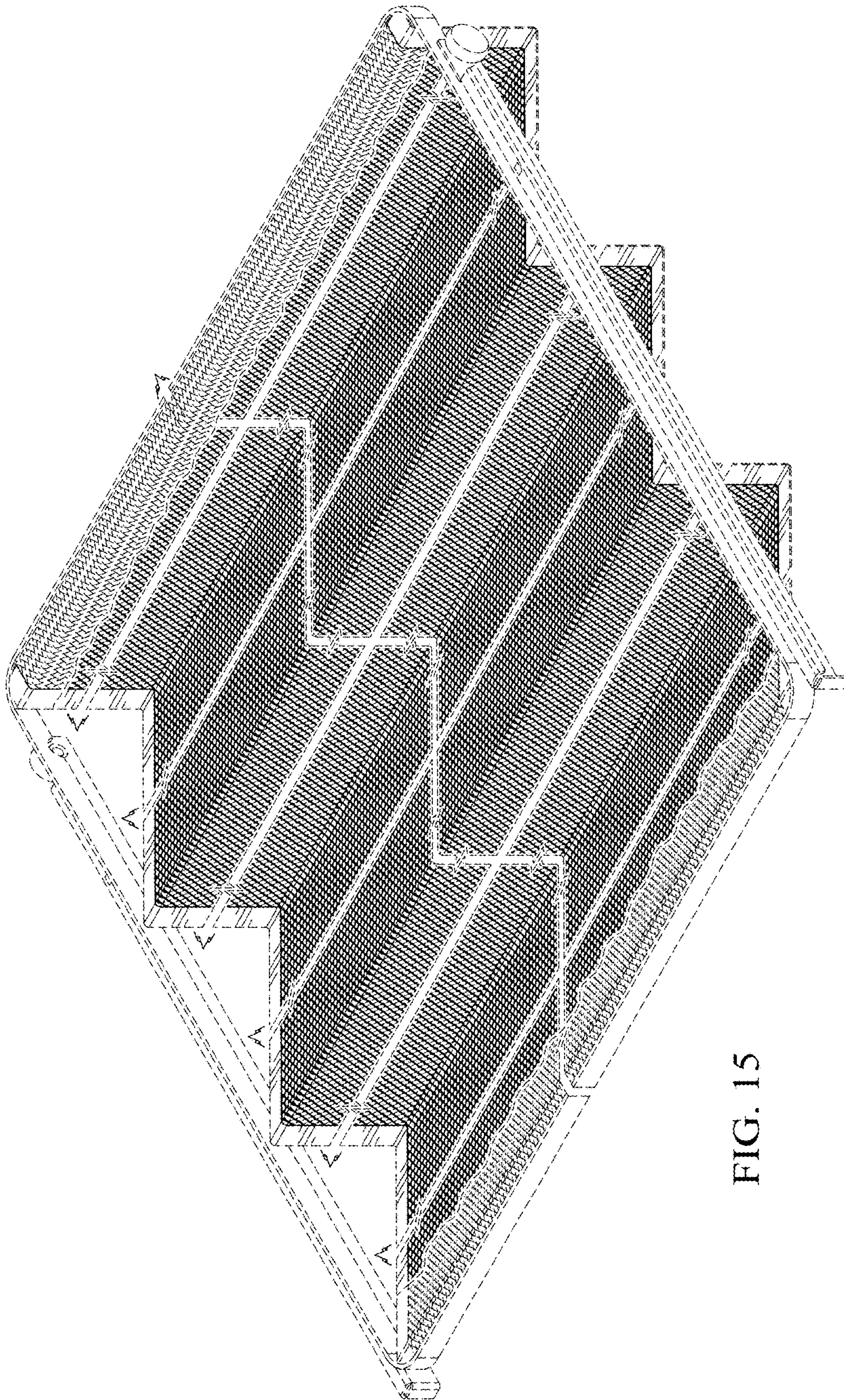

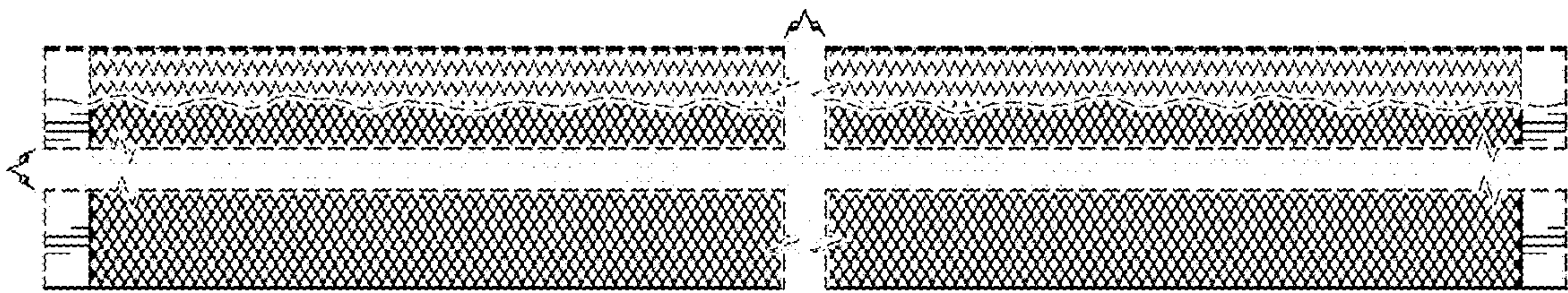

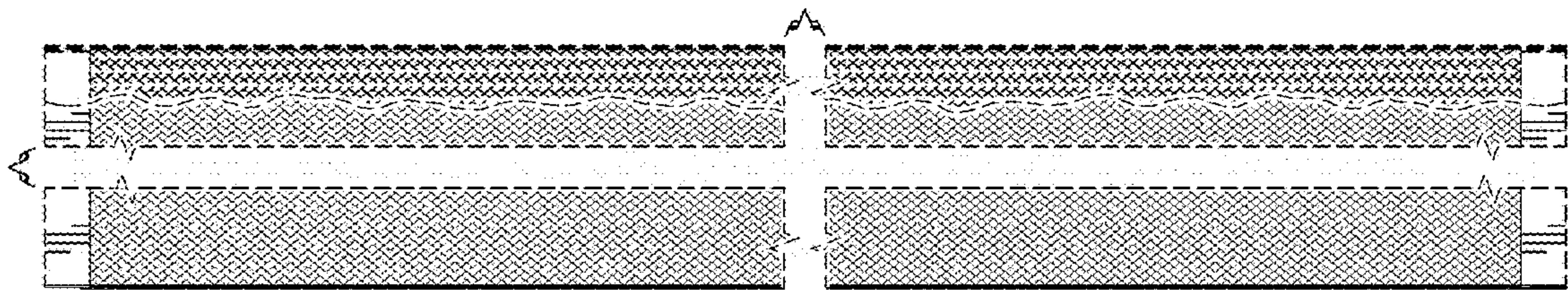

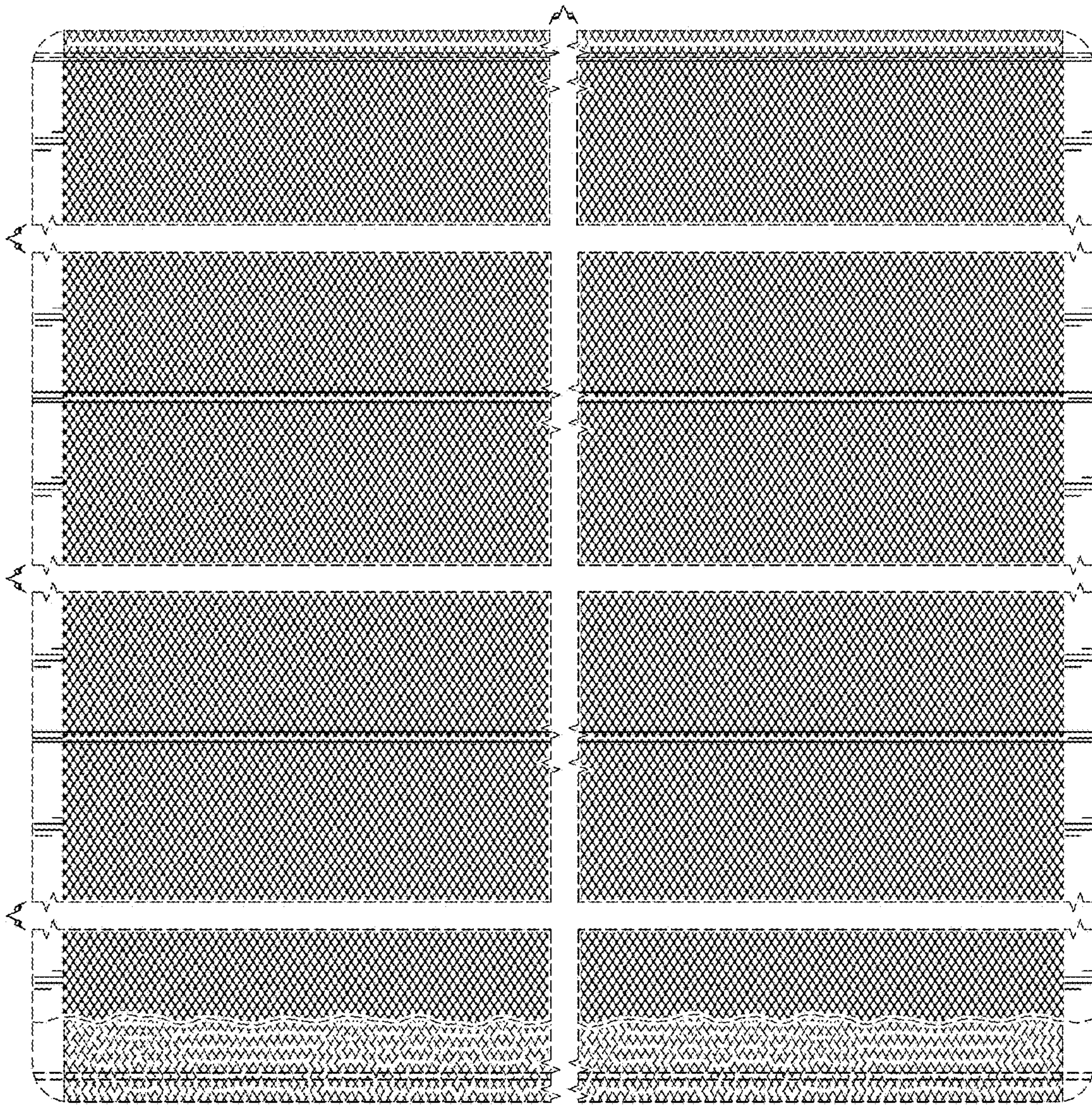

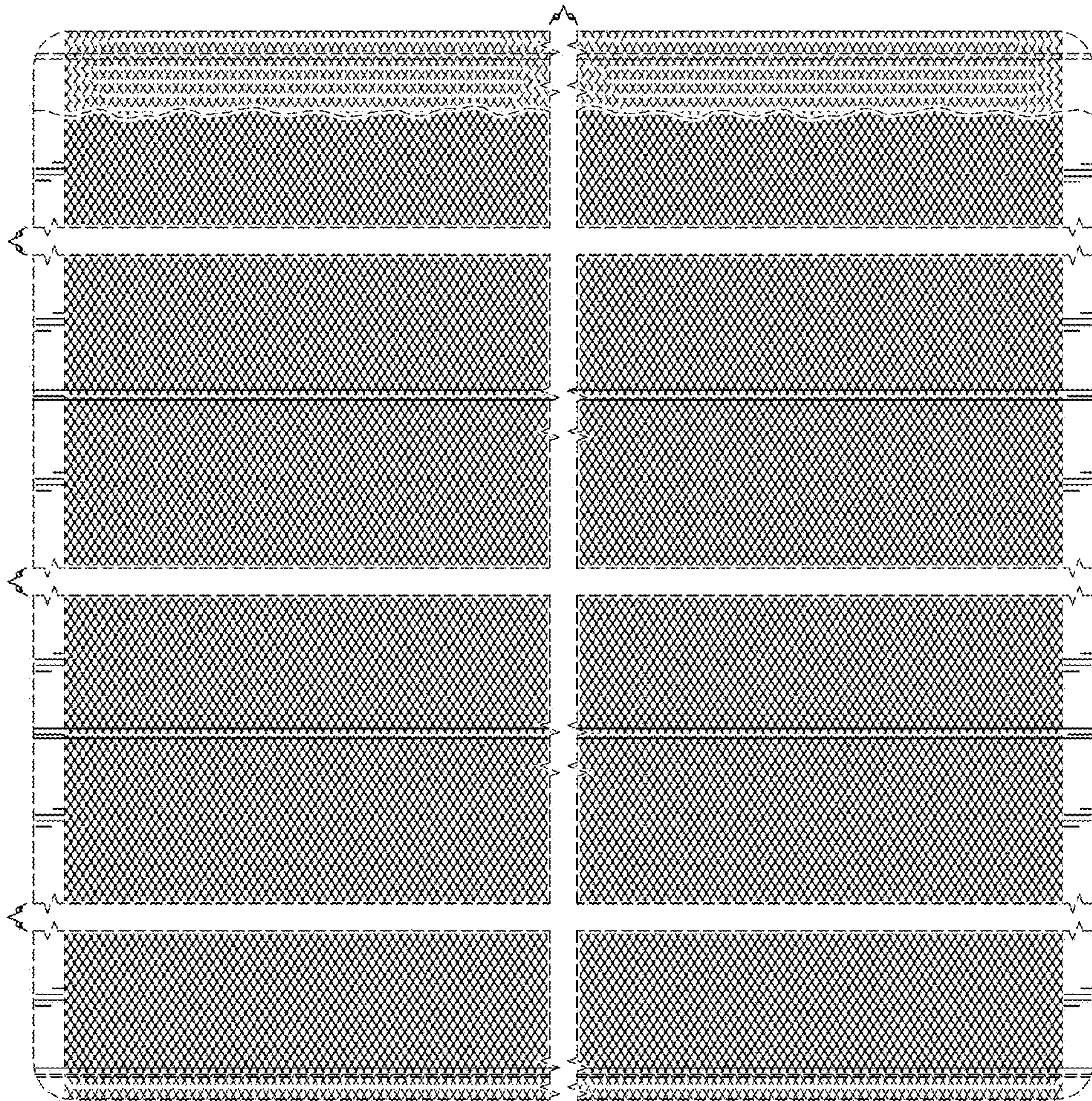

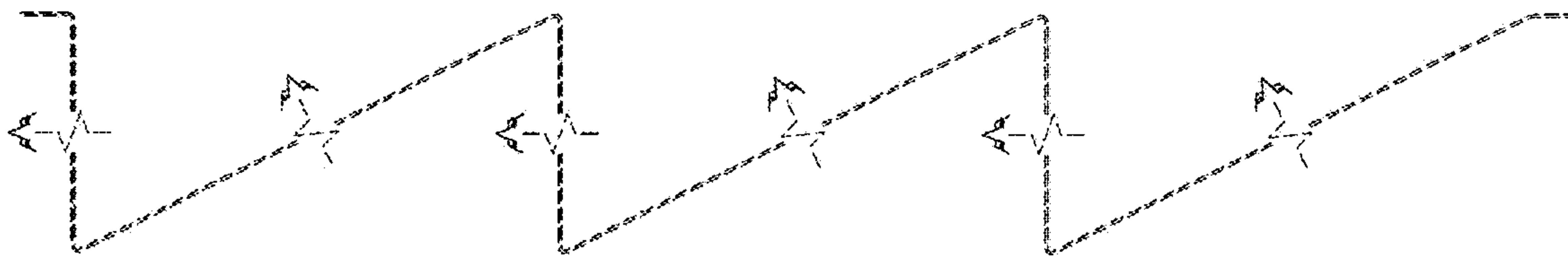

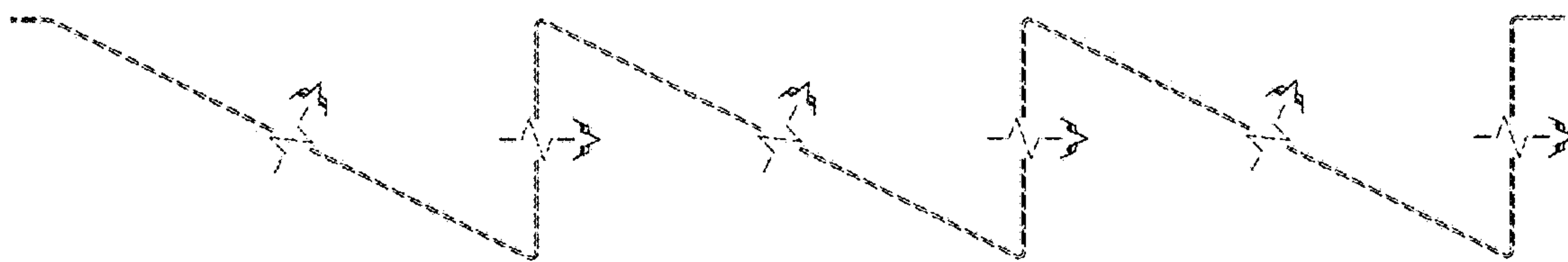

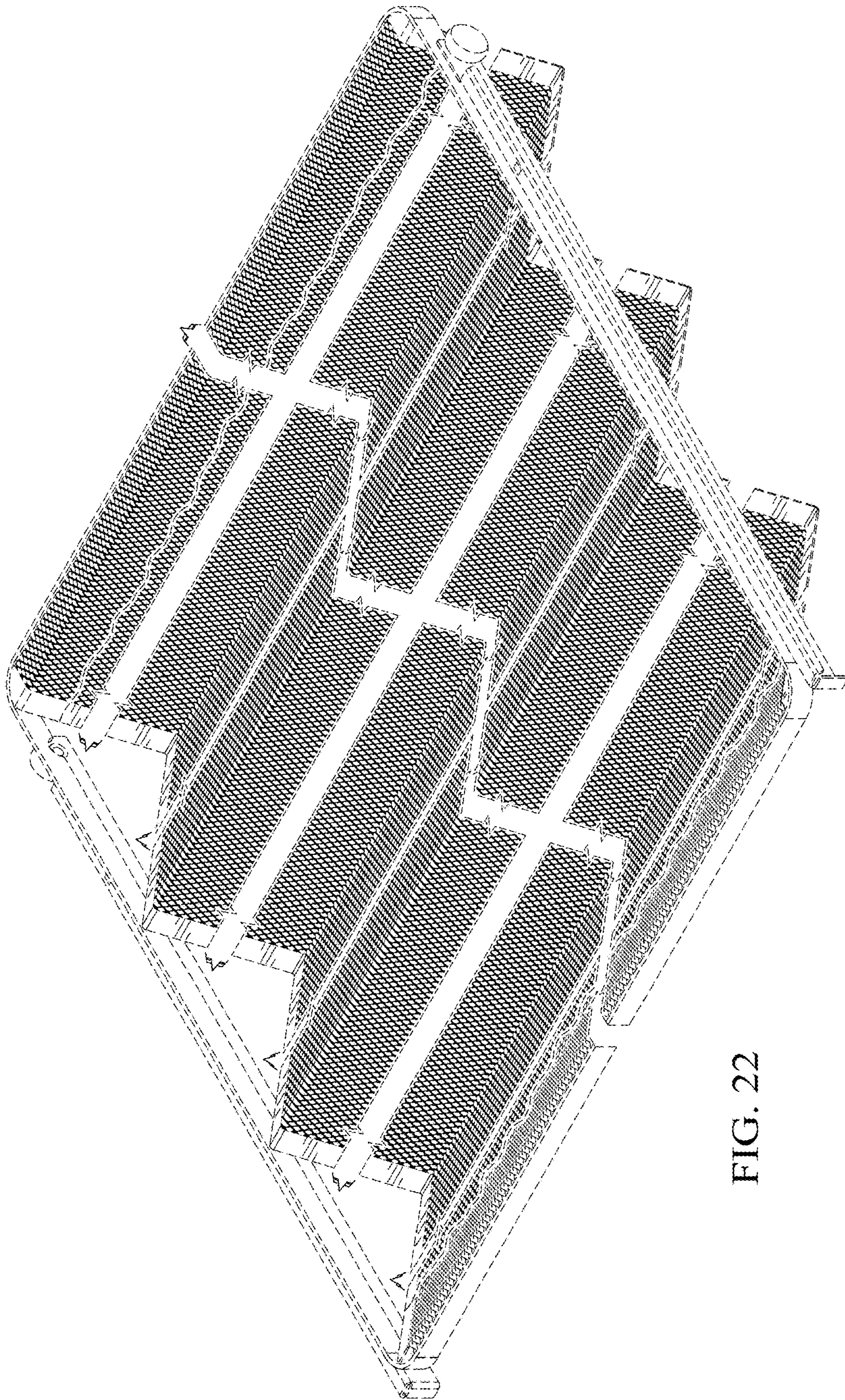

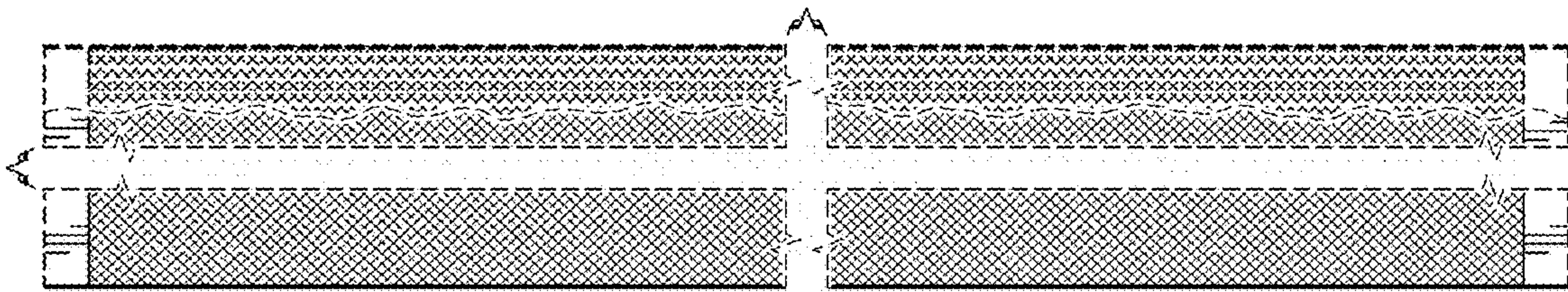

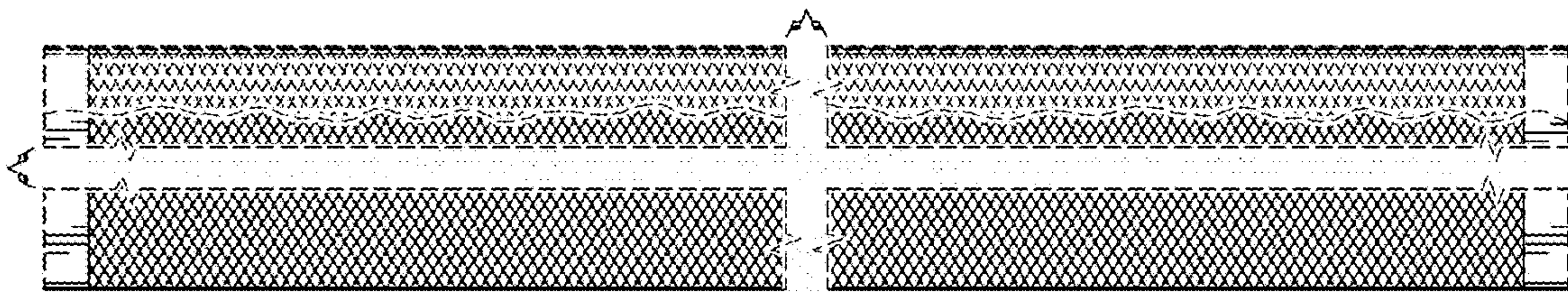

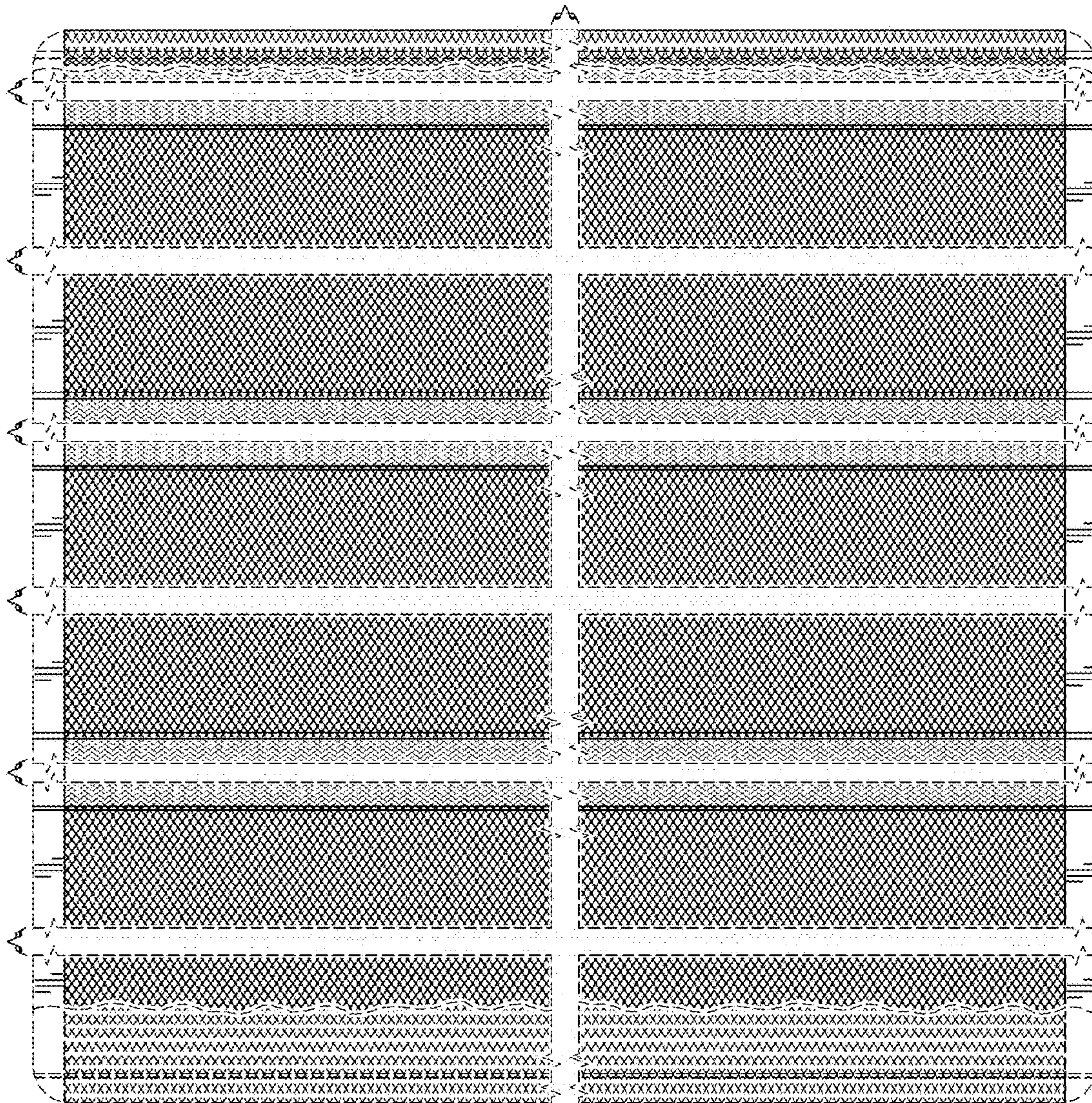

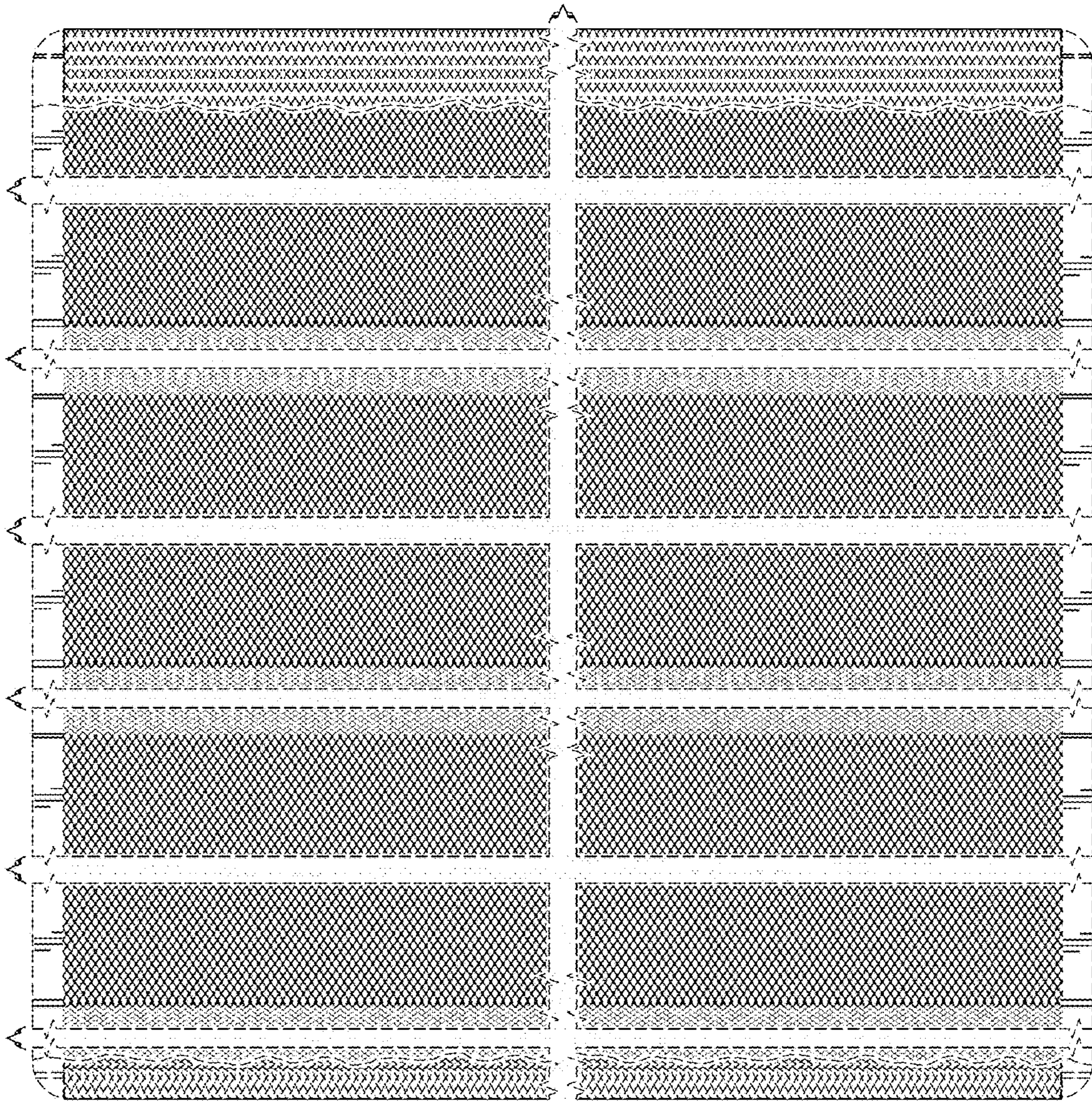

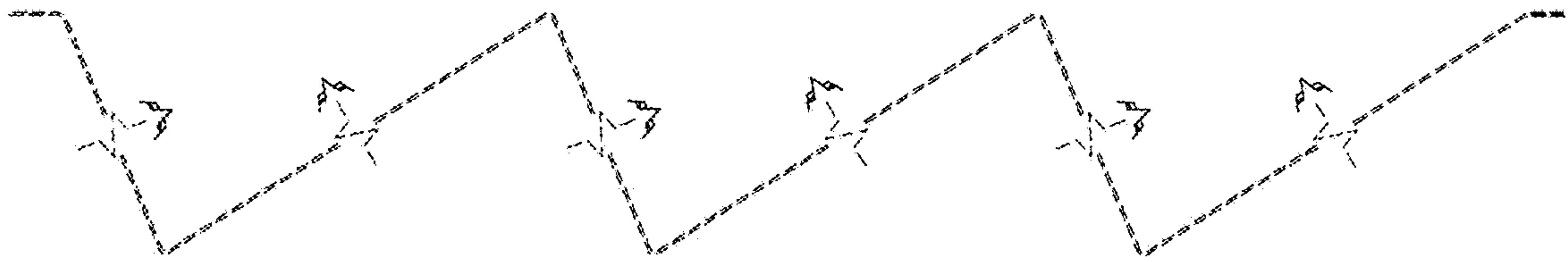

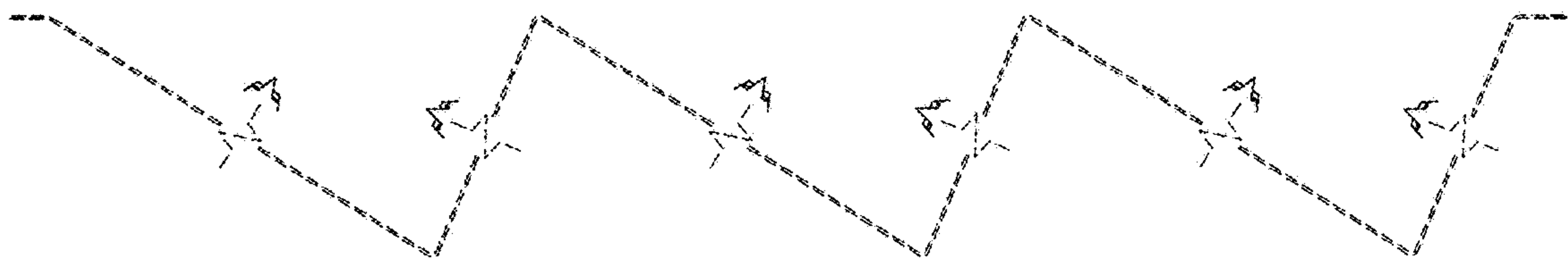
