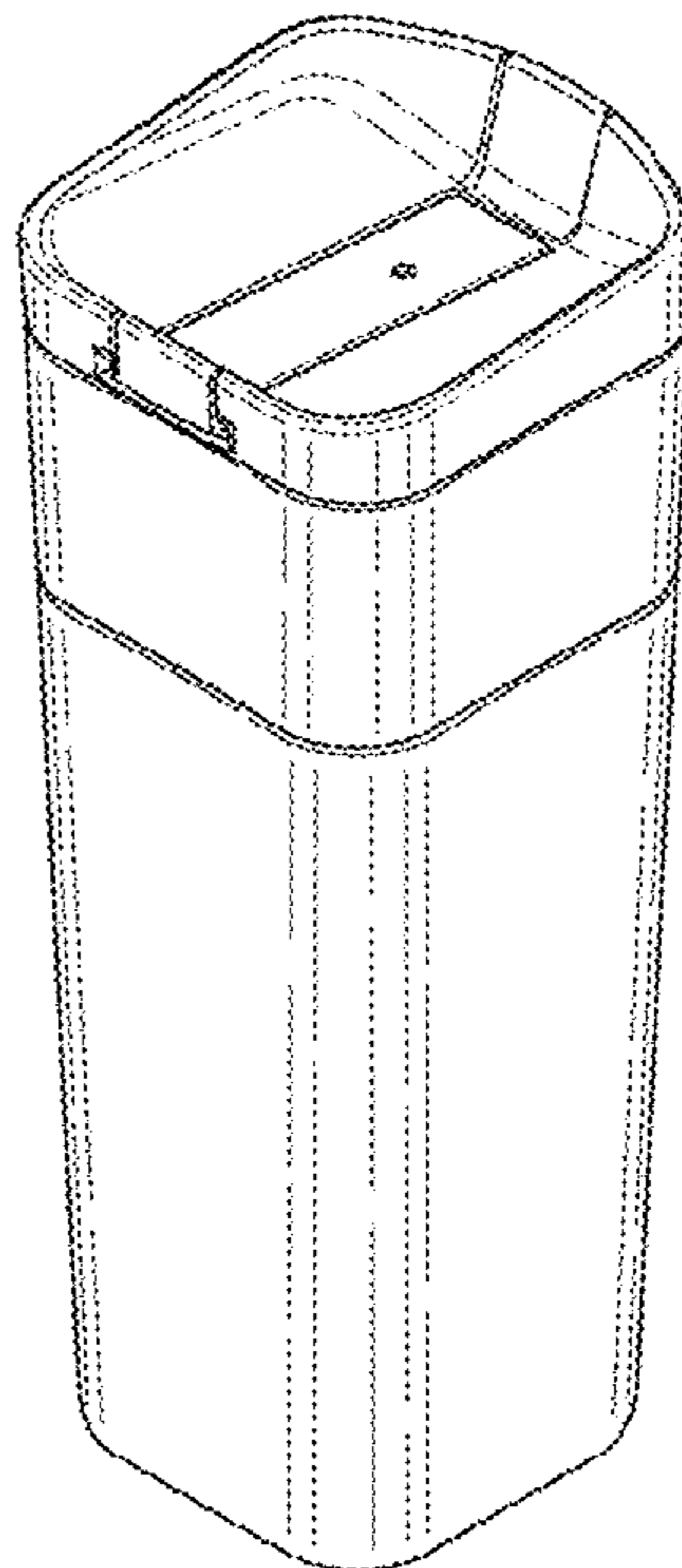
FIG. 1 is a perspective view of a beverage container showing our new design;

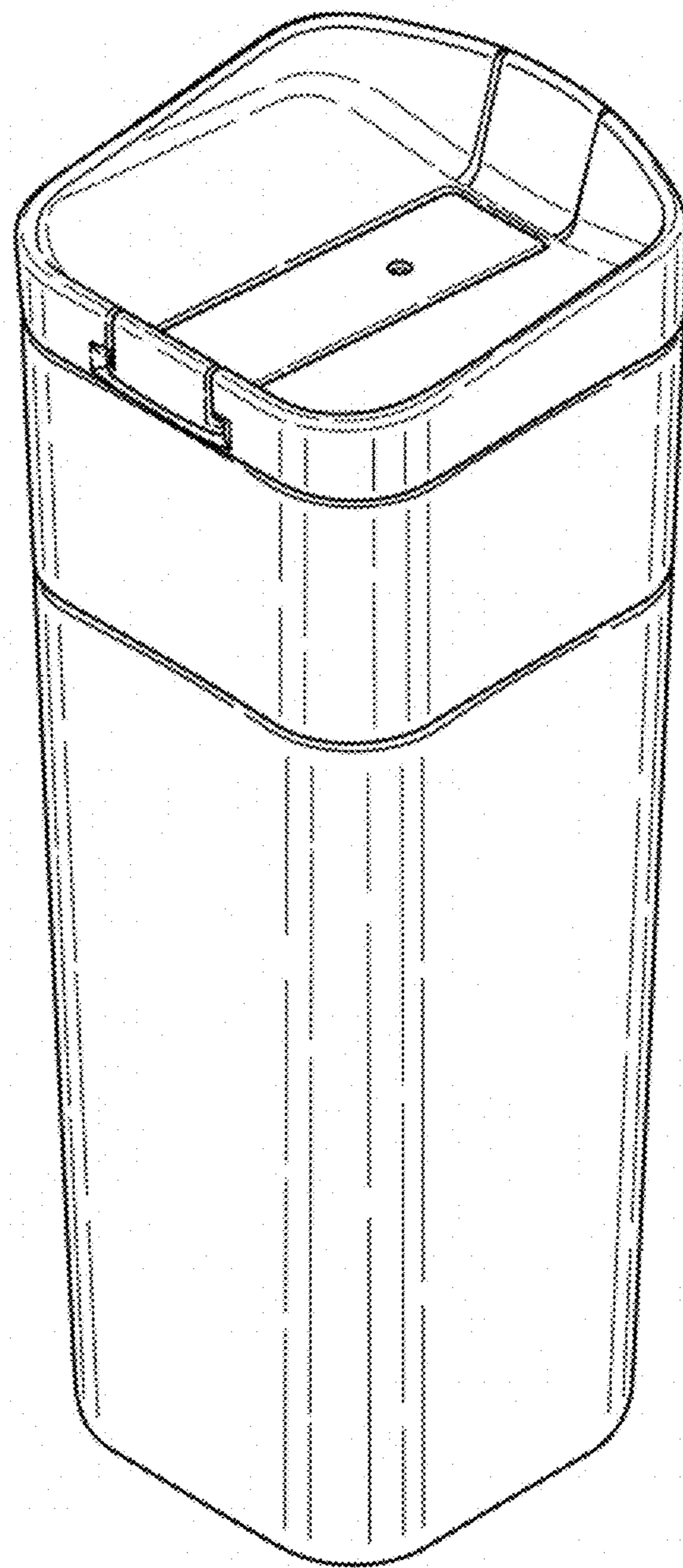

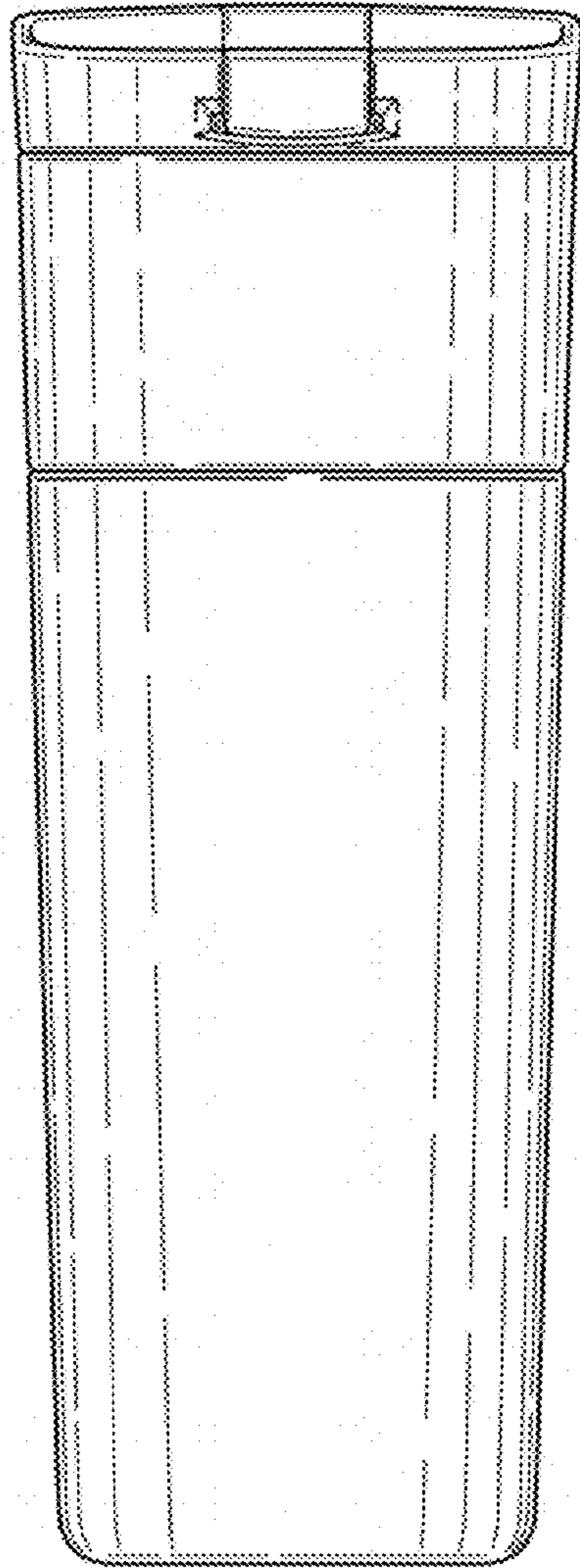

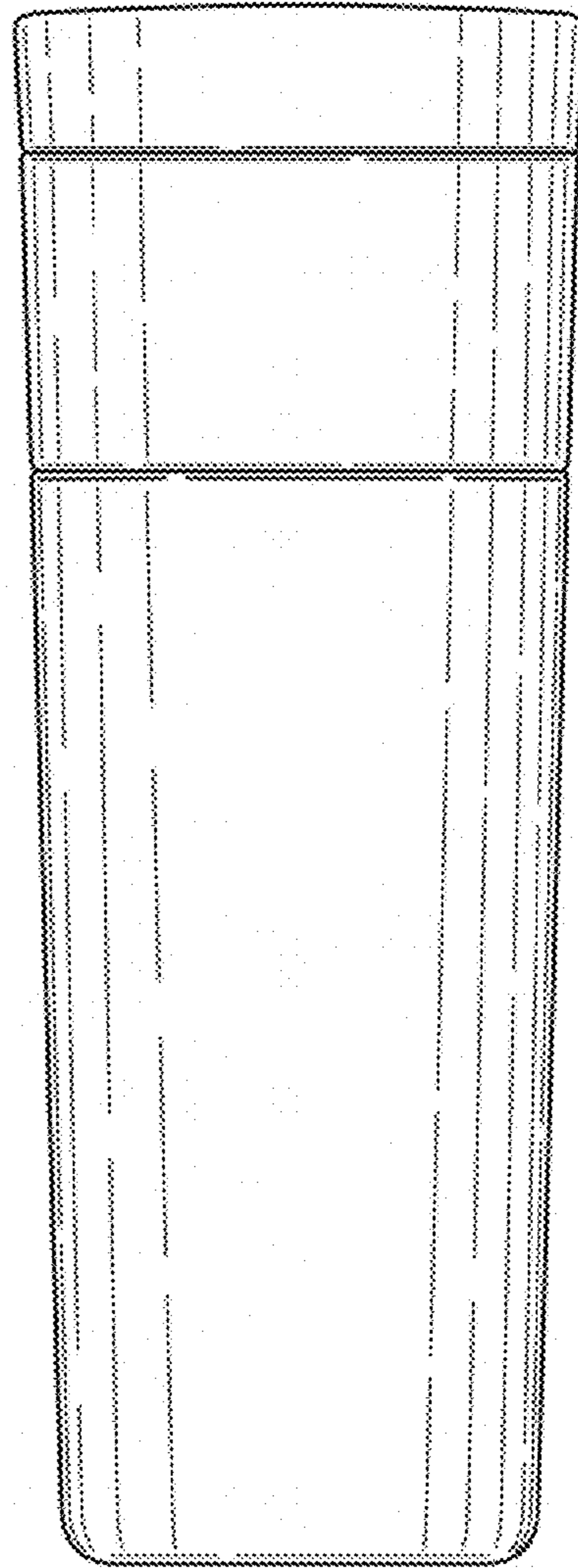

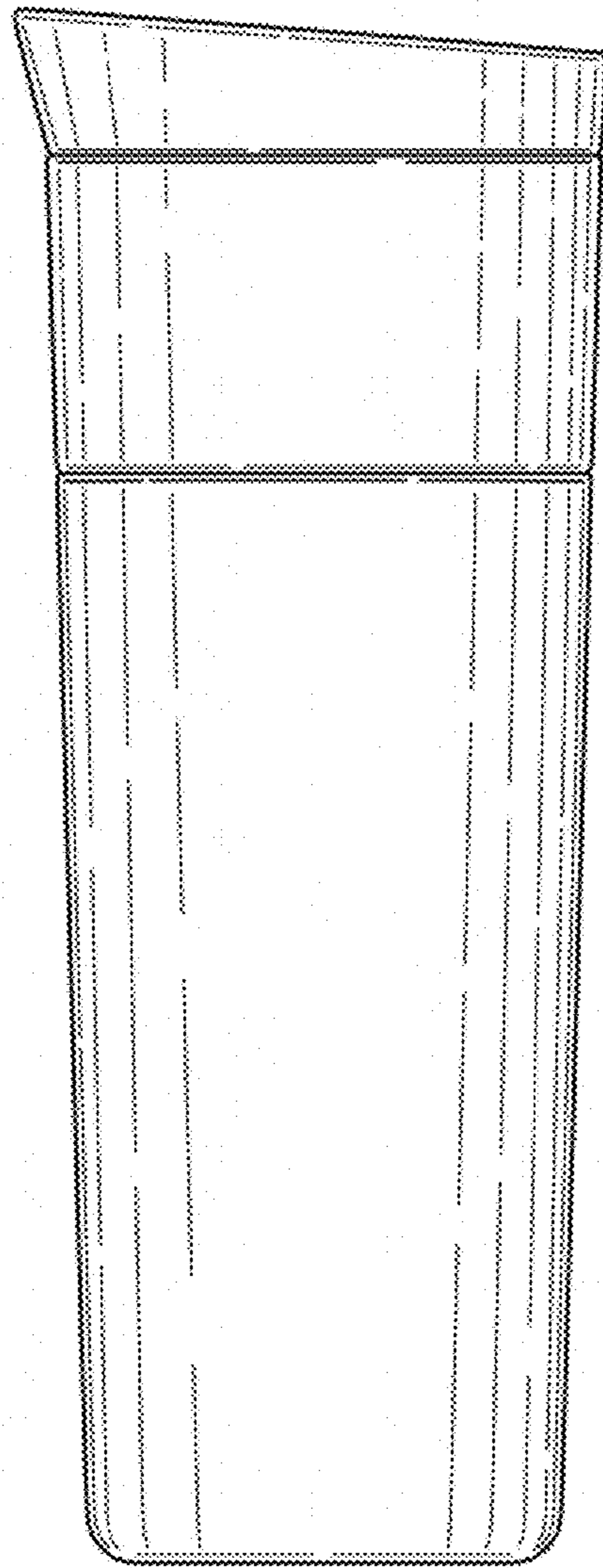

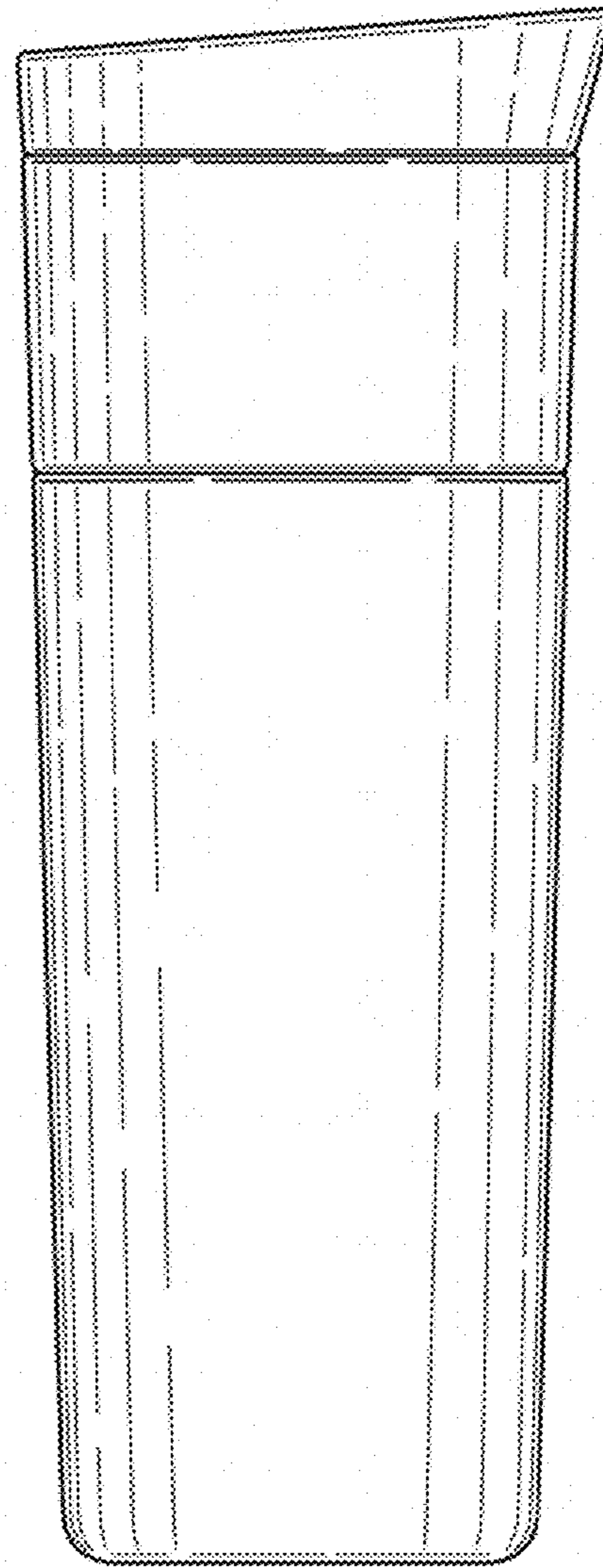

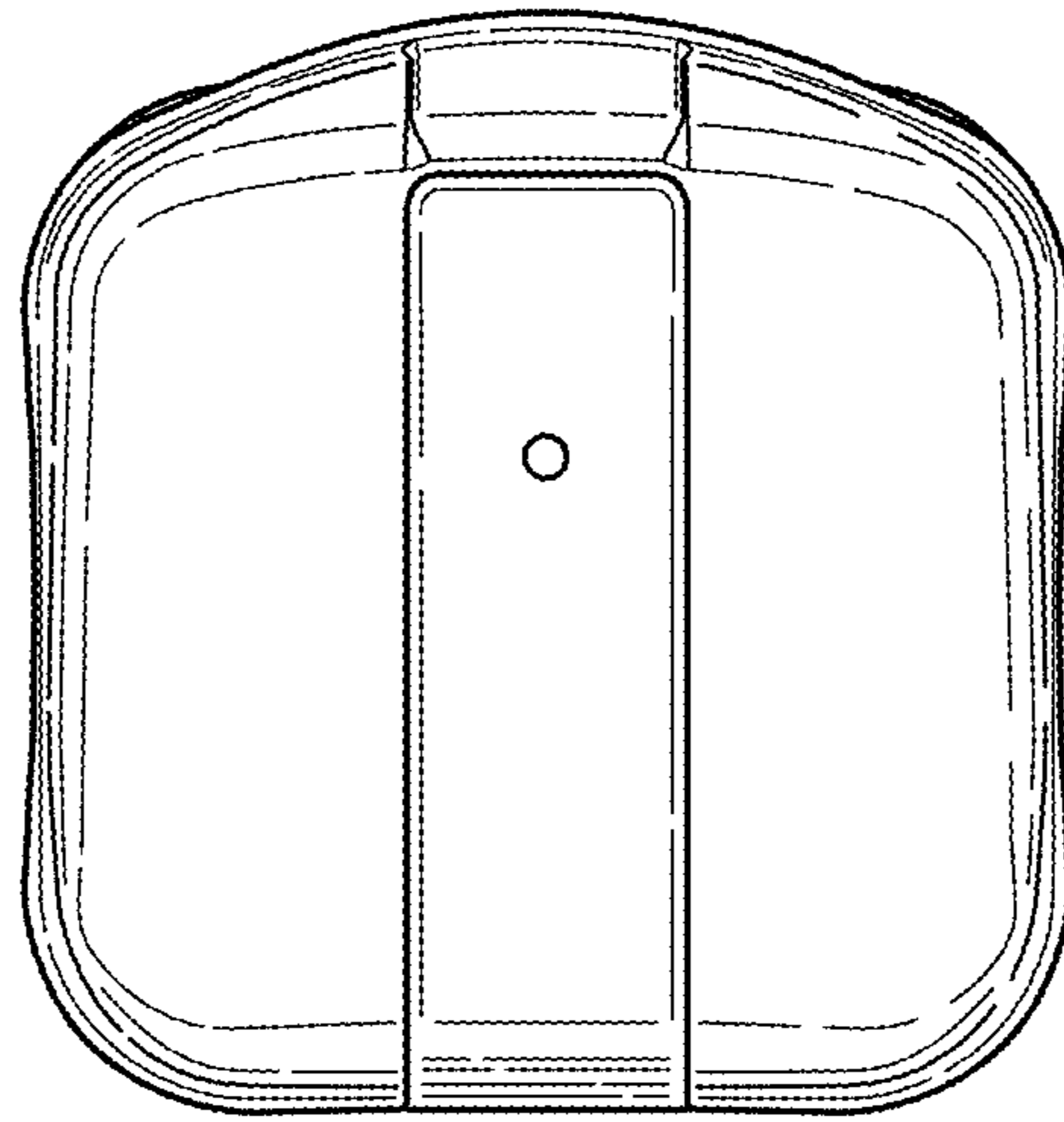

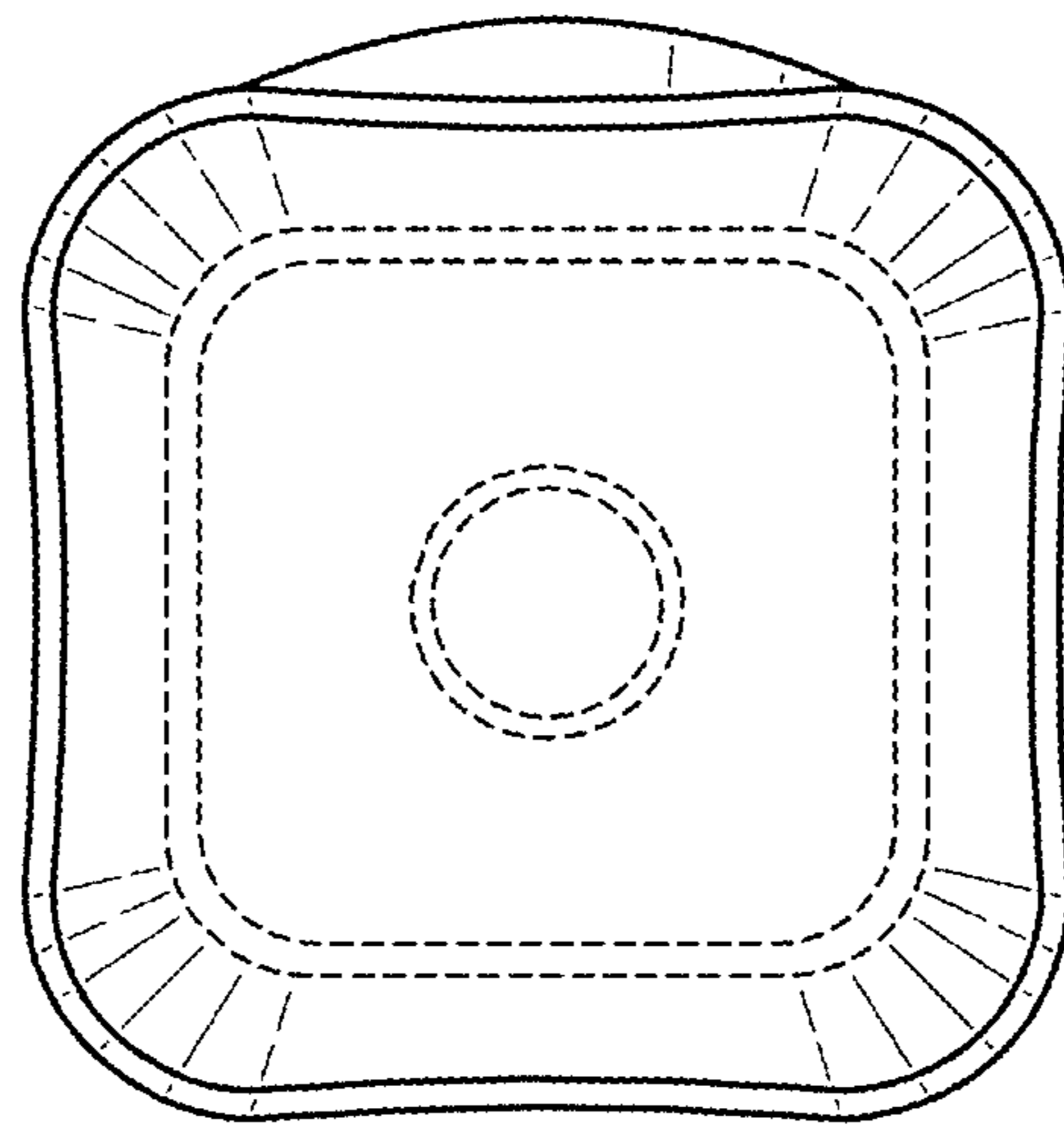

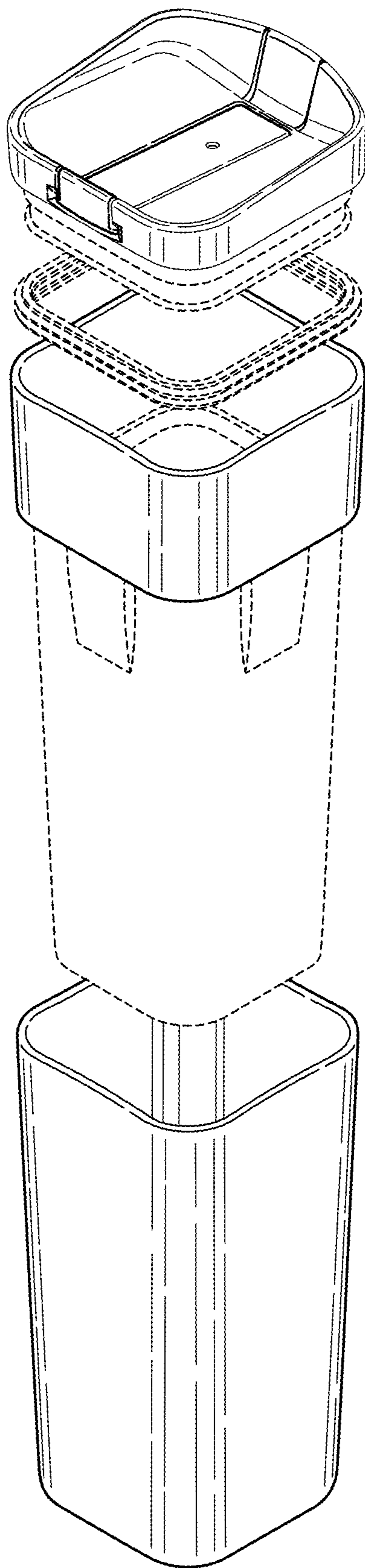
