The ornamental design for the light bulb changer head, as shown and described.

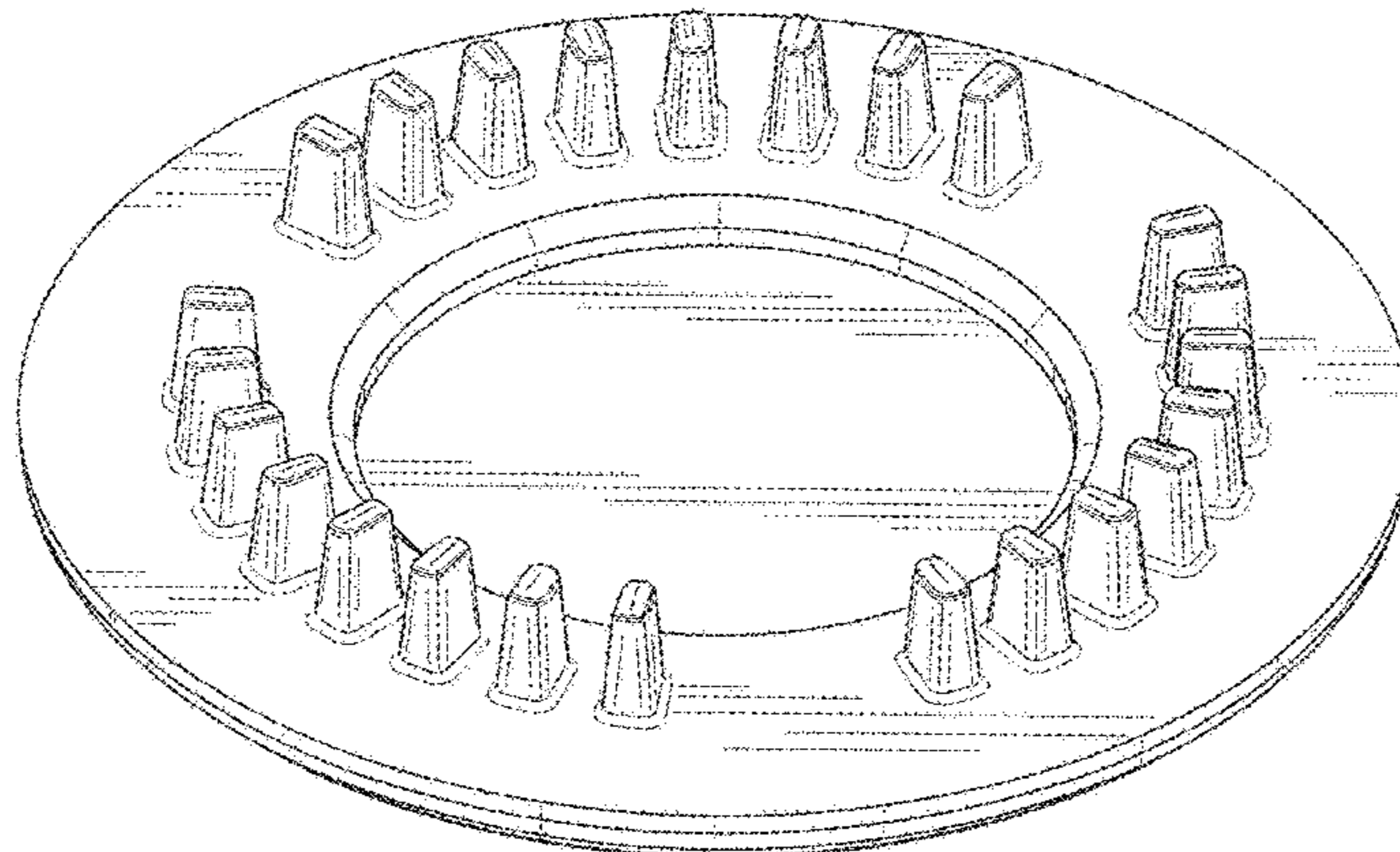
**DESCRIPTION**

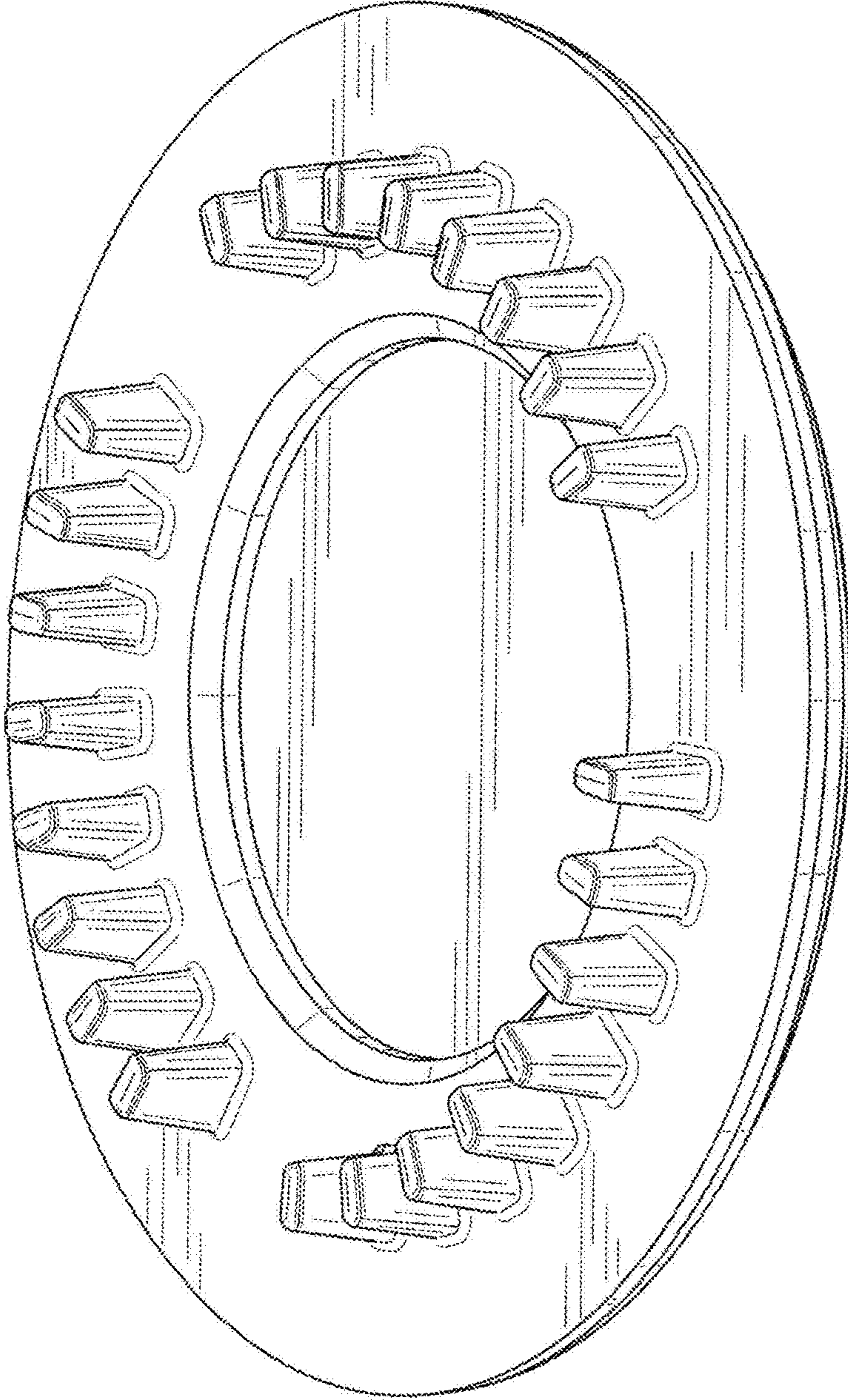

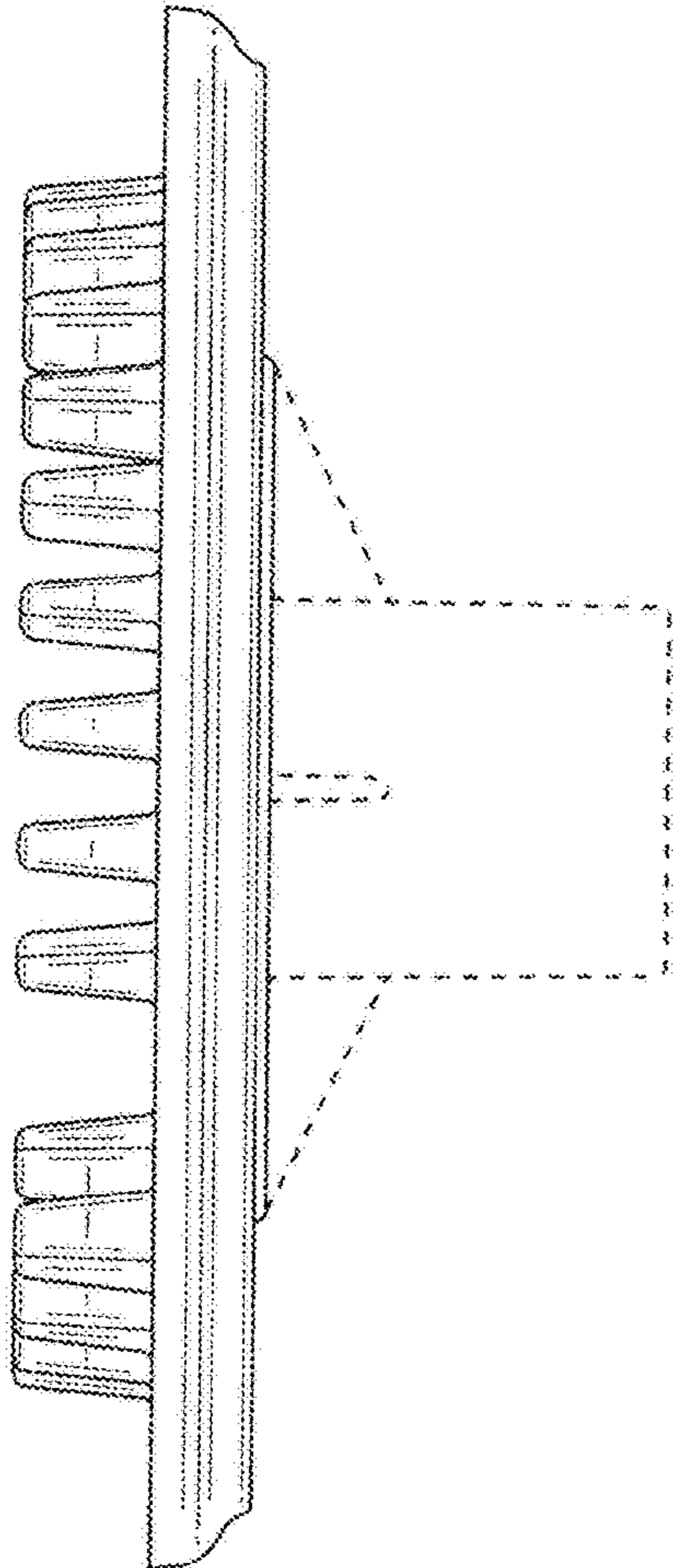

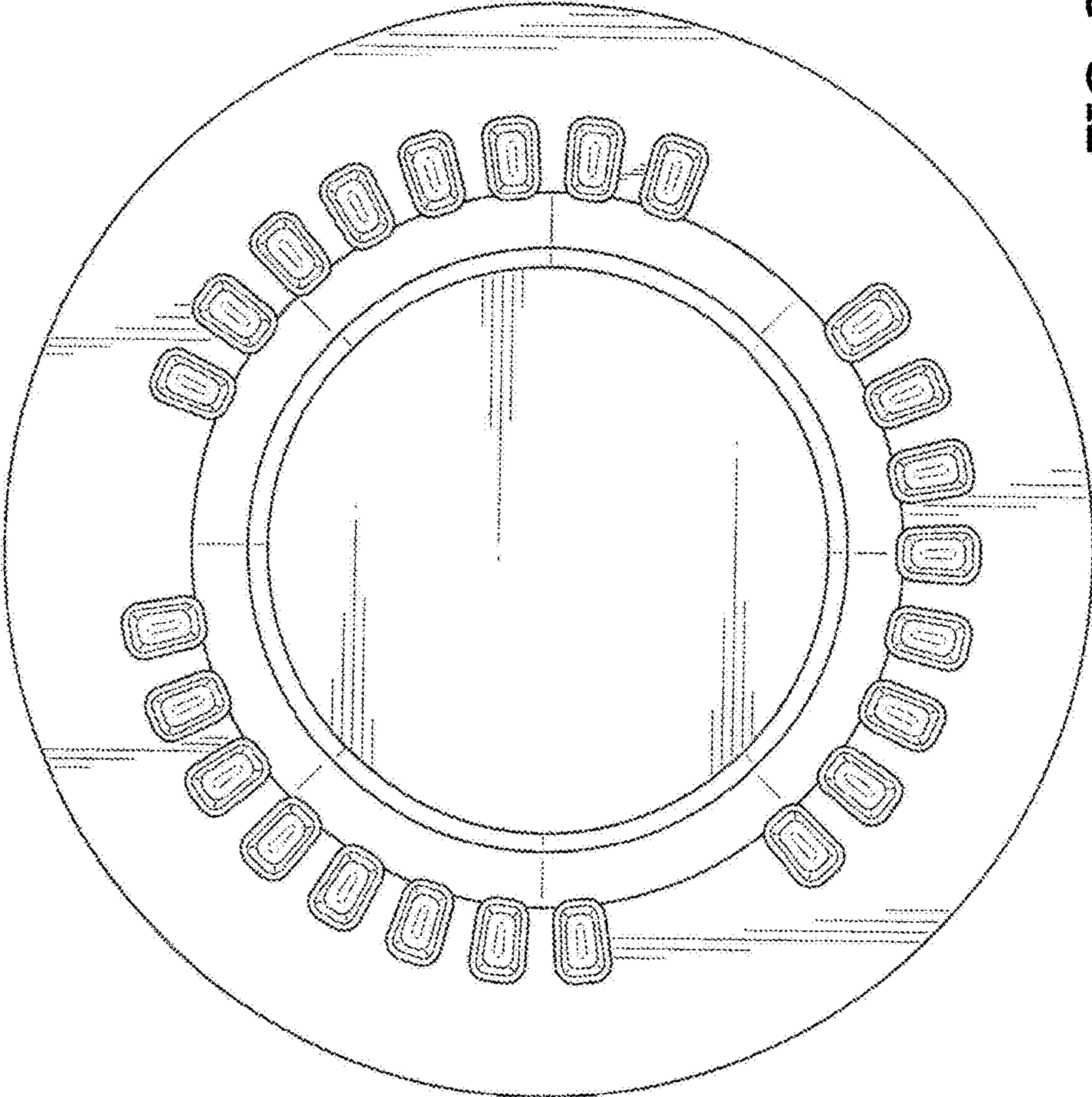

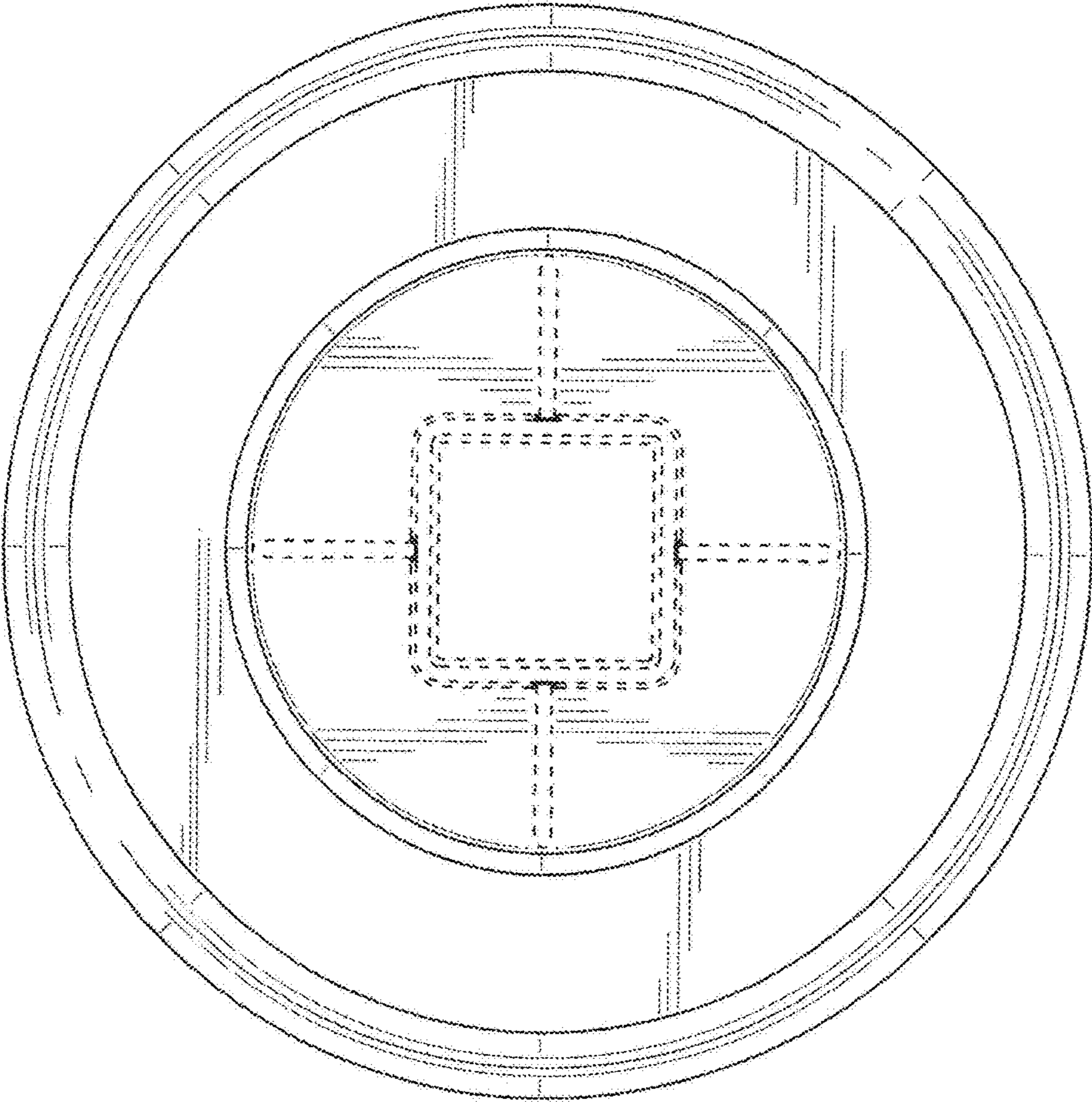
