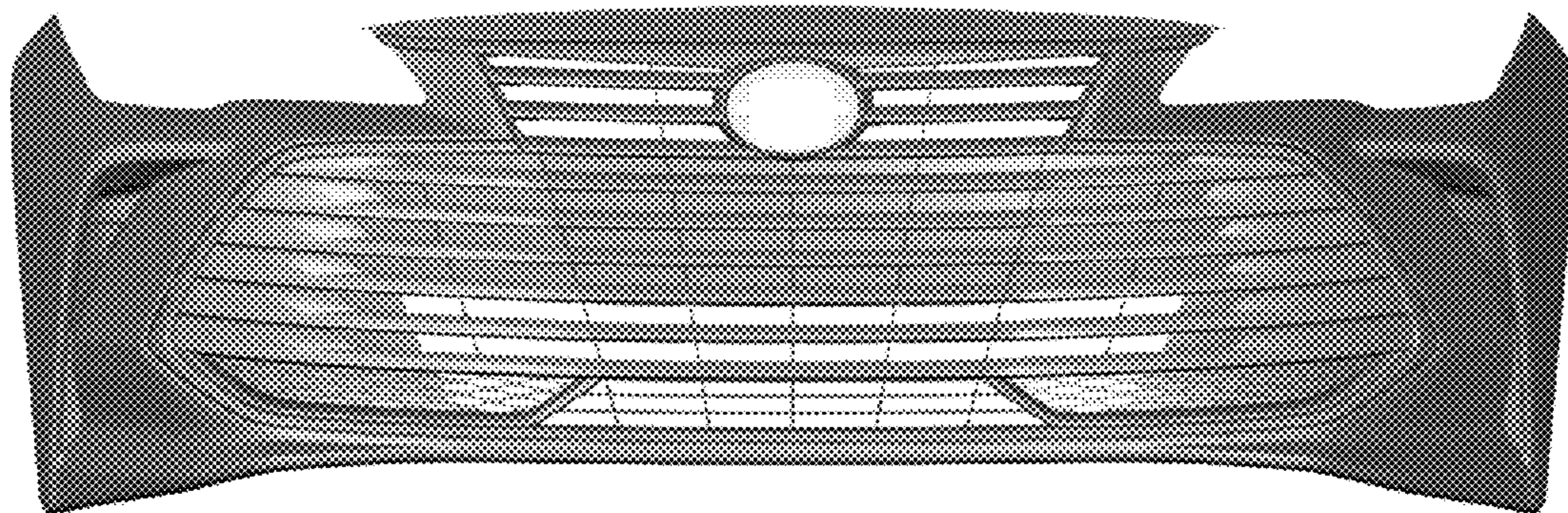
FIG. 1 is a perspective view of a front bumper for an automobile showing our new design;

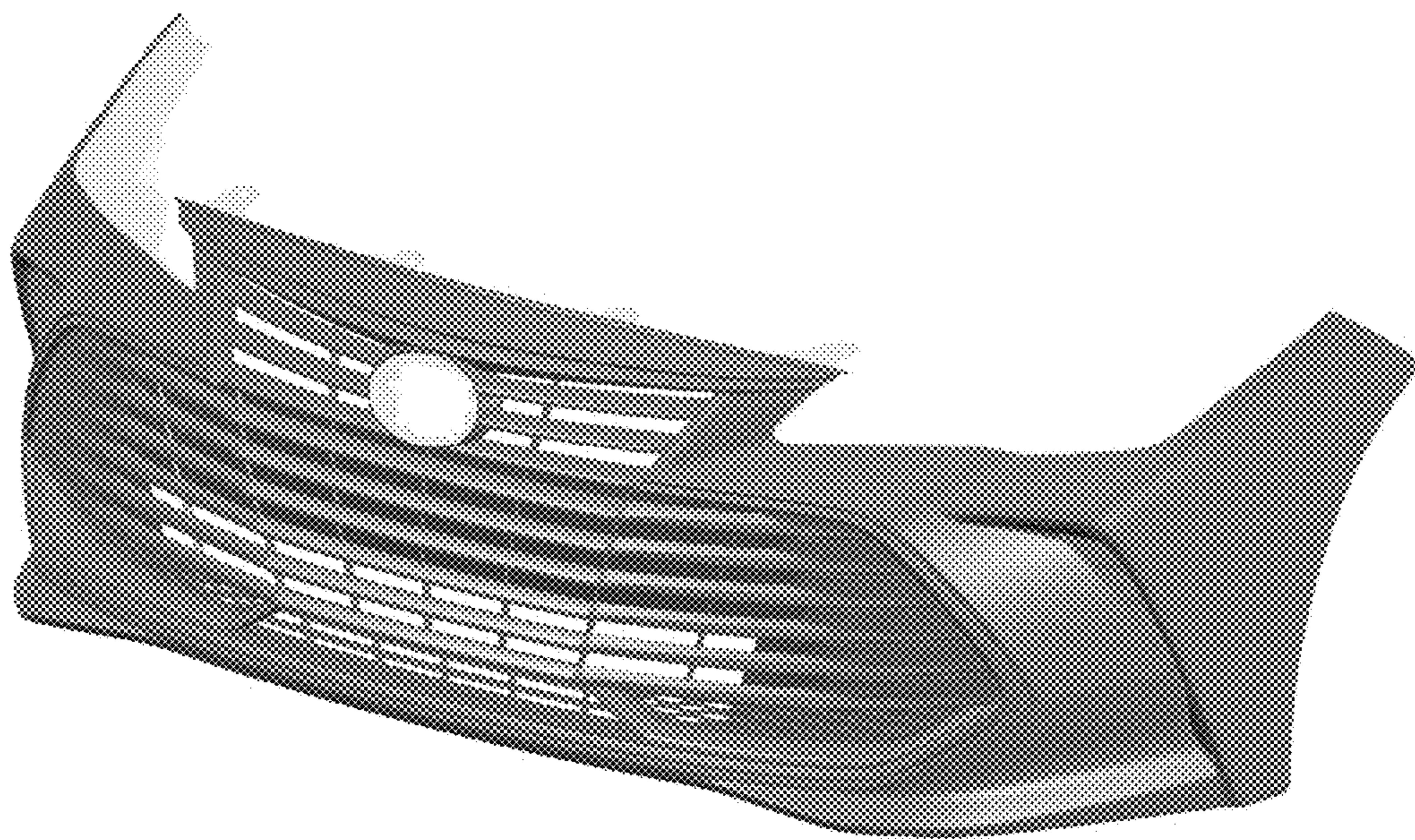

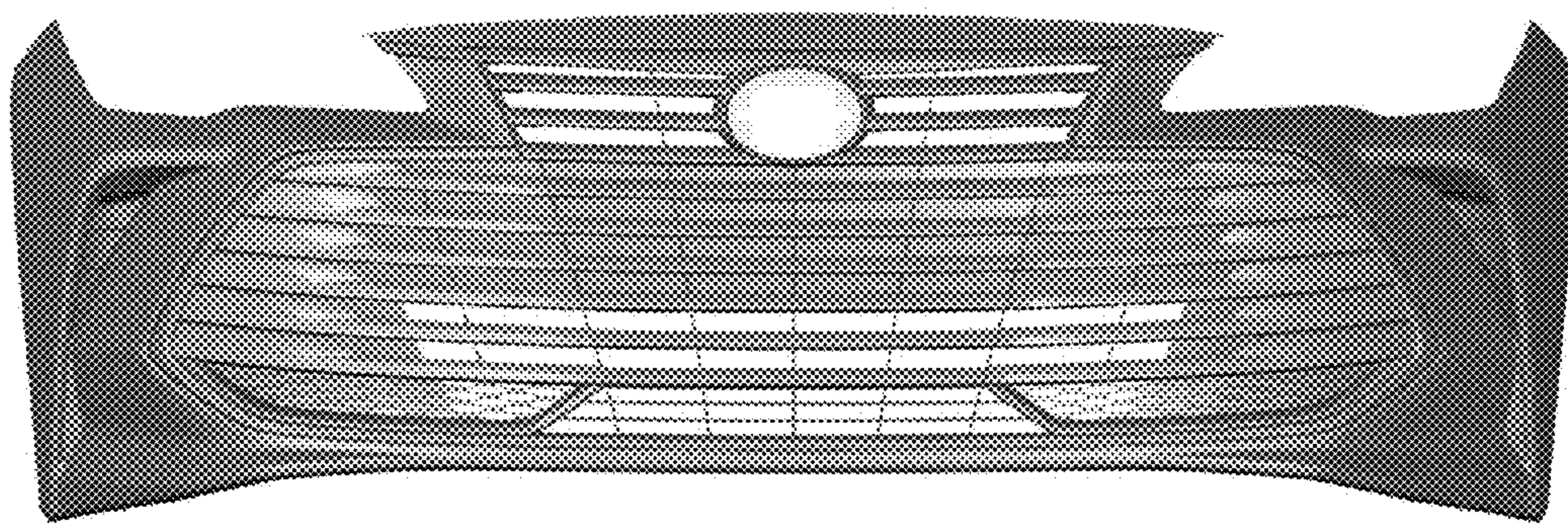

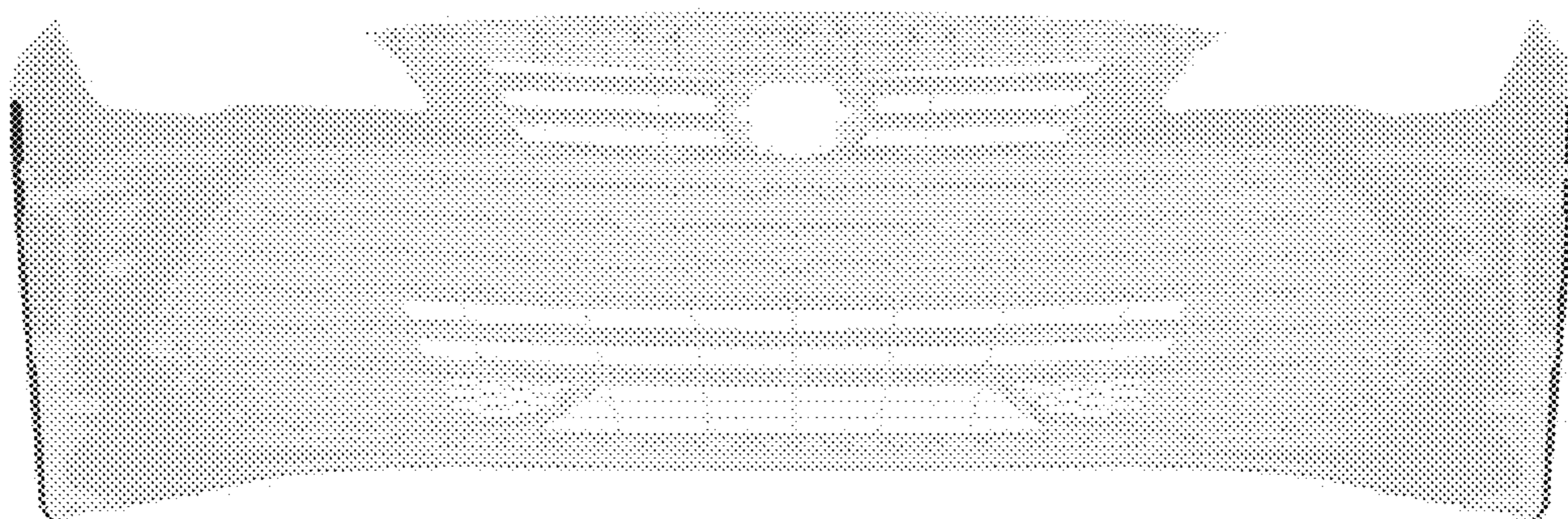

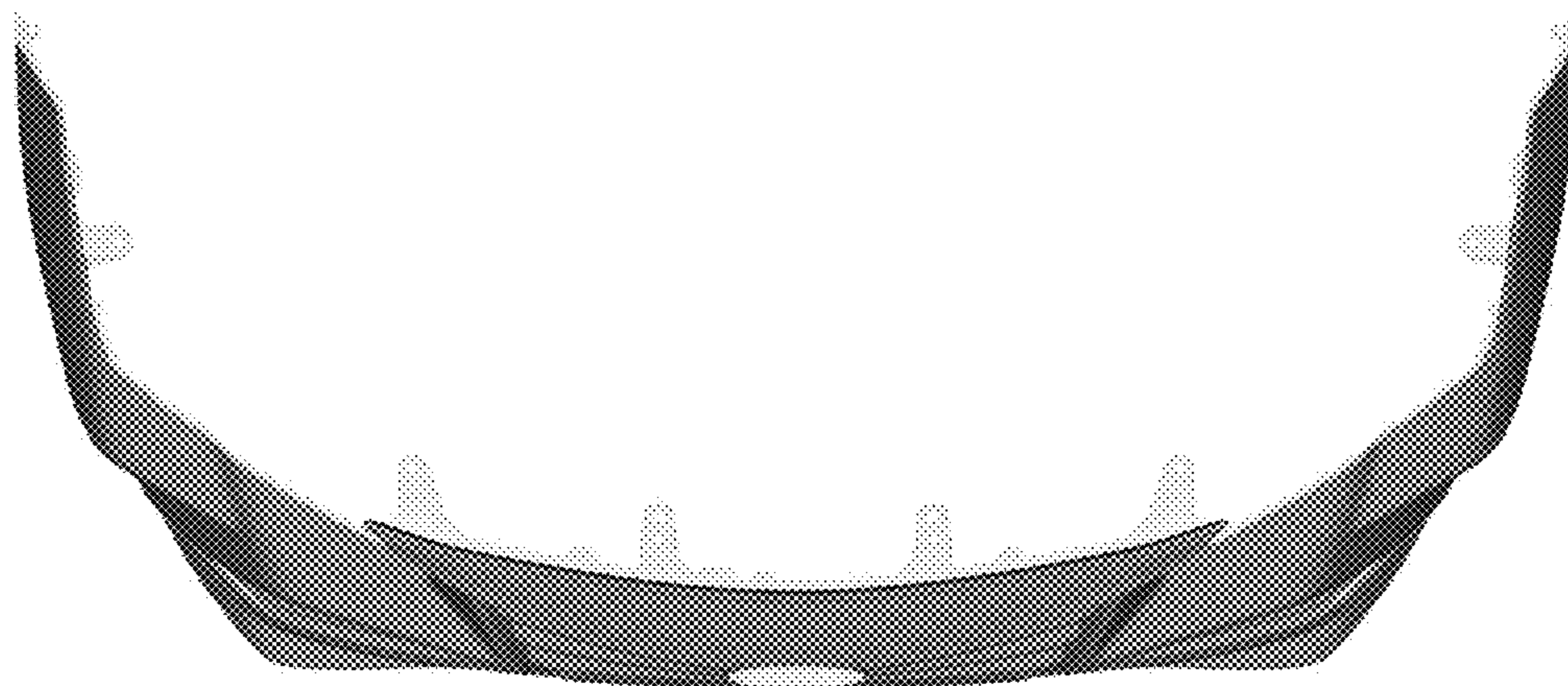

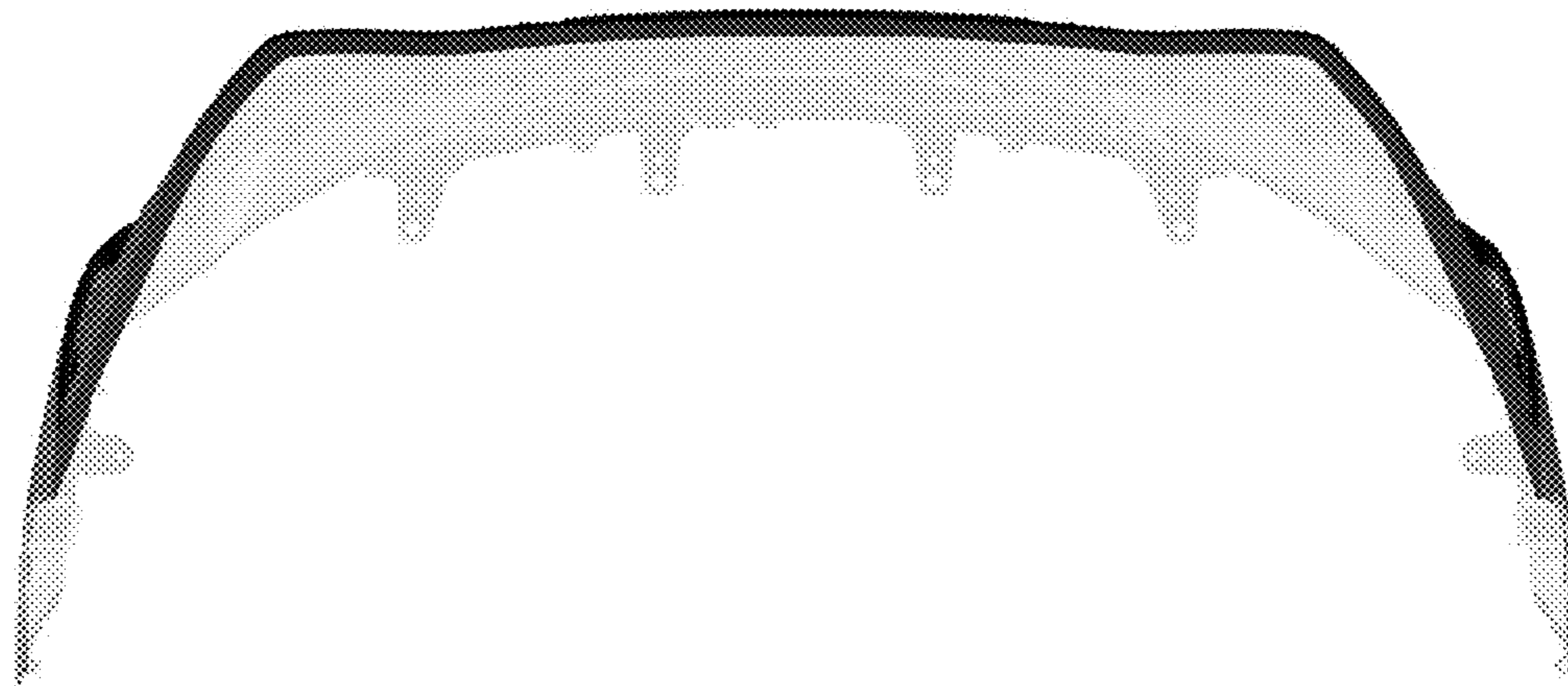

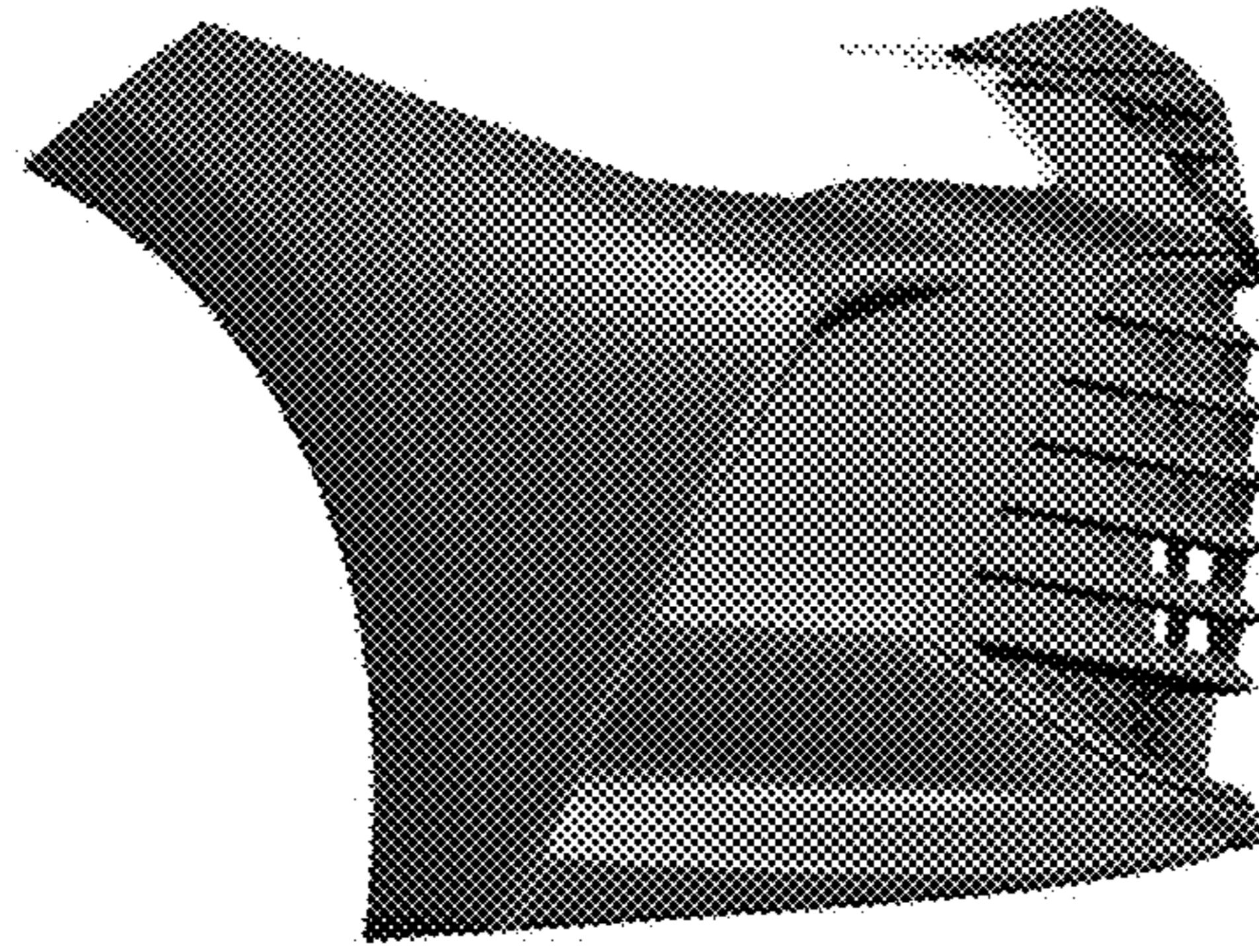

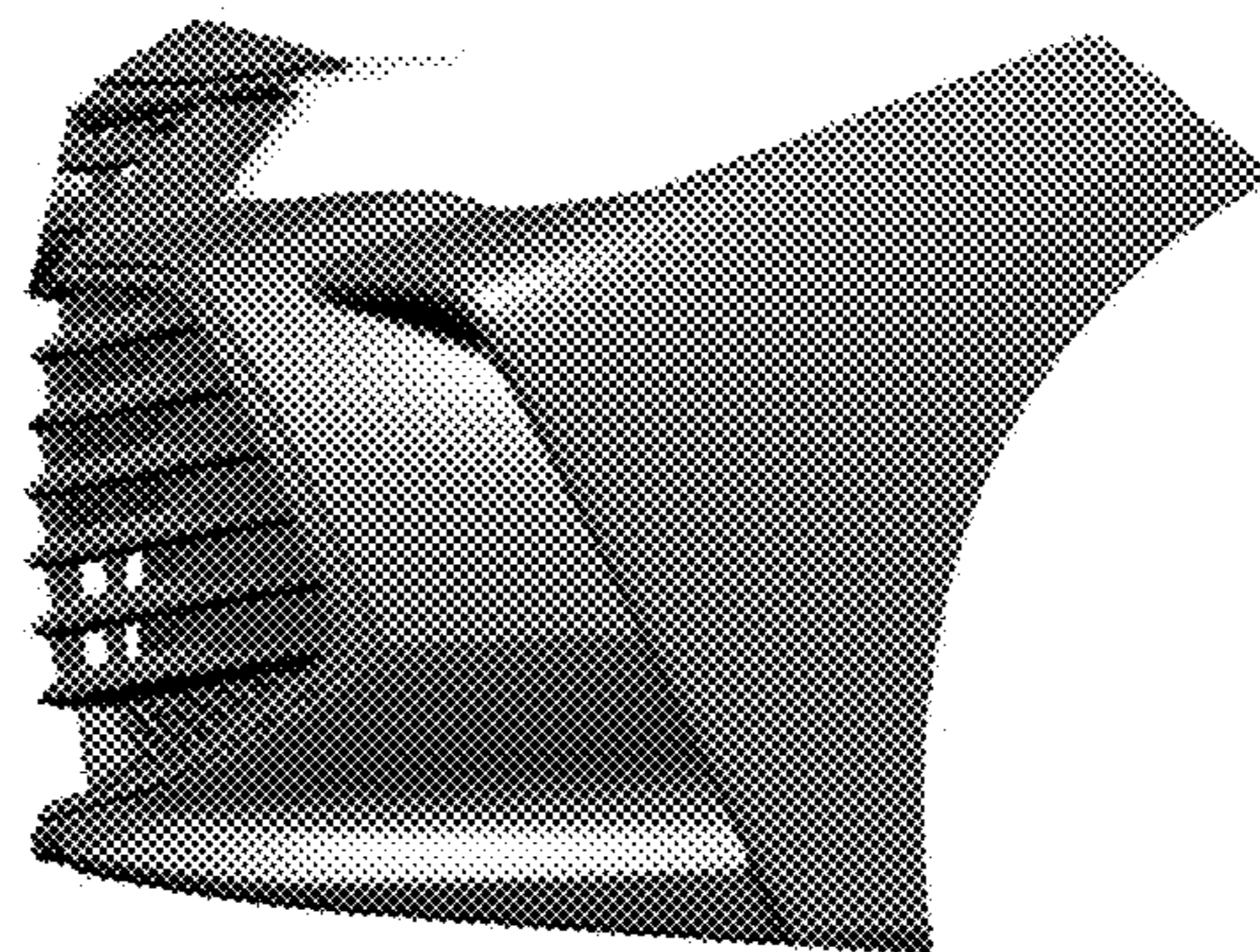
