(57) **CLAIM**

The ornamental design for a case for electronic communications device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a case for electronic communications device showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The interior region of the case that immediately surrounds the camera opening and that is shown in solid lines is included in the claimed design. However, the remainder of the interior of the case shown in FIGS. 1 and 3 forms no part of the claimed design.

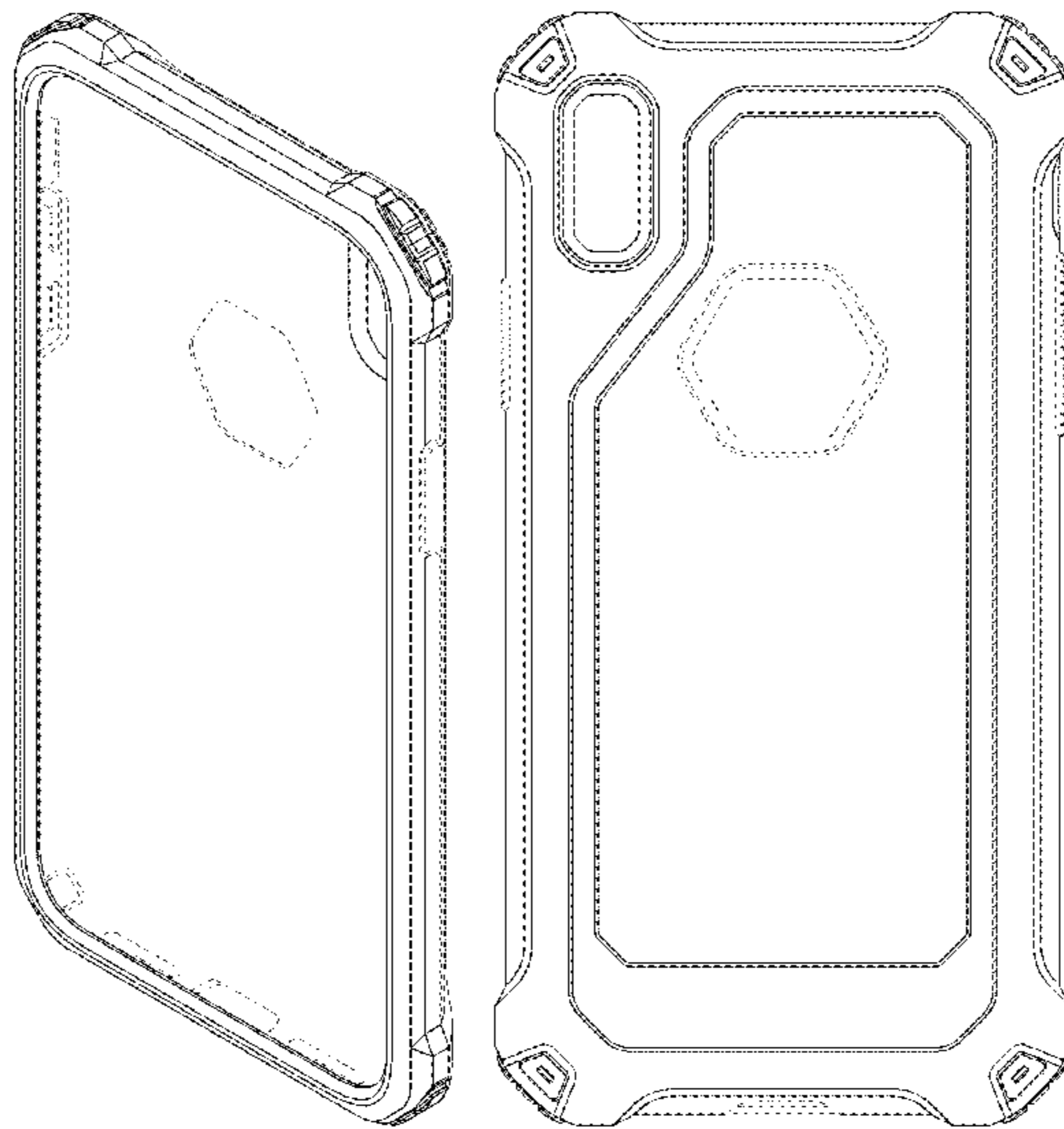

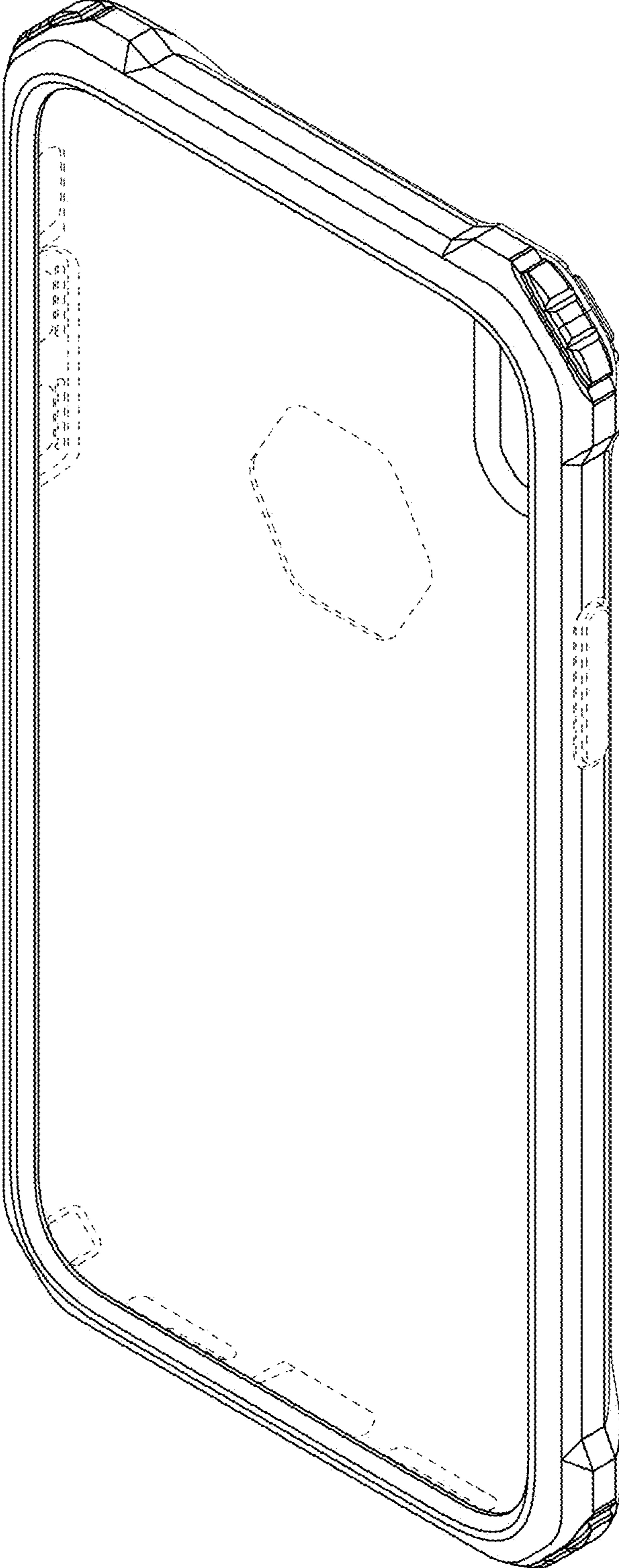

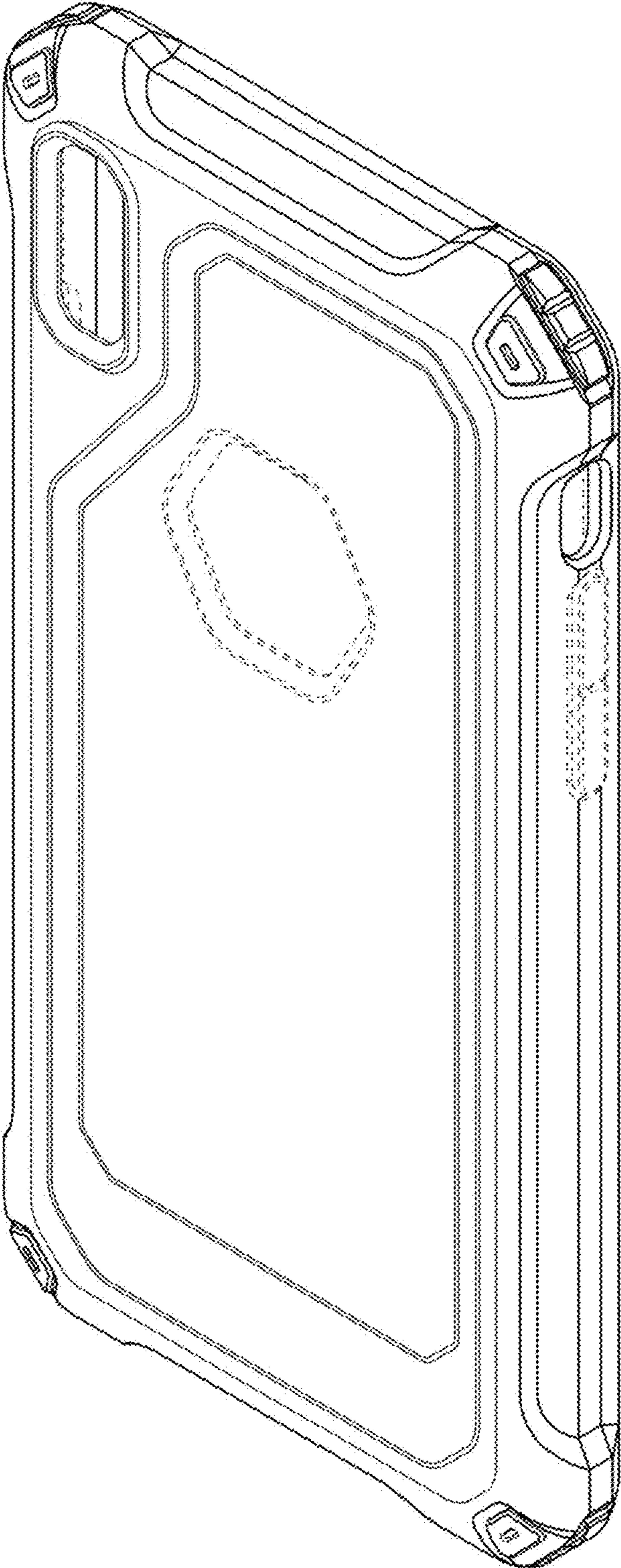

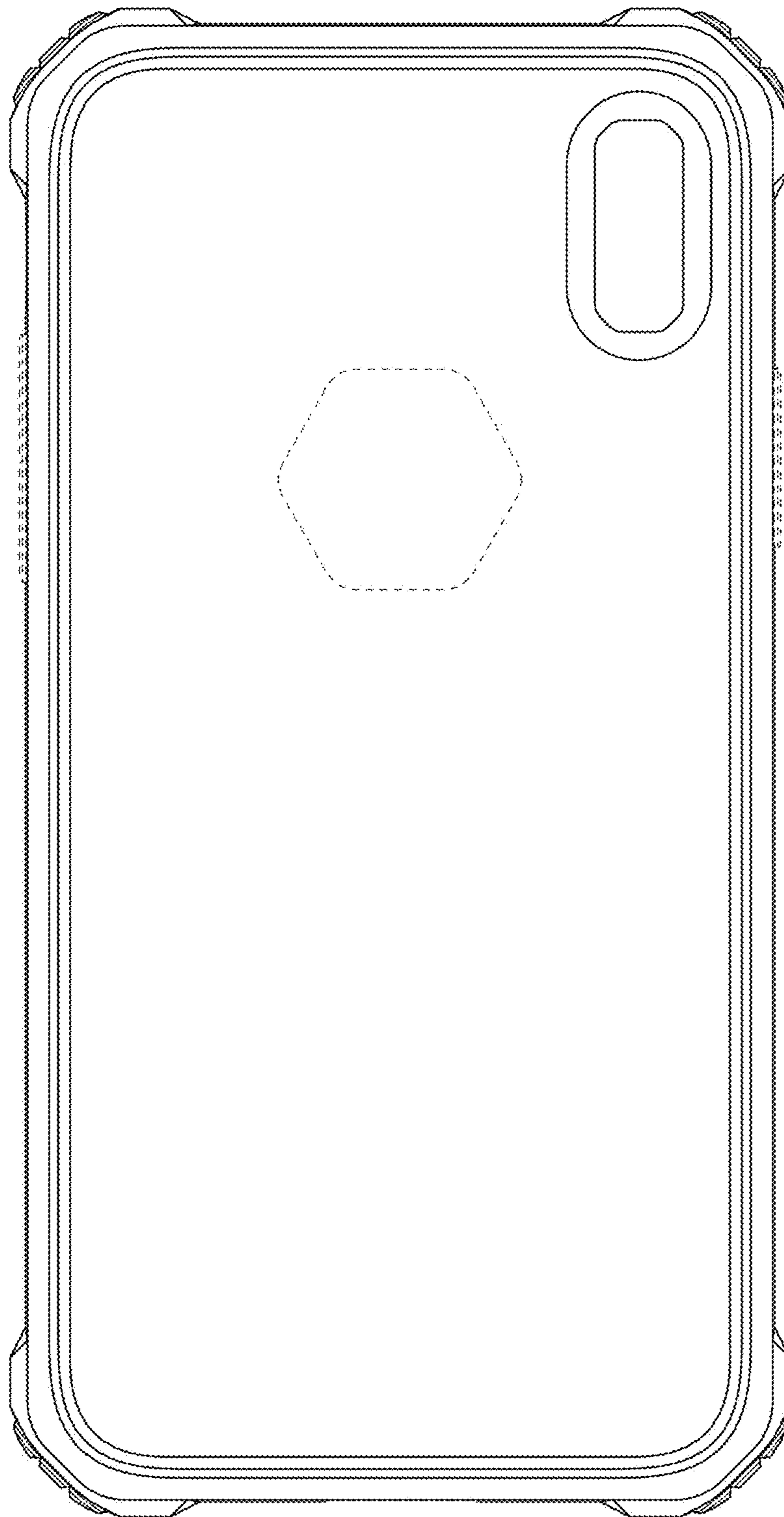

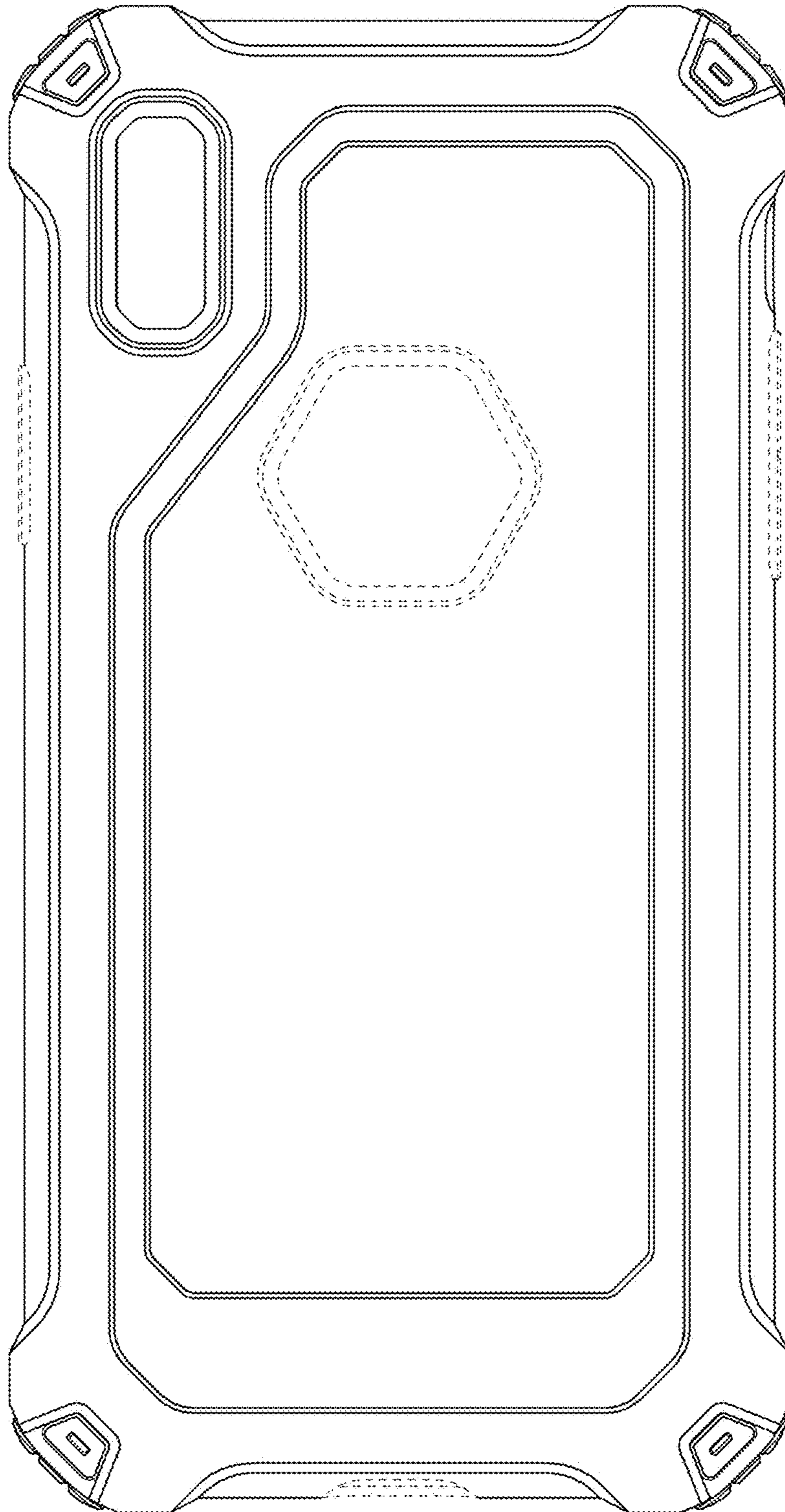

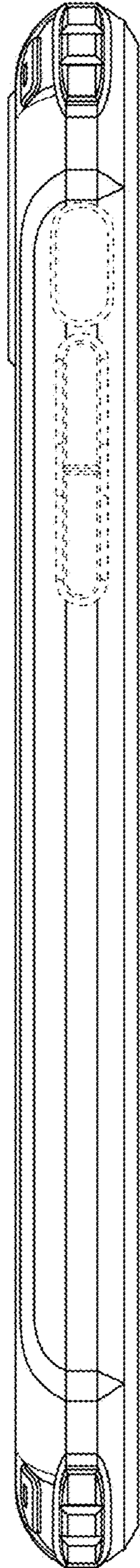

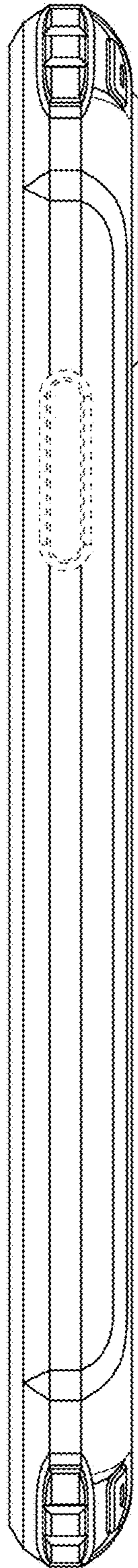

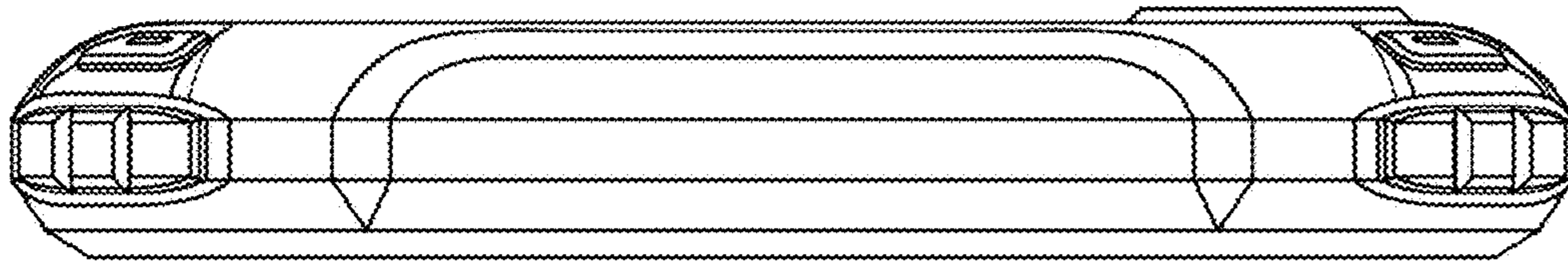
