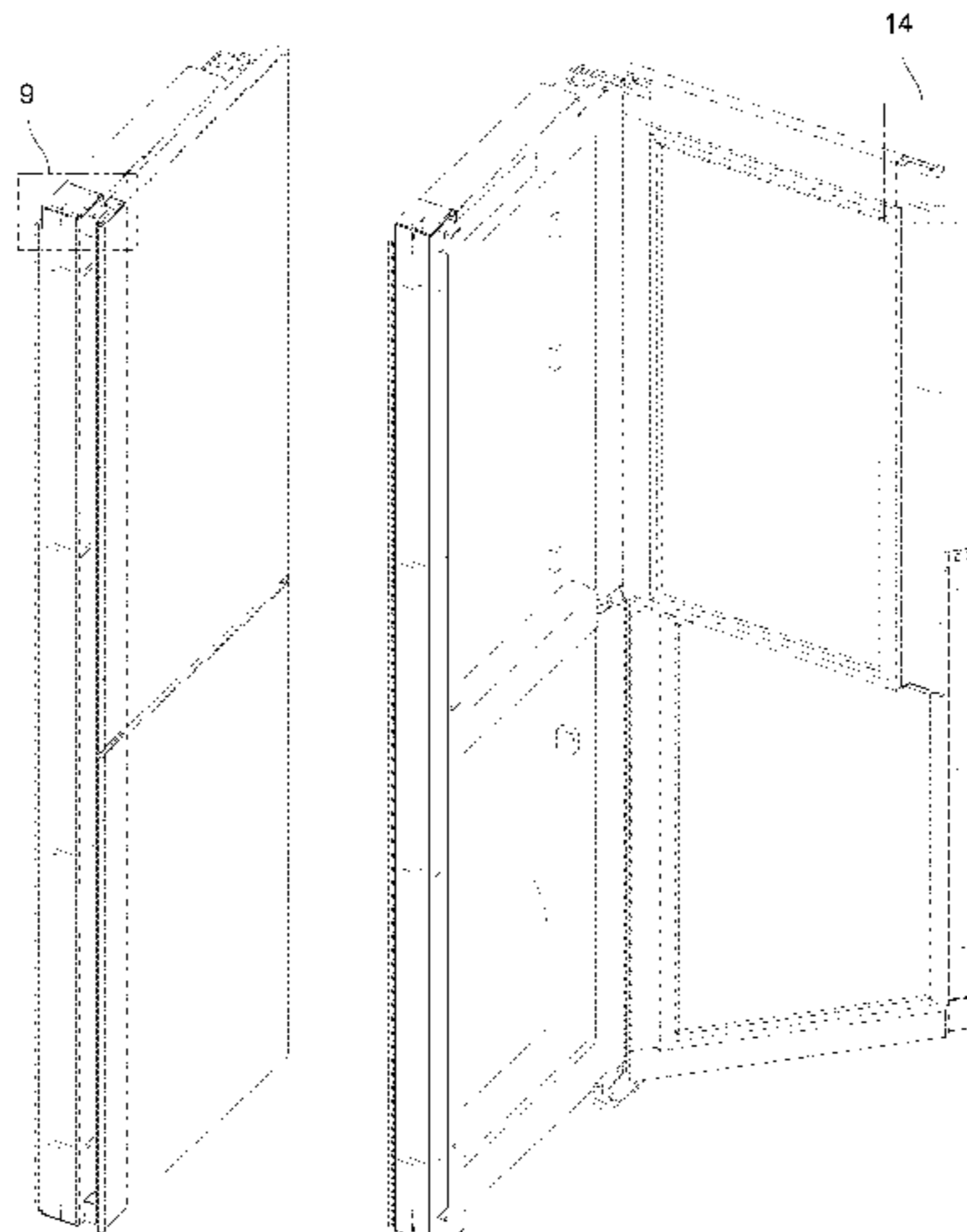
(57) **CLAIM**

We claim the ornamental design for a door for refrigerator,
as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a door for refrigerator showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a cross-sectional view taken through line 8-8 of FIG. 2;
FIG. 9 is an enlarged view of the encircled portion shown in FIG. 1;
FIG. 10 is an enlarged view of the encircled portion shown in FIG. 6;
FIG. 11 is an enlarged view of the encircled portion shown in FIG. 8;
FIG. 12 is a top plan view of the door for refrigerator shown in an open position;
FIG. 13 is a front perspective view of the door for refrigerator shown in an open position;
FIG. 14 is an enlarged view of the encircled portion shown in FIG. 13; and,
FIG. 15 is a front perspective view thereof in which a refrigerator is shown in broken lines to illustrate an example environment in an open position.

The dot-dash broken lines in the figures represent a boundary line and form no part of the claimed design.

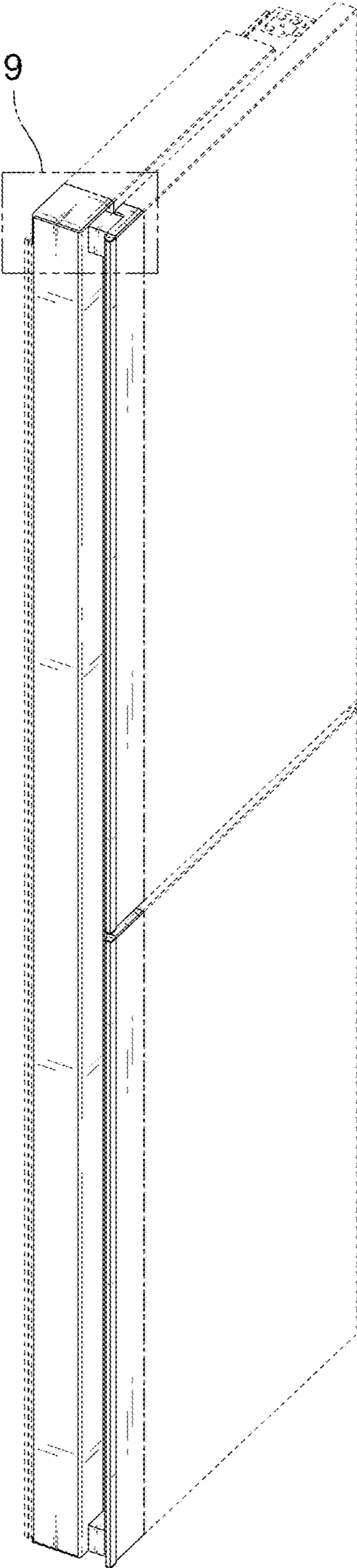

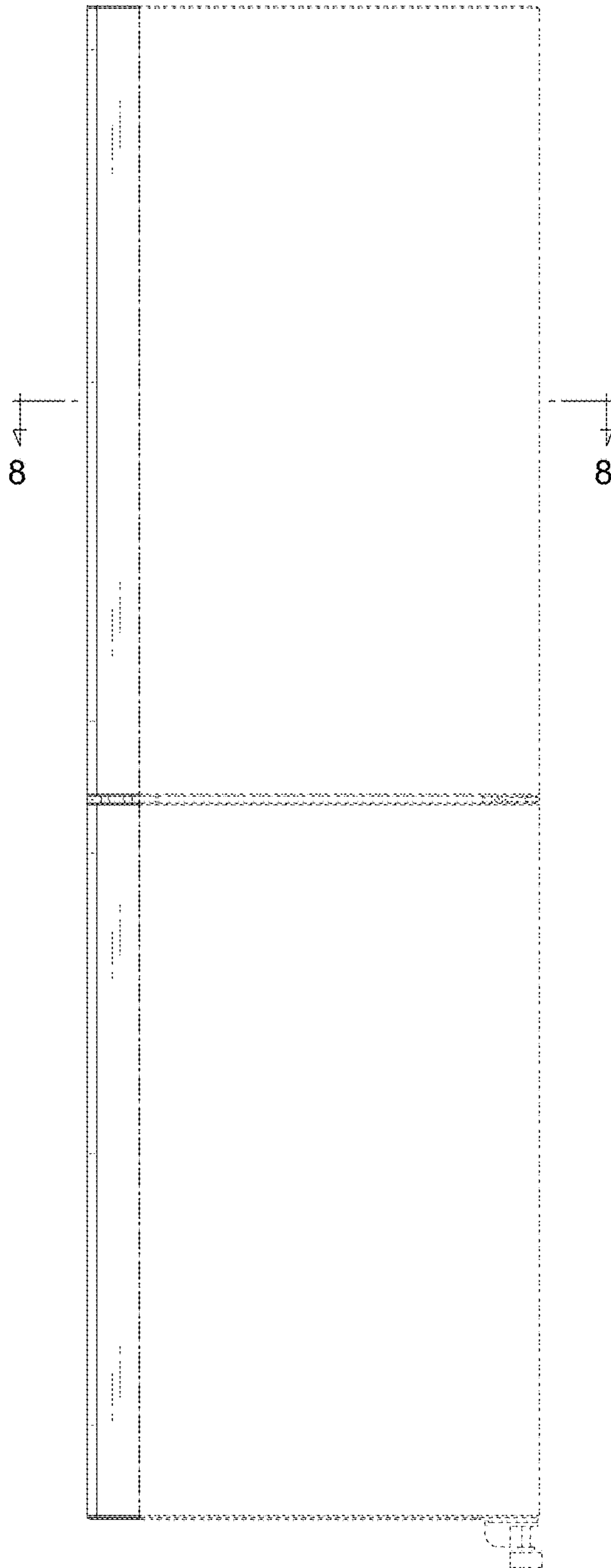

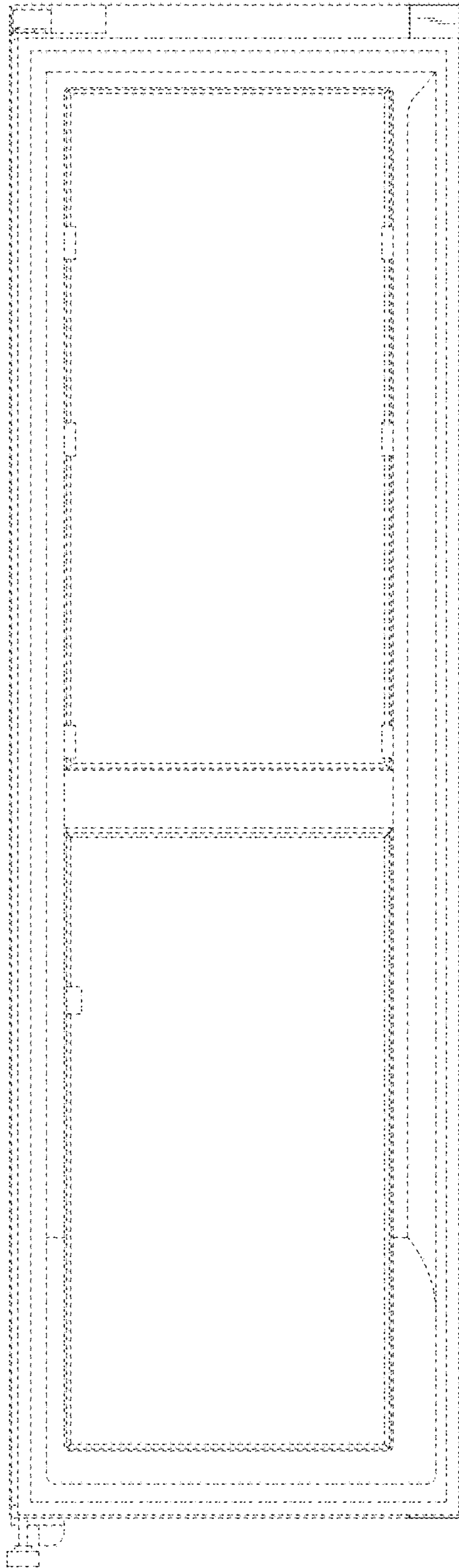

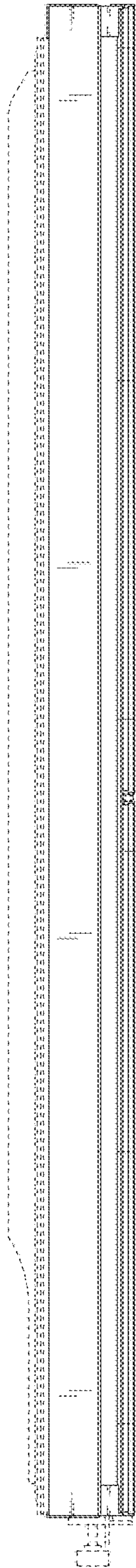

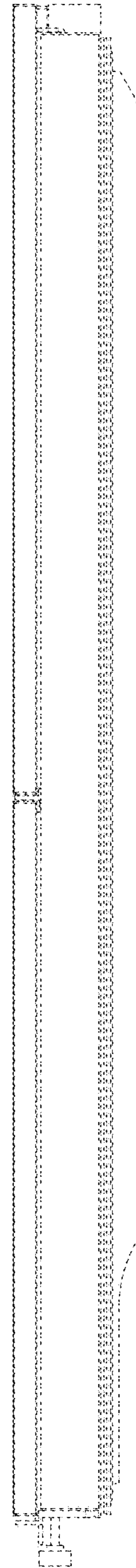

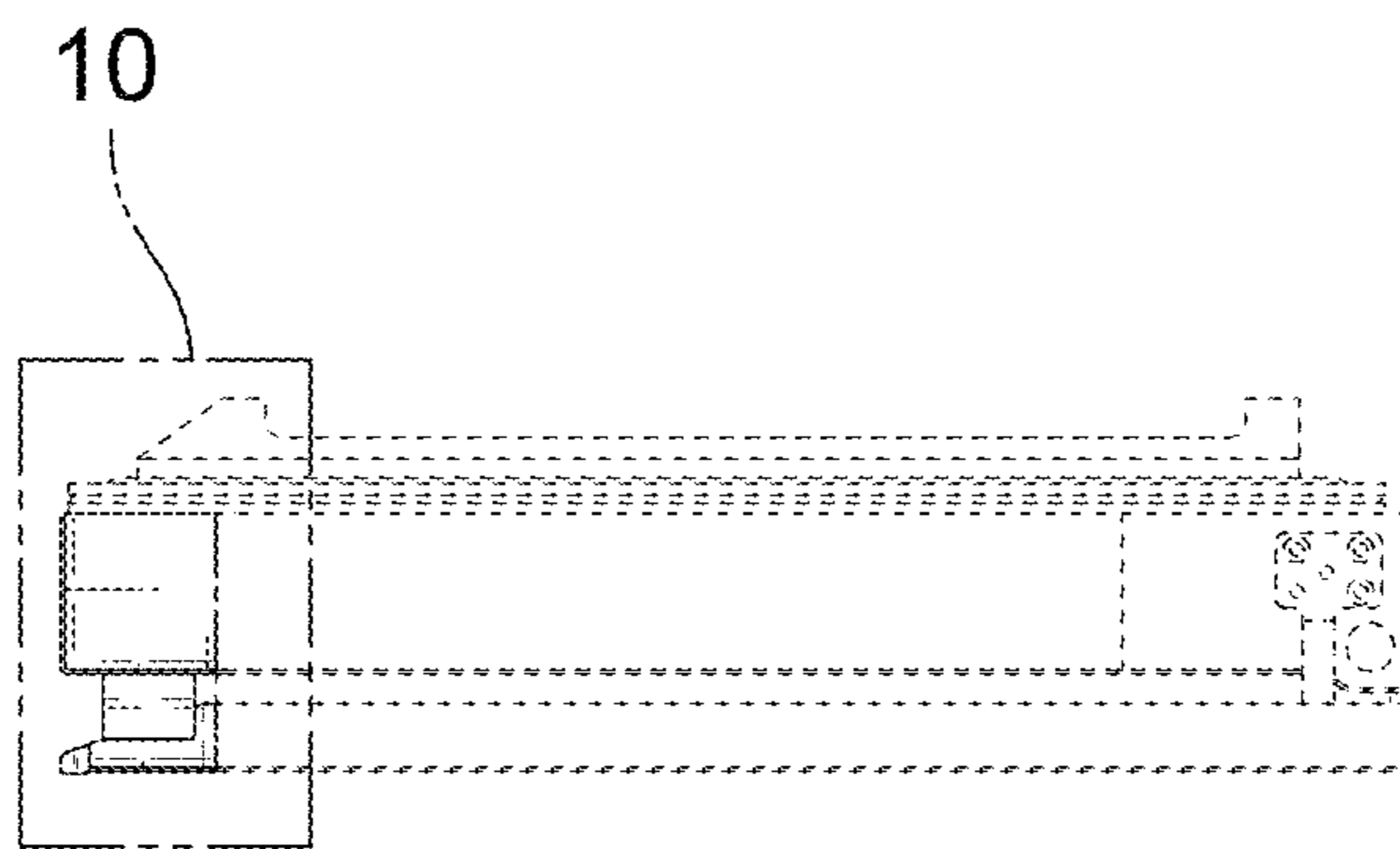

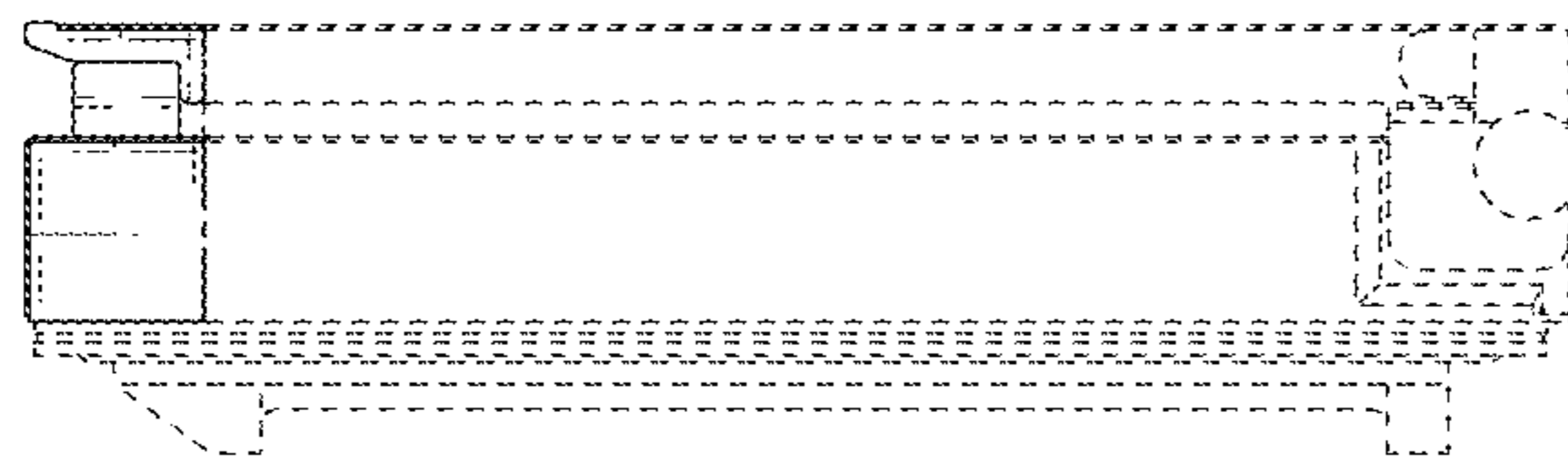

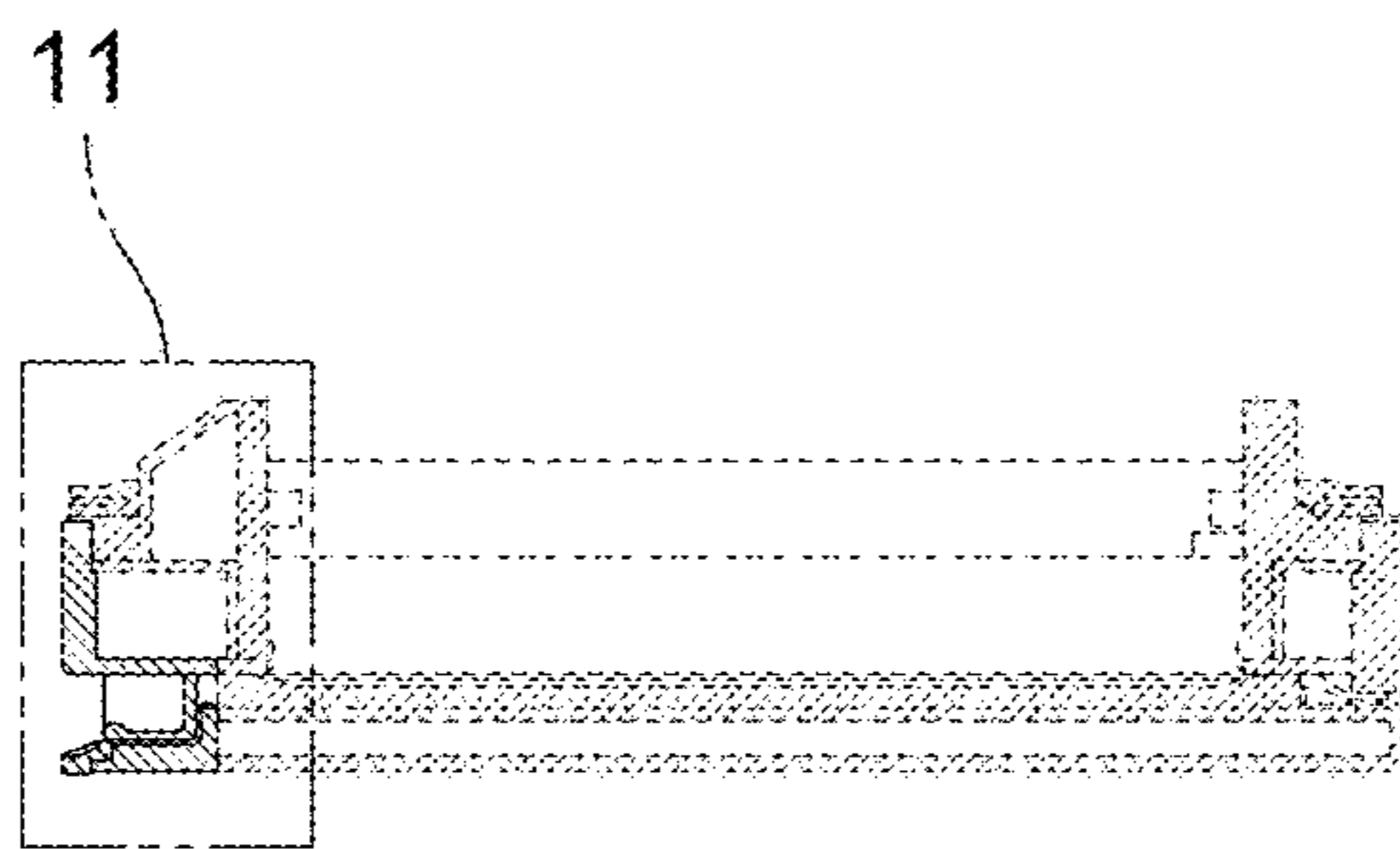

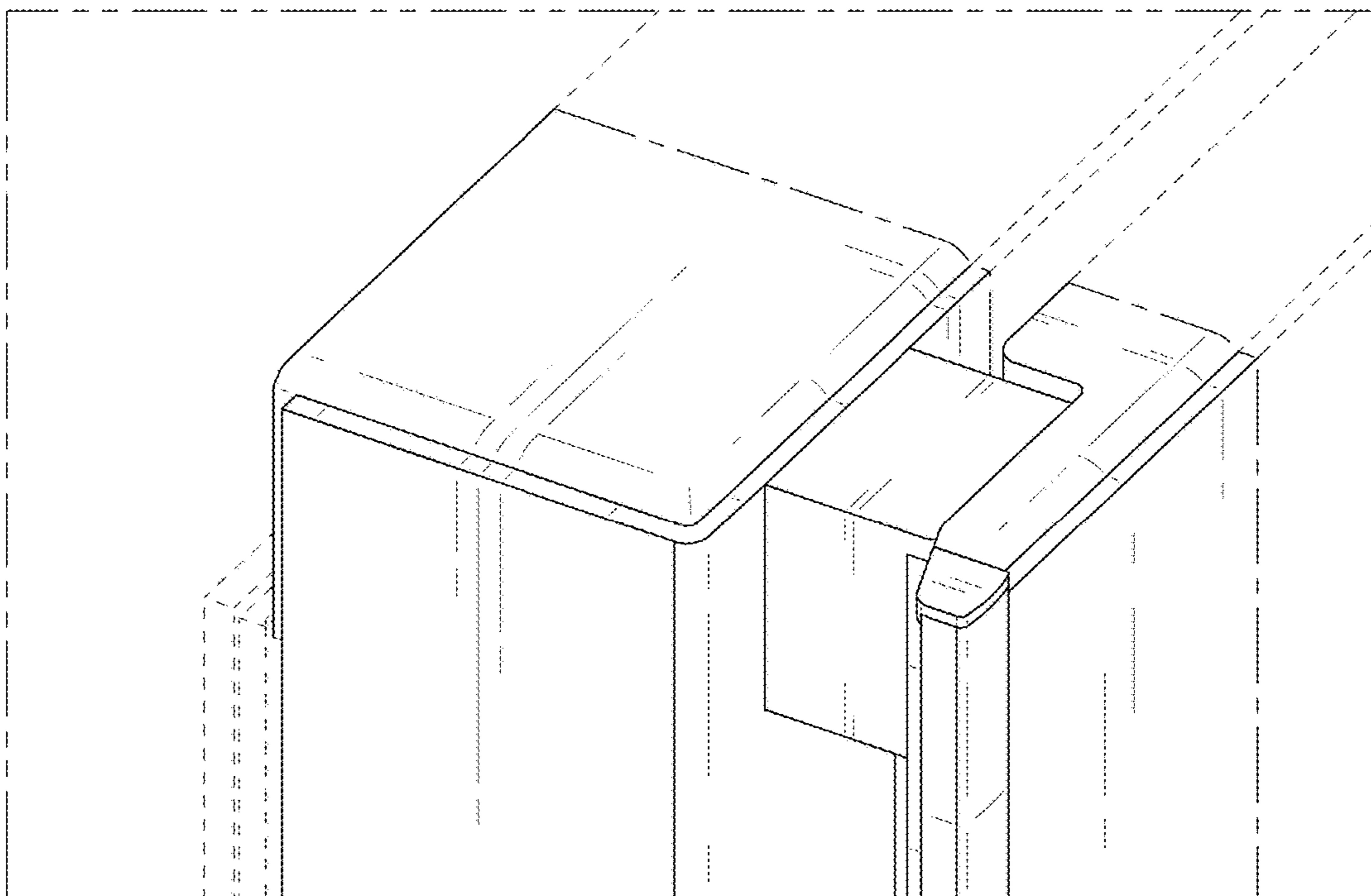

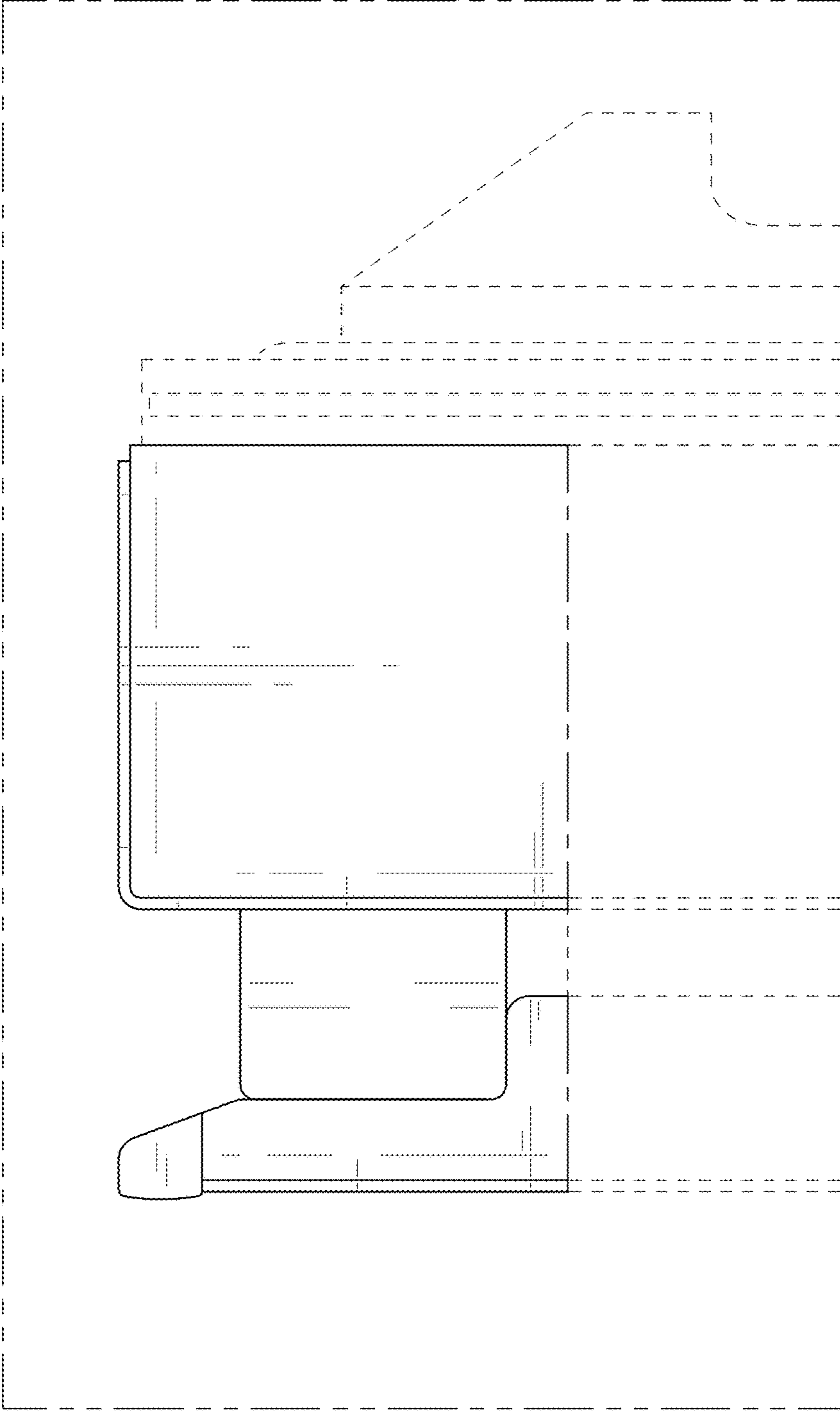

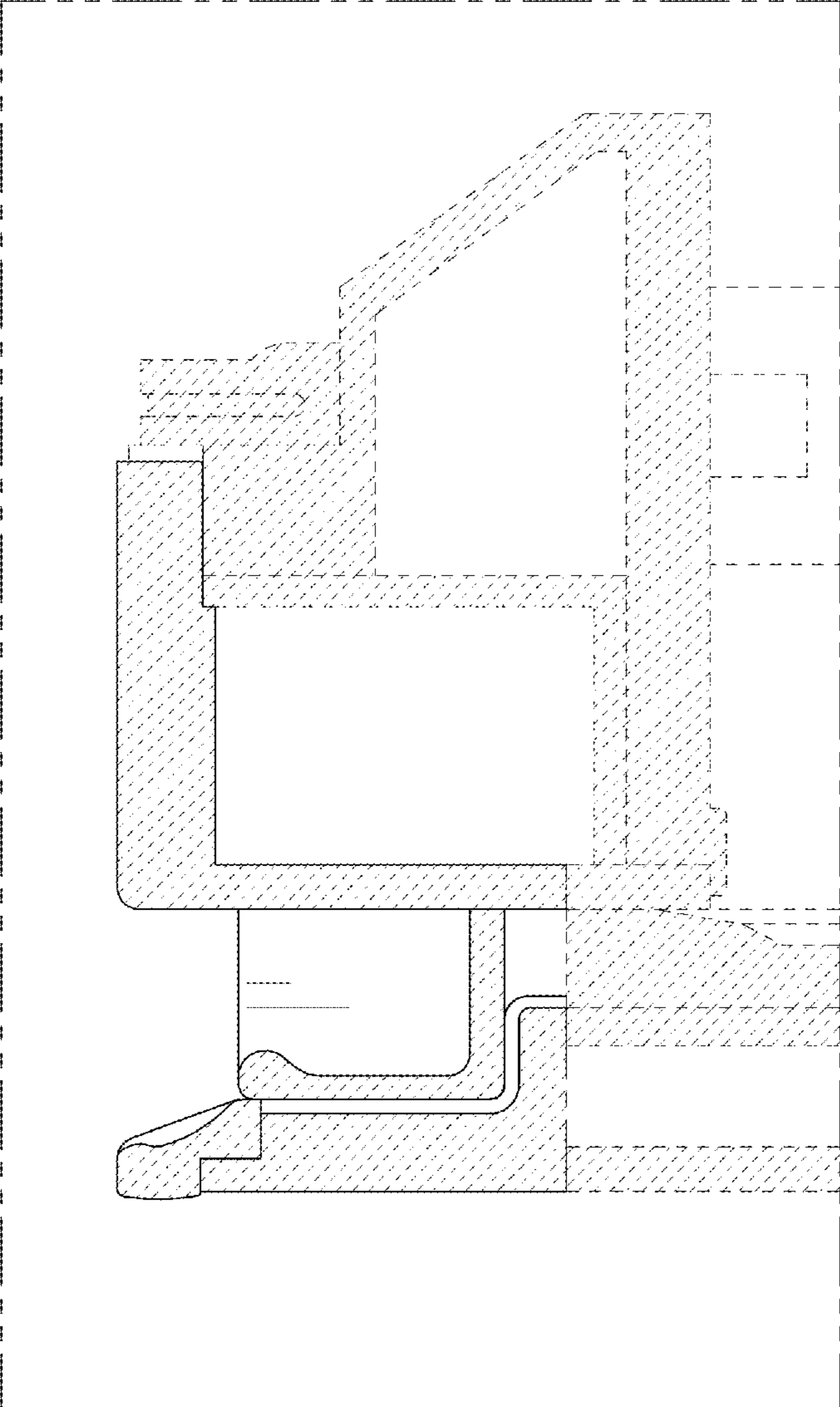

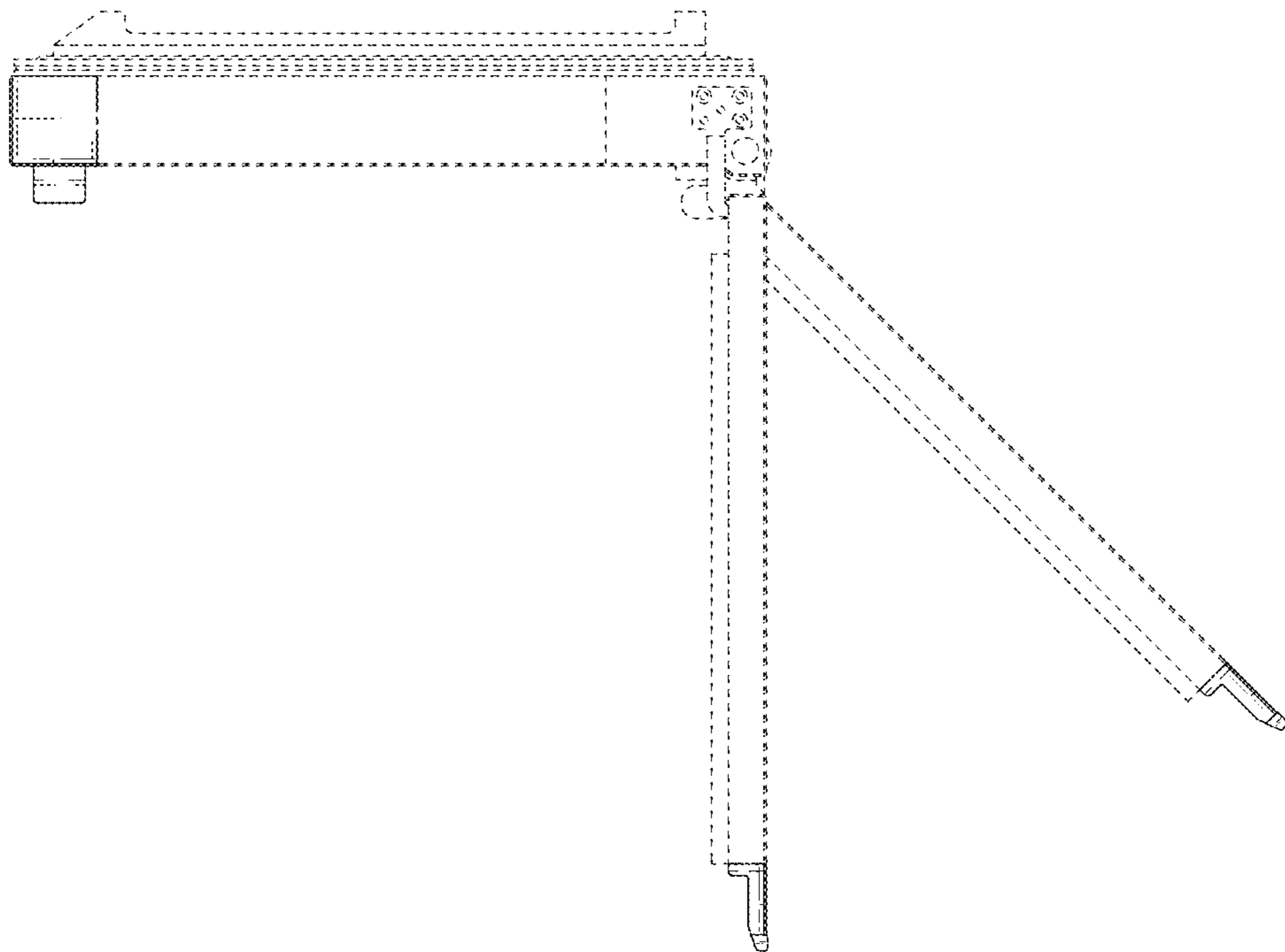

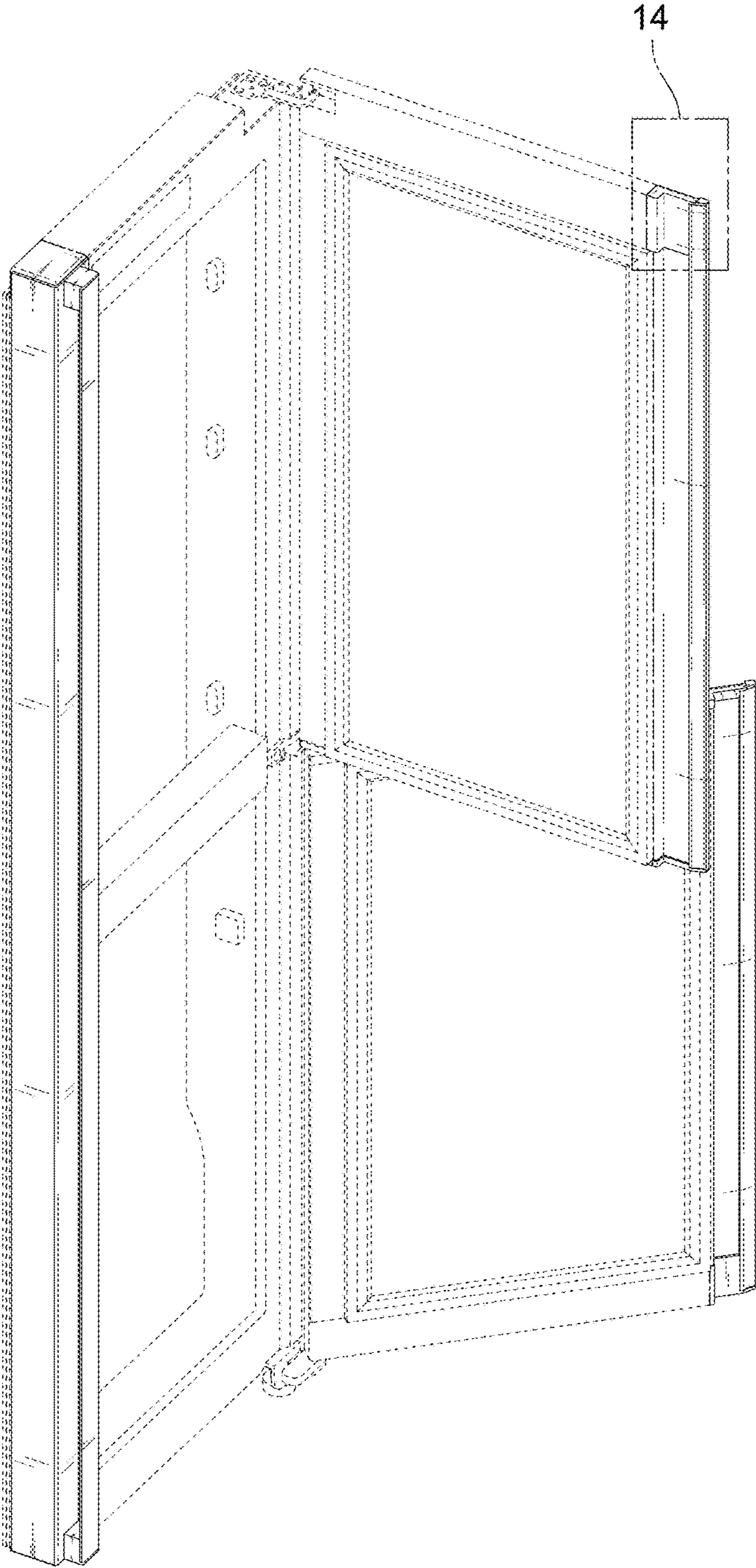

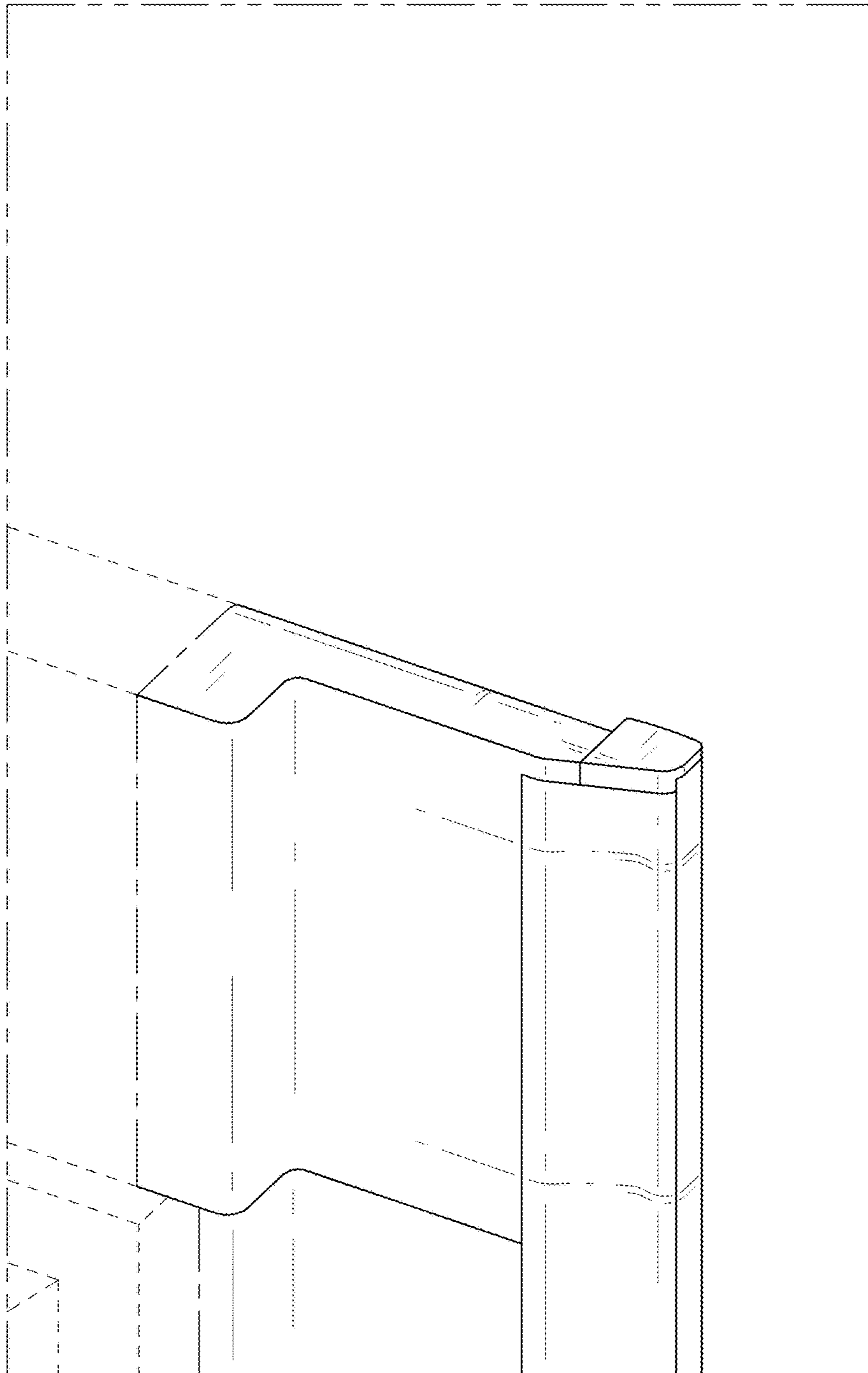
