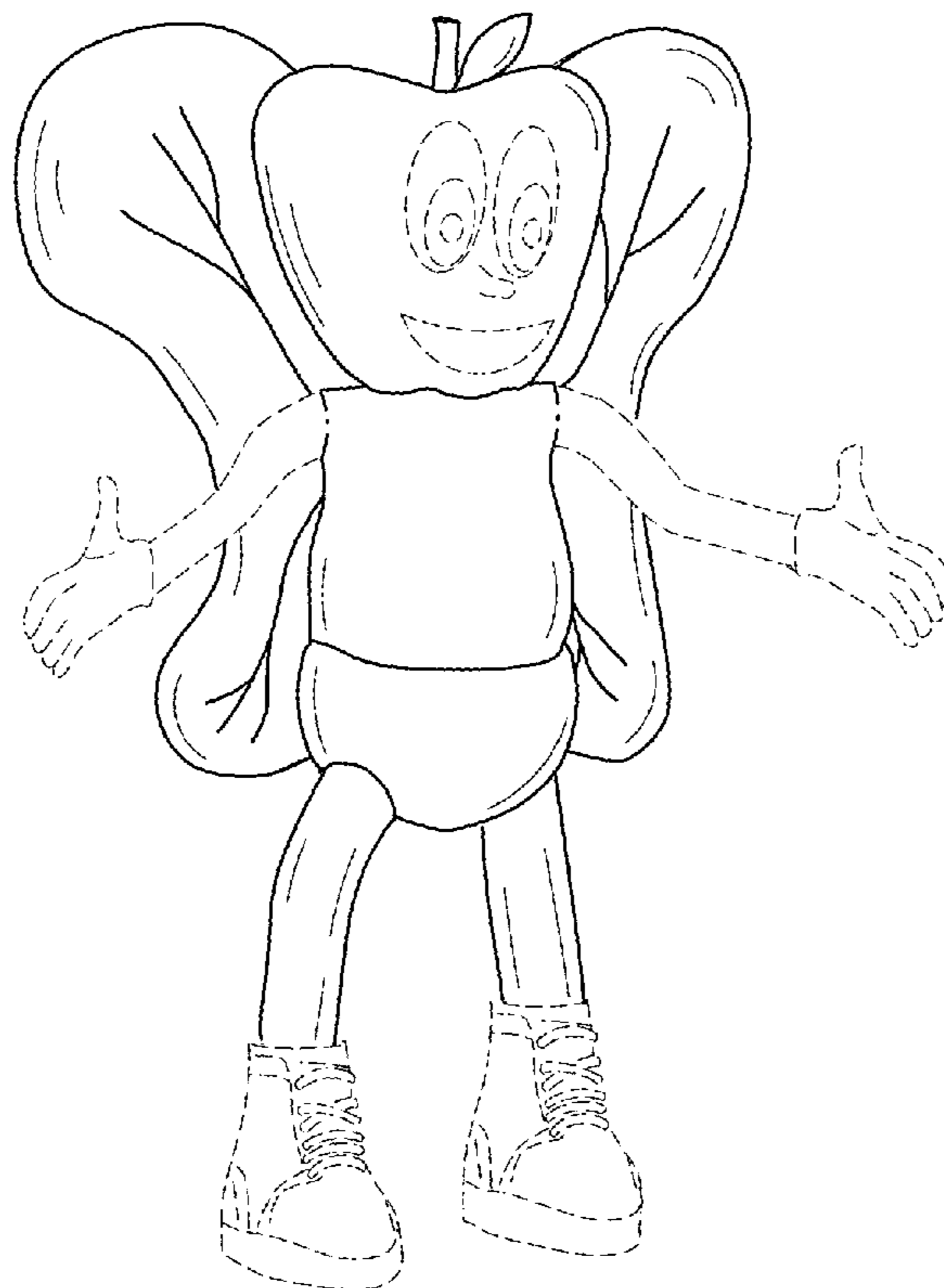
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the apple head bee plush
toy showing my new design;
FIG. 2 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof;

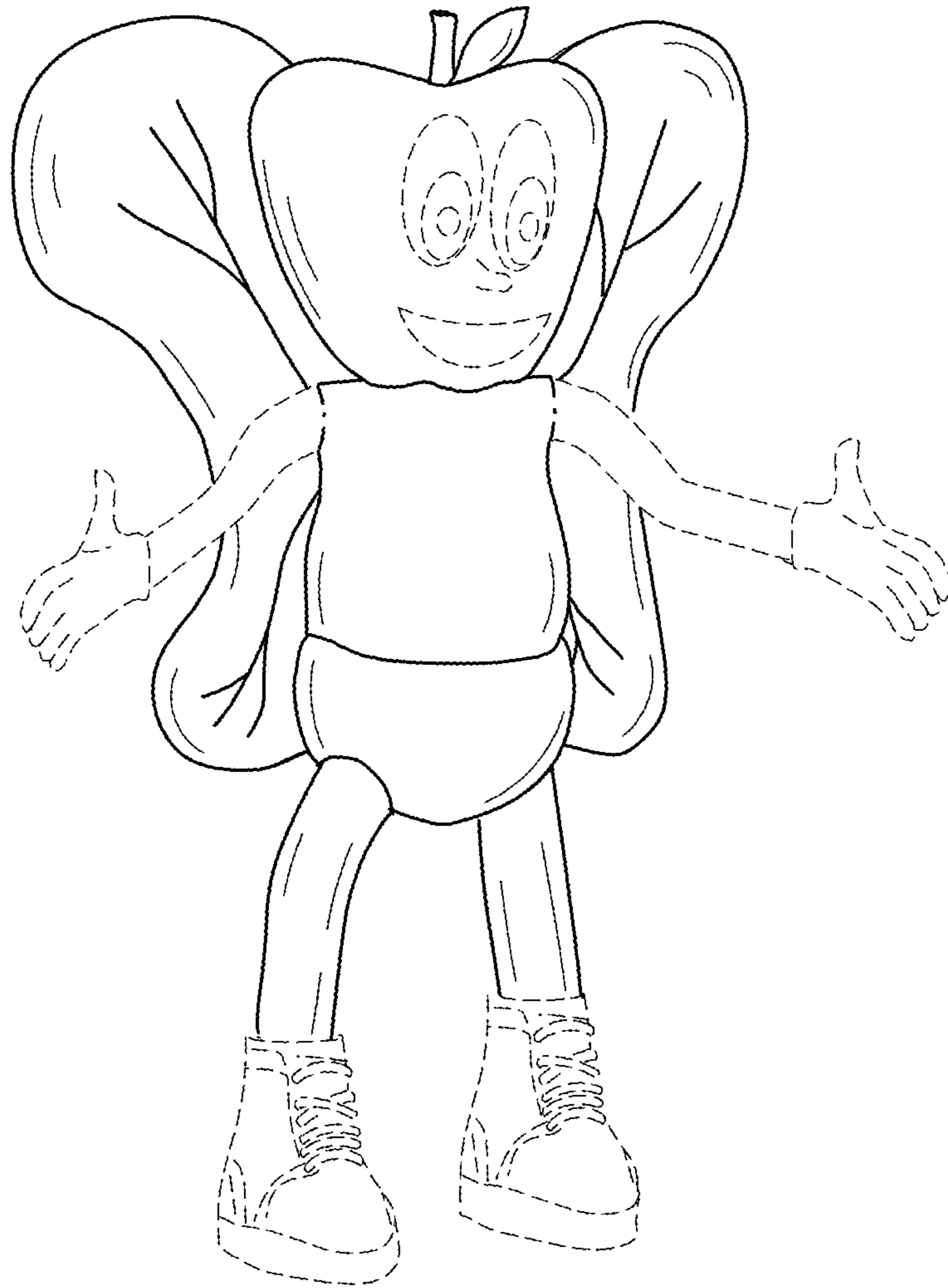

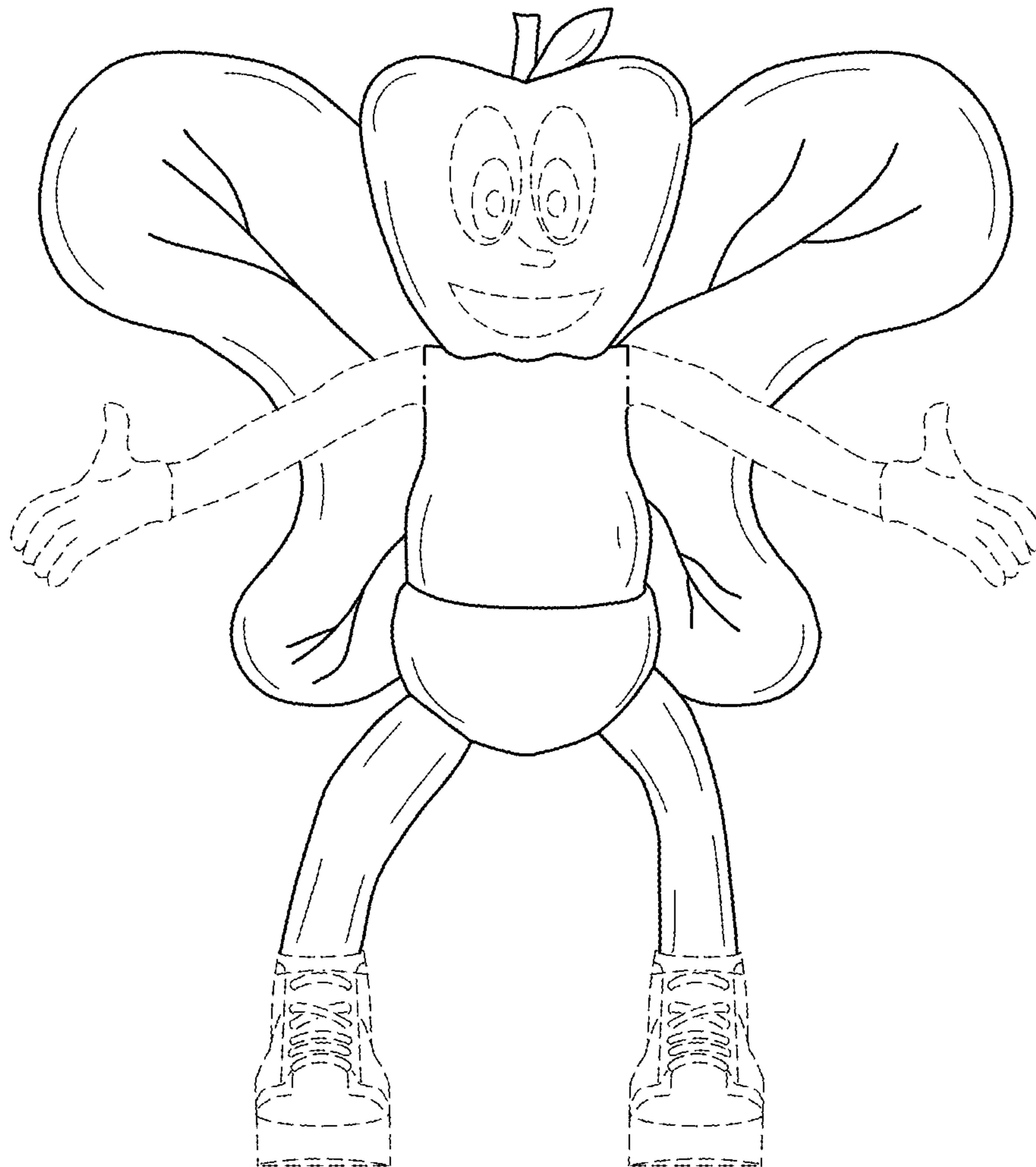

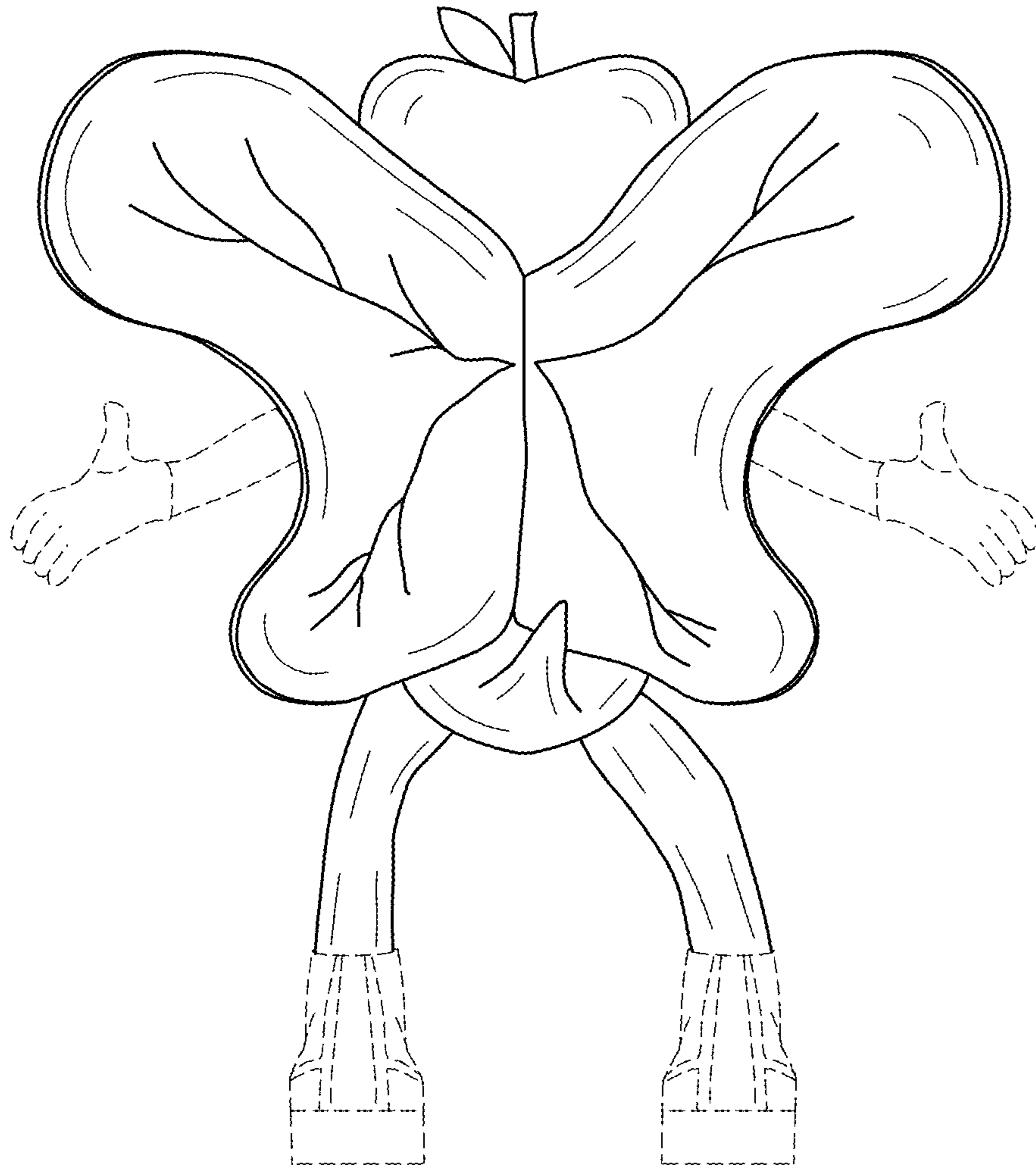

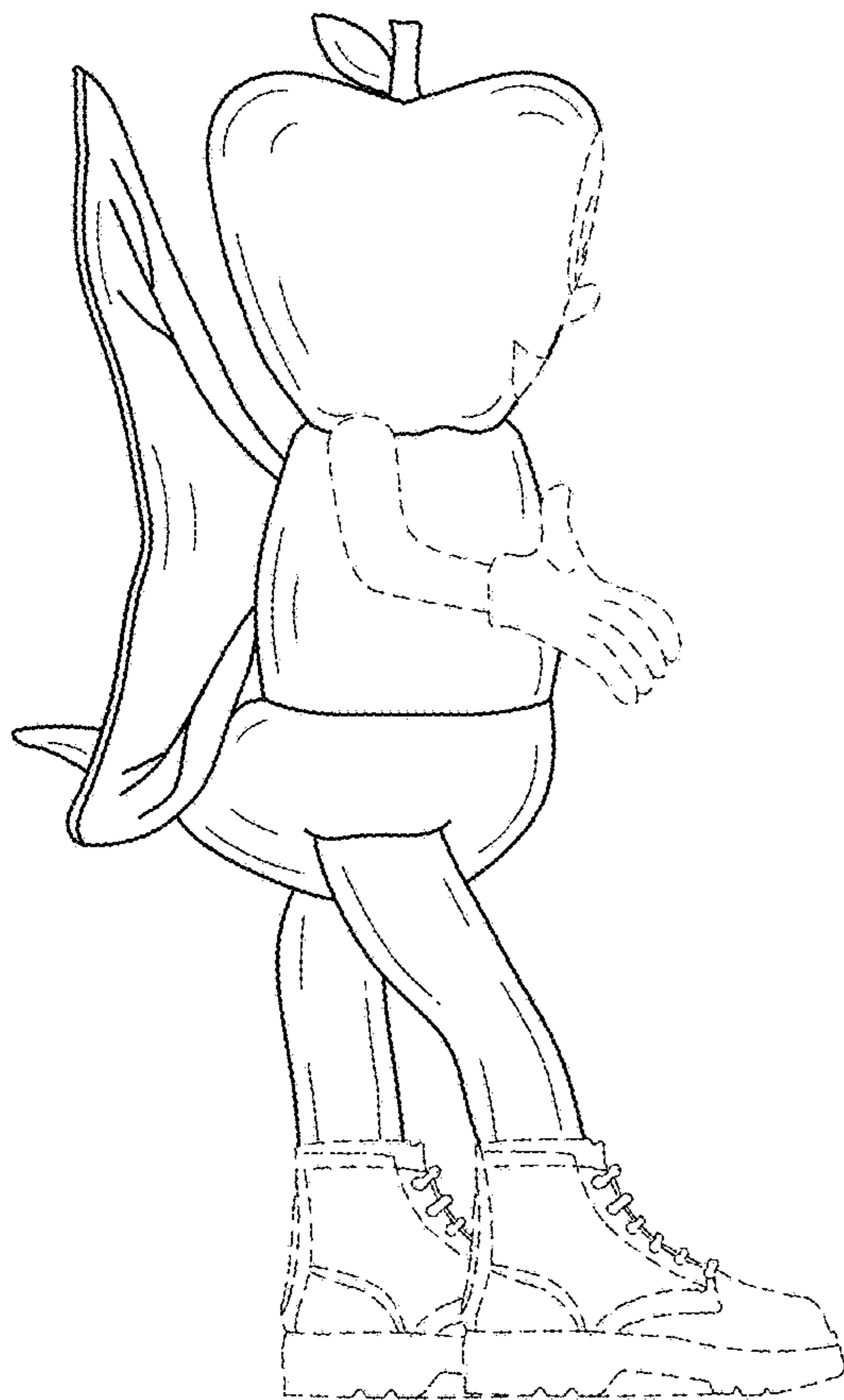

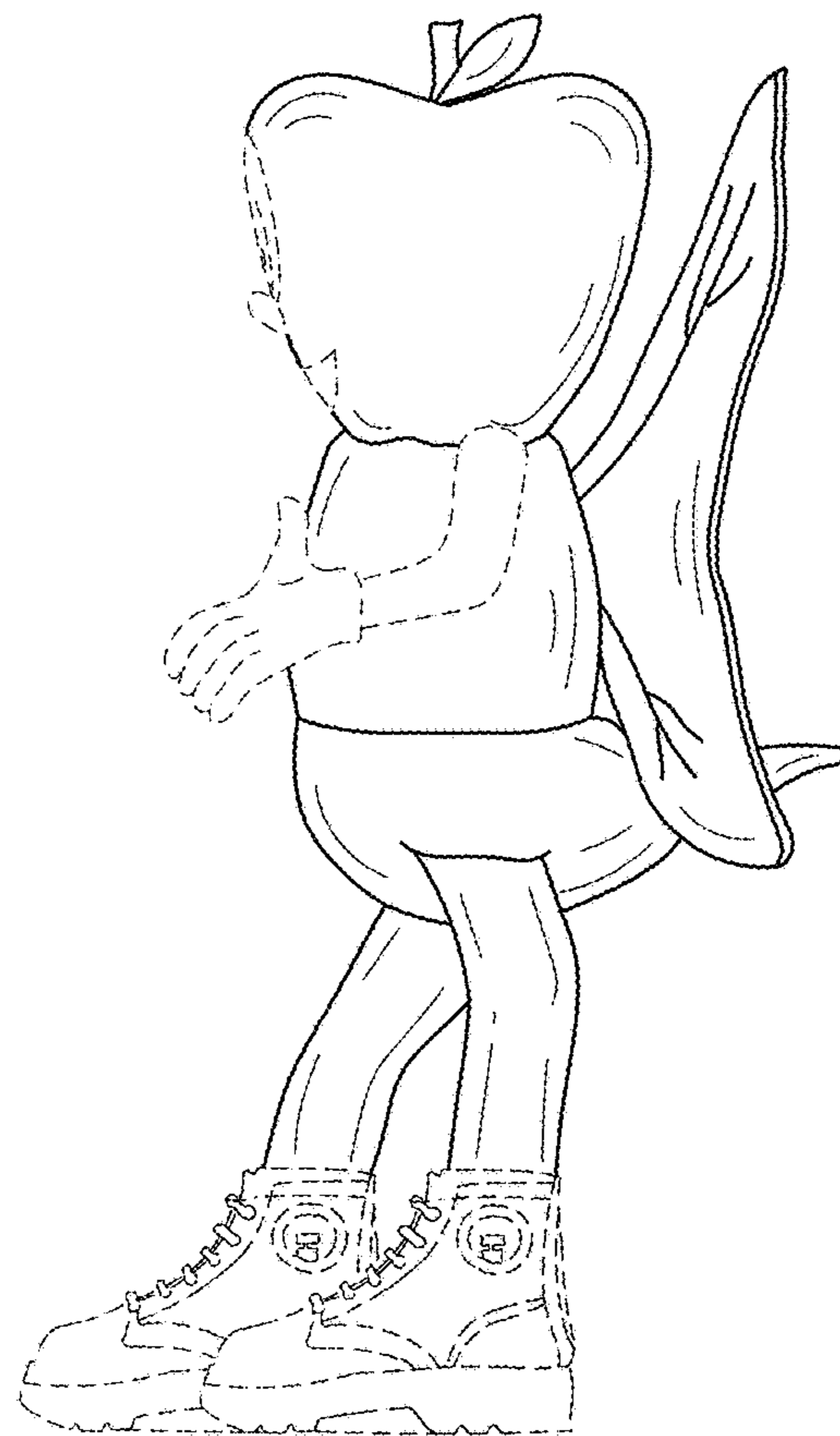

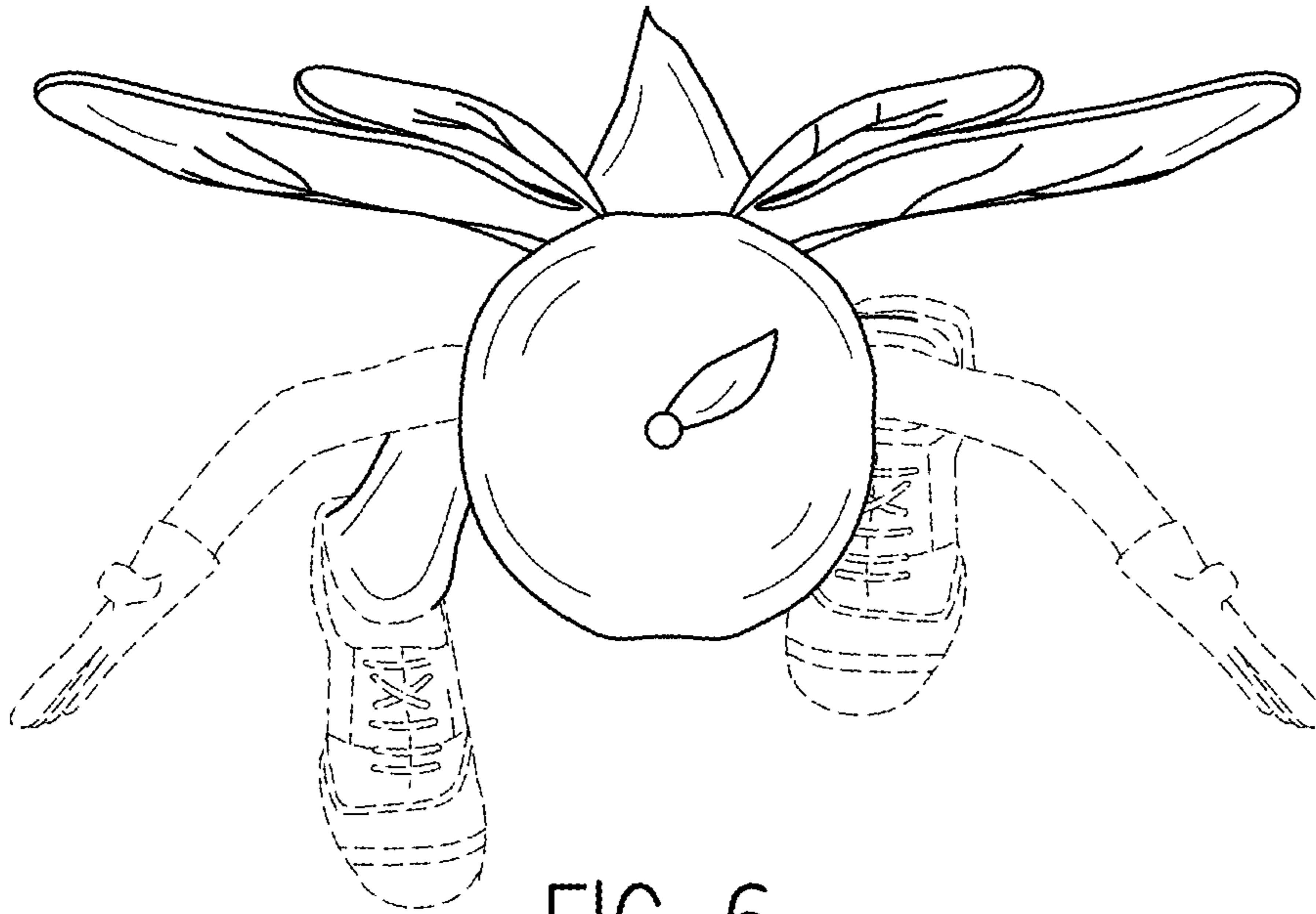

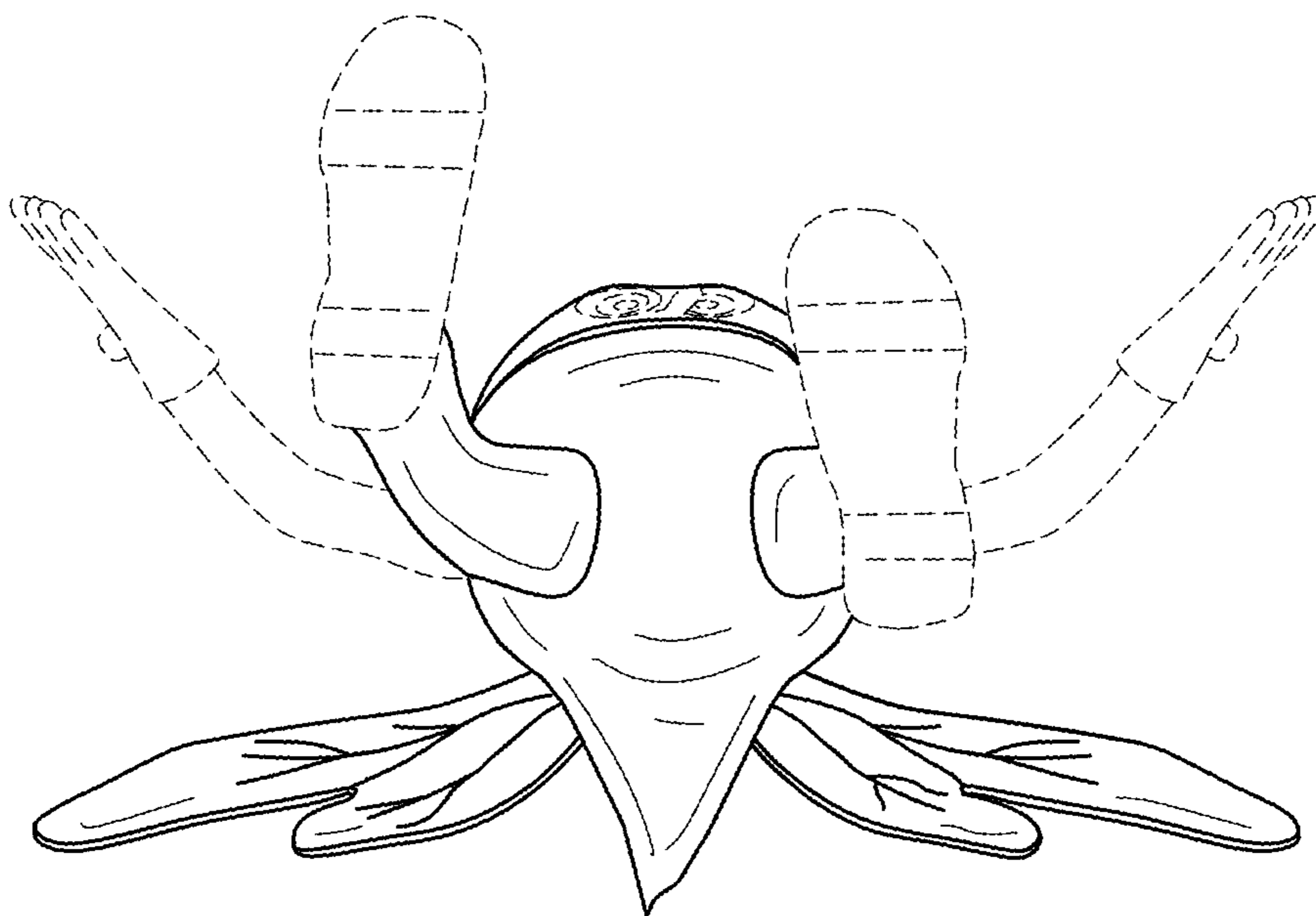
