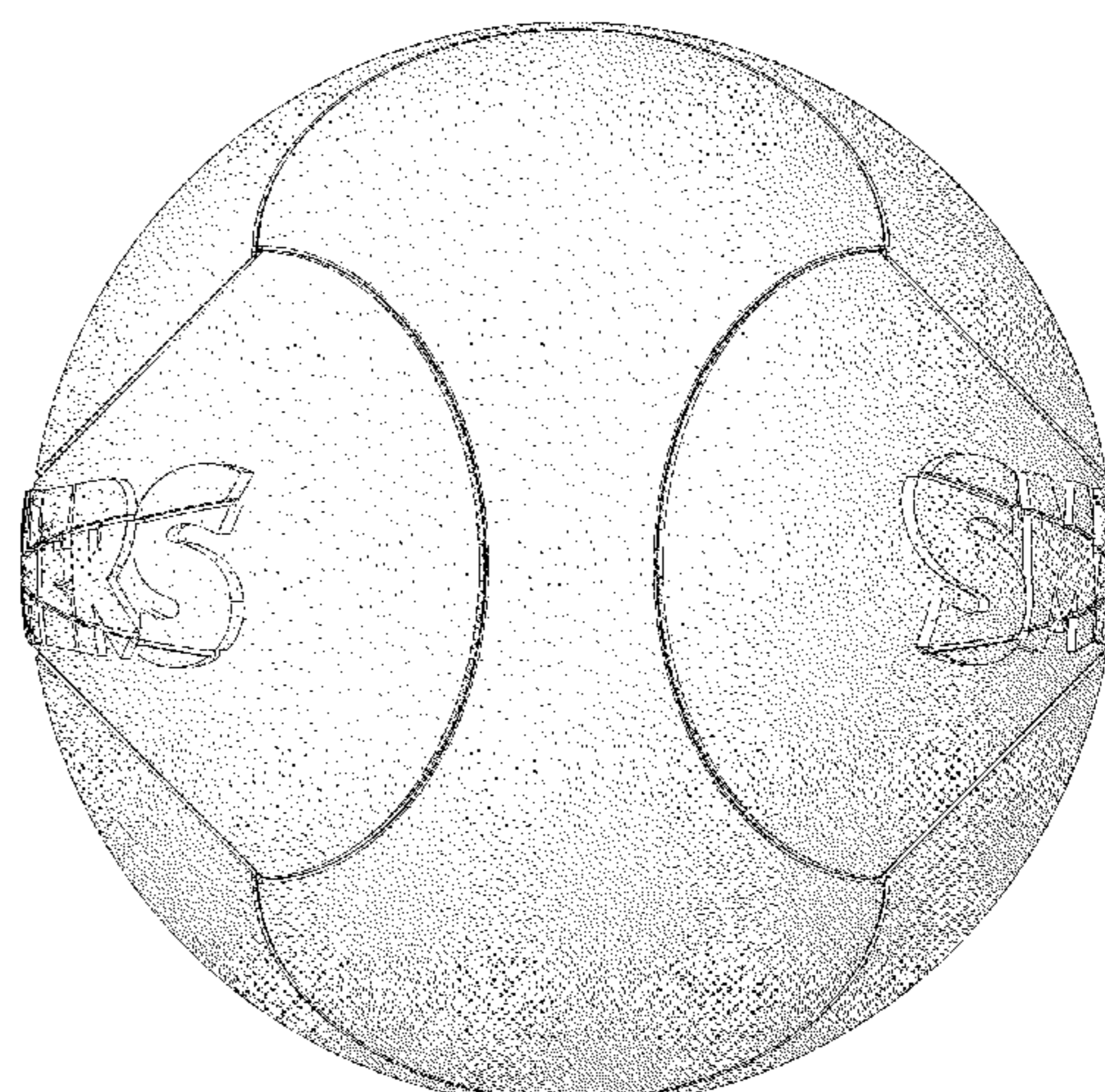
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a ball showing my new design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevational view thereof.
FIG. 4 is a top plan view thereof.
FIG. 5 is a bottom plan view thereof.
FIG. 6 is a left side elevational view thereof.
FIG. 7 is a right side elevational view thereof; and,
FIG. 8 is a diametric cross-sectional view thereof.
The broken lines showing the interior ball portions in FIG. 8 are for illustrative purposes only; and form no part of the claimed design.

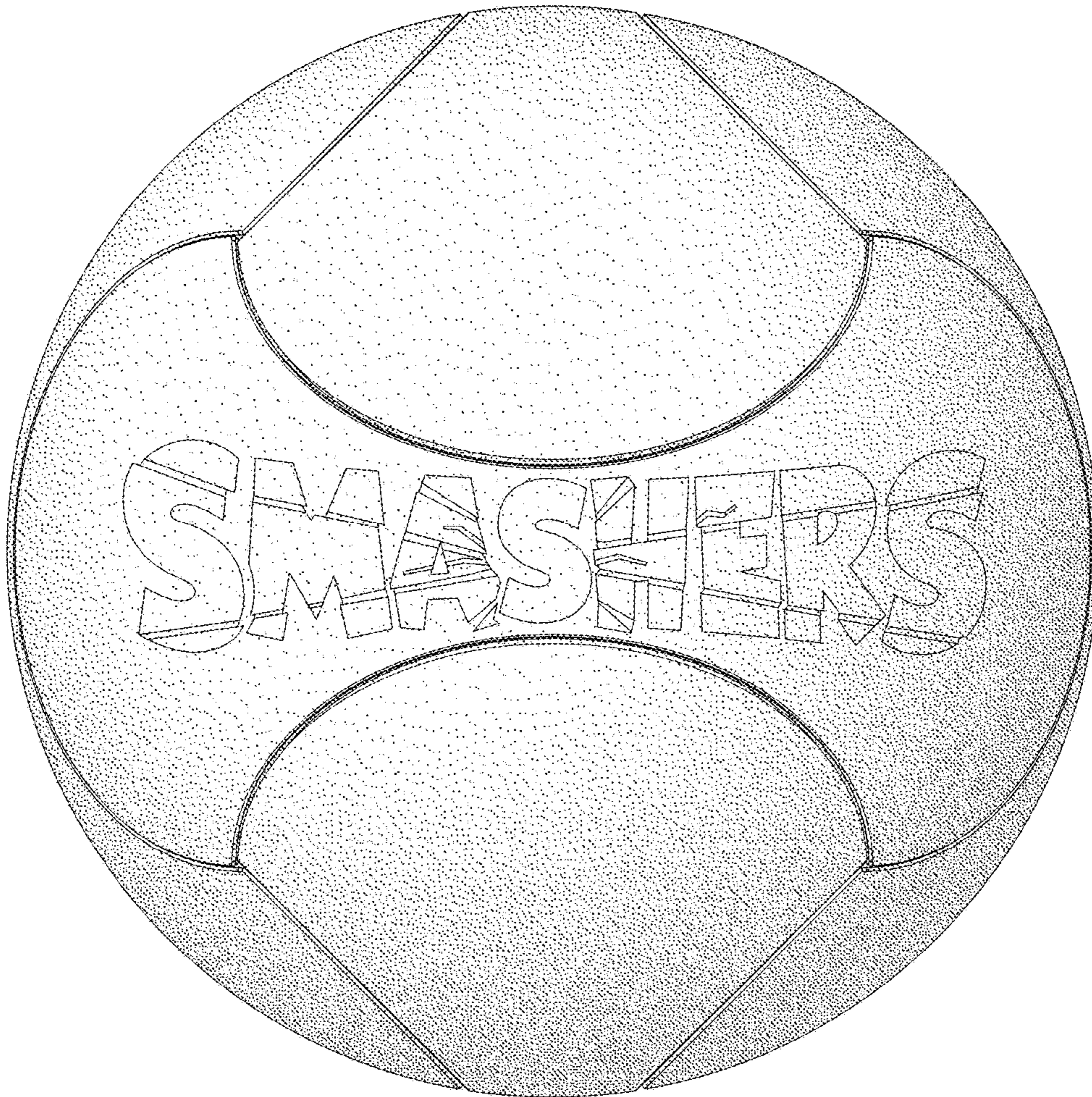

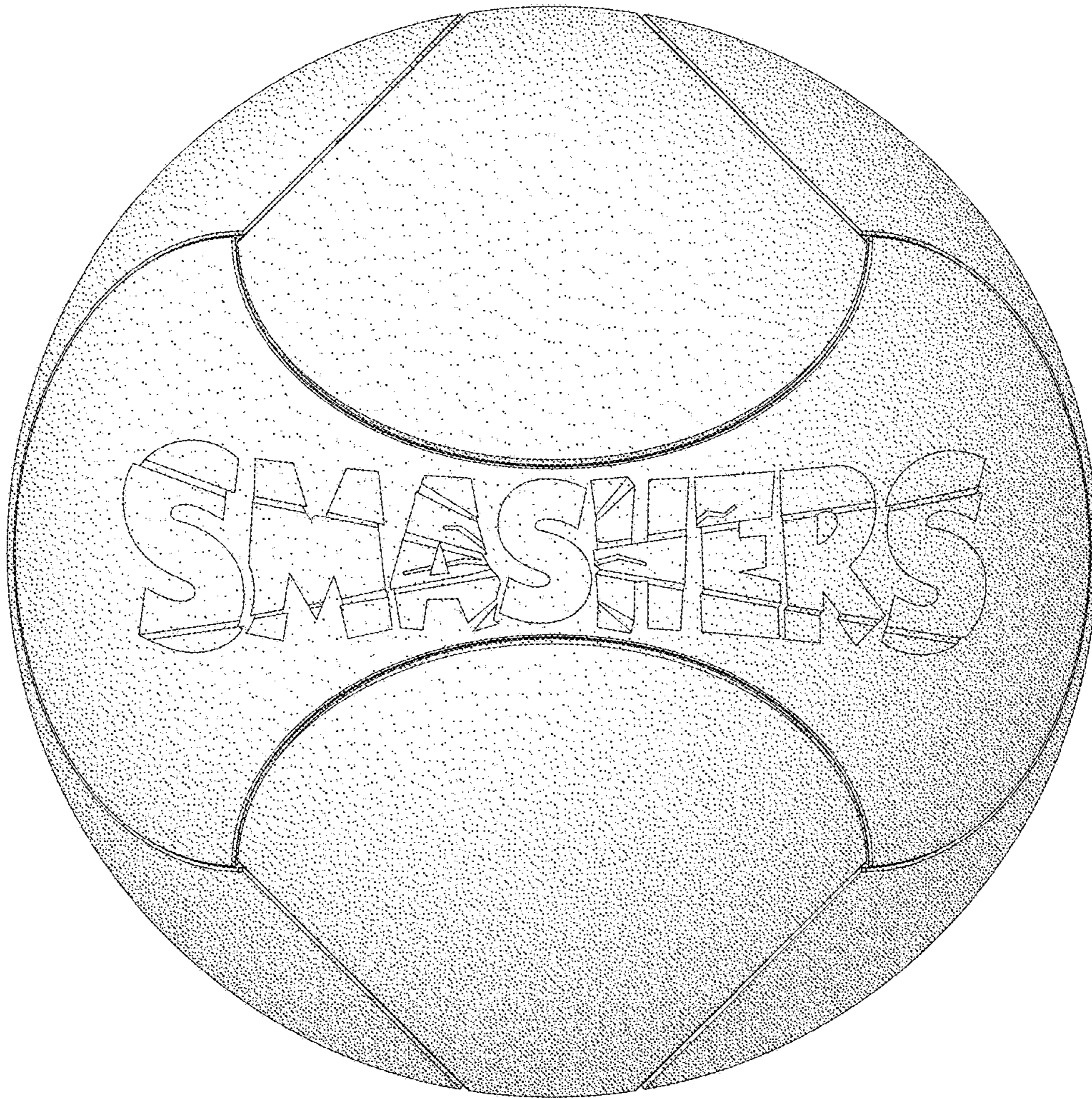

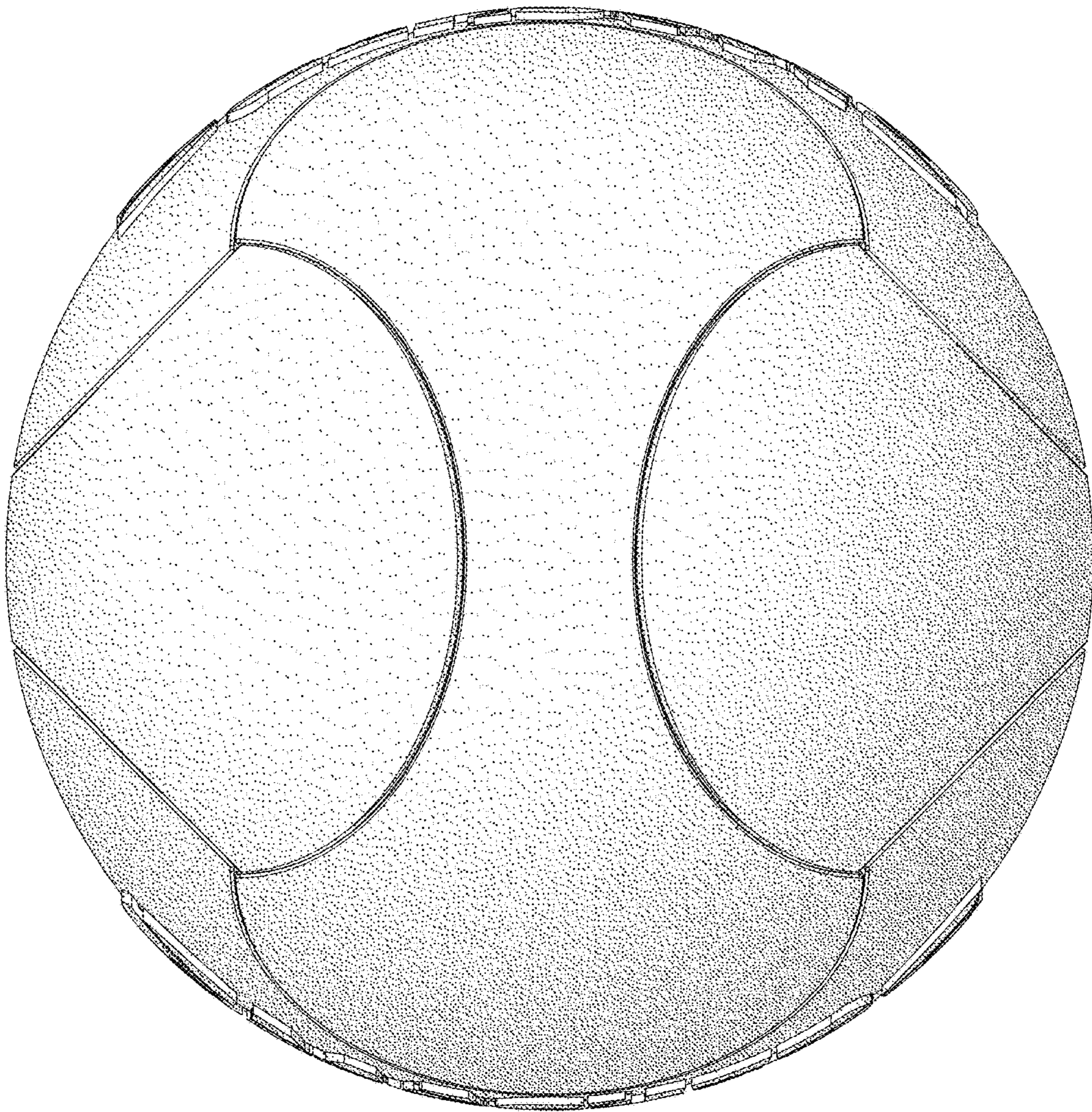

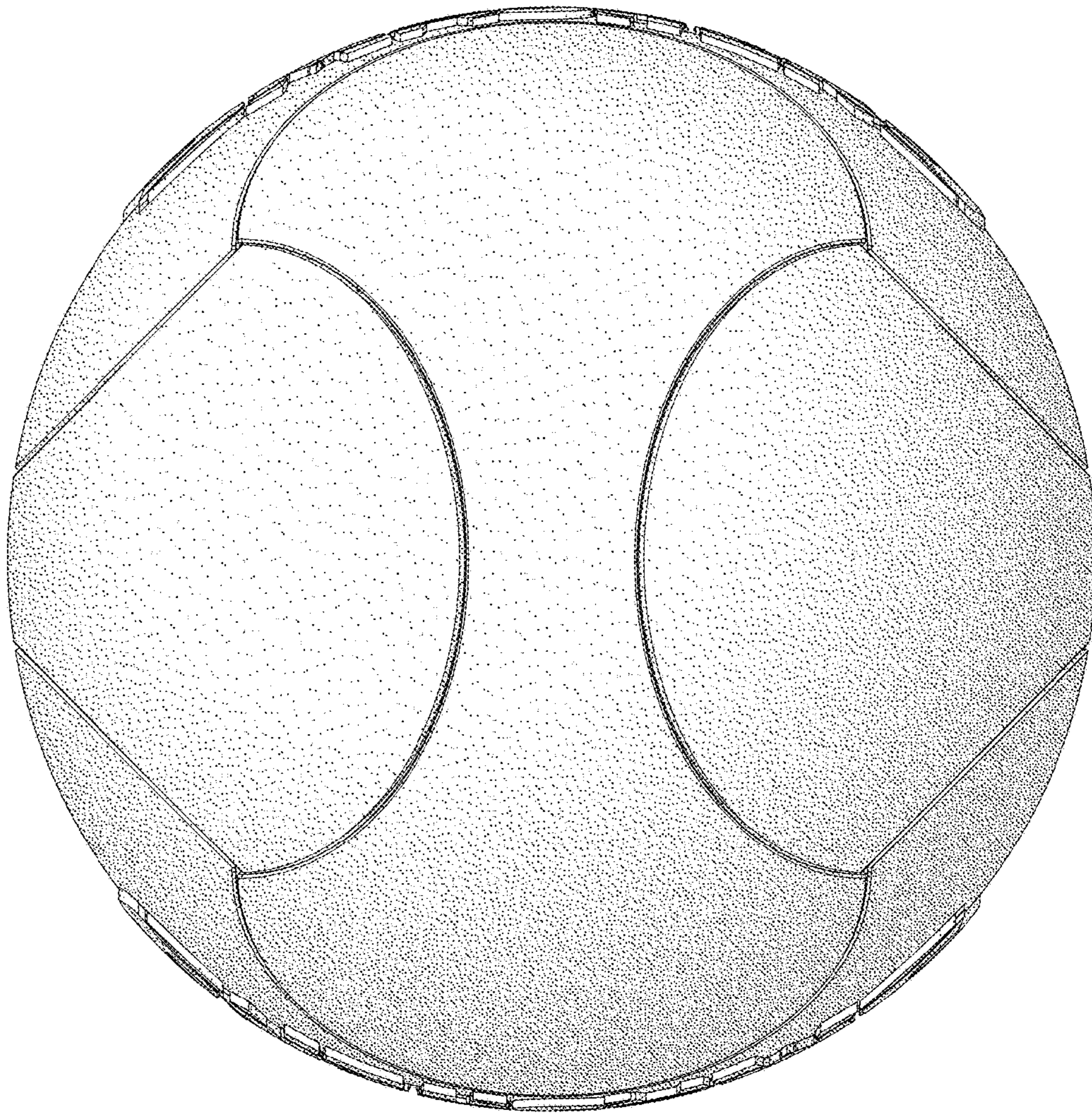

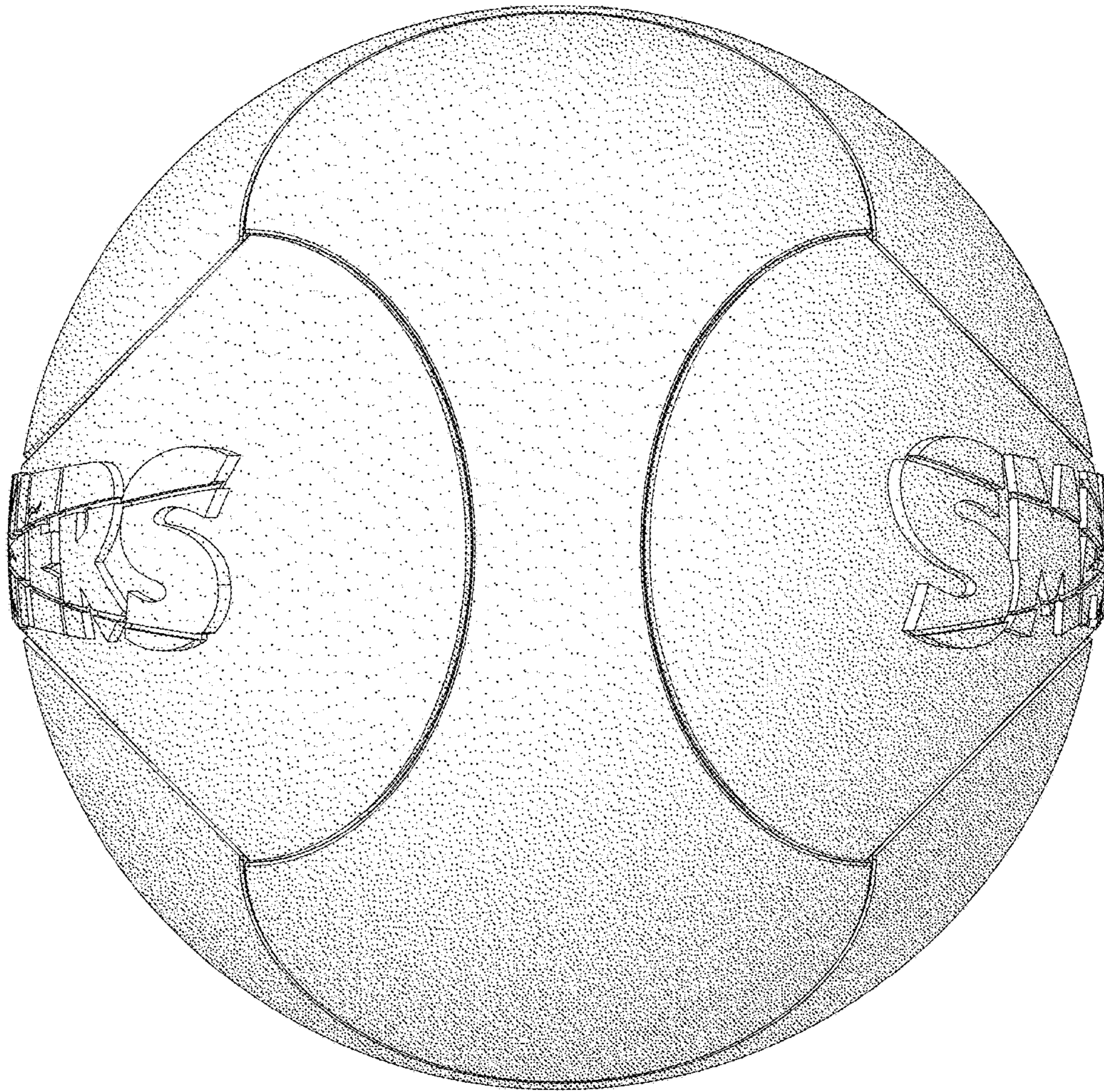

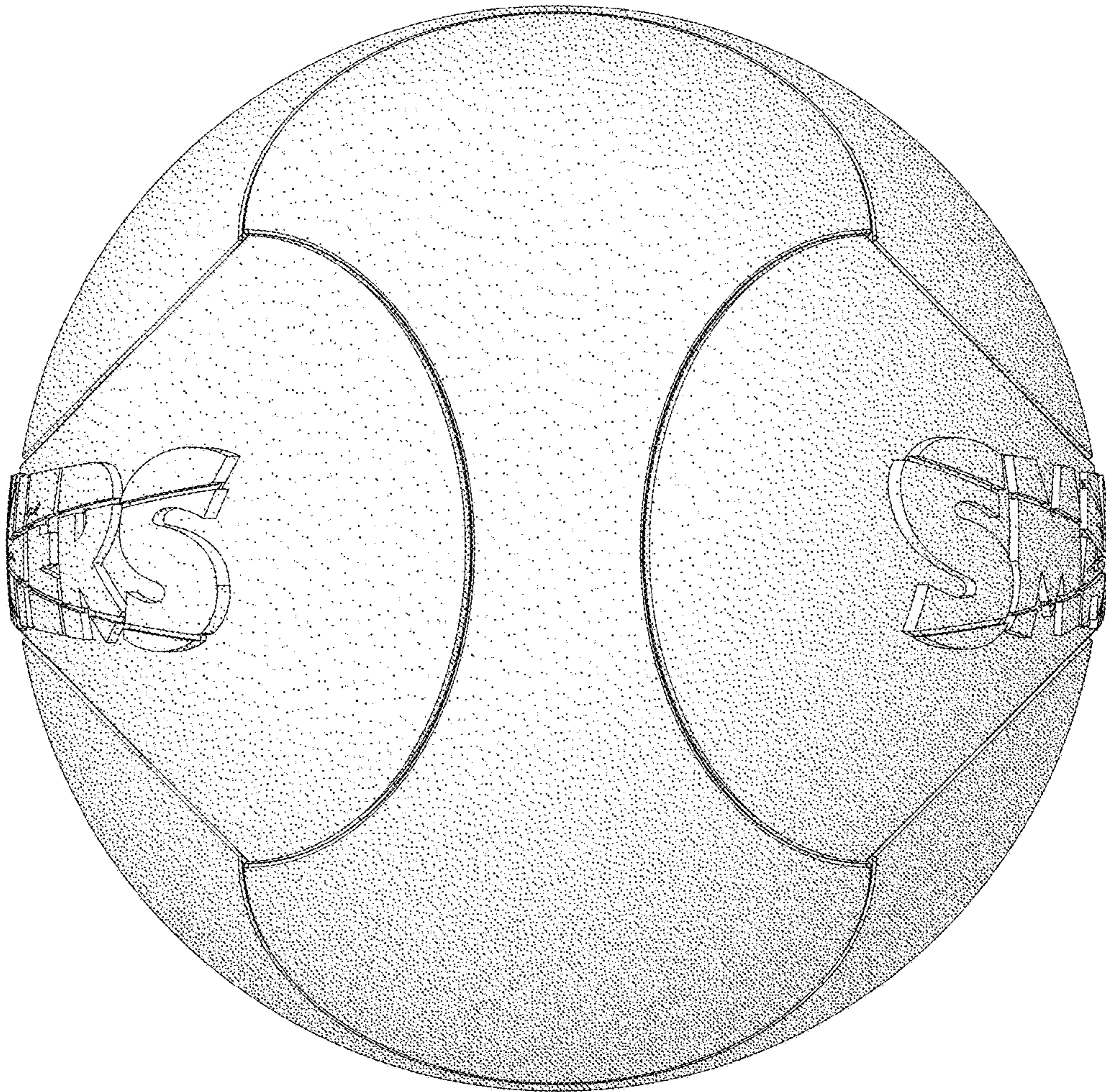

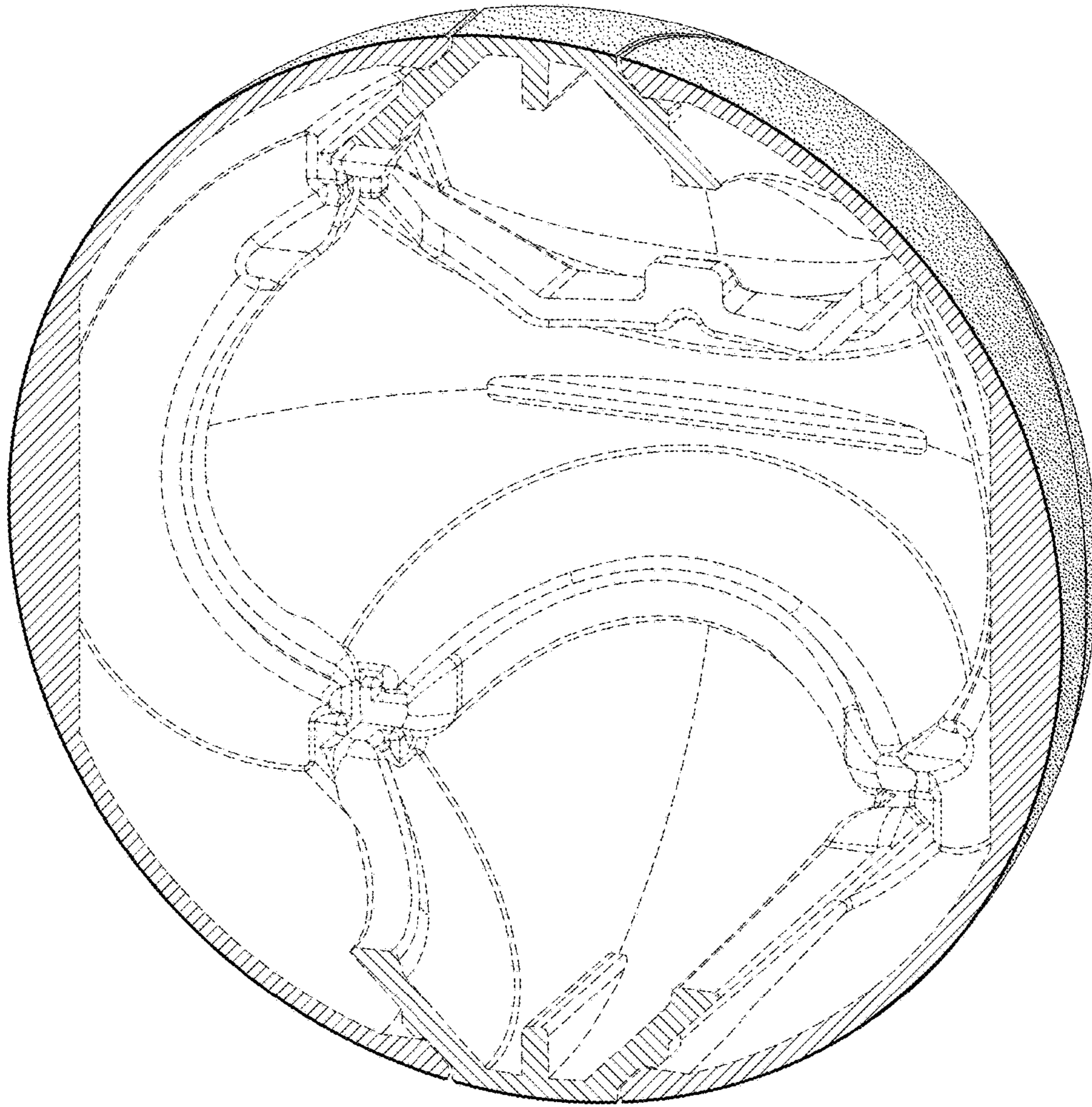
