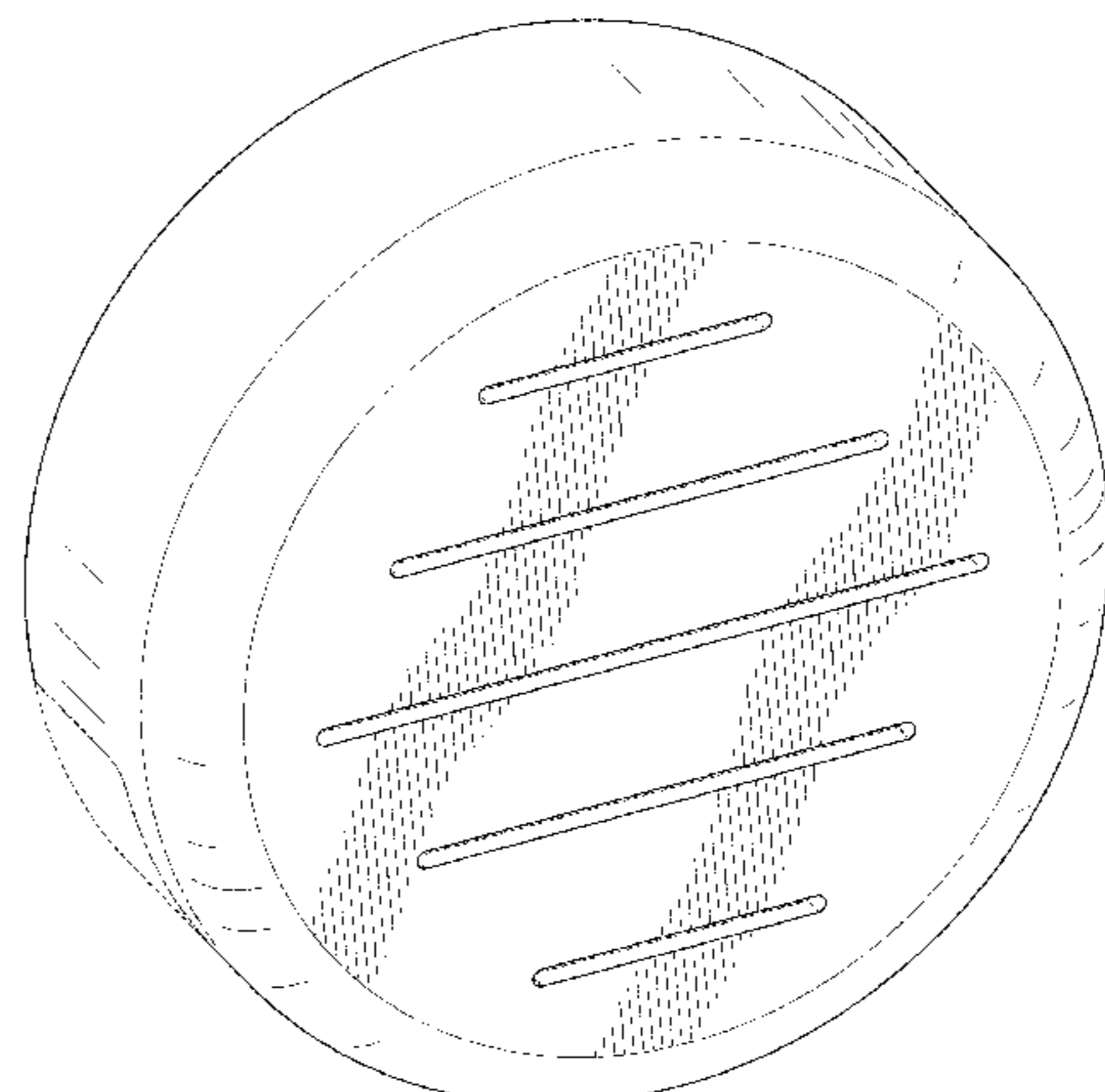
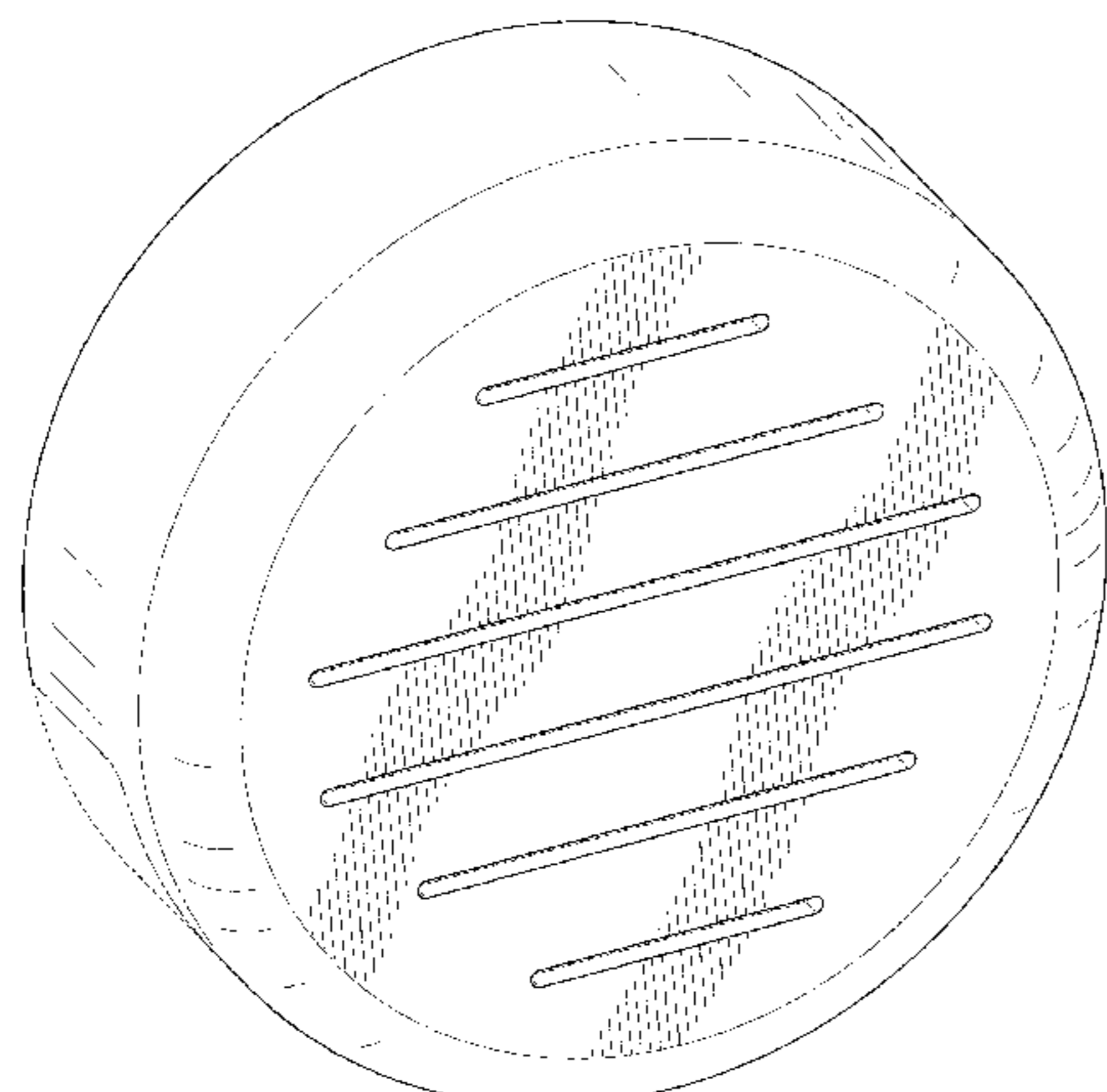
(57) **CLAIM**

The ornamental design for an overflow cap, shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of an overflow cap according to my new design; FIG. 2 is another perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof, the opposite, right side being a mirror image thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a cross-sectional view thereof taken along cut lines 8-8 in FIG. 3; FIG. 9 is a perspective view of a second embodiment of an overflow cap according to my new design; FIG. 10 is another perspective view thereof; FIG. 11 is a front elevation view thereof; FIG. 12 is a rear elevation view thereof; FIG. 13 is a left side elevation view thereof, the opposite, right side being a mirror image thereof; FIG. 14 is a top plan view thereof; FIG. 15 is a bottom plan view thereof; FIG. 16 is a cross-sectional view thereof taken along cut lines 16-16 in FIG. 11; FIG. 17 is a perspective view of a third embodiment of an overflow cap according to my new design; FIG. 18 is another perspective view thereof; FIG. 19 is a front elevation view thereof; FIG. 20 is a rear elevation view thereof; FIG. 21 is a left side elevation view thereof, the opposite, right side being a mirror image thereof; FIG. 22 is a top plan view thereof; FIG. 23 is a bottom plan view thereof; and, FIG. 24 is a cross-sectional view thereof taken along cut lines 24-24 in FIG. 19.

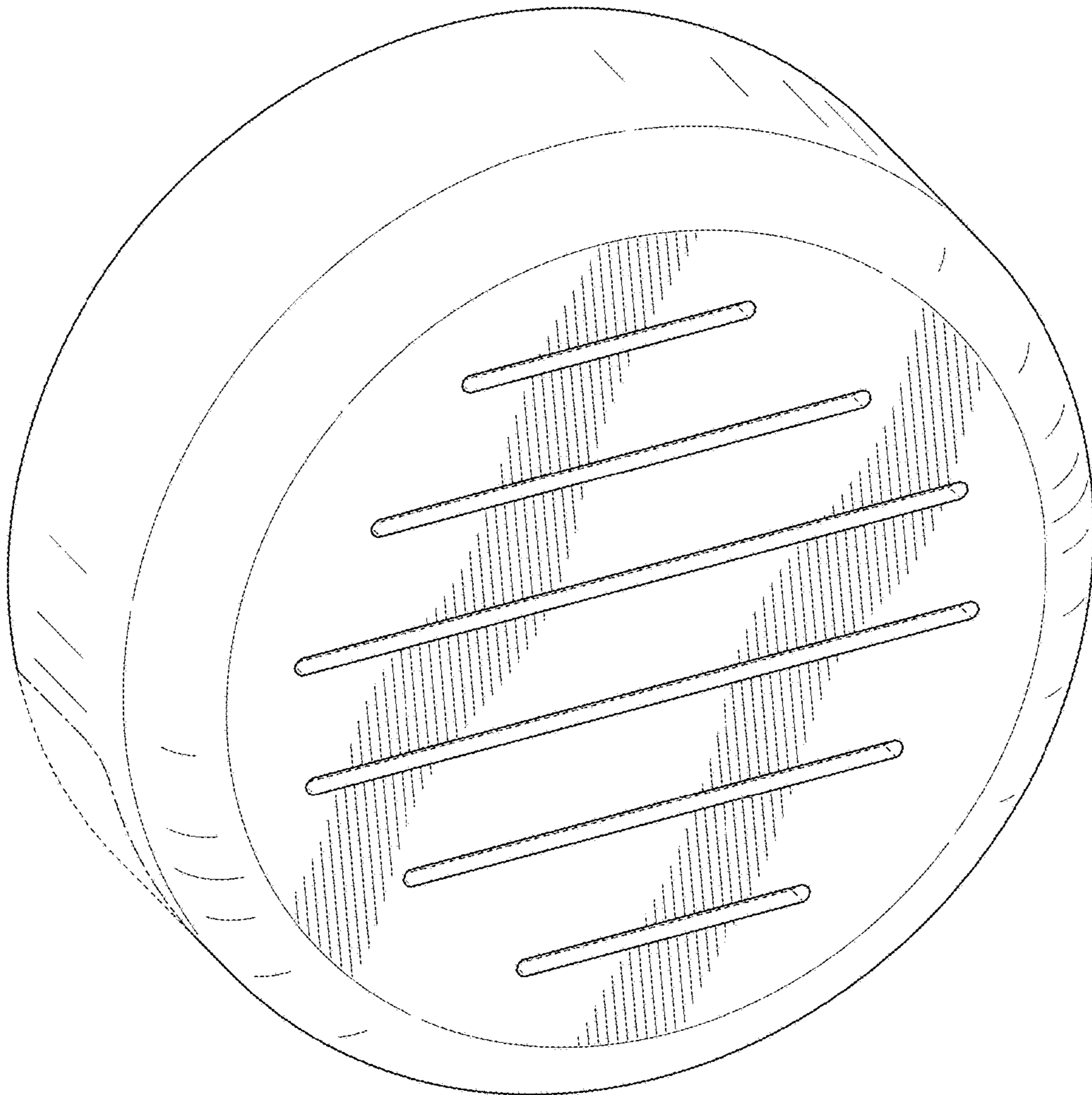

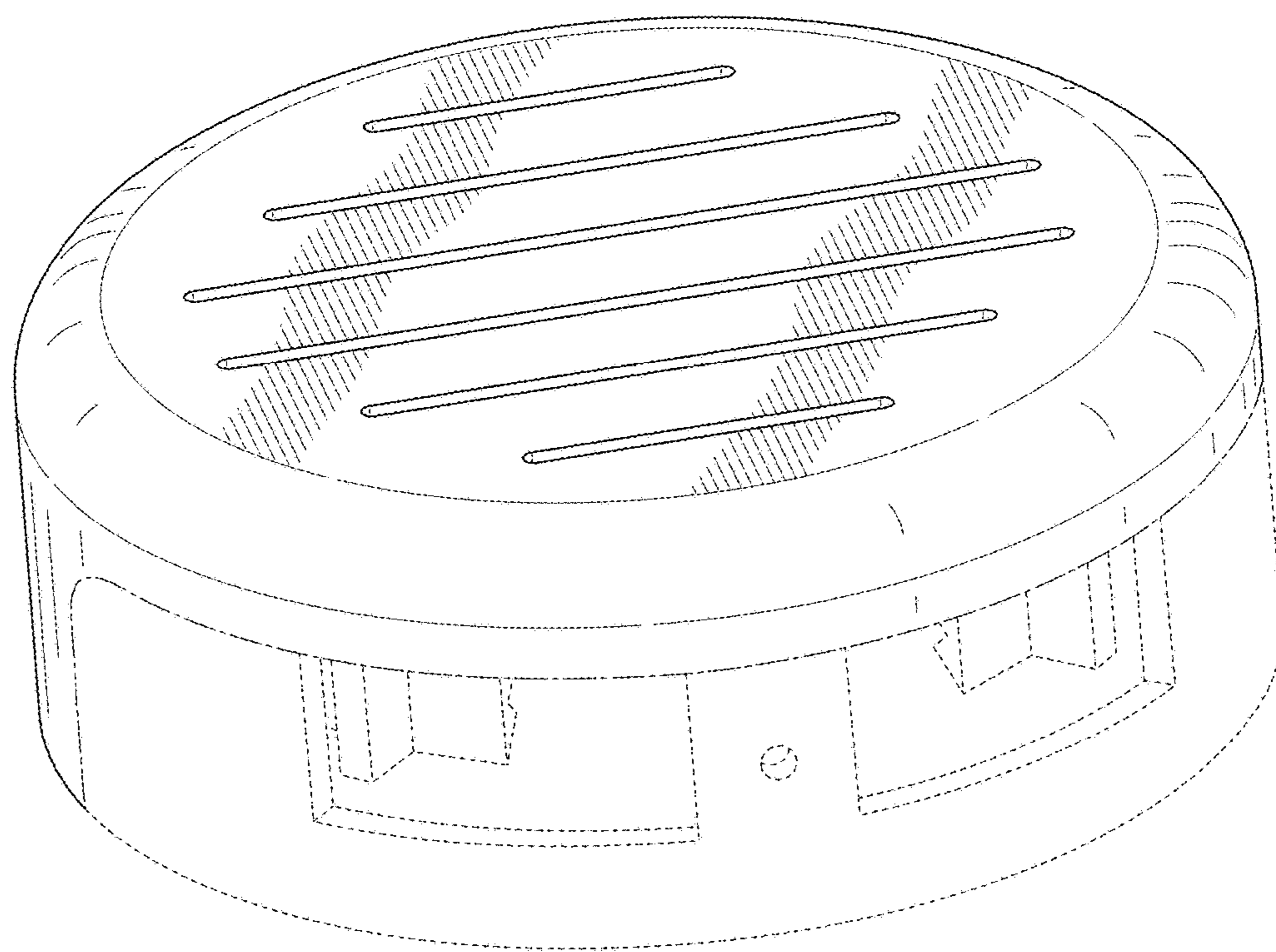

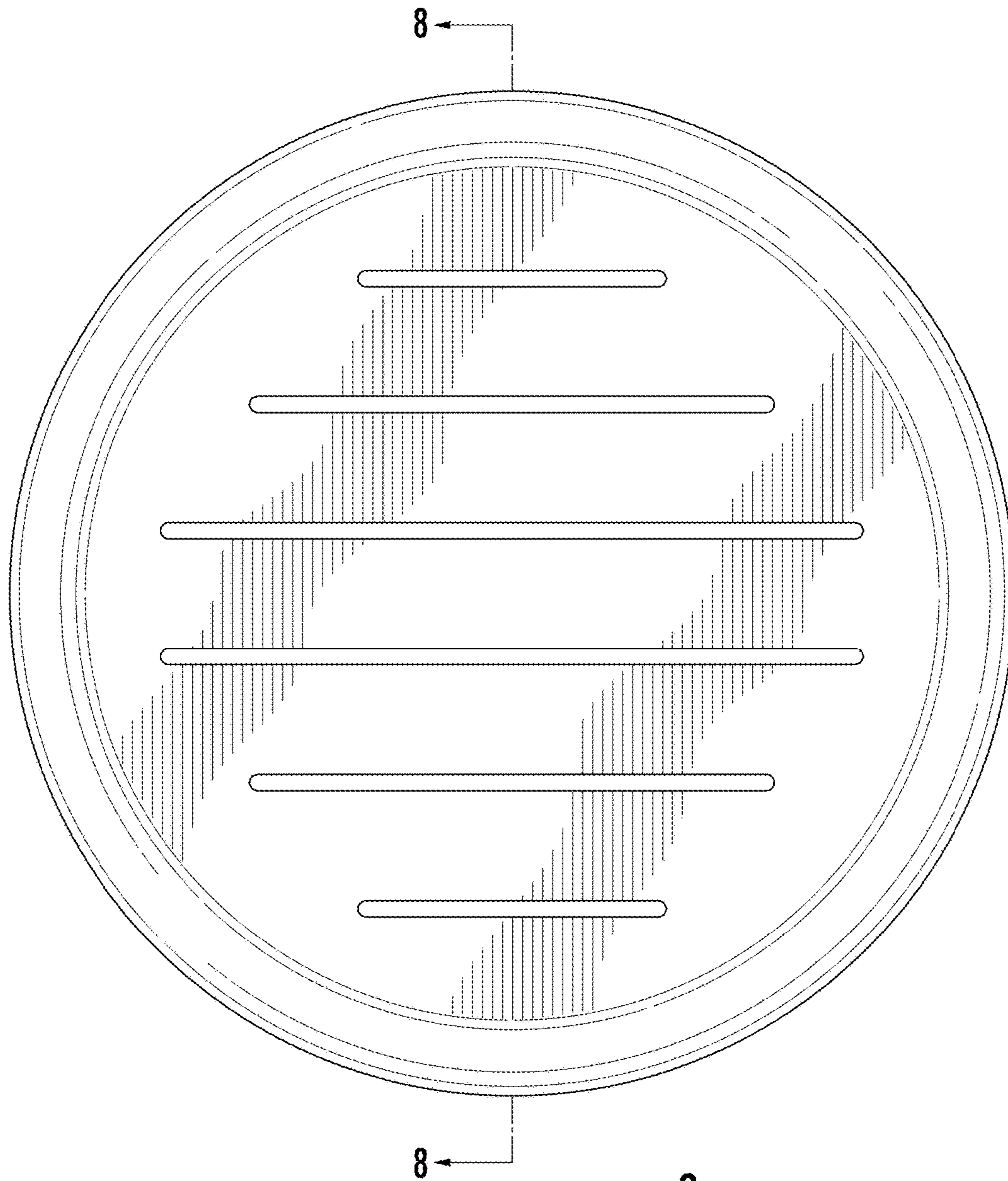

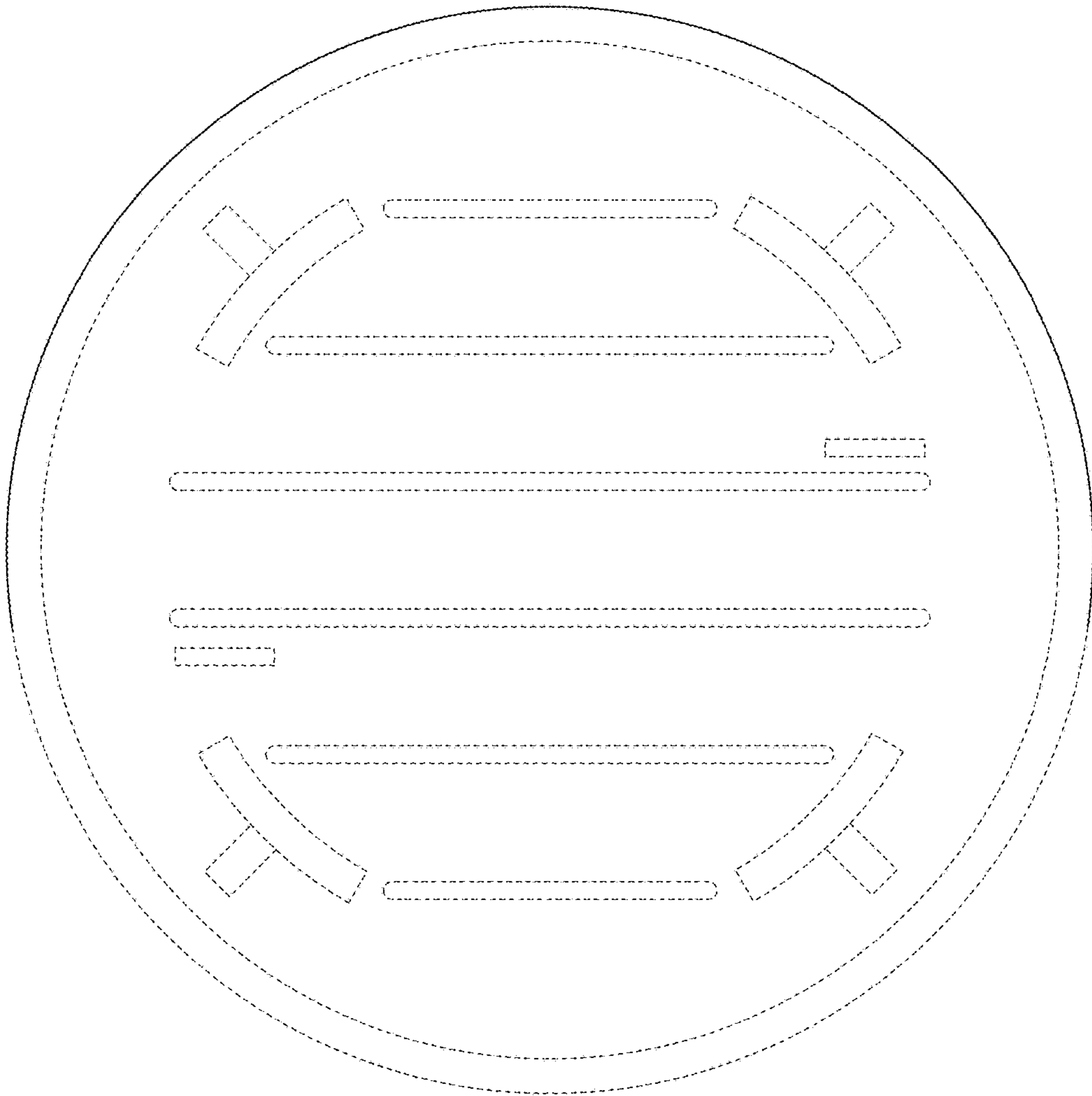
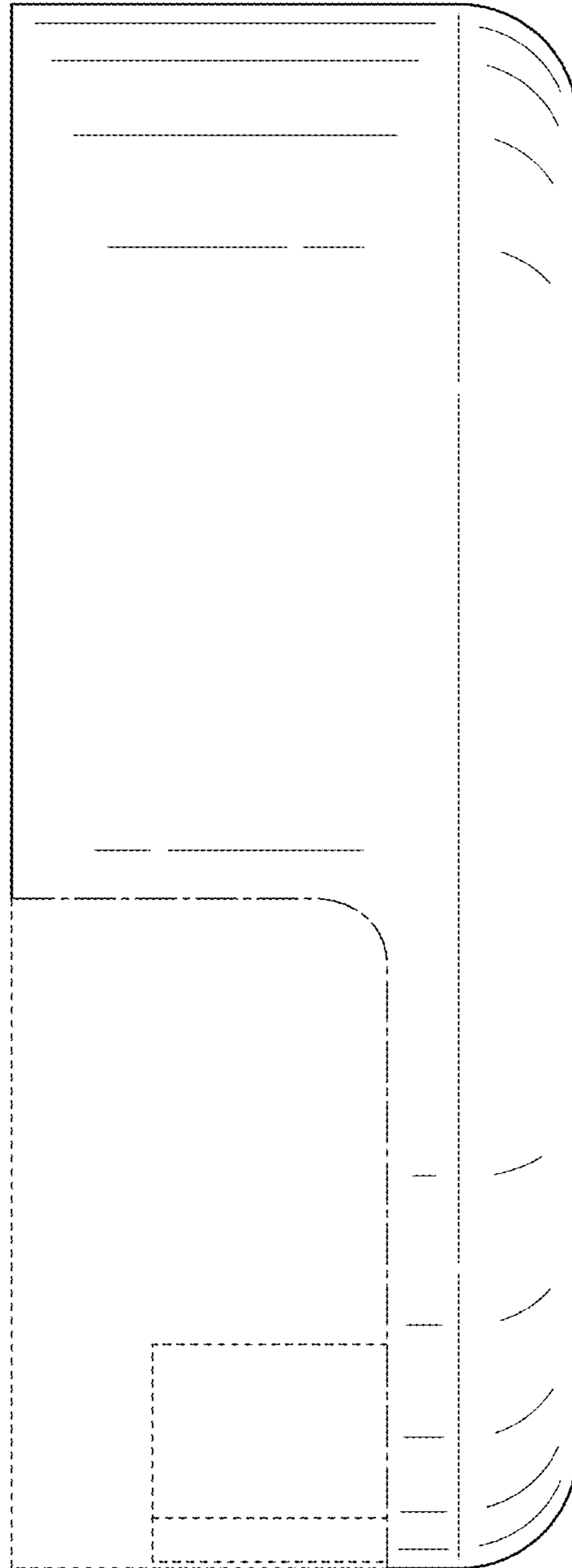

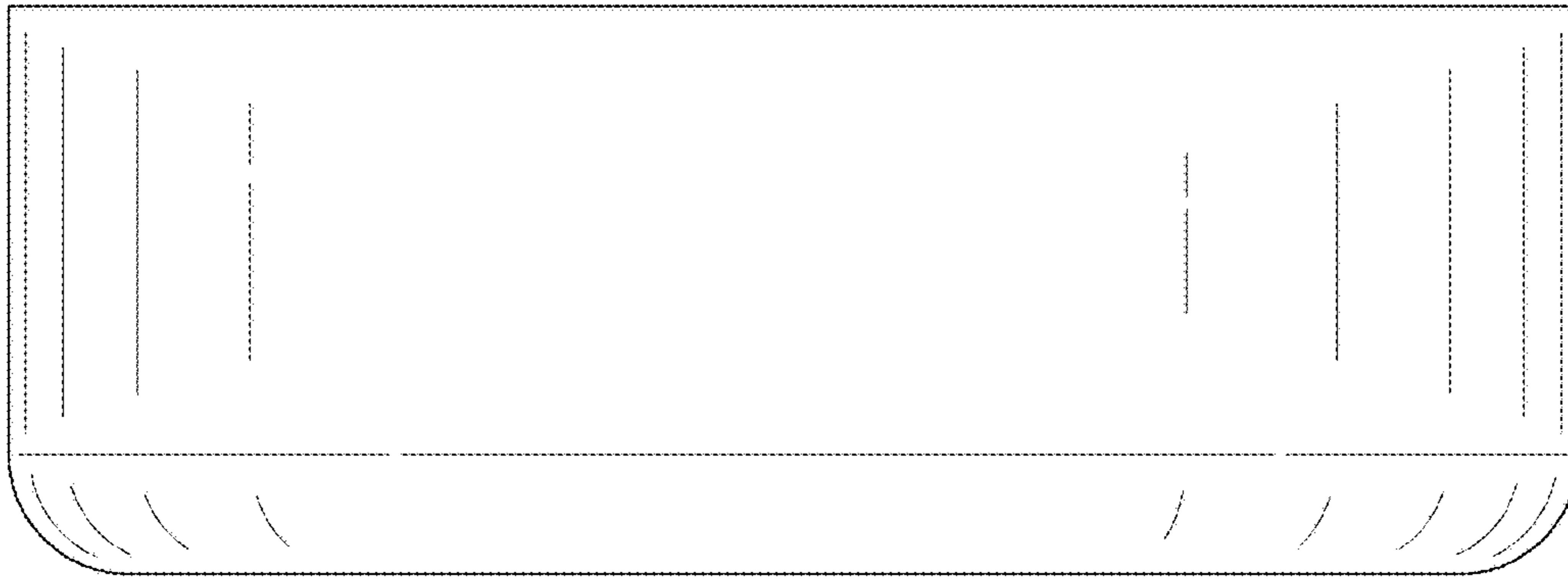

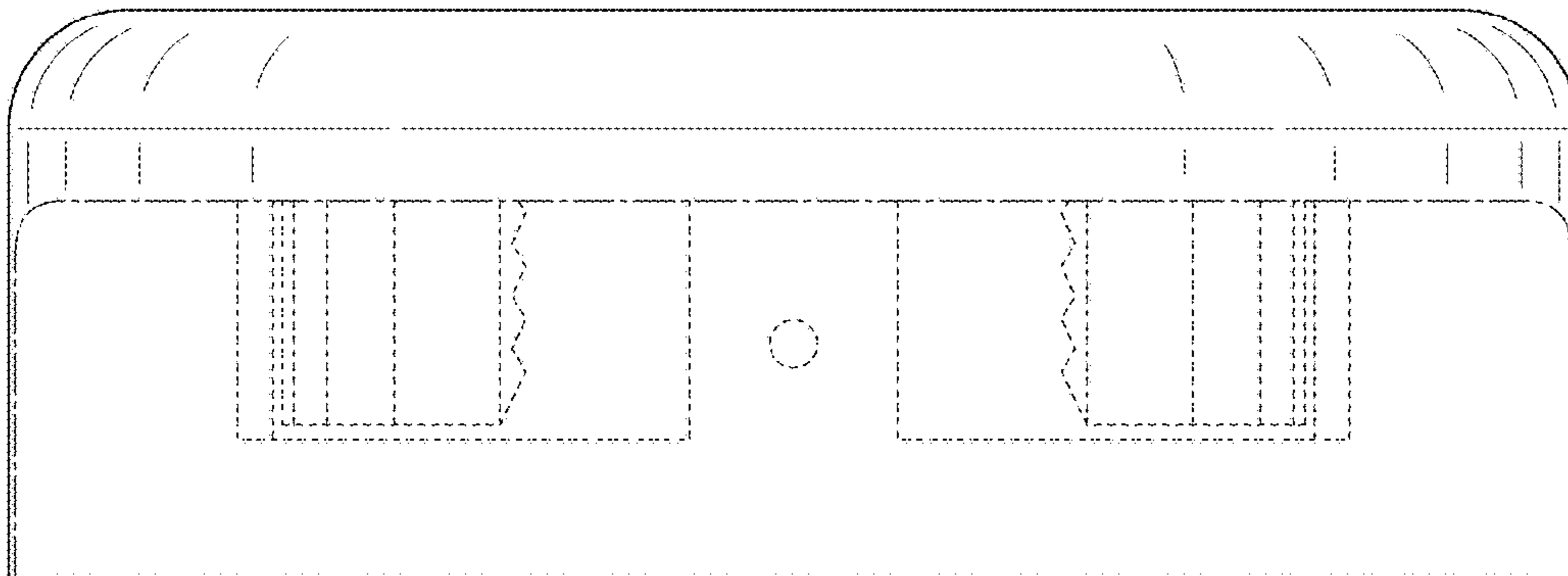
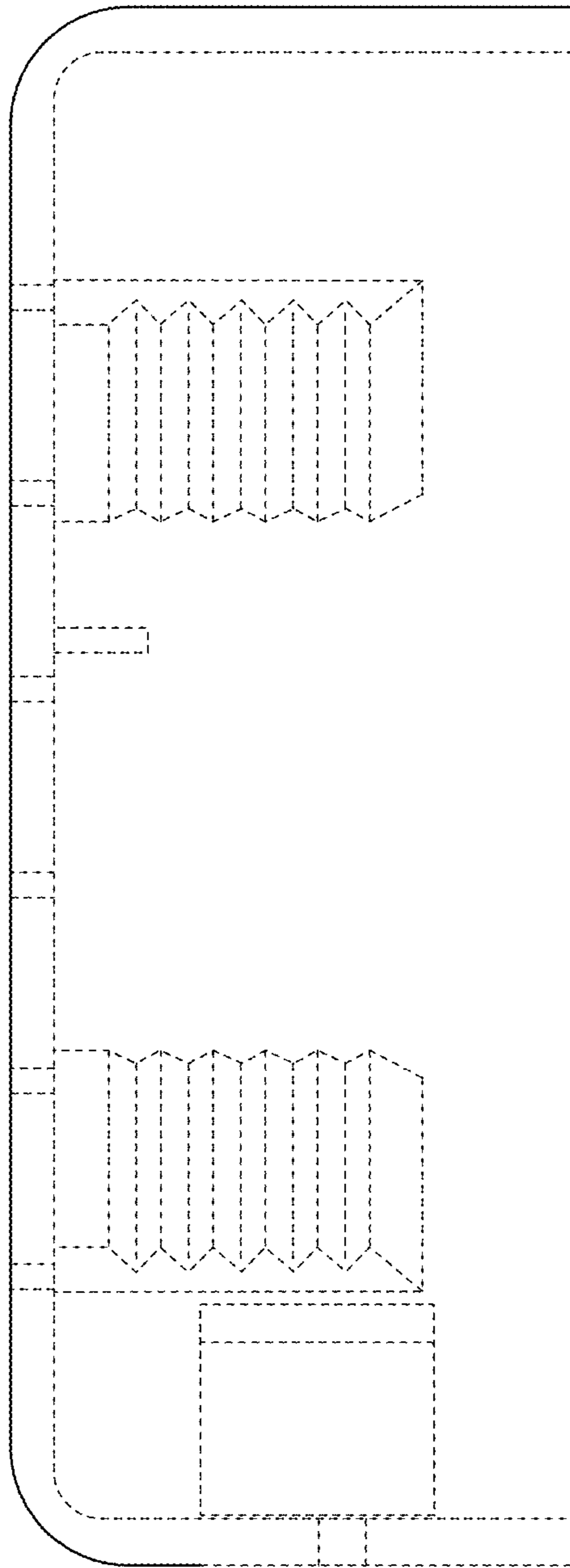

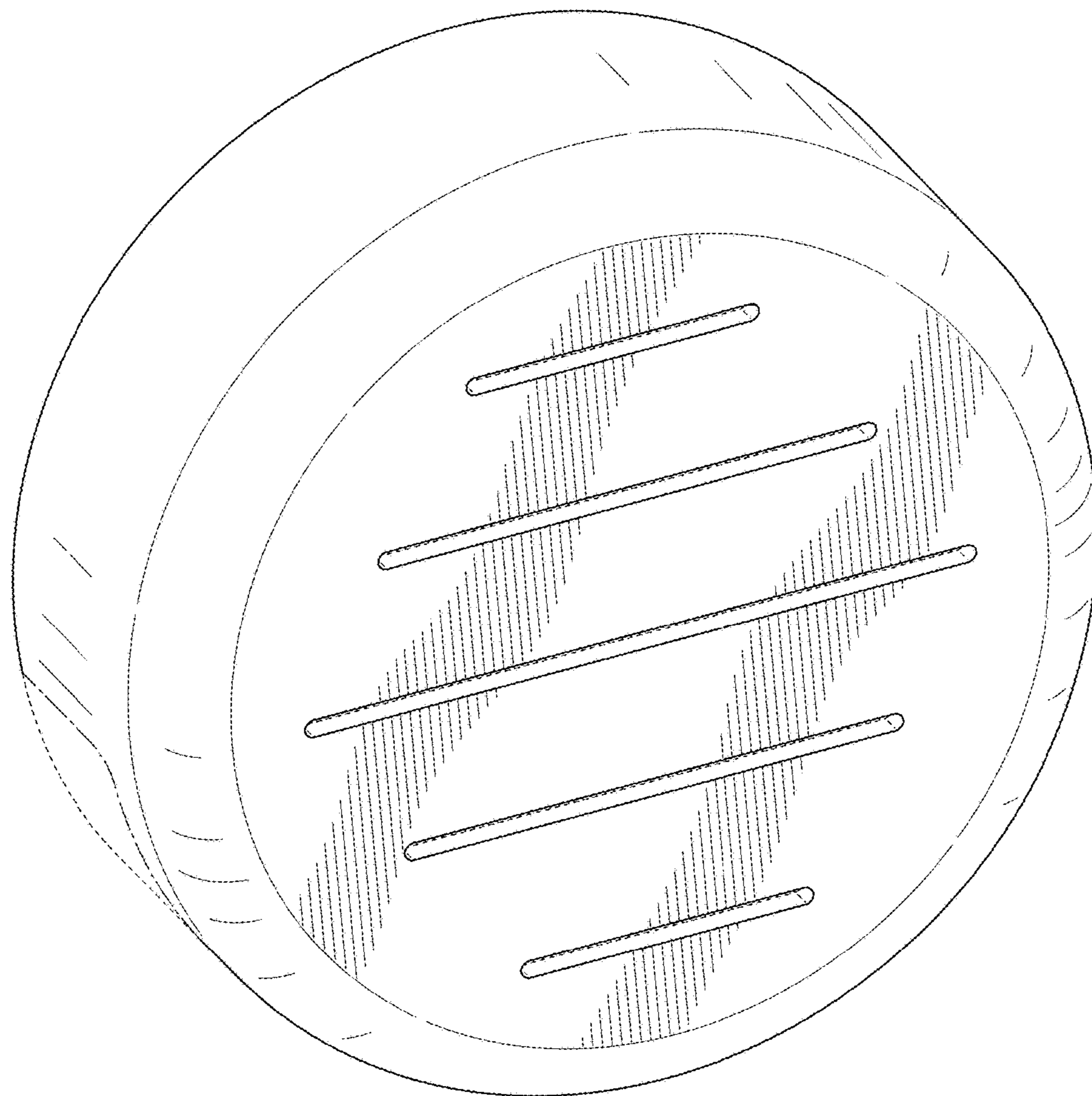

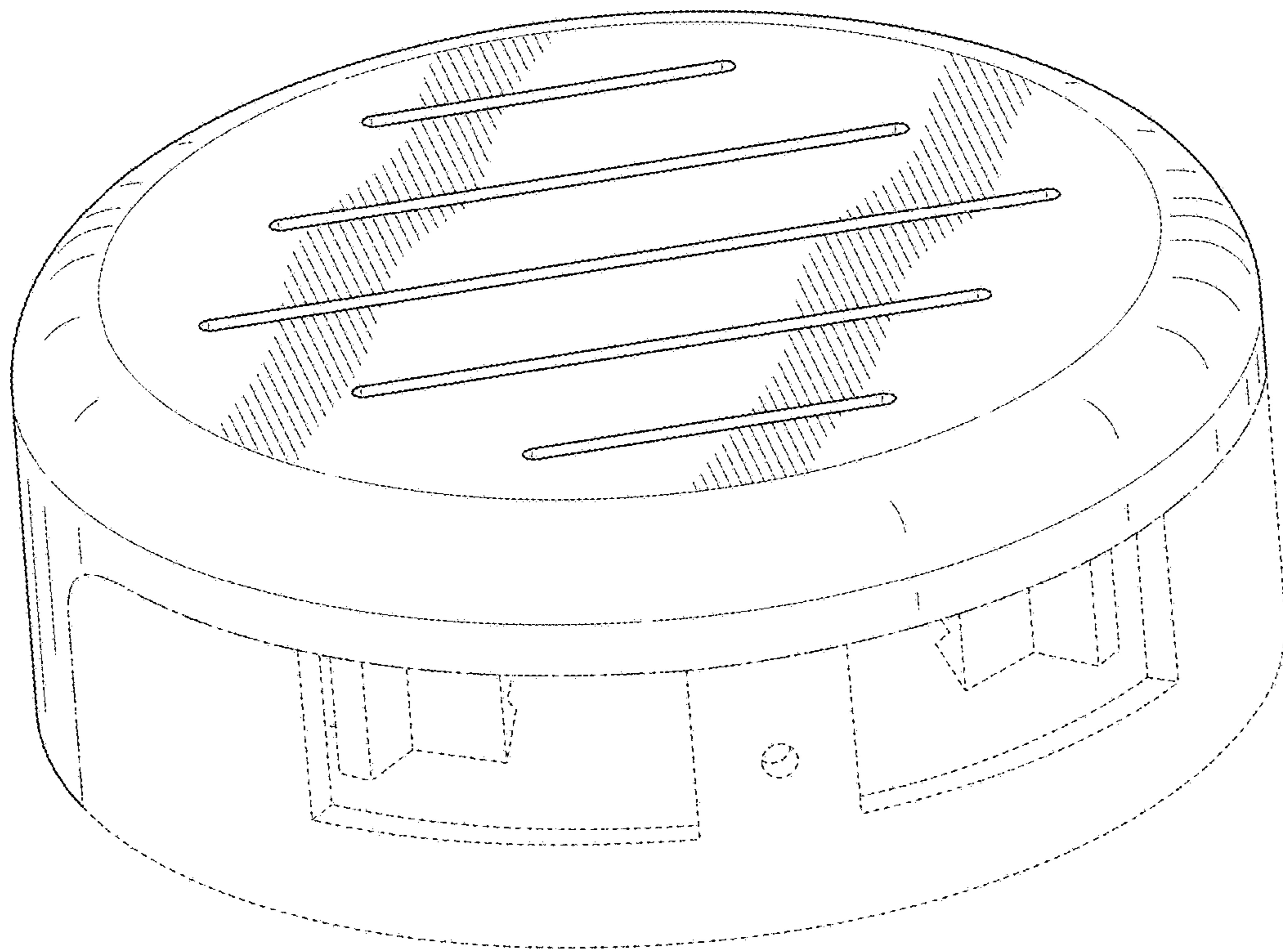

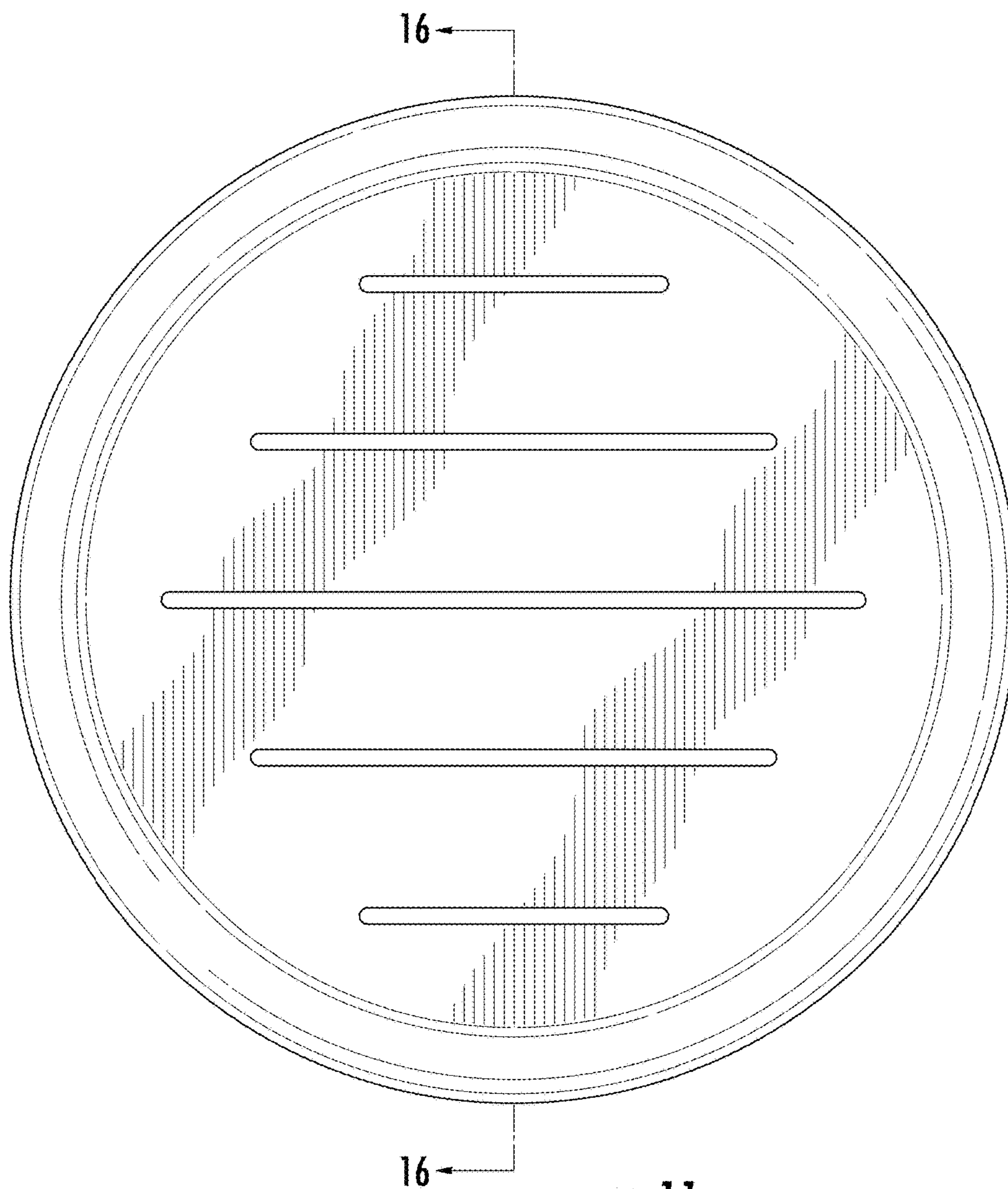

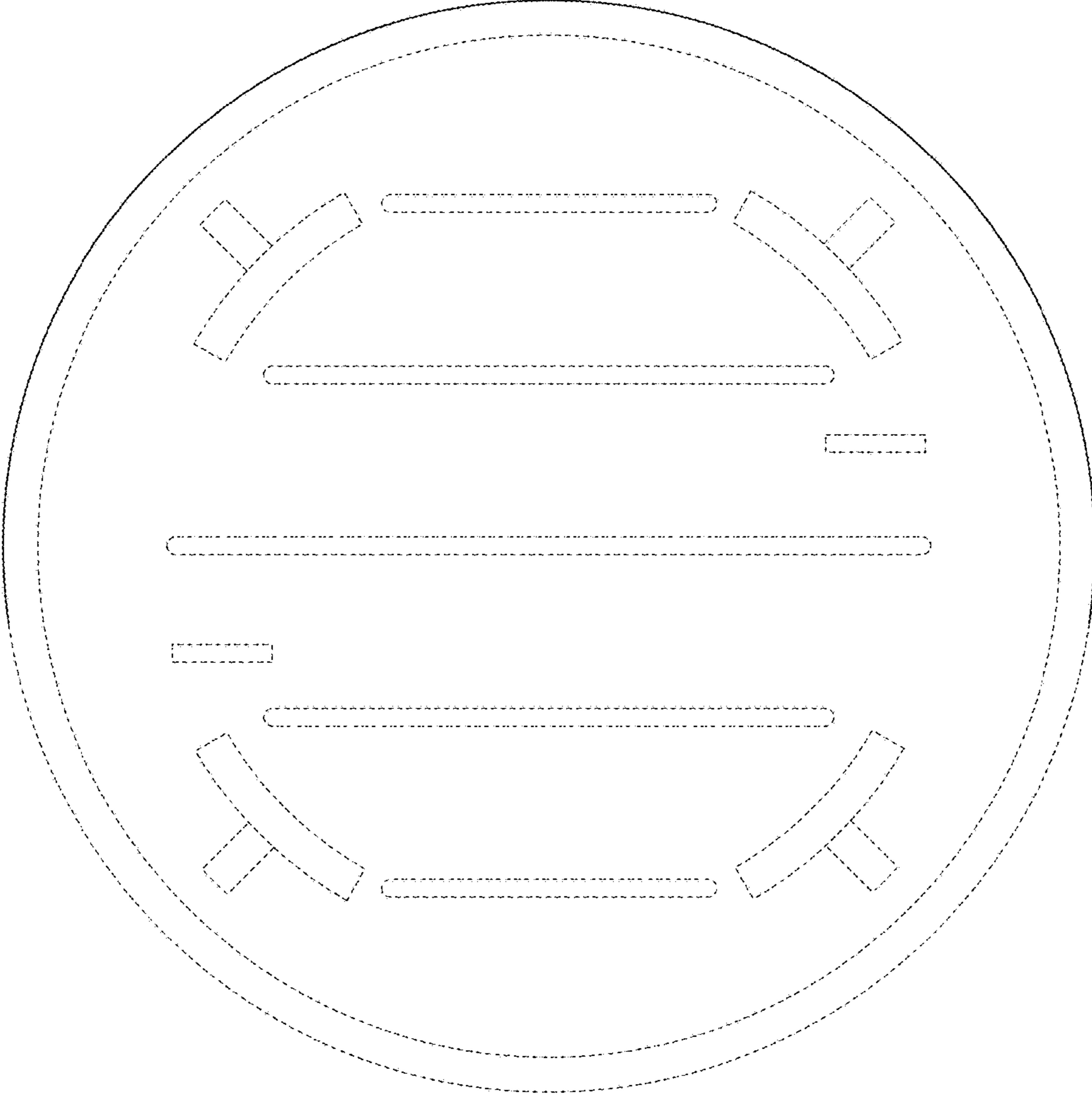
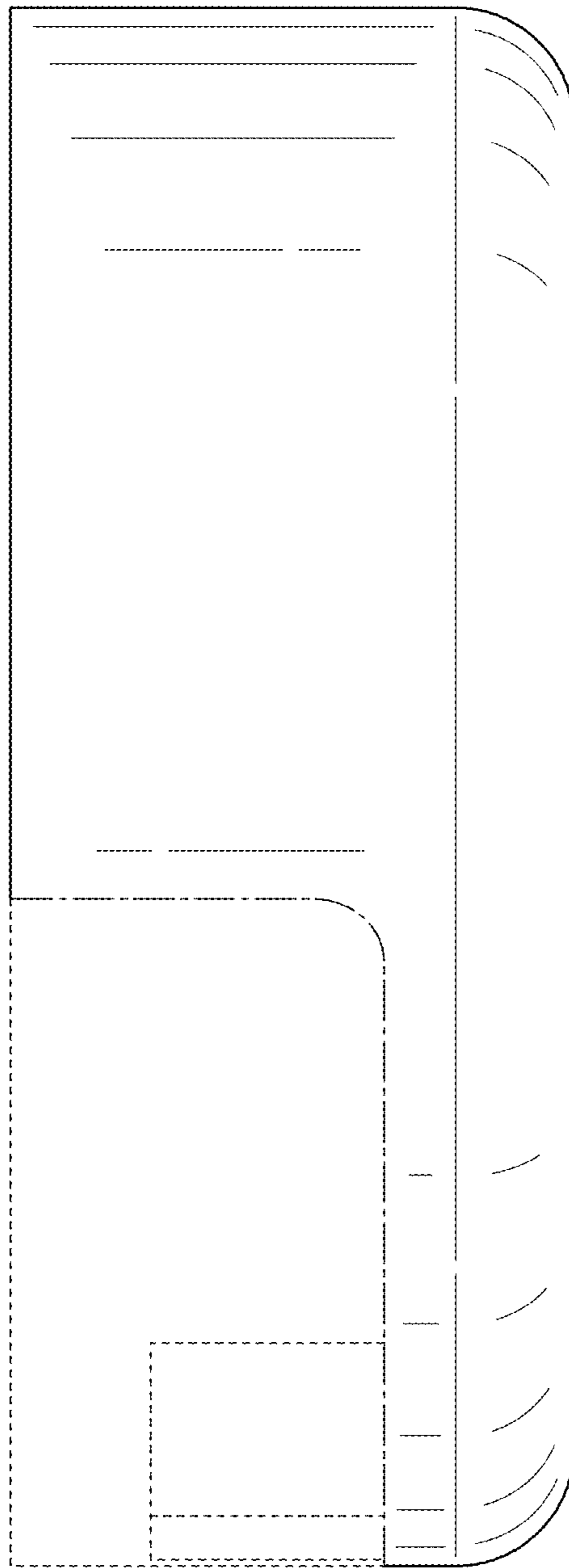

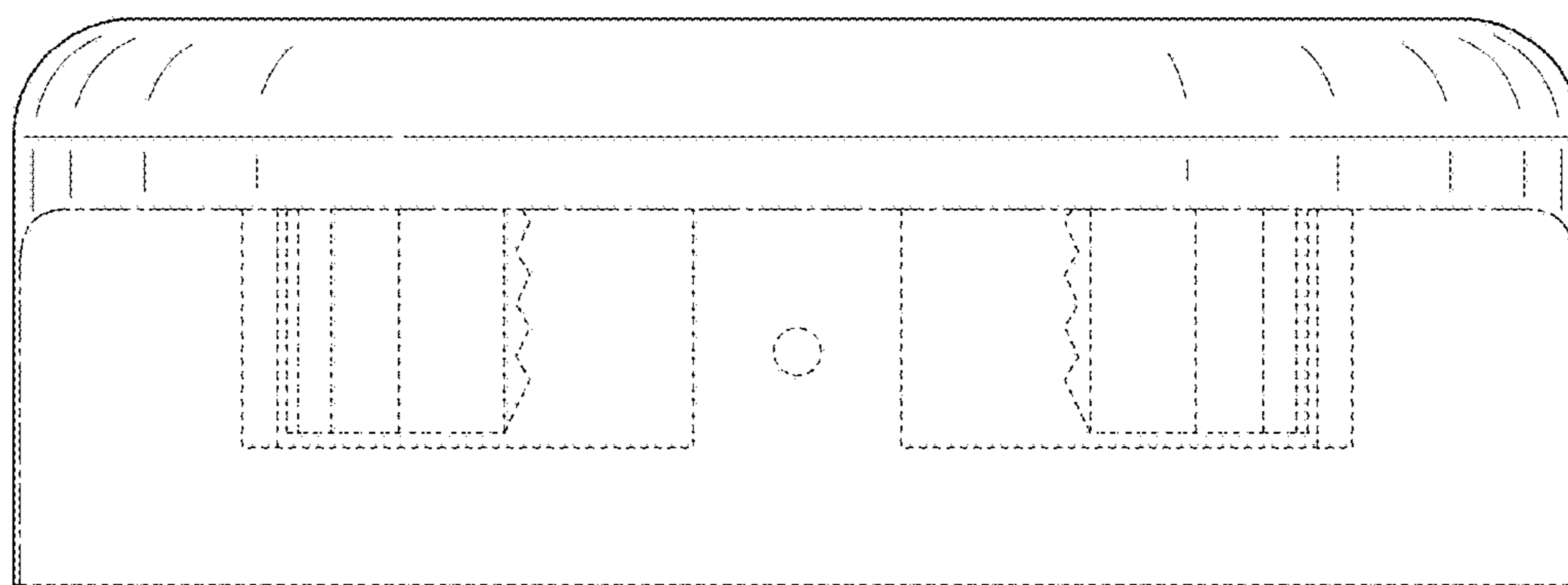
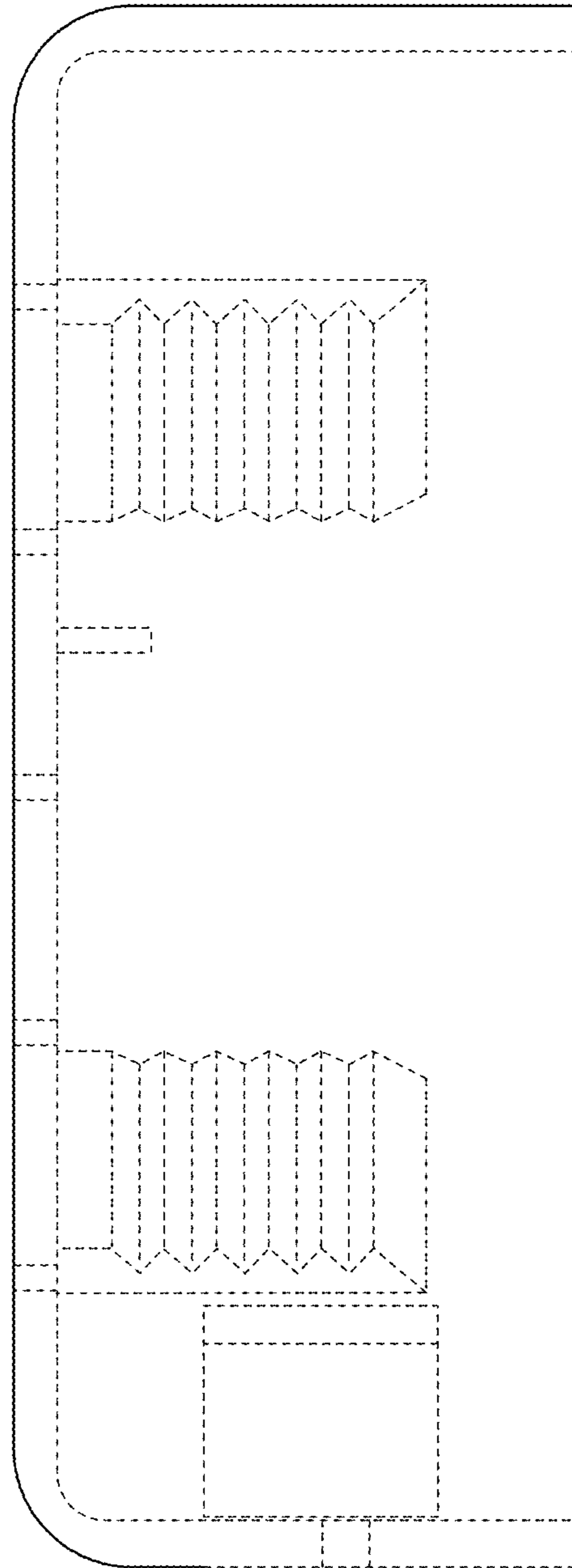

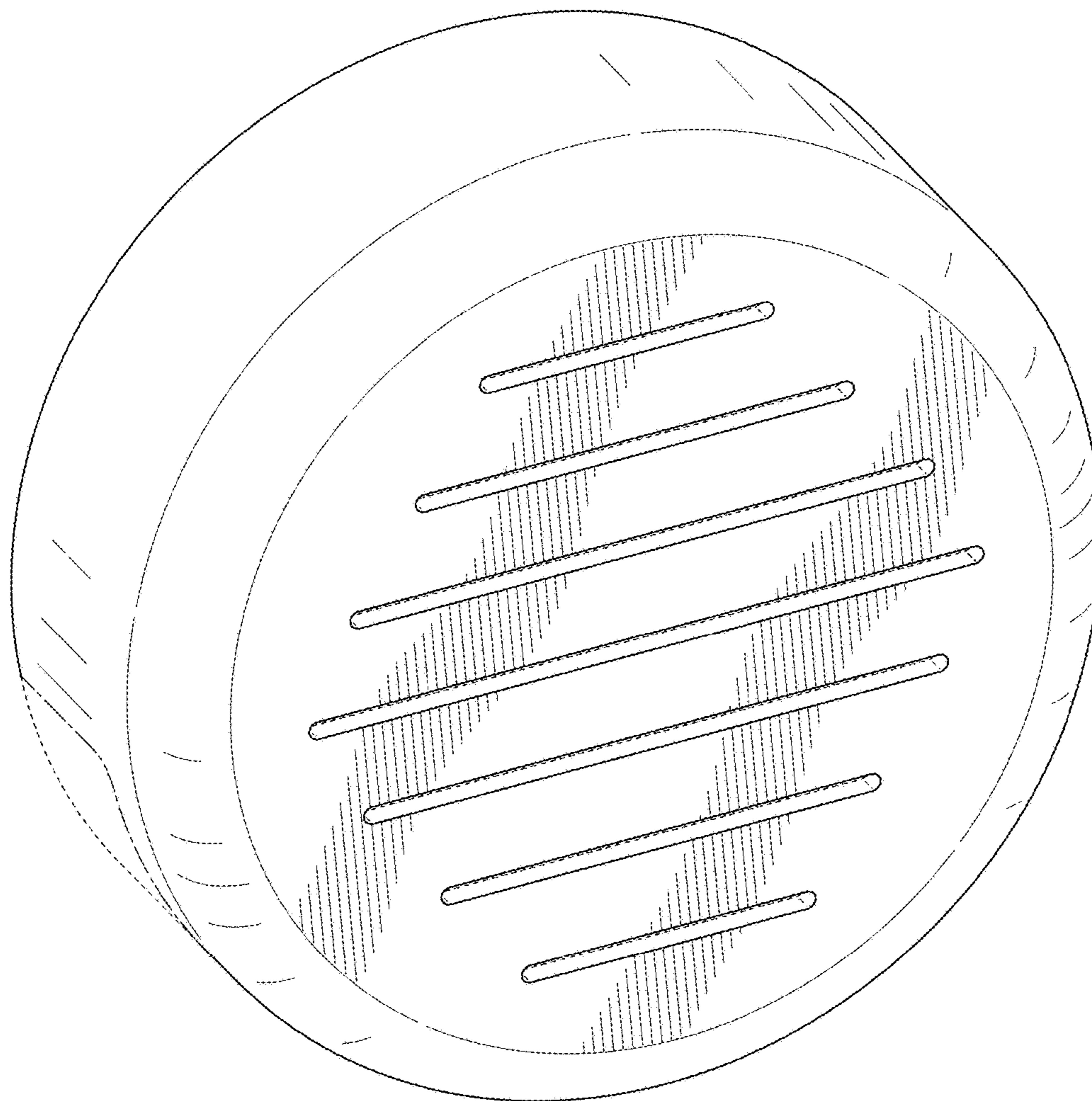

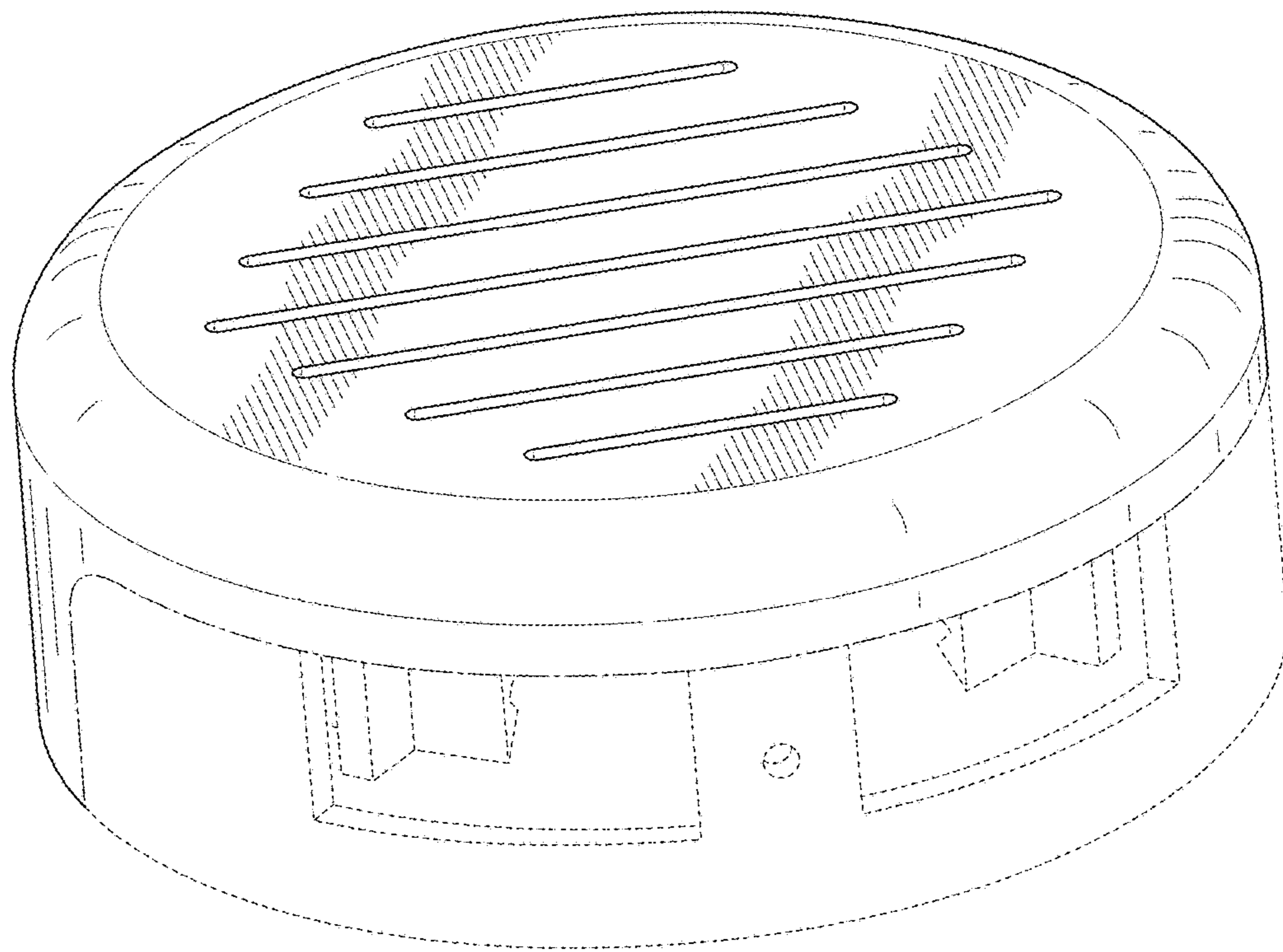

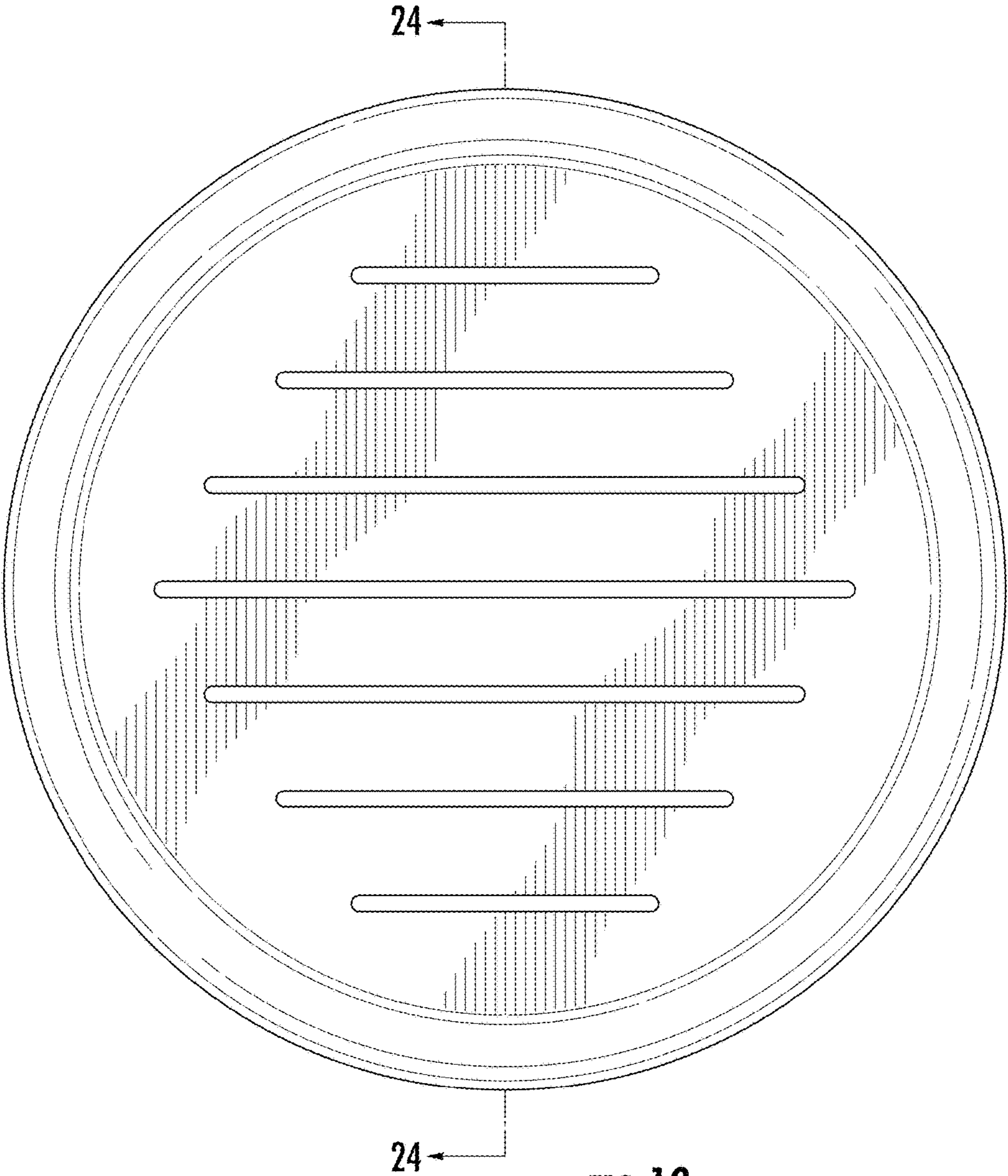

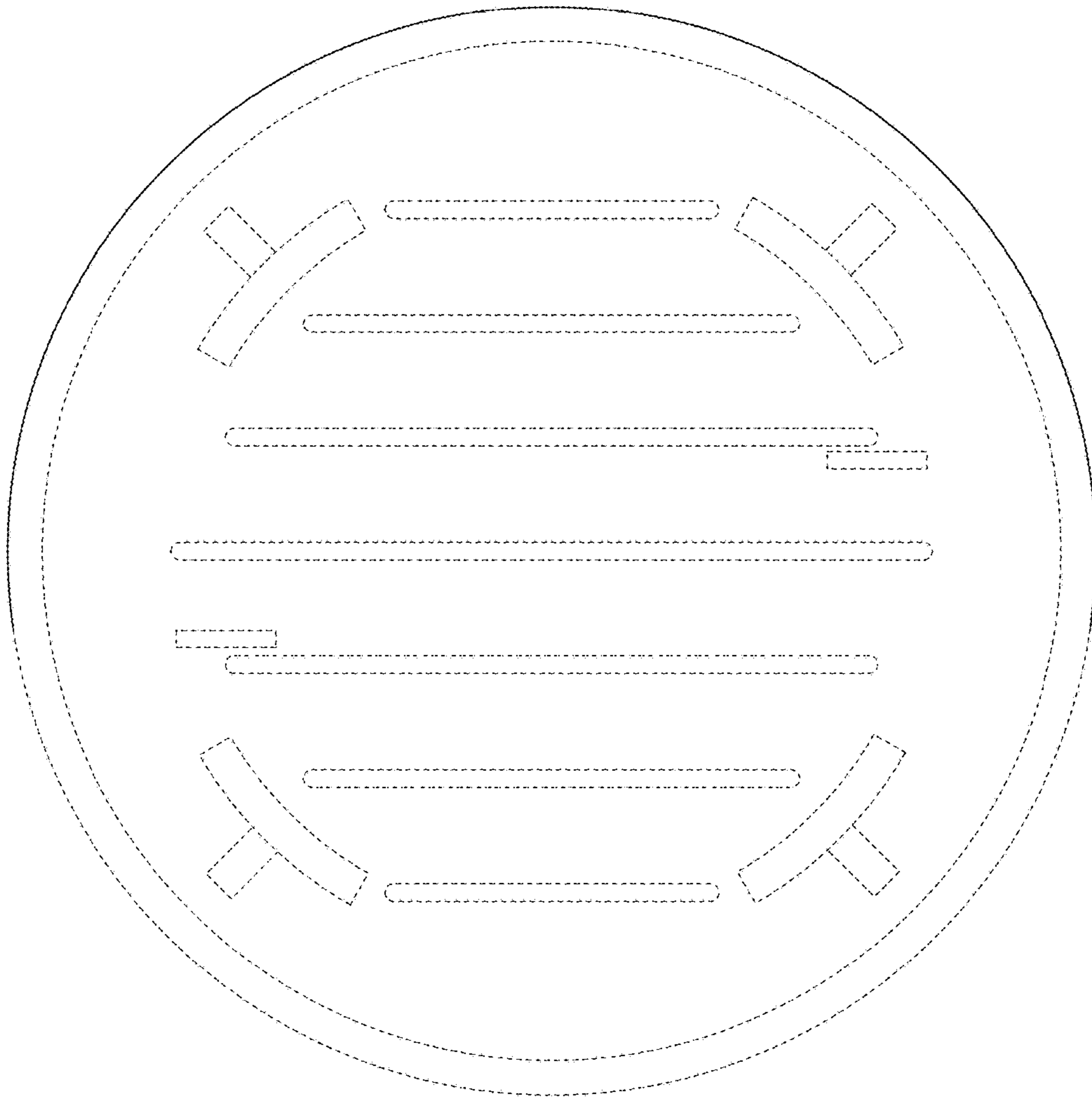
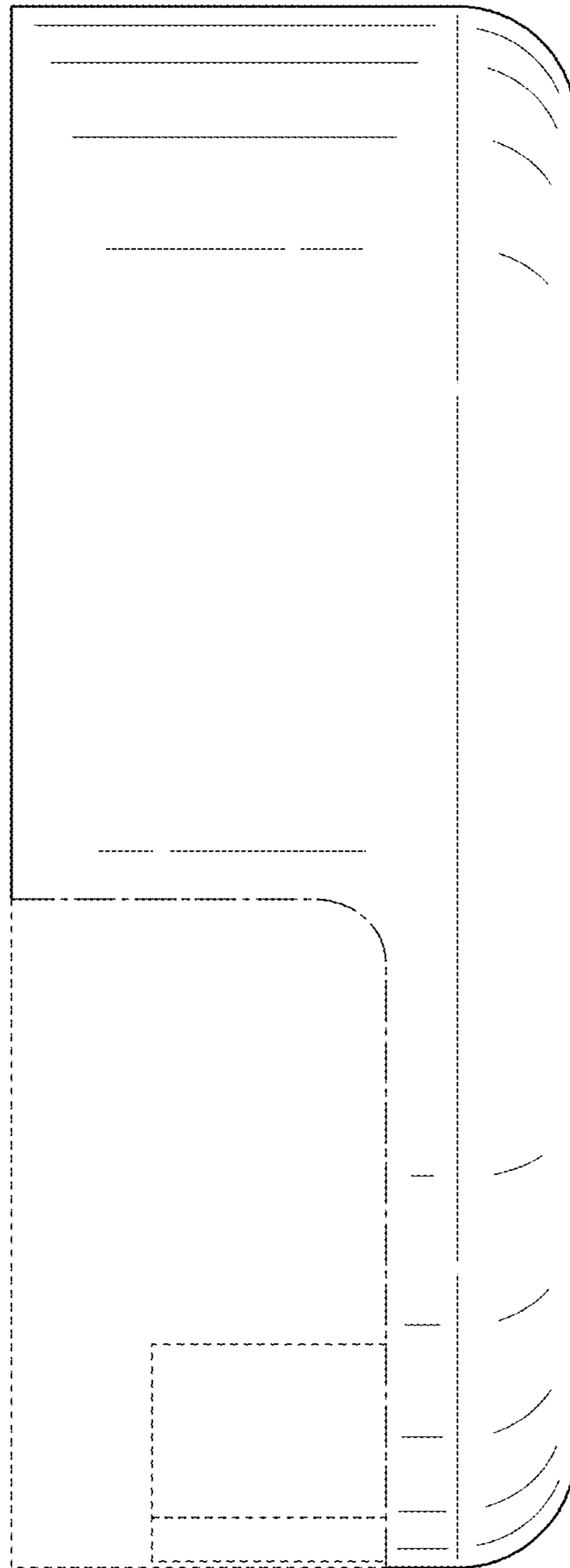

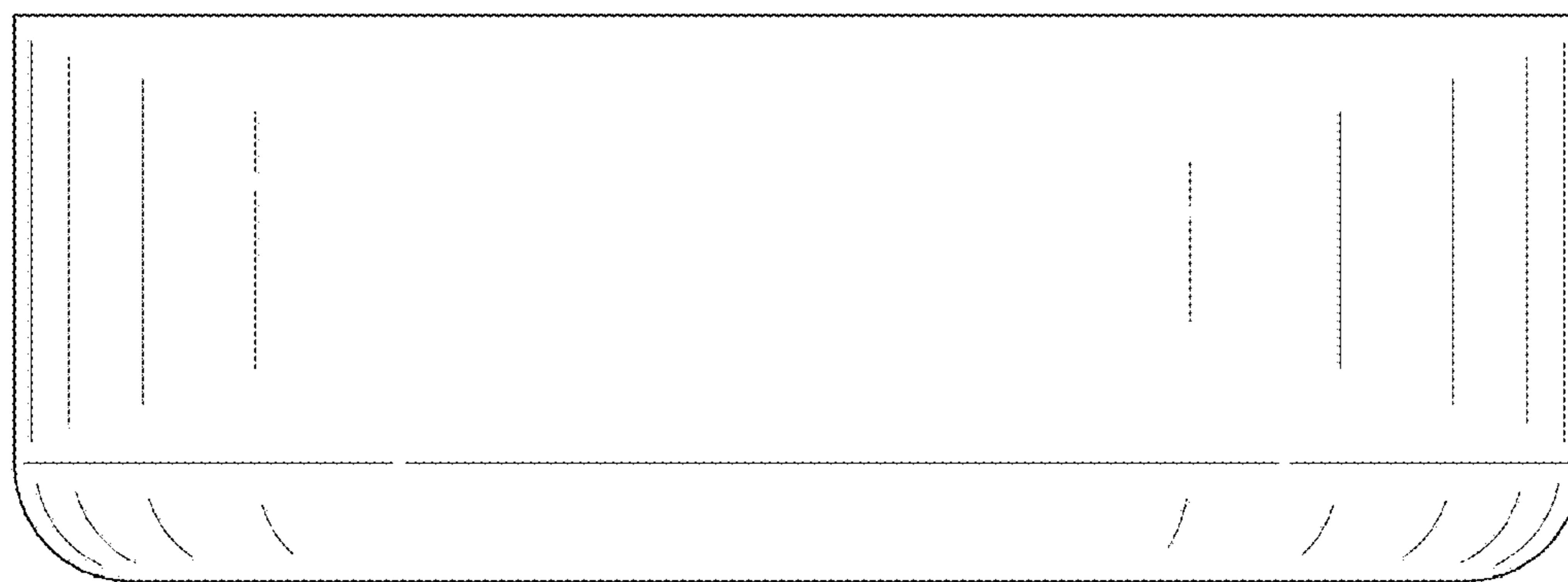

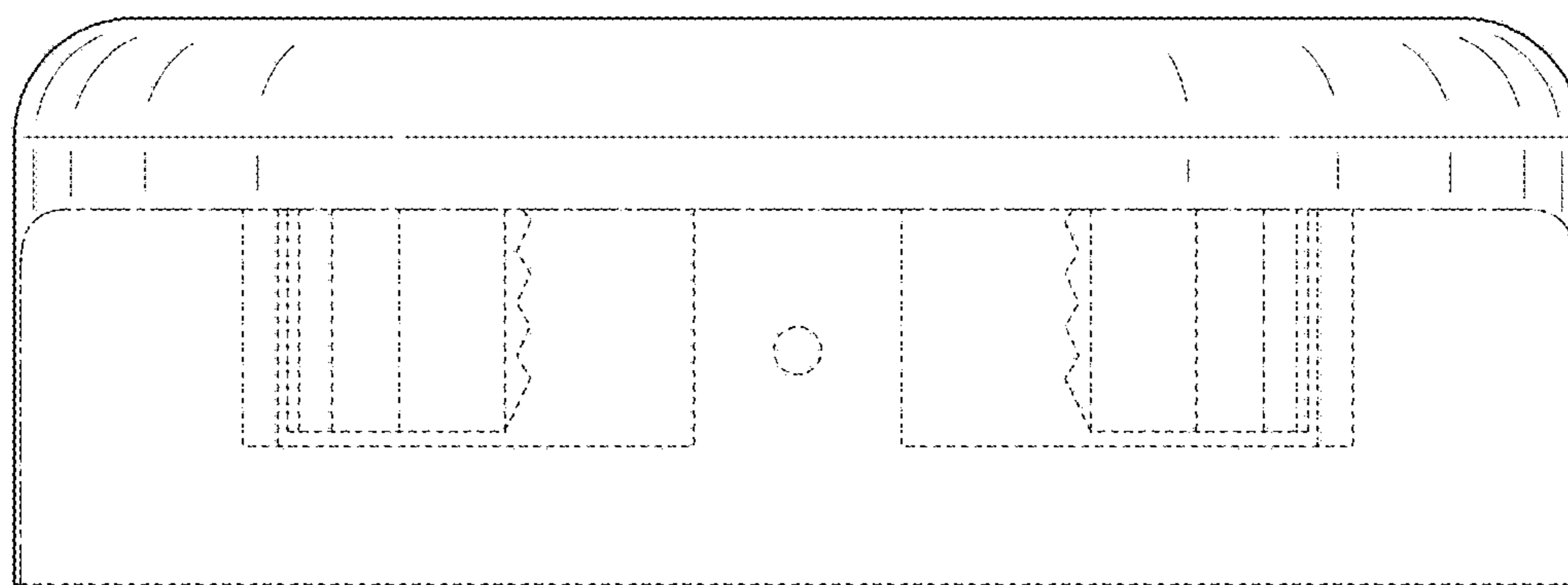
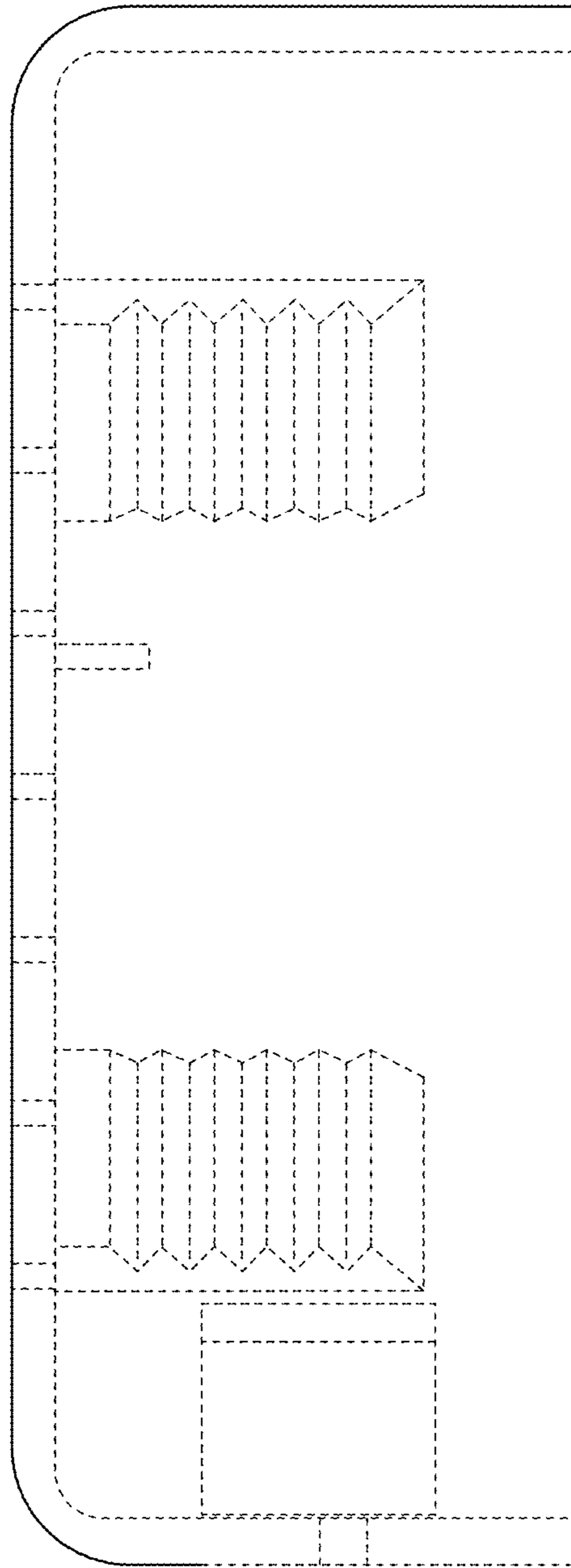
