(57) **CLAIM**

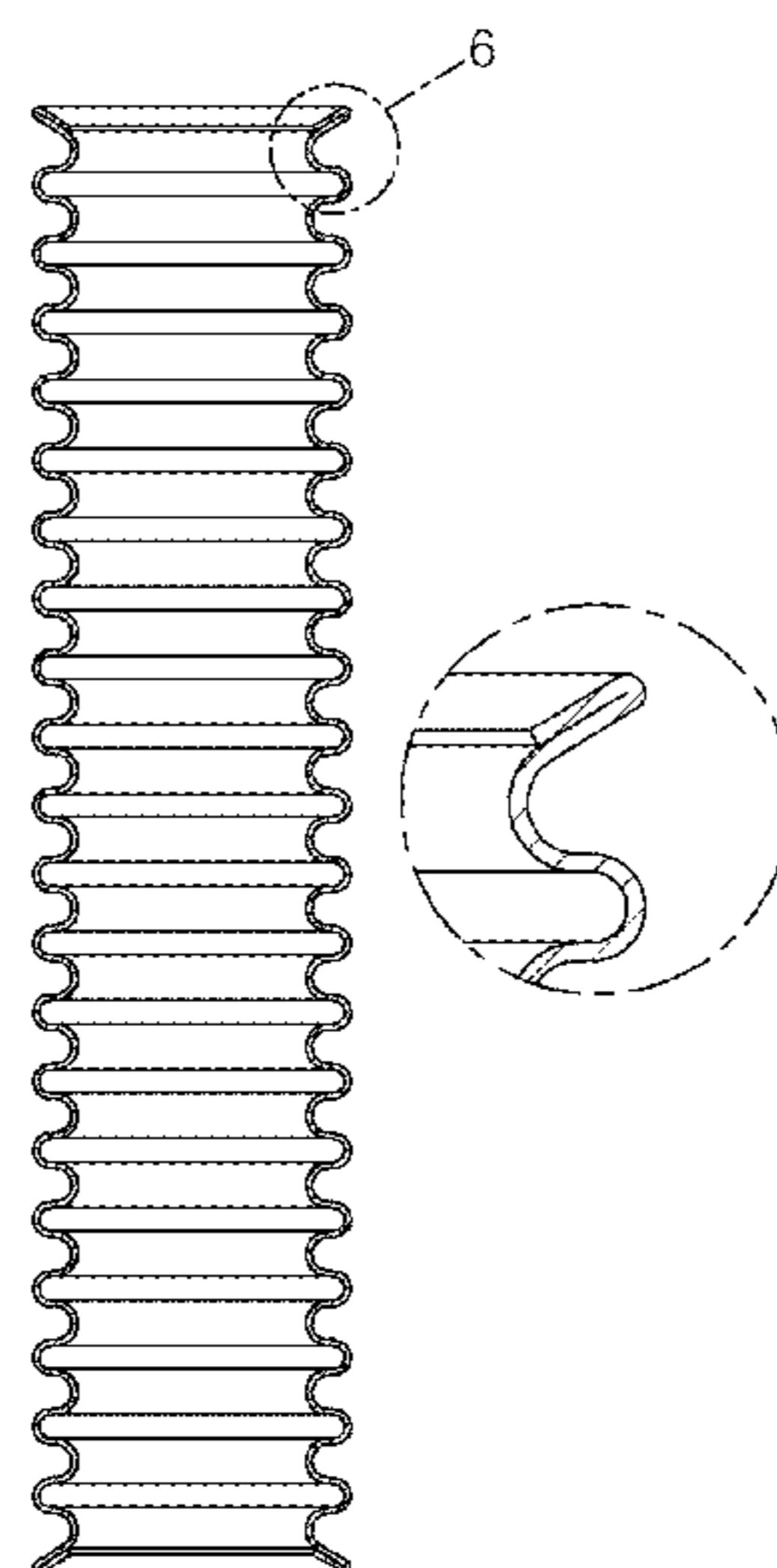
The ornamental design for a wrinkle tube for piping work, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the wrinkle tube for piping work showing new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a cross-sectional view taken along the line 4-4 of FIG. 2;
FIG. 5 is a cross-sectional view thereof shown in a position of use with tightening nut and packing for sealing; and,
FIG. 6 is an enlarged view of the portion within the circle line of FIG. 4.

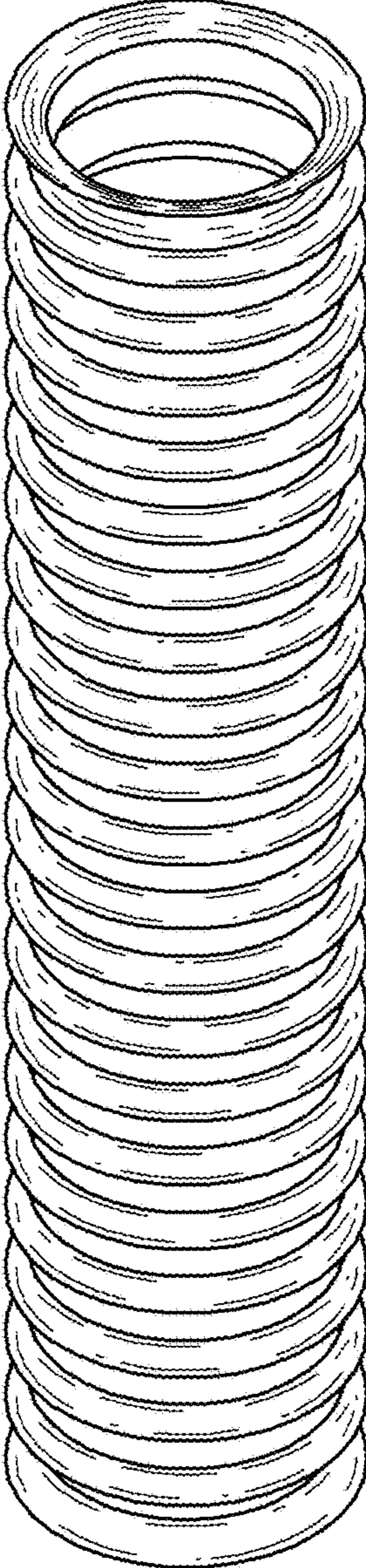

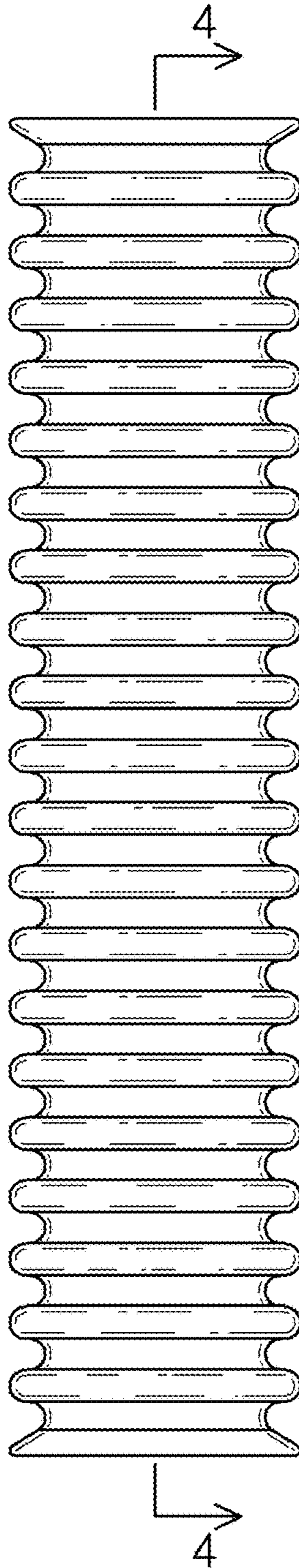

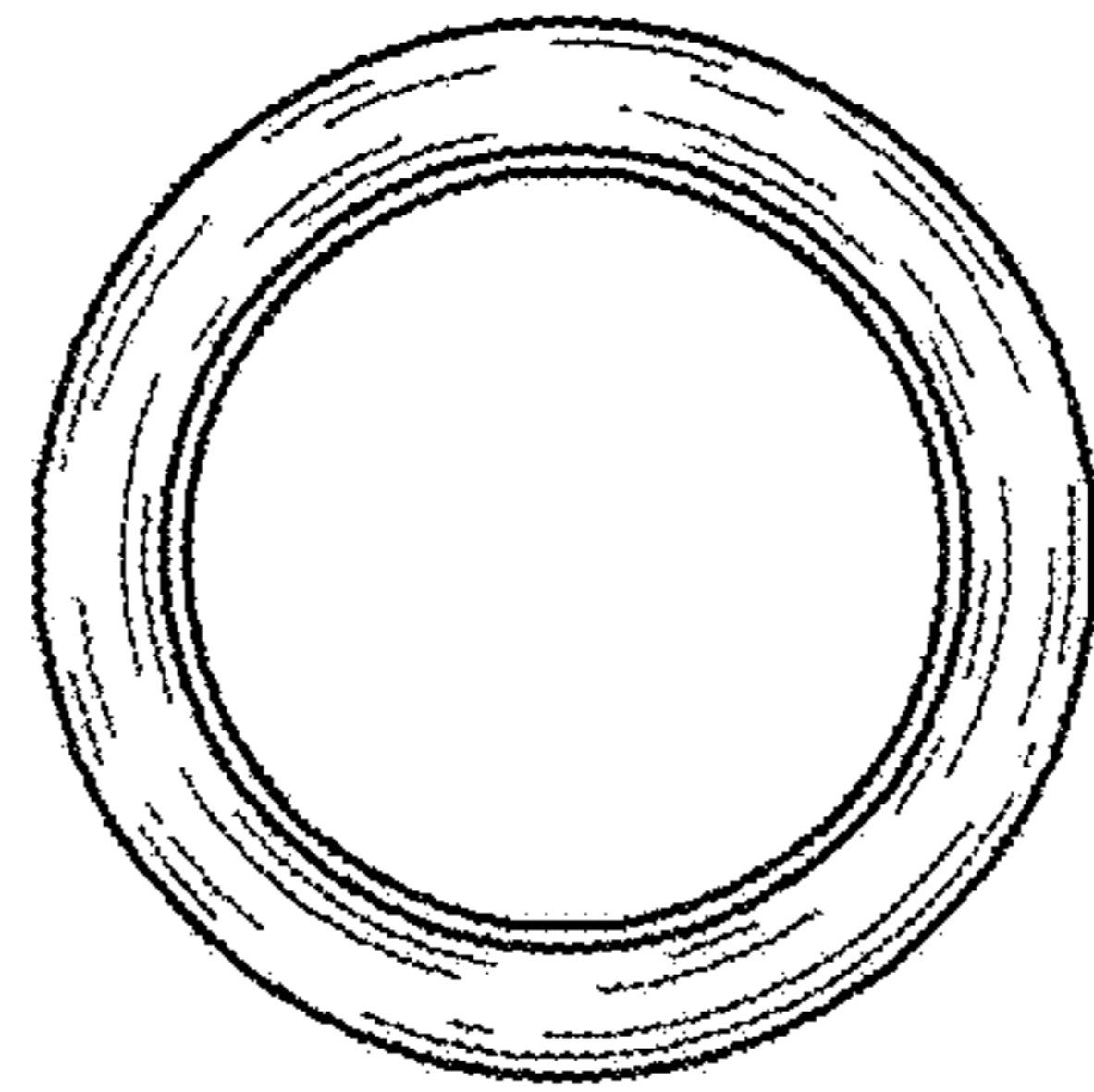

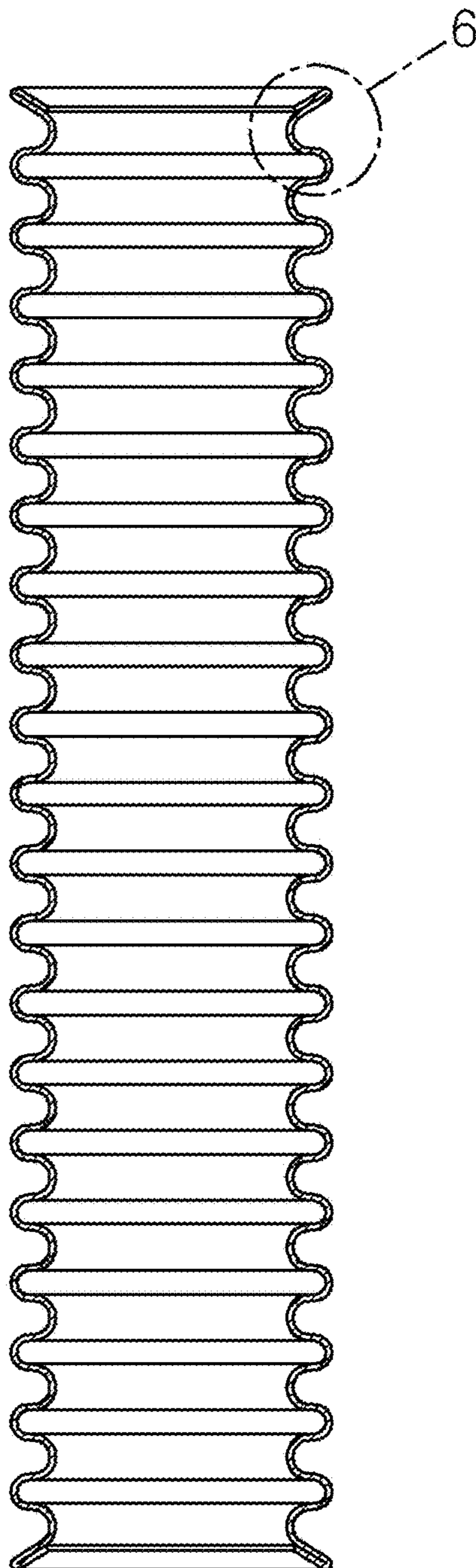

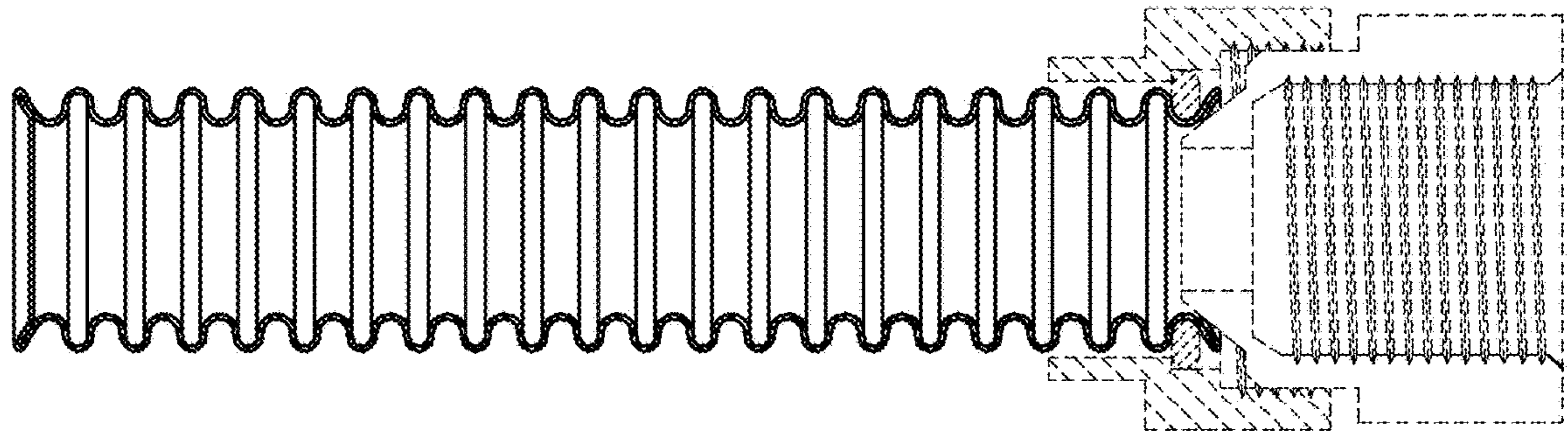
