FIG. 1 is a perspective view of an absorbent article with a
pattern;
FIG. 2 is a front view thereof;

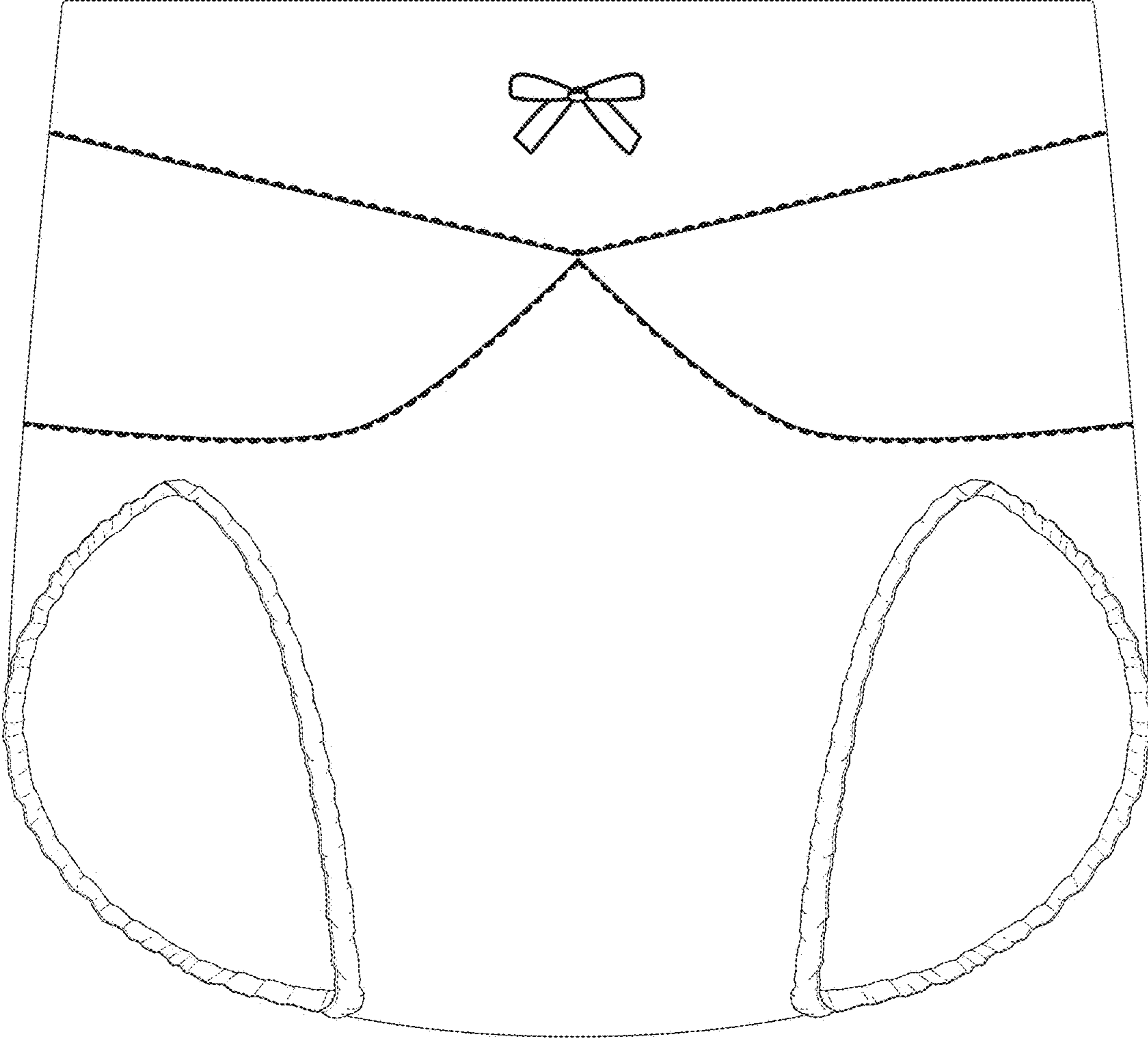

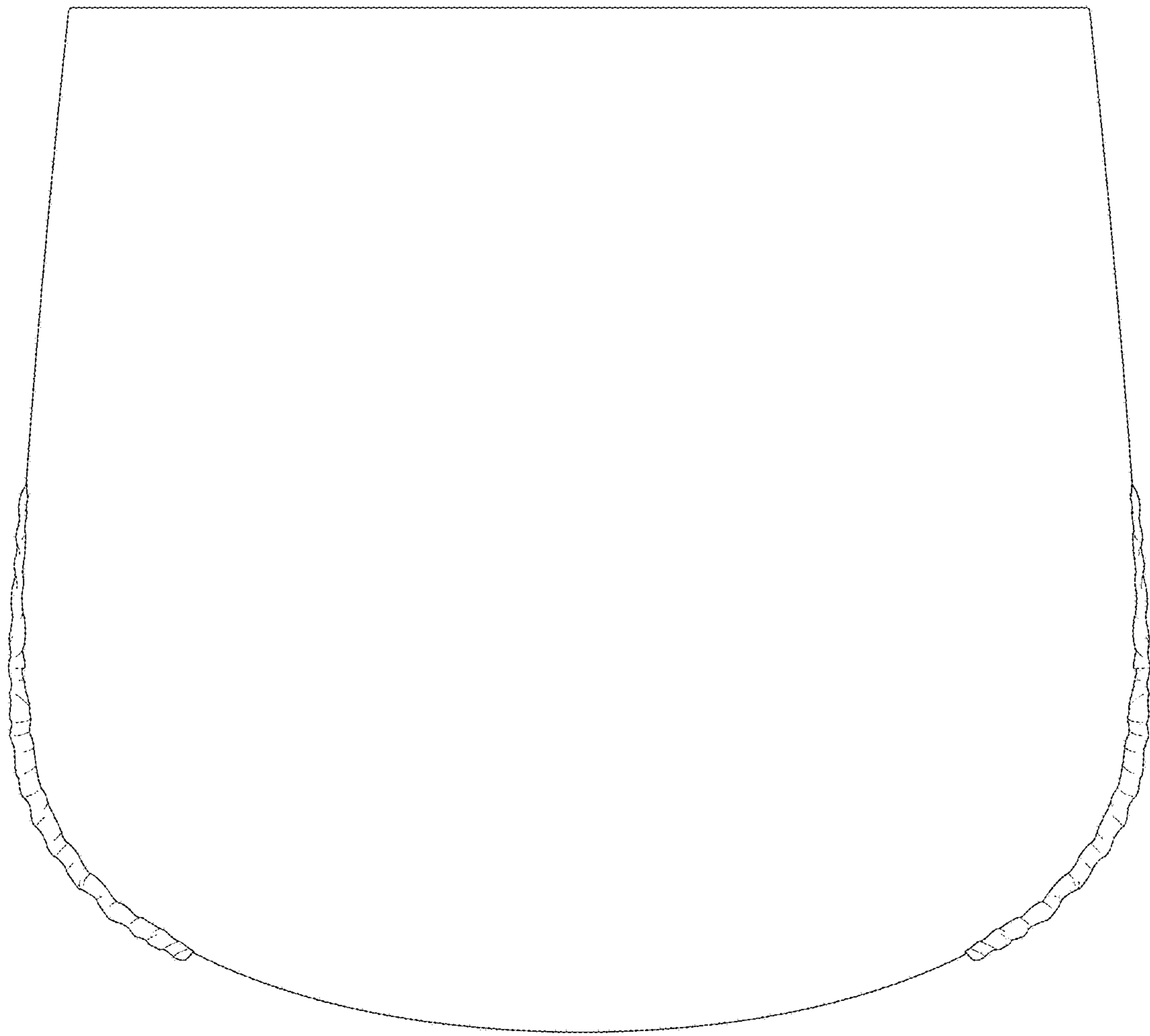

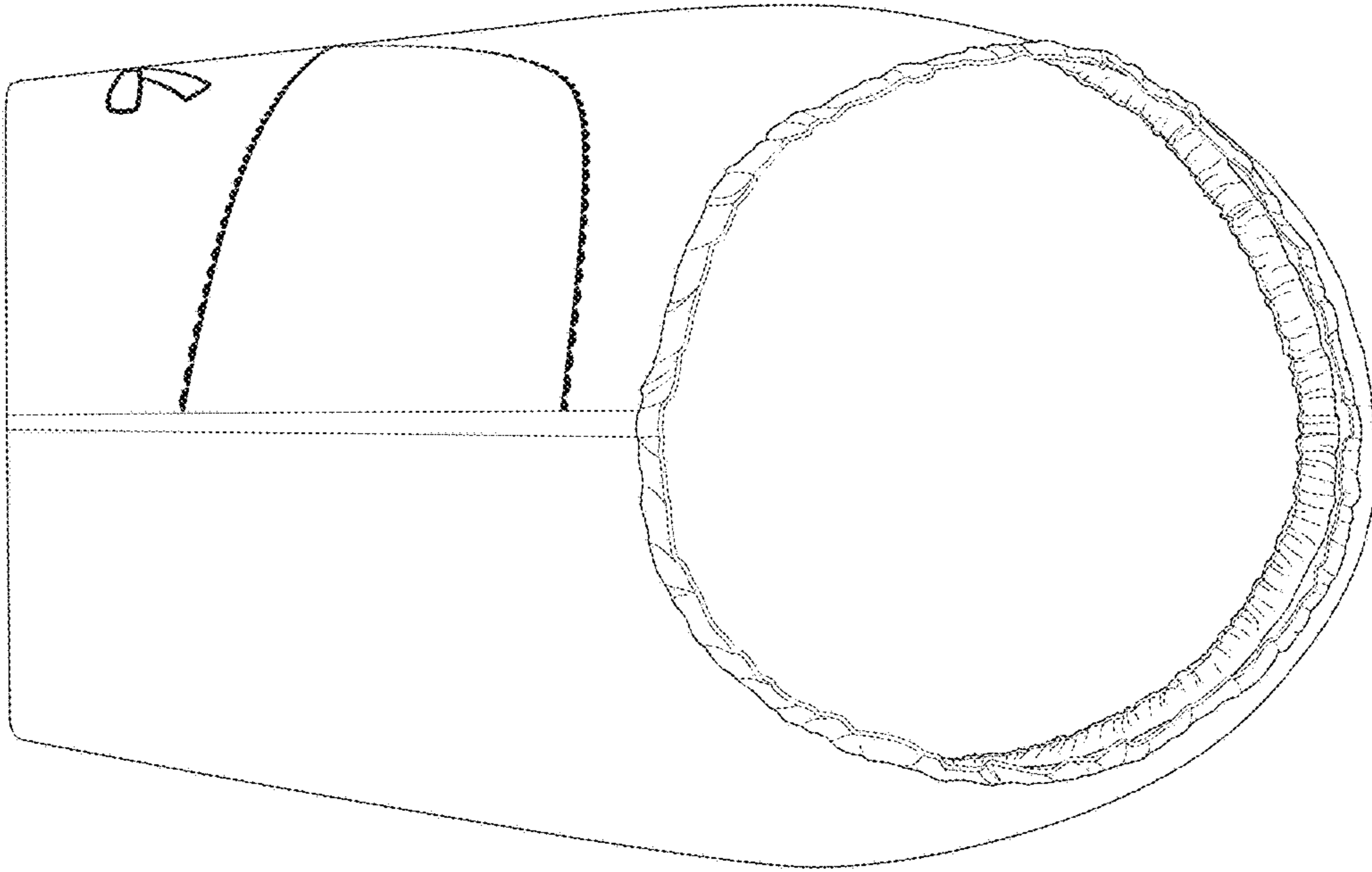

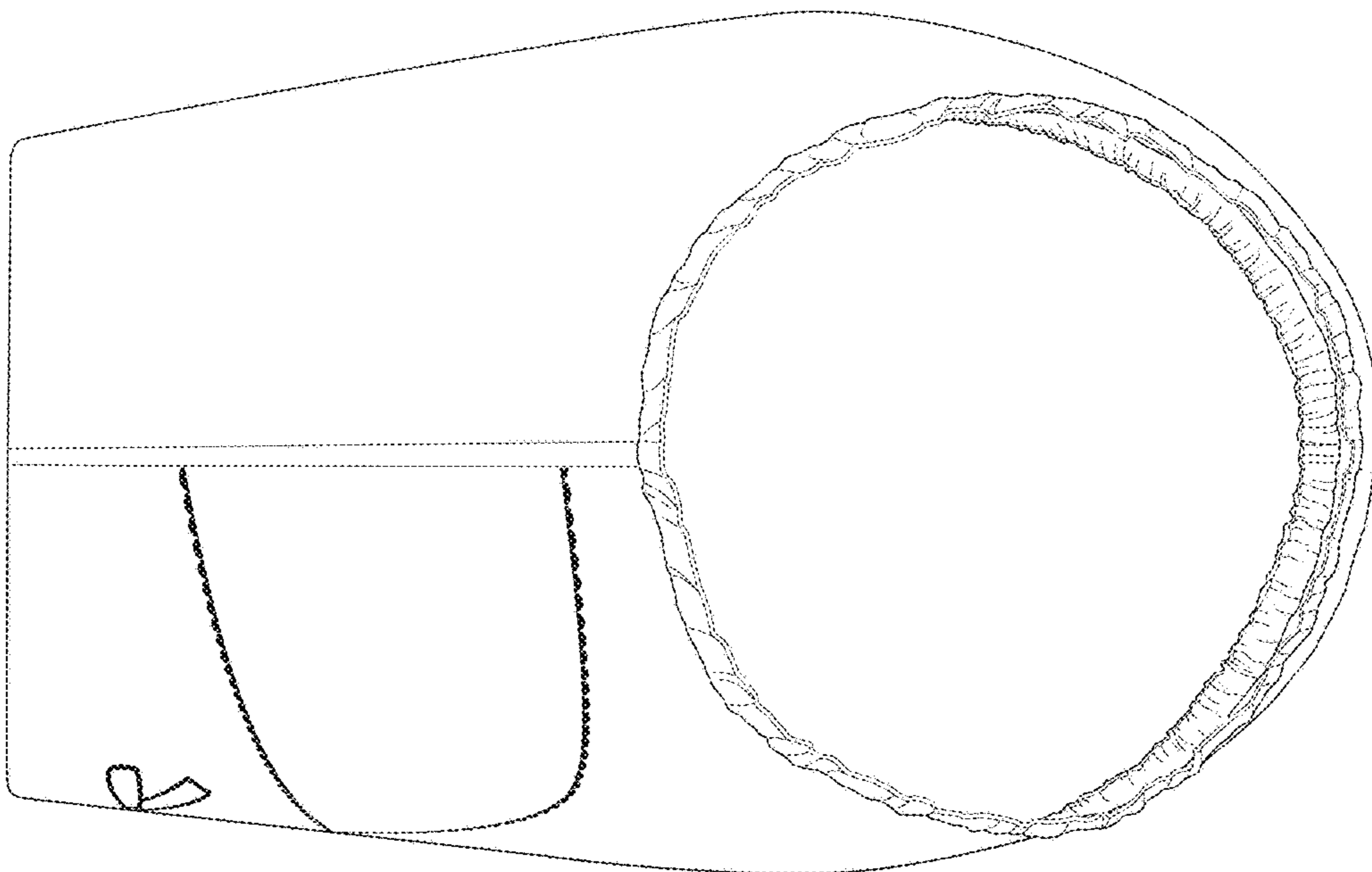
