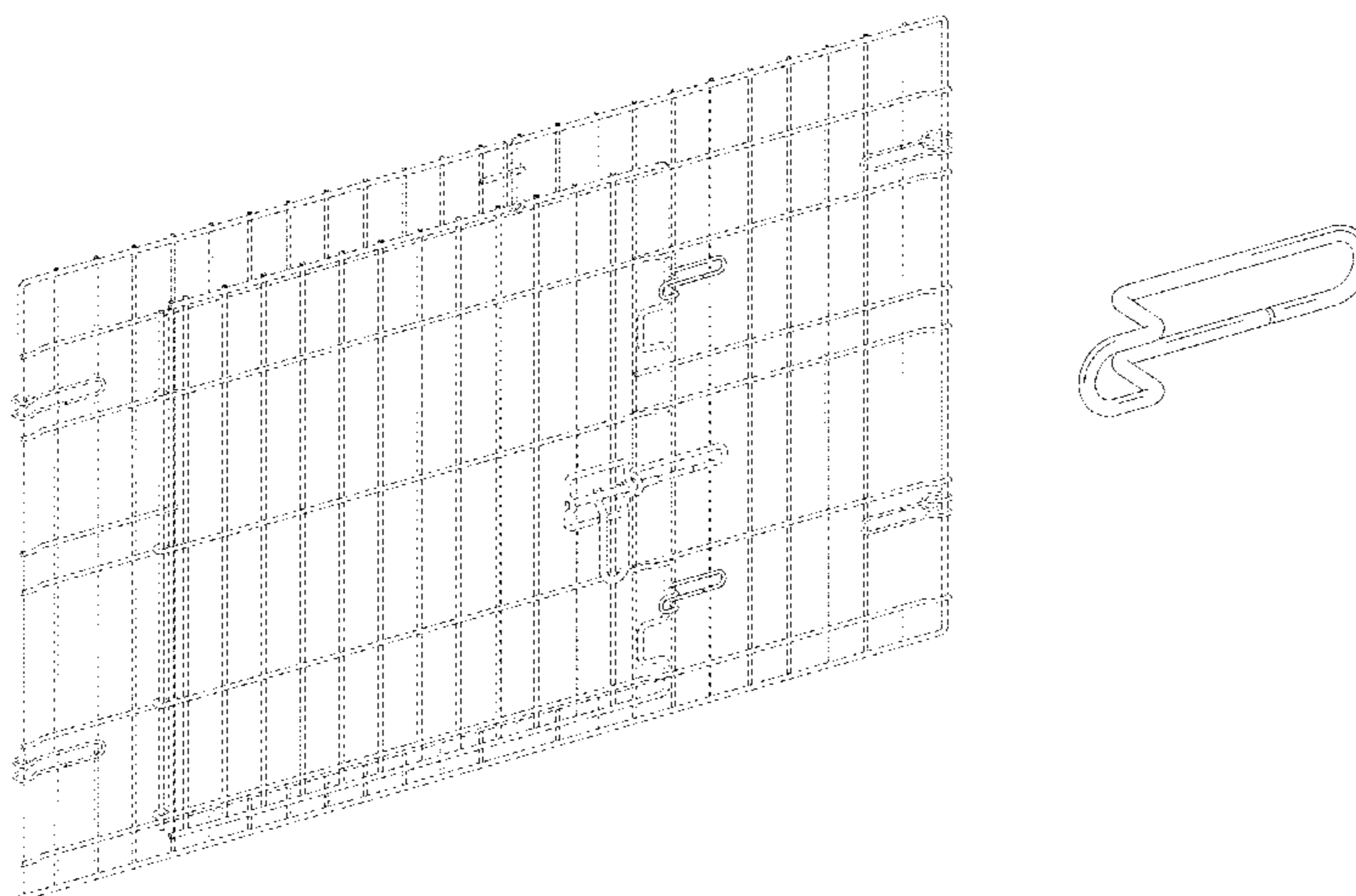
(57) **CLAIM**

The ornamental design for a clip for a door assembly of an animal enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a clip for a door assembly of an animal enclosure showing our new design within an environmental use;
FIG. 2 is a front perspective view of a clip for a door assembly of an animal enclosure;

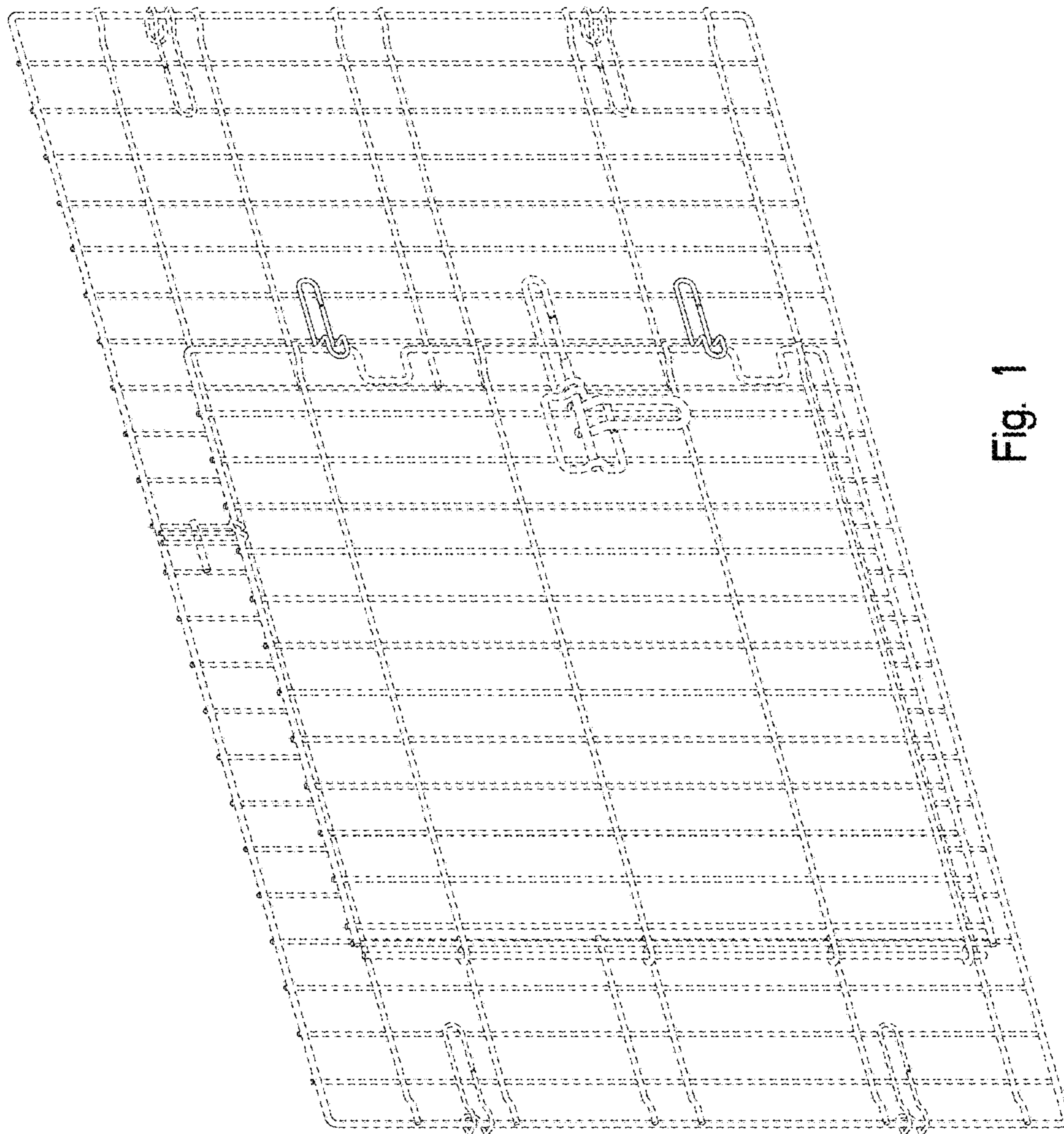

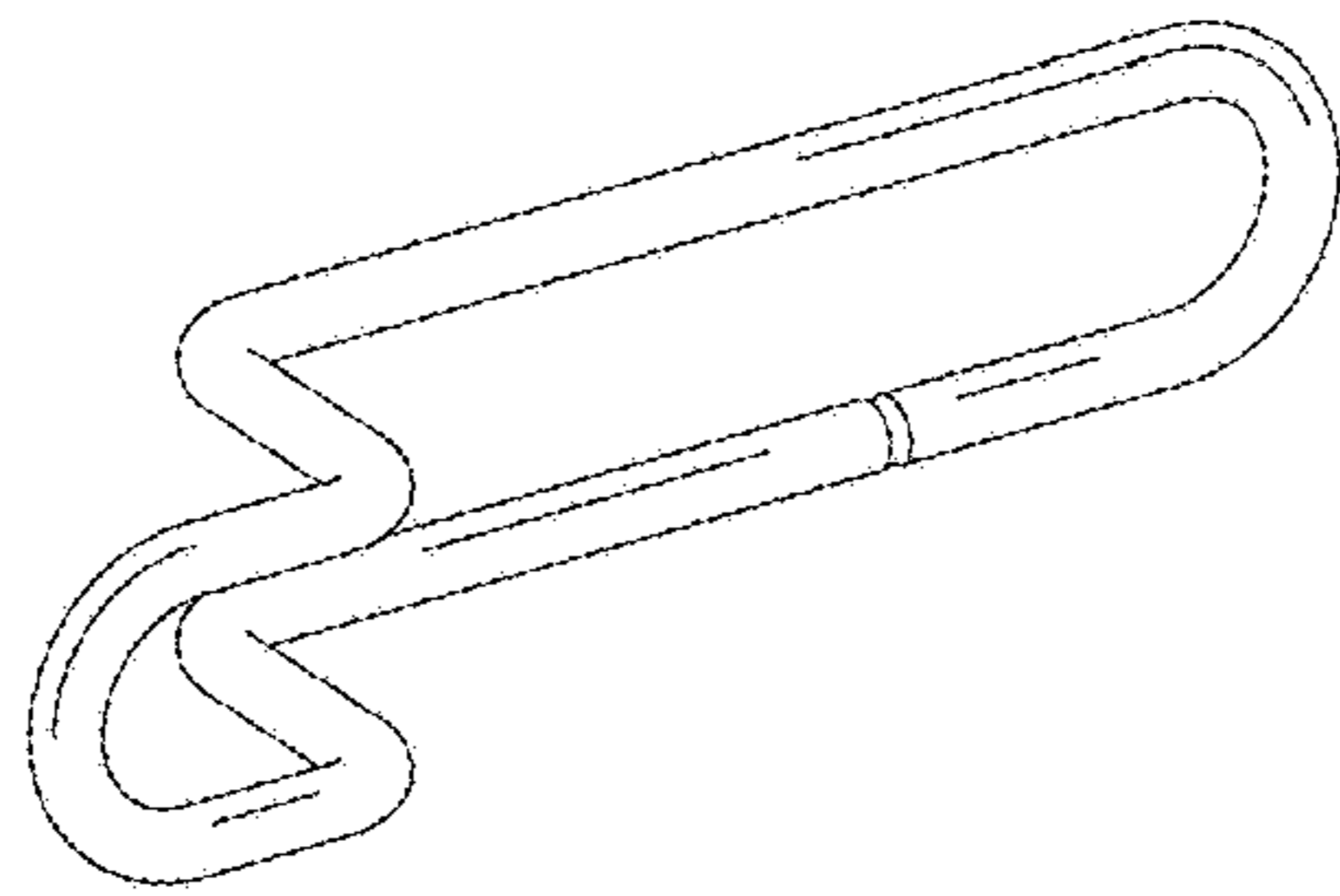

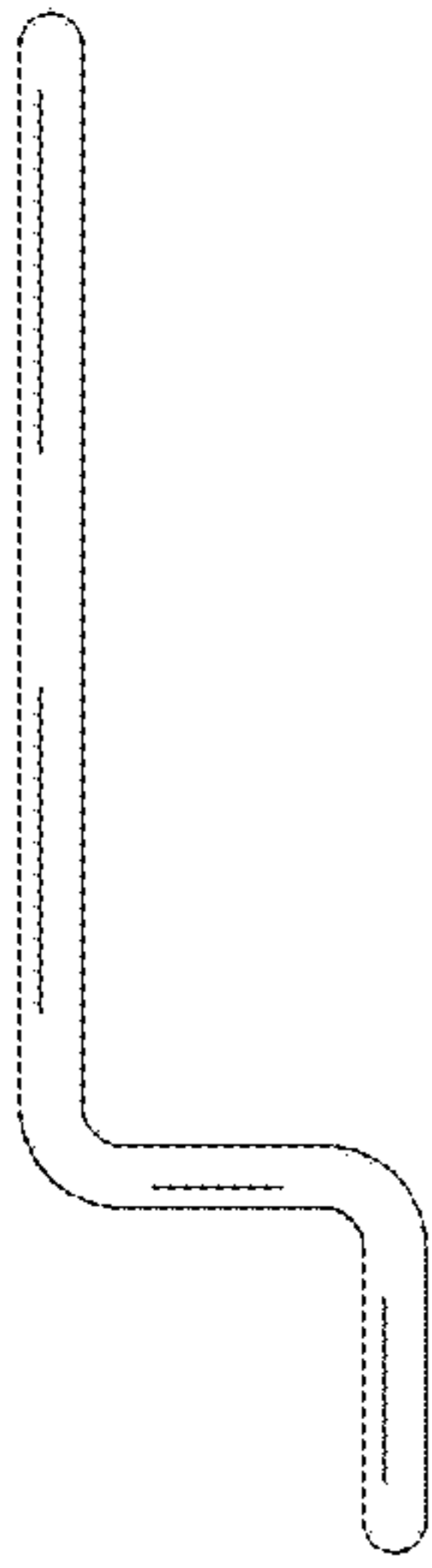

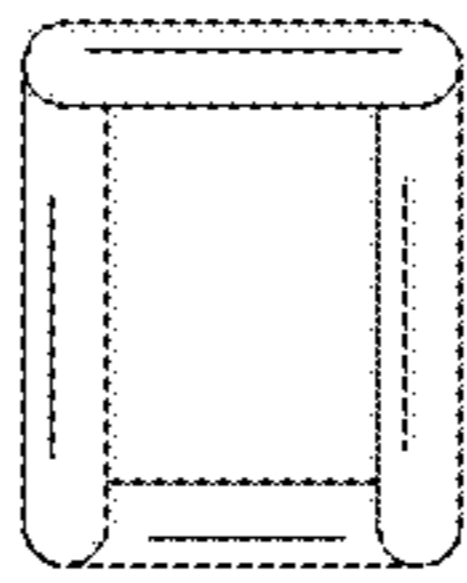

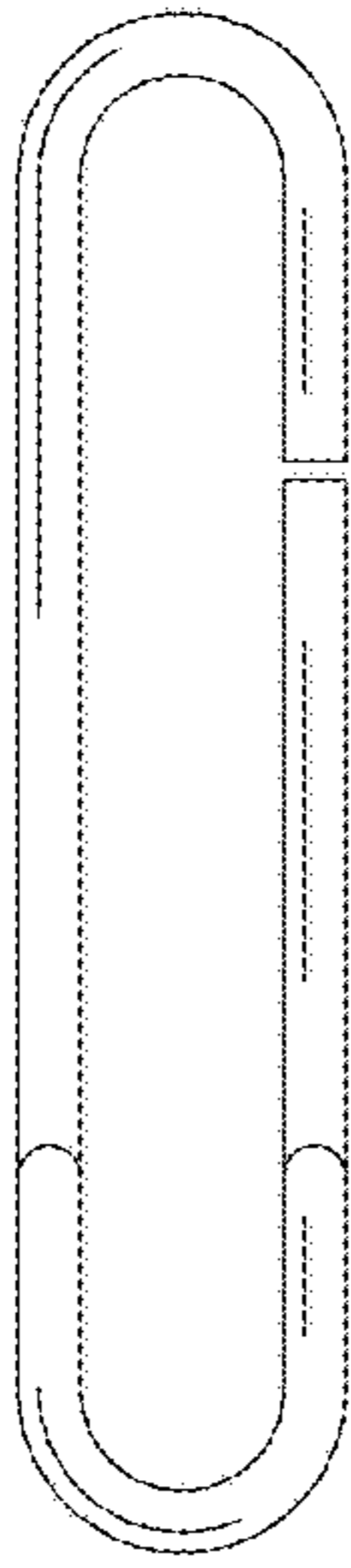

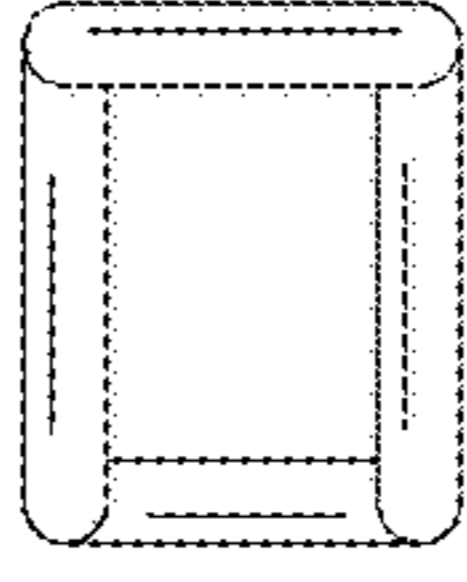

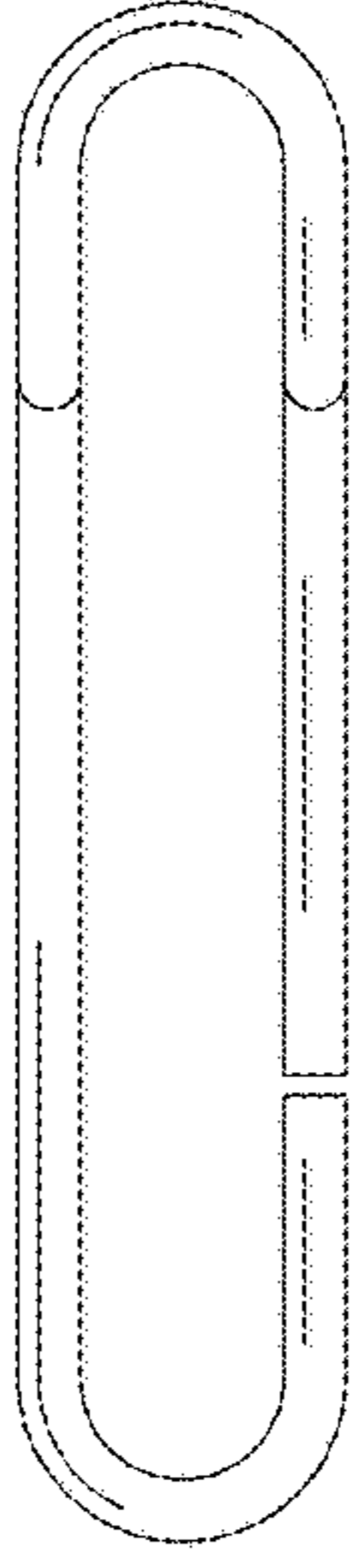

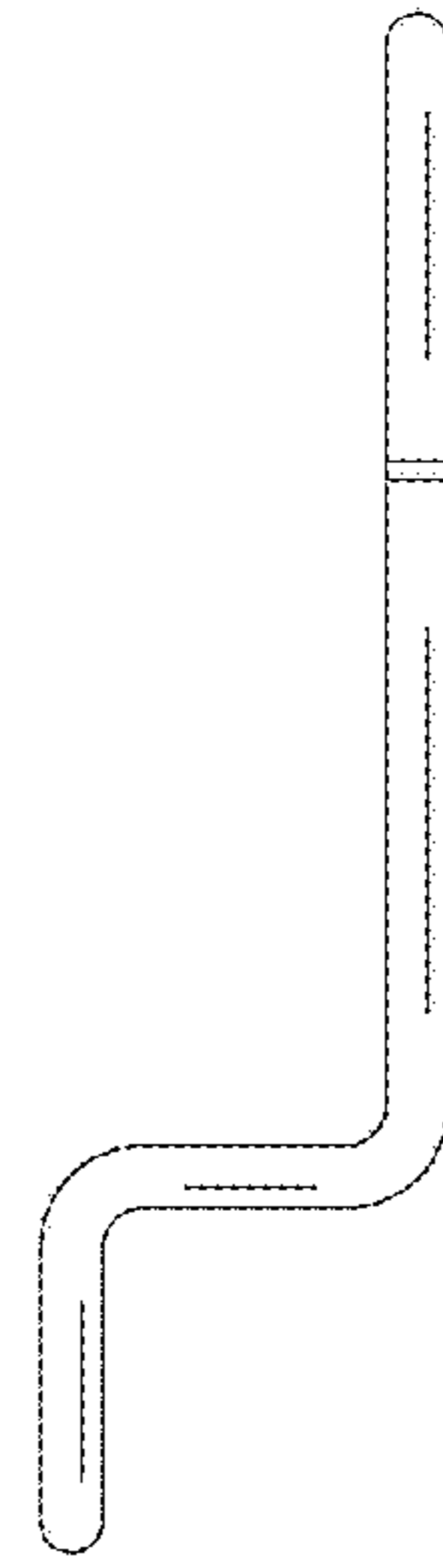
