**1.4** is a left-side elevation view thereof;

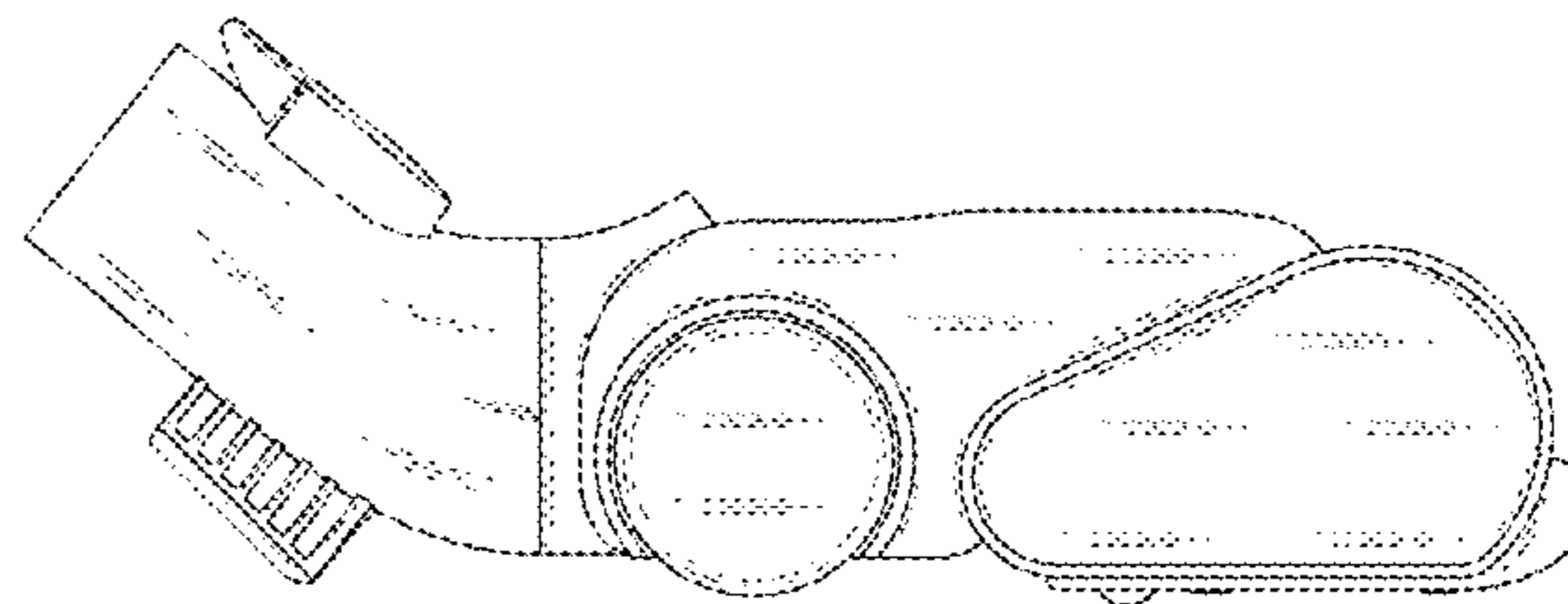
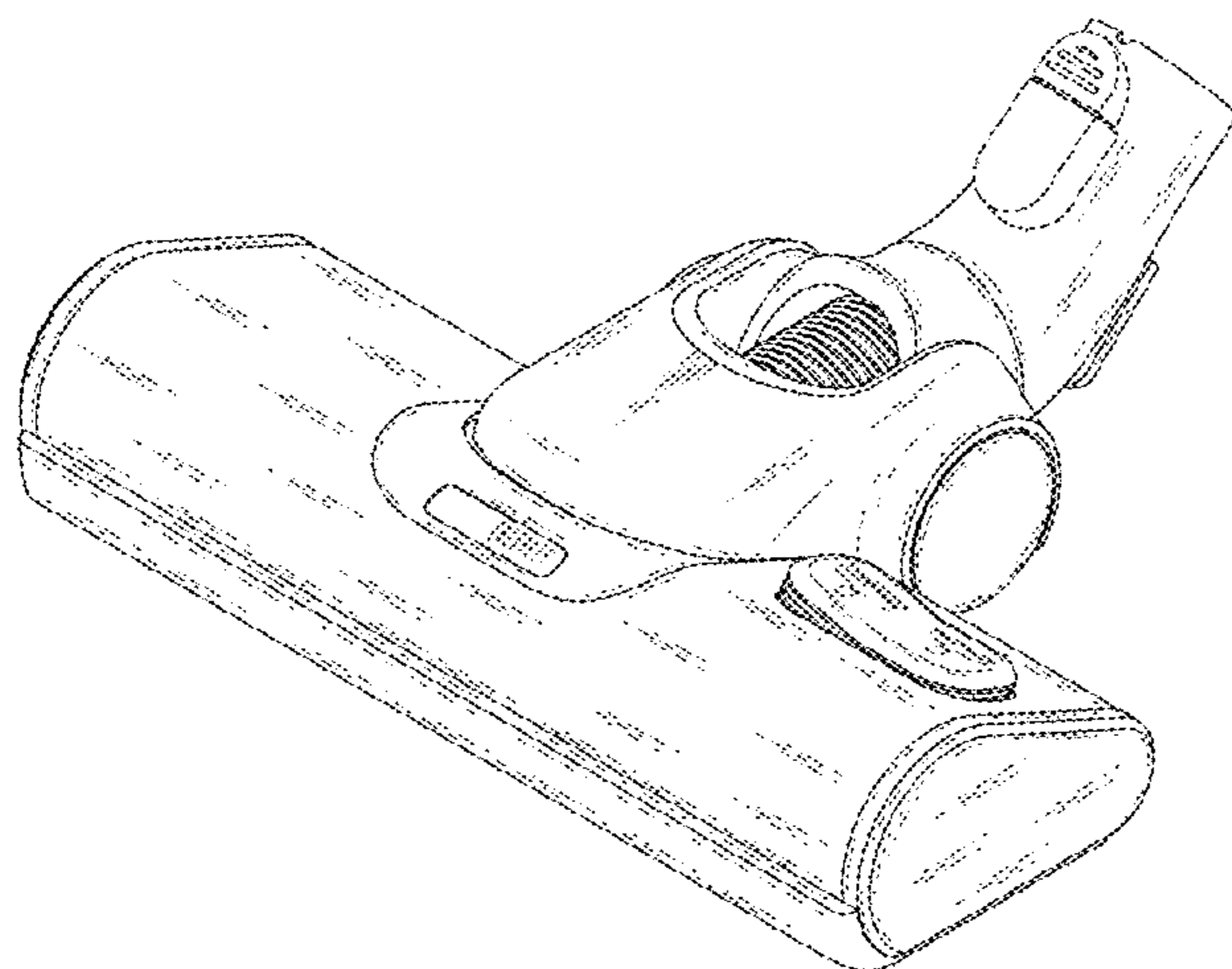
**1.5** is a right-side elevation view thereof;

**1.6** is a top plan view thereof; and

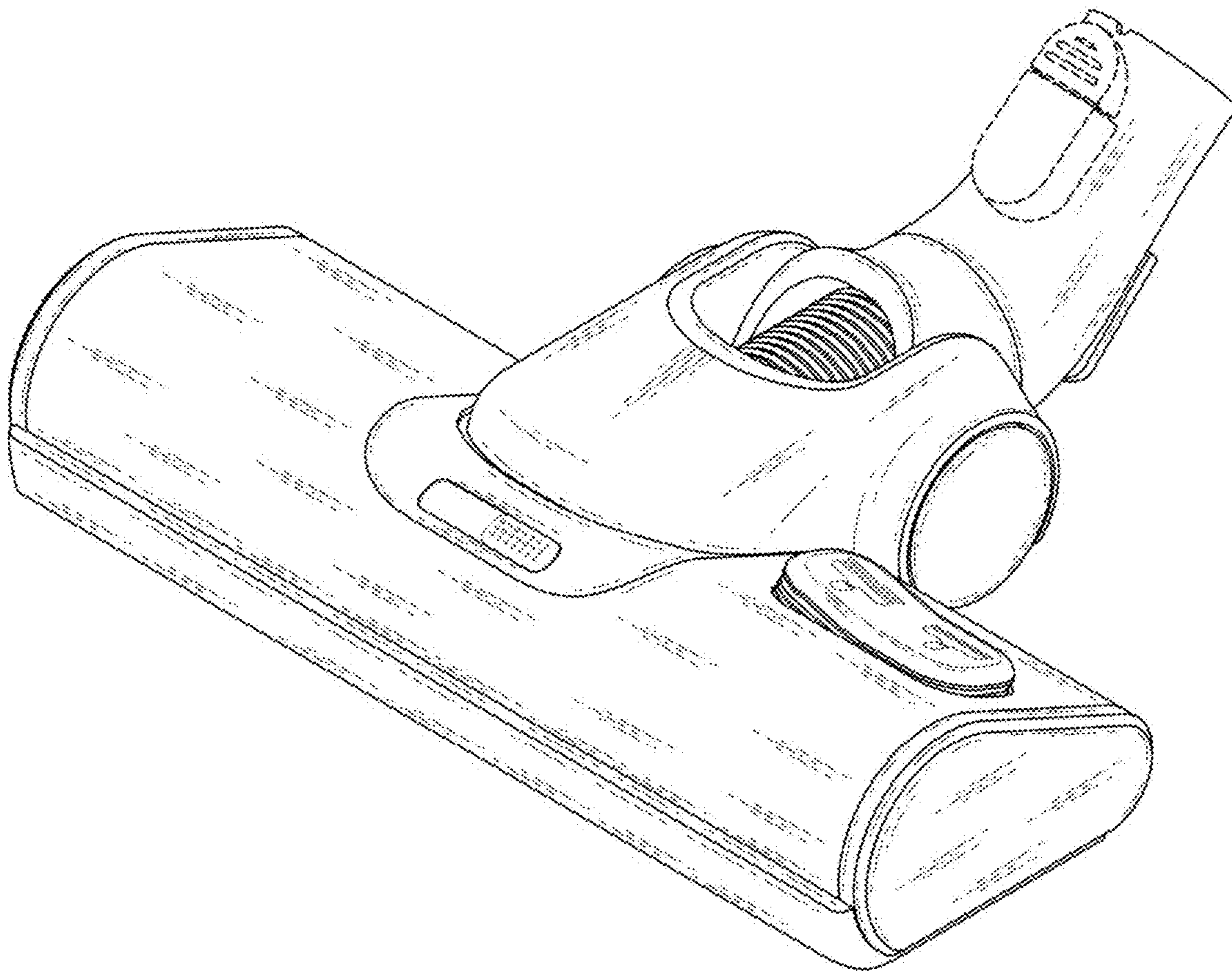
**1.7** is a bottom plan view thereof.

The broken line shown in figures **1.1** through **1.6** is for the purpose of illustrating portions that do not form a part of the claimed design.

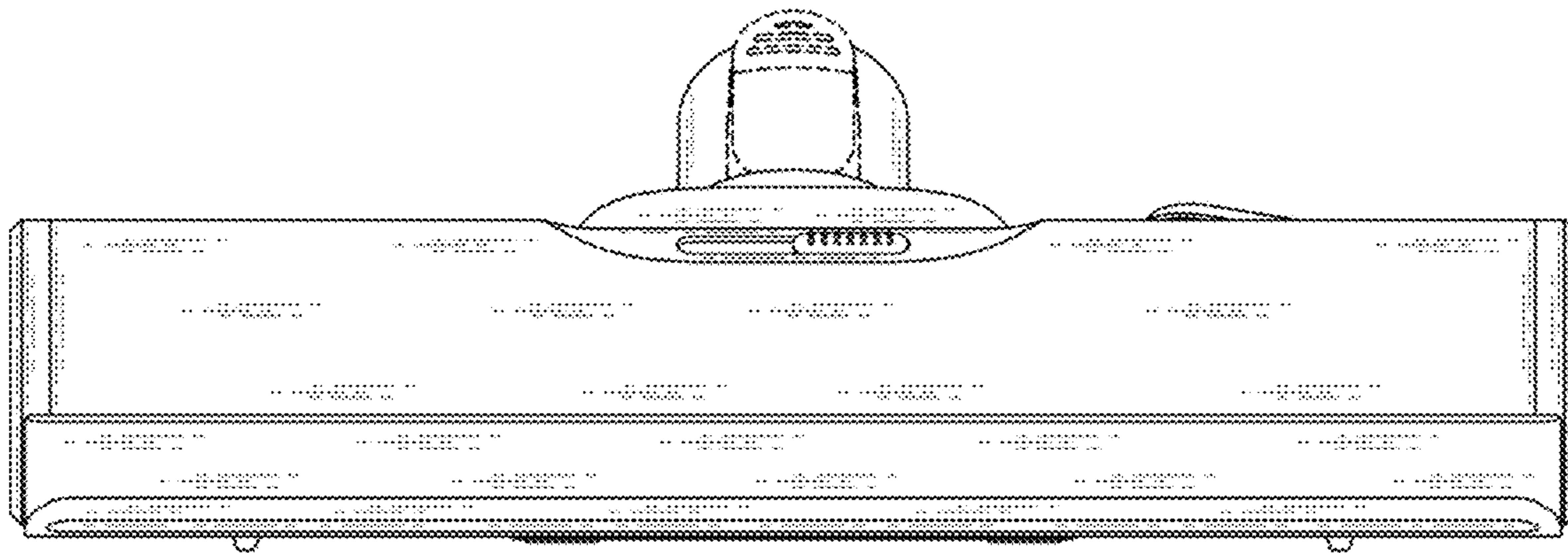

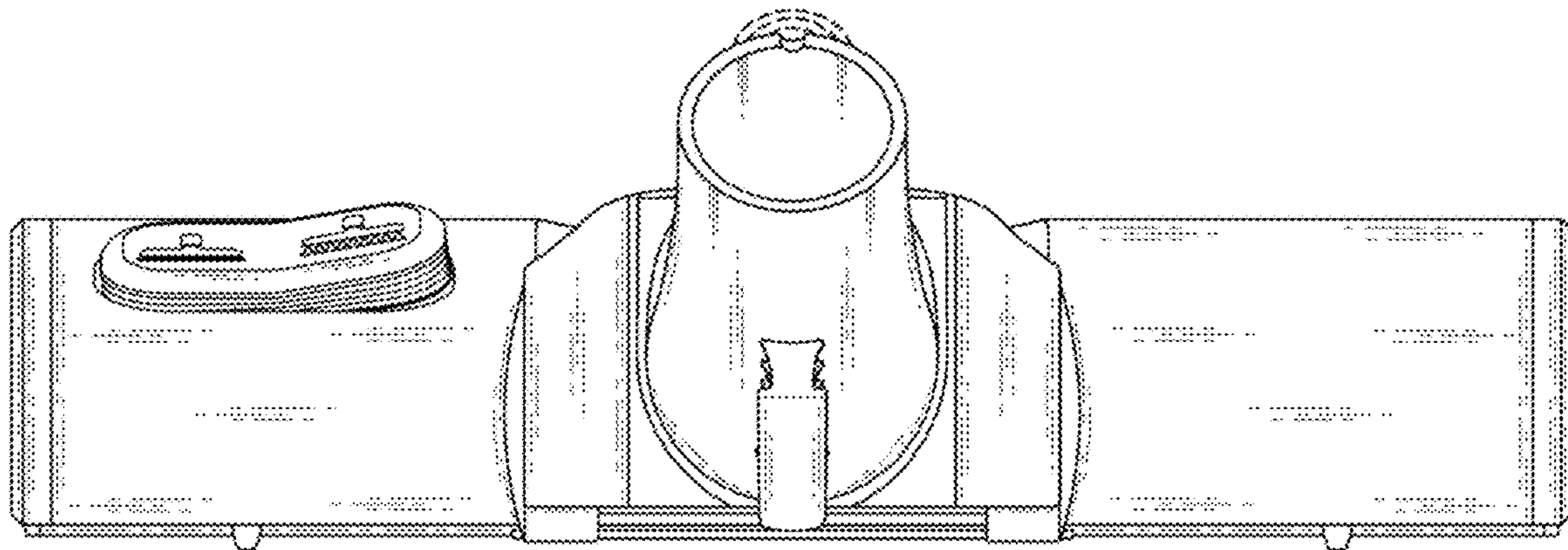

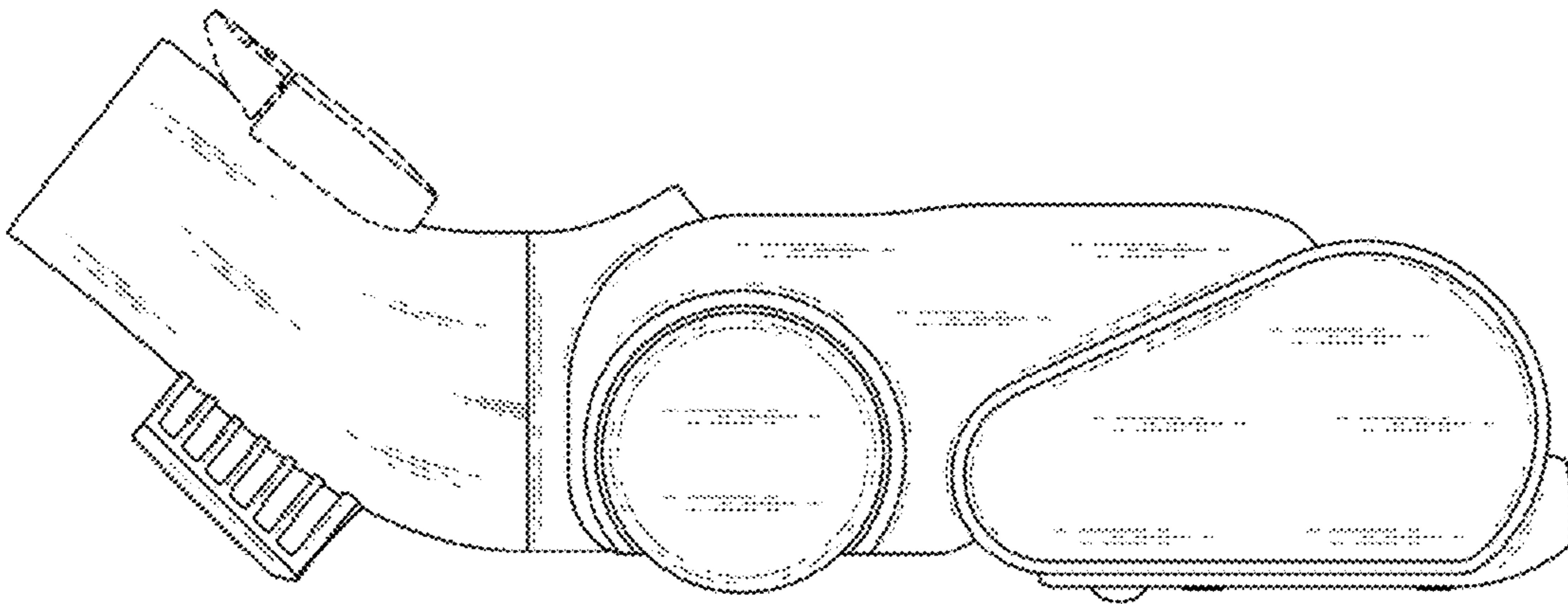

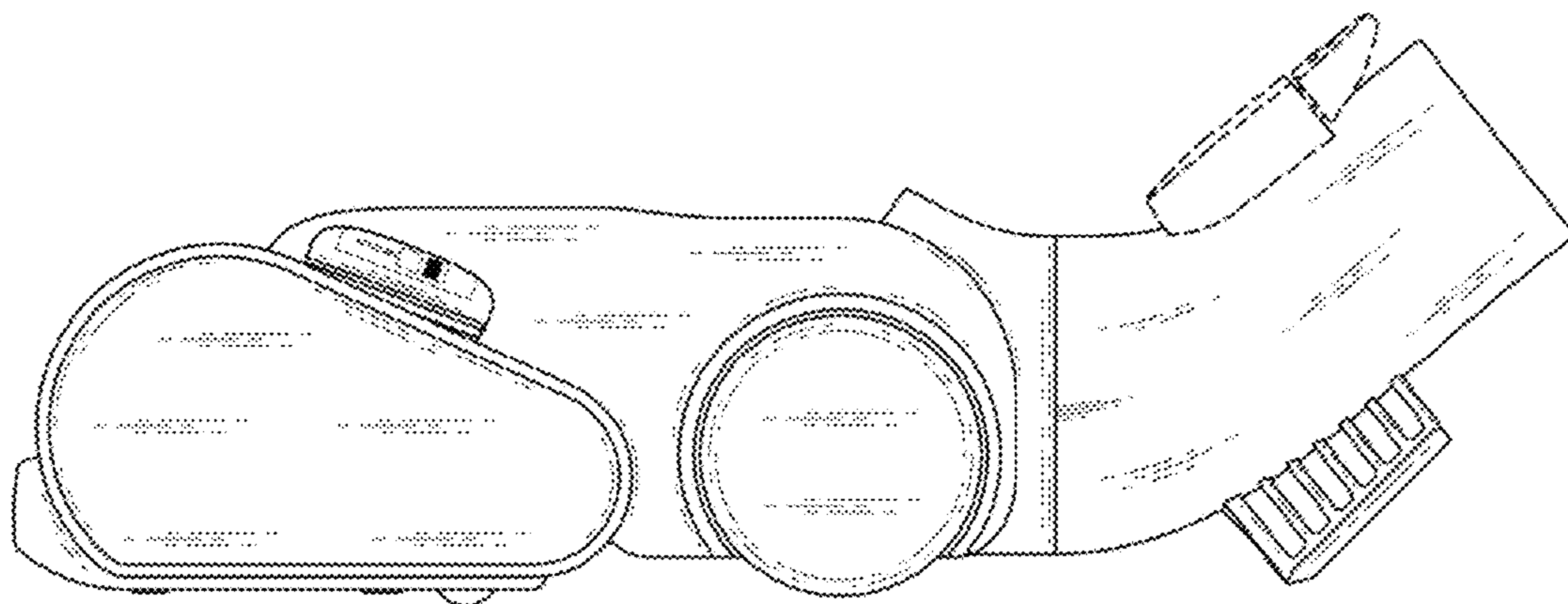




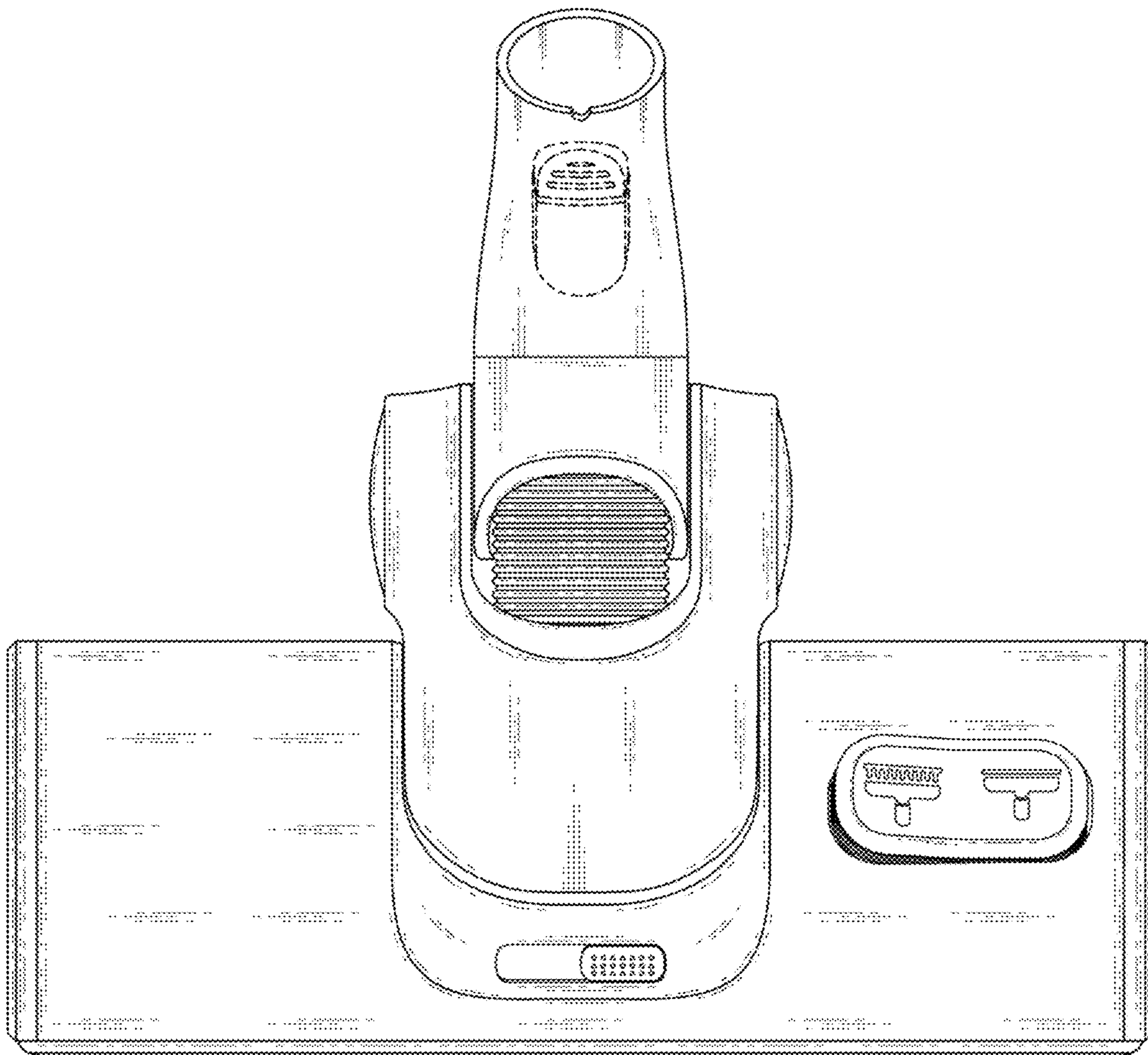
