DESCRIPTION

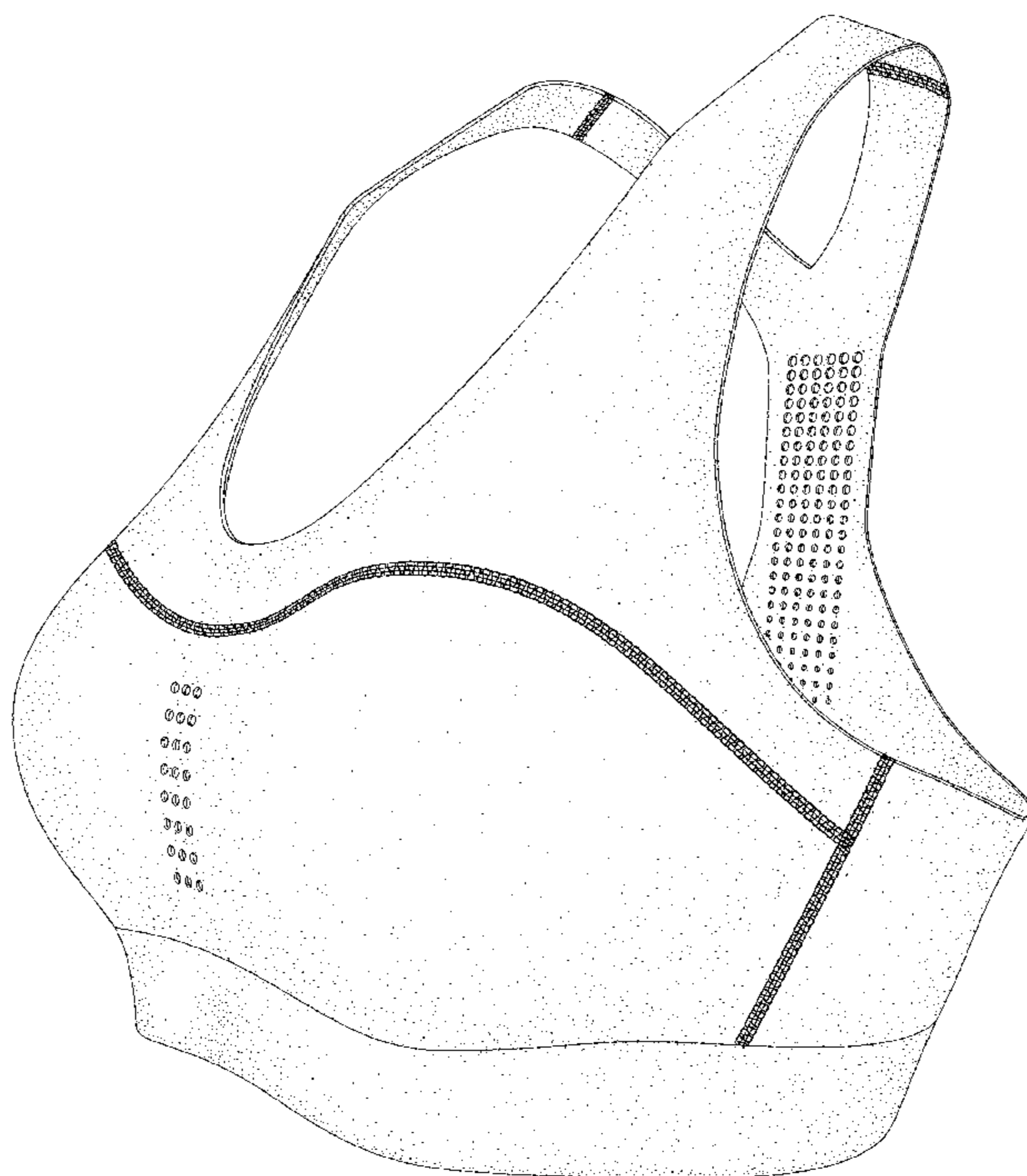
FIG. 1 is a front perspective view of apparel showing the claimed design;

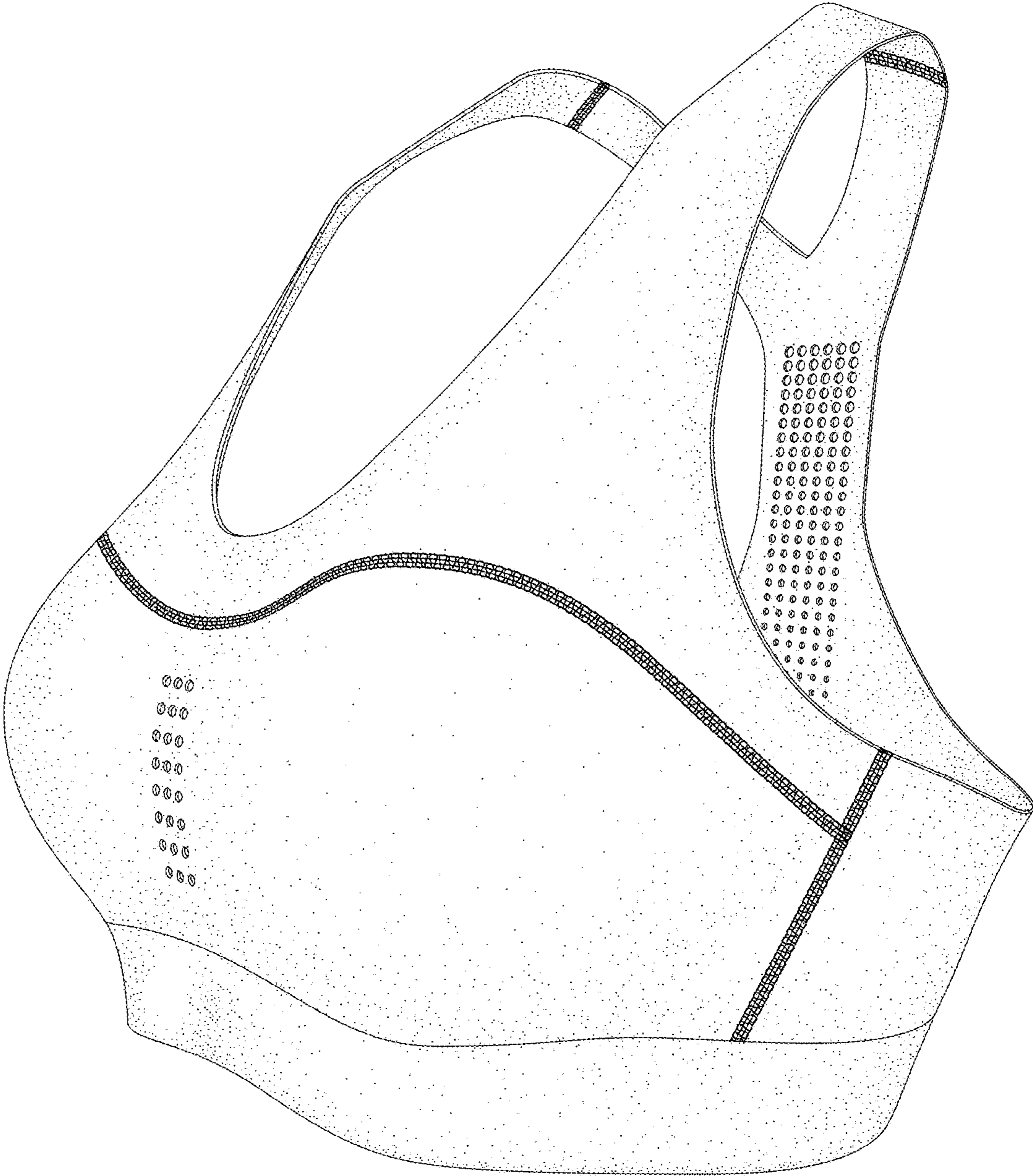

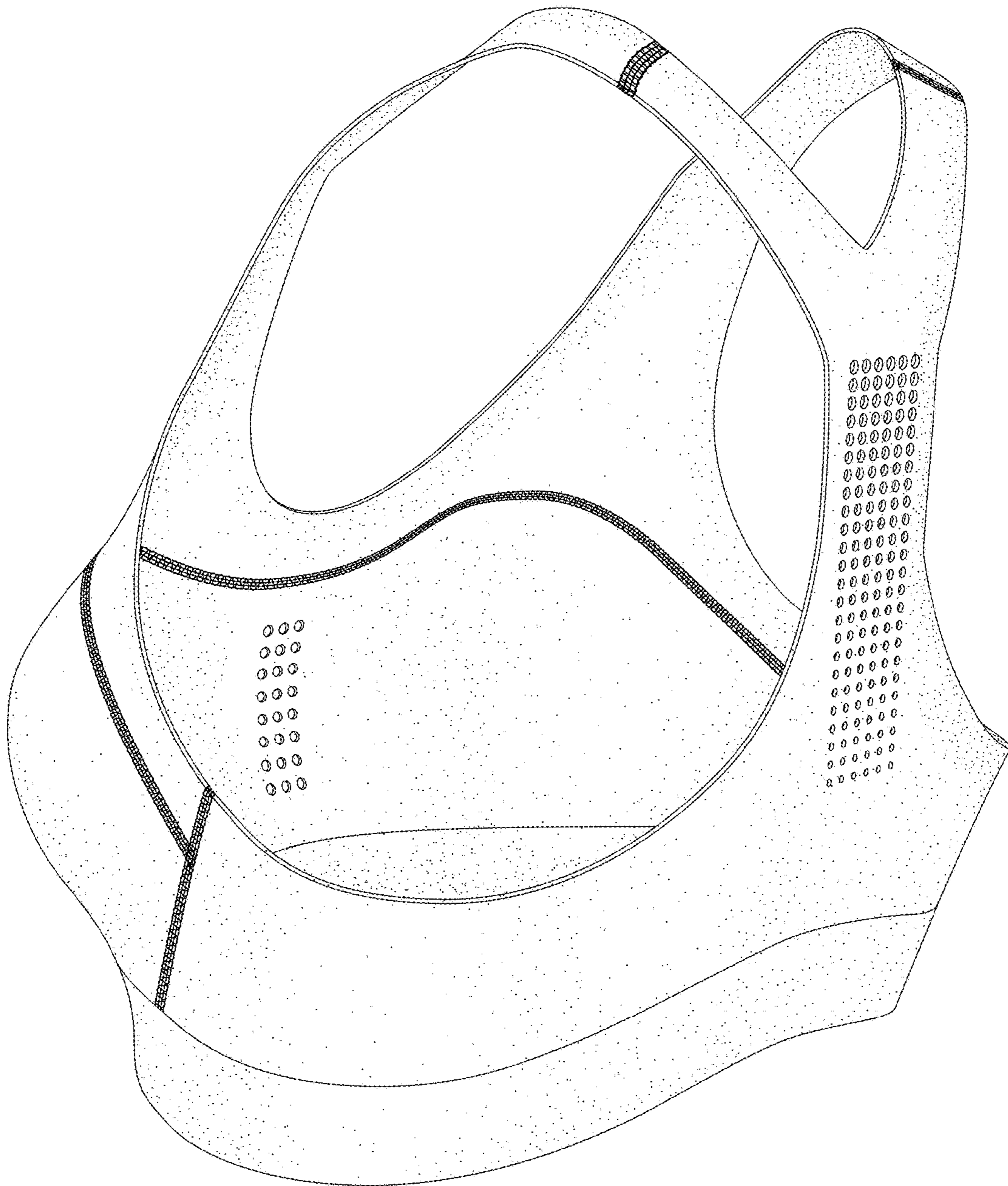

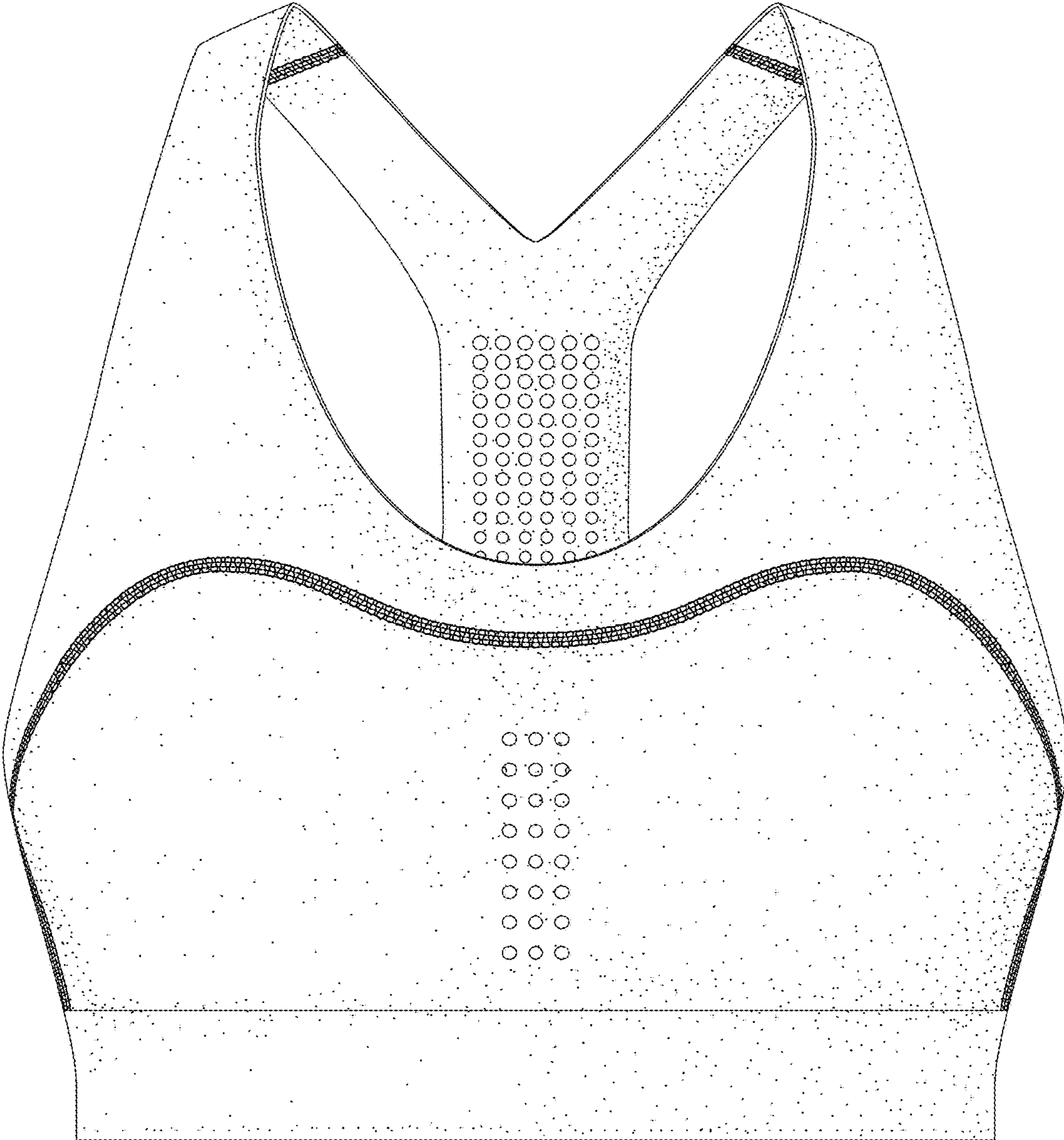

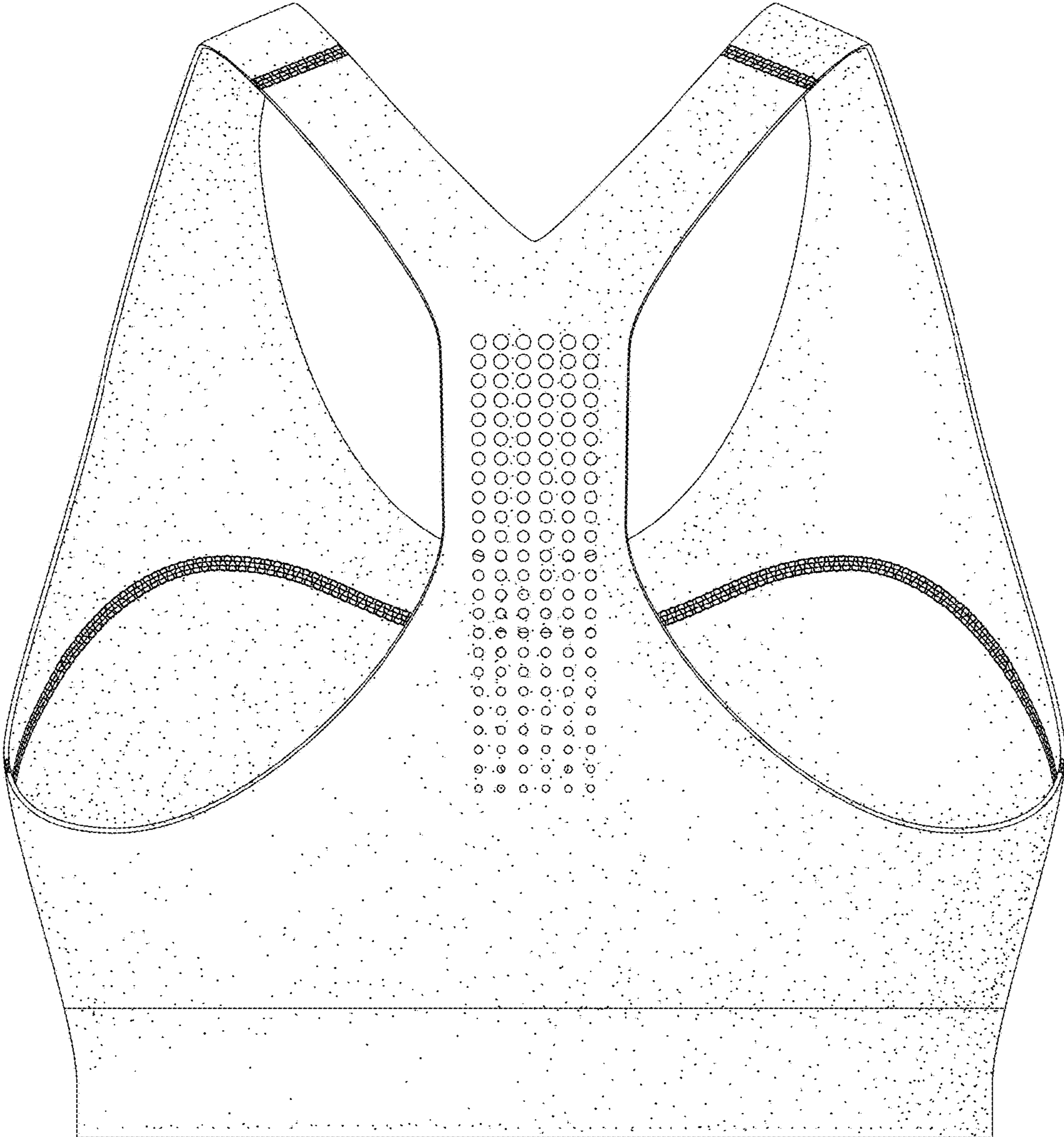

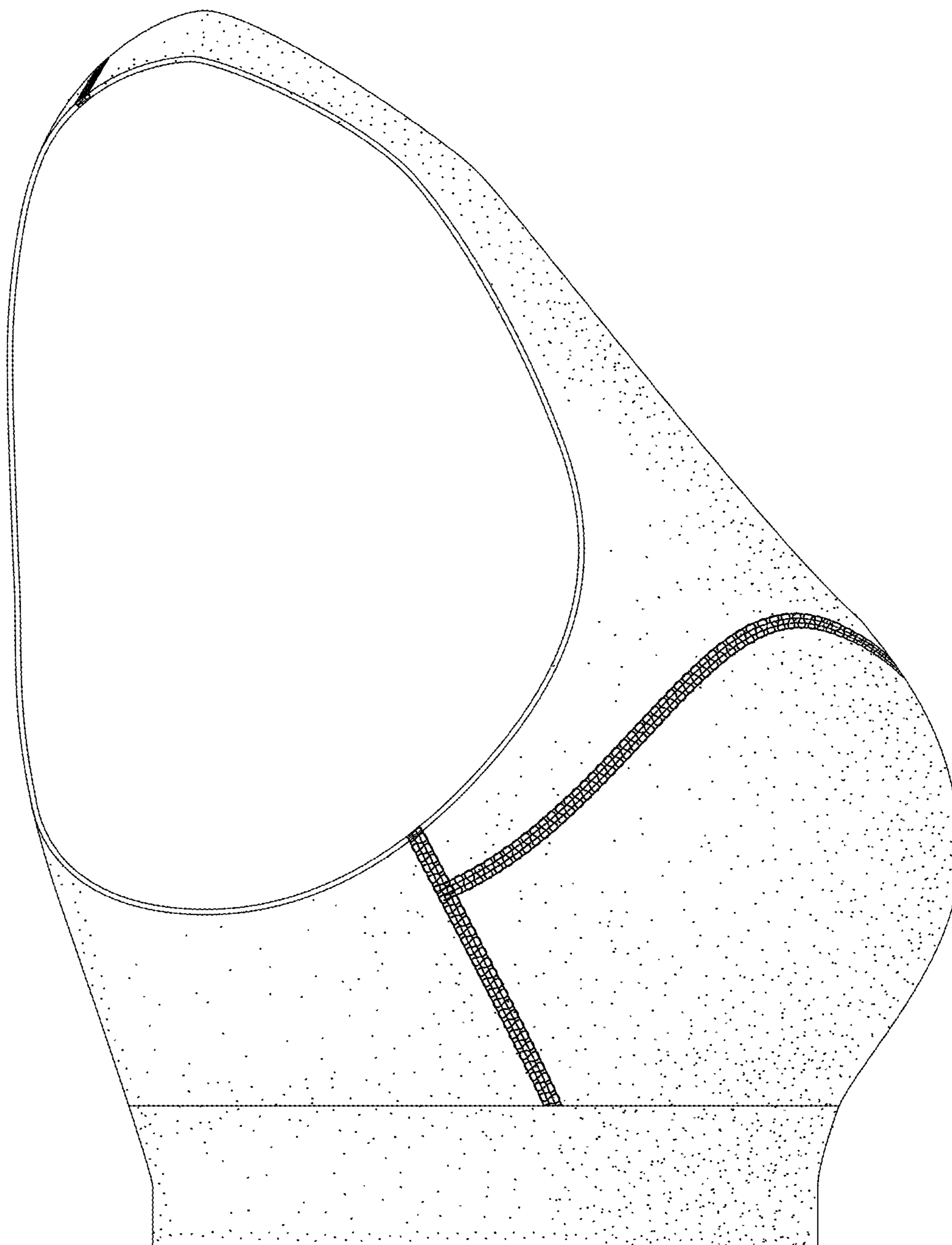

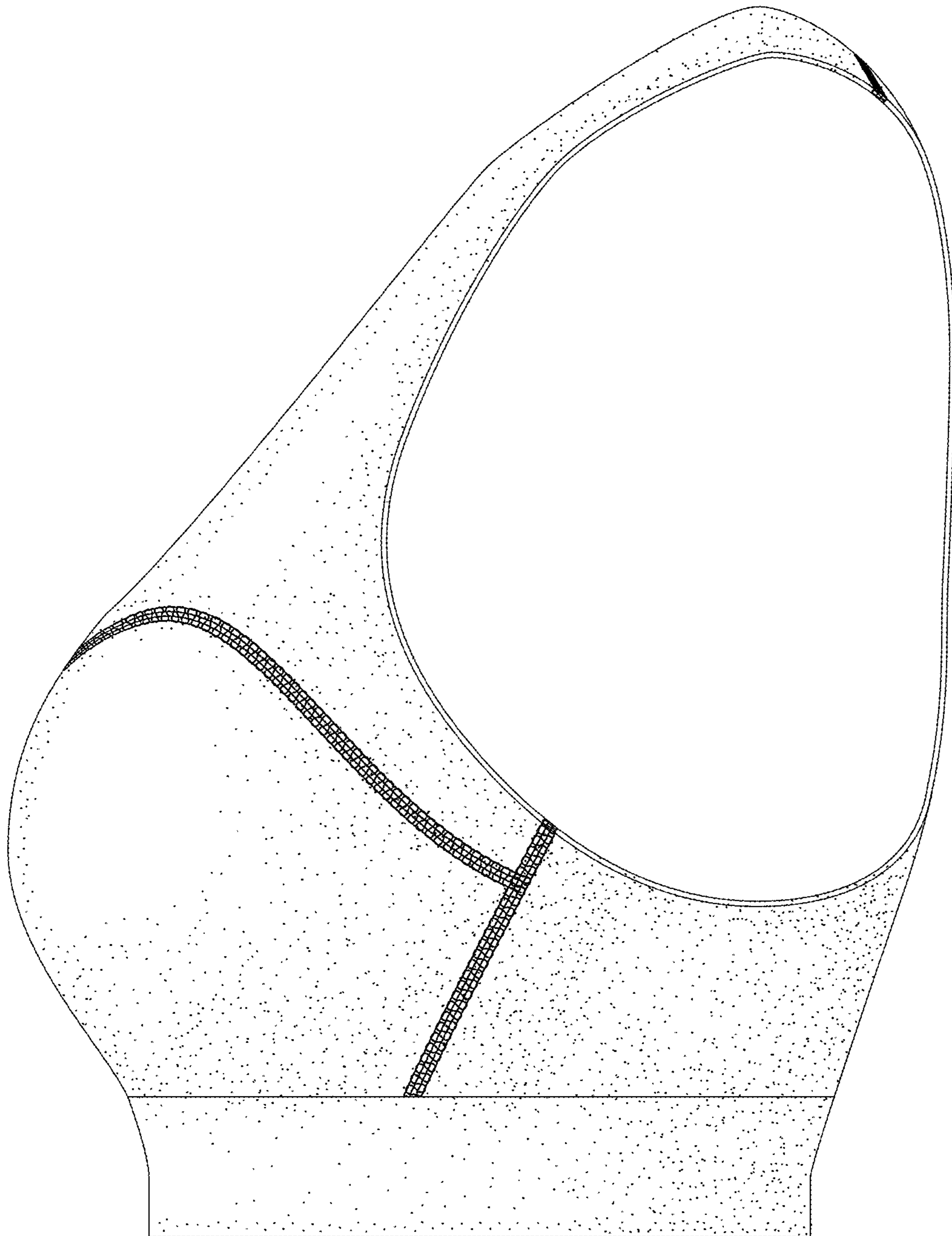
