and described.

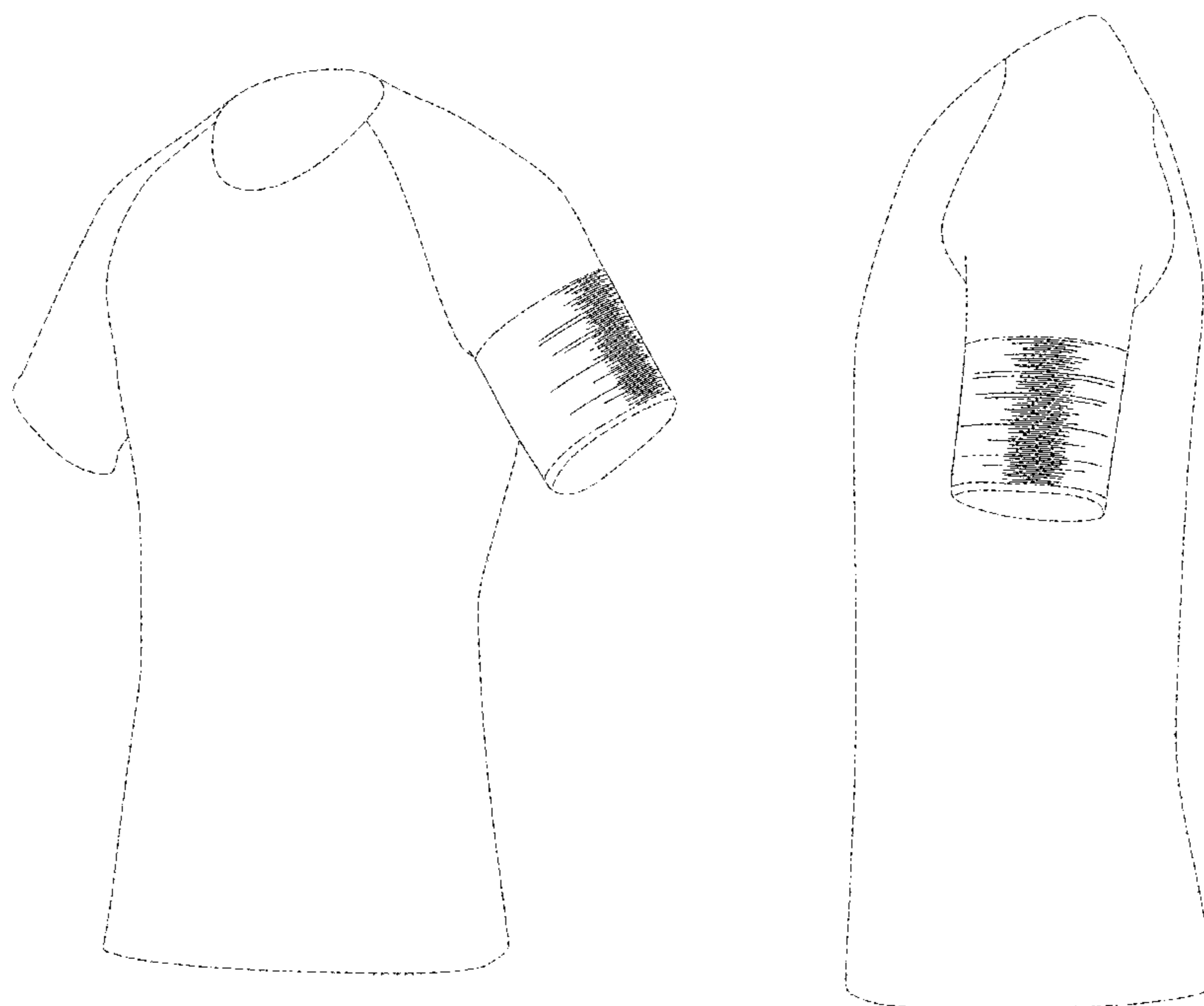
DESCRIPTION

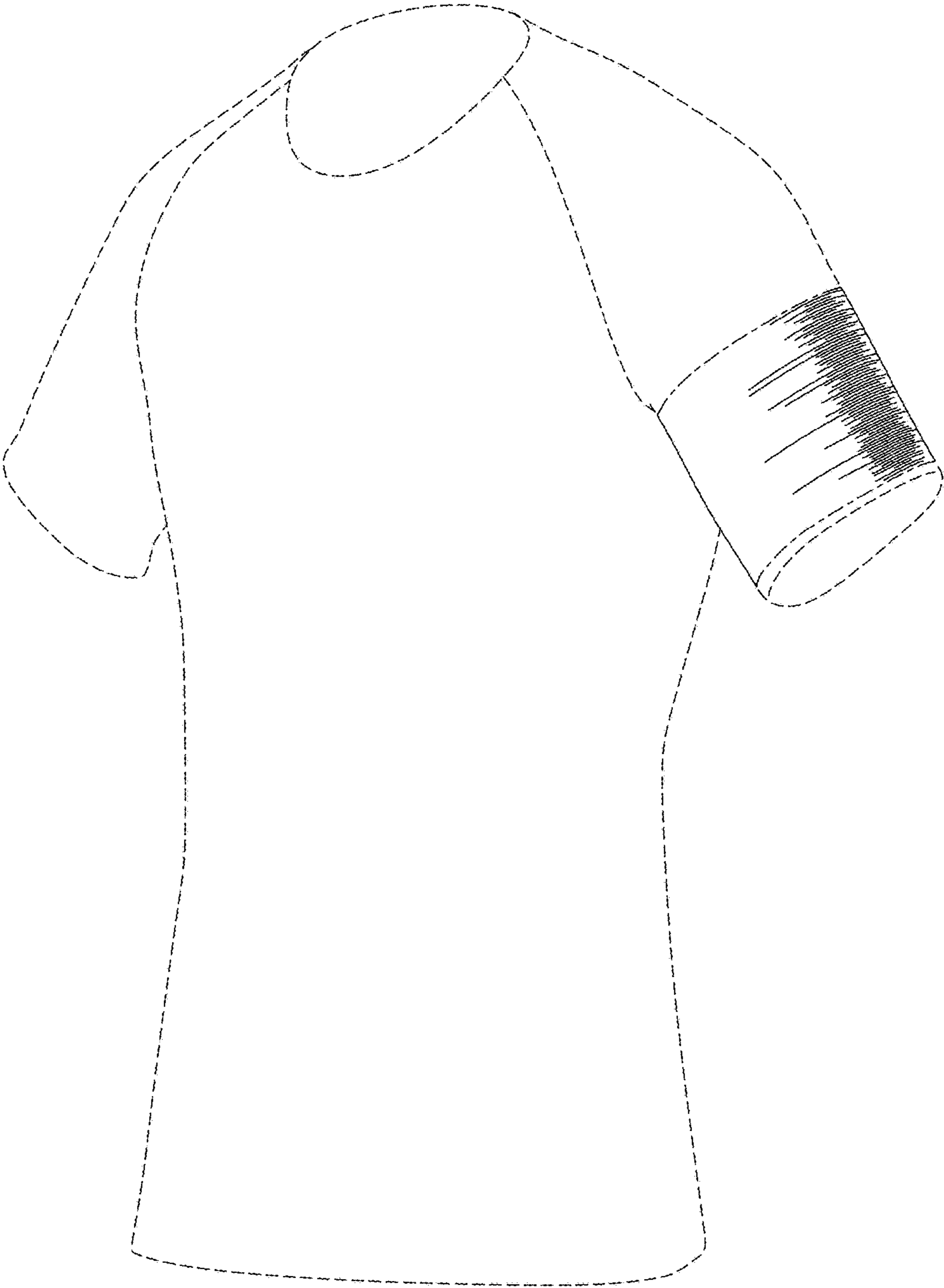

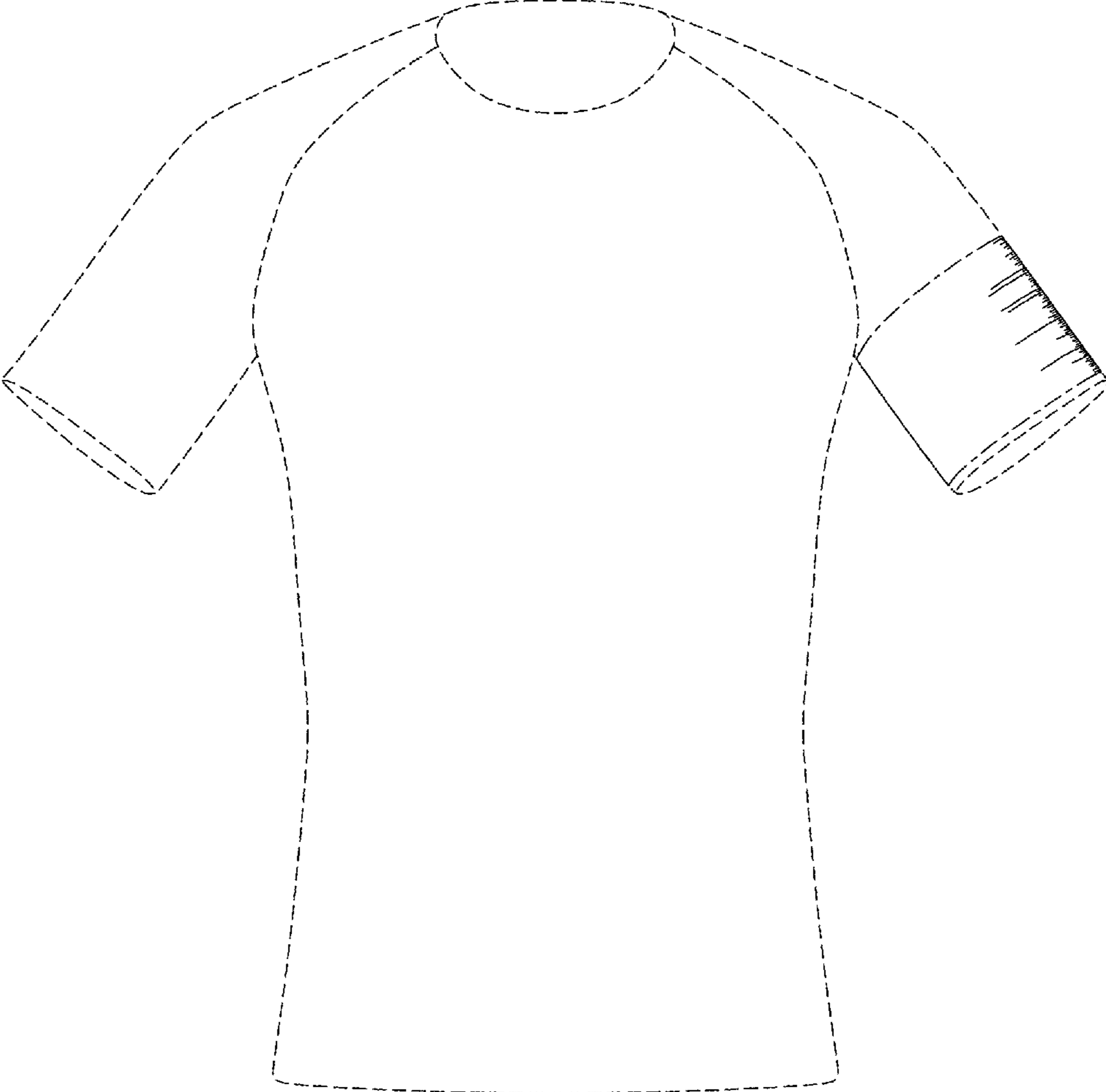

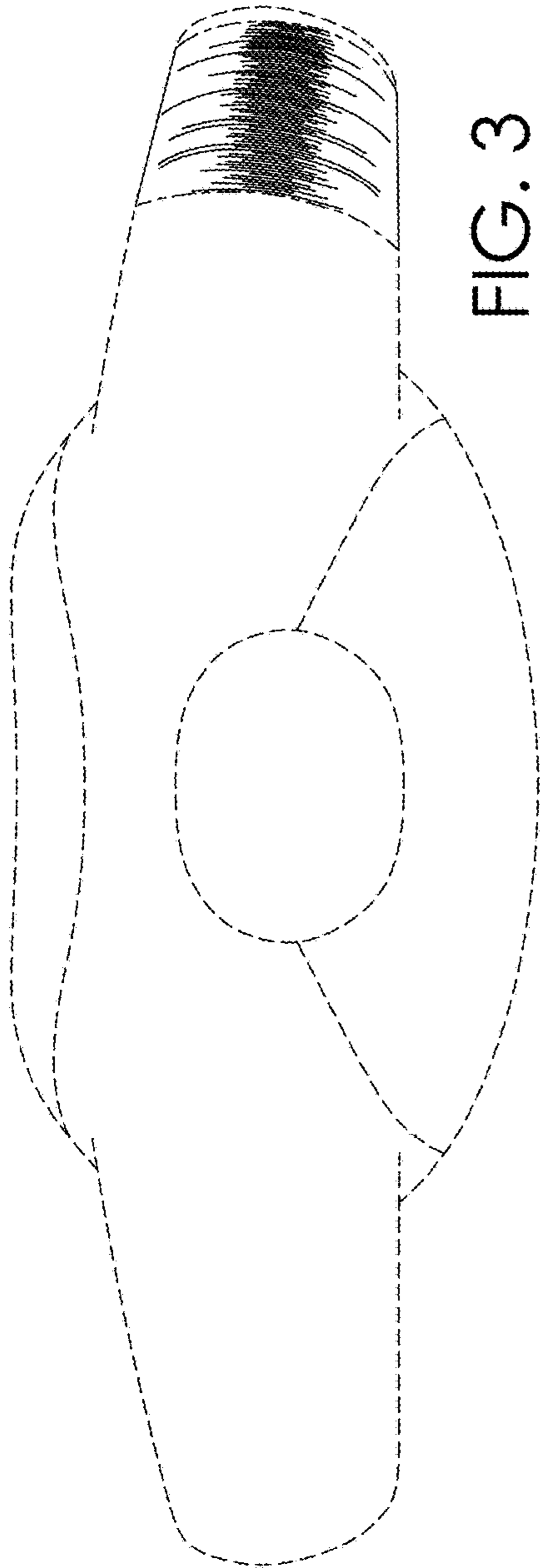

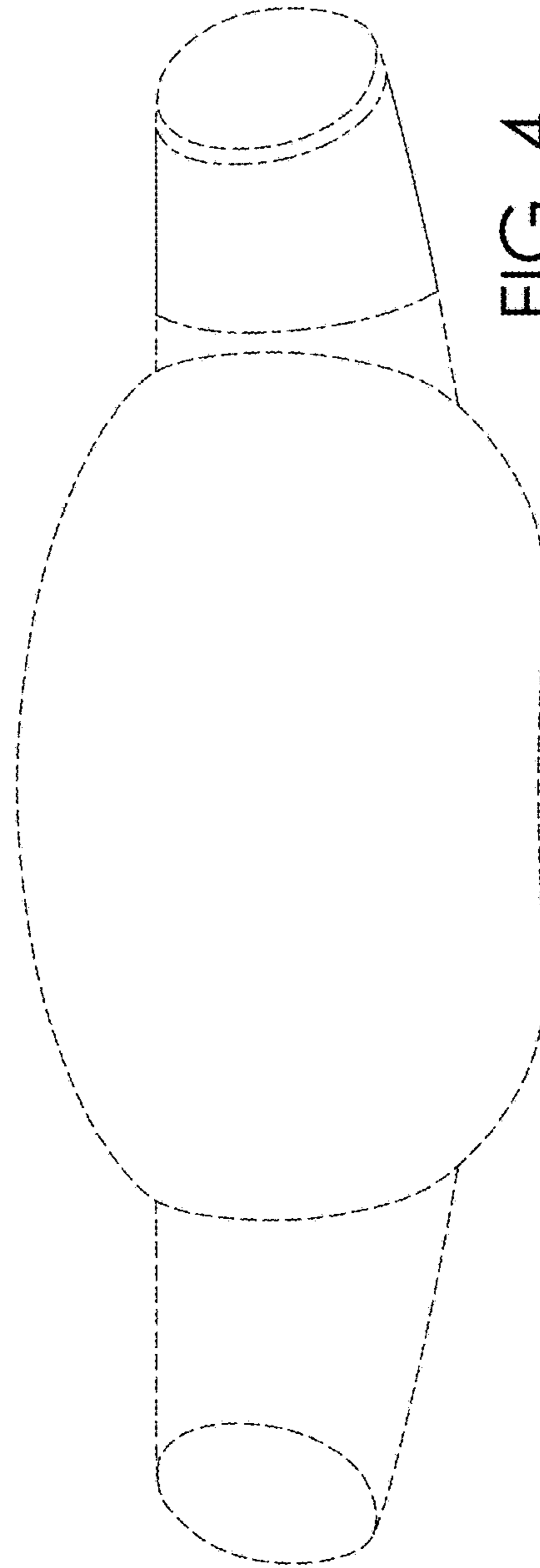

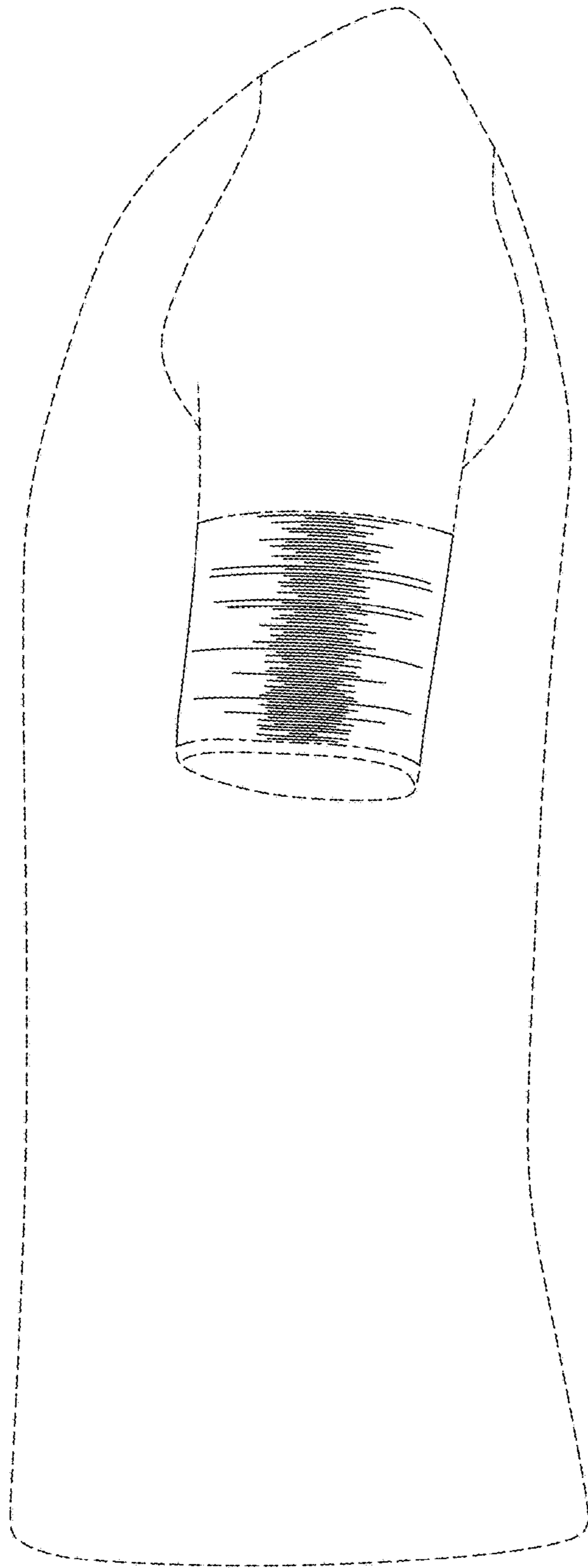

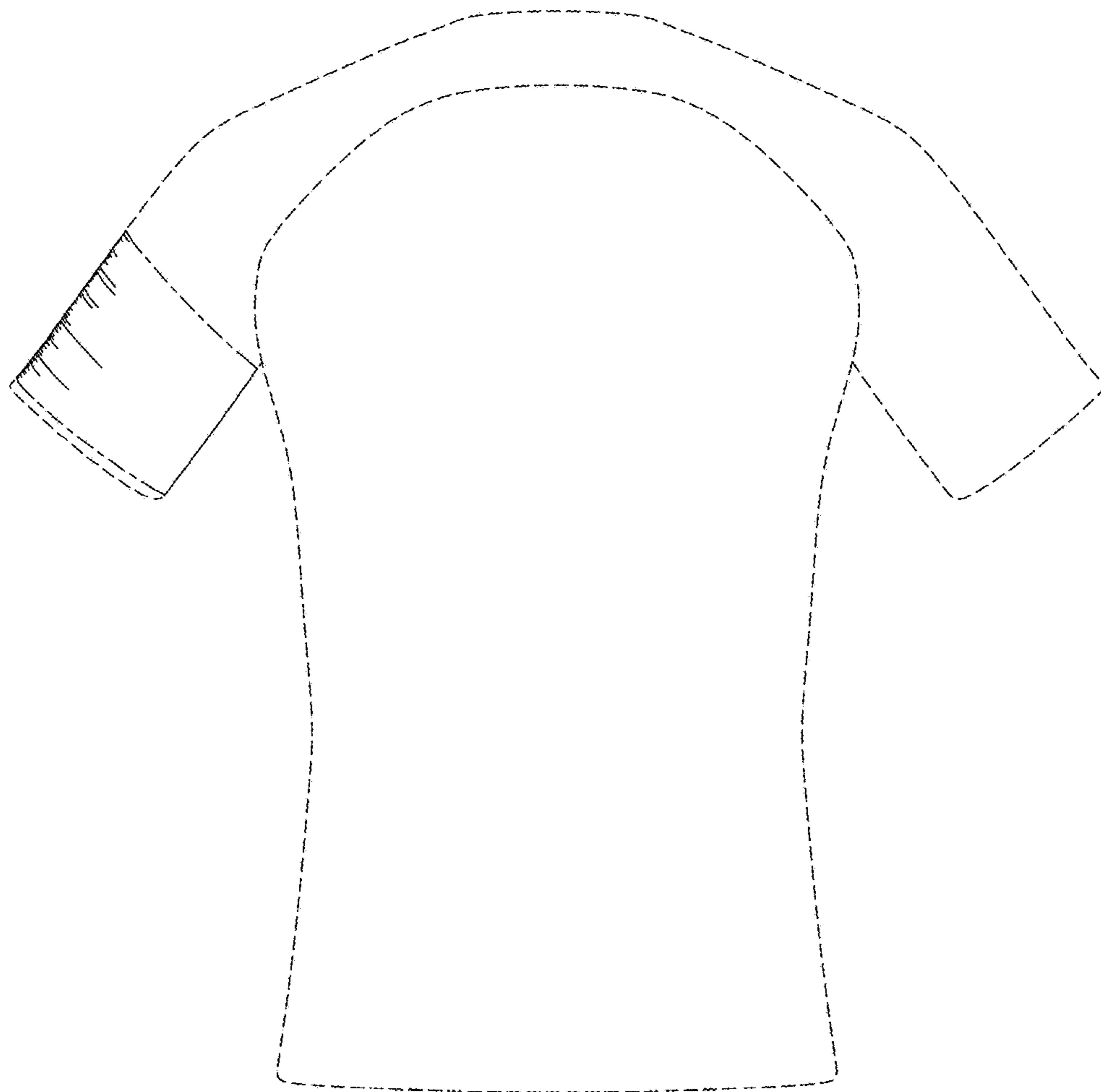

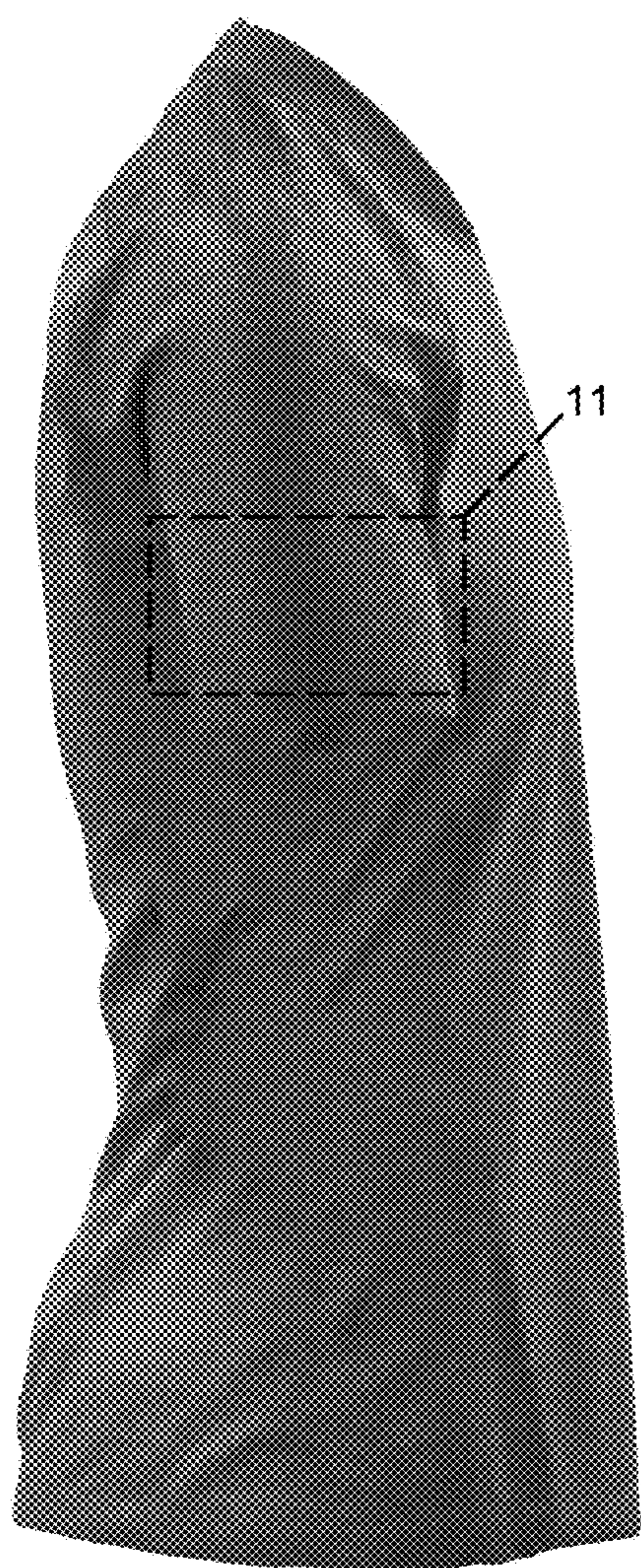

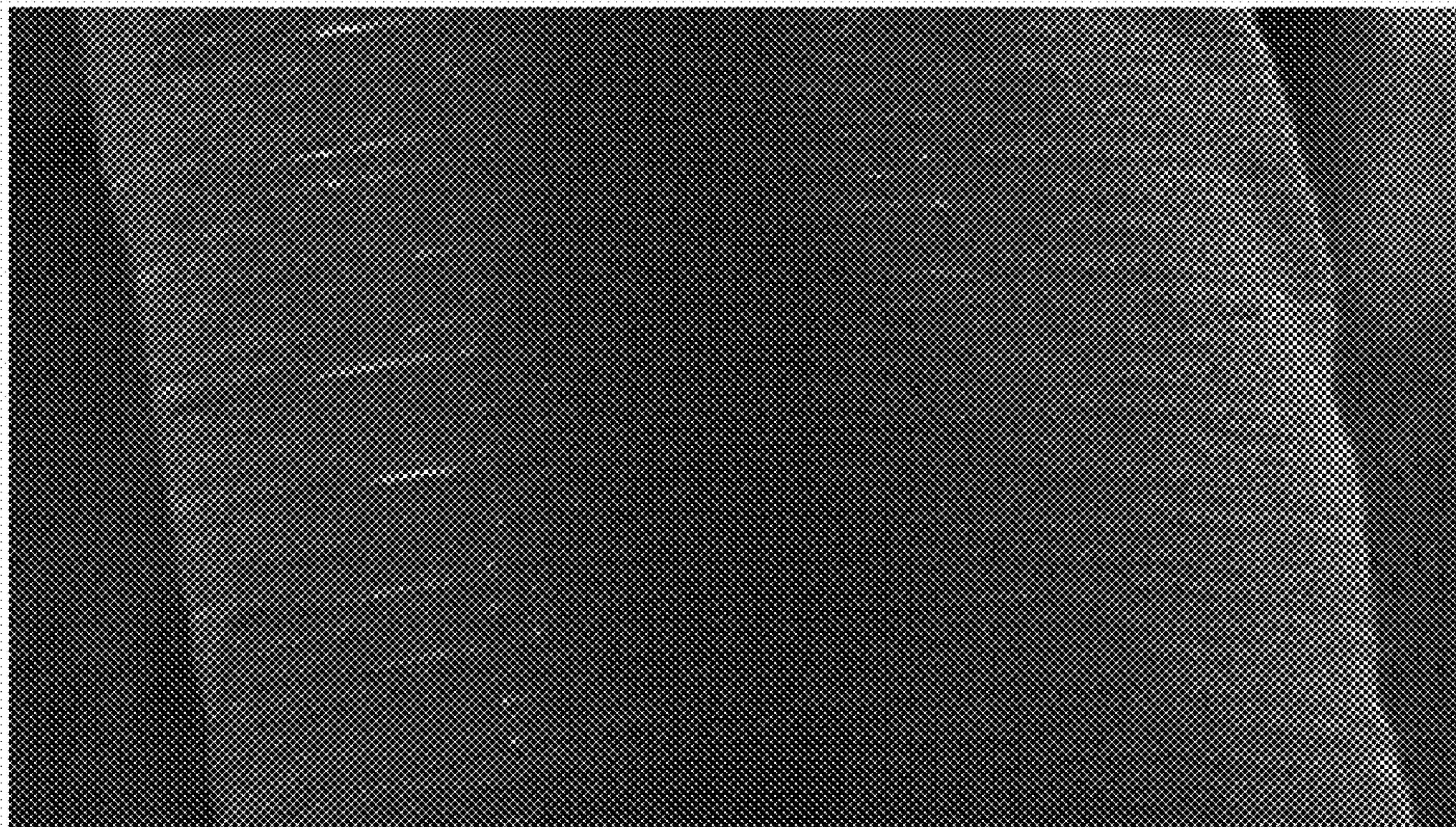
