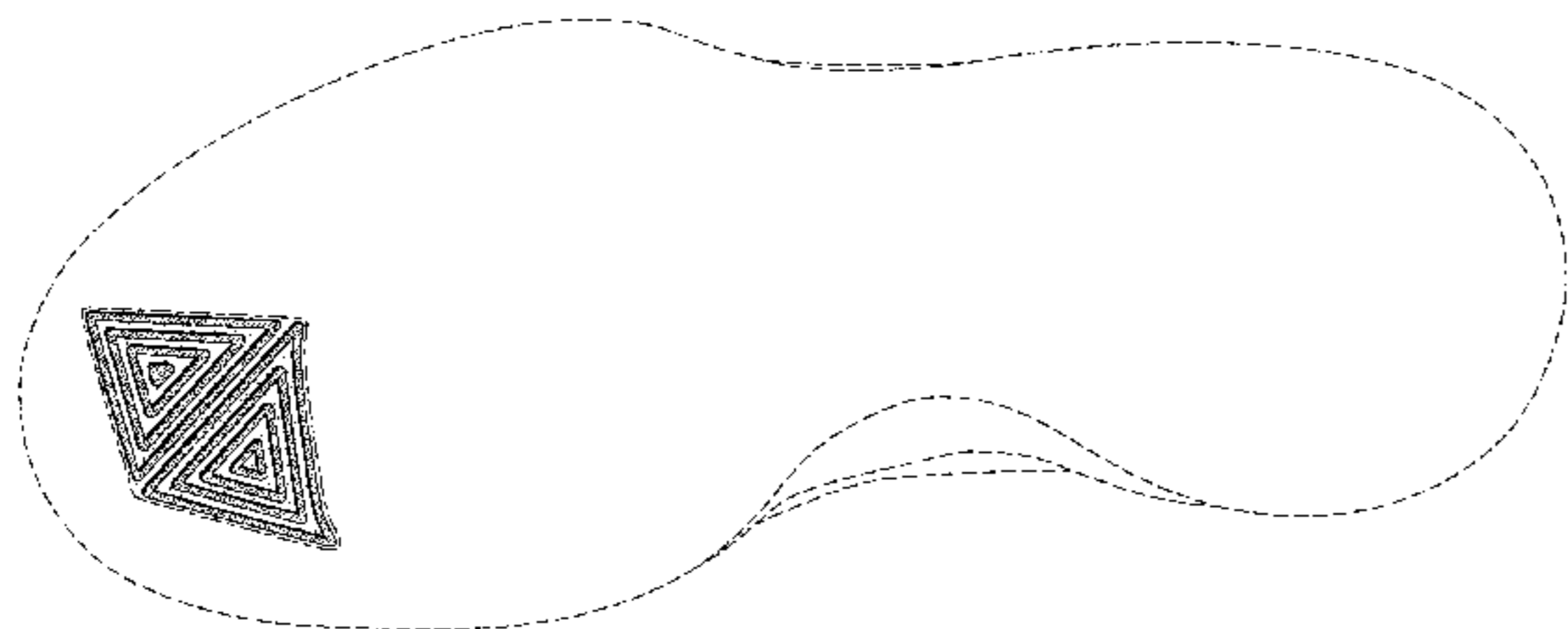
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a shoe outsole showing my design; FIG. 2 is a first side perspective thereof view thereof; and, FIG. 3 is a second side front perspective view thereof. The long-and-short broken lines form an unclaimed boundary around the claimed subject matter, and form no part of the claimed design. The even-length broken lines, which show the remainder of the article, are directed to the environment, represent unclaimed subject matter, and form no part of the claimed design.

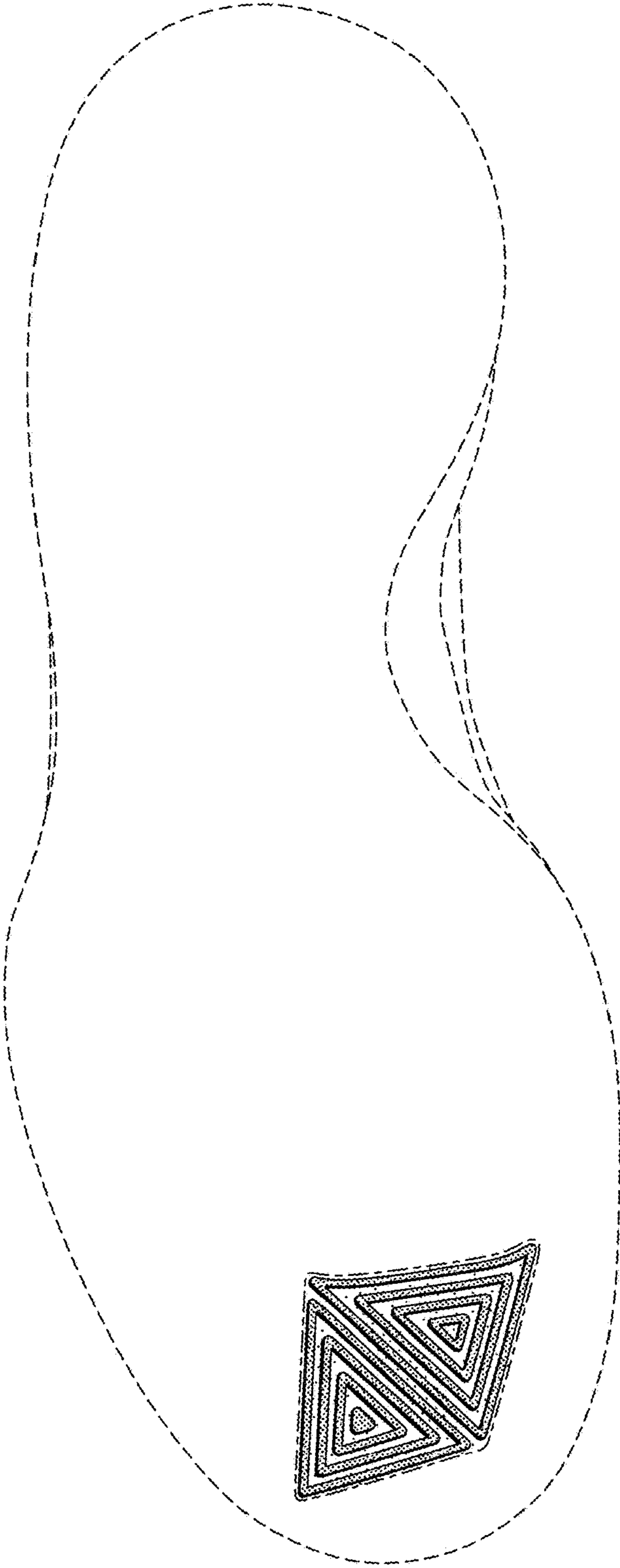

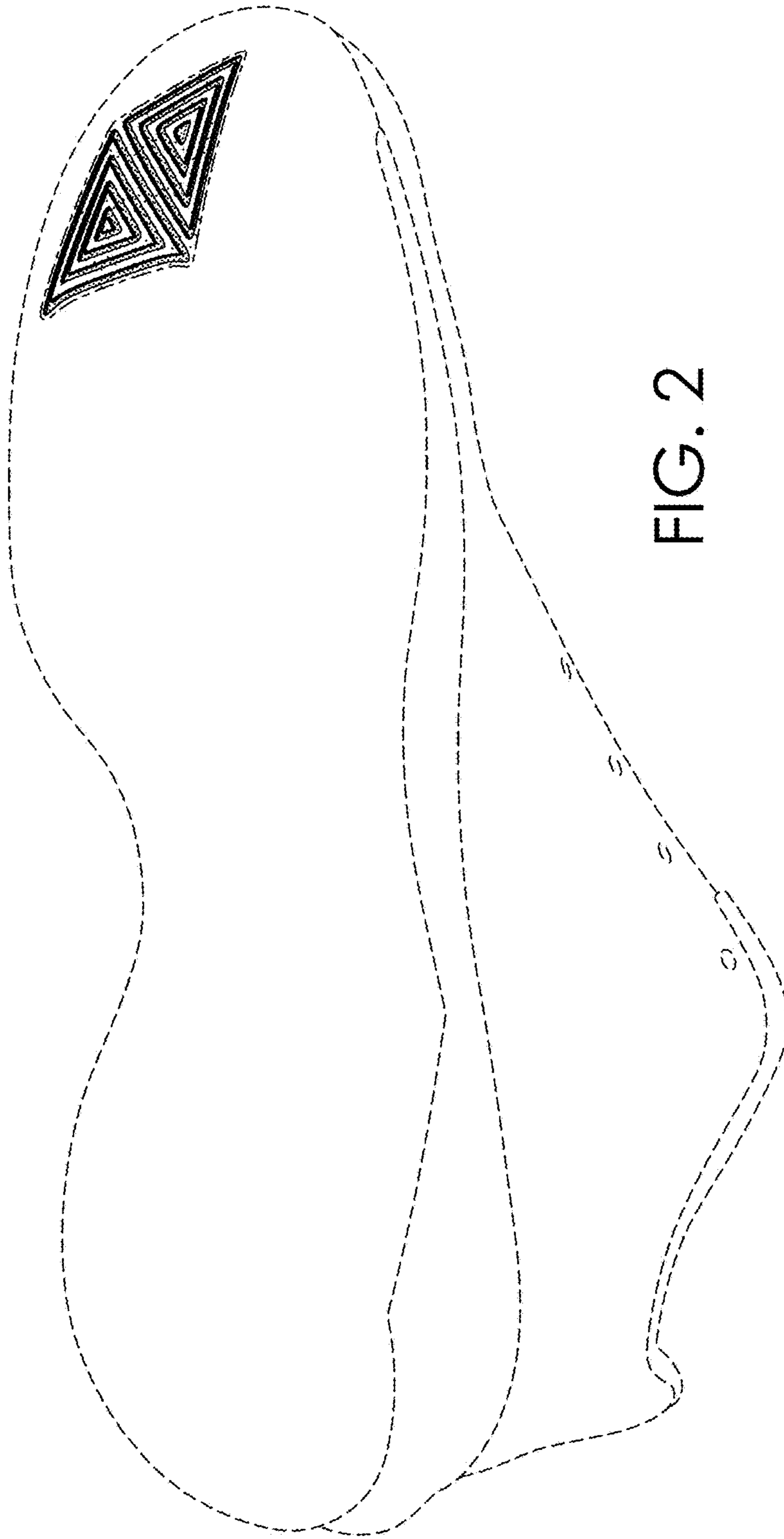

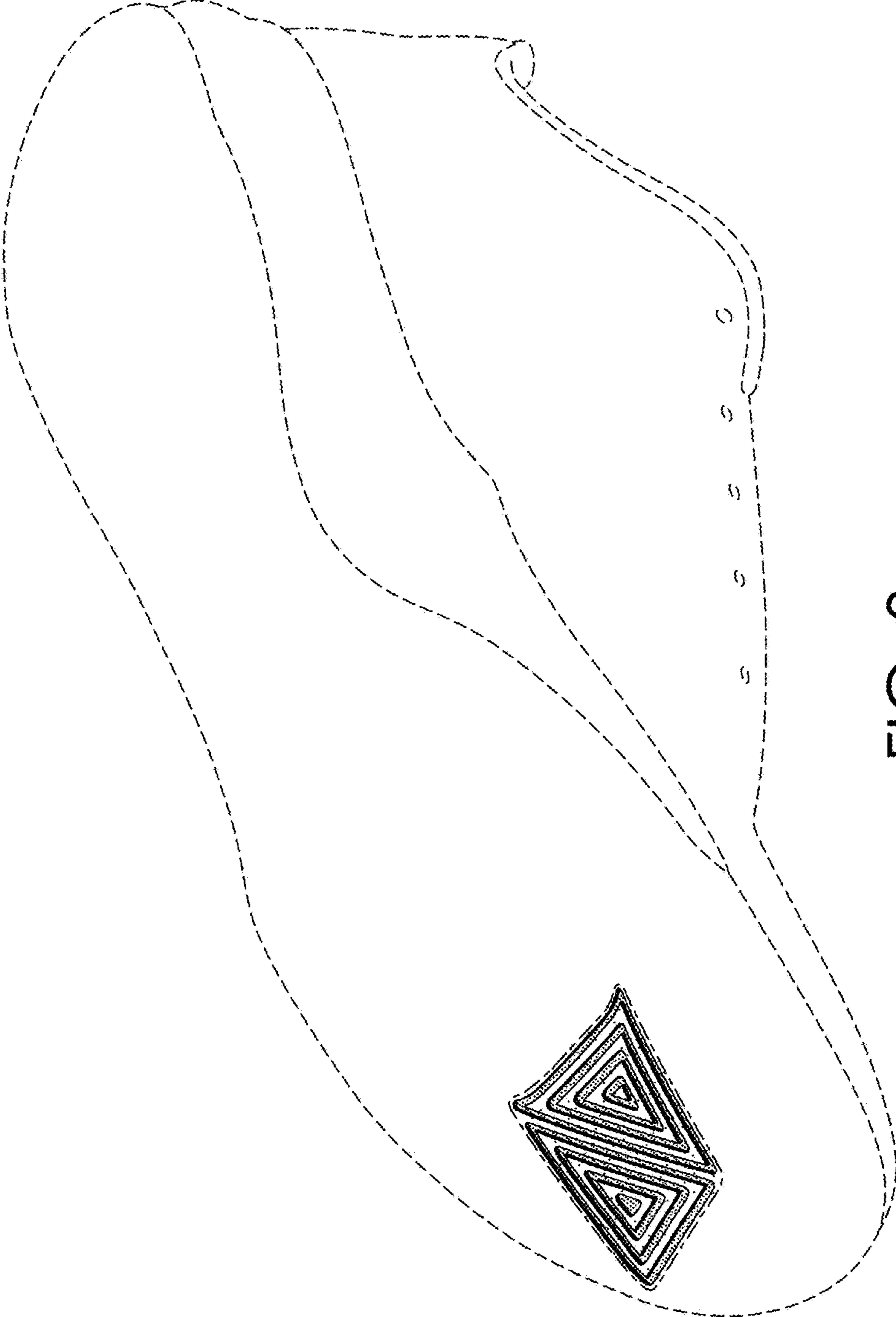
