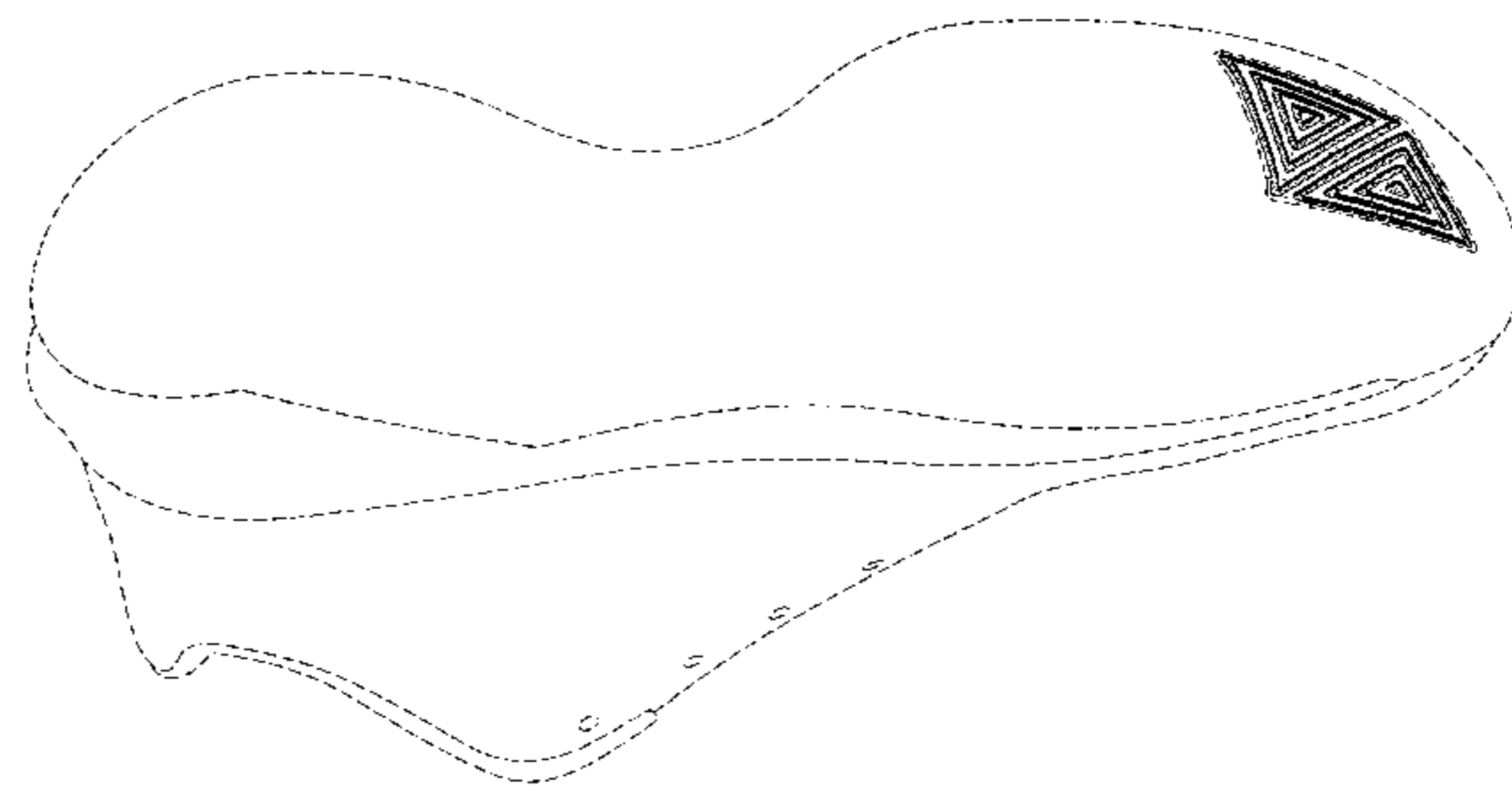
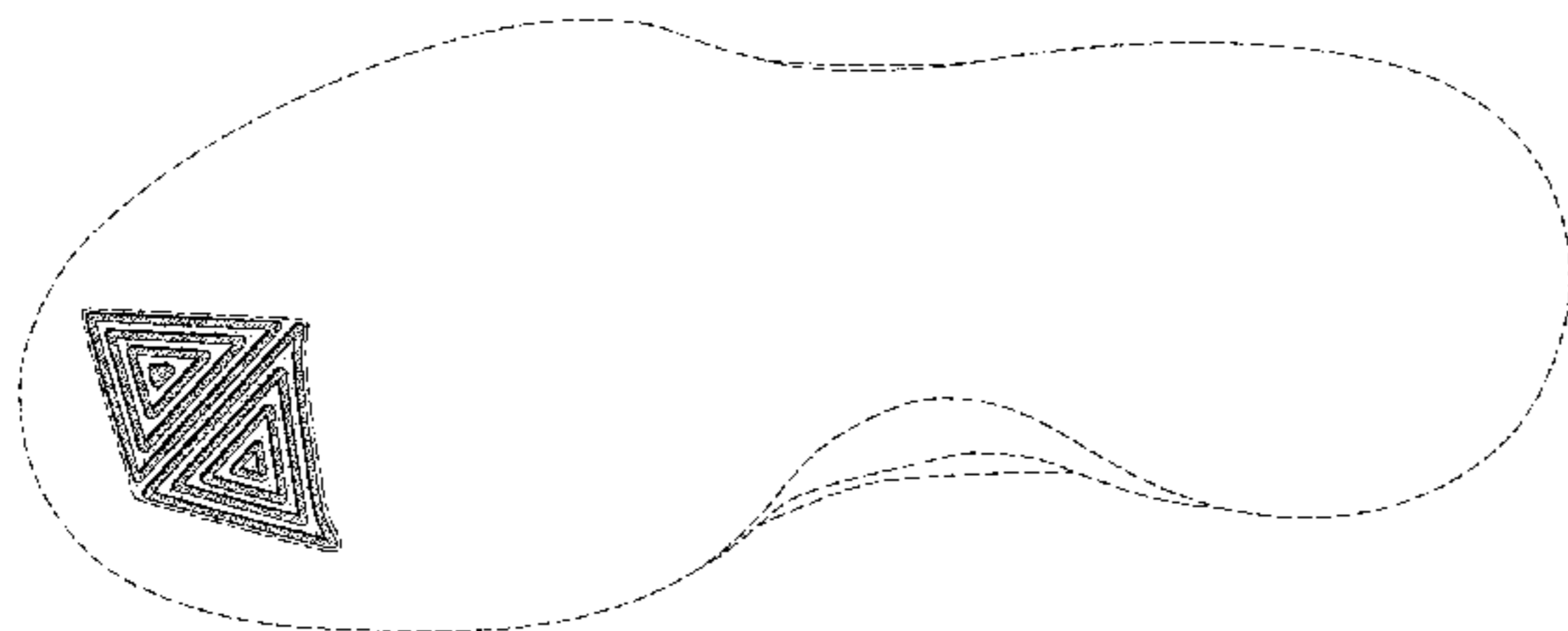
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom plan view of a shoe outsole showing my design;
FIG. 2 is a first side perspective thereof view thereof; and,

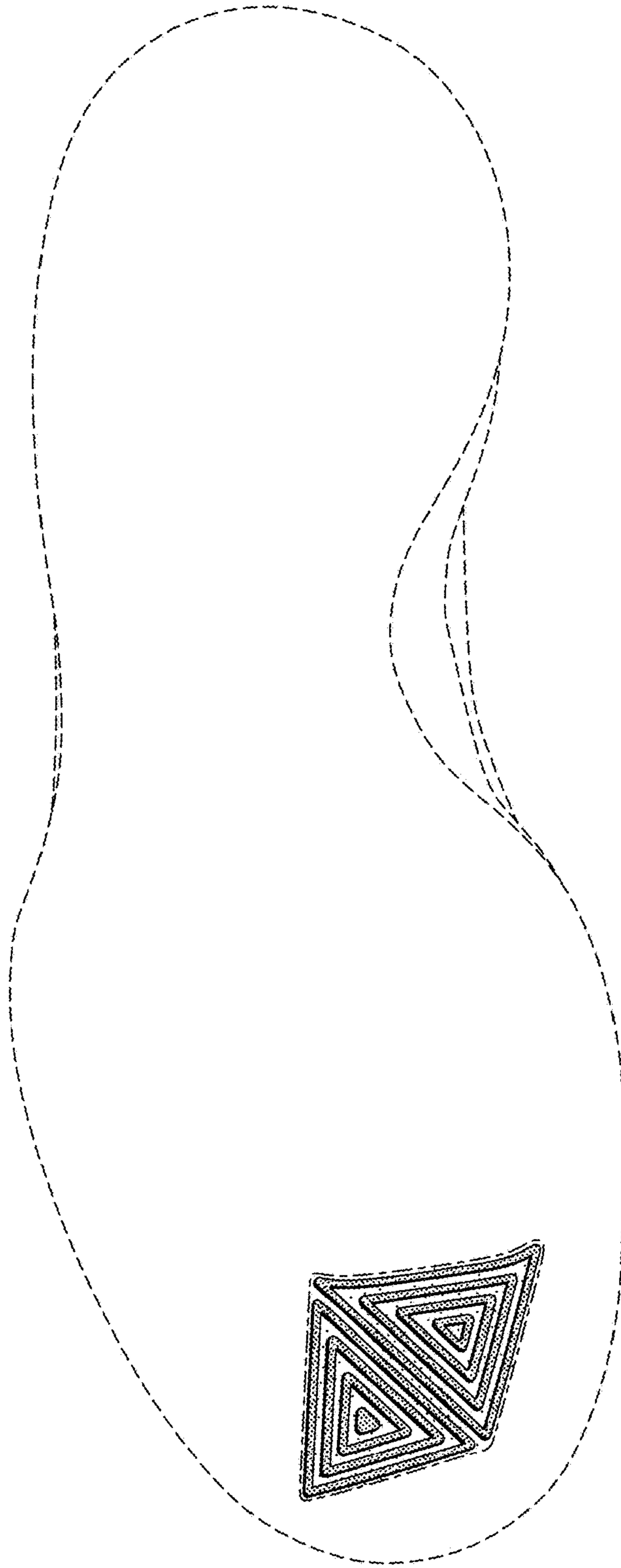

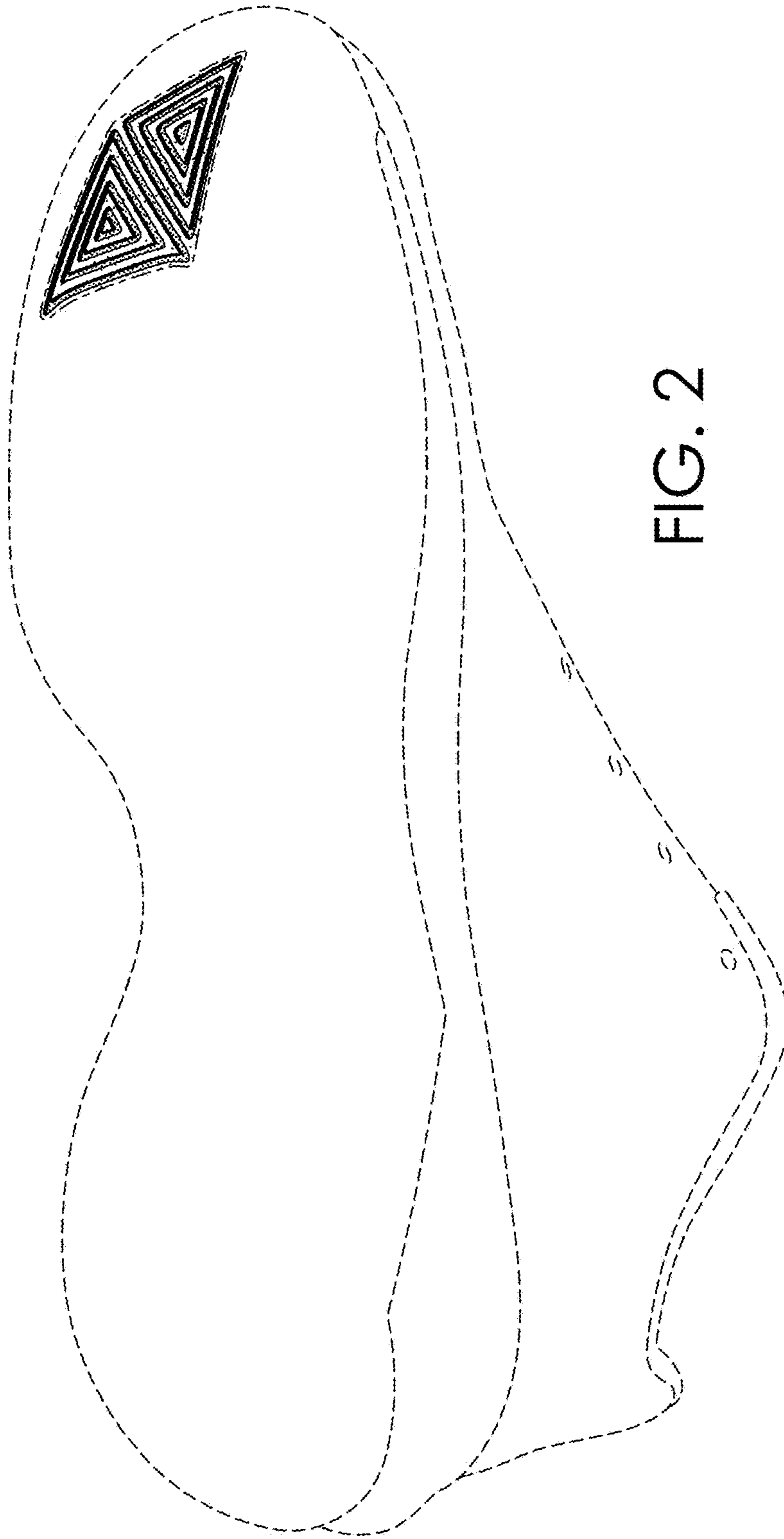

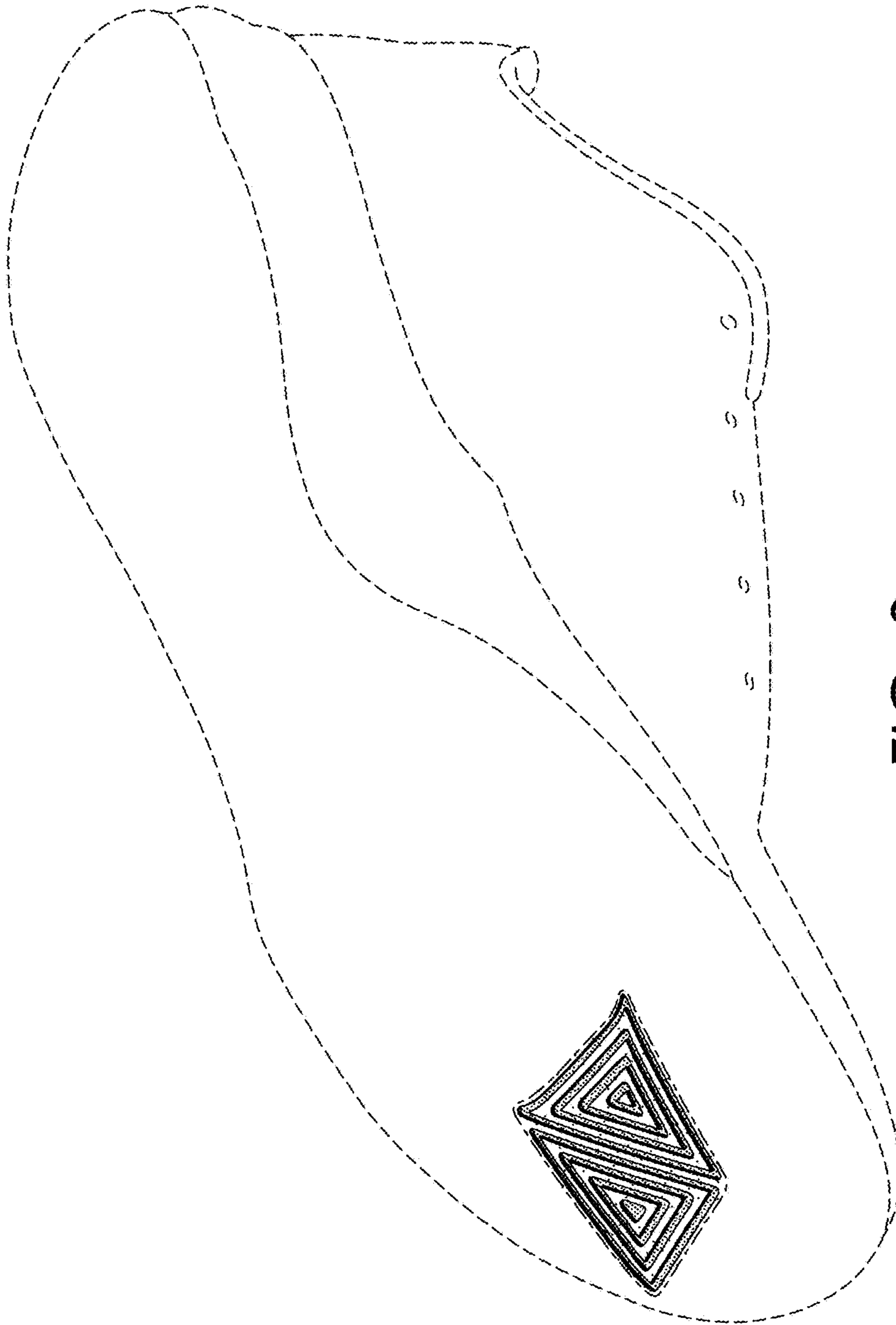
