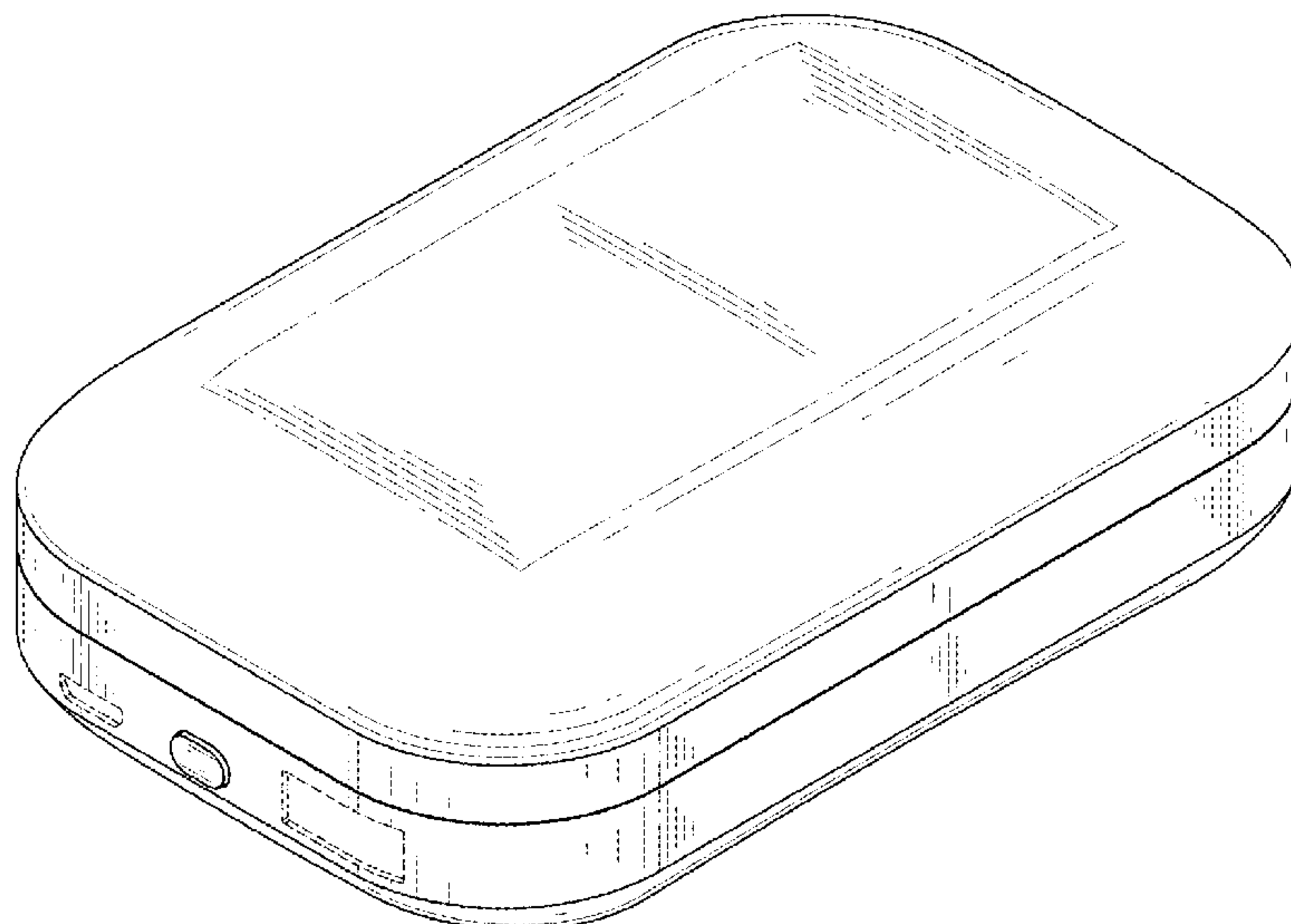
(57) **CLAIM**

The ornamental design for a power box with wireless earphone, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and left end perspective view of the power box with wireless earphone showing my new design; FIG. 2 is a bottom and right end perspective view thereof; FIG. 3 is a left end elevation view thereof; FIG. 4 is a right end elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a perspective view thereof with the top lid of the power box shown in an open position. The broken lines depict environmental structure and are included for the purpose of illustrating only and form no part of the claimed design.

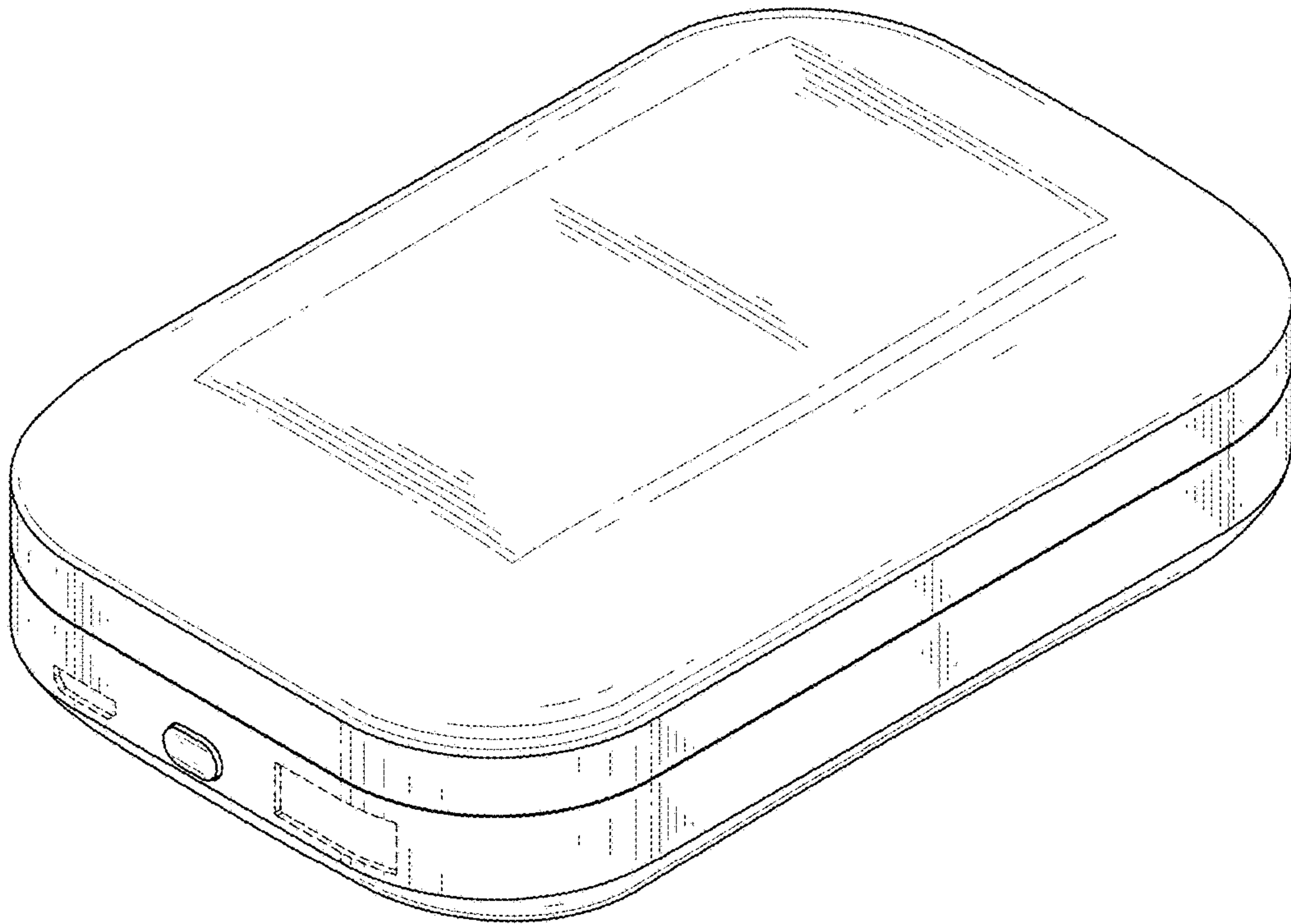

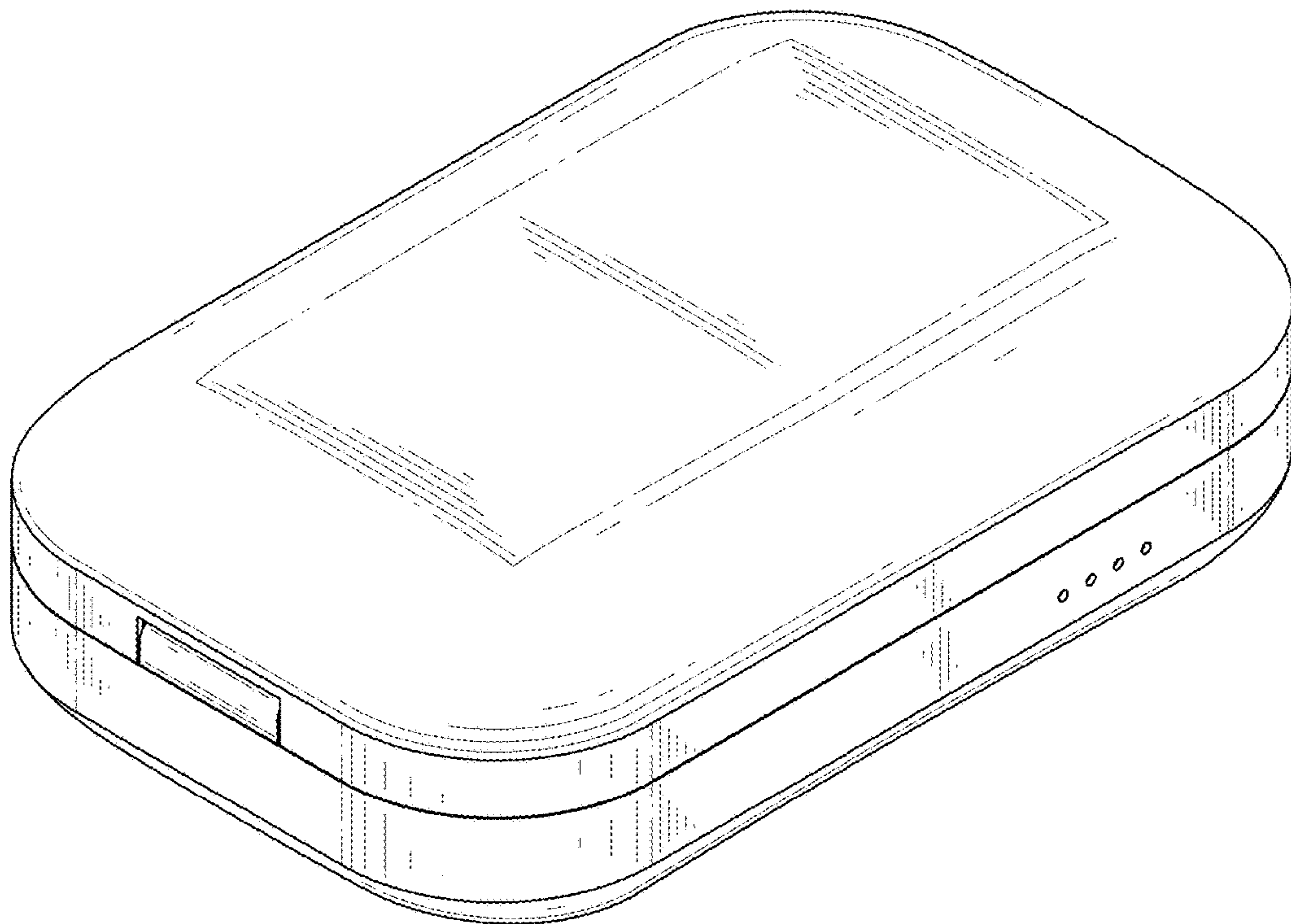

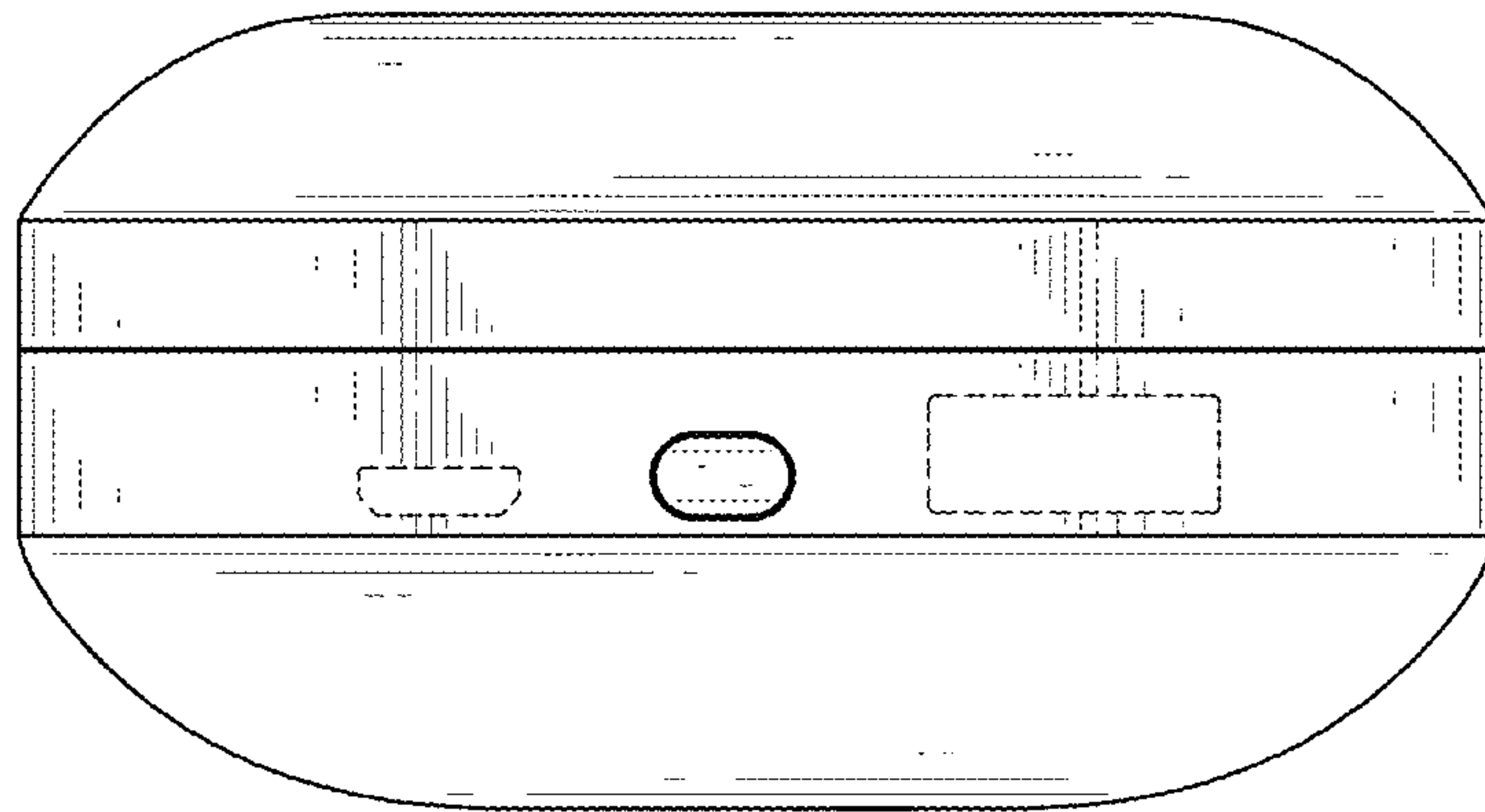

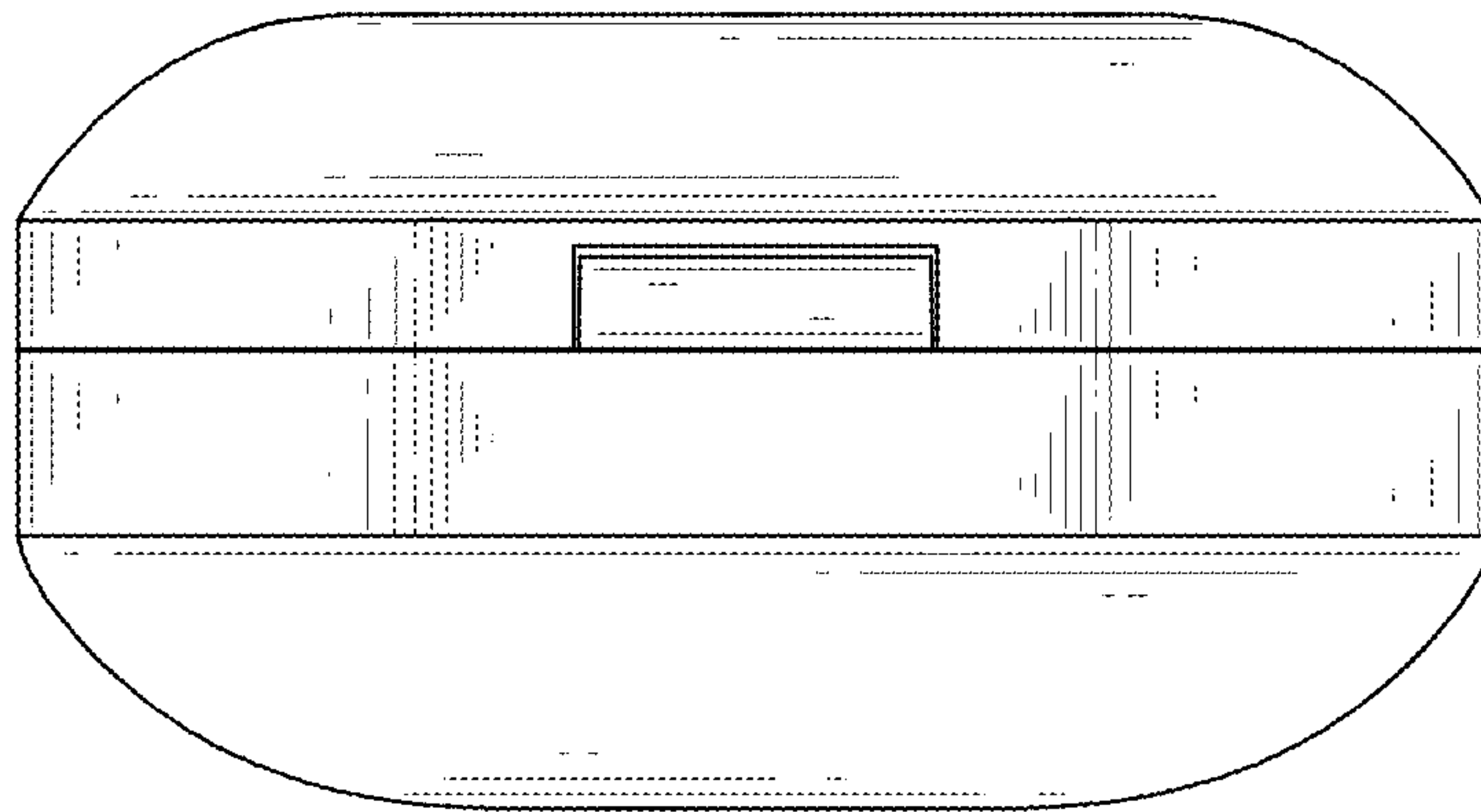

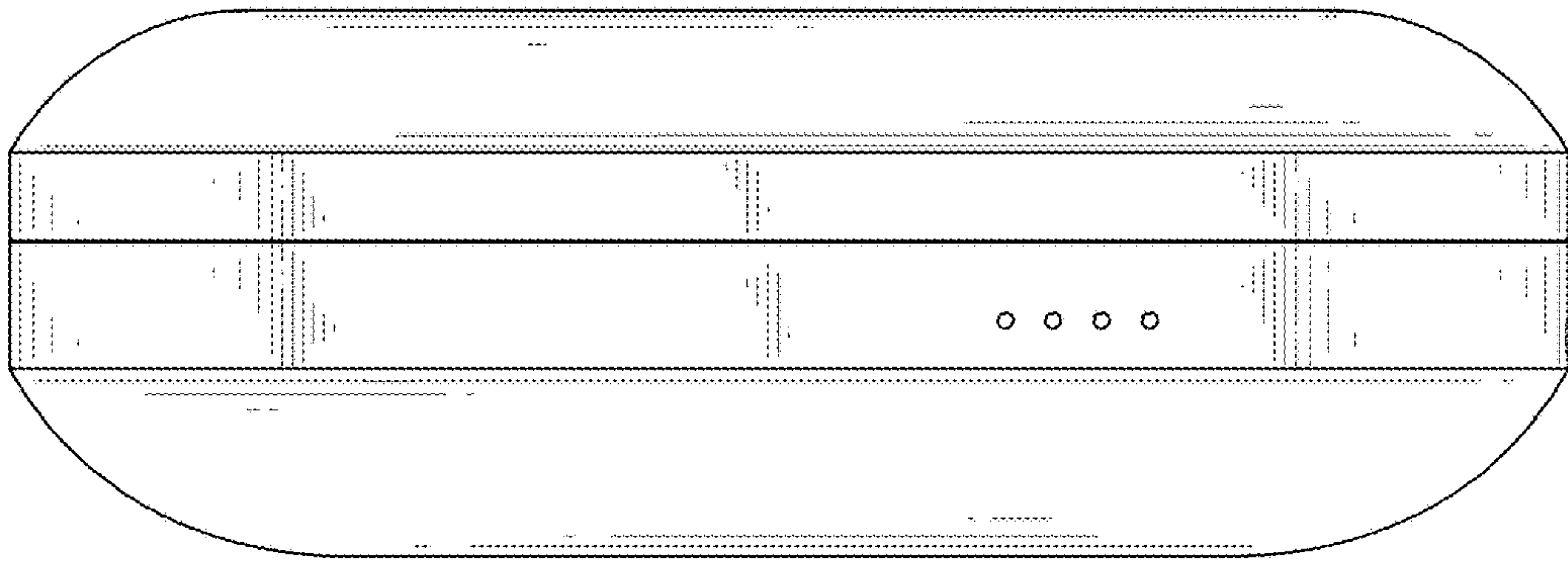

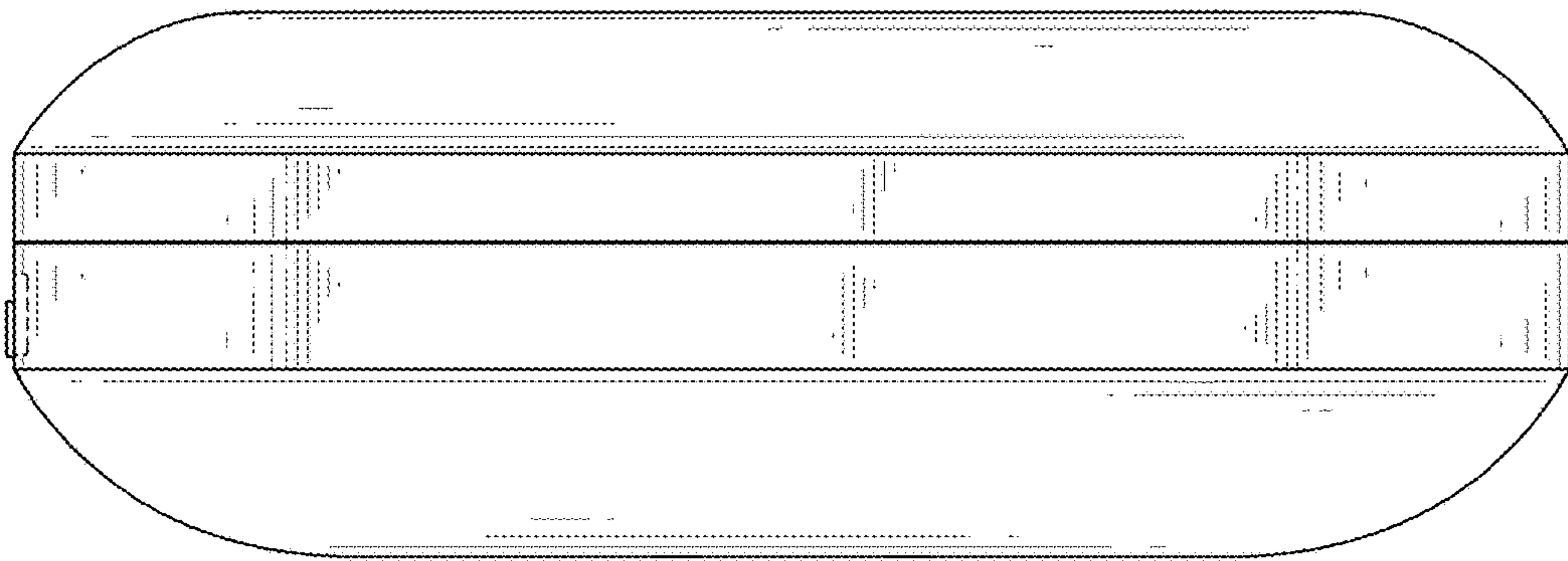

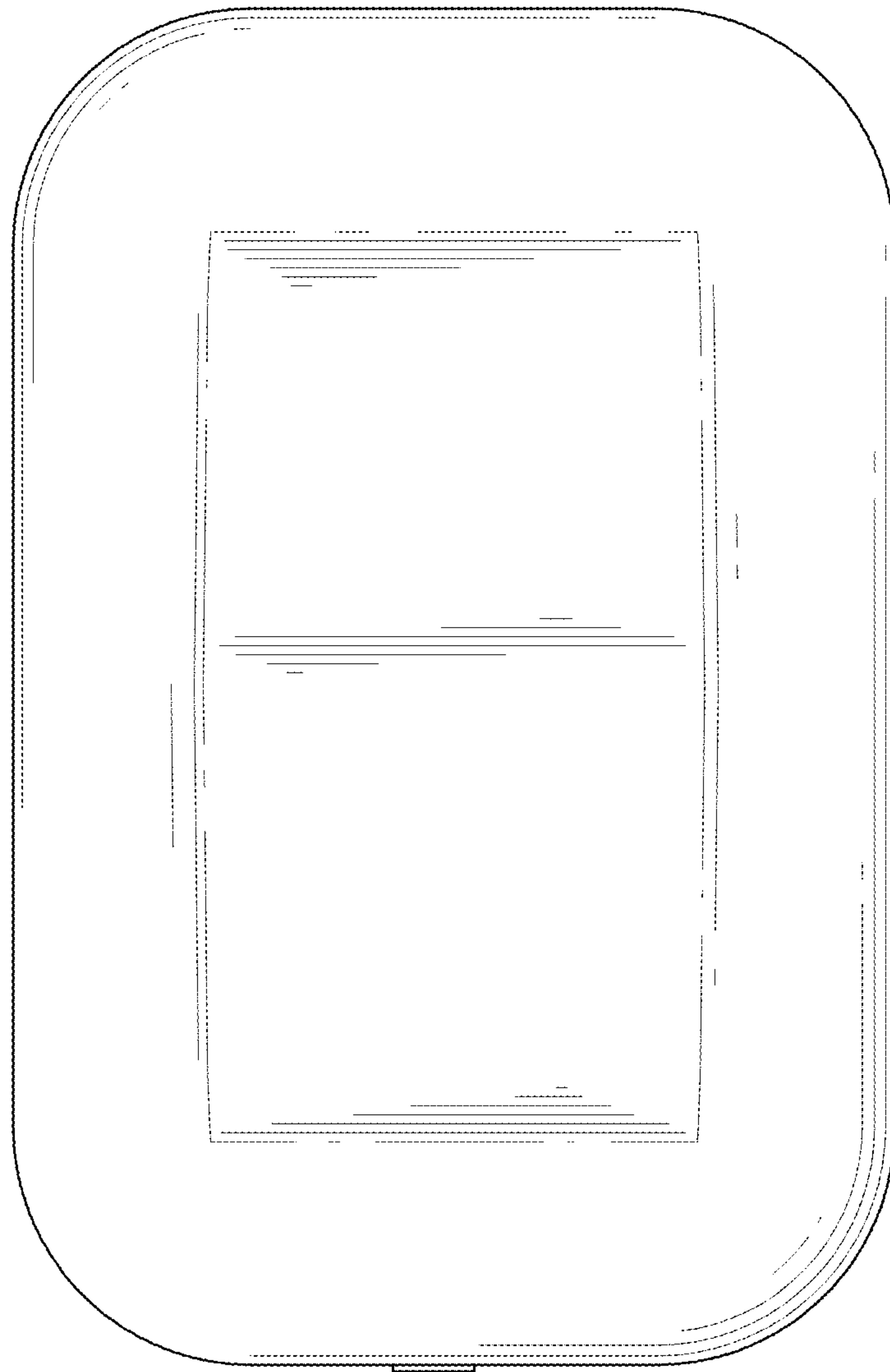

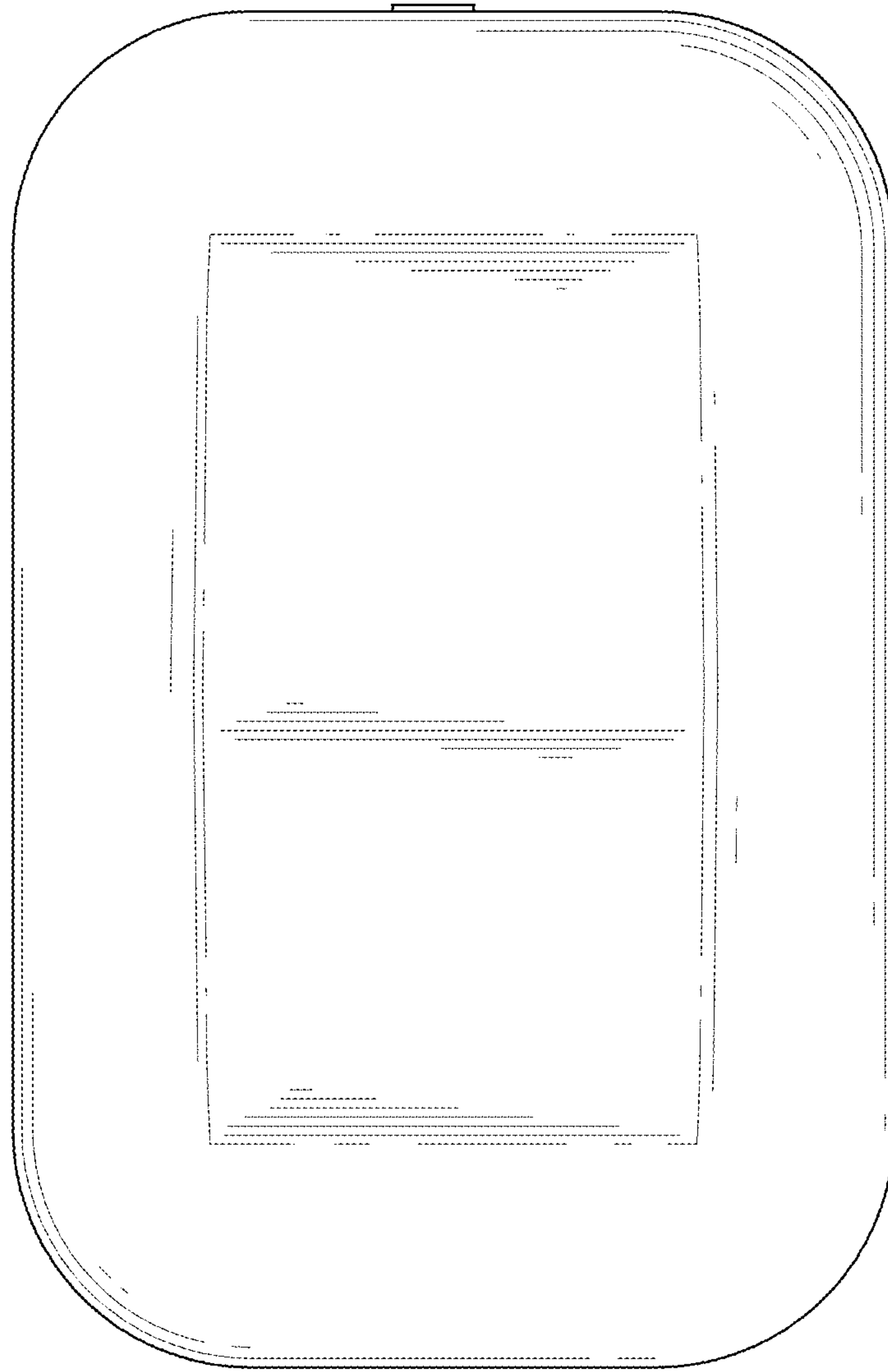

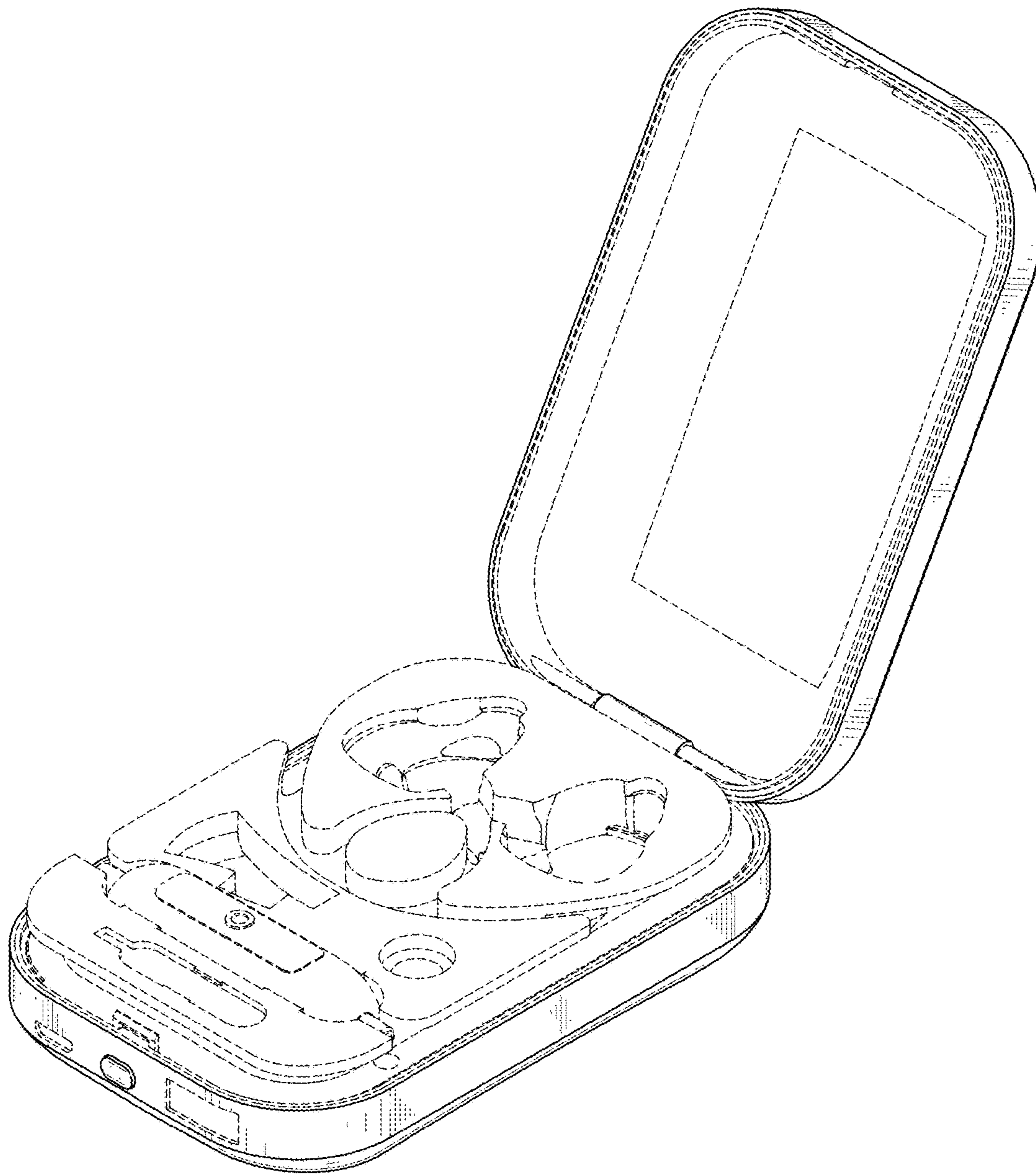
