The ornamental design for a vehicle seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a vehicle seat;  
FIG. 2 is a rear and right side perspective view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is an elevation view thereof from the left side; and,  
FIG. 6 is an elevation view thereof from the right side.

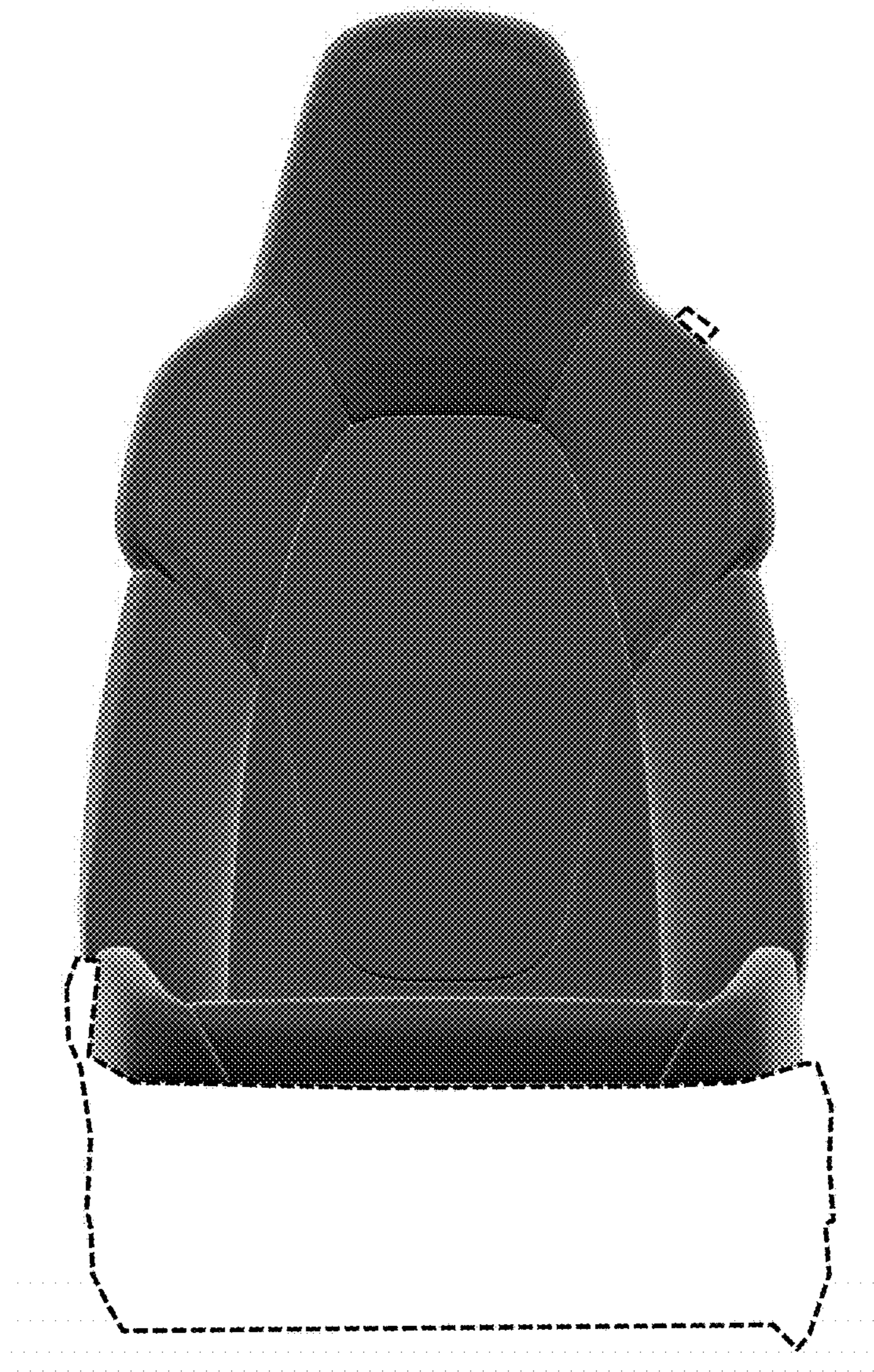

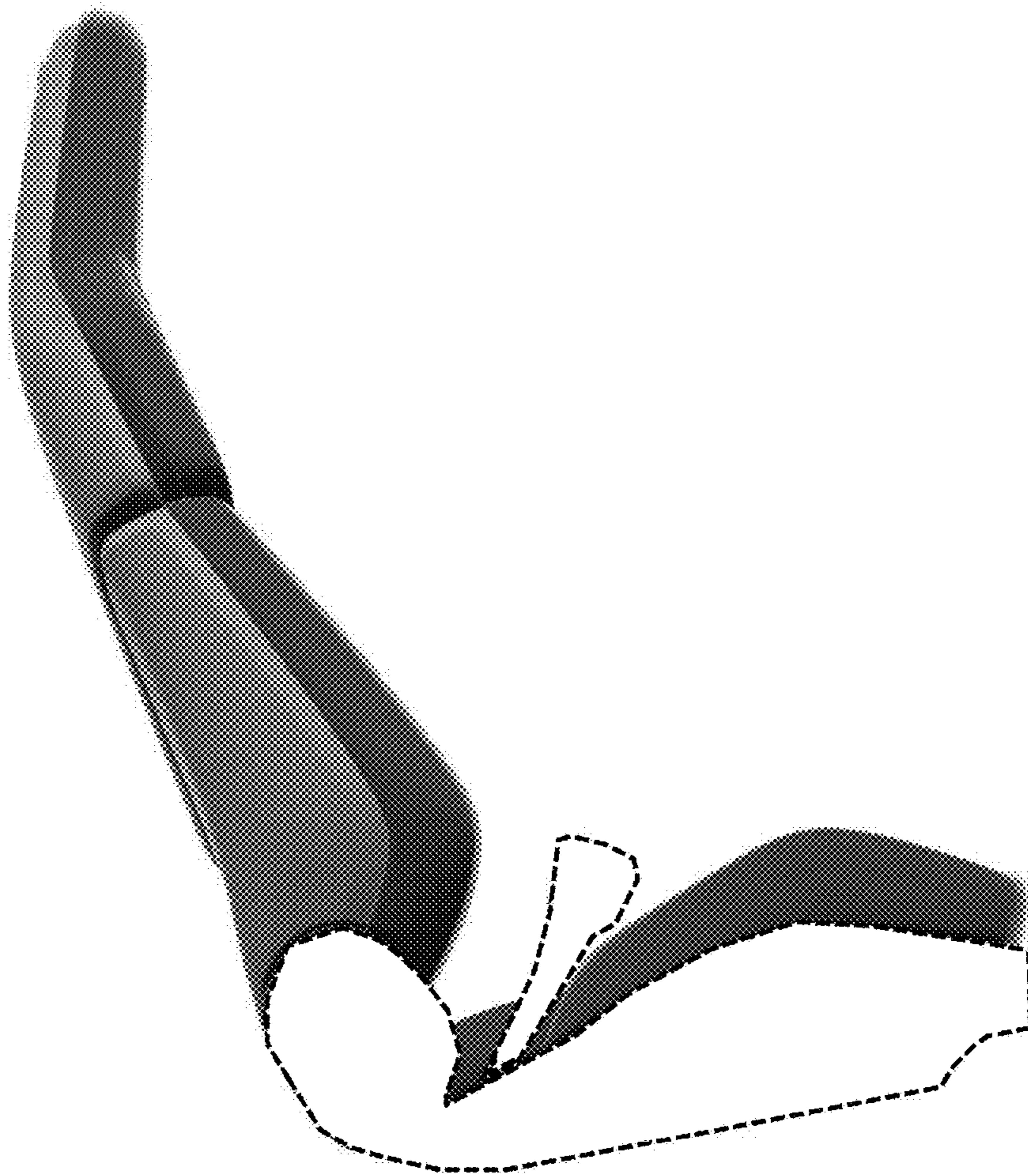

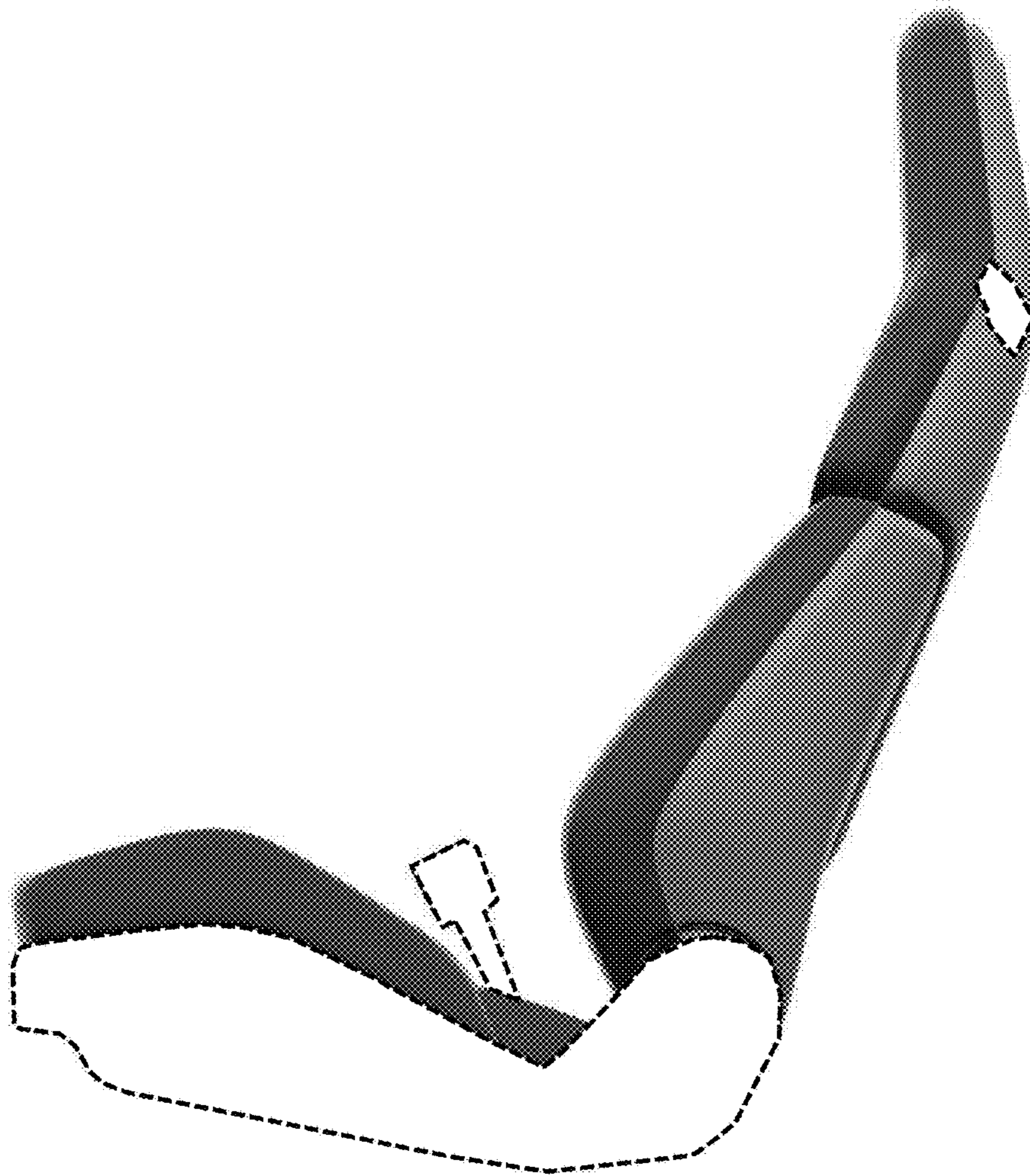
